
The deadline for submission of titles for the AAAP Scientific Program at the 1999 AVMA meeting in New Orleans is ember 4, 998.

## 1998 Report from the Ken Eskelund Preceptorship Committee

There was great concern that for 1998 there were only 4 applications for the Preceptorship program. This compares to 14 last year. Possible reasons and solutions were addressed.

It was agreed that a separate letter of recruitment would be sent to the Student Chapter of AVMA (SCAVMA) president's office within each school of veterinary medicine within the United States. A letter of recruitment would continue to be sent to the AAAP representative within each veterinary school and to the Dean's office. Dr. Glisson suggested that the decreased number of applicants may not be alarming because there are natural valleys and peaks for applicants to the University of Georgia's MAM program over the years. Dr. Salem suggested recruiting in Latin America to increase the appplicant pool (The preceptorships are given to applicants from AVMA accredited institutions). Dr. Glisson noted that the Preceptorships went to a few very qualified students and that he was pleased with the committees efforts. It was also agreed that with the help of Bob Eckroade and the AAAP office, the committee would make the follow-up calls to the AAAP representatives at the various colleges to make sure that the Preceptorship materials were being properly distributed. It was suggested by Dr. Eskelund that all members of AAAP that are associated with veterinary colleges make an extra effort to be certain that the veterinary students with whom they are in contact are aware of the benefits of the Preceptorship Program, as an introduction to the opportunities for a career in avian medicine.



## Poultry Health Management Residency Master of Specialized Veterinary Medicine

North Carolina State University College of Veterinary Medicine (NCSU CVM) is offering a unique opportunity for post-veterinary professional development: a combined Residency in Poultry Health Management and Master of Specialized Veterinary Medicine. Successful completion of this 24 month program will result in certification of Residency completion and a non-thesis Master's degree. This program provides post-veterinary training in the identification and control of factors impacting poultry health and production. Goals of the program are to prepare veterinarians for productive roles in the modern poultry industry and provide experiences which will enhance eligibility for certification by the American College of Poultry Veterinarians. Poultry Health Management residents/graduate students will participate in (1) field investigations and research related to poultry health management and disease prevention, (2) application and interpretation of laboratory diagnostic technology e.g. serology, microbiology, and pathology, (3) teaching activities of the Poultry Health Management faculty, 4) production of commercial turkey and broiler flocks at the NCSU CVM Teaching Animal Unit, and (5) use of computers for word processing, presentations, and data management and analysis.

The Poultry Health Management program makes use of resources at the College of Veterinary Medicine, NCSU Poultry Science Department and Poultry Cooperative Extension Service, North Carolina Department of Agriculture Animal Disease Diagnostic Laboratories, and integrated poultry production companies.

Applicants must submit (1) application form, (2) letter of intent, (3) transcripts of university and veterinary college performance, (4) curriculum vitae or resume, and (5) three letters of recommendation by 1 February 1999 to be eligible for the Poultry Health Management program beginning 1 July 1999.
