### A Sad Note

Dr. E.S. Bryant passed away on June 12, 1994 after a brief illness. Dr. Bryant was a professor and extension veterinarian for 24 years at the University of Connecticut. After retiring in 1992 he remained active as a private poultry veterinarian throughout New England. Dr. Bryant was born in Belfast, Maine on May 8, 1930. He received a Bachelor of Science degree from the University of Maine and his doctor of veterinary medicine degree from Cornell in 1964. Dr. Bryant specialized in Avian Medicine and Pathology, and conducted extensive research in poultry diseases. He published many journal articles regarding his research in diseases of poultry and pet birds. He was an editor of the "New England Poultry Letter" for many years. Dr. Bryant was a well known speaker and was Chairman of the New England Poultry Health conference from its inception until 1992. He was one of the first to recognize the need to protect the New England region from Avian Influenza in 1986 and Salmonella in the 1990's. Under his leadership, preventive programs were developed and the New England poultry industry was spared catastrophic economic losses from Avian Influenza and Salmonella enteritidis. He received many honors and awards throughout his career. He is survived by his wife Lucille, two sons, a daughter and five grandchildren. Memorial contributions may be made to the AAAP Foundation, the Storrs Congregational Church Memorial Fund, Storrs, CT 06268 or to a charity of the donor's choice.

# FROM THE DESK OF DAVID ANDERSON





### FDA Citation Awarded to Dr. Richard McCapes

Prug Administration Commissioner's Special Citation at the FDA Awards Ceremony in Maryland on May 27. He was selected for special recognition of his accomplishments and the invaluable assistance he has provided to the FDA on issues that impact the well-being of the public. Dr McCapes was honored for outstanding contributions as a clinician, teacher, researcher, administrator and advisor on salmonella in feed, public health and avian veterinary medicine. An internationally recognized expert in the area of clinical poultry medicine, Dr. McCapes has been at the University of California, Davis, School of Veterinary Medicine since 1970. He served as AAAP president in 1978, was elected into the National Academy of Practice as a Distinquished Practitioner in Veterinary Medicine in 1990 and is a member of the USDA Secretary's Advisory Committee on Foreign Animal and Poultry Diseases.

### 37th Annual Report (Year ended April 30, 1994)

The American Association of Avian Pathologists enters its 38th year with a total membership of 993 (803 domestic and 190 international). 893 (731 domestic and 162 international) of the 993 members have paid their 1994 dues or are life or retired members and are exempt from paying dues. The membership consists of 648 members, 212 associate members, 84 retired members, 20 life members, 17 student members and 12 international associate members.

Subscriptions to Avian Diseases were up from last year with an average of 1900 copies printed per issue for volume 37 (volume 36 averaged 1835 copies per issue).

In the 1993-94 audit for AAAP business transactions prepared by Robert Capone, CPA of Elko, Fischer, McCabe and Rudman of Media, PA the following items were particularly noteworthy.

Unrestricted fund revenues were up from last year and totaled \$268,590 for fiscal year 1993-94 as compared with \$228,070 last year. Revenue generated by *Avian Diseases* totaled \$175,011 as compared with \$149,920 last year. Sales of educational materials were up slightly this year, totalling \$34,302 compared with \$32,786 last year.

The sales volume for the third edition of the *Avian Disease Manual* was up \$188 with a year

to date total sales of \$13,309. The sales volume for A Laboratory Manual for the Isolation and Identification of Avian Pathogens was up \$1,341 bringing the sales for 1993-94 to \$5,655. The sales of Avian Histopathology were also up with a year to date sales total of \$3,751. Sales of the slide study sets decreased \$1,830 for a year to date total of \$8,065. Sales of the Marek's, Salmonella Symposia and Chlamydiosis Manuals were up slightly from last year. Sales of the Spanish Avian Disease manuals were down slightly from last year. Sales of the USDA Biosecurity

Video were up \$720 to \$1,100. Royalties from *Diseases of Poultry* were up \$4,384 to \$10,673. Interest income was up \$197 to \$4,583.

Unrestricted fund disbursements were \$230,567 (in 1992/93 they were \$247,333) resulting in a gain of \$38,023 for the year.

The financial status of the AAAP is sound. Our reserves increased this past year due to the changes made in dues and subscription charges. We must continue to watch the annual changes in our reserves.

### 5th Annual Foundation Report

The Preceptorship committee reviewed 8 applications this year.

Six applicants were awarded financial aide up to \$800.00.

The 1993-94 audit of the AAAP Foundation, Inc. was prepared by Robert Capone, CPA of Elko, Fischer, McCabe and Rudman of Media, PA. A copy has been sent to the audit committee of AAAP and is included in the agenda materials given to the Board of Directors.

Restricted accounts include the C.A. Bottorff and Reed Rumsey Student Funds. The C.A. Bottorff fund now totals \$43,602. Revenue this year consisted of interest income of \$2,313 and contributions of \$2,941. Expenses were \$2,100 resulting in a net increase of \$3,154. The Reed Rumsey Student Fund now totals \$45,207. Revenue consisted of interest income of \$2,104 and contributions of \$1,475. Expenses were \$3,121 resulting in a net increase of \$458.

The preceptorship fund now totals \$57,256. This year's revenue consisted of interest income of \$2,709 and contributions of \$825. Expenses were \$5,367 resulting in a net loss of \$1,833. The "unrestricted" account totals \$15,567. Revenue consisted of \$258 in interest income and \$8,010 in contributions. Expenses were \$3,645 resulting in a net increase of \$4,623.

The total fund balance for AAAP foundation is \$161,632.

The Foundation also sent educational material to developing countries. This consisted of 3 AVIAN DISEASES subscriptions, 7 copies of AVIAN DISEASES 37-1, 6 second editions of ISOLATION AND IDENTIFICATION OF AVIAN PATHOGENS, 15 third editions of ISOLATION AND IDENTIFICATION OF AVIAN PATHOGENS, 24 AVIAN DISEASE MANUALS, 15 AVIAN HISTOPATHOLOGY MANUALS, 15 CHLAMYDIOSIS MANUALS, 2 SALMONELLA SYMPOSIUM MANUAL, 1 MAREK'S SYMPOSIUM MANUAL, 1 Slide study set #4 and 1 complete set of slide study sets. The Foundation also sent a donated set of Journals. The material has gone to Albania, Iraq, Philippines, Pakistan, Algeria, Morocco and India.

### 1994 COMMITTEE REPORTS

Report of the Tumor Viruses
Committee Meeting - July 11, 1994
John Donahoe, Chair

The new policies of the AAAP Board as they relate to the Committee were reviewed. The Committee is a special interest group and, as such, must attend to its own needs regarding membership and communication. The Committee agreed to use the newsletter to seek interested participation and membership. The Committee is to elect Committee Chairs.

The following is a discussion of roundtable topics agreed to by the membership prior to the meeting.

**REV** This topic was chosen because of rising concern about the spread of reticuloendotheliosis virus (REV) by various means, including vaccine contamination. Israel and Australia are examples of countries with regulations attempting to exclude or reduce RE virus and who ban the importation of RE virus and REV - positive birds. A discussion of detection methods ensued. Biologics companies present are using a variety of techniques to test their master seed stocks for REV. Concern was expressed that the COFAR was not the most sensitive test but other methods are not yet accepted by all in the community as superior. Dr. Eugene Smith of East Lansing has a PCR method worked out but it has not yet been fully evaluated. Enzyme immunoassays have been shown more sensitive and specific than other published methods. Vaccine companies should standardize detection methods. The recently isolated REV was hard to detect. Extraneous pathogenicity (EP) tests would have to have been held at least 21 days to find this REV. That, of course, would result in embryos hatching prior to the test completion.

Dr. Fadly reported that the wing stab and injection methods of vaccination have spread REV in the past. The U.S.

outbreak was in fowl pox vaccine. A prior outbreak in Japan was due to presence of REV in Marek's vaccine. A question was raised as to how breeders can keep birds REV antibody negative. This is hard to do, especially in regions like the south, where mosquitos are prevalent and horizontal spread is common.

MDV Possible changes in the Marek's disease (MD) pathogenic spectrum were discussed. Presence of very virulent MD virus (VVMDV) strains has been demonstrated on the Eastern Shore. Some of these strains may not differ much from classic MDV. The committee agreed that it was not yet possible to determine if vaccine variation and environmental load variations are more the cause of some current field problems than MDV pathotype variation.

A discussion of the genetics of vaccinal immunity to MDV followed based on recent and past work of Drs. Bacon, Spencer and others. For example, it was discussed that different haplotype Chicken lines are better protected by 301B/1 vaccine versus others which don't show much difference. B2B5 haplotypes respond well to serotype II vaccine. Without a complete knowledge of haplotypes in a given primary breed line, one can check a given vaccine strain in a pedigree line

of birds versus other strains of vaccine. It may be possible to observe differences. Findings in this area are considered by the researchers as being quite preliminary but can lead to expanded areas of future research. For example, molecular haplotyping may be a future tool for use by breeders.

ALV Retroviruses in heavy breeders were discussed. Myelomatosis is seen in Europe with "subtype J" and this has created concern. There may be some benefits to elimination of avian leukosis virus (ALV) but data on this subject is not yet published. There may be some novel subgroups. Some heavy breeders want to eradicate exogenous ALV.

As it's final item of business, the Committee elected Dr. Aly Fadly as it's next Chair by unanimous acclaim. ### 1994 COMMITTEE REPORTS CONT.

Report of the Respiratory Diseases Committee Meeting - July 9, 1994 Frederic Hoerr, Chair

The AAAP Respiratory Diseases Committee met at the ANA Hotel, San Francisco, CA at 7:00 pm on Saturday, July 9. Eighteen committee members and guests were present.

Dr. Otis Miller reported on changes approved for the National Poultry Improvement Plan at the recently concluded biennial conference. The changes will officially take effect when published in the Federal Register.

Dr. Jim Pearson reported on the current situation of avian influenza (AI) in Mexico and on characterization studies of AI virus isolates conducted at NVSL. The committee approved by general consent a recommendation to AAAP members to heighten biosecurity practices, especially among consultants and poultry company personnel traveling between the U.S. and Mexico.


Dr. Dan Domingo reported on an outbreak of infectious coryza in broiler breeders in trinidad involving *H. paragallinarum* type C. Dr. Fred Hoerr reported on infectious coryza in broilers in Alabama involving *H. paragallinarum* type A.

Dr. Lloyd Lauerman presented a case report on the effectiveness of the polymerase chain reaction (PCR) in the detection of *Mycoplasma gallisepticum* infection in broiler breeders.

The committee was directed by the AAAP president to recommend a chairman for 1994-95. By general consent, the committee adopted a recommendation that the current chairman continue in that capacity. by the same manner, the members also supported the current practive of having committee membership open to all interested AAAP members.

On July 10, 1994, the committee sponsored a AAAP symposium, "Respiratory Diseases of Broilers and Turkeys" at the convention center.

Fifteen oral presentations were given and accompanied by program notes. The committee expresses thanks and appreciation to the AAAP and the AVMA for support of the symposium.



AAAP Liaison Committee Meeting Report - July 11, 1994 Peter Poss, Chair

The Liaison Committee met in San Francisco on July 11, 1994 and took up two agenda items and a discussion on drug availability. Harold Zweighaft our AVMA Liaison member did not attend. All other members were present with the exception of Oscar Fletcher who had another commitment but gave us his input prior to the meeting.

AVMA meeting accommodations this year were considered to be excellent and a pleasant reversal of past inadequacies. The positive change was

the result of many personal AAAP contacts with AVMA representatives and particularly a letter to AVMA President Leon Russell that was written in September of 1993. The letter was from President Halvorson, Secretary Treasurer Eckroade and President Elect Fletcher and detailed the serious situation that had developed with a request for consideration. We are appreciative of the response and thank President Russell for his efforts on our behalf.

The committee recognizes the need and recommends that we have an ongoing commitment to future personal contacts with the incoming leadership in AVMA to maintain priority for our association and our meeting accommodations. The committee would also like to see an AVMA staff person appointed as a second AVMA representative on our committee.

The membership survey which was conducted this past winter was reviewed as it pertains to our annual meeting and our relationship with AVMA. It indicates a strong interest in continuing our annual meeting in conjunction with the AVMA annual meeting.

16th Annual Meeting of the Southern Poultry Science Society will be held in Atlanta, Georgia on January 16-17, 1995 preceding the Southeastern Poultry & Egg Association International Poultry Exposition at the Georgia World Congress Center. The Southern Poultry Science Society (SPSS) will have a call for papers (oral communications and poster presentations) around October 1, 1994 with an abstract due date around November 15, 1994. SPSS is seeking participation of Poultry Veterinarians and Pathologists, who may be associated with Poultry and Allied Industries and those with Governmental and Academic affiliations as well. The SPSS offers specialized scientific sessions covering such diverse subjects as Pathology, Genetics, Physiology, Immunology, Environment & Management, Nutrition, Processing & Products, Extension, and Marketing. Presentations are of high quality and are divided between applied and basic research topics of current and long-term interest to the Poultry Industry. The SPSS Annual Meeting is the ideal Winter meeting for Poultry Veterinarians and Pathologists planning to attend the SEPEA International Poultry Exposition. 

Six have been published and CVM plans to complete the five remaining ones by July 1, 1995.

Supplies of the first six published are about exhausted and they are currently being revised and republished. It is the aim of CVM to translate and publish these books into Spanish and French once they are published in English. This will provide CVM and all agencies working in animal and public health a single source, comprehensive, practical and appropriate technology that can be used around the world. Using its membership, other agencies, para-government organizations and marketing means such as the "voice of america", CVM makes books available to those that are directly involved in providing service to subsistence farmers.



It was the first of the latest revisions and has been republished in English. It is our desire now, to publish it in both Spanish and French,. #### INTERN PROGRAM IN AVIAN MEDICINE

North Carolina State University College of Veterinary medicine is offering two internships in avian medicine for 1995/96. Production of poultry and eggs is the leading agricultural industry in North Carolina. The avian medicine intern program is designed to provide postveterinary training in all facets of the poultry industry, with primary emphasis on the prevention, diagnosis, and treatment of poultry diseases. In addition, interns will have some experience in the postmortem diagnosis of pet and wild bird diseases. Goals of the program are to prepare veterinarians for productive roles in the modern poultry industry and provide experiences which will enhance eligibility to the American College of Poultry Veterinarians. The avian medicine intern program makes use of resources at the College of Veterinary Medicine, NCSU Poultry Science Department and Poultry Extension Service, North Carolina Department of Agriculture Animal Disease Diagnostic Laboratories, and local poultry production facilities. Applicants must submit an application form, letter of intent, transcripts of university performance, curriculum vitae or resume, and 2-3 letters of recommendation by 1 February 1995 to be eligible for internships beginning 1 July 1995. # THE AMERICAN ASSOCIATION OF AVIAN PATHOLOGISTS THIRTY SEVENTH ANNUAL MEETING JULY 12, 1994 SAN FRANCISCO, CALIFORNIA

The thirty-seventh annual meeting of the American Association of Avian Pathologists was called to order by Dr. Dave Halvorson, President, at 10:45 am. The meeting was attended by approximately one hundred and twenty three members.

Dr. Halvorson asked the membership to pause for a moment of silence to remember five of our members who passed away this year. Drs. R.A. Bankowski, William Dungan, Mike Rosenstein, Howard Kahan and Everett Bryant.

A motion was carried to approve the minutes of the thirty-sixth annual meeting as published in the newsletter.

### **Recognition of Retiring Board Members**

Dr. Halvorson recognized two Board members who are leaving the Board this year. Dr. Bill Chase, Past President and Dr. Max Brugh, Southern District Director.

#### **Southern District Election**

Dr. John Glisson has been elected to serve as the Southern District Director for the next four years. He will replace Dr. Max Brugh.

### **37th Annual Report**

Dr. Eckroade reported that AAAP began its 38th year with 993 members. Subscriptions to Avian Diseases were up to 1900 this year. The following were reported from the 1993/94 audit done by Elko, Fischer, McCabe and Rudman: Unrestricted fund revenues were up from last year and totaled \$268,590 for fiscal year 1993-94 as compared with \$228,070 last year. Revenue generated by Avian Diseases totaled \$175,011 as compared with \$149,920 last year. Sales of educational materials were up slightly this year, totalling \$34,302 compared with \$32,786 last year. The sales volume for the third edition of the Avian Disease Manual was \$13,309. This stays about the same from year to year. The sales volume for A Laboratory Manual for the Isolation and Identification of Avian Pathogens was \$5,655. The sales of Avian Histopathology were \$3,751. Sales of the slide study sets were about \$8,000. Unrestricted fund disbursements were \$230,567 (in 1992/93 they were \$247,333) resulting in a gain of \$38,023 for the year. We should keep at least one years operating expenses in the bank.

### AAAP Foundation Annual Report
