Dear Sir:

The American Association of Avian Pathologists is alarmed over USDA's proposal to substantially reduce the APHIS-Veterinary Services poultry disease program in the 1979-80 fiscal budget. Specifically, we understand the following programs are to be deleted:

- 1) Salmonella serotyping and feasibility studies;
- 2) Non-enteric bacteria identification, such as Pasteurella and ornithosis;
- 3) Diagnostic antigen production and standardization, and;
- 4) Newcastle disease surveillance and regional epidemiologist positions.

The current budget for these programs, we understand, is \$1,325,000.

We are opposed to this precipitous program deletion. The current APHIS poultry disease program is a bare-boned minimum, and there is no ready alternative means to provide these services at the state and industry level. The APHIS program is a vital and functional part of our nation's efficient, but fragile, industry— state— federal poultry health program. Severe disruptions to the delivery of essential health services to poultry populations throughout the United States will result if these APHIS programs are suddenly curtailed. Such actions would ultimately result in a lack of awareness to major diseases and loss of productivity. We wish, if at all possible, to discuss this issue with you or your representatives prior to the House and Senate appropriations subcommittee hearings on the APHIS budget during the week of March 5. Dr. B. S. Pomeroy and myself could visit Washington, DC during the week of February 26 or March 5 at your convenience.

Copies of this letter are going to key industry and other House and Senate leadership.
