CONSTITUTION

ARTICLE I

Section 1. The name of this organization shall be the American Association of Avian Pathologists.

ARTICLE II

Section 1. The American Association of Avian Pathologists shall be incorporated as a non-profit organization.

ARTICLE III

Objectives

Section 1. To provide an organization for the promotion of mutual interest of those persons engaged in the field of avian diseases.

Section 2. To stimulate scientific progress in avian pathology.

Section 3. To encourage adequate training in poultry diseases and management in schools of veterinary medicine.

Section 4. To encourage graduate and other forms of advanced training in avian diseases.

Section 5. To encourage the publication of a scientific journal on avian diseases.

BY-LAWS

ARTICLE IV

Membership

Section 1. The types of membership in this organization shall be:

- (1) Charter member.
- (2) Member.
- (3) Life member.
- (4) Associate member.
- (5) Honorary member.

Section 2. Qualifications for membership:

(1) Charter member.

- (a) Charter members shall have the qualifications of members and shall be those who have had fifteen years experience in avian pathology joined together at the 1957 Annual Meeting of the American Veterinary Medical Association to initiate this association, plus others elected by a two-thirds vote of the original charter membership. These latter must also have fifteen years of experience in avian pathology and shall be elected within the first year following adoption of the constitution and by-laws.

(2) Member.

- (a) Be a permanent resident of one of the four districts (Art. 5, Sec. 3) and be a graduate of a veterinary college.
- (b) Have satisfactory moral and ethical standings in the profession and a minimum of three years' experience in avian diseases.

(3) Life member.

- (a) A category of membership to which charter members and members may be elected upon entering retirement. In order to be considered for life membership, a person must have made significant contributions to the field of avian pathology and to this association, and shall have been ac-

tive in the field a minimum of 25 years. Life members shall not be required to pay any dues or assessments.

(4) Associate member.

- (a) Persons without a degree in veterinary medicine who have been engaged in some phase of avian pathology for a minimum of three years and who have made significant contributions to the knowledge in this field.

(5) Honorary member.

- (a) Scientists who have made unusually significant contributions to the field of avian pathology. Not more than two honorary members shall be selected in any one year. An honorary member shall not be required to pay any dues or assessments.

Section 3. Application for membership:

- (1) An applicant for membership (member or associate member) shall be proposed by two members, and the application shall be submitted to the Secretary-Treasurer.
- (2) Applications for membership (member or associate member) shall be approved by the membership committee and accepted by a two thirds vote of the governing board of the association.
- (3) Nominations for life members and honorary members shall be made by the membership committee and approved

by a two thirds vote of the governing board of the association.

Section 4. Rights of membership:

- (1) The rights to vote, to hold elective office and to hold committee chairmanship shall be restricted to charter members, members and life members. Associate members and honorary members shall have all other rights and privileges of membership.

ARTICLE V

Officers

Section 1. The officers of this organization shall consist of the following: President, Vice-President, Secretary-Treasurer, and Board of seven Directors.

Section 2. The election of these officers and their duties shall be as provided in the by-laws.

Section 3. The organization shall be governed by a board of directors consisting of the President, Vice-President, Secretary-Treasurer, the past-president and one board member from each of the four designated regional districts and two members at large. The area board members will be elected for a four year period and so arranged that the election for only one area will occur each year. In order to begin the timing of this election of board members this first year (59-60), the duration of tenure in office will be as follows: Northeastern District, 2 years; Southern District, 3 years; Central District, 4 years, and Western District, 1 year.

The specific districts are as follows:

Northeastern—Maine, New Hampshire, Vermont, New York, New Jersey, Connecticut, Delaware, Rhode Island, Pennsylvania, Maryland, West Virginia, Massachusetts, Washington, D.C. and the following Provinces of Canada: (Quebec, Ontario, Nova Scotia, Prince Edward Island, New Brunswick and Newfoundland).

Southern—Alabama, Arkansas, Georgia, Louisiana, North Carolina, South Carolina, Texas, Virginia, Florida, Mississippi, Oklahoma, Kentucky and Tennessee.

Central—Illinois, Indiana, Iowa, Kansas, Michigan, Missouri, Minnesota, Nebraska, Ohio, South Dakota, Wisconsin, North Dakota and Alaska.

Western—California, Oregon, Utah, Arizona, Colorado, Idaho, Montana, Nevada, New Mexico, Washington, Wyoming, Hawaii, Mexico and the following Provinces of Canada: (British Columbia, Alberta, Saskatchewan, Manitoba).

Each district shall elect its area board member by the following procedure: The Secretary-Treasurer shall solicit nominations by mail from the voting membership in the district. The three names receiving the greatest number of nominations will appear on the official ballot. This official ballot will be distributed to the voting membership for mail vote. The ballots are to be returned to the Secretary-Treasurer for official count which is to be approved by the President or whom-ever he may designate. The candidate receiv-

ing the greatest number of votes shall be declared elected. Should the office be vacated, the first runner-up in this election shall complete the unexpired term; if not available, the second runner-up shall complete the term. If neither is available the vacancy shall be filled by election by the board of directors.

The two board members at large shall be elected at the annual meeting by those assembled. The candidates shall be presented by the nominating committee. Each board member at large shall be elected for a two year term. Vacancies in the office of board members-at-large shall be filled by election at the next annual meeting by those assembled. The elected member(s)-at-large shall complete the normal term of office of the member he replaces.

ARTICLE VI

Section 1. The organization shall hold an annual meeting in conjunction with the annual meeting of the American Veterinary Medical Association unless specified otherwise by the officers.

Section 2. A special meeting may be called by the President upon the written request of five members in good standing.

ARTICLE VII

Amendments

Section 1. Proposed amendments to this constitution and to the by-laws signed by at least three members in good standing, shall first be submitted to the officers for their consideration. The proposed amendment with

the recommendation of the officers will be announced at least thirty (30) days in advance of any regular or special meeting at which time the proposed amendment will be discussed. An affirmative mail vote of at least two-thirds of the membership voting shall be required for the adoption of the amendment.

ARTICLE VIII

Election and Duties of Officers

Section 1. The President, Vice-President, and Secretary-Treasurer shall be elected by secret ballot by a majority of the voting membership present.

The officers shall serve for one year and until their successors shall have been elected. The first election shall be held at a called meeting of the association and future elections at regular annual meetings.

Section 2. Nominations for officers shall be made by a committee of three members appointed by the President. Officers shall be ineligible to serve on the nominating committee. Additional nominations may be made in open meeting or by mail by any member or charter member in good standing. The vice-president shall be a nominee for the office of president.

Section 3. Duties of the President and Vice-President:

- (1) The President shall preside over all meetings of the Association, shall be an ex-officio member of all committees, except Nominating Committee, and shall perform the usual duties of such office. Upon completion of his term,

the President shall serve for one year as voting member of the board of directors.

(2) The President shall appoint the following committees and others as deemed necessary:

(a) Nominating Committee (three members).

(b) Membership committee (three members).

(c) Resolutions committee (three members).

(3) The Vice-President shall be an ex-officio member of all committees, except Nominating Committee, preside at meetings in absence of the President, and shall succeed to the office of President should that office be vacated.

Section 4. Duties of the Secretary-Treasurer: The Secretary-Treasurer shall serve as executive officer of the Association. He shall conduct business affairs of the organization, collect dues, issue receipts, draw vouchers, and pay bills and expenses. He shall arrange for safe keeping of funds, shall keep records of all transactions and submit a yearly statement of financial affairs to the organization. He shall keep minutes of all meetings and shall perform the usual duties of a Secretary-Treasurer and such other duties as are assigned by the President.

Section 5. Duties of the Board of Directors: The Directors and the Officers of the organization shall act upon business matters requiring immediate action that may arise from

time to time and that do not require action or approval from the membership. The primary purpose of the Board of Directors is to provide continuity of effective action from year to year concerning objectives and policies adopted by the organization.

ARTICLE IX

Dues

Section 1. The annual dues and initiation fee shall be as established by the organization.

- (1) The dues shall be \$8.00 per year until changed by the organization.

The dues shall include a subscription to "Avian Diseases."

- (2) In addition to the annual dues a new member shall pay a membership fee of \$5.00.

Section 2. Dues shall become payable on January 1 of each year and shall be remitted to the Secretary-Treasurer. Any member whose dues are in arrears for one year will be disassociated from the organization after due notice has been given. Persons who have lost their membership status may be reinstated upon approval by the officers and board of directors after payment of dues in arrears as well as dues for the ensuing year.

ARTICLE X

Conduct of Business

Section 1. Fifteen eligible voting members shall constitute a quorum.

Section 2. A quorum of the Board of Directors shall consist of six, two of whom shall

be the President, the Vice-President or the Secretary-Treasurer.

Section 3. Suspension of By-Laws may be voted at any meeting by unanimous consent of the members present provided a quorum is in attendance.

Section 4. The Roberts' Rules of Order, revised, shall govern the conduct of all meetings.
