Dispensation to enter, pass and raise to the sublime degree a man with a physical, that prevents him from making the signs, normally.

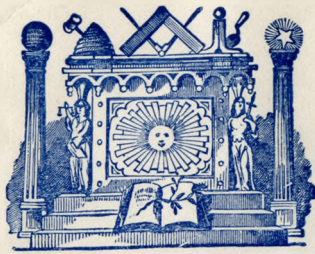
To whom the presents may come Greetings:
