TUSKUGEE, Alabama, Nov. 1, 98. This is to say that I have been acquainted with Major John F. Lacey, Member of Congress from Iowa, for a number of years and have watched closely his work in Congress. I have had a special opportunity to observe his deep interest in the lifting up of the colored people of the country, and our race has no warmer or helpful friend in Congress than Mr. Lacey. He is conservative, fair and honest at all times, and is a man of whom any people should feel proud to have as their representative. I very much hope that the colored people in his district can see their way clear to give him warm and unanimous support.

NO VOTE FOR COLORED CITIZENS.

Then Why Should We Vote For The Democratic Party.

In many parts of the South and especially in North Carolina the race war is growing more alarming, and the white people who are only about two fifths of the voting power are determined to rule the commonwealth; if they have to kill the Negroes as they say they will before they will be ruled by them. Read below what a Chicago Record Staff correspondent says: "In Wilmington, for example, where the greatest danger exist, the white people pay 96 per cent of the taxes and own 97 per cent of the property, but out of a total population of 25,000 the Negroes cast 1,200 more votes than the whites, fill 78 per cent of the offices and expend the money which the white taxpayers contribute to the treasury. For several years the tendency has been toward Negro domination and the whites claim that it has already become intolerable. Therefore they resort to bullets to overcome ballots and openly proclaim their intention to kill the Negro voters who have the temerity to come to the polls and exercise the rights guaranteed them by the constitution. The city is practically in a state of siege and the ban has been placed not only upon the colored race, but upon all white men who encourage or defend them in asserting their rights. It is no secret movement. There is no Ku Klux Klan and no white-cap organization. The crusade for the supremacy of the taxpayer is preached from the pulpit, proclaimed in the daily newspapers and asserted in every shop and upon every street corner. Not only must Negro candidates for office be defeated but Negroes who now hold office must resign. Death is the penalty in both cases. The citizens are armed and make no secret of the fact. There is a new Gatling gun in the local armory and 2,000 Winchester rifles are said on trustworthy authority to be distributed among private residences. In each block of the city is a lieutenant, while every six blocks is in charge of a captain. Each block has its place of refuge already selected, to which the women and children can flee for safety when the race war breaks out and where they will be protected by the men of their vicinity. The same conditions prevail in every city in the eastern part of the state. In the western counties the whites are very largely in the majority."

Colored voters after reading the above actions and assertion from the democratic party. Can you vote for such a party? Can any colored men consistently say by your actions, continue to disfranchise the poor colored man? Can you my colored voter of Iowa or the North support and aid this democratic party? The very party that try and do suppress and kill your brothers every chance they get. No you cannot afford to a thousand times no; no race loving man nor self respecting Negro will do so. Let us be like the Germans, Catholics or Swedes whenever you suppress my nationality you hit me and we will stand together and strike you, the world will admire us for the heroic bravery in which we stand together and repel all intruding forces. 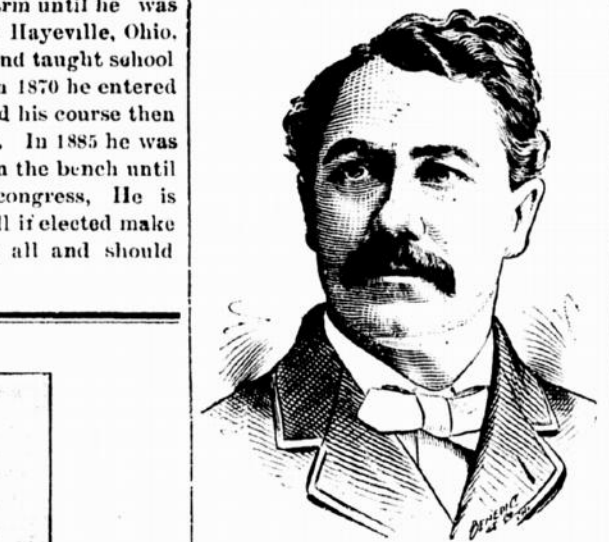

HON. DAVID BREMNER HENDERSON

With pleasure we present our many readers with a brief history of that gallant brave senior member of the Iowa delegation in congress, Col. David B. Henderson of the 3d district, who has been elected continuously to congress since 1882. He was born in the Old Dover district, Aberdeen county, Scotland, March 14, 1840. In 1846 his parents came across the big Ocean and settled in Illinois, three years later they moved to Northern Iowa, settling on a farm where he worked until he was 21. When the battle-ery came to save the union he enlisted in Company C 12th Iowa Inf.; losing his leg in the famous battle of Shiloh. He was made Colonel of the 16th Iowa Inf., in June 1864 and served until the close of the war. After the war he studied law and was admitted the bar. He was 42 years old when first sent to congress and has remained there ever since. He is an able speaker, fearless and brave Republican, of the Lincoln type. He is a special favorite among the old soldiers and a good friend to the colored race; as he is always found voting and working for their interest. He merits the hearty support of every republican voter in his district.



Hon. Joe Reed Lane, the able attorney, who is a candidate for congress from the Second District, was born in Davenport, Iowa May 6 1858, where he attended the public schools, later he attended the Knox College at Galesburg, Ill., where he graduated in 1878, in the same class with Colonel G.
