VICE PRESIDENT HOBART'S DEATH.

The sad intelligence of the death of vice president Garrett A. Hobart this week has brought sorrow to the American people. While he had been a sufferer for several months and dangerously ill for the past fortnight, his death did not come until last Tuesday morning about 8:30, when he passed quietly away at his home in New Jersey, surrounded by his entire family. The funeral will take place Saturday.

But few men were better or more generally liked by all classes of people as Mr. Hobart. He enjoyed the good will of all and supreme confidence of the thinking democrats. He was a true type of an American; starting in life a poor boy, but with that earnest, honest ambition and a determination to make a name for himself. He became quite wealthy and a successful lawyer and politician, esteemed by all citizens, thus the nation joins in with the family in mourning for her lost citizen, while in the middle of life.

NOTED COLORED WRITER DEAD.

We forgot last week to mention the death of Gussie L. Davis of New York, one of the greatest song writers that the colored race has yet produced. DEATH OF THE VICE-PRESIDENT

Succumbs to Long Illness—The Career of Garrett A. Hobart.

Vice-President Hobart died at 8:30 o'clock Tuesday morning at his home in Paterson, N. J. The family and physician were at Mr. Hobart's bedside when he expired. The vice-president had been falling since late Monday afternoon, although the reports given out at the house were that he was holding his own. At midnight he became unconscious, and at 7 o'clock he had an attack of angina pectoris, from which he never rallied. His death followed. Mrs. Hobart, Dr. Newton, Mrs. Newton, who is a cousin of Mrs. Hobart, and Miss Alice Waddell, the nurse, were at the patient's bedside constantly from the time he became unconscious. At 7:30 the vice-president's private secretary, Mr. Evans, called up the white house by telephone and notified President McKinley that Mr. Hobart was dying. At 9 o'clock Mr. Evans communicated again with the president, notifying him of the vice-president's death.

Garret Augustus Hobart was born June 3, 1844, at Long Branch, Monmouth county, N. J. His ancestors were English on his father's side and Dutch on his mother's. In 1863 he graduated from Rutgers college at the early age of 19 years. In the same year he began to teach school, but after a term of three months he gave it up and began the study of law under Socrates Tuttle, then the leading lawyer of Paterson, N. J., and was shortly

here his ability as a campaigner soon became manifest. In 1884 he became a member of the national committee, and was elected vice-chairman in 1891. During the campaign of 1890, when he was nominated for vice-president, Hobart's name was not much known outside of his own state. His field of operations was limited because of the fact that New Jersey usually went Democratic. This only prevented his election to the United States senate, for he was several times the choice of his party for that honor. When the problem arose of selecting a running mate for McKinley who would be thoroughly in accord with him on all questions, and who also was familiar with the machinery necessary for the operation of a great campaign, the choice naturally fell upon Hobart, and he was nominated almost without opposition. Since the election he has occupied his post of honor with dignity and credit.

After the cabinet meeting the president issued the following proclamation: By the President of the United States.—A Proclamation.—To the People of the United States: Garret Augustus Hobart, vice-president of the United States, died at his home in Paterson, N. J., at 8:30 o'clock this morning. In him the nation has lost one of its most illustrious citizens and one of its most faithful servants.

afterward admitted to the bar. In law he found his proper sphere, and his success was immediate and striking. The remarkable career of business and political success which followed showed a combination of natural ability, energy and popularity which has rarely been equaled.

July 21, 1889, Hobart married Jennie Tuttle, only daughter of his first patron and law partner. His home life always held a leading part in his affections, notwithstanding his many business and political cares, and was a model of conjugal felicity. His wife and two children, Fannie B. and Garrett A. Jr., survive him.

In 1871 Hobart was elected a member of the city council of Paterson, his first public office. In November, 1872, he was elected Republican member of the state legislature by the largest majority that the district had ever given. The next year he was re-elected and chosen speaker of the house. In accordance with the traditions of the party in his state he refused to be a candidate for a third term, though strongly urged by his constituents.

Though raised a Democrat, Hobart always thoroughly indorsed the principles of the Republican party, and soon became a power in the politics of the state. In 1876 he was elected to the state senate by a plurality double that of Hayes for president, and in 1879 was re-elected. He became president of that body in 1881. The statutes of New Jersey will show Hobart's influence upon them, especially in matters of reform, in which he always took a leading part.

From 1880 to 1891 he was chairman of the state Republican committee, and

his participation in the business life and the lawmaking body of his native state was marked by unswerving fidelity and by a high order of talents and attainments; and his too brief career as vice-president of the United States and president of the senate exhibited the loftiest qualities of upright and sagacious statesmanship. In the world of affairs he had few equals among his contemporaries. His private character was gentle and noble. He will long be mourned by his friends as a man of singular purity and attractiveness, whose sweetness of disposition won all hearts, while his elevated purposes, his unbending integrity, and whole-hearted devotion to the public good deserved and acquired universal respect and esteem.

In sorrowful testimony of the loss which has fallen upon the country, I direct that on the day of the funeral, the executive officers of the United States shall be closed and all stations of the army and navy shall display the national flag at half-mast, and that the representatives of the United States in foreign countries shall pay appropriate tribute to the illustrious dead for a period of thirty days.

In witness whereof I have set my hand and caused the seal of the United States to be affixed. Done at the city of Washington, this 21st day of November, in the year of our Lord, one thousand eight hundred and ninety-nine, and of the independence of the United States the one hundred and twenty-fourth.

Fresh Portions of Natal Being Overrun By the Boers. LONDON, Nov. 24.—The fact that the fresh portions of Natal are being overrun daily by the Boers is producing exasperation in that colony and intense humiliation in Great Britain.

CUBAN EDITOR THREATENS. Intimates That Cuban People are Ready For Revolt. HAVANA, Nov. 23.—General Collazo, in an editorial in the Cubano today, says: "We are only waiting for the decision of the United States congress, upon which depends the decision that Cuba herself will reach."

SERIOUS CHARGE IS MADE. Colonel Metcalf Accused of Shooting a Prisoner. TOPEKA, Kan., Nov. 21.—Lieutenant Hall of Lawrence, formerly of the Twentieth Kansas regiment, in a letter to the Topeka Journal, makes the charge that Colonel Metcalf, recently brevetted brigadier general for gallantry in the Philippines, shot an unarmed and supplicating Filipino prisoner, and in support of it furnishes affidavits of Private Husky of the Twentieth Kansas and First Lieutenant Ferguson, of the Thirty-sixth infantry. Husky swears that at the battle of Calapan he was ordered by Major Metcalf, that he saw a prisoner brought out of the trenches by Corporal Metcalf, who shot the prisoner with his revolver, and at the time of the shooting the prisoner was unarmed and on his knees.

STATE CONTROL OF POLICE. Governor Roosevelt's Plan to Usurp Municipal Powers. NEW YORK, Nov. 24.—Governor Roosevelt and Senator T. C. Platt had a conference upon the proposed constabulary bill by which control of the police in cities of the first and second classes is to be vested in a commission appointed by the governor. After the conference, it was reported that the governor had agreed to sign the measure if it were passed by the legislature by a good majority. Should the proposed bill become a law it would take from the municipal authorities and give to the state government full control of the police forces of New York city, Buffalo, Rochester, Albany, Troy and Syracuse. The total number of policemen in Greater New York is 7,485.

SHELL THE CAMP. Boer Artillery Begins an Attack at Mool River. MOOI RIVER, Natal, Nov. 24.—Boer guns began to shell the camp at 3 yesterday morning. The British artillery is in position on high ground to the east, west and north of the station. The artillery duel continued until 8, when it ceased for an hour. The Boers recommenced at 9, and dropped three shells into camp. They are still firing at intervals, with no damage, although their aim is good.

TO SEND FOR MAINE DEAD. War Ship Will Bring Home 104 Dead From Havana Cemetery. WASHINGTON, Nov. 24.—The navy department will send a ship of war to Havana before February to bring home the bodies of 104 sailors of the Maine now buried in Colon cemetery. The bodies will be brought to Washington and buried in Arlington National cemetery with suitable honors.

Patents Allowed to Western Inventors. Des Moines, Nov. 21.—To J. A. Cooper of Adair, Iowa, for a combined match safe and cigar tip cutter. When a cigar is placed in the cutter the tip is cut and a single match is automatically discharged upon a shelf where it may be easily reached. To S. A. Wilson, of Oshkosh, Ia., for an adjustable hood for vapor burning stoves which may be quickly and easily raised and lowered relative to a stove and cooking utensils and retained at any point of elevation desired. To J. McCormick, of Spear Fish, S. D., for an automatic checkrow corn planter and marker for simultaneously planting two rows and dropping seeds at regular intervals of space and also marking the ground as required to machine back and forth across the field in parallel lines. Printed matter containing valuable information for inventors sent to applicants and advice given free.

ELECTRIC LINE IS A GO. Messrs. Folk and Hippee Return From New York. Des Moines, Nov. 21.—That Polk and Madison counties will have direct connection with Des Moines by suburban electric railway is now an assured fact, and within a year the road will be in partial working condition, at least. The company formation, incorporation and organization and the terminal of the line will be decided upon some time during the winter and by spring the preparatory arrangements will have reached a position where active operations may begin. J. S. Polk and G. B. Hippee, president and general manager of the Des Moines City Railway Company, have just returned from their eastern trip, after an absence of over two weeks. The trip was made to New York and other points for the purpose of inspecting and examining interurban and suburban railway lines, and interesting eastern capital in the proposed line to be built between Des Moines and Winterset and ultimately to Greenfield. They have been successful in their efforts and will proceed at once to perfect plans for the road.

IOWA CATTLE FOR THE WORLD. Enormous Shipment by a Cass County Farmer. MARNE, Nov. 24.—O. Blakslee, one of the largest and most successful feeders in western Iowa, consigned and delivered to Schwarzhild, Sulzburger & Co., 431 head of fine fat cattle, averaging in weight about 1,395 net, making a train of twenty-seven car loads, for which he received a check of about \$38,000. The cattle were loaded at Marne and shipped over the Rock Island as far as Joliet, Ill., being transferred to the Lake Shore at that point. Thirty-one head will be slaughtered at New York city, the remaining 400 will be loaded or transported to Newport News for export to London and Liverpool. Mr. Blakslee makes about two shipments annually, this being the largest he has ever made, and undoubtedly is the largest ever made from southwestern Iowa. He has a splendidly equipped farm with many large barns built expressly for the comforts of stock.

IOWA SALOON STATISTICS. Forty-eight Counties Have Multi in Operation. Des Moines, Nov. 23.—In 48 counties in Iowa saloons operate legally. During the year ending June 30, 1899, there were 1,530 saloons operated in these 48 counties. They paid \$1,120,544 into the treasuries of county and city. These and many other interesting facts concerning the operations of the liquor law have been compiled for State Auditor Merriam, and will be published in his forthcoming report. No statistics on the multi law and its operation have ever before been presented in an official report of a state department. That there are multi saloons in 48 counties will be a surprise to many people. It has commonly been estimated that they existed in only about one-third of the counties. In eight counties, however, the petitions on file are only for single cities; in all the other forty they are for the entire county.

SAD ACCIDENT AT SIOUX CITY. General Manager F. C. Hills and His Wife Poisoned, the Former Fatally. SIOUX CITY, Nov. 24.—As the result of a terrible mistake on the part of a servant girl, Frederick Hills, general manager for the Sioux City & Western railway company, is dead, and his wife was for a while at the point of death. It appears that a former girl in the employ of the Hills family mixed some arsenic with breakfast food to exterminate rodents in the house. It was put away, and recently this girl left the employ of the family. A new girl was engaged, and she prepared the breakfast for the family. Not knowing the presence of the poison, she took the wrong box, and served the cooked food and poison to Mr. and Mrs. Hills.

GLANDERS QUARANTINED. Stock on Fellar Farm Placed Under Six Months Quarantine. Des Moines, Nov. 23.—A six months' rigid quarantine has been established on the Andy Fellar farm at Van Meter by the state board of health. This is the farm upon which Assistant State Veterinarian Talbott recently found a pronounced case of glanders in a horse. Mrs. Fellar refused to allow the animal to be killed. The neighbors protested so loudly that the state board of health deemed it necessary to establish the quarantine. The entire stock upon the farm have been placed in the barns and will be kept there the ensuing six months.

Ewing Gives Drake \$45,000. Des Moines, Nov. 23.—David R. Ewing announced at the meeting of the board of directors of Drake University that he had determined to donate to the university a library building, costing in the neighborhood of \$45,000. Mr. Ewing is a member of the firm of Ewing & Jewett, lumber dealers on West Locust street, and has always manifested a liberal spirit in his donations to the institution. At the same time other gifts amounting to \$65,000 were announced, \$25,000 being from Governor Drake. The \$65,000 will be used to pay off the debts of the institution, which will then be clear of debt.

Got Seven Years Each. CEDAR RAPIDS, Nov. 24.—Geo. Wagner, alias Camball, and John Daly, alias Andrews, were sentenced at Marion to seven years each at Anamosa for shooting Police Officer Palmer, of Cedar Rapids, while trying to elude arrest for burglary. Both men had had records in many states. They carried safe blowers' tools when arrested. Despondent and Hanged Himself. CEDAR RAPIDS, Nov. 23.—Frank Falter, a Bohemian living ten miles west of the city committed suicide by hanging himself from a rafter in his barn. He had been despondent ever since his wife died a few weeks ago, and is assigned as the cause.

BIG ROBBERY AT MARSHALLTOWN.

Daring Act Performed at Noon On a Prominent Street. MARSHALLTOWN, Nov. 21.—A daring robbery took place at noon yesterday, when the office of the Southwestern Mutual Life Association in the court house was entered and the large safe blown open with a dynamite cartridge and all the valuable contents removed. The robbers, however, succeeded in getting only about \$400 or \$500 that were in checks and drafts and valuable papers are missing. H. S. Halbert, president of the company, left the office 15 minutes after 12, with two of his stenographers, and Vice-President A. J. Cooper arrived at 12:30 and found the interior of the large safe partly torn to pieces and the contents scattered. The safe was set facing a large half basement window, where hundreds of people pass during the noon hour, and the robbers must have worked in full sight of passers by had they been noticed. Entrance was gained by raising a window in the main hall of the basement floor and the entire work was done within 15 minutes. The explosion was muffled by shutting the heavy doors and was not heard by the several people in the building.

James Burne Killed at Odebolt. ODEBOLT, Nov. 23.—James Burne, aged 21, a brakeman whose parents live at Casey, was fatally injured while coupling cars. His pelvic bone was crushed and he only lived two hours after being injured.

REVIVITIES. At Bloomfield recently the jury in the case of the state of Iowa vs. Clarence for murder returned a verdict of guilty in the first degree, with a penalty of life in the penitentiary. George W. Randall of Ottumwa, shot and perhaps fatally injured Elmer Howard during a quarrel. The shooting occurred on Main street, the trouble being over a woman. Randall surrendered himself to the police. A bold attempt was made a few days ago to rob the Wapello county treasurer's office during the absence of the clerks at dinner. Entrance was gained by smashing a plate glass door. An attempt to force the vault combination was unsuccessful. Waukon, in Allamakee county, claims to have one of the best prospective iron mines in the country. Over 300 acres have been leased two miles north of the town and works are being erected. The output is said to be exceptionally heavy. Fifty tons daily of ore are sent to Milwaukee, where smelting works turn out the iron. The ore is said to be of high grade.

Bet Harland, a Cedar Rapids painter, in an attempt recently to commit suicide drank three quarts of green paint. It was discovered almost immediately and he was hurried to the hospital where a stomach pump was brought into play and his life was saved. Harland's domestic life has not been a happy one and it is stated that his wife recently skipped out with another man.

At Iowa City recently, while playing in an inter-class football game Winfred Norton Stevenson, of Des Moines, a senior in the collegiate department of the State University, was killed. He was playing left end for the seniors against the juniors. He tackled the opposing end and as a result was thrown violently to the ground. His skull was fractured, the young man dying within an hour of the accident.

Des Moines dispatch: Attorney General Remley has applied at Marshalltown for a receiver for the Marshalltown Accident Insurance Company. The company was only two years old and had \$31,000 insurance in force. The company was in poor condition and was about to consolidate with the Imperial accident of Des Moines. The state auditor objected to the plan of consolidation and under his directions the application for a receiver was made.

Dr. R. E. Coniff, of the state board of health went to Storm Lake a few days ago to investigate the cases of small pox reported from that place. In all he reported he found five cases of the terrible disease, and steps have been taken to prevent the spread if possible. The town has been quarantined and the doctor says the health officers of Storm Lake are doing everything in their power to stamp out the disease, and orders have been given that vaccinations begin at once. It is hardly feared there will be a spread of the disease to other parts of the state, but health officers in all sections of the state have been notified to look carefully out for any signs of the dread malady anywhere else. PATCH OF A DIFFERENT COLOR. When Skin Grafting is Done These Concerned Should Be of Same Race. Many physicians in Chicago have recently shown a deep interest in the matter of skin-grafting, and several operations of the kind have been undertaken which have been successful beyond the expectations of the physicians themselves. These operations have been quite frequent of late, both in this city and elsewhere. At a clinical lecture at a city hospital a few weeks ago the demonstrator exhibited a patient who illustrated the fact that skin grafts do not always acquire the color of the individual on whom they grow.

"Some of you," said the lecturer, "will remember the negro whose leg was amputated in the clinic over a year ago. Owing to an effort to save to much of the limb sloughing occurred in the flaps and a raw, granulating surface resulted over six inches in diameter. You will recollect that as soon as active suppuration ceased he was brought before you again and the defect covered by Thiersch's method of skin grafting. Usually skin grafts are cut from the individual's thigh, but in this instance they were taken from the leg of a white man which had been amputated a few moments before. I remember telling you that it seemed a shame to mutilate black skin when so much white skin was going to waste and expressed in belief, based on the investigation of Karg, that pigmentation would occur and that the white skin would gradually become black. The operation of skin grafting was a perfect success and the patient was discharged in two weeks with a well-healed stump. He comes back for exhibition today. The artificially formed skin is firm, pliable and painless, but as white as on the day it was implanted. Fortunately, owing to its position, it is a matter of no consequence. Had it been upon the face and had the colors been reversed, there might be a lively suit for malpractice."—Chicago Chronicle.

CURIOUS PETS FOR WOMEN. Some minds are strikingly original, even in the choice of pets. Certainly this was the case with the wife of a gentleman farmer who made a pet of a pig. RACE ECHOES.

Joseph S. Cotter the colored poet of Louisville Ky., has issued his book "Links of Friendship."

The Boward machine shops, Bradford N. Y. has a Negro foreman. The workmen are all white.

The colored people Indianapolis, Ind., are domiciled in six public school buildings, and have 43 colored teachers, including one teacher in Germany.

One of the chief attractions at the Ft. Smith Arkansas, street fair, Oct. 16-21 was the Negro exhibit. Mr. W. E. Joshenberger, the colored mail carrier, superintended the exhibit which was made in fourteen departments.

It has been definitely decided to provide for a Negro exhibit at the Paris Exposition. Mr. Thomas Calloway, of the War Department has been appointed to take direct charge of the colored department.

Mrs. W. A. Hunton the wife of Rev. W. A. Hunton of Atlanta, Ga., has opened a school at that place and will teach business methods, bookkeeping, stenography and typewriting. Mrs. Hunton is graduated from a Boston business college, and is the only colored woman to graduate from the Spencerian School of Commerce, Philadelphia.

Benjamin L. Shook, a Negro elevator boy in the employ of the McWaters Dolan clothing house, Cleveland Ohio, speaks five languages—English, German, French, Bohemian and Italian. He also reads Latin and Greek, and is a talented musician.

Cass county Mich., the Negro population outnumber the white two to one, and are masters of the whole township. They hold all of the office votes and collect the taxes, build the school houses, employ their own people as teachers and have charge of all the internal improvements and have their own postmaster without any fear of his being lynched.

Oberton is a village in the Choctaw Nation, Indian Territory, of about 500 inhabitants, all of whom are Negroes. The postmaster is a Negro, the notary public is a Negro; and there is a Negro marshal. The town has not yet been incorporated, likely will be soon at which time the entire set of officers will be Negroes. There is considerable business enterprise among some of the people of the neighborhood, which comprises a circle of about fifteen miles.

O. P. Huntington has recently given to the Tuskegee Normal and Industrial Institute a 75 horse power boiler and a 125 horse power engine, to be used in lighting the entire school grounds by electricity and for other purposes.

The result of the Cleveland Ohio strike is, several colored boys have secured positions as conductors and motormen on the street railway lines. The union labor organizations would not have the black man until now.
