EDITORIALS.

WHO ARE THE BARRIERS TO RACE PROGRESS?

In recent years we hear many of our colored leaders, ministers, public speakers and politicians make a great speech about race harmony, race unity and race progress, stating that we must be united and work together for the success of one another. The above idea and expressions are good and should be carried out. Let us see where the fault lies and why they are not carried out. First. When our race hold a called convention or a mass meeting, or even meet in literary, debating or a political organization, the first thing you see them do is to get into a little clique to down or defeat someone that this little clique think ought to be defeated, or to get up and try to create a feeling between old citizens and the new comer or what is still more observable, to create a feeling between the young men and the older men. All of these acts are narrow, mean, treacherous and injurious to any race or class of people. In nearly every case those foolish cliques are started by some young man with no matured judgment, and less discretion. It is true that the older men of our race have most of the political preference and better standing in the community than the unacquainted young man would have, even though the young man is ever so much better qualified for said place. Now again, let us be honest, who is it to-day that keeps the race separate in every community in America. It is the young, unreasonable, egotistical, self-conceited man. Then another thing that is per se and must be stopped is, when any colored person is elected to a position, the next time every colored person tries for that same position; the result is generally that some white man secures it. The market mastership and constable was lost in our city for that reason. Then when a man or woman of our race receives an appointment, a few of the race will start to try to have him or her displaced to put in some one else who suits their particular fancy; then the next year that man or woman may not suit their fancy, so they seek to have him or her displaced and thus keep the race from being united. Why there are hundreds of other places that ought to and can be opened to the race if they would work for it. Then my young man, it does seem to me, as a young man, that some of us are our own worst hindrance the race has, to keep them from being united and working in peace and harmony.

U. S. COURT HITS COAL COMBINE issues Injunction Against Coal Dealers Who Controlled Prices at Chicago.

DISMISSED BY STATE COURTS. Judge Decided State Had No Jurisdiction and the Matter Was Therefore Taken to the Federal Court—To Argue Permanent Injunction April 6.

Chicago, March 25.—Ten Indiana companies and ten individual operators were restrained by Judge Kohl-saat in the United States circuit court yesterday from continuing their combination for the regulation of coal prices and output. The defendants were given until April 6th to show why the order should not be made permanent.

The corporations and individuals enjoined are the same as recently tried in state court on charges of raising the price of coal and restricting the output in Illinois, thus causing the coal famine in Chicago last winter. Judge Chetlain dismissed the case on the ground that the offense committed was against the federal law and not against the statutes of Illinois. The defendants are: The Crescent Coal and Mining company, Brullette Creek Coal company, Wash Valley Coal company, Oak Hill Coal and Mining company, Coal Bluff Mining company, Parke County Coal company, Glen Oak Coal and Mining company, and the Coal company, Indiana Fuel company, McClellan, Sons & Co., corporations; Walter Bogle, Hug Shirkie, Max Elchberg, J. H. Higgins, J. Smith Talley, Joseph Martin, Edward Shirkie, H. R. McClellan and John Shirkie, individuals.

The injunction granted will stand until further order of the court. It recites that the action of the court is taken upon the application of United States District Attorney Bethea and upon affidavits of Assistant State's Attorney Bethea and of the coal company, that the defendants are especially restrained and enjoined from in any manner complying with or executing the terms of a certain contract made and entered into between you during the month of March, 1902, which by its terms was to be in effect on April 1, 1902, or any similar contract.

They are restrained from entering into any combination among themselves to ship the bituminous coal mined and to be mined on their property in Indiana to the Crescent Coal and Mining company and to the coal company, and from selling or disposing of any coal mined on their property to any consumer in any manner complying with or executing the terms of a certain contract made and entered into between you during the month of March, 1902, which by its terms was to be in effect on April 1, 1902, or any similar contract.

650,000,000 FOR IRELAND. Land Bill Introduced in Parliament by the Irish Secretary.

London, March 26.—The Irish secretary, Mr. Wyndham, introduced the government's long-anticipated land bill in the house of commons yesterday. It proposes a free grant of \$60,000,000 for the purpose of the bill. Secretary Wyndham said that the new legislation, which is hoped, will promote peace and contentment in Ireland, was evidenced by the crowded house.

The peers gallery and the distinguished strangers gallery were filled and there has not been such a gathering of members of parliament since the opening of the session. Michael Davitt, the father of the Land League, celebrated his 75th birthday by re-entering the house for the first time since he ceased to be a member, in order to hear the chief secretary for Ireland unfold his plans.

Mr. Wyndham, who was heartily cheered when he rose to speak, announced at an outset that the government thought cash aid was necessary for the fulfillment of the proposed scheme, but it attached great importance to the credit operation than to the cash operation.

He then unfolded the scheme which provides for advances of money for the purchase of land by the tenants. The advances will be in the shape of cash and not of stock, but in order to enable cash to be raised a new issue is to be floated.

The Irish land bill also provides that tenants shall pay 3/4 per cent on loans from the government; that tenanted farms and grazing farms will be sold to neighboring tenants, and that three commissioners will be appointed to carry out the scheme.

The advance to tenants, through the provisions of the land bill, are limited to \$2,500 in the congested districts and \$5,000 elsewhere. The bill will become effective November 1. Mr. Wyndham said \$50,000,000 could safely be advanced on Irish land but he thought the scheme would not involve \$50,000,000.

The Irish secretary explained that while the maximum charge on the English treasury would not exceed \$1,975,000 in a single year, the reduction in the cost of the administration of Ireland would amount to \$1,200,000. It will be called "guaranteed 2 1/2 per cent stock" and will be redeemable for thirty years.

Mr. Wyndham doubted if \$500,000,000 of the stock would be needed. It will be issued at the rate of \$25,000,000 yearly for the first three years and afterwards possibly in larger sums. In addition to this, the government proposed a free grant of \$60,000,000, to be raised by addition to the stock, the interest and sinking fund of which will be borne by the treasury, and the maximum annual charge of which will not exceed \$1,975,000.

Proceeding Mr. Wyndham dealt with the details of the bill, which contains a bewildering mass of figures showing how advances would be made and the terms of repayment, but it is in the main to be on the lines laid down by the land conference report and will be satisfactory to the landlords and tenants.

"It is remarkable under those circumstances," asked the Irish secretary, "if the landlords and tenants could be brought together." Mr. Wyndham did not think any recon- dite or vested reasons need be looked for. Past experience showed the state incurred no risk in giving such aid. From the tax-payers' view point it was stated that aid for the land purchase was a safe commercial proposition. By the aid of the state 80,000 tenants had already bought their holdings and the state had not lost a half penny. Public opinion supported repayment, and this was high moral security, besides which was the security of the land itself.

WITHDRAWS RESIGNATION. Castro Bows Before Desire of Congress and Takes up Burden. Caracas March 26.—After reading his special message to congress General Castro withdrew his resignation of the presidency of Venezuela.

Caracas March 26.—After reading his special message to congress General Castro withdrew his resignation of the presidency of Venezuela. "Notwithstanding those reasons which were weighty to my mind," he continues, "congress does not accept my resignation and insists that I should continue, that I should not persist therein, but considers me still useful in the government. I bow before the desire of congress to refer to the new obligations imposed by my country, but only until the work of pacifying the nation shall be complete and order re-established in the public offices of the republic. I hope the future will prove my right. Accept my expressions of respect and thanks for the generous demonstration of which you have made me the object."

When it was known that he had not resigned a popular demonstration took place. Crum to Serve as Collector. Washington, March 21.—The president today re-appointed Dr. W. D. Crum, colored, collector of customs at Charleston, S. C., and William B. Byrnes, United States district attorney for Delaware. Both of these nominations failed of confirmation at the recent session of the senate, just adjourned. They will at least hold until the next session of congress.

APPEAL EUROPEAN POWERS.

Startling Communication Sent to Rulers of the World.

Cleveland, Ohio, March 21.—While American missionaries and church people are appealing to the powers of Europe to stop the atrocities which periodically are practiced on the Armenians, the same powers will receive from the Negroes of the United States asking the foreign courts to protect them from the "barbarities" of the white people of this country.

TEXT OF NEGROES' APPEAL.

"We, the Afro-Americans of the United States of America, says the appeal, 'are brutally and barbarously maltreated and basely compelled, for no crime or misdemeanor, to suffer every indignity, cruelty, and murder that inhuman, fiendish nature can invent, by some of those who once held the Afro-Americans in bondage and slavery or the descendants of those who once held the Afro-Americans in slavery and bondage in the United States, and who still, without cause, harbor in their hearts a deadly hatred against the Afro-American race.'

"From one to five or more are either tortured, hung, shot, or butchered and driven from their homes daily, while others are burnt to death at the stake. It has come to be such a common occurrence that the press and pulpit say but little about it. They pay more attention to the barbarities of the foreign countries than they do to their own America; to slake the deadly hate and avarice for murder and to wallow their hands in the warm blood of their dying victims.

"And while the victims are writhing in pain in the fire, their ears, eyes, and fingers are cut out and off for souvenirs and pieces of their sizzling, frying, and burning flesh are slashed from their burning bodies and are auctioned off to the highest bidder after this fashion, holding it up: 'Who wants a piece of nigger meat? Who wants a piece of nigger meat? It is sold at 10 cents.' The meat is divided into quarters and is sold at 25 cents each.

"And they seldom get employment, except at menial labor. Wages that they receive are the smallest, that are paid to any other employe. They are barred out of most every place that other races are admitted, and in places of amusement and on common carriers, in hotels the color line is drawn on them. They are discriminated against in courts, now and then permitted to sit on the jury, but not if the Afro-American is litigant in a suit against any other nationality. They cannot even rent a decent house to live in.

"We have time and again pleaded and appealed to Presidents, to Congresses of the United States to enforce the laws and to stop that inhuman wholesale murder, that discrimination and slaughter of an innocent people, but every plea and appeal has been ignored.

"Ask Old World to Interfere. 'We, therefore, now, in the name of God Almighty, do hereby appeal for the powers of Europe and to every civilized nation of the old world, through their representatives at Washington, D. C., to interfere in some way in behalf of the poor, downtrodden, outraged Afro-American of the United States.

"The Americans intervened so they claimed, for humanity, because of Spain's barbarous treatment to the Cubans. They drove the Spanish army from that island at the cost of many lives, censured the Spanish throne for wholesale murder, butchery, and torture of innocent Cubans, forgetting the beam that was in their eye; of their unequal savagery, of burning men alive at the stake, which Spaniards would not tolerate to be done to their bitterest foe.

"The foreign powers have the same and a better right to interfere in defense of 10,000,000 people that are liable to be murdered at will by prejudiced classes who use that nickname, the whites of America, for no cause whatever, only their skin is darker than those who call themselves white people.

"Name Monarchs They Rely on. 'In God's name will the King of England, will the Emperor of Germany, will the Czar of Russia, will the Sultan of Turkey, will the Sha of Persia, will the Emperor of China, will the King of Italy, and will the King of Greece, will the President of Switzerland, the President of France, will the King of Sweden, and will the King of Siam, will the Emperor of China, will the Emperor of the Mikado of Japan, will the rulers of Belgium, Roumania, Luxemburg, Montenegro, and all other foreign powers interfere in some way in behalf of the suffering, outraged, and murdered Afro-American people of the United States and thus save the name of Christianity from reproach, mockery, and derision?'
