"TOUSSAINT L'OUVERTURE"

I have just completed reading for the second time Wendell Phillips' lecture entitled, "Toussaint L'Ouverture." Every Negro should read it.

It is impossible to make a proper estimate of your race without a knowledge of the accomplishments of some of its great individuals and of the group generally. To read "Toussaint L'Ouverture" is to make you proud you are black. The history of this great black general gives the uncontradictable lie to the theory of Negro inferiority.

We are accused of not being hero worshippers. The fact is that we know not well enough the story of the glorious deeds of our forebearers. The stories of the lives of great Negroes are not recorded by historians in the same fair manner that the lives of great white men are recorded. If the black boy and girl is to learn of the great deeds of their ancestors, they must dig deep in the hidden passages.

If there is a boy or girl in your family, go to the library and get Wendell Phillips' lecture on "Toussaint L'Ouverture," pull the chairs up around the fireside and read the story to them.

With that story in their hearts no white child can walk down the street with a higher head; with that story in their hearts, they will recognize the native superiority of no mortal on earth. With that story in their hearts, they will arise to greater heights in character and citizenship.

Here was a black man who led black soldiers, made from slaves, to victory over the flower of European military genius.

Here was a black ruler, who was the author of these gems of statesmanship: "Make it the first line of my Constitution that I know no difference between religious beliefs"; "Put at the head of the Chapter of Commerce that the Ports of St. Domingo are open to the trade of the world."

Here was a black general who uttered these words: "My children, France comes to make us slaves. God gave us liberty; France has no right to take it away. Burn the cities, destroy the harvests, tear up the roads with cannon, poison the wells, show the white man the hell he comes to make."

A French general, looking upon the shabby troops, said to him: "L'Ouverture, had you continued the war, where could you have got arms?" He replied: "I would have taken yours." These are the words and thoughts of a black man, who was taught to read by a fellow slave.

Why should you not be proud you are black?

Charge Police with Murder

Cincinnati, Ohio, Sept. 29, (P.N.S.)—The Constitution declares that the courts shall be open to any person seeking redress. When the clerk of the city prosecutor refused a warrant, he is closing the courts to some one.

This statement was made Thursday by Judge Stanley Struble, in Common Pleas Court, when he issued a writ of mandamus to compel Frank Lewis, clerk of Courts, to issue a warrant charging murder against John Buganier and William Brasher, policemen of the Fourth District.

Brasher and Buganier, it is alleged, shot and killed James Elliott, aged 87, of 741 W. Fourth St., a Civil War Veteran, during a raid on his home, August 3rd, last. They said that Elliott seized a revolver upon their entrance into his room and was going to shoot.

Coroner F. C. Swing, following an inquest, exonerated the two officers, saying that they were justified in shooting under the circumstances.

A niece of the victim, Miss Nannie Mayberry, in her mandamus suit, filed by Attorney A. Lee Beatty, charged that circumstances in the shooting warranted a murder charge.

INDIANA GOVERNOR AND SENATOR SPEAK

Shelbyville, Ind., Sept. 28—Governor Ed. Jackson and U. S. Senator Robinson were the principal speakers at the Emancipation Celebration held here Thursday afternoon.

The Negro forms a very definite part of American citizenship. One of the rights that he earned with his blood is the right to enjoy the School System on the same basis that everybody else enjoys it. There is no more just reason why Negro boys and girls should be compelled to go to separate schools than Italian, French, English, Indian or Hebrew boys and girls.

Black men have shed their blood in every war entered by this country, by that bloodshed, have these rights been earned, possibly by the shedding of more of that blood must these rights be maintained, but, maintained they must be.

Slay Witness Who Testified Against Them

"Man is a worshipping creature; all men believe in some kind of immortality, and the Christian religion, a superior religion, can be accommodated to all forms of life," declared the Rev. L. K. Williams, president of the National Convention, and pastor of Olivet Baptist Church of Chicago, while speaking on "The Value of Christian Worship," before a packed audience, Sunday afternoon at Corinthian Baptist Church, in closing the Dedication week services.

"Christ can overcome all weaknesses of life. The Christian religion can be adapted to all forms of living. Most people think of religion as something of another world. That is the wrong conception of the Christian religion. You must learn how to live here before you can live in heaven," he pointed out. "True, it is good to be prepared to die, but doesn't it sound better to be prepared to live. Death is not necessary to become a successful Christian."

In explaining the need for churches, the Rev. Williams said that God has a social passion in His heart. He wants some created man, in whom He places a natural religious or social passion, and the church is where God and man must meet to satisfy these kindred emotions.

"No man is truly converted, who has no desire to be in the Church of God," said the Rev. Mr. Williams, "the church is the trying place between God and man."


"Religion must start at home," he asserted, "if a supposedly converted man mistreats his wife at home, he hasn't any religion, I believe that churches should really have a 'courtin' corner,' he humorously declared. "This love at first sight business isn't really love, it takes several sittings to assure true love. This might prevent some of the hasty marriages and divorces that are so prevalent today."

"The church should not only teach people how to live on Sunday, but every day in the year. The devil keeps his services going both night and day every day in the year. The church must also learn to hold their doors open on days other than the Sabbath. Let us dedicate Corinthian church to not only the religious aspects of this community, but the social as well," he concluded.

THE SOUTH WILL SUPPORT THE DEMOCRATIC NOMINEE

Some people have high opinions of what ought to be done but unfortunately see facts as they ought to be rather than as they are. There are those who have led themselves to believe that if Gov. Al Smith of New York got the democratic nomination for president, the South would not vote for him.

A dispatch from Washington speaking of Senator Overman of North Carolina who has spent many years in the Senate and is one of the leaders, says:

"Senator Overman of North Carolina came to town today. He has been credited with opening a fight on Smith in North Carolina, along with Senator Simmons. But this report quickly turned out untrue. Senator Overman declared he was not opposing Smith, not supporting a candidate, that North Carolina would send an unpledged delegation and that if Smith is nominated, North Carolina will vote for him in the election. Senator Overman also declared the South would support Smith if he is nominated, though Tennessee and Kentucky might be doubtful."

The senator knows Southern sentiment. He realizes that the South will vote for anybody—not disparaging governor Smith at all for he has had a wonderful career—as long as the name is found on the democratic side of the ticket. Anyone who thinks differently is kidding himself as well as those whom he seeks to convince otherwise.

NEGROES SEEK HIGHER EDUCATION

Despite the lack of economic opportunities for Negroes in Des Moines this year, more than ever before are seeking higher education. Over twenty have enrolled in the two universities of the city.

The surprising feature of the situation is the diversified fields which the students are preparing to enter. At Des Moines University: Stanley Proctor is in engineering; Everett Newcomb, social service work; Lawrence Chapman, music; Everett Wadsworth and Susie Pinkney, education; and Alfred Shepherd, dental. At Drake: Miss Marguerite Esters is completing her Liberal Arts work preparatory to entering the law school; Misses Clara Webb, Madeline Dixon, Leona Palmer and Faye Sethers are in education; Anna Wilson is taking two years of Liberal Arts previous to entering the law school; William Oney, after acquiring his A. B., will also enter the law school; Nelson Thompson is majoring in mathematics while taking his Liberal Arts course at Drake preparatory to entering the Ames engineering school; Fred Stanton is in the Commerce and Finance College of Drake, specializing in banking; Oswald Pensall of Kingston, Jamaica, B. W. I., is in theology; Jerome Freeman, who received his degree from the law school in August, is continuing his study in botany before sailing for Monrovia, Liberia, West Africa, to begin his law practice; Miss Lucile Simmons and Miss Roberta Maupin will receive their B. Mus. next June. Miss Simmons in piano and Miss Maupin in both voice and piano. Clifford McKay is in Liberal Arts majoring in Journalism.

NORTHERN CALIFORNIA BRANCH AROUSED OVER OKLAHOMA EXTRADITION

New York, Sept. 23—The Northern California Branch of the N. A. A. C. P., reports to the National Office through Hattie E. De Hart, its Secretary, that it has been working night and day to prevent extradition to Oklahoma of Edward Glass, wanted for shooting a police officer in the defense of his home after police persecution.

The Board of Directors of the N. A. A. C. P. have notified the Branch that they can draw on the National Office to the extent of \$250, if necessary, for defraying the expenses of the case. Mrs. De Hart reports that the Northern California Branch has already raised \$600 in two mass meetings.

After extradition papers for Glass had been forwarded to Governor C. C. Young of California, a hearing was held before the Governor's Secretary attended by many Oakland people, representing the N. A. A. C. P. while the hearing was in progress a writ of Habeas Corpus was petitioned for in Alameda County. The Governor signed the extradition writ but exacted a promise from the district attorney that the prisoner would be given full opportunity to present his case in court.

Urban League Reports on Labor

REPORTS ON INDUSTRY FOR JULY AND AUGUST

New York, Sept. 23—Bulletin No. 17 of the Industrial Department of the National Urban League summarizes employment as follows:

Gains
In Cape Girardeau, Mo., work was begun on the \$1,500,000 traffic bridge with twenty experienced Negroes as sand hogs. In Philadelphia the subway which is now under construction is employing a large number of Negroes. Some of these are being placed as Foremen. In San Antonio several new hotels are employing colored waiters, and some cafes have dismissed their white waiters and are employing colored. In Pine Bluff there is a heavy demand for unskilled labor in automobile plants. A night force has been established and an addition to the plant is being built. In the saw mills and on the street car tracks Negroes are finding work in Hot Springs. There has been a slight gain in the brick mason, plumbing and plastering trades in Winston-Salem and Negroes are being employed on many of the large jobs throughout the city. The West Hotel of Minneapolis has employed a colored chef and kitchen crew. This is doubtless due to the fine record of ten years of service made by the headwaiter. The hotel is now using colored elevator girls. Another hotel in Minneapolis has opened with a full line of waiters. The A. & P. stores in Baltimore in the colored neighborhoods are now employing Negro clerks. At least four have begun work already. Another chain store corporation followed the A. & P. in the use of colored help. A white firm in Baltimore has employed a Negro boy as assistant to chemist. A few Negroes were added to the police force in Detroit. A prominent hotel in Boston is now employing colored help. One factory in Brooklyn has recently employed eight Negroes, and an automobile paint shop employed its first colored painter. In Portland a young woman has been placed as an attendant in the Physio-Therapy Department of the State Industrial Commission. Two large plants have recently opened up in Milwaukee with a Negro as foreman and two as straw bosses. Negro union building tradesmen are working on Bamberger's store in Newark, a ten million dollar structure which will require two years for completion. Newark also witnessed the placement of twenty girls in a dress factory, the first to be employed as pressers in that shop.

Losses
In Portland six regular and two extra waitresses were discharged from a popular cafe because the manager promised increased patronage if white waitresses were substituted. The colored girls were given written references stating that they were not being replaced because of inefficiency as their work was most satisfactory. The Pennsylvania Railroad has laid off two hundred or more Negroes in Columbus. Negroes are suffering lay-offs from the mills in Pittsburgh. Most of the mills in that district are running half time to four or five days a week. Considerable loss was experienced in Baltimore due to a strike on the larger buildings. The Bass Foundry and rolling Mills in Fort Wayne are still working three to four days a week. In Buffalo all industries are running less than 50% capacity. There has been some loss among the factory workers in Winston-Salem.

Organized Labor
In Pittsburgh there is a noticeable change in the relation of Negroes to organized labor. Former union men who now work as strikers declare that their reason for so doing is that on the whole there is as much discrimination against the Negro within the union as there is without.

Wonders of World

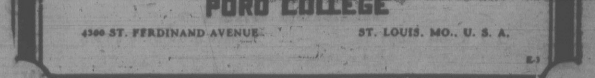
