Woodson's Reply Provokes Mirth

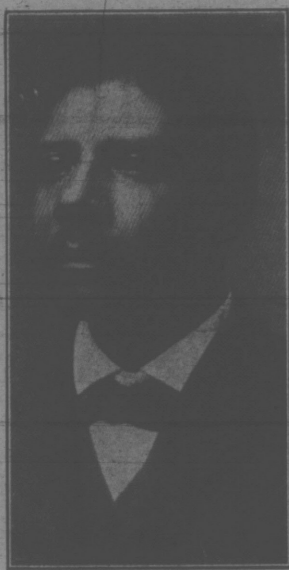
Woman Given Twelve Days on Murder Charge

Kills Chinaman And Gets Shortest Murder Sentence in History

Philadelphia, Pa., June 15—Frances Lee, who was indicted and tried for the murder of Lew Dock on May 2, was found guilty of manslaughter and received the shortest sentence ever given in Philadelphia county in a murder case. She was sentenced by Judge Brown to remain in prison twelve days.

Frances Lee, on December 17, 1927, was living with Lew Dock, a Chinaman, as his common law wife, at 410 S. Twentieth Street. An altercation arose about 1 A. M. on the morning of December 18, 1927, and a fight ensued in which Lew Dock was stabbed five times in the back with a butcher knife by Frances Lee, who, after stabbing him, fled to New York City. Lew Dock died almost immediately. On December 25, 1927, Frances Lee was arrested as a fugitive in New York City.

Attorney Austin Norris represented Frances Lee and was complimented by Judge Brown for the manner in which he handled this case.

Kansas City, June 13—(Special)—George H. Woodson of Des Moines was addressing the resolutions committee in the G. O. P. Convention Tuesday when the meeting was disrupted by an army of farmers bearing banners, "If we don't get it here, we will go to Houston." Woodson was pleading for more liberal government in the Virgin Islands when the farmers entered with their demands for a farm plank.

Senator Smoot of Utah, chairman of the resolutions committee granted Woodson two and one-half minutes to speak. Upon taking the floor, shouts were raised, "Who are you?" "I'm good looking and black," Woodson responded. His speech was drowned out in the ensuing roars of laughter.

Negroes Playing Stronger in G.O.P. Than Ever Before

Texans Plan To Bar Negroes At Primaries

San Antonio Express Estimates 5,000 Negroes Will Be Barred from Polls.

New York, June 8—Despite the clear pronouncement of the United States Supreme Court in the Texas White Primary case won last year, holding primary elections part of the machinery of voting and prohibiting the barring of Negroes by state enactment, Texas politicians are now planning to exclude Negroes from the primaries in that state.

After the Texas White Primary law was held unconstitutional, the Texas legislature placed power to fix qualifications for voters in the hands of the state executive committee of the various parties.

The San Antonio Express estimates that between 4,000 and 5,000 Negroes will be barred from the polls in DEXAR County alone, where the state chairman has written to the county chairman declaring himself in favor of barring Negroes.

In the opinion of attorneys this new form of disenfranchisement will also be outlawed by the Supreme Court if it should have to be carried before that tribunal.

Georgia Minister Fires Bullet Into Chest Of Episcopal Prelate

Charleston, S. C., June 15—Believed to have been suffering from a sting to his pride of several years' duration, the Rev. J. H. Woodward, of Brunswick, Ga., walked into the study of the Rt. Rev. William A. Guerry, bishop of the South Carolina diocese of the Protestant Episcopal church, and fired a bullet into the chest of the prelate and then turned the gun on himself and took his own life.

It is said that several years ago, Rev. Woodward clashed with Bishop Guerry when the latter sought a suffragan bishop for work among Negroes of the diocese. Woodward was finally retired after numerous speeches and attacks on the bishop. Woodward is said to have slain a Negro some time ago.

Los Angeles, Cal., June 15—With her body and face scarred and bruised little Geraldine Broadway was brought to the city hall here from Bell, a suburb, by Mrs. Victoria Jacquet, who told of how the little girl, her ward by adoption had been set upon by three armed white boys and cruelly beaten about the head, face and body.

The case was reported in the sheriff's office and an investigation was started at once. It was learned that the same white boys dressed in K. K. K. disguises had previously beaten up a young white boy, cutting a deep gash in his head.

Race Democrats Plan Meeting At Cleveland

Five Thousand Are Expected To Attend Meet; Social Sessions Planned

Cleveland, Ohio, June 15—Five thousand delegates are expected to attend the convention of the National Colored Democratic Association at Cleveland, July 23, 24 and 25. Under the direction of Ohio's national committeeman, Attorney Walter L. Brown elaborate preparations are being made for their entertainment. Councilman J. E. Grogg will be named mayor of Cleveland for the first day, July 23, and will make the welcome address and present the keys of the city to the delegation. Headquarters of the convention will be at the Zion Hill Baptist church.

The evenings will be given over to pleasure. On Monday evening a public reception will be held; Tuesday evening there will be a delightful boat ride down Lake Erie, and on Wednesday, an elaborate ball will be staged at Cleveland's most spacious and up-to-date dance hall, "Danceland." Due to the persistent efforts of Councilman Grogg, permission has been granted for a street carnival every evening of the convention.

There is a growing interest in the work of the Negro Democratic clubs of the city. Recently, a woman's auxiliary, under the leadership of Mrs. Alice Hendrick, was organized with more than 500 women. According to Attorney Brown, there are more than nine hundred Negro Democrats in Cleveland.

Southern Negro Delegates Wear Frock Coats; Unable To Find George Woodson

Here we are at a republican national convention. Kansas City is prepared for it. The delegates and visitors are doing their bit. Thousands are in the halls; thousands are on the outside listening to the proceedings from the megaphones.

The convention hall is large, well suited for a convention of this kind. Delegates are here from every state in the union, the Philippines, Porto Rico, Alaska, Hawaii but none from the Virgin Islands. No placards on the floor display the words "Virgin Islands." I have not been able to find uncle George Woodson who received an offer, accepted and got his credentials to represent the Islands.

Its Hoover of course. That was settled Tuesday when Messrs Mellon and Butler told their state delegations that President Coolidge could not be persuaded to run and that they were supporting Hoover. The Hoover machine is in the saddle and it works with clock-like precision. Secretary Mellon, Senators Butler, Root, Moses, Fess know how to do things on occasions like this which comes from long years of experience.

Like A Musical

There is one thing about a national convention which the home folks don't know and that is 99% of the delegates have nothing to do with running the program. The procedure reminds an observer of a musical. The master of ceremonies announces the participants even the movers of motions. Of course there is a good reason for this. Who would control 1000 delegates running wild in a convention like this?

Iowa should be proud of James W. Hood, Hoover's campaign manager for he has built a splendid machine and has carried his candidate to victory. The first test vote came Wednesday on a contest of the Texas delegation. The national committee had asked the Hoover delegates. The majority report upholding the national committee submitted by the credentials committee to which it had been referred presented by Mrs. Mabel Willbrandt, an able assistance to the attorney general and who hails from California, was carried by a vote of 67 to 3. A minority report was filed, ably defended and while its adoption would have seated additional Negro delegates, Negroes played politics and supported the Hoover machine.

Farmers Wear Badges

There are lots of people here wearing badges "Equality for agriculture", but it means very little except to remind the delegates that the farmers need help which they already know and will take some action about in keeping with the policies of the republican party. Disaffection in the ranks of the farmers does not appear so imminent as it did when I was in Iowa. However Iowa might as well understand that this aid cannot come at the command of men leading our present delegation. A word from God and the powers that be soon

It will not only be a mark against Negroes of Slater, Mo., but a boomerang in the faces of every Negro in the country, who will attempt to speak on similar crimes ordinarily perpetrated in the South by whites.—C. Howard On Ground
 All the big Negroes are here; Perry Howard and Ben Davis national committeemen; Mrs. Williams and Mrs. Boaze, national committeewomen; Oscar DePriest, congressional nominee from Chicago; J. John R. Hawkins and hundreds of lesser light too numerous to mention. Charles Howard has been pretty busy among the gang and has succeeded in landing a place on resolution committee from our group which is asking that the platform committee include an honest-to-goodness plank on the enforcement of civil rights amendments. John Thompson and his son, Nelson are here moving among friends. Negro newspapermen are to be entertained by the press of Kansas City Friday night.

I had to meet DePriest not only because he is the republican nominee for congress but also because as a delegate from his home state he is a real worker, high up in party circles, has real influence and knows the game of politics. You can't beat that combination and I am convinced that he will make a creditable showing in congress.

Wear Frock Coats
 There are lots of Negro delegates from the south entirely too many frock coats. Menden says that they are decreasing at each convention. I hope the day will soon come when there will be none. The average fellow looks upon these Negro delegates as purchasable influence. 'Tis true of some of them; 'tis true of some of the white; but as a matter of fact the southern Negro delegates seek patronage and influence for their friends and some cash in return for the support of a cause the same as a northern white delegate.

The Iowa group reelected Senator Rawson as its national committeeman. A finer thing could not have been done. Senator Rawson is well liked, works well with the powers that be and takes care of his constituents at home. No Iowa has been kept out of the convention if either Senator Rawson or P. R. Baldridge knew about it.

Negroes Play Strong Roles
 While this is my first national convention, I can realize that Negroes are playing stronger roles in the delegations from the northern and border states. It means much.

I cannot close this article without saying a word for Kansas City. There are lots of Negroes here and they are doing big things. It is estimated that more than fifty thousand people were thrilled last week at a local theatre by the golden voice of George Dewey Washington, Negro singer, who holds his audiences spell-bound with his art.

Washington, doubtless, created more racial good-will with his thirty appearances on the stage in the seven days that he was in the city than has been created in a years banqueting and discussing of racial problems by so-called interracial commissions and boards, etc., the members of which so easily forget about the resolutions passed and decisions agreed upon after the meeting has adjourned.

On the other hand, Washington's art is something that will linger for no short length of time in the minds of his hearers. He put his whole soul in his singing, and after the first two notes, the audience quickly forgets that it is a soul encased in black skin, a fact quite well shown in the thunderous applause that he receives.

How plainly Washington's reception shows that in the end ability and ability alone wether it be natural or acquired always eradicates color prejudice. Of course, it is necessary to make some allowances for this statement, especially in Des Moines where Mr. Washington, despite his ability, could not get hotel accommodations.

"There ought not to be—there must not be—there shall not be if I can prevent it a foot of American soil where the people are denied the right of free speech and peaceful assembly." These illustrious words are not quoted from the great emancipator, but from the mouth of Tom Heflin, renowned United States senator from Alabama, champion of race prejudice, anti-catholic propaganda and stool pidgeon of the Ku Klux Klan (defunct). Bravely spoken but not bravely meant, these words just do not fit in with the past record of intolerance that Tom has made. But you can not expect consistency from Tom, that goes only with intelligence.
