NEGRO WEDS BARONESS

Charges Baptist Minister Father Of Her Child

Spartanburg, S. C., March 14.—Claiming that the Rev. J. W. Coleman, pastor of the Majority Baptist church here was the father of her seven weeks old baby boy, Miss Malissa Preston filed a paternity suit against the minister here this week on her return from New York, where she went for her confinement.

Miss Preston, a former teacher in the city schools and a graduate of the Hampton Institute in 1915, declined at first to make any statement when interviewed. Later she is reported to have said:

Doesn't Feel Ashamed

"You see this thing has happened. The child is born. The Rev. Coleman is its father and I am not married to him, but I don't feel so terribly ashamed of myself.

"I am only sore with the Rev. Mr. Coleman for taking advantage of me in the way he did. I can't talk about it to you, but I was justified in going as far as I did with him, for he appeared to be so good and truthful and a minister, too, and I one of his best workers in his church. After having lost my father and mother, in my house there is no one but my niece and myself. I believe his promises and there you are.

Asked Her to Bring Baby Back

"He asked me not to bring the baby back here, but when he refused to look after me further and let it be led away by the police, I took it to the police and I figured that I had better come back and have some kind of an understanding with him.

"My lawyer advised me to have the courts decide on the affair and that is all I have to say."

Lautier Believes DePriest Will be Get in Congress

By Louis Lautier Washington, D. C., March 14.—Inasmuch as there is no opponent contesting the seat of Oscar DePriest, representative-elect from the First congressional district of Illinois, and he has the certificate of election, it is believed in congressional circles that he will be permitted to take his seat when the extra session of the seventy-first Congressional convenes, April 15.

Mr. DePriest, I learned, has been placed on the payroll. William Tyler Page, the clerk of the House, issued a certificate to the sergeant-at-arms authorizing him to place the name of Mr. DePriest on the payroll. Mr. DePriest's action on the fact that Mr. DePriest possesses a certificate of election properly signed.

May Object

It is not unlikely, however, that objections will be offered to the swearing in of Mr. DePriest when the House meets to organize. When the clerk calls the list of members-elect by states to take the oath, it is expected that objection will be raised to his being sworn in.

After the House has been organized, a resolution will probably be offered that the question of his right to be sworn in as well as of his final right to a seat be referred either to the judiciary committee or a special committee. It is predicted that the part of the resolution dealing with his right to be sworn in will be defeated. The vote on that part regarding his right to a seat in the House may be determined by the outcome of trial in Chicago on charges of graft in connection with a primary election there.

Polygamist Starts Precedent

The precedent of denying the oath to a member-elect was established in the house in the case of Brigham H. Roberts, a polygamist, of Utah, in the fifty-sixth Congress. It was followed in the case of Victor L. Berger in the sixty-fifth Congress. It is these precedents that members who will oppose the swearing in and the seating of Mr. DePriest will seek to have the House follow in his case.

President Herbert Hoover issued a proclamation March 7 calling an extra session of the Seventy-first Congress to convene at noon, April 14, for the purpose of enacting legislation to effect further agricultural relief and limited changes in the tariff. Proclamation Includes "All Persons" The proclamation states that "all persons who shall at that time be entitled to act as members thereof are hereby required to take notice."

Mr. DePriest will be the first colored person in 27 years to be a member of Congress. The last one was George Henry White of North Carolina, who was a member of the fifty-sixth Congress.

Des Moines had a representative last year in the person of Miss Anastatia Scott who took the Sectional Contest in Kansas City and placed fifth in the National contest in Chicago. This same opportunity is available to Iowa youth this year. Attorney Chas. P. Howard, has been appointed State Director of this years oratorical contest and has arranged under the direct supervision of the Grand Lodge to hold the state contest in Des Moines, Iowa, at St. Paul A. M. E. Church, April 29, 1929, which will be open to any high school student of the state who had not reached his or her 19th birthday, Feb. 28, 1929.

The contestants are to select one of the following subjects and the orations are limited to 10 or 12 minutes.

Subjects of Orations

- The Constitution and Slavery. The Constitution and Citizenship. The Relation of the Book, "Uncle Tom's Cabin" to the Constitution. Harriet Beecher Stowe and the Constitution. Frederick Douglas and the Constitution. Lincoln and the Constitution. John Marshall and the Constitution. The winner for the state contest will go to the Sectional contest at the winner there to the National contest at Atlantic City, New Jersey, the seat of the convention. Charge Ottumwa Man for Larceny

Ottumwa, Ia., Mar. 15, (INB)—Tex Barber, charged with larceny of furniture from Mrs. Cora Montgomery was bound over to the grand jury under \$1000 bonds by Justice of the Peace J. H. Cremer today. Similar charges against Mrs. Tex Barber had been dismissed by County Attorney E. K. Bekman.

Barber is alleged to have been left in care of the Montgomery home on South Vine street and to have sold the furniture, valued at about \$2000 to the Murray Furniture company, several weeks ago. Barber was arrested several days later at Des Moines and returned to Ottumwa, where he pleaded not guilty to the charges. He was unable to furnish bonds and was sent to the county jail.

Washington, D. C., March 14.—The date of the second trial of Perry W. Howard, Republican national committeeman from Mississippi, and Attorney S. D. Redmond, chairman of the Mississippi state central committee, has been set for March 18 at Meridian, Miss.

Mr. Howard and Mr. Redmond, along with other prominent members of the Republican party in Mississippi, were acquitted of charges of selling federal patronage some time ago in Jackson and it was rumored that the Meridian trial would not be held. According to reports, Mrs. Mabel Willebrandt, a former co-worker of Attorney Howard in the Department of Justice, who conducted the investigations which led to the indictments against the colored lawyers, has demanded that the trial be carried out and that she will do all in her power to secure conviction.

Reports from Mississippi, however, are that Attorneys Howard and Redmond will again be acquitted and this case, like the first one, is considered another attempt to discredit the Negroes as political leaders and to have the federal patronage dispensed by faction of the Republican party, which white folks of the Hawkins-Roland is lily white.

N. Y. May Get Negro in Congress

Conference Held at Association of Trade and Commerce

New York, March 14.—Former Assemblyman Edward A. Johnson was endorsed for the Republican nomination for Congress to fill the vacancy in the Twenty-first Congressional district created through the death of Royal O. Weller, in a conference of Harlem Republicans held on Friday in the Association of Trade and Commerce.

The conference, which was sponsored by the Appomattox Republican Club, considered a number of individuals, and following extended discussion Johnson emerged as the unanimous choice.

Under the law the governor may within thirty days, call a special election to fill the vacancy, such action, however, being discretionary with the chief executive, who if he so elects, may refrain from calling a special election and permit the vacancy to be filled at the next general election. In view of the fact that the Democratic party has carried the district for several years the consensus of opinion is that Governor Roosevelt will call the special election, to be held early in April.

Allen, secretary; Mrs. Roxie Mitchell, vice president; Mrs. Lottie Ware, secretary; and Mrs. Etha Ellis, treasurer.

Minnesotan Weds Amid Splendor

Budapest, Hungary, March 15.—Amid the pomp and splendor of old romance, John S. Sutherland, handsome young scholar of Minneapolis, Minn., U. S. A., was married to Baroness Edith von Greiner, beautiful daughter of Baron von Greiner, a wealthy statesman. The family is one of the oldest and most aristocratic in Hungary.

The colorful ceremony in which every means to reflect beauty of the occasion was employed took place in a fashionable church near the Von Greiner estate. Officiating with the bishop were other high church dignitaries of the Episcopal denomination. The bride was regal in a court costume of white velvet and her jewels were diamonds and pearls. She was attended by Marquise Sylvania Phillippe, her close friend. The ring bearers were little Andre and Sandor, children of Baron and Baroness von Keleher, who were fairly like in their costumes of silver and gold. The best man was the Austrian writer Anton Sutter, who has been the friend and sponsor of the young American since his arrival.

Received by Nobility

At the brilliant reception which followed the bride's parents introduced their new son-in-law to many of the titled families of the capital. The couple was accompanied as far as Paris by Von Sutter, who arranged many entertaining features in their honor.

The romance of the titled beauty and the clever cultured American attracted much attention, which grew sympathetic as rumors of parental interference became known. At first her family refused to see Sutherland, holding that the baroness should wed one of her own station and color. It was after she tried to commit suicide with an overdose of veronal that they agreed to meet her suitor. When they found him to be a gentleman of breeding and attainment they agreed to the union and immediately began plans for the wedding.

Sutherland Lectures

The young lovers met at a tea given by one of the prominent families of Budapest. Sutherland appeared in a lecture-recital and made such an impression that the two became inseparable from that time.

Believe Boyd Going Insane

Ft. Madison, Iowa, March 12 (INS)—William Boyd, convicted murder of Dewey Marshall, Polk county deputy sheriff, has been declared insane by prison doctors.

Slashing his neck and arms with a razor-coupled with his desire for inflicting other bodily injuries upon himself, caused the warden to question his mentality.

Boyd has been placed in a cell by himself where he will receive treatment and his only exercise will be walks around the prison yards.

Boyd killed deputy sheriff Marshall, when the latter, in company with other officers, went to the Boyd home near Mitchellville to arrest him on a bad check charge.

After the killing Boyd escaped and for several days officials conducted one of the most intensive man-hunts in the county's history. The prisoner finally surrendered through his attorney, Charles P. Howard.

Hold Rites For Wife Of Bishop Brook

Atty. S. Joe Brown, who was Iowa's only delegate to the General Conference of African Methodism at Chicago last year, is in receipt of the following:

San Antonio Texas, March 13th, 1929.

Wife died this afternoon at five o'clock. Funeral at twelve o'clock Monday noon at Bethel A. M. E. Church Baltimore, Md. Inform friends. Signed Bishop Brooks.

Des Moines people in general and especially those of the African Methodist connection are especially interested in Bishop Brooks and his wife for the reason that one of the last churches served by them before his elevation to the bishopric in 1920 was St. Paul A. M. E. Church of this city, the Missionary Society of which is named for him.

Immediately upon his election he was assigned as Bishop of West Africa to which place his devoted wife Mrs. Susie Brooks accompanied him, and remaining in that very hot climate for eight consecutive years, during which time she assisted him materially in his erection of Monrovia College and Industrial School, the first (\$1000) one thousand dollars for which were contributed by the members and friends of the Des Moines Church.

This African service completely wrecked the health of Mrs. Brooks who took down with the dreaded African fever and for a time it was feared that she would not live to return to America; but she recovered sufficiently to return with her husband when he came back to attend the General Conference at Chicago last May; and, largely on account of her health Bishop Brooks was transferred from the African field to the district including Texas where he was presented with a palatial residence at 908 Dawson St. San Antonio, Texas, from which she passed to her reward on Wednesday afternoon. She will be buried from Bethel A. M. E. Church Baltimore, Md., which was the church in which she and her husband were laboring when he was selected Bishop in May, 1920.

UP TO CONGRESS

A recent dispatch says that the legislature of the state of Wisconsin has passed a resolution asking congress to appropriate as much money for the enforcement of the fourteenth amendment to the constitution of the United States as it has appropriated for the enforcement of the eighteenth amendment.

Some will say that Wisconsin has done this simply because it is not in sympathy with the eighteenth amendment and has therefore asked congress to appropriate money for the enforcement of the fourteenth amendment to embarrass it, if such a thing can be done.

The trouble with us is that we have elected to obey those laws only which meet our approval—a thing which has gotten us into an inconsistent position.

A person not familiar with the amendment might question for what purpose this money should be spent. We quote this portion for their benefit:

nor shall any state deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

The Negro in America

The little straws gliding around around usually give the direction of the wind. For the first time since Theodore Roosevelt's administration colored citizens have received social courtesies from the White House, two colored committeewomen, Mrs. Mary Booze from Mississippi and Mrs. George Williams from Georgia accompanied by Mrs. Booze's father, attended the brilliant reception at the White House immediately after the inaugural parade.

President Hoover's body guard was composed of members of the National army in alternate ranks, colored and white, which expresses better than words that the new commander in chief of the army so regards the national defense. These indications on the part of president Hoover mean more to the black citizens of America than an entire inaugural address on the race problem.

The 70th Congress passed the joint resolution to create a commission to assure plans and designs for and to erect a memorial building as a tribute to the Negro's contribution to American achievement at a cost of \$500,000. Mr. Thomas J. Calloway, secretary of the interracial commission for Maryland, a body created by law, informed us that a measure to repeal the "Jim Crow" regulation upon common carriers will be introduced at the next meeting of its legislature. This statute failed by one vote at the last legislative session and it is reported that the gentlemen who blocked its passage is now for the measure.
