Reverse Conviction of Arkansas Child Murderer

AGAIN REVERSE MURDER CONVICTION OF ROBERT BELL, ARKANSAS BOY

New York, Oct. 17.—The Arkansas Supreme Court has for the second time reversed the case of Robert Bell Swain, who with Grady Swain has twice been convicted and sentenced first to death, then to life imprisonment for the alleged murder by drowning of two white boys.

W. J. Lanier, white attorney, who has defended the boys and is convinced of their innocence, informs the N. A. A. C. P. that the two friendly and helpless colored boys face a third trial. The N. A. A. C. P. to date has expended \$1,240.00 in keeping these two boys from the electric chair and prison. In his letter to the N. A. A. C. P., Mr. Lanier writes:

"The reversal was great victory for justice. I feel that every thing which could have been done for this boy has been done—nothing left undone which could have been done. . . . It took four days and nights to try the case which as you know resulted in verdict of murder in the first degree with life sentence. Grady Swain is in the same situation of the Bell boy. His trial will also come up at the same time as that of Robert Bell. . . . I believe if the proper attention is given to these two little boys' cases we will be able the next time to clear them, but I must be up and doing. . . . I have paid out of my own pocket considerable sums during the last trial."

Fourteen Circuit Judges To Sit on Bess Case

New York, Oct. 17.—All fourteen Circuit Judges of the State of South Carolina have been called to sit upon the case of Ben Bess, colored farmer who has served thirteen years of a 30-year sentence on a white woman's perjured testimony.

This information comes to the N. A. A. C. P. from N. J. Frederick, colored attorney of Columbia, S. C., in charge of the case, who writes: "So important are the questions raised in the Ben Bess case that an En Banc session has been called for Saturday morning next at 10 o'clock. This means that all of the Circuit Judges of the State (14) have been called to sit with the Supreme Court to hear and determine this case. "Of course we are hoping that we will be able to show them that Ben Bess ought not even now be in prison. I will let your office know the result." The N. A. A. C. P. has contributed \$300.00 to date toward the expenses of this long and persistent legal battle for the freedom of this unjustly convicted South Carolina farmer."

RALPH BAKER LEAVES HOSPITAL; GOES HOME UNDER BAIL

New York, Oct. 17.—Ralph Baker, Lincoln University student shot by a police officer in Brooklyn on September 9th, has left the hospital and has been released to go to his home, under bail, according to announcement today by the N. A. A. C. P. Mr. Baker and his fellow student, Mr. Fontaine, are charged with disorderly conduct. The patrolman, who it is charged by the boys and by witnesses, gathered by the N. A. A. C. P., fired on an innocent person, has been summoned to appear in court on Oct. 21. William T. Andrews, Special Legal Assistant, is representing the N. A. A. C. P. in the case.

Dr. Moton Will Address Historical Group

Dr. R. R. Moton of Tuskegee Institute will deliver an address at the annual meeting of the Association for the Study of Negro Life and History to be held in Washington, D. C., from the 27th to the 31st of this month. His theme will be the present economic situation of the Negro. This address will be the keynote of the session devoted to the discussion of the "Negro as a Business Man." The institution which he heads and the Business League have always manifested interest in this important aspect of the development of the Negro. Tuskegee itself is an evidence of the business ability of the Negro.

On the same program will appear others who will discuss various aspects of the question. Mr. John R. Hawkins, president of the Prudential Bank, will speak on the Negro in business compared with the Chinaman. Mr. John E. Nail of New York City will discuss the Negro business man compared with the Jew. While these addresses will be historical they will at the same time enlighten the public on the situation of today.

WORSHIPPERS IGNORE KLANSMEN

New York City, Oct. 17.—(By A. N. P.)—Unnoticed, unheralded and unsung, twenty-five members of the Ku Klux Klan attended the services at the St. Matthews Protestant Episcopal Church, Sunday, to aid the rector, Rev. William St. John Blackshear, uphold his declaration in favor of "Jim Crow Christianity."

The "apostle of Jim Crow Christianity," who hails from Texas, a hotbed for Kluxism, however, stated that he did not know the Klansmen were in the audience until informed by them after the services were over.

If the purpose of the Kluxers was to keep Negroes away, their object was not attained. This might have been due to the fact that the "protectors" became so enthusiastic over the preaching of the "protected" they forgot to look around to see if there were any Negroes present.

Mrs. Allie Turner was born in Columbus, Kans. April 17, 1881, and departed this life Oct. 6, 1929 at 10 A. M. She was reared in Kansas City, Mo., and converted 31 years ago and joined her membership with the Second Baptist Church, Rev. Bacott pastor. She came to Iowa 20 years ago making her residence in Enterprise and later moved to Des Moines where she joined the Corinthian Baptist Church. She was married to Rev. C. W. Turner, December 15, 1920.

She leaves to mourn her loss a devoted husband, Rev. Turner, a sister Mrs. Lena Bratcher of Omaha, Neb., a cousin, Mr. James Wilson, also of Omaha, Neb., and a host of friends. She was a member of Mt. Zion Baptist Church and a devout christian always willing to do anything worth while she could. Fraternal services were held at Rebecca Tabernacle and Court of Calanthe. Funeral services were conducted at Corinthian Baptist Church, Thursday, October 10, Rev. G. W. Robinson officiated.

Washington, D. C., Oct. 17.—(C. N. S.)—Aroused over the proposed marriage of Miss Edith Margaret Oedelshoff, white, to Phil Edwards, dusky athletic star of New York University and captain of the track team, which was scheduled to take place in New York City, Thursday, Freeport Klan No. 10, of the Knights and Ladies of the Ku Klux Klan, Incorporated, of New York State, is seeking to outlaw mixed marriages in New York State.

A resolution adopted at their meeting on October 9, has been sent to state senators and assemblymen in an effort to stir them up to action against a "growing evil."

Coming as the sixth of a series of interracial marriages between colored and white women of reputable families, during the past few months, the recent marriage completely outraged the sensibilities of the klansmen.

The luncheon was given by the English Speaking Union, of which Miss Gardner is a member, in co-operation with several other organizations. In the course of his address at the luncheon the premier urged these groups to work for peace between nations, which also implies between racial groups.

NEWARK CLERGYMAN IN SERMON DENOUNCES RACIAL COLORED LINE

New York, Oct. 17.—One of the numerous outgrowths of the recent "discouraging" of Negroes from joining the Protestant Episcopal Church of St. Matthew, was a recent Sunday meeting in the church of the Redeemer, Newark, N. J., at which the pastor, Rev. L. Hamilton Garner denounced the color line.

He urged upon his hearers that they familiarize themselves with the work of organizations devoted to bettering race relations.

NEW WAR ON RACE DISCRIMINATION IN CERTAIN RESIDENTIAL SECTIONS LOGGED

Detroit, Oct. 17.—(Special)—Colored citizens of Detroit are greatly aroused over the bombing of the nine-family apartment house occupied by Negroes, at 10334 Charlevoix Avenue, corner of Garland Avenue. The bombing occurred Thursday evening shortly after 8:30 o'clock and drove more than a score of the tenants into the street and shattered windows throughout the neighborhood.

Two rather strange coincidences are connected with the bombing. First, the bombing occurred directly across the street from the home of Dr. Ossian H. Sweet, who during 1925 and 1926 was the central figure in a race riot in which one white man was killed. The Sweet case assumed national interest and Clarence Darrow, famed jurist of Chicago, was detailed by the National Association for the Advancement of Colored People to defend Dr. Sweet, and he, as well as those charged with him, were acquitted. Second, the other puzzling coincidence is the fact that the bombing came just after the close of the most bitter contest for mayor ever staged in Detroit, and some are ascribing the act to political reasons. Dr. Sweet took a very active part in the present campaign on behalf of former Mayor John W. Smith, and was instrumental in creating great sentiment among race voters for the former mayor. It is expected that a sweeping investigation will be made promptly for political purposes and expediency.

The building was taken over by Negro tenants last August and no threats had been made. The bomb consisted of several sticks of dynamite placed in a glass container, and the explosion occurred in the rear court of the building. Approximately \$2,000 damage was done to the building. The tenants are determined to "stand their ground" and demand proper protection as law-abiding citizens. No further disturbance is anticipated, as the attitude of Detroit Negroes in previous cases has been to answer "fire with fire."

GORDON H. KITCHEN IS DELEGATE TO NATIONAL Y.M.C.A. CONFERENCE OF COLORED WORK

Local "Y" Secretary Represents Des Moines in Chicago

Gordon H. Kitchen, executive secretary of the Crocker Street Department of the Y.M.C.A. left Wednesday evening for Chicago, where he will represent Des Moines at the National Conference of Colored Work to be held in Chicago, at the Wabash Avenue Department, October 18-21.

There will be some five hundred leading Y.M.C.A. men from all over America attending the Conference. Such speakers as Dr. R. R. Moton of Tuskegee Institution; John Hope of Morehouse College; Congressman DePriest; Mrs. Max Yergan, South Africa; C. H. Tobias of the National Council and Julius Rosenwald of Chicago will be among the speakers on the program.

The following themes will be discussed: Services of National and State Agencies to Local Associations; Extent and Quality of Local Association Programs; Occupying the Unoccupied Fields; and the World-Wide Outreach of Colored Associations.

The local program of the Crocker Street "Y" will be enlarged on the return of Mr. Kitchen from Chicago.

U of Minnesota Takes Down Color Bar

New York, Oct. 17.—The Twin City Herald, published in Minneapolis and St. Paul, Minn., reports a complete victory against the color bar in Minnesota University, won for a colored student, Miss Frances McHie, by the N. A. A. C. P.

The case arose when Miss McHie's application for entry to the nurse training course in the university was refused because of her color, the university claiming it only sought to spare Miss McHie because of the embarrassment she would meet as a colored student.

When the matter came to the attention of the local N. A. A. C. P., Senator S. A. Stockwell, a member of the branch executive committee, interested George B. Leonard, one of the ablest lawyers in the state. Mr. Leonard called a conference of N. A. A. C. P. officers, where it was decided to fight the exclusion. Application for her admission was prepared together court, should suit become necessary. The result was that the university conceded the legal right of all citizens with briefs for submission to the state to enjoy its privileges. Miss McHie entered the course on October 3, and is now on her way to become a trained nurse.

"Preacher" Killed in Police Raid

Chicago, Oct. 17.—(A. N. P.)—In a battle with a raiding squad, Rev. Reyo H. Mayweather was shot and killed here Saturday night at his home. He fell a victim of the "shoot to kill" policy of the Chicago police.

According to police reports, a police squad, headed by Sergeant James Fitzgerald went to Mayweather's home at 4752 Federal Street to investigate charges that earlier in the day Mayweather had attacked a bailiff who was attempting to serve a writ of replevin on his furniture. When the officers entered Mayweather picked up a flat-iron and hurled it with deadly aim, striking Sergeant Fitzgerald in the face and breaking his nose.

Seeing their leader felled, the others opened fire on Mayweather, who was seeking to escape through a window armed with an axe. The volley of shots stopped Mayweather who fell back into the room dead.

While claiming that he was a minister, his wife could not tell officers just what church he pastored or what denomination he represented.

TWO A. M. E. CONFERENCE TO JOIN FORCES AT DAYTON

Wayton, Ohio, Oct. 17.—Merger of two of the three conferences of the A. M. E. church in this state will take place in Dayton, when ministers and lay delegates of the Ohio and South Ohio conferences meet in Wayman A. M. E. Church Tuesday. It was announced Wednesday.

The meeting will bring some 300 of the outstanding church ministers and members of the denomination to Dayton. The other conference, the North Ohio, will not be disturbed in the merger, which is being consummated because of being able to better handle the affairs of the church in so doing.

Rev. J. E. Williams, pastor of the Wayman A. M. E. Church, states that among the outstanding ministers from various sections of the state of Ohio and Pennsylvania in attendance will be three bishops of the church.

POOR REPRESENTATION AT THE STATE HOUSE

When a citizen puts in a lot of time helping candidates get elected, he feels that some results should come as a reward for his work. This result is evidenced by getting some of the spoils.

The Bystander desires to call attention to our state offices where the head of every department is a republican and all of whom made a bid for the Negro vote. There are five men who have jobs worth some consideration; three under the executive council, one with the superintendent of public instruction, and the governor's messenger.

The secretary of state has dozens of employes, none of whom are Negroes; the state treasurer the same; the board of control the same, auditor and the health department and the secretary of agriculture. It is common knowledge that application has been made for jobs by competent Negroes in some of these departments, but the applications went to the waste basket.

Other states are giving competent Negroes representation, but Iowa lags behind. A campaign will be started soon and it is the time to begin lining up with candidates who have the inclination to keep up with other progressive communities where Negroes are getting jobs, in spite of their color, in keeping with their training and experience.

LABOR ORGANIZATION

The American Federation of Labor announced recently that it is planning a campaign to organize labor in the south. It has met little success in the south in the past because that part of the country has not built up large industries where large groups of labor has been assembled in single communities. Then, too, the Negro has been the backbone of southern labor and the Federation has not felt inclined to organize Negro labor.

However, the south is growing industrially and, of course, its labor troubles are multiplying. In the cotton mill districts of North Carolina where a great deal has been heard about strike riots followed by murder of workers and peace officers, the trial of several workers charged with the murder of the chief of police is in progress now. These strikes have been conducted by the International Textile Union, a branch of the radical International Labor Union. The latter organization has been organizing the southern workers in many communities. It has for one of its object equality of all workers, black or white. Some witnesses so expressed themselves in their testimony in open court.

Negroes are poor followers of radicalism and rightly so. Yet, it is easy to see how any organization of white and colored people advocating a thing which Negroes all over the world are fighting for, will make a strong appeal. They know the American Federation has not given them protection even in the unions, where they have been accepted. It will be interesting to watch the two organizations.

The Negro in America

There is a new horizon for the American Negro. The trend of this new era has been developing for the last decade. The intelligent Negro realizes that it is incumbent upon him to make and develop his own opportunities. In his spiritual or religious pursuits the Negro has created and developed a Christian society that ranks with and has the respects of every other similar institutions. Many of our clergy rank with the best of any other race or nation. We are ashamed of those of our race who present that inferior complex by their continuous efforts to get away from their own.

Why do intelligent Negroes in communities where there are race churches of their own faith and belief persist in attending and clamoring for membership in white churches is beyond me.

The world puts the same estimate on you that you put upon yourself. "As a man thinketh in his heart, so is he." If we as Negroes think that anything white is superior to anything black, the rest of mankind will think so. We had just as well stop kidding ourselves about being indistinguishable from the rest. That church affair in New York where those Negroes were told to go to their own churches has done us more harm than we may realize at first inspection. The first thing the other fellow thinks is, that we are ashamed of our own. We as a race will be placed at the tail end of the procession so long as we feel that we are not as good under our own leadership as we are under that of the other fellow.

Weekly Health Talk

RHEUMATISM

From what has been observed it seems that most of the rheumatism complained of begins in the tonsils. Excluding the teeth and the cavities in the head called sinusitis the tonsils may be said to be the greatest cause for rheumatism, causing more cases than the other two put together. The necessity for their treatment or removal is plain and becomes more necessary when the increasing incidence of heart disease from this cause is demonstrated. The term rheumatism embraces a variety of affections with any degree of discomfort up to pain, mild, moderate or severe, presenting weather variations, being more severe in damp or cold weather when chronic in nature. Usually not much significance is attached to it as the whole trouble is blamed on the weather. Rheumatism of the kind involving the joints is very liable to be severe once begun and should be taken care of early before there is irreparable change in the joint causing it to become stiffened and so remain. A beginning soreness in any joint, the knee, shoulder, elbow, ankle, spine, hip, wrist, joints of the hand or foot, or those between the ribs and the chest bone has a beginning usually in the tonsils, teeth, or sinuses but may proceed from some other cause as there are many more possibilities. If the treatment is disregarded because the joint affection is trifling whatever its nature or extent is mild, the possibility of a heart affection, however remote, should call protective forces into action to prevent this remote possibility from becoming an actual fact.



Aliens Must Be Citizens or Pay U. S. Tax

Portland, Ore., Oct. 11.—A bill to compel foreigners to become citizens or pay an occupational tax will be proposed to G. O. P. leaders by Congressman Oscar DePriest when he returns to Congress.

Speaking here to a large audience in Lincoln High School auditorium, which he addressed as "brothers and sisters," Mr. DePriest said: "As I go about over the country, I see so many men doing the work you used to do, men who are not citizens—men who will not defend our government in the time of war."

"I shall take up with the Republican leaders in Congress the question of introducing a bill requiring every foreigner to pay an occupational tax unless he declares—within a five year period—intention of becoming a citizen. No man or woman has the right to come to America earn a living, educate his children in our public schools and not assume the responsibility of citizenship."

West Indians-Chinese
"No Chinese, Japanese, Italians, Swedes, Norwegians, West Indians should stay in our country and not assume the responsibility of supporting our government."

"During the world war there were hundreds of thousands of them who could not be sent over there because they were not American citizens."
"You have your alien land laws out here on the coast which afford some protection, but there are thousands of American citizens unemployed where the non-citizens are employed."

New York, Oct. 4.—Miss Mary White Ovington, Chairman of the Board of Directors of the N. A. A. C. P. is one of the contributors representing various organizations who have written chapters in "The Amazing Benjamin Franklin", a book published under the auspices of the Philadelphia Chapter of the Sons of the American Revolution.

The book is published by Frederick A. Stokes Company in New York City.

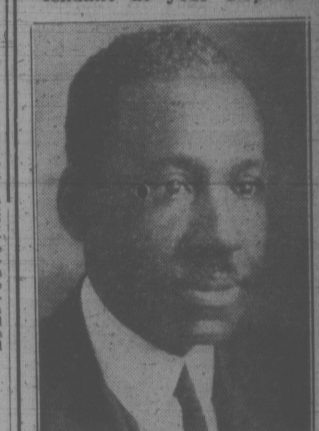
