Hold Open House New Year's Day



During the afternoon and evening of New Year's Day, about 500 visitors of both races were ushered through his newly remodeled establishment by Mr. Tug W. Wilson, president and manager of the Wilson Funeral Home at 811 West 14th St. Each visitor upon arrival was met at the door by Mr. Wilson or one of his courteous assistants and requested to register in the reception room. They were conducted first into the family room, which is screened off from the chapel, so that the immediate family may have privacy and at the same time hear the services being conducted in the chapel, which is equipped with an invisible loud speaker electrically attached to an unseen victrola upon which are played the choicest of sacred songs at appropriate times during the services.

Funeral Prices Lowged

Throughout the family room and the chapel were on display all styles of caskets ranging from that for an infant to full couch brocade plush and steel caskets ranging in price from \$90 to \$500 with each of which the attendant explained Mr. Wilson is furnishing a complete funeral including embalming, grave, hearse, pallbearers' coach, and family car without extra charge.

After having inspected the caskets, the visitors were ushered through Mr. Wilson's private office and the operating room all of which are newly equipped with the most modern appliances.

After having inspected the entire business plant on the first floor, the

visitors were conducted upstairs where they were permitted to inspect the living quarters consisting of reception room, two bed rooms, bath room, kitchenette and dining room in the latter of which they were received by Mrs. Wilson and served to light refreshments and presented with a handsome New Year greeting in the form of a calendar bearing a portrait in colors of Abraham Lincoln and four beautiful Negro children. Tennis Ass'n Hits Barring of Negroes

New York, Dec. 31—Arthur E. Francis, president of the New York Tennis association, which is affiliated with the American Tennis Association has written a letter backing up the protest made by the N. A. A. C. P. against the barring of two young colored tennis stars from the National Junior Indoor Tournament.

The letter of Mr. Francis, copy of which he sent the N. A. A. C. P., is addressed to Edward B. Moss, Executive Secretary of the U. S. Lawn Tennis Association, and characterizes the barring as "un-American, un-sportsmanlike, narrow-minded, and shortsighted," and says it will bring down just and long-continued protest on that body.

Mr. Francis states that Reginald Weir, one of the young men barred is considered potential Davis Cup team material by both the American and French Davis Cup team coaches.

"I am and the country is shocked at your recent action in barring these two young Negro players," writes Mr. Francis to the U. S. Lawn Tennis Association, "and can only say to you in the words of the late Booker T. Washington, 'the only way to keep the Negro down is to stay down with him.'"

Other letters and messages endorsing the N. A. A. C. P. protest are being received, among them one from Sydney Strong, at the Hotel Wolcott, who says he is also writing in protest to the U. S. Lawn Tennis Association.

Hold Memorial for President of Nat'l NAACP

The Des Moines Branch of the N. A. A. C. P. held a memorial for Judge Morefield Storey, the first and only president of the National Association, at Corinthian Baptist church Wednesday evening, Jan. 1. Heretofore, it has been the custom to celebrate the ation by Abraham Lincoln, but since Judge Storey had been so closely identified with the National Association and its work since its beginning, the memorial was very appropriate.

The meeting opened by singing "Life Every Voice", the official hymn of the N. A. A. C. P. and the invocation by Rev. H. L. Overton. The first speaker, Atty. S. J. Brown, one of the founders and the first president of the Des Moines Branch, gave a brief history of the life of Judge Storey with particular reference to his service with the N. A. A. C. P. and cited several cases which had been won before the supreme court greatly through his efforts.

Attorney Howard J. Clark spoke of Judge Storey as a member of the American bar. Mr. Clark pointed out that Judge Storey, independent of the necessity of practicing law to win his livelihood, devoted his talent to raising the level of the masses of a race which needed his help, adding that when he made his appearance in the court listened to Judge Storey with close attention for they realized that these appearances were not for personal gain or property rights but he was seeking an interpretation of the fundamental law of the land affecting human rights.

Mr. Harvey Ingham spoke of Judge Storey as a humanitarian emphasizing that this particular trait actuated Judge Storey in all of his activities in behalf of the Negro. Congressman L. J. Dickinson delivered a short address in which he praised Congressman DePriest with whom he is serving in the house of representatives and said that Mr. DePriest was fully capable and was taking care of his

Boycott Hotel Refusing to Admit Race Delegates

Alice Says Battle Just Beginning

New Rochelle, N. Y., Jan. 3.—With advice from Las Vegas, Nev., that Leonard Kip Rhinelander, member of a wealthy New York family, had obtained a decree divorcing his wife, Mrs. Alice Jones Rhinelander, daughter of a New Rochelle coachman, counsel for Mrs. Rhinelander declare that the court battles between Kip and his wife are just beginning.

Counsel for Mrs. Rhinelander said that he plans to go into court this week and file his client's delayed suit for separation from Kip Rhinelander. Mrs. Rhinelander will charge desertion and cruelty.

William D. Cunningham, representing Mrs. Rhinelander, says he has just received from Reno, Nev., two affidavits which tend to show that Kip had a Nevada residence and representations in his suit which his client will contest.

It is understood that Mrs. Rhinelander will not ask any specific amount of alimony. She will, however, request the court to fix a reasonable amount to provide necessities for the \$200 a month allowed during the pendency of the annulment action.

Mrs. Rhinelander did not seem the least bit concerned about the divorce obtained by her husband. She also added that no matter what legal action her husband had taken in the Nevada city, her property rights in New York would not suffer.

Word from Las Vegas, Nev., says that Kip Rhinelander is a "happy man" since he won his final decree as a result of the third suit he had filed against Mrs. Rhinelander. Circuit Judge William E. Orr was on the bench when the seion of a wealthy New York family was granted his decree. His wife was not represented in court. Harlem Harmon, personal attorney for Rhinelander, was the only attorney appearing at the brief hearing.

Rhinelander alleged mental cruelty and was the principal witness in the unfurled hearing.

"I am a Neveadan now," Kip said. "I came West to get a divorce and I am staying to grow up with the country. When the great Boulder dam is built I hope to have the privilege of playing my part in that work."

Other witnesses testified that Rhinelander had resided in the state. Following the hearing Judge Orr ordered the decree entered.

Alice Jones, daughter of a New Rochelle cabman worked as maid in the Rhinelander home. There she met Kip and they were married Oct. 14, 1924. No official announcement was made for a month. When the facts became known the young heir of the Rhinelander family left the home of his bride's parents and went into seclusion. Objection to her by his family on the basis of her color resulted in the filing of an annulment action in Westchester supreme court in 1924.

After the trial, which provided something of a sensation, the annulment action was decided against the Rhinelanders.

Subsequently Leonard Kip dropped out of sight, first going to New Mexico and later taking up residence in Nevada. His wife continued to live in New Rochelle.

Music was furnished by a trio consisting of Misses Mildred Young and Clara Webb and Mr. Salee. Rev. G. W. Robinson gave the benediction. Atty. James B. Morris presided.

Fails to Pass, Parham May Be Suspended Yet

New York, Jan. 3.—Failure to pass the regular December test in mathematics may result in the suspension of Alonzo S. Parham, the only member of his race in attendance at the United States Military academy, it became known this week.

Parham was required to take a second test last Thursday, the result of which will not be known until the return of Maj. Gen. William B. Smith, superintendent of the academy, who is with Army football team on the West coast.

Parham was one of the 54 to flunk in mathematics. If he failed in the second test his case will be referred to the academic board, which has the power to suspend him for 60 days, when he may apply for a last examination. Should he fail for the third time he automatically becomes ineligible and could be reinstated only by another appointment.

The appointment of Parham by Congressman Oscar DePriest was one of the solon's first official acts, and caused widespread comment throughout the country. The Chicago boy has been the subject of discussion ever since he entered the West Point school. Various stories have been told relative to his treatment by officers and other cadets. Mr. DePriest made a personal trip to the academy to visit his protegee in order to learn first hand the true status of the situation. After his return the congressman denied that Parham was being mistreated by school officials. It was also brought out that no special consideration was shown him because of his race. On occasions he had asked for special instruction in his weak subject and in accordance with the practice at the school his requests were granted.

Pittsburgh, Pa., Jan. 4.—Three hundred and twenty-eight delegates who attended the opening session on Sunday of the fourth national convention marched in a body, together with hundreds of Pittsburgh workers, to demonstrate against the Monongahela Hotel which refused admission to Negro delegates.

A police squad was lined up at the door of the hotel, but the workers entered and filled the lobby. Five hundred voices demand the registration of the Negro delegates and no discrimination against Negroes.

The clerk, guarded by police behind the desk refused. A strong protest demonstration followed. J. Louis Engdahl, national secretary of the International Labor Defense, mounted a chair and introduced as speakers Frank, Negro member of the workers' jury in Gastonia; Harold Williams, of the American Negro Labor Congress; Pat Devine, district organizer of the Communist Party; Robert Minor, editor of the Daily Worker; Fred Beal, one of the Gastonia defendants, and Ella Reeve Bloor.

The demonstration lasted for one hour in the lobby. Ringing cheers greeted the demands for Negro equality, the International Labor Defense, the Communist Party and the Communist International.

Pat Devine called for applications for memberships in the Communist party. Many workers joined the party. The workers then sang the International and displayed their protest banners. Five hundred demonstrators then left the hotel and marched in a solid body back to the convention singing revolutionary songs.

Iowa City, Jan. 3.—Fellowship, loyalty and reverence were combined in the motive for the formation of an organization called the Carey Social Center here, according to the Rev. E. L. Fuller, its founder.

Although the Center is composed of fraternity, non-fraternity and sorority members, the spirit displayed from its beginning up to the present is indeed one of service to the Negro students on the campus of the State University of Iowa.

Louis B. White, a student at the University and president of the organization sets forth its purpose as aiming for better co-operation among the Negro students, thus making it possible for many students to attend school who would not be able to do so otherwise. The president expects the organization to be a monument to the African Methodist Episcopal church at large.

Dudley Black, a Des Moines boy, who is secretary-treasurer of the Center has been one of the most active members according to the Rev. Mr. Fuller. Mack Wilson and Henry Johnson, both students at the university and from Des Moines are interested in the project.

National Office with the company's district office in Wilkes-Barre, as a result of which Mr. Brown received the following letter:

"Your letter of Nov. 4th written to our New York office has been turned over to the Wilkes-Barre office for investigation. We have taken steps to have a thorough investigation made at that point by our traveling superintendent. Since receiving your letter, we have changed the management of the Food Department in the Altoona store. The man who was responsible for this condition is no more in our employ."

The United States Tennis Association announces that it will bar Negroes from the National Junior Inoor Tennis Tournament. Brisbane says it will not be a national meet if Negroes are to be barred. That is true and yet there are hundreds of other "national" organizations carrying the name but who forfeit the right to it by prejudice such as this association tolerates.

The N. A. A. C. P. meeting was poorly attended Wednesday night. Many of our leaders were conspicuously absent and yet this was a very important occasion, a meeting in memory of a man who was a leader of men and who headed an organization which is a leading movement among the Negro people. If the leadership does not rally to this and other movements of like nature, then it is a pity that these leaders pose as such for they handicap the substantial average man who chooses these leaders as guides.

POLITICS IN 1930

Nineteen Hundred Thirty is here. The political pot is boiling. Many of these fellows whose friends have been urging them to run for this or that office are announcing that the urge is being heeded. Some of this urging comes from friends, some are echoes from the candidates themselves. Some of these fellows whom you have not seen for two or more years are coming around and reminding you that "we were boys together" or "I knew you when you were junior" in the apartment where I once lived" and are expecting your support and that of your friends on that basis.

We suffer more from lack of jobs or the lack of jobs some what in keeping with the training of individual applicants here than anything else. It is bad enough when Negroes have a difficult time securing places in privately owned institutions, but when it is realized that we don't have three jobs in the state house worth scrapping for, two in the court house and four in the city hall, one naturally wonders on what basis did these office holders get the support of the Negro constituency.

Iowa is overwhelmingly republican. In all state and most county offices nomination is equivalent to election. Now is the time to scrap this proposition out with candidates for the nomination to these places. It will do no good next fall.

The Bystander believes every candidate should be interrogated on the question of giving Negroes jobs. Of course many will attempt to hide behind the statute which forbids candidates from making pledges to give any body a job, but don't let them bluff you. They do it every day and it works.

Heretofore, we have had some kind of an organization to go after these things. They made mistakes of course, but in spite of these mistakes we got more years than when we had no organization. Don't get excited about the money. Some white, white and black. If something, now is the

The Negro in America

We went to see Porgy, the folk play and thought it was great. We also read the criticism of the play published in the Tribune of Thursday, the 26th. Of course everyone has a perfect right to express his opinion, so we take this opportunity to give you ours.

Any play true to life and gripping in every mood of life that it attempts to portray is worthy of the highest praise. The way to judge a play is to understand what the actors are trying to present and knowing that you can better judge the merits. It is not a question of what we think they should be doing but how well they did that which they were assigned to do. To censure an ignorant person for using the nominative case instead of the objective or the possessive has no place in the discussion. To censure Crown, the stevedore, for saying "spirited" is rather far fetched criticism. In the synopsis it tells you "Place, Charleston, S. C., Time, present." Therefore he was, perfectly within his rights to use any modern word to express himself that he was capable of mastering.

It is not necessary to be familiar with Catfish Row in Charleston, S. C., to verify the facts; Many of them are demonstrated on Center street and other places today and there was nothing overdrawn or omitted—wit, humor, pathos, tragedy, faith, superstition, sentiment, emotion, laughter and tears.

You cannot see Porgy and not be entertained. That is the prime object of the theatre. Porgy is the great success that it is because it fills the bill.

Porgy is the first Negro drama with an all Negro cast to ever get out of New York and survive. The people who build theatres and pay actors to fill them are going to produce such plays as the public is willing to pay for, and until the intelligentsia provide a means by which our talented actors can procure a livelihood their criticism of them is unkind, untimely and ill put.

The Porgy players are proud of their play because it has demonstrated to the world that Negro drama by Negroes is possible. All Negroes should be proud of it because it has opened up an avenue for Negro talent. We are grateful to the Theatre Guild, Inc., and thankful to him who doth all things well. Greater things than this will come because of the successful showing of Porgy.

This we believe is the true sentiment of thoughtful Negroes.

N. A. A. C. P. ACTS TO PROTECT JAMAICA RESIDENT MENACED BY MOB

New York, Dec. 25—Two representatives of the N. A. A. C. P., William T. Andrews, Long Island, branch will confer with T. S. Edwards of Jamaica, whose windows have been smashed, shrubbery about his house torn up, and threats made against him and his family's safety in an effort to drive him from his newly purchased residence. The conference is to be held for the purpose of taking steps to assure full protection for Mr. Edwards, wards the amount paid for the house. He threatened that if they did not move, their house would be blown up. He also inquired of Mrs. Edwards as to the time of her husband's return home and the train he traveled on, information which Mrs. Edwards declined to give. During this white man's visit a group of other white people stood on the street his family and his property.

The latest threat against Mr. Edwards took the form of a white man's visit and rude entrance into the house; holding up his hand which had been blackened, before Mrs. Edwards. TURLEY WRIGHT "NOT GUILTY" AFTER CONVICTION OF ASSAULT

New York, Dec. 26—Upon appeal assisted by the N. A. A. C. P., a young colored man in Tennessee, convicted of "assault" upon perjured testimony has been given a verdict of not guilty and is now a free man.

The young man, Turley Wright, was accused of having attacked an elderly white woman, and was convicted and sentenced to ten years imprisonment upon testimony of herself and two granddaughters, later shown to have been perjured. Broadcasting Will Aid World Harmony

A future in which races throughout the world will use English as a secondary language is envisaged by General James G. Harbord, who was Chief of Staff of the A. E. F. and now is President of the Radio Corporation of America, writing on radio as an instrument for promoting international understanding and peace.

Since the greater and most appealing part of the world's broadcast entertainment is offered in English from America and the British Isles, radio has provided the strongest incentive in history for many races to master a common tongue. General Harbord points out that the nations' confusion of tongues has in itself been one of the most fruitful sources of international division and misunderstanding. People distrust what they do not understand; let them develop a common medium of communication and still another cause of distrust will fall by the wayside of human progress.

Radio and its allied science, television, will prove as valuable and perhaps more valuable than all diplomatic conferences in assuring universal peace for the future, General Harbord believes.

WASHINGTON, Dec. 26.—Dr. Charles S. Johnson of Fisk University has been appointed American commissioner on the international commission which will investigate alleged slavery conditions in Liberia, it was announced by the State Department Thursday.

Announcement was made last summer that the Liberian government intended to appoint an international commission to investigate alleged forced labor conditions in that country and that the United States was being requested to recommend a member to serve on the commission. It is in accordance with such request that the United States government has named Dr. Charles S. Johnson, the announcement said.

Following the declination of Dr. Emmett J. Scott of Howard University, who could not accept the detail, the name of Dr. Johnson was brought forward for consideration and he was requested to undertake this service. He had the support of outstanding educational and civic leaders whose recommendation "duly and impressed the State Department. Dr. Johnson is believed to be particularly qualified for this important service. A graduate of Virginia Union University and of the University of Chicago, he looms as one of the outstanding investigators of the race. From 1917 to 1919 he was director of research and investigations of the Chicago Urban League and later editor of Opportunity magazine.

COWS GIVE MORE MILK BY RADIO

The first test under practical dairy conditions of providing radio music for cows has proved a big success, according to officials of the Detroit Creamery Company, near Mount Clemens, Mich. The creamery company officials bought RCA loudspeakers for each of their barns when a Radiola receiving set installed to entertain the men doing the milking. Now all the 900 cows on the model farm enjoy radio programs.

MEDAL TO OPERATOR 11,000 MILES AWAY

Malcolm P. Hanson, With Byrd Near South Pole, Hears Tribute.

One of the most striking methods of making an award of merit ever devised was the recent presentation of the Veteran Wireless Operators Association medal in a speech by David Sarnoff in New York to Malcolm P. Hanson, radio operator with Byrd, listening by radio in the Antarctic wastes near the South Pole.

Mr. Sarnoff, Executive Vice-President of the Radio Corporation, praising Hanson, mentioned also the altitude of the wife of the operator, who had consented that her husband go on the hazardous expedition for the sake of science. After she had received the medal for safe keeping, Mrs. Hanson, who was deeply touched, spoke to her husband across the vast distance within a

PHOTORADIO MAKES STRIKING ADVANCE

Photoradio has made such strides recently that it promises more than ever to fulfill some day the forecast of Owen D. Young at a dinner given in 1923 to General James G. Harbord, President of the Radio Corporation, that it eventually will make it possible to flash whole pages of newspapers across the ocean.

The most recent developments are the simplification of photoradio apparatus, greater speed and the reduction in rates between New York and London which has been announced by W. A. Winterbottom, Vice-President in charge of communications of R. C. A. Communications, Inc. The reduction was made possible by the simplification and the greater speed. The new rate is figured in centimeters.

"It is my privilege," Mr. Sarnoff said, "to pay tribute tonight to a man who has made an unusual contribution to science and civilization. Although he is 11,000 miles distant from this glass-enclosed room in Madison Square Garden, where I now stand, he is nevertheless able, through the instrumentality of Radio, to listen to the sound of my voice. That fact alone is worthy of commemoration, even in this day of extraordinary progress in science.

"Malcolm P. Hanson, as Chief Radio Operator of the Byrd Antarctic Expedition, you have been awarded the annual medal of the Veteran Wireless Operators' Association, for the most distinguished contribution, by a radio operator, in 1928, to wireless communication. As a member of that association, with some knowledge of its romantic traditions and standards of service, I feel that the award is well earned and well deserved."

Mr. Sarnoff related how Hanson planted his slender steel tower on the edge of the great ice barrier, cheered his comrades with news from home and gave the world for the first time a thrilling daily account of a polar expedition. Those things alone would have been a contribution to history, he said, but Hanson added to radio knowledge by testing signals against the polar sky, observed the phenomena of the Aurora Australis and made a record of radio behavior under conditions hitherto unknown. To Mrs. Hanson, Mr. Sarnoff said:

"Your sacrifice was all the greater because soon after your husband sailed for the Antarctic, you bore him a child. No medal can ever reward or repay you for your own courage and heroism."

The "heart" of a high speed facsimile transmitter is approximately 2 1/2 square inch. The old rate was \$3.20 a square inch. The accompanying cut shows the carriage of lights, called the "doughnut light," which center illumination on a point of the picture or printed matter placed on a roller across from the carriage. This light beam is reflected from the picture or printed matter into the photocell box behind the lights. The "doughnut" is on a carriage which moves across and back in front of the roller. After every trip the carriage makes from one side to the other, the roller turns over so slightly.

As the spot of light from the "doughnut" passes back and forth the lightness and darkness of the points it touches change the intensity of the reflected beam. The reflected beam produces electrical impulses, which are amplified, sent by radio to a receiver hundreds of miles away and changed by the receiver to electrical impulses again. These electrical impulses cause a neon light to glow at intervals timed perfectly with the beam on the transmitter. The glow of the neon light is reproduced on photographic paper, placed in the same position on a roller on the receiver that the original is in on the transmitter. Thus an exact duplicate of the original is made.

RADIO TELEGRAPH EXPANDS SERVICE

Recent additions to the radio telegraph service from the United States are of special interest, now as indications that America is striving to hold her own in a radio telegraph leadership, which is made more difficult to maintain by the British merger of radio telegraph and cables. The announcement that R. C. A. Communications, Inc., will begin work at once to establish an inland telegraph network in fourteen strategic cities in the United States, with plans for inland stations, as wave lengths are granted, also has added to the country-wide attention to this modern means of communication.

Within the last few weeks three new direct international circuits have been announced by W. A. Winterbottom, Vice-President in charge of Communications, Inc., to Spain, Syria and Costa Rica.

Several reductions of rates for radio telegraph service also have been announced recently by Mr. Winterbottom. It was the competition of radio telegraph which forced a reduction of cable rates by which users have saved \$80,000,000 in the last eight years.

PITTSBURGH POLICEMAN DISMISSED FOR INSULTING COLORED GIRLS

Pittsburgh, Pa., Dec. 26—The Pittsburgh branch of the N. A. A. C. P., acting with local attorneys, brought about the dismissal from the police force of a white policeman who after profanely talking to two colored girls, arrested them and took them to the police station in a patrol wagon, charged with "jay walking."

Thomas Baron represented one of the girls and the Pittsburgh N. A. A. C. P. was represented by Homer Brown. According to the report published in the Courier, the two girls were roughly accosted by the policeman while they were crossing the street at an intersection. When a colored man protested, the policeman retorted "I'll throw them into jail," which he did.

His dismissal followed the instance of the two attorneys, and it is now stated that suit for illegal arrest will be brought against the officer.

SNOW AMAZES TWO AFRICAN NATIVES

NEW YORK, Dec. 27.—Two native Africans, who arrived here Monday aboard the Mauretania, showed unmistakable astonishment as they watched the snowflakes fall. It was their first time to witness such a sight and they referred to the phenomena as "floating white flossoms."

The aborigines are Riano and Mulla, who are being taken to Hollywood to work in a motion picture, a part of which was filmed in Africa.

U. S. APPEALS COURT TO PASS ON VIRGINIA ELECTION LAW

New York, Dec. 10—The United States Circuit Court of Appeals will pass on the Virginia election law, which makes it possible for state party committees to bar Negroes from state primary elections. This information is contained in a letter sent to the National Association for the Advancement of Colored People by Alfred E. Cohen, attorney of Richmond, Virginia, who, with Joseph R. Pollard, has been in charge of the case through the lower courts.

LYNCHINGS DECREASE IN 1929

According to the records compiled in the Department of Records and Research of the Tuskegee Institute, there were 10 persons lynched in 1929. This is 1 less than the number 11 for 1928, 6 less than the number 16 for 1927, 9 less than the number 19 for 1926 and 7 less than the number 17 for 1925. Six of the persons lynched were taken from the hands of the law, 5 from jail and 1 from officers of the law outside of jails.

ENGLISH SOCIETY OF FRIENDS SOCIETY OF SPREAD OF COLOR BAR

New York, Dec. 31—The N. A. A. C. P. is informed by the Far and Near Press Bureau that a recent meeting of the Society of Friends (Quakers) in London, took action to prevent the further spread of the color bar. A resolution was unanimously passed to form a permanent joint council of white and colored people, to encourage personal contacts, to spread information and make known in Great Britain the achievements of Negroes. About 250 people attended the conference, representing various missionary societies and other bodies.

CHICAGO, Dec. 27.—Mrs. Anna Morris, 536 East 37th St., was probably as surprised as anybody else when on the elevated station at Adams and Wabash Ave., Saturday afternoon a son was born to her. Seeing her plight, policemen, elevated guards, and various other altruistic persons, scurried around, secured blankets, made her as comfortable as possible, and then rushed her to Research hospital.

Mrs. Morris, who is 25 years old, had started downtown to do some pre-Christmas shopping when the unexpected event sent her pell-mell to the hospital. She is said to have smiled and said: "Well, this is about the best Christmas gift I could have received even if I wasn't looking for it."

There were 27 instances in which officers of the law prevented lynchings. 3 of these were in Northern States and 24 in southern states. In 24 of the cases the prisoners were removed or the guards augmented or other precautions taken. In 3 other instances, armed force was used to repel the would be lynchers, 12 white men, 20 Negro men and 2 Negro women were thus saved from death at the hands of mobs.

Of the 10 persons lynched, 7 were Negroes and 3 were whites. The offenses charged were: rape, 3; writing insulting notes, 2; murder, 1; wounding a man in altercation, 1; wounding officers of the law, 2; charge not reported, 1.

The states in which the lynchings occurred and the number in each state are as follows: Florida, 4; Kentucky, 1; Mississippi, 1; Tennessee, 1; Texas, 3.

N. A. A. C. P. PROTESTS BARRING OF TWO COLORED TENNIS STARS

New York, Dec. 31—Barring of two young colored tennis stars from the National Junior Indoor Tennis Tournament, by the U. S. Lawn Tennis Association, today brought a sharp letter of protest to that body from the N. A. A. C. P.

One of the boys, Gerald L. Norman, Jr., is captain of the Flushing High School tennis team and that school's sole representative in the tournament. The other is Reginald Weir of the City College of New York tennis team. Entries of both boys were accepted and payment of their fees received, and it was only when their names failed to appear in the draw published Sunday, that it became known that they had been excluded from the tournament. Gerald Norman, father of the boy excluded, reports that he was informed by Edward B. Moss, Executive Secretary of the U. S. Lawn Tennis Association, that colored players were not permitted to take part in that body's tournaments.

The letter written by the N. A. A. C. P., and addressed to Mr. Moss characterizes the barring of the boys as an expression of "class and caste snobbery" such as is not relished by patrons of American sport. The letter is signed by Robert W. Bagnall, Associate Secretary of the Association.

SEGREGATED IN CHURCH TOGETHER AT PRIZE FIGHT

New York, Dec. 31—How colored and white people, segregated in church, sat together at a prize fight, in Charlottesville, Virginia, is told in a letter sent to the N. A. A. C. P. by Dr. James H. Dillard, Director of the Jeanes Fund. Dr. Dillard, labeling the story "A Christmas, Conundrum for Saints and Sinners" to which only sinners can give the answer, writes: "A few weeks ago in the Parish House of Christ church, Mr. Wallace Battle, representative of the Episcopal church Institute for Negroes, spoke in behalf of these church schools. The colored people of the audience sat so high up in a gallery that I did not know where there were any present until the meeting was over. There was no provision for them even by separation, on the main floor. "Last night George went to a sparring match in the Army between two colored boxers. When he got back he came up to my room to tell me that he had seen an illustration of race relations. It was not a mob crowd. There were students from the University and some of the 'best' people in town. There were white people and colored people. There was no division of seats. Anybody sat by anybody."

DECADE BRINGS VAST RADIO CHANGE

The anniversary, marking the passing of ten years since the Radio Corporation of America was founded, is significant for the entire field of radio because the corporation has been associated so closely with the great changes which have pushed back world horizons.

How great these changes have been it is hard to realize now that radio is accepted casually as one of the biggest of American industries, doing a business of more than \$600,000,000 a year. It helps to bring some realization to consider radio as it appeared to the men who formed the corporation, starting business on December 1, 1919.

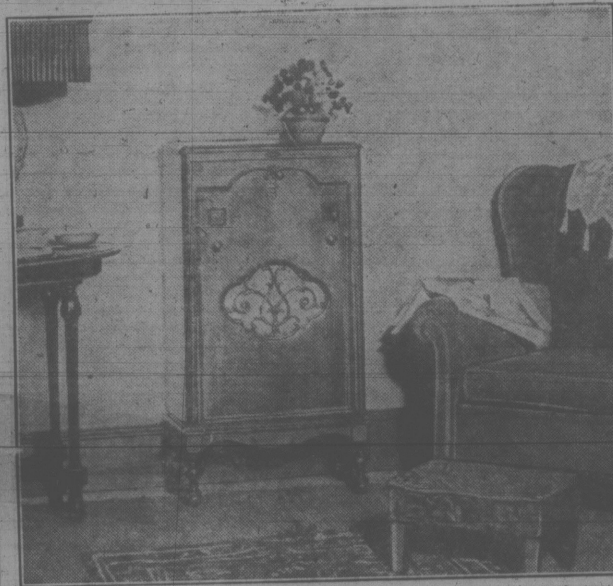
