ARKANSAS HALTS RACE VOTE

CHESTERTOWN, Md., March 27.—(C.N.S.)—It was certainly not an ill wind that blew \$500 in \$5 bills into the arms of Harrison Jenkins—but the second gust—well, that's another matter.

Jenkins was bound for the railroad station when he saw a \$5 bill blowing up the street. As he proceeded toward the station the number of bills, scurrying along in the March wind, became more numerous, and Jenkins gathered up \$50 in \$5 bills and two \$1 notes.

Cobb as judge of the Municipal Court of the District of Columbia, Judge Cobb handed down a decision against the fiery senator from the Palmetto State, it was learned here Saturday.

Blaise Refuses to Pay
The Industrial Loan Bank, through their agent, C. H. Seebold, filed suit in the Municipal Court to recover on a judgment awarded against the senator in the County Court of Richland county, S. C., on March 4, 1925, in the amount of \$172, which Senator Blaise had refused and failed to pay in spite of repeated and insistent demands.

Attacks Negro Judges
The motion was overruled January 12, 1929, by Judge Cobb, who handed down a decision for the plaintiff on March 8, 1930, ten days before the senator makes an attack upon "nigger" judges on the floor of the Senate and three days before the settlement with the Industrial Loan Bank was due and payable.

War Department Says Gold Star Mothers Are Not Complaining and Their Complaint Would Have More Weight Than Others
WASHINGTON, D. C., March 27.—(C.N.S.)—Not a single Gold Star mother or widow who is eligible to make the trip to Europe as the guest of the federal government has formally registered her protest against the jim-crow arrangements for the pilgrimage to the European graves of their heroes, War Department officials told a reporter for the Capital News Service on Friday.

No Complaint Made
While protests against the policy of segregating the mothers on their sacred pilgrimage to the battlefields of France have been voiced by a score of national organizations, prominent citizens and practically every Negro newspaper throughout the country, the mothers themselves have registered no complaint, it was pointed out. The protests were considered but caused no change to be made in the plans. In the absence of the protests of the mothers and widows themselves, officials claim to be justified in their conclusion that they are satisfied, it is frankly stated.

222 To Go
Continuing officials point out that even after complaints began pouring into the War Department following the exposure of the "jim-crow" plan by the Capital News Service, four additional mothers have signified a willingness to make the trip, bringing the total number up to 222 to go in 1930 and five to sail at some later date.

Weekly trolley passes have been placed on sale in more than eighty community and downtown stores, it was announced by the Des Moines Railway company Tuesday. Sale of passes on street cars was discontinued March 26.

NEW ORLEANS, March 28.—A middle aged plantation owner was on his way to Atlanta penitentiary Tuesday night after pleading guilty to a charge of holding his Negro farm hands in slavery.

GREEN EIGHTEEN MONTHS
He was James E. Pigott, lanky cotton planter of considerable wealth, who was sentenced to eighteen months when he confessed to Federal Judge Wayne Borah he often chained his Negroes to trees when they attempted to escape from his plantation in Washington parish, near here.

PLEADS GUILTY
Pigott stood before the court and smilingly pleaded guilty to all the counts of the peonage charges except allegations that he had beaten his Negroes with tire chains.

NEGROES DON'T TESTIFY
Preston Allen, Herbert Dyson, and Jesse Hall, three Negroes who said they were at one time held by Pigott, were in the courtroom but were not called to testify.

NEW YORK, March 28.—Harriet Pickens, daughter of William Pickens, field secretary of the N. A. A. C. P., is the first of her race to receive the coveted award of the "89" pin, one of six awarded at Smith College, Northampton, Mass., one of the foremost women's colleges in the country.

Three memorable services on last Sunday at Burns' M. E. Church, 811 Crocker Street, Rev. H. L. Overton, pastor, brought to an end an intensive drive by the congregation to raise \$1,500. The result was an overwhelming success. At the conclusion of the services Sunday night, Bishop Mathew W. Clair dedicated the church building and spoke words of praise and congratulations to pastor and people. The final count of all moneys raised totaled to \$2,005.06.

Capacity crowds, two wonderful sermons and several unusual incidents characterized the days proceedings. Bishop Clair delivered a powerful gospel message at the morning service, taking the life of Job as his subject. An interesting incident was the presence of Attorney and Mrs. James R. Morris with their daughter, Jean, who was born in May, 1920, on the day that Bishop Clair was consecrated at the Des Moines Session of the General Conference of the Methodist Episcopal Church.

Mr. W. H. Kidder of the First Methodist Church reported contributions from Grace, Wesley and Trinity M. E. Churches, and Mr. William Toney, prominent business man of the city, presented a check of \$497.80 as a gift from the membership of First Methodist Episcopal Church.

Rev. and Mrs. Overton Honored
There was much happiness expressed and suppressed excitement as the total showed Burns had once more scored a remarkable victory and had gone over the top several hundred dollars under the able leadership of the pastor, Rev. H. L. Overton. At this juncture, Mr. Ed. R. Brown, the legal advisor of Methodism in this area, stepped forward and invited Rev. Overton and his wife to stand together on the rostrum. There was immediate silence while the distinguished attorney spoke feelingly of the splendid qualities and the congenial personalities of Rev. and Mrs. Overton and then in behalf of the Rev. Mr. Kenna and the congregation of First Methodist Church, he presented Rev. and Mrs. Overton each with checks for \$50. The sympathetic feeling and appreciation was so intense at the moment, that tears were observed coursing down the cheeks of more than half the congregation. So filled with emotion was Rev. Overton, that he could with difficulty make any response.

VOTE MONDAY

The city campaign is drawing to a close. Considerable talking has been done but there has not been the interest displayed as in former years.

There are some outstanding candidates in the field, men and women who have had a clean record as far as our group is concerned. Some of the candidates in their public and private dealings have been right on all occasions. They have given employment to Negroes in their private business; they have done so in their capacity as public servants. Some have not. The record can be had, but we make no effort to produce it here.

Unfortunately, little concerted action has been taken to line the vote up definitely but the average citizen knows the record of the candidates and will vote correctly Monday. Many of these records are so outstanding that few will be lured by sweet voices and delayed promises.

A CASE IN POINT

"Down in Greensboro, N. C., a young white merchant is trying out a most novel experiment. He has a number of Negro clerks in his grocery business. The business is growing by leaps and bounds. Many stores here and there employ Negroes who 'help around the store,' but they cannot get nearer than a mile to the cash register.

"Our Greensboro white merchant is letting the Negroes even handle the cash register and ring up their sales."

"A white salesman noticing this unusual procedure, began to chide the merchant for taking such 'desperate chances' with Negro clerks. Said he: 'Do you not know that within a short time they are going to steal you, store and all?' Our sensible young merchant replied: 'When I had all-white clerks, they stole all they could get, and certainly the Negroes cannot do more. What is more, where the white clerks stole dollars, the Negroes steal only dimes.'—Portland Advocate.

This should be a splendid example to the merchants of Des Moines, many of whom enjoy considerable Negro trade. One of the leading stores down town has hired a Negro saleslady for more than twenty years and her ability is recognized by some of the best people of the city.

It is simply a matter of breaking the ice and standing by what is right. A leading Des Moines business man once said that the failure of people to give Negroes employment were acts of cowardice, though he had been guilty himself.

A FEW ECONOMIC FUNDAMENTALS

It is a music you can feel because it reaches every emotion of the soul from the minor chords of misery and sorrow, to the majors of ecstasy; from the cadence of despair to the diapason of victory.

Weekly Health Talk

I am sure the world would welcome a cure for this malady and recent work on such a cure if tradition repeats itself is to the optimistic anticipation of a coming event. To say that no advance has been made in the perfection of a cure would be to discourage investigation and to put to naught all methods which have been successful in the past in the discovery of cures which have attacked mankind.

From what I am able to glean from recent news the cure is on the way. At present, however, the only protection against cancer in any of its forms or in any of the common locations is the early discovery of its presence and treatment which removes it while it is in its beginning. It presents a very characteristic appearance even in its early stages before it has given any symptoms such as pain which is usually the first symptom which causes the patient to seek medical advice.

It is possible for cancer to occur at any age but the common age is after forty-five. A routine examination at this age would prevent many of the deaths which occur from this affliction. Cancer may occur in any portion of the body but is most common in the stomach, the breast and the reproductive organs.

Its early recognition in the breast makes an early cure possible because it is readily seen. In the stomach and the uterus more care must be exercised that a beginning growth of this kind be not neglected.

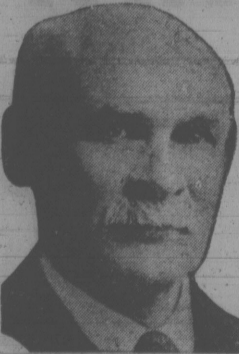
