St. Paul Crosses \$2500 Mark in Rally Effort

WASHINGTON TELLS WALTER WHITE NEGRO STAR IS IN ASCENDANT

New York, May 28.—Returned from a speaking tour, which included visits to prominent senators and political leaders in Washington, Walter White, acting secretary of the N. A. A. C. P., reports the consensus of opinion to be that as a consequence of the defeat of Judge Parker's nomination to the U. S. supreme court, the Negro's star is in the ascendant.

"Both from the way in which the senators in Washington received me as a representative of the N. A. A. C. P.," said Mr. White, "and from what I learned in conversation with the best informed newspaper correspondents, I can say that the Negro's star, politically, and on a national scale, is in the ascendant. One well informed newspaper correspondent with whom I carefully went over the situation informed me that eleven senators at least had been affected in their vote on Judge Parker's nomination by their Negro constituents.

"Now a word of warning to colored people. This warning comes direct from Washington. The colored citizens of America have staged a major demonstration. But the job is well and thoroughly begun, it is not ended. It will not be ended until some of those senators who defied their colored constituents and voted for Judge Parker have been decisively defeated when they come up for re-election.

"The politicians are awake to the Negro vote and its possibilities. But that possibility must be translated into fact. If Negro voters fail to do what they have said they would do, then in the future the political leaders will ignore them or give them only minor consideration. So it remains to finish decisively, the job which was begun when the senate voted 41 to 39 against Judge Parker.

"Let the colored voters throughout the country make a note of how their senators voted on that issue. Let them keep that note ever before them. The N. A. A. C. P. memory in the Parker case reached back ten years to a political speech Judge Parker made in 1920, and on the basis of the N. A. A. C. P. memory Judge Parker was defeated. Let the memory of colored voters keep alive the vote of their senators until each senator comes up for re-election. Then let the colored vote register. If anyone forgets, let him ask the N. A. A. C. P. The N. A. A. C. P. memory will not fail. The records will be kept. They are available to anyone who inquires. Remember, let us finish the job of establishing the Negro's full membership rights throughout the United States. That is the one of the sure ways to end lynching, peonage, race riots and Jim Crow discrimination of all kinds."

Louisiana Jury Acquits Negro of Rape Count

First Such Victory in That State and Many Other Far Southern States

New York, May 28.—For the first time in the history of Louisiana courts and probably of many other far southern states, a Negro has been acquitted, at Monroe, of a rape charge which usually brings brutal lynching without any trial whatever.

This report comes to the N. A. A. C. P., 69 Fifth avenue, from Hugh T. Layne, white attorney retained in the case by the Monroe branch of the N. A. A. C. P., under the presidency of C. H. Myers, the national office contributing \$125 toward the expenses of the legal battle.

Mr. Layne writes to the N. A. A. C. P.: "It was one of the hardest fought legal battles Louisiana has ever known, the result of which was an acquittal, the first verdict of its kind in such a case that has ever been rendered in a Louisiana court, and in so far as I can learn, the first of its kind in many states in the south."

Thought To Have Been Framed The colored man, Jack Rose, defended and acquitted in this case, is generally thought to have been "framed." Mr. Layne, after accepting the case and investigating, expressed his strong belief that the colored man was entirely innocent, a belief which the jury later shared.

The victory in this case is hailed as the more epochal by the N. A. A. C. P. inasmuch as that part of Louisiana has been notorious for its evil treatment of colored people and has been a headquarters of the Ku Klux Klan. Mer Rouge, about twenty miles from Monroe, was the scene of terrible murders some years ago.

This is the third great victory won by the N. A. A. C. P. in Louisiana in the past year. The first victory brought about the conviction of two white men, at Eros, for the brutal and unprovoked murder of two colored women. The second victory, in New Orleans, resulted in the passing of death sentence upon a white police officer for shooting a colored girl who had resisted his advances.

Rev. Guy Sets New Record for Local Congreg'n

This is the year of great things with the congregation of St. Paul A. M. E. church, corner of Twelfth and Crocker streets, under the pastoral leadership of Rev. Dr. William E. Guy.

Des Moines is experiencing some new thrills since Dr. Guy and his good wife came to our city the first of February. The Easter candle service was something new, something different and full of inspiration, and the people of Des Moines are still talking about it and are looking forward toward witnessing it some time hence at Easter time.

The third Sunday in May was Co-operative Sunday at St. Paul's and the ministers of the city, with their congregations, came in good numbers. It is conceded by everybody that the co-operative meeting of the Ministerial Alliance at St. Paul was the best co-operative meeting in the history of Des Moines Ministerial Alliance. Each of the ten preachers gave his sermonette on ministerial co-operation and each church group associated with one of St. Paul's clubs and rendered a group song number. The offering was as follows:

Especially so since the church was besieged by creditors who were threatening to sue and get judgment before their accounts were outlawed. Some of these bills ran back as far as the administration of five former pastors and included coal bills, money borrowed to pay chautauqua assessments and former pastors' salaries. With a master hand Dr. Guy assumed control. For three weeks he was so busy getting a grip on things that he did not even take time to draw a single dollar for salary, though he had advanced his own money and paid his own expenses. Ten weeks ago he launched a financial campaign.

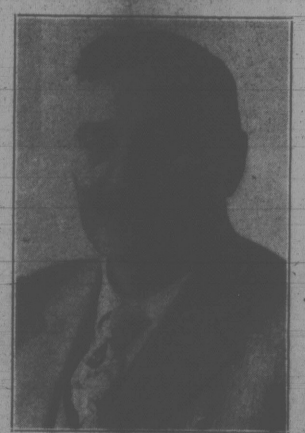

Victory in High Court Foiled Plan to Punish Purchaser

Washington, D. C., May 28.—A Negro attorney, William H. Lewis, was revealed Wednesday as the brains behind the legal move which foiled the government's attempt to prosecute the buyer of bootleg liquor.

Lewis, who played center on the Harvard football team in 1921 when he was taking a law degree there, was counsel for James E. Farrar, Boston motorist, whom the government tries to prosecute for buying two pints of liquor from a bootlegger.

Lewis won the case in a Massachusetts district court, and finally was victorious when the supreme court held in a significant decision Monday that the government could not punish Farrar—or anybody else—under the Volstead act for buying liquor.

The Farrar case, far-reaching as it was in consequence, was just another case for the Boston Negro lawyer. He has had a distinguished career which included two years in the Taft administration as an assistant attorney general.

Lewis does not look his 42 years. A person of scholarly appearance, well built, of medium height, he is the calm and composed veteran pleader before the bar. He graduated from the Harvard law school after taking an A. B. degree at Amherst, alma mater of President Coolidge and Dwight H. Morrow.

Mr. Lewis was at one time assistant United States attorney in Massachusetts and later was appointed an assistant attorney general by the late President Taft.

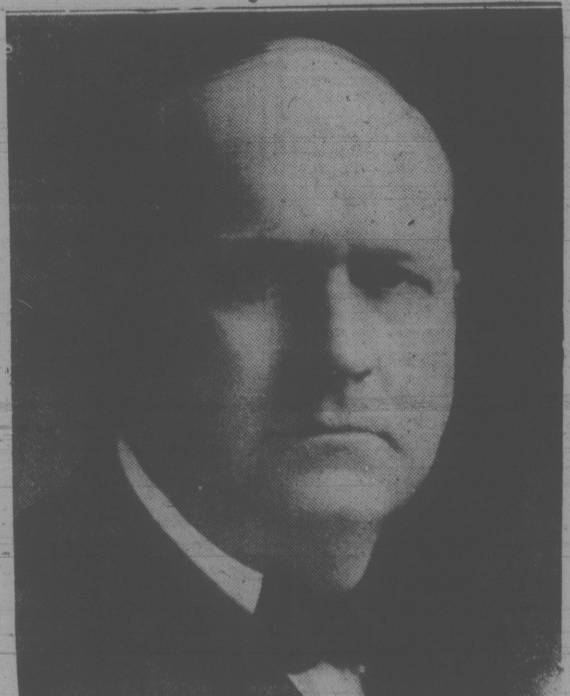

TRUE TO FORM

The Iowa Unionist, official labor paper, in one of its bombastic editorials in the issue of May 3 has brought the Bystander in for some criticism, which is quoted below:

"Some time back the Iowa Bystander, Negro publication, printed an editorial advising the Street Car Men's union to accept the one man car. Since then this publication has received advertising from the street railway company at a larger space of inches than it did previously."

"In last week's issue the Bystander again comes to the aid of this public utility and states that the city council should not hamper the 'progress' of the street railway by passing the two man-car ordinance. We used to think the Bystander represented the colored people of Des Moines, but we are convinced that it must represent the exploiters of the workers, of which the Negroes are such a large part. Certainly there is no original thought in their arguments for one man cars. The editorial is simply a rebash of things the company has been feeding the public, and the editor says no men will be thrown out of work, because the OFFICERS OF THE COMPANY SAY SO. The editorial says the council was given a petition with 8,000 signatures favoring one man cars. Even the Bystander, with a little investigation, would know that this petition was the work of paid employees of the company and that the signers were either fools or signed because they were forced to."

"The editorial says that 'Des Moines can boast of few large industries greatly due to the fact that they have been given little inducement to locate here. Our street railway has been in and out of court for many years because certain interests have sought to squeeze the company for every available nickel without regard to the fact that the company must earn money to stay in business.'"

"According to this theory the big business interests should be given the town if they will but locate here and then the citizens should leave them run things to suit themselves as far as profits are concerned, so that distant owners and stockholders may live the life of Riley down in Palm Beach or some other resort while the wage slaves here in Des Moines struggle along on a cheap wage or walk the streets seeking work when the company so desires to throw them out. If the Bystander really wants to help the street railway and all citizens concerned, let it criticize the ones responsible for the over-capitalization of these public utilities."

"But while the public utility is given a monopoly in its field and by the terms of its franchise is not allowed competition then it should be subject to regulation in the interest of the public welfare. Let it squeeze the water out of its stock and not the life out of the citizens."

Many inquiries have been made among the readers of the Unionist and we are yet to find one who has read the article, which proves that very little attention is paid to it."

However, the real trouble with the Iowa Unionist is not that the Bystander is misleading its readers on the one man cars, but that it is painfully grieved because the present management of the Des Moines Railway company has seen fit to give the Bystander its rightful share of advertising. They have not succeeded in working its high pressure "labor gas" to block our advertising solicitors on the Street Car Company as they have

The Negro in America

The constructive campaign as conducted by Dan H. Turner of Corning for the republican nomination for governor of Iowa reflects credit to him and inspires the people's confidence in his policies.

He stands now, at the close of his campaign for nomination, exactly where he stood at the beginning; he stays put. This is a very necessary requisite for leadership. He stands for the things that he honestly believes will help lighten the tax burdens of those least able to bear them and places them on the shoulders of those more able to carry them.

He did not hop into this campaign on one leg and then shift to the other one because he thought it would bring more votes. He knew what he wanted to put forward from the beginning and has stuck to his guns, so now we do not find him embarrassed or having to explain his position or make excuses for his public acts.

In politics the citizens of a community should choose the man whose ability and character are of the highest standard. Any candidate for office who uses or permits to be used misleading propaganda for the sake of furthering his political advancement is unworthy of the public's trust or confidence.

Very few people in the ordinary walks of life understand the intricacies of the problems of government, therefore any man who takes advantage of this ignorance to garble the evidence and obliterate the facts for the sake of obtaining votes is too small in caliber for a big office. To tell a man who is getting a salary of \$500 a year that he will have to pay an income tax or at least make out an income tax report is stretching the blanket too far.

The spirit behind such a statement is too culpable for words. It is a malicious intent to deceive. Any man who uses such methods or condones their use by others in his behalf disqualifies himself for any representative office. All citizens hoping to improve the status of our public servants will do well to study the prospective office seeker's campaign methods. It will give them one of the best insights on the personal character of the man. A vote for Dan H. Turner of Corning for governor is a vote of appreciation to men of his high standing and it will induce other good men to seek public office when they are convinced that real work will be recognized above circus billboard advertising.

Of course this attitude is in line with a lot of union men and unionists who cry "we workers" when they want help and then place clauses in their constitutions and refuse to work Negro mechanics even though equally skilled. In other words, too often they force the labor union question on an employer and then place clauses in their laws barring Negroes from joining the union.

It is the tendency today among labor to get away from the selfishness which keeps Negroes out of the unions. There is some evidence of it in Iowa today. We do not propose to say who the Unionist influences, but we do know that few people—even labor—heed what they attempt to say.

Weekly Health Talk

By Dr. Hubert H. London

DIABETES, as most everyone knows since the recent publicity given this disease by the discovery of insulin, is an affliction of the pancreas, which consists in a destruction of certain areas of this organ, known as the "Islands" of Langerhans.

It was definitely proved a long time ago that these areas and their destruction to a small or large degree accounted for the symptoms which characterize the disease before mentioned, and the symptoms which are mild or severe, depending upon the amount of destruction that has occurred. An excess of sugar in the urine or blood, together with symptoms of which the patient complains, are the manifestations of damage to this organ.

Concerning actual cause of the destruction of the Islands nothing is known, definitely, and as a rule a cure is not discovered until the cause of a disease is known, except perchance by luck. A comparison in disease of the kidneys seems fitting since recent experiments on the eating of meat alone, with no other food in the diet, seems to show that meat might be eaten indefinitely without affecting the kidneys or showing even slight damage to these organs. This experiment was made at Bellevue hospital, N. Y., by four physicians on two Arctic explorers, who did not harm themselves by living on all meat for one year and ten days, neither the health or the efficiency of anyone was affected. Refuting this result and experiment was done on a laboratory worker that was fed a diet of 32 per cent lean meat for a period of six months, after which time true nephritis or kidney disease developed. This contradiction is explained by the observation that the diet of the Arctic explorers was only 20 per cent lean meat, the rest being animal fat, high in some way protected the kidney from harm. The small amount of 20 per cent lean meat being insufficient also to do damage to these organs. The idea

among those who do not work in science is that an excess of sugar causes diabetic disease. We have never believed this, but nevertheless other elements of the diet, if insufficient, might allow sugar to become a causative factor in the production of this disease—who knows.

Experiments along this line might prove quite as interesting and enlightening as those on the kidney show the importance of the proper selection of the elements of the diet, and give us all some standard for the taking of sugar without harm to structures, or the inciting of disease.

Browne, serving his sixth year as head waiter, has eighteen men on his staff in the winter season and twelve are on duty now. Mr. Browne is exceptionally efficient in the performance of his duties. Before assuming his present position at the Savery Mr. Browne spent five years at Hotel Fort Des Moines.



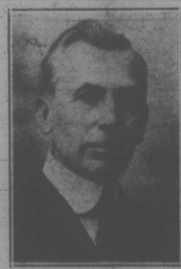
