The meeting opened Monday morning with the Ministers and Deacons' Wives Union, with Mrs. J. C. Bothic of Yankton, S. D., presiding. Inspirational were led by Mrs. A. M. Smith of Cedar Rapids. The president's annual address and an address by Mrs. Grace Stokes on "Woman's Place in the Church" concluded the morning business.

Rev. Bell Preaches

The afternoon session was spent in electing officers and the organization of study groups for the school of methods. In the evening Rev. W. Bell of Clarinda was scheduled to deliver the sermon, which was preceded by music by Shiloh choir and a solo by Mrs. A. M. Smith of Cedar Rapids. The Ministers and Deacons' Union called their opening session at 9 a. m. Tuesday morning, with Rev. J. C. Bothic, president, presiding. Inspirational were placed in the hands of Rev. J. H. Reynolds of Council Bluffs and Elean Green. The theme of the meeting, "Example of Service," was outlined by Rev. J. Patten of Waterloo.

The principal address of the morning was delivered by Rev. A. Ross Brent of Maple Street Baptist church, who spoke on "Why should the Negro prepare to meet the economic world today?" The Rev. Mr. Brant pointed out the necessity of Negroes building up their own business enterprises and patronizing only those white ones who employ Negroes.

The official report, introduction of visitors and announcements occupied the rest of the morning.

Corinthian Quartet Sings

The school of methods held two forty-five minute periods daily. Election of officers, together with the president's annual address, were the two incentives of the afternoon meeting.

Rev. E. P. Green preached the sermon Tuesday evening. The feature of the meeting was the appearance of the Corinthian quartet.

"Christ's Call To Service," the theme of the Sunday School convention, was discussed by Mrs. John Gibson of Manley at their opening session Wednesday morning, following the devotionals, which were led by Lyle Williams of Davenport. Mr. H. Dudley of Maple Street, Des Moines, was presiding.

The Rev. T. T. Lovelace of Ottumwa, who is serving his first year in the Iowa field, was the principal speaker at the morning meeting. He spoke on "Trained Leaders An Asset to Kingdom Leaders." Miss Louise Greenup of Ottumwa gave a reading. The conventional choir sang several numbers—preceding remarks by the Rev. J. W. Tutt of Union, dean of the school of methods.

Man in Wild Rage Slashes Wife's Throat; Then Takes Own Life

Waterloo, June 13.—After cutting off both ears an ably mutilating her face, Eugene Thomas, 35, a World War veteran, prompted by jealousy, severed the head from the body of his sweet-heart and common law wife, Thelma Shaw, 27, here Sunday afternoon. Thomas then cut his own throat and died shortly afterward.

Had Quarrel Often

According to neighbors the couple had been living together for some time, during which numerous quarrels had occurred, and Thomas, who was of a jealous nature, had threatened the life of the woman several times.

The cutting scrape was the result of a heated quarrel over his sweet-heart's refusal to tell him where she was going, when she started out of the door, his aunt, Mrs. Susie Walker, said.

"Where Are You Going?"

"Where are you going?" he asked her. The woman kept on going out the door without giving him a reply, and thinking she was going to meet another lover, he became infuriated, grabbed her arm, snatched a straight edge razor out of his pocket and severed the left ear from her head. Her screams attracted neighbors, who, thinking it was no more than the usual quarrel, did not interfere. After slashing her face several times he then drew the razor across her throat, killing her instantly.

Commits Suicide

He is said to have called the girl's cousin, Mrs. Mildora Williams, following the tragedy, and after showing the girl's body, made a leap for her with the blood stained razor in his hand. Mrs. Williams ran out of the door and escaped. He then committed suicide.

On the 17th they will visit the birthplace of Christopher Columbus at Genoa, Italy, and will spend from the 19th to the 26th in Paris and Versailles, France; sailing from Havre on the steamship "France" on the 27th.

SOOT AND DUST RAISE HEAT BILLS

Blamed in the Heating Plant

There is a tremendous wastage of coal and fuel oil during the heating season, due to the fact that home owners do not keep their heating systems clean. Many heating plants are literally filled with soot and dust, and, according to the Holland Institute of Thermology of Holland, Mich., the dirty condition is responsible for unsatisfactory functioning of the heating system and consequent waste. In substantiation of the foregoing, the institute quotes from a report by the United States Bureau of Standards to the effect that even a thin coat of soot, one-eighth inch, cuts down a plant's efficiency 25 per cent, and a quarter-inch of soot will result in a 48 per cent cut in operating efficiency. This explains why difficulty was experienced by some home owners in

keeping their homes warm in last winter's cold weather. The soot and dirt in the heating system interfered with delivery of heat when it was most needed.

There is only one remedy for a condition of this sort, and that is to subject the heating system, including the chimney, to a thorough cleaning before the next heating season starts. When soot and dirt are cleaned out, draft troubles may be eliminated, combustion is more thorough, more heat is extracted from the fuel burned, and the home is more satisfactorily heated at less expense. Formerly this was a dirty, messy job. Now it is accomplished as easily as the vacuum cleaning of the interior of the home, and much the same way. Cleaning of heating plants is now done by means of a giant vacuum cleaner that comes to the job mounted on a motor truck. The cleaner is attached to various openings in the heating plant, including the chimney, and the powerful suction of the fan draws out the dirt and soot, forcing it into the bag for later disposal. The cost of a job of this sort is less than the price of a ton of coal, though many times that will be saved in the course of a year in eliminating fuel waste and cleaning expenses.

NEGRO LIEUTENANT COMMENDS MOTHERS FOR REFUSING JIM CROW JOURNEY

New York, June 10.—Commendation of the fifty-five Negro gold star mothers who told President Hoover they would rather stay in America than go to their sons' graves on French battlefields in a segregated "pilgrimage" has been sent to the N. A. A. C. P. by a colored man who served with the 349th field artillery of the United States army.

Lieutenant Walter R. St. Clair of Asheville, N. C., writes that the news of the colored mothers' refusal to go on the Jim Crow voyage to France filled him with pride and with joy. His letter to the N. A. A. C. P. continues: "All honor to these splendid understanding women. To have accepted the opportunity to make the pilgrimage under segregation would have shown the Negro race in America totally devoid of self-respect and opened the way for other insults and humiliations."

"Of all the small, silly, unfair and un-American acts done against American Negroes under vicious race prejudice, the proposal of the war department and evidently with the approval of President Hoover, to separate the mothers because of color is the worst. Refusing to go under those revolting conditions teaches white America a lesson that is bound to penetrate even the thick skin of the most ardent race hater."

Buffalo, N. Y., June 8.—That the Negro in America has gained more than he lost in the changing structure was the consensus of opinion of those experts, social workers and economists who assembled here to attend the annual conference of the National Urban League. The theme of the conference—Vocational Opportunity for Negro Workers—served as the magnet which attracted a large number of the leaders of both races to what is considered to have been the most successful conference in the history of the Urban League movement.

CHICAGO.—The ballyhoo against margarine in the dairy sections has failed to stampede consumers into banning this product from their tables, according to Dr. J. S. Abbott, secretary of the Institute of Margarine Manufacturers.

"Even in farming areas where margarine has been boycotted and exiled from the retail grocery stores," said Dr. Abbott, "consumers are still interested in buying the product and in many cases are making their purchases direct from the manufacturers."

"The consumer realizes that it is his right as a free American citizen to purchase the food fats of his choice and no coercion is going to prevent him. He realizes, also, that margarine is a clean, safe, and economical product, safeguarded by a Federal government supervision through its various phases of manufacture as no other food product on the market is safeguarded."

HOWE CAVERNS AREA MAGNET TO TOURISTS

ALBANY, N. Y.—Tourist traffic in the United States for the 1930 vacation period will reach its peak-point in the area of upstate New York, 40 miles west of here, between the Finger Lakes region and the Catskills, popularly designated the Howe Caverns country.

More motorists, vacation-bound, will follow the macadam trails which wind idly through the caverns country than will pass over any comparable mileage in the United States, according to a survey by the American Research Foundation.

The rolling caverns country is a strategic hub at which highways from national centers of population south, east, and west converge, to diverge again to the favorite playgrounds of Canada, the Adirondacks, and the New England seashore.

Three historic state highways, each either meeting or forming a part of a national highway between Canada and Florida, or between the Atlantic and Pacific coasts, inevitably bring travelers arriving in north central New York from any direction, within the proverbial stone's throw of Howe Caverns at Cobleskill. Cobleskill is 100 miles northeast of Binghamton and 40 miles west of Albany, or 30 miles southwest of Schenectady, all terminal points of the Revolutionary trail, a link in the highway through the Appalachians from Florida to Quebec.

The chambers of Howe Caverns are accessible by electric elevator service to visitors. They extend two fantastic miles into the limestone heart of the highlands over which Rip Van Winkle, Leatherstocking, John Burroughs, and the border heroes of the Revolution once ranged. State geologists have termed the caverns the largest in the northeast United States and a twin-wonder to Niagara Falls.

The question will no doubt be submitted to the voters in a few short years. Some of our best and leading citizens, men high in business, professional, legal, church and educational life have spoken out against the present conditions.
