Three Bank Failures Blow to Chicago

Officers Silent on Future; May Pay Depositors in Full

Chicago, August 8.—An examination by representatives of the state auditor's office this week resulted in the closing of the Binga State Bank, 35th and State streets, at 1:57 p. m. Thursday. The institution, with a capital of \$400,000; a surplus of \$45,000 and, according to reports, \$1,200,000 on deposit is the only state bank in Chicago controlled by members of the Race. It was organized in 1908.

The news spread like wildfire and within less than a half hour after the state examiners had locked the doors, police reserves were beating back the milling throng which was gathered in front of the bank. On the door leading to the bank a statement by State Auditor Oscar Nelson told the story that gripped the hearts of hundreds of men and women whose lives' earnings lay within the vaults of the defunct bank. The statement read:

"Closed for Adjustment and Examination"

Assistant Chief Examiner A. E. Kimlin was interviewed in his office at 35 La Salle street regarding the circumstances surrounding the closing of the bank and the prospects of reopening, he said:

"At the end of regular examination of the bank's condition, the report showed that in addition to frozen assets in the form of real estate loans, which the bank was carrying, there was insufficient cash to meet the requirements of the state. The members of the board of directors were called in and asked what they intended to do. When they discovered that the stockholders were unable to make good, the state auditor was requested to take charge of the bank.

The chief examiner stated that he could not say whether anyone connected with the bank could be criminally involved. He declined to reply to the inquiry, "what were the requirements demanded of the bank officials to restore the stability of the institution", stating that it was confidential.

Regarding the prospects of the banks reopening Kimlin said, "An inventory of the bank's assets which is taken, at the completion of which, an attempt will be made to reorganize it. If the attempt is unsuccessful, a receiver will be appointed, the assets liquidated and an accounting made to the depositors."

As near as he could figure, Kimlin said, it will be thirty days before anything definite can be done.

President Jesse Binga could not be reached by newspaper reporters seeking an interview, nor could Carol Langston, cashier, Dr. U. G. Bailey, head of the Dailey hospital and one of the directors of the bank was reached by telephone and had only this to say: "I could make no statement except to repeat that made by the auditor."

One depositor, a retired policy wheel operator, is said to have withdrawn \$28,000 within the last two weeks. Through the grapevine method of word warning went out to various big-time racketeers and politicians, who, it is alleged, began to make withdrawals quietly. A few hours before the bank closed, lawyers, doctors and other depositors rushed their office girls to make withdrawals.

Several leading business houses owned by members of both races are reported to be on the verge of collapse as a result of the crash. A number of individuals are said to be flat. One institution of the South Center section is reported not to have been able to pay its help.

The Douglas National Bank, 3621 Starr street, immediately after the closing of the Binga bank is reported to have secured \$100,000 from the Federal Reserve System in anticipation of heavy withdrawals Friday and Saturday.

TWO MORE CHICAGO

BANKS FAIL

Chicago, Aug. 8.—The failure of the Binga State Bank seemingly marked the same fate for many of the South Side banks in which Negroes are heavy depositors, when two more failed Saturday morning, another Monday and another on Tuesday.

Saturday the Bankers State Bank, at 47th and South Parkway and the Roosevelt State Bank at 35th and South Parkway, both owned by the same corporation succumbed to withdrawals of depositors, following the crash of the Binga bank.

Monday, the Citizens State Bank, located at 55th and State added its name to the growing list of defunct banking institutions on the south side. And Tuesday it is reported that the Industrial State Bank located at 47th and State street went under.

It is rumored that the Lincoln State Bank located at 55th and State streets, was shaky, and refused to pay any more depositors who were making a run on the veteran bank. Many of the other banks who are not so weak, are nevertheless, feeling the effects of the Binga bank crash, which seemingly, has made south side citizens lose all faith in neighborhood financial businesses.

National Evangelist Preacher in City

Rev. Paul Perkins, National Evangelist of the National Baptist Convention is in the city during the week of July 27th. He delivered his first sermon Sunday evening at the Union Baptist Church; Monday he preached at Burns M. E. Church; Tuesday at St. Paul's M. E., and Wednesday at Corinthian Baptist.

Thursday morning Rev. Perkins left for Fort Dodge for a series of engagements. Rev. Perkins through very young in age, has been preaching for fourteen years, during which time he has traveled over 22 states. He is accompanied on his evangelistic tour by his wife. He carried on a revival at the Maple Street church four years ago.

From reliable sources comes the information that the crash could have been averted if President Binga had agreed to resign from the active management of the institution. An entirely new personnel from chairman of the board down, had been planned by those who sponsored the replacement of the president and founder.

It is reported that the state bank officials at a meeting with the board of directors previous to the closing had informed them that if they could raise \$14,000 within a few hours the bank would remain open.

The general business depression and the vast unemployment which precipitated the closing of the bank, old timers believe, presages one of the most dreadful winters ever witnessed in Chicago.

The closing of the Binga bank, which has been regarded for years by both races throughout the country as one of the strongest financial institutions of the Race, will seriously affect business conditions here and in other large centers. National skepticism toward our business institutions will be felt, it is believed, as was the case following the closing of the Standard Life Insurance Company of Atlanta and the collapse of Brown and Stevens Bank in Philadelphia.

Boys' Y Camp Period in Session

The Crocker Street Department of the Des Moines Y. M. C. A. began its annual Y. M. C. A. Camp at Boone, August 6, with the largest camp of Negro youths in its history. Each year the Crocker Street Branch produces one of the largest camps for Negro lads in America for a single period.

The camp period this year will be directed by Gordon H. Kitchen, Executive Secretary of the work, former Grinnell athlete. He will be assisted by Henry F. Hasbrouck, of the local Y. M. C. A., along with a capable staff. Wright, Great Chicago Lawyer Is Dead

Hon. Edward L. Wright passed away at 5 o'clock Wednesday morning at the Mayo Brothers clinic in Rochester, Minn., where he had gone several weeks ago to undergo an operation.

His political activities had their beginning in the early 90's in Chicago with his election as South Town clerk, which position he held with credit and distinction.

In his upward trend he was elected and served two terms as a member of the county board, during which time he enjoyed the honor of serving as president of the board and also chairman of the finance committee.

The advent of Mayor William Hale Thompson as the leader of political affairs in Chicago again brought Edward L. Wright to the front as the recognized spokesman of his Race.

This new political setting gave him great force and influence, not only in local affairs, but extended his operations to state-wide circles. He was appointed by Mayor Thompson as Assistant Corporation Counsel.

BUS CARRYING WOMEN IN FATAL CRASH

Philadelphia, Aug. 7.—Huddled together helplessly, frantic, praying, screaming, as the bus in which they were riding tumbled down the side of the Savage Mountain at Frostburg, Md., at 80 miles per hour with locked gears and broken brakes; 22 members of the American-Womenmen awaited what seemed to be certain death on Monday night, July 27. They were part of the Philadelphia delegation to the American Womenmen's Convention who were returning from St. Louis, and were victorious in field drill and brass band competition.

Through the cool-headedness and courage of the driver, Joseph Mahon, the bus was kept on the roadway as it ran wild for at least two miles. Mahon was finally able to avert the car sharply to the right and succeeded in crashing into a cluster of trees, thus bringing the wild ride to a sudden end. By crashing into the trees, Mr. Mahon averted a worse tragedy, as the bus was headed directly toward a river which runs at the foot of Big Savage Mountain through the village of Frostburg, Md.

DePriest Names More Negro Candidates to West Point

Washington, Aug. 7.—Representative Oscar De Priest, Republican of Chicago, is entitled to make two nominations to the United States Military Academy for admission July 1 next, according to an announcement of vacancies at West Point by the War Department last Thursday.

The candidates nominated will be examined on the first Tuesday in March, 1931, with a view to admission on July 1.

Each candidate must pass a rigid physical examination. None is accepted who has any defect or infirmity which renders him unfit for military service. In addition, each candidate must pass an examination in the subjects of algebra, geometry, English grammar, composition, and literature, and history. Graduates of first-class high schools and students at universities and colleges of recognized standing, however, may submit educational certificates which will be considered by the Academic Board and if satisfactory may be accepted in lieu of the mental examination.

The pay of a cadet is \$780 a year and commutation of rations, at present fixed at 60 cents a day, making a total of \$1,072 a year.

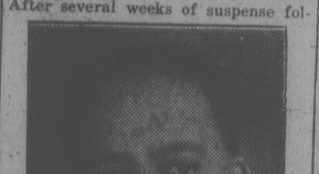
Iowans Form Branch of National Medical Society

St. Paul Church in Rally for Conference Claims

The pastor, officers and congregation of St. Paul's A. M. E. church are quite busy closing the work of the conference year. Just six months ago this congregation was left pastorless. After several weeks of suspense fol-



lowing the removal of Dr. C. M. Tanner to the pastorate of Wayman Chapel A. M. E. Church, Chicago, the cheering news swept over Des Moines that Rev. William E. Guy, one of the outstanding pastors of the A. M. E. connection, had been appointed pastor of St. Paul's.

Within these six months it is reported by the officers of the church that St. Paul's is in better spiritual and financial condition than she has enjoyed for many years. Old debts reaching back through four pastoral administrations have been wiped out.

Titling Rally Day

Dr. Guy and his officers are now in the midst of a campaign to raise the conference claims and report to the annual conference which meets in Cedar Rapids, August 26th, presided over by Bishop A. J. Carey of Chicago. The third Sunday, August 17th is to be observed as Titling Rally Day. Each member of the church is bringing to the church one-tenth of a two-weeks' income.

Rev. Robinson To Preach

In the afternoon, at 3 o'clock, Rev. G. W. Robinson will preach and Corinthian choir will sing.

On the fourth Sunday at 3 P. M. Reverends H. L. Overton, G. W. Regester, J. W. Goodall and their congregations will worship with St. Paul's. The Burns M. E. Church choir will sing. On that evening at 8 P. M. Dr. Guy will preach his farewell sermon—at least for this conference year.

It is the unanimous desire of the officers of St. Paul's official staff, the Bystander is reliably informed, as well as of the whole of Des Moines, that Dr. Guy shall return to the pastorate of St. Paul's A. M. E. Church—not alone for many years yet to come.

Rev. J. W. Tutt and Union Baptist Church choir worshipped with St. Paul's the second Sunday afternoon.

WATERLOO MINISTER WINS COURT BATTLE

Waterloo, Iowa, Aug. 8.—Rev. C. R. Waters, pastor of the Payne Chapel A. M. E. church, was the victor in a lawsuit against R. B. Pratt, owner of a root beer concession, located in a lobby of a theatre here, who refused to serve him.

In fining the defendant, who pleaded guilty to the charges, Judge J. J. Howard, of the municipal court, told Pratt that Waterloo treats all of its citizens alike, regardless of religion, race or color.

One Death

The one death that occurred was that of John Butler of 1600 N. Warnock Street, who leaped from the bus in an attempt to save his life just before the crash. As a result of the crashing the bus was completely demolished and 16 of the 22 occupants were painfully injured.

New Angle in Baptist Mystery Murder

Tuskegee Institute, Ala., Aug. 8.—The customary peace and quiet of the Tuskegee campus was shattered last week by the wanton and tragic murder of Miss Mary S. Booth, superintendent of nurses at John A. Andrew Memorial hospital, whose funeral services were held in the chapel Sunday afternoon.

As the clock in the tower of White Hall struck eight, Miss Booth, who, unaccompanied was enroute to Greenwood, the Institute community, was shot from the rear, when she neared the Alumni Hut on the road that leads from the hospital to the chapel. She fell, her body pierced by six bullets. Her unknown assailant fled back of the Alumni Hut and escaped through the truck garden.

Slayer of Teacher Still in Hiding

Efforts of school officials and law enforcement officers of county and town have as yet failed to uncover the slayer. Although conscious to the end, some three hours after the shooting occurred, Miss Booth was unable to tell who shot her, or give a motive for the crime. At her bedside in the hospital her sister Mrs. Moton, wife of the principal, stood up bravely under the shock of the most tragic incident that has come to Tuskegee.

It is a mystery to officials around the campus, why Miss Booth should have been attacked and by whom. They pointed out that the unfortunate nurse was beloved and respected by students, teachers and villagers, many of whom had come under care at the hospital.

Funeral Quiet

Despite the tension which gripped the community since the unprecedented tragedy, the funeral services at which the Rev. G. Lake Ines officiated, was calm and dignified, those who had known her and loved her holding their emotions in restraint.

Led by the Institute choir the vast audience swelled into "Steal Away" singing not with the customary carefree swing of the famous spiritual, but with a mournful and poignant sense of loss. Many who worked with her and knew her, hastily reached for their handkerchiefs to wipe away the tears which no longer could be suppressed.

"I've Done My Work"

And then after Dr. Will Alexander, Dr. Robert Taylor and other notables had paid their last respects to a truly great woman who had given her life in the service of others, and as the rays of the late afternoon sun came streaming through the stained-glass windows, Miss Anola Miller, stood up a lone figure and sang "I've Done My Work". Her voice rose softly, clearly and poignantly. In the second verse she trembled but in a determined effort, straightened and continued, the melody seeming to mingle with the soft weeping of many who sought the only natural way to assuage their grief.

Attesting the esteem in which they held Miss Booth, friends from the community, from Atlanta, Columbus, Montgomery, Selma and several other cities attended the funeral, while many others sent messages of condolence.

Associates Attend

The altar was banked with floral offerings. Forty registered nurses from the Veterans hospital, clad in the white uniforms of their profession occupied a reserved section in the chapel. Twenty-two women, being trained for the profession under Miss Booth, attended bearing floral designs.

Body To Virginia

Early the next morning from Alabama, from Tuskegee's rolling campus where she had lived and served faithfully bringing aid, cheer and comfort to the suffering, where she had enjoyed the richness of life, where she was known and beloved by all, to be buried in Virginia, her native state.

Woman Angle

Dr. Sutton E. Griggs, distinguished Baptist leader and author who has been in Chicago several weeks conferring with President L. K. Williams, left hurriedly for Nashville two weeks ago. Dr. Griggs is reported to have come out in the open and acknowledged that the most plausible theory of the myser murder of Auditor Pierson is that he came to his death as result of his being entangled with a Kentucky woman. Dr. Griggs states that this is the theory that was brought back to Chicago by the most famous Negro detective of this city, who was the first sleuth employed to probe into the auditor's death. Dr. Griggs is reported as saying that the detective informed his employers that there was not a chance in a hundred years of convicting Dr. A. M. Townsend or any of the other accused Baptist leaders being implicated in the murder of the auditor. Dr. Griggs uncovered an important bit of information in telling his fellow Baptist preachers at Nashville that the detective found that Auditor Pierson had made some 17 trips to Louisville within a short period prior to his death.

Funds Safe

McIntyre and Short, certified public accountants at Nashville, who for several weeks have been auditing the books at the Nashville publishing house, reported to the assembled members of the national Sunday School board of the Baptist Convention Wednesday of last week that their audit, covering a period of two years showed that there had been no "juggling" of funds at the publishing house and there was nothing irregular about the famous "\$62,000 loan" that has been the talk of the nation and named as the thing that brought about the death of Auditor Pierson. These accountants stated also that they found no other shortages or discrepancies at the publishing house. Dr. A. M. Townsend had stated that there was nothing about the \$62,000 that was irregular, and that the matter long since had been a closed incident. But failure of President Williams to tell the public the same thing caused the members of the board to employ expert accountants to audit the book for a period of two years, going back to the time when the loan was secured. Members of the board from various states assembled at the publishing house to hear the report. Upon hearing it a committee drafted resolutions acknowledging the report of the auditors and expressing their absolute confidence in Mr. Townsend, the accused secretary.

Of the many messages received only one was read—that from her associates at the hospital expressing their sense of loss and extending sympathy to the bereaved family.

Of course we don't hear about the other group for they are being denied admission, and are dismissed each year but it looks suspicious—having in mind the experience of the late Col. Young—that ALL Negroes are turned down eventually ALL the time.

THE Y CAMPS

This year more boys and girls went to the Y camps than ever before in spite of the financial depression. This fine showing is due to the assistance given by white and Negro civic organizations, and a general rise in sentiment in favor of the work in the Blue Triangle and Crocker Street branches.

The Negro in America

The world seems to have gone giddy on endurance records. We have them sitting on cactus bushes in Arizona, theatre balconies in Des Moines to 2:00 hour dances in Chicago. Maybe this is the reaction from watching these refusing contests; to see people heads thrown back watching guys whirl around and around for weeks that way at a time in this hot weather would make us dizzy.

The Negro churches of Chicago have an unique contest all their own: each is trying to outdo the other by seeing who can pay the most for second churches. Now comes a Congregation undertaking to buy a Jewish tabernacle at the handsome price of \$400,000. There is interpenetration in church extension just the same as in other enterprises. If you are going to put that much money into a church, why not put it into a new one? While we never doubt the efficacy of the church we do feel that such an enormous sum invested in a place of worship and nothing in a place to work and earn is far outside of the realm of common sense.

That sum of money invested in a business manufacturing shirts, dresses, handkerchiefs, hosiery, etc., controlled and operated by Negroes, would be more beneficial to our group, economically, politically, morally and spiritually, than all of the churches you could build from Lake Michigan to Caro street. It matters not how happy you may get in a \$400,000 Church on Sunday you can get so hungry during the intervening six days that your faith will be down to zero before next Sunday meeting. "Faith without work is vain."

We need better churches, but we are going at it the wrong way. First improve the economic status of the congregation, then the better the buildings will follow as a natural sequence. A means by which to earn an honest living for one's self and those dependent on one is a greater blessing to humanity than an altar of gold without such an opportunity.

We learn from the Bible, that the Ark of the Covenant rested in a tent from the time of Abraham to Solomon, until after the Jews had become an established nation with a capital city at Jerusalem, a period of more than two thousand years. Not until they had the visible means by which such an edifice as the great Temple of Solomon could be maintained, were they permitted to build a house of worship.

If the half million dollars that the nine thousand Negroes of Des Moines have invested in church property were invested in some line of productive industry, every idle man and woman could be employed, and we as a group would be far better off spiritually than we are now.

REDUCED RATES TO NATIONAL BAPTIST CONVENTION

VARIETY OF FOODS BEST AID TO HEALTH

CHICAGO.—Science has blasted the theory that nature has provided a single and complete food for the human body in some form or another, according to a bulletin issued here by the American Research Foundation.

"Pigeons and doves are more fortunate than human beings in having a single food provided for all their needs, since they can thrive readily on grain alone," says the bulletin. "But human beings must eat a wide variety of foods to obtain all the elements necessary to the health and well-being of the body."

"The average varied food ration contains plenty of vitamins and other elements needed to nourish and sustain the health. An adequate amount of fats is necessary, since fats supply energy to the body in the form of heat and power to work. Tests have proved that wholesome margarine, which is a combination of animal fats, vegetable oils, salt, and milk, supplies the body pound for pound with the same amount of heat and energy as any other fats."

90 PER CENT OF NATION'S BABIES DUE FOR RICKETS

CHICAGO.—The average baby has only one chance in ten of escaping rickets, dread deforming malady. "Ninety per cent of the babies of America have rickets in some form or another," declared Esther Ackerson Fischer, nationally known dietitian. "Prevalence of this disease could be reduced by proper preventive measures. Rickets is due to under-nourishment or to lack of a correct program of feeding and infant care. If mothers consulted their family doctors more frequently and followed their advice on nutrition and care, the ravages of this disease could be greatly lessened."

"Rickets occur most frequently in temperate zones and may be cured by giving the baby sufficient direct sunshine or by feeding him regularly a good grade of pure cod liver oil."

WASHINGTON, D. C.—Women who have made New Year vows to shun all fatty foods might as well haul down the "never again" sign and either resign themselves to rounded contours or find some other way of reducing. And here's why!

Something like one-third of the food the average American eats comes under the category of fat. It was explained by Dr. J. S. Abbott, secretary of the Institute of Margarine Manufacturers here.

"The average person on a diet may not realize he or she is eating fat," declared Dr. Abbott, "but they're getting it in large quantities in one way or another daily. It is essential to life."

There is fat in a surprising number of the foods we eat. The crumbly coconut covering on the layer cake the bridge club hostess serves is full of delicious fat. Mayonnaise and salad dressings are made with highly refined olive oil or cottonseed oil. A steak would not be fine and savory if it were not fat. The wholesome margarine, made from milk, vegetable oils, and meat fats, that goes on millions of American tables daily and into the cooking of toothsome dishes is another valuable source of fat supply. There is a fat content in milk, cream, and dozens of other articles of food.

So it's no use, girls. You're going to have to eat fat.

Recently we learned that the scandalous handling of federal patronage in the south had been eliminated—meaning no doubt that control had been placed in the hands of the lily-white element. Now comes word that the Washington authorities and the southern republicans are at odds over the disposition of federal patronage. Sure, why? We are inclined to believe the Washington authorities are demanding something which the southern republicans cannot do—deliver the electoral votes in succeeding elections to the republican party. Somebody will realize eventually that it is better to keep what you can hold than go after something you cannot get.

OUR ANNIVERSARY EDITION

The Iowa Bystander is one of the oldest institutions in Iowa operated by Negroes. Shortly it will close its thirty-seventh year. It has not been the custom to publish anniversary issues, other than twenty-fifth or fiftieth years. However, beginning this year, the paper will issue a special edition annually.

ANOTHER

The Negro in America

The world seems to have gone giddy on endurance records. We have seen sitting on cactus bushes in Arizona, theatre balconies in Des Moines to 2:00 hour dances in Chicago. Maybe this is the reaction from watching these rearing contests; to see people's heads thrown back watching guys whirl around and around for weeks that way at a time in this hot weather would make us dizzy.

The Negro churches of Chicago have an unique contest all their own: each is trying to outdo the other by seeing who can pay the most for second churches. Now comes a Congregation undertaking to buy a Jewish tabernacle at the handsome price of \$450,000. There is intemperance in church extension just the same as in other enterprises. If you are going to put that much money into a church, why not put it into a new one? While we never doubt the efficacy of the church we do feel that such an enormous sum invested in a place of worship and nothing in a place to work and earn is far outside of the realm of common sense.

That sum of money invested in a business manufacturing shirts, dresses, handkerchiefs, hosiery, etc. controlled and operated by Negroes, would be more beneficial to our group, economically, politically, morally and spiritually, than all of the churches you could build from Lake Michigan to Caro street. It matters not how happy you may get in a \$450,000 Church on Sunday you can get so hungry during the intervening six days that your faith will be down to zero before next Sunday meeting. "Faith without work is vain."

We need better churches, but we are going at it the wrong way. First improve the economic status of the congregation, then the better the buildings will follow as a natural sequence. A means by which to earn a honest living for one's self and those dependent on one is a greater blessing to humanity than an altar of gold without such an opportunity.

We learn from the Bible, that the Ark of the Covenant rested in a tent from the time of Abraham to Solomon, until after the Jews had become an established nation with a capital city at Jerusalem, a period of more than two thousand years. Not until they had the visible means by which such an edifice as the great Temple of Solomon could be maintained were they permitted to build a house of worship.

If the half million dollars that the nine thousand Negroes of Des Moines have invested in church property were invested in some line of productive industry, every idle man and woman could be employed, and we as a group would be far better off spiritually than we are now.

REDUCED RATES TO NATIONAL BAPTIST CONVENTION

HEALTH TALKS

ULCER OF THE STOMACH

Stomach diseases are very common and the variety of ailments that occur in this organ makes it necessary to single out the one that is causing the disturbance. It is so often termed Gastritis that this may mean anything from nausea to cancer of this organ. Occupying the middle position between the mildest of stomach complaints and the most serious is one that takes its toll in disability and is often overlooked and is known as ulceration of the stomach. An ulcer wherever found but is much easier to heal one that can be seen and very difficult to heal one which is out of sight more so when there is some doubt in the mind, that such a condition exists. The symptoms are so distinct, and regular in some cases that no mistake can be made and in others so vague that it takes every means at the command to define the exact nature of the condition. The stomach has much work to do and because it has a variety of foods introduced into it at regular or irregular intervals little or much or too much as the case may be, this in solid or liquid form. The introduction of the wrong food or (2) 121 Bystander

liquid in overdose is liable to be beginning of this ulceration and the constant and regular introduction of wrong foods or liquids a source of irritation which prevents the healing of an ulcer once begun. Hence, it is necessary in every case to prescribe a diet as the first step in the cure of this condition. This diet must be rigidly followed if cure is to be expected.

Chicago, Ill., Aug. 1.—Poro college has moved its headquarters to Chicago. Mrs. Annie M. Malone, founder and owner of the famous institution, made the announcement this week in a letter which was sent to the more than 50,000 agents affiliated with this organization and who are scattered throughout every nook and cranny of the country.

It has been known for some time in business circles here that Mrs. Malone was quietly acquiring extensive real estate holdings in Chicago. She now owns the entire block on South Parkway, formerly Grand boulevard, between 44th and 45th streets. This block in former years was occupied by a group of multi-millionaires, John R. Thompson, the restaurant man; Thomas Carey, the brick magnate, and other ultra wealthy men built the magnificent houses surrounded by expansive lawns which fill the block. These buildings have been remodeled and for the present will house the various departments of the business. One structure for some time has been occupied by the College of Beauty Culture.

Poro block will be the designation of this new Poro home. Mrs. Malone is said to have plans for a pretentious building program, but no announcement of her intentions in this regard has been made public. Mrs. Malone did, however, issue a statement in which she explained the transfer of the business from St. Louis to Chicago.

Entire Staff Goes

The gigantic task of moving Poro, undoubtedly the largest manufacturing enterprise within the group, from one city to another was accomplished with the precision and dispatch for which the organization is famous. Everything was planned. It is said

that shipping and correspondence suffered only one day's delay. Nearly a special freight train was required for transportation aside from the fleet of motor vans which brought loads of special equipment over the highway.

Practically all of the managerial, clerical and manufacturing personnel moved to Chicago with the business. Many whole families moved to Chicago, so as to be with members who were working in the organization and wished to retain their places.

Famous Building Abandoned

A few employes have been left at St. Louis to care for the Poro building, which is being kept open to accommodate the public which has been accustomed to its hospitality. A branch office is to be maintained there. Just what disposition will be made of the building, however, has not been determined. Mrs. Malone is said to prefer that the building which has been a sort of community center to St. Louis be used in some manner which will continue it in the service of the community, rather than to accept offers to convert it into an industrial site.

To "Turn State's Evidence"

In such cases there is generally an express or implied promise on the part of the authorities that they will not prosecute the witness who thus testifies, or that he will at least be dealt with leniently. Prosecutors do not usually promise such immunity unless there is insufficient evidence to convict the defendant without the testimony in question. —Pathfinder Magazine.

Airplane's "Flying" and "Cruising" Speed Differ

Cruising speed of an airplane is the speed at which it runs to best advantage considering oil and fuel consumption rate, vibration, laboring of and strain on motor. In other words, the speed one would care to run the motor (or airplane) on a long trip so that one would not burn up too much gas per hour at, perhaps, a slightly lower motor speed at, perhaps, no decrease in airplane speed; so that the motor would not waste oil; so that the motor would vibrate least; so that the motor would take it most easily. Comparable to an automobile there is top speed—say 85 miles per hour—and cruising speed (speed at which a car runs most smoothly with not too much strain on steering, say at 30 miles per hour). In a plane, top speed might be 105 miles per hour; cruising speed, 90 miles per hour. Speed necessary to keep the plane in air is called flying speed. Minimum flying speed is called stalling speed. Landing speed is usually about two miles per hour greater than stalling speed.

TELLS BEST OIL FOR WINTER USE

NEW YORK—An oil theory that motorists should use lighter oil when cold weather strikes has been exploded by the American Research Foundation which has just issued a bulletin explaining why it is a mistaken notion that winter driving necessitates lighter oil than summer driving.

The reasons, as pointed out in the bulletin, are:

"First, in cold weather the clearance between the piston and cylinder is greater and in starting the gasoline leakage will be much greater than at its normal operating temperature.

"Second, leakage of gasoline past the piston rings into the crank case has a greater effect upon the diluting, or thinning, of the motor oil in cold weather than in warm.

"If thinner oil, therefore, is used in cold weather to facilitate starting, this oil will become too thin under operating temperatures to properly lubricate the engine parts during the operation," the bulletin states. "The lubricating oil will also be too thin to produce the proper seal on the piston rings, thereby further increasing the gasoline leakage and resulting in loss of power."

WHITE PLAINS NEGRO COMMITTEE REFUSES TO ACCEPT LEADERSHIP DICTATED BY WHITE SEGREGATIONISTS

New York, Aug. 1.—The colored committee of the White Plains Y. M. C. A. is insisting on choosing its own leaders and at a meeting on Tuesday, July 29th, refused to accept the leadership selected for it by the members of the white Board. The members of the colored Y. M. C. A. Committee informed the Board that they must reserve the right to select men in whom they have confidence and that they wished leaders of the type of the

committee members who were dropped by the Board, because they moved into a white neighborhood. This impasse has grown out of the summary discharge of Secretary Samuel Morsell because he lodged with Dr. Collymore, who moved into a white neighborhood and the dropping of Dr. Collymore and Dr. Williams from the Board, because they refused to move from the white district when their presence was protested.

Dr. Collymore informs the N. A. A. C. P., which has been acting in his behalf, that he is assured of the renewal of his fire insurance, which was cancelled, and that the opposition has quieted.

GOVERNOR URGED TO THROW OUT NEGRO PRIMARY VOTE

Memphis, Tenn., August 7.—L. E. Gwinn, candidate for Governor, has urged Governor Horton, who is a candidate for re-election, to throw out all ballot boxes that contain votes cast by Negroes in the coming Democratic primary. Gwinn states that the Democratic primary belongs to the white folks and that Negroes should not be allowed to participate therein. "A decent consideration," said Gwinn, "for the white Democrats of Tennessee requires that participation in the primary be limited to white Democrats. Every man in Tennessee above the in-

telligence of a half wit knows that a Negro Democrat is about as scarce as a hen's tooth and unless the Democrats of Tennessee have abandoned the fundamental principle of the South of white supremacy—the keynote of Democracy in the South—they will join in the demand that the contest between Governor Horton and myself be decided by white Democrats of Tennessee.
