### Attorneys Agree on Bail Fixed by Judge

Scottsburg, Ind., Sept. 19.—A murder plot of amazing cruelty involving the lives of several leaders of the National Baptist Convention, Inc., was disclosed here today for the state and for the defense rested at the conclusion of testimony in the court action described as the general denial to the return for the writ of habeas corpus and the plea for admission to bail in behalf of George Washington, indicted for first degree murder in convention with the death of Edward D. Pierson, auditor of the convention.

Despite the evidence disclosed, however, Judge John R. Carney of the sixth judicial circuit in Indiana, allowed the plea for bail and the amount was set at \$10,000 through the agreement of the opposing counsel.

Pierson was found with six bullets in his body, neck and feet tied with ropes to which had been attached a spitcase and a grip, clinging to a willow branch on the bank of the Muscatuck river, April 16th.

George Washington, Indianapolis gunman, Arthur M. Townsend, Sr., secretary of the publishing board of the National Baptist Convention, Inc., and Arthur Townsend, Jr., his son, were indicted for the murder in June after Washington had been apprehended and is said to have confessed.

The governor of Tennessee has denied Indiana extradition of the Townsends. It was said that since they were not in Indiana at the time of the murder they could not be considered fugitives from justice.

Washington, the 35-year-old alleged slayer, is considered somewhat of a hero in this little town, who is getting its first big thrill since the ending of the World War. He is allowed more liberty than any of the other prisoners in the city bastille.

### Baptists Meeting at Ottumwa

On Monday, Sept. 15th, the Women's Home and Foreign Missionary Convention Auxiliary to the Iowa-South Dakota Baptist Association, opened this year's annual meeting. The association proper, opened its meeting Sept. 18, with Rev. G. W. Robinson, Moderator, presiding. The host of the association is the Second Baptist church of Ottumwa, whose pastor is Rev. T. T. Lovelace. This year's program was arranged under the direction of the executive secretary, Rev. J. W. Tutt.

### Ohio Republicans Condemn Lynching

Columbus, Ohio, Sept. 19.—Ohio Republicans assembled here at a state convention last week, took a vigorous stand against lynching on the platform adopted. A section of the platform reads: "The republican party favors the enactment and enforcement of adequate laws, state and federal, to prohibit lynching, and promises its party influence in securing such national legislation as to suppress this national disgrace."

Race delegates to the convention consisted of State Representative Perry B. Jackson of Cleveland and Atty. William B. Rush of Cincinnati.

### Connecticut Governor Takes No Chances on Alabama

#### NEGROES COMMIT SUICIDE LESS THAN WHITES

New York, Sept. 12.—That suicide in the United States is almost entirely confined to white people, is the statement made by Louis I. Dublin, statistician of the Metropolitan Life Insurance Company, writing in the September Harper's Magazine on "To Be or Not To Be?"

His conclusions concerning the racial incidence of suicide, as excerpted by the N. A. A. C. P., are as follows: "Suicide in the United States is almost altogether limited to white people. Among our eleven million Negroes there are annually only about five hundred cases of self-destruction. This fact is particularly significant since it is among the colored people that the very highest homicide rates prevail. There is, therefore, apparently little ground for believing that suicide and homicide go hand in hand, and that both reflect a contempt for human life."

### Negro Hospital Needs Outlined

New York, Sept. 12.—The hospital needs of the American Negro are outlined in an address on "Hospital Provision for the Negro Race", delivered by Dr. Peter Marshall Murray before the Annual Congress on Medical Education, Medical Licensure and Hospitals in Chicago, of which Dr. Murray has sent a reprint to the National Association for the Advancement of Colored People.

In his address Dr. Murray states that although there is one hospital bed for each 139 persons in the country, there is only one for every 1,941 Negroes. New York through Harlem Hospital and Cleveland through its City Hospital, have become leaders in opening up municipal hospital facilities to Negro patients, doctors, and nurses, Dr. Murray points out.

New York, Sept. 12.—Governor John H. Trumbull of Connecticut has refused to honor extradition papers from Alabama, demanding the return there from Hartford of Johnny Williams, charged with the murder of Ethel White, a nineteen-year-old white girl, in Henry County, Alabama, after the Hartford branch of the N. A. A. C. P., urged Governor Trumbull not to permit the extradition.

Governor Trumbull told the officers he could not honor the extradition papers because a grand jury in Alabama had failed to indict Williams six months after the crime, which had been committed in 1928. There was therefore no legal indication that Williams was in any way connected with the murder. Williams had been working for a year and four months in Hartford, in a barrel factory, before the extradition attempt was made. Williams was represented by Benedict M. Holden, and Howard P. Drew, attorneys who had been retained by the Hartford branch of the N. A. A. C. P.

### Interracial Committee Begins Fall Sessions

The Des Moines Interracial Commission held its first fall meeting since adjournment last spring at the Y. M. C. A. Monday evening, September 15th.

The program consisted of a report by the chairman, Atty. James B. Morris, and an address by Mrs. S. Joe Brown covering her recent trip to Europe. She gave a brief outline of her activities from the time of leaving Des Moines until her return with particular reference to the splendid reception given the Negro delegates by the European women. Many photographs were exhibited during the address, illustrating the trip.

### MME. WALKER SALESMAN VISITS IN DES MOINES

Mr. George J. Harzen, national traveling salesman of the Mme. C. J. Walker Co., of Indianapolis, Ind., was in Des Moines this week calling on a number of drug houses in the interest of the company. Mr. Harzen is the inventor of the special cap which the company has on sale.

### Colored Voters Urged to Query Candidates on Issue

New York, Sept. 12.—Eighteen lynchings as compared with twelve for the entire year 1929, have brought about a determination in the N. A. A. C. P. to campaign anew for the enactment of a federal anti-lynching law. Attorneys of the N. A. A. C. P. under the leadership of Arthur B. Spingarn, chairman of the National Legal Committee, and Herbert K. Stockton who has exhaustively studied the measure, are already at work going over the bills introduced in past sessions of Congress with a view to drafting a measure with teeth in it.

Besides the eighteen lynchings officially listed as such by the N. A. A. C. P. there are reports of five others, the details as yet unverified and the N. A. A. C. P. is making every effort to obtain proof that they occurred. If details can be obtained, these additional reported but as yet unverified lynchings will be added to the year's total.

In announcing the decision to campaign for a new federal anti-lynching law, Walter White, Acting Secretary of the N. A. A. C. P. made the following statement:

"The nearest we ever got to the enactment of a federal anti-lynching law was in 1922, when the House of Representatives passed the Dyer bill by a vote of 230 to 119, and a filibuster of southern senators from lynching states forced withdrawal of the measure."

"The threat of that bill did bring about a sharp reduction in the number of mob murders. And the N. A. A. C. P., hoping that an aroused public opinion would be come effective in stamping out this American disease, held in abeyance its demand for federal action."

### Spingarn Medal Award Set for Later Date

New York, Sept. 12.—By a resolution of the Spingarn Medal Award Committee, the medal, presented annually for most distinguished achievement by a United States citizen of African descent, is to be awarded earlier in the year than formerly.

Instead of meeting early in June to designate the recipient, the Award Committee has decided to meet early in the year, in the month of January or February. The medal will continue to be presented as heretofore at the Annual Conference of the National Association for the Advancement of Colored People.

The reason given for pushing forward the date of the Committee's meeting is that it is desired to avoid confusion in the public mind as to what period of time was covered by the award. Heretofore, when the medal was awarded in June, it was believed by some that the elapsed months of the new year were included in the Committee's considerations. By making the award in January or February, it will be clear that only the passed calendar year up to December 31, and the preceding years, are included in the scope of the award.

### ELECTRIC HEATERS FOR STREET CARS THIS WINTER

Installation of electric heaters in twenty-six additional Des Moines street cars is now under way, Des Moines Railway company officials said today. The use of coke-burning stoves is being gradually eliminated by the company.

This winter, a total of one hundred and five cars will be equipped with thermostat-controlled electric heaters, compared with twenty cars electrically heated last winter.

In addition, all cars in service are to be equipped with special electric heaters placed directly under the front windows. These heaters will keep the operators' hands warm in zero weather, and will prevent frosting of the front windows.

The new electric heat system is operated automatically and produces an even temperature at all times in all parts of the car. It eliminates unsightly kindling and coke boxes, and conserves the time of the operator.

### Millions of Hours Lost by Disabling Illnesses

On an average, each person in the country has at least one disabling illness every year, the committee on the "cost of medical care" has reported after a survey of various sickness reports compiled by the United States public health service and other organizations.

There have, according to the report, once a year, women about twice and children one twice during the school year. Colds, bronchitis, grippe, influenza and pneumonia are the most common causes of these disabling illnesses and cause the longest disability. On the same basis of the number of cases and total time lost, digestive disorders and diseases also take a high place.

About 180,000,000 cases of disabling illnesses occur in the United States each year. Adding nondisabling illnesses more than doubles the figure, the committee reported. The 36,000,000 wage earners in the country lose at least 250,000,000 work days a year, and the 24,000,000 school children lose 170,000,000 school days a year. These figures account for only one-half of the total population.—Kansas City Star's Science Service.

### Republican Voters Organize; First Meeting Draws Many

Negroes from fourteen cities in Iowa met at McCree Hall, East 15th and Filmore, Thursday, Sept. 11th, and formed the Iowa Republican Negro Voters' League.

The preliminary work had been a matter of a long time and was jointly worked out by the Lincoln Club of Waterloo, J. H. Patten, Chairman, East Des Moines Booster Club, Harry E. Wilson, Chairman, and Des Moines Community Forum, W. C. Adams, Chairman, and without question, proved a success beyond their expectations.

The meeting was called to order by J. G. Browne, Des Moines, who explained the nature of the meeting and presented J. H. Patten, Temporary chairman, Harry E. Wilson, temporary secretary. Rev. G. W. Robinson, state moderator and pastor of Corinthian Baptist church who opened the meeting with peppy talk and a prayer. Mr. W. C. Adams, Chairman of West Des Moines Forum offered a motion to declare the organization a permanent with officers as follows: State conventional chairman and executive director, Rev. J. H. Patten, Waterloo; State District Chairman, J. G. Browne, Des Moines; State District Co-Chairman, Atty. Gertrude Rush, Des Moines; General Secretary, Harry E. ### N. A. A. C. P. WATCHES "BLACK SHIRT" MOVE TO OUST NEGROES FROM JOBS

New York, Sept. 12.—The N. A. A. C. P. is closely and carefully watching the newly organized "American Fascist Association" or Black Shirts, organized in Georgia for the purpose of replacing Negroes in jobs with white men. While the new organization professes Kean principles its program is economic and therefore a danger to Negro wage earners.

To date the American fascists have had rough sledding. "Time" for Sept. 8th, reports they received an editorial drubbing from the Macon "Telegraph" which calls the black shirt organization "the newest nasty thing". The Atlanta "Constitution", according to "Time", reports a Federal Grand Jury investigation coming into the threats alleged to have been made by black shirts against employers to bring about discharge of Negro labor. A federal statute provides ten years in jail or \$5,000 fine for conspiracy "to injure, oppress, threaten or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States."

The N. A. A. C. P. is also informed that the black shirts were active in Sherman, Texas, at the time of the recent lynching, threatening white employers of colored labor. Some of the white employers had their colored employees stay with them overnight to assure their safety.

### CLARENCE DARROW SENDS CLIPPINGS RECOUNTING NEGRO MUSIC TRIUMPH

NEW YORK, Sept. 5.—Clippings forwarded by Mr. and Mrs. Clarence Darrow from Chicago tell of the triumph there of a chorus of 1,000 colored singers in the recent musical festival held before an audience of 150,000 people.

In one of the clippings from the Chicago Tribune, James O'Donnell Bennett reports that "the colored brethren have 'stolen the show.' Everybody is glad." He also singles out the Negro singers for their work in the large chorus, writing of them: "The bulwark of this mass of vocalists was of course the 1,000 Negro singers. Nothing could go wrong with them—so proficient, so powerful and so confident to buttress the situation. The white singers loyally let them command the movement, the intricacies and the climaxes of the noblest hymn of adoration ever written."

Rev. W. H. Griffin, another former pastor at Des Moines, who is now pastor at Grant Memorial church, 46th and Evans, is one of the most active ministers in the conference.

### RADIO STATION RULES OUT DISCRIMINATION AFTER PROTEST

New York, Sept. 12.—Protest to radio station WOR, at discriminatory remarks made by a speaker from its studio, has brought assurance from that station that such remarks would not be permitted in future, according to information sent to the N. A. A. C. P. of New Brunswick, N. J.

Dr. Miller reports that on the third of September, one Clifford Parlin broadcast an invitation to citizens of New York City who were "twenty-one and white" to come to the offices of his firm for instructions as to how to make money in their spare time. Dr. Miller at once telegraphed protest both to the speaker and to the radio station.

### Pepper Production

Black and white pepper comes from southern India, Sumatra, Java, Ceylon, Siam, Borneo, Penang and other parts of the Malay peninsula. Black pepper consists of the dried immature berries of a perennial climbing shrub called Piper nigrum, native to the forests of western and southern India. White pepper is practically the same product as black pepper except that the outer shell of the berry is removed to a greater or less extent by friction following soaking in water. Red pepper is the powdered ripe pod, both flesh and seeds of any variety of capsicum, the plant which gives us the edible fresh pepper, but which bears no relation to the true pepper plant. Cayenne pepper is, by ruling of the board of food and drug inspection of 1906, distinguished from red pepper as being obtained only from small-fruited varieties of capsicum.

It is impossible to long deny full recognition to a group that can produce in so short a time so famous a personage. That the Negro woman has arrived, there is no question. Records of history are constantly growing fairer and fairer, and in due course of time you will just be an American.

held in the beautiful rooms of the Hofburg, the old imperial palace, which will lend to this "Parliament of Women" dignity fitting for an assembly held under the auspices of the "Mother of the League of Nations".

That a great deal of ability to promote Universal Peace, lies with the women of the world, was the general conclusion of the one thousand women delegates from forty-six countries, who made up the International Council of Women, May 26th to June 8th of this year.

But before attempting to give you my findings, I feel that I should give you something of the formation and past history of this world-wide organization, which had its origin in the minds of some of our American women; and, its genealogical tree reads somewhat as follows:

The Declaration of Independence beget the Anti-slavery Cause and the "Woman's Rights Movement". The Woman's Rights Movement took for its advance leadership, the Woman Suffrage demand and led to the crusade against the social evil and the saloon, and gave birth to higher education of women, their new professional opportunities; and an increasing achievement of equality with men under the law, in personal and property rights.

The industrial revolution which transferred the center of labor from the household to the factory, gave new leisure to the house mothers and started their organization for social service, thus enlarging the mother office to world ministry.

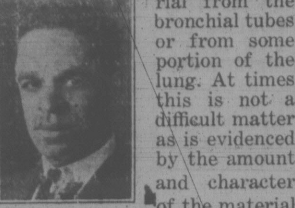
This same industrial revolution gave the mass of women the "feel" of the pay envelope on the palm; and enlarged the scope of women's self-supporting activities, while it specialized their functional skill.

The new ambitions and experiences, these twin results of the new machine-dominated industrial order, gave birth to business and professional alignments of women, on the one side; and led to the Club Movement on the other. Of these twin were born the Association for the Advancement of Women, which brought together the already achieving great personalities among women.

HEALTH TALKS

COUGH



A cough is an effort on the part of Nature to expel some offending material from the bronchial tubes or from some portion of the lung. At times this is not a difficult matter as is evidenced by the amount and character of the material coughed up but at other times in spite of the strength and length of the cough nothing is obtained.

A cough is not always prompted by the necessity of having something removed from the passages. There are different varieties and different causes. Some are necessary and others cause great harm to the passages and lung tissue, the injury increasing with the length of time the cough continues. The old idea that anyone was liable to catch cold in the winter time seems now not quite correct as a very great number could be listed who cough through winter after winter without a single cough. A reason for this immunity exists and is dependent upon some factor or combination of things. No doubt it is accounted for by the normal functioning of every organ and part which is the result of the proper taking of food, sufficient rest and attention to all conditions which are known to produce a state of health. Unknown factors undoubtedly exist. At any rate a cough should be treated at its beginning to ward off any serious result which often arises from its continuance.

The Negro in America

The Negroes of Iowa have organized a state-wide republican voters league, for the sole purpose of securing for the black citizens of this commonwealth the rights guaranteed to them under the constitution. The promoters of this movement have worked for the betterment of all members of our groups. They are not accepting pay, are seeking recognition; there is no dollar mark attached to their service, because they realize that the only success worth while is that built upon the confidence of those whom they serve. They know that "A good name is rather to be chosen than great riches." They issued the call to their fellow-men throughout the state and frankly told them that it was a movement in which every participant must bear his part of the burden, that their hope of reward lay in future results, that the only thing in sight just now was self sacrifice and toil. They answered the call, loyal hearts and true, from north, south, east and west, with nothing but themselves to offer as living sacrifices on the altar of service. Was it not grand that they bowed in prayer and invoked the benediction of the Grand Master of the universe? Could you not feel the deep earnestness as their voices swelled in that song of hope? Under such auspices there can be no failure: Thus was the "Negro Republican Voters League of Iowa" ushered into being. If you love your race and want to help in its uplift, there is only one way to prove it: help this movement. If there are any improvements you can make, come in and make them; you are welcome. This is not an effort in which the sponsors "presume to be all sufficient. Any wholesome, progressive, unselfish suggestion will be given a respectful hearing: we want your support, the task is so great we need you and earnestly solicit your co-operation. The grand success of Thursday, September 11th, has not puffed us up, nor swelled our heads; we have had the opposite effect. It has filled us with humility; we realize that we are on the brink of wonderful possibilities and want you to realize it also.

TOURISTS INFLUENCE U. S. EATING HABITS

CHICAGO.—What Uncle Sam spreads on his bread is due in large measure to the influence of American tourists returning home with a liking for European eating habits. "In the case of both butter and margarine the influence of foreign travelers is apparent," says a bulletin of the American Research Foundation. "The demand for a light-colored, milk-flavored spread for bread, such as trans-Atlantic travelers are served in Europe, has caused manufacturers to adopt this type in America. "Similarly the shift from a high color to a straw color in the spreads for our bread, is attributed by many to the influence of European tourists. The wide-spread use of margarine in Europe is having a profound effect in promoting the popularity of this toothsome product in America. The American traveler abroad finds margarine on the table in the most fashionable cafes and restaurants of the Continent. He acquires a liking for margarine and naturally asks for it when he gets back home."

URGE REPEAL OF TAX

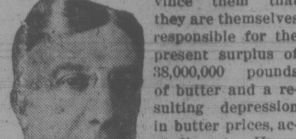
CHICAGO.—Repeal of federal and state license taxes on retail grocers who sell margarine will be sought by the National Association of Retail Grocers, it was disclosed in the recent annual meeting of the board of directors here.

The association representing 80,000 retail grocery establishments in the United States regards these taxes as an "unjust discrimination against both grocers and consumers," according to H. Janssen, of St. Paul, secretary.

URGES DAIRYMEN TO ADOPT DANES' FARMING SYSTEM

CHICAGO.—Unsound advice is being given to American dairy farmers in an attempt to convince them that they are themselves responsible for the present surplus of 38,000,000 pounds of butter and a resulting depression in butter prices, according to Harry Edward Freund, noted economist and lecturer.



Freund cited the case of Denmark, recognized as one of the world's most thrifty and prosperous countries, to prove his contention that American farmers are receiving "unsound advice" when they are told to "eat more butter and keep the prices up." Instead, he said, American farmers should be advised to follow the thrifty Danes toward economic stability by "making good butter and eating wholesome substitutes if economically advisable."

"Denmark relies almost entirely on its dairying industry for prosperity," Freund pointed out. "The people of Denmark consume nearly sixteen times as much margarine per capita as do Americans. Yet the Danes are noted for their sturdy health and physical development. The death rate in Denmark from tuberculosis, various forms of kidney diseases, and other ailments due to improper diet is about 30 per cent less than the death rate from similar causes in the United States."

"While the Danes ship their butter abroad, they are great milk drinkers and patronize their dairies for milk and cream to a much greater degree than do Americans. And thus they avoid vast butter surpluses. "American dairy farmers would do well to follow the successful Danish plan rather than the economically unsound advice of those whose chief aim seems to be 'blame the farmer.'"

CURING COLDS COSTS WORKERS \$50 YEARLY

CHICAGO.—Catching cold is an expensive pastime. Among other things it costs the average American worker \$50 a year for time off from his job and doctor bills for curing up colds. "Sneezes, coughs, sore throats, sniffles, and wheezes and the impaired efficiency which common colds impose on the nation's army of workers result in an economic loss to the United States of more than \$200,000,000 annually," declared Ferdinand A. Bunte of Bunte Brothers, Chicago candy manufacturers. "The nation's bill for cough drops alone, to alleviate colds, runs into millions of dollars a year. "Children constitute one of the biggest groups suffering from colds, and rank as large consumers of cough drops. Many parents instead of dosing their youngsters with syrups which upset the juvenile stomachs, soothe their little throats with cooling menthol in candy form."

### COVERALL APRON SAVES WASHING FOR HOUSEWIFE

There's no excuse for any woman going about her work looking disheveled and unattractive. House frocks of today, even the least expensive ones, are smartly cut and becomingly trimmed. The houndstooth, worn while working, has mercifully disappeared. Work aprons of the quickly soiled and easily mused variety have been displaced by sturdy yet attractive aprons of rubberized gingham which save and protect the dress underneath.

Every housewife needs at least two or three of flickery coverall aprons. One should be kept for general work about the kitchen—preparing vegetables, baking and cooking. Another should be kept for cleaning days when there is heavy, dirty work to be done and, where there is a baby in the family, a third apron should be kept for



wearing when he is bathed, changed or dressed, and should be kept handy in the bathroom or nursery.

And here's a secret—in one household at least, the head of the house insists on having a rubber work apron all of his own! It's a fact! He sometimes offers to help dry the dishes or is pressed into service for opening obdurate jars and whipping the cream. 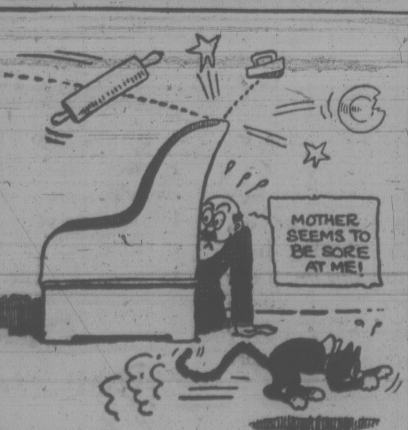
