CONG. OSCAR DEPRIEST IS REELECTED

Negro Representative Wins in Spite Demo Landslide

The first congressional district in Illinois has re-elected Oscar DePriest to represent them in the House of Representatives.



DePriest drew much comment when he advised his people not to follow the suggestion of Mayor Thompson and vote for J. Hamilton Lewis. Many believed that he would not be returned. However his district remained republican and DePriest piled up a majority over his democratic opponent, Harry Baker.

DePriest's district is the second richest district in the United States according to unofficial returns.

Judge Albert George, along with nine other republican judges, lost in the democratic landslide.

Iowa G. O. P. Wins Tuesday Election

Dan W. Turner of Corning, Republican, wrestled a two-to-one victory from Fred P. Hagenmann, democrat in the gubernatorial race, while L. J. Dickinson of Algona, Republican, unseated Daniel F. Steck, Democratic incumbent, in the senatorial race in Iowa. Turner's lead reached about 155,000 while Dickinson's passed 65,000 votes.

Motorist Held in Kiser Death

On Friday night, Oct. 31, an automobile driven by R. V. Hoop, 37, Stuart, Iowa, struck and killed Mrs. Bessie Kiser, 31, 350 Tenth street, on Keo Way.

Mrs. Kiser was crossing the intersection of Twelfth Street when she was struck by Hoop's machine. The shock was so severe that she died immediately. Police arrested Hoop and charged him with intoxication and operating an automobile while intoxicated. A companion in the car with Hoop, Carl McComly, 40, of 2117 Southwest Ninth street, also had been drinking and was arrested on a charge of intoxication.

Hoop pleaded not guilty to a charge of manslaughter in municipal court Saturday. The charge was changed to manslaughter after an investigation by traffic officials. A \$700 bond was placed on Hoop awaiting a hearing on Nov. 10th.

Laurence Jones Addresses Miss. Conference

WHITE YOUNG PEOPLE OF MISSISSIPPI M. E. CHURCH INVITE NEGRO TO ADDRESS THEM

Prof. Laurence C. Jones, founder and principal of the Piney Woods School has returned to Des Moines after a flying trip to Mississippi where he was called to deliver the opening address of the Methodist Young People of Mississippi, an organization representing the entire white Methodist church of that state. The meeting was held in the auditorium of Whitworth College, Brookhaven, Miss., which was only a few blocks from where two of our group were lynched last summer because of a dispute with an oil station man.

The address of Principal Jones developed "The Spirit of Interracial Good Will and Cooperation", in which he summarized the race who were intolerant and bigoted and therefore failed in their mission and the races whose prosperity are due to practicing peace and good will. After the address Prof. Jones was invited to deliver the same address to three white Southern churches.

He was accompanied on the trip by Frank Mathews, senior college student of Simpson College who was granted a week's leave of absence by the college to make the trip and by Hubert Jones.

CAPITAL CITY PROGRESSIVE LEAGUE HOLDS POLITICAL MEETING

The shout of "vote the ticket straight" reverberated at two enthusiastic rallies which ended the Republican party's speaking campaign here last Friday night, Oct. 31.

Congressman C. C. Dowell and the Hon. H. E. Spangler, chairman of the state Republican central committee, were among the speakers at Amos Hiatt Junior High school. The meeting was sponsored by the Capital City Progressive League.

In a brief talk Chairman Spangler pleaded that the Republican voters go to the polls and prevent President Hoover from being "hampered by democratic opposition."

S. Joe Brown appeared on the platform on behalf of the candidacy of Judge Loy Ladd and Mrs. Agnes Lee Hermansen, county recorder. Brown said it was up to party organization to elect Judge Ladd for the short term beginning November 4 and ending December 31, by writing Ladd's name on slide No. 22 of the voting machines.

William C. Walker, republican nominee for sheriff, declared that he was willing to face any propaganda that might be circulated against him.

Other speakers at the rally were the Hon. J. W. Long, state auditor, and Mrs. Hermansen. Elbert R. Hall acted as chairman of the meeting.

N. J. TUBERCULOSIS HOSPITAL COLOR BAR TO BE INVESTIGATED

New York, Oct. 31.—Reports that the Essex County Tuberculosis Hospital in New Jersey had declined to permit colored physicians to have access to their patients brought to the hospital for treatment, are to be investigated by the New Jersey State Conference of the N. A. A. C. P.

The New Jersey N. A. A. C. P. has appointed a committee of physicians to get all facts in the matter, looking to whatever action may be necessary to remedy the exclusion of colored doctors.

Hoover Invites Howard Professor to Conference

Washington, D. C., Nov. 1.—Dr. Algonon B. Jackson, professor of bacteriology at Howard University, and specialist in public health has been invited by President Herbert Hoover to be a delegate to the White House Conference on Child Health and Protection, which is called in the City of Washington, November 19 to 22nd.

SECRETARY WILBUR TO SPEAK ON EDUCATION PROGRAM

Plans for the program on Negro education which will be broadcast during American Education Week have just been completed, according to an announcement made by the U. S. Office of Education. The program will consist of short addresses interspersed with music.

Honorable Ray Lyman Wilbur, secretary of the Interior, will deliver the major address. President John W. Davis of West Virginia State College will also speak; he is a former president of the National Association of Teachers in Colored Schools. He is also a recent recipient of the Harmon award for distinguished service in the field of education. The third address will be given by Dr. Ambrose Caliver, Specialist in Negro Education, of the U. S. Office of Education, President Mordecai W. Johnson, of Howard University will be master of ceremonies.

The program on Negro education will be broadcast on Wednesday, November 12, from 5 to 5:30 P. M. All time periods specified are Eastern Standard Time.

STUDIES NEGRO AUTHORS DES MOINES BOOK FORUM

At the opening session of the Fall and Winter season of the "Book Forum", an organization composed of some of the leading literary lights of the city headed by Mr. Forest C. Spaulding at the Jewish Community Center, last Monday evening, not only was the Negro in American Literature the topic of discussion, but for the first time in the history of this organization, a large part of the discussion was led by Negroes.

Atty. Victor Shultz, a member of the Register staff, presided and presented Mr. Bert Strauss, who gave an interesting review of the recent publication, "Born to Be", by Taylor Gordon; then the Rev. C. J. Dutton, pastor of the Unitarian Church gave a review of Langston Hughes latest novel, "Not Without Laughter" and was followed by our own Jack Smith, who gave some of his personal experiences with Langston Hughes while in New York City. Mrs. Cliff Millen was then presented and reviewed some of the poems of Countee Cullen and the two novels "Fire in the Flint" and "Rope and Faggot" by Walter White, acting Secretary of the N. A. A. C. Robert Webb, Jr., former West and North High star scored first and second places in the 440 yard run and the 100 yard dash, respectively, and was given a gold and silver medal. Elbert R. Hall, Jr., crack East High school weight man of two years ago, placed second in the shot-put, third in the discus and fourth in the javelin.

When it is considered that neither of these boys have been in training for more than a year it looks as though they will be valuable additions to the track squad.

Minimum of Waste in Sardine-Canning Plant

In a Down East sardine canning factory the only thing that is wasted is the odor. That may not be a dead loss, for there are persons who assert they like the smell of a sardine factory. The scales are sold to the manufacturers of artificial pearls. The fish meal is in demand in Germany and in this country. The waste oil is collected and utilized in the production of paints and varnishes. Even the tin cuttings from the cans are baled and shipped to England for repressing into new sheets of the metal.

Down East sardines are sent to 95 different countries. In Java, when representatives sought a new market, the natives would have nothing to do with the "little fishes bailed in oil." Two hundred free cases were offered if the prospective customers would place a 1,000 case order. At last the deal was made. The sardines were heaped high on trucks, together with a band of native musicians, taken from bazaar to bazaar, and sold. Thus introduced, there was no further difficulty in adding Java to the list of sardine consumers.—New York Times.

REV. C. H. BRATTON AT MAPLE STREET

Maple St. Baptist church of Des Moines is conducting a revival which closes Nov. 14th. The guest minister is the Rev. C. H. Bratton of Mexico, Mo., who has already since being here proven himself a very forceful speaker.

On Sunday, Nov. 9th there will be a big mass meeting, of special interest to the young people. Rev. Bratton will deliver a message on "The Choice of Life". Appropriate music will be rendered at the service. Take part in these meetings for they benefit to the whole community as well as the church.

It was announced Tuesday, Nov. 4, that Roland Hayes, singer of international fame, will be in Des Moines on March 2. The announcement was made by J. G. Browne, 1415 Maryland Ave., who is to be the local promoter of this outstanding musical event of the theatrical season in Des Moines. Brown received a telegram from W. H. Brennan, manager of the Boston Symphony Orchestra, which is in charge of Hayes' American tour, sending the contract for the recital.

Roland Hayes has completed six tours of the United States since he began journeys over the country to demonstrate the magnetic power of his tenor voice. On his sixth tour he visited forty-four cities and gave recitals; in many cases he appeared several times in the same city. In October he began his seventh tour, which promises to be even greater than any previous tours of the great artist.

The great Hayes has received the endorsement of the press all over the nation. New York, Washington, D. C., Portland, Ore., San Francisco, and the many other large cities give their tribute to Hayes as being the leading tenor of the stage, drawing large audiences by the hypnotic spell of his voice.

In a recent issue of the magazine TIME he was named as one of the four leading artists which drew the largest crowds and box office receipts Hayes was the only singer of the group.

Plans are being made under the direction of Mr. Browne for concert equal to any of Mr. Hayes' tour.

SPRINGFIELD, MASS., ORGANIZING TO INCREASE N. A. A. C.

P. POWER

Springfield, Mass., Oct. 31.—An intensive organization campaign for the N. A. A. C. P. has been organized in this city by Robert W. Bagnall, national Director of Branches, to be held during the week of November 10 to 15. Springfield, being one of the most liberal cities in America in its attitude on race relations, is expected to exert a powerful influence throughout the State of Massachusetts, hence the efforts put forth to strengthen the local N. A. A. C. P. The city was the scene of the Association's highly successful 21st Annual Spring Conference last June.

INDIANA N. A. A. C. P. HEARS WHITE DENOUNCE MARION LYNCHERS

New York, Oct. 31.—(Special Dispatch) A sharp denunciation of the lynchers of Marion, Indiana, and a warning of the nation-wide menace of the lyncher, delivered by Walter White, Acting Secretary of N. A. A. C. P. stirred the Indiana State Conference of N. A. A. C. P. Branches at French Lick.

Mr. White declared the Marion lynching fitted "snugly into the frame which is Indiana", recalling the reign there of the Ku Klux Klan, the governors in jail or who narrowly escaped going there, the official corruption and racial and religious intolerance of the state. Mr. White urged upon colored people a policy of political independence as a remedy for their wrongs.

The conference discussed a plan to investigate the segregation of colored school children in the cities and towns of Indiana and appointed standing committees to deal with state problems.

CONCLUSIONS FROM TUESDAY

The election Tuesday is a distinct setback to the present administration for the voters not only showed that they were not in accord with the policies of President Hoover but they have put the control of congress in hostile hands.

Several things stand out boldly as a result of the vote:

First, prosperity or the like of it adopted by the Republican as a weapon against the democrats in years ago was one of the most vital in this campaign.

Second, the prohibition forces lost considerably as had been predicted by those who admitted the anti-prohibition forces are gaining ground.

Third, the republican administration in Washington is finding more each day that its popularity in the south in 1928 has gone by; that in their attempt to gain the south they abandoned the Negro voters of the north who in a great many states and congressional districts defeated administration candidates.

Fourth, that the N. A. A. C. P. again demonstrated its ability to fight to the last ditch for those things which they think are necessary to the welfare of the Negro. Notable examples of this are the defeat of Senator Allen of Kansas and Senator McCullough of Ohio who supported Judge Parker in his memorable battle for confirmation as judge of the Supreme Court. The association led the fight against Judge Parker; they fought Senators Allen and McCullough.

Nobody will say for a moment that N. A. A. C. P. did not make a great fight. It is the kind of fight which makes them respected more and more.

HEALTH TALKS The Observer

DIPHTHERIA

A sore throat containing the germ of Diphtheria is one which can be made healthy in a relatively short time if it is known to be Diphtheria. If this is not known the outcome cannot be determined. Diphtheria, once known to take a large toll in human life, is no more to be feared and serious results the result of this disease are due only to the neglect of the patient who has failed to have an infected throat looked after or has put off too long the examination which would reveal the nature of the throat affliction.

It is necessary that the kind of throat infection be known so that healthy persons may be protected and if it be Diphtheria the immunizing dose of the antitoxin known to protect may be administered, protecting those who have been in contact with the disease. To have such a remedy at hand and available and to know that it will definitely convey such a protection is a blessing—a scientific fact not to be kept ever present in the mind and above all to be used when the necessity demands.

The fact that Diphtheria has been practically eliminated from certain localities has been due to this vigilance; a return could mean only that this vigilance had been relaxed and this fact forgotten.

The Negro in America

Mrs. Myrtle M. Eldred, in the Evening Tribune of Nov. 1st under the caption, "Why Robeson Remains Abroad," attempted to refute the contention of Jack Smith before the Book Forum, that race prejudice is the reason Robeson does not play Othello on the American stage.

Mr. Robeson did star in "All God's Chillun's Got Wings," opposite Mary Blair, a white woman. But Mrs. Eldred did not state that Mr. Robeson never kissed his wife in the love scenes. They simply held hands; neither does she relate the fact that on account of the activities of the Ku Klux Klan the play was held up for a whole season. As to Robeson's breach of contract and suspension from the Equity Association, there was no signed contract; everything was tentative. Furthermore, his suspension did not extend beyond a period of a few months. He is now in good standing with the Association.

We all know that technical violation of rules is an American specialty, practiced against Negro artists in all lines of endeavor, to cover and camouflage racial discrimination. For instance, Chas. Brooks, University of Iowa coach was all right so long as it was not generally known that he had Negro blood in his veins. When that leaked out, he was discharged because he had married twice in sixty days, although that episode was of several years standing and the color question has just been revealed.

Then read the American critics on the European presentation of "Othello," and see what they stress. For example, in Burns Mantel, they are amazed at a Negro kissing his leading lady on the stage, she being white.

It is a sad truth that America's contribution to art is "Racial Discrimination." If this were not true where would Rose McClendon, the star in "Deep River" be? Alexander Woolcott said, "after seeing Rose McClendon in Deep River, I should not be surprised if the next Duse were a black woman. Ethel Barrymore and Jane Cowl might well learn poise from her."

Abbie Mitchell by far one of America's most celebrated Negro actresses, a woman of highest culture and renowned of the "La Fayette stock" fame, had her last opportunity to act upon the American stage in the role of maid to Helen Hayes in "Coquette."

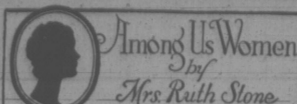
Executive and board members of the Public Welfare Bureau are working on the campaign goal. Each agency which receives aid from the bureau, was first supervised by a member of the board of directors and then, having drawn up its budget, appeared for a hearing before the entire board. The submitted budgets are now being reviewed and compiled for the campaign goal.

Nearly every citizen in Des Moines benefits by one or more of the agencies, a brief resume of their yearly reports shows.

Among other organizations sponsored by the campaign are the Charity League, an organization for the welfare of colored people, maintained a home and shelter for working girls and aged women. Activities of the Community Service, Inc., negro community center, reached 32,000 people through recreational classes and baby clinics.

What part of an article gives out first? Where the greatest strain is, naturally, and with corset, corset or girdle, or whatever article one finds most comfortable and convenient, the part that is sure to go first is the hose supporter that gets a constant tug and strain all day long. They also get somewhat soiled from constant rubbing against clothing, which makes the whole garment seem shabby and worn out. The next time you are tempted to discard your girdle, try washing it and then putting on a fresh pair of Hickory so-on garters and see what a difference it makes.

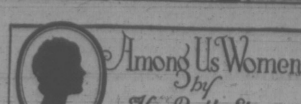

Cut is also an important part of the waist. The arms must be full cut to avoid binding and the front and neck sufficiently low not to show above the outer garments.

weight in beautifully patterned rubber for evening and dress wear. In all styles, a shaped band of net, balisook or silk over the hips makes the apron fit smoothly and allows for ventilation. Many women prefer to baste a sanitary apron in each frock, so that there is no extra garment to be put on, nor springs around the waist, and the apron is always in perfect position. The apron is removed before the frock is sent to the cleaners. It should be washed in lukewarm water with pure soap flakes, and dried with a towel.

In addition to keeping skirts wrinkle-free and affording periodic protection, the use of a sanitary apron tends to make transparent garments shadow proof.

Millions of Hours Lost by Disabling Illnesses

On an average, each person in the country has at least one disabling illness every year, the committee on the "cost of medical care" has reported after a survey of various sickness reports compiled by the United States public health service and other organizations. Men have a disabling sickness about once a year, women about twice and children over twice during the school year. Colds, bronchitis, grippe, influenza and pneumonia are oftentimes the cause of these disabling illnesses and cause the longest disability. On the same basis of the number of cases and total time lost, digestive disorders and diseases also take a high place. About 150,000,000 cases of disabling illnesses occur in the United States each year. Adding disabling illnesses more than doubles the figure, the committee reported. The 26,000,000 wage earners in the country lose at least 200,000,000 work days a year, and the 24,000,000 school children lose 170,000,000 school days a year. These figures account for only one-half of the total population.—Kansas City Star's Science Service.

Early Postal Records Destroyed by Flames

The first 60 years of American postal history are almost a complete blank because of the great fire of 1878, which destroyed the Post Office building at Washington and with it almost every vestige of postal records. Years later a postmaster general was forced to admit to congress that he was unable to supply the names of assistant postmasters general who had served from the beginning of the system. One volume alone was saved from the flames by a youthful messenger in the office of the auditor of the treasury for the Post Office department. This book, still in existence and now under control of the chief clerk of the Post Office department, is a ledger of postal revenues for the years 1776, 1777 and 1778. So far as is known, no other postal records of the early years are in existence.—Detroit News.

Causes of "Blood Rain"

There are many cases of so-called miraculous showers in which the substance found on the ground did not actually fall from aloft. Thus some alleged rains of blood are due to the deposit of red fluid ejected by certain species of lepidoptera emerging simultaneously in large numbers from their cocoons, and others to the rapid multiplications in rain pools of algae and rotifers containing red coloring matter. The well-known red snow of polar regions results from the case of another organism.

Monarch's Nest Rebuke to Overzealous Priest

King Leopold of Belgium—merry old soul—had a caustic wit. On one occasion when he was at his chalet at Ostend, the parish priest approached him and asked for a private word with him. When the two were alone, the priest began to read Leopold II a long sermon: "Sire, I am profoundly grieved," he said. "There is a rumor, I am sorry to say, that your majesty's private life is not marked by the austerity suited to the lofty and difficult task which God has laid upon the monarchs of this earth. Remember, sire, that it behooves kings to set an example to their subjects."

For 20 minutes the king listened patiently to the utterances of the good man, until the priest desisted from want of breath, relates Evelyn Graham (in his authorized biography of King Albert, nephew of Leopold).

"What a funny thing, Monsieur le Oere," said the king, bring him with a cold look and smiling slightly. "Do you know, people have told me exactly the same thing about you!—I am only I refused to believe it."—Kansas City Times.
