#### IS GUEST SPEAKER AT MISSISSIPPI HI-Y CONFERENCE

Bearing credentials from Gov. Dan W. Turner, commissioning him as Iowa's official representative to the Fiftyth Anniversary Celebration at Tuskegee Institute, Atty. S. Joe Brown leaves Saturday night in order to be present at that auspicious occasion next Tuesday.

He also holds a similar position from the President of the State University of Iowa, since he is its first Negro Liberal Arts graduate as well as the first member of his race to receive an advanced degree from that institution, the latter occurring in June, 1902, and furnished the prime reason for Dr. Booker T. Washington's being the commencement orator on that occasion, he being the only person ever thus honored by the University.

Brown's prime object for this southern trip, however, is to deliver a series of addresses before the State Colored Boy's "Hi-Y" Conference that is to be held at Piney Woods School, Piney Woods, Miss., next Thursday, Friday and Saturday, upon invitation from Prof. Laurence C. Jones, also an alumnus of Iowa University, who is founder and Principal of the Piney Woods school.

#### SENATOR ROBERTS CASTS DECIDING VOTE IN ILLINOIS DRY LAW REPEAL

Springfield, Illinois—(CNS)—Senator Adelbert Roberts, of the Second State Senatorial district is being given much credit for the passage of the bill for the repeal of the Illinois prohibition law here last week. It was his vote in the upper house, after a fight of six years, that brought victory for the wets by a vote of 26 to 24.

Roberts is said to have arose in the Senate at the dramatic moment when it appeared that the measure might be lost, with a brief burst of eloquence declared: "Much as it pains me to do so, I vote 'aye' on this measure to carry out the mandate of the people of my district."

The measure must be signed by Governor Emmerson before it becomes effective.

### Rev. Guy Returns Race Mixture in Hawaii Produces Able Children

Rev. W. E. Guy, energetic pastor of St. Paul's A. M. E. church, returned last Tuesday, April 7, from Springfield, Illinois, where he officiated at the funeral of his brother in the ministry, Rev. D. A. Harshaw.

In the interview, Dr. Guy stated, "How heavily the hand of Death has fallen on the ranks of our mother Conference (Illinois); First, Rev. A. J. Carey, Bishop of Conference; then Rev. H. W. Jamieson, leading Presiding Elder; and finally the most promising and able pastor of the district, Rev. Harshaw, all of whom have died within the short period of two months." Dr. Guy spent four successful years at Springfield, prior to coming to Des Moines, and while on a very sad mission, it was a pleasure to greet his many friends at Springfield.

He reported a grand Easter day program at St. Paul's. Before departing on his trip last week, Dr. Guy arranged for the triumphal services of beautiful singing by vested choirs and gorgeous resplendent decorations in the church, and with the usual efficiency and fine management, his well directed officers and assistants were able to perform the work in a thoroughly organized manner during his unexpected absence.

Tuskegee Institute, Ala., April 7. The feature of Tuskegee's Fiftyth Anniversary program will be the Founder Day address of Dr. Anson Phelps-Stokes, canon of the Washington Cathedral, who speaks in the Institute Chapel just prior to President Hoover's radio address, Tuesday, April 14, 4:30 P. M.

Dr. Stokes represents one of Tuskegee's earliest and most beneficial families of donors. The favorable impression Dr. Washington made upon this family and the lasting faith it maintained in the Institution began as early as 1891 and continues down to the present.

New York, April 3—That racial mixture among the various peoples living in Hawaii produces able children and that there is no demonstrable mental inferiority as a result of such mixture, is the conclusion of Dr. S. D. Porteous of the University of Hawaii. A brief summary of his report is cabled to the New York Times and relayed by the N. A. A. C. P.

"Generally speaking," says his report, "our results go to show that in mental as well as physical characteristics the children of racial mixtures tend to occupy a position intermediate to that of the parent groups. Some writers affirm that the results of race mixtures are extremely unfavorable, the children of such unions tending to inherit the worst features of the parent races."

"As far as our results throw any light on this question, this does not appear to be true."

In 1901 Misses Olivia and Caroline Phelps-Stokes gave to the Institute Dorothy Hall, named in honor of a given name in the family for more than three hundred years. The Hall is used as the Women's Industrial Hall where trades are taught to girl students.

Rev. H. L. Overton is to close five years pastorate here Sunday, April 12th, at the Burns Methodist Episcopal church, 311 Crocker St., having come here from a very successful pastorate in California, Mo.

The Annual Conference will take place in St. Joseph, Mo., April 15th, 1931. Bishop R. E. Jones of the New Orleans Area will preside at this session of the Conference.

At present there are over 270 C. M. A. Stores, and their growth is actually just starting. The volume of business the chain may eventually control is illustrated by a survey made by the Negro Business League which disclosed that the Negroes annual food bill in this country is approximately \$1,650,000,000.

## HEALTH TALKS "About Town"

### THE HEART

The blood is distributed all over the human body and performs certain functions, such as the supplying of oxygen to the tissues and carrying nourishment to them. The heart is not designed to be a container of blood for its cavities are too small to accommodate only a very small amount at a time. It acts as a conveyor of blood to and through the tissues of the body. It does this by filling and expelling blood at regular intervals forcing it through the arteries with pumplike action. Consequently, when the heart is damaged in any way other organs do not perform their duties well, are not furnished proper nourishment, are not properly oxygenated and are left with waste materials in them which should be removed.

The heart is so constructed of specialized muscle tissue that it takes a severe blood infection to damage it but when once damaged it is somewhat difficult to repair because it works normally with much precision. The complete opening and closing of its valves is such a necessary action that any condition which prevents this complete opening and closing causes an alteration in organs near or distant, dependent on perfect heart action. This dependence of all organs and tissues on perfect heart action may have something to do with the greater number of heart cases over all others.

### D. A. R. SEGREGATES NEGROES IN WASHINGTON CHOIR CONCERT

New York, Mar. 27.—The D. A. R., (Daughters of the American Revolution), were responsible for the segregation of Negroes at the concert Saturday night, March 21, in Constitution Hall, Washington, D. C., by the Hampton Institute Choir, according to information reaching the N. A. A. C. P.

Negroes were permitted to purchase seats only in two corners, with the result that the hall was two-thirds empty. The Washington Daily News of the Scripps-Howard chain, which

always champions the cause of fair treatment of minority groups, published an editorial charging that the D. A. R. "showed a double face" in arranging this concert. The concert, ironically enough, was for the benefit of the National Memorial Association, which is seeking to build in Washington a memorial to the achievements of Negroes.

### WIND HELPS DISPERSE MOB

Scottsboro, Ala., April 3.—Nine men held in jail here for an alleged attack on two girls (white), who were bunched on a freight train, were saved from the fury of a mob and possible death last Wednesday by the presence of the sheriff, his nine deputies and 100 national guardsmen. A sharp, cold wind blowing down from the mountains also helped disperse the mob until it dwindled from three hundred to about twenty.

New York, Mar. 27.—The U. S. War Department in response to a query from the N. A. A. C. P. has announced that on this year's pilgrimage to France, as on last year's, Negro Gold Star Mothers and widows will be sent to Europe on separate steamships. The N. A. A. C. P. is urging the eligible Gold Star Mothers to decline to go and to repudiate the trip.

The situation is made the subject of an extensive interview in yesterday afternoon's World-Telegram, with Walter White, Secretary of the N. A. A. C. P. The interview, written by Mary Bennett, quotes Mr. White as follows:

"Segregation of Negro gold star mothers and widows on a pilgrimage of this nature is a gratuitous insult to the colored race."

### "JUSTICE IN GEORGIA"

Atlanta, Ga., April 2.—(ANP)—Just how cheaply the life of a Negro is held, no matter what his station in life might be, when it is taken by a white man, was indicated here Tues-

day when Aubrey Sykes, a white man, was found guilty of voluntary manslaughter in connection with the killing of Dennis Hubert, a Morehouse College student, and sentenced to two years in the penitentiary.

The sentence was a distinct disappointment to a large group of citizens of both races. That the murder was one of the most cold-blooded and wanton ever committed here, was a well known fact and was brought out time and again by the prosecutors. How Hubert was watching children at play in Crogman's playground when he was set upon by six white men, was portrayed vividly by the prosecuting attorneys and how he was struck down by them was depicted.

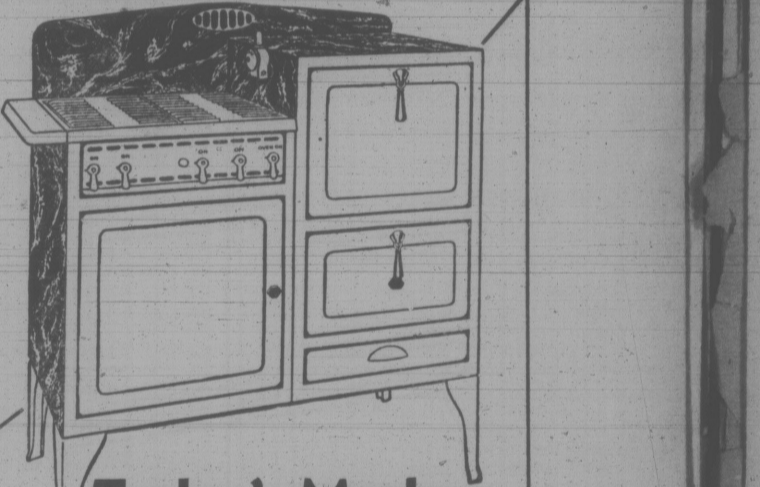
