Alleged Action in Withdrawing Case From Docket Frees All Those Charged With Crime

SPLIT IN FEDERAL BAR THREATENED ON RACIAL ISSUE

New York, (CNS)—The New York, New Jersey and Connecticut branch of the Federal Bar Association threatened to secede from the National organization at a meeting here Monday night unless it is permitted to retain as members four colored lawyers barred from affiliation under the constitution of the association.

The four Negroes are Francis X. Giles, an assistant United States attorney in the eastern New York district; Oliver Randolph, assistant United States attorney in New Jersey; Richard L. Baltimore, former assistant United States attorney in the eastern New York district, and Hubert T. Delany, an assistant United States attorney in the Southern District of New York.

A severance from the association seemed inevitable for the branch, whose members include present and past attorneys in Federal service, officers of its metropolitan area branch asserted at the meeting adopted a resolution to notify the national association that it "would be glad" to continue affiliation if it can retain its disputed members.

Prof. Miller Loses Position At Ohio

Ousted Professor Says White Girls Danced with Students "Because They Could Dance Better"

Columbus, O., June 27.—Dr. Herbert Miller, deposed professor of sociology at Ohio State University, has admitted that white co-eds of the school, on their trip to Wilberforce recently, danced with the colored boys—and liked it.

Dr. Miller, internationally known and respected as an educator, appeared before the commission which killed a resolution to conduct a House investigation of charges and reasons surrounding his dismissal, here last week.

Dr. Guy came to Des Moines eighteen months ago in the middle of one of the worst winters of recent years. Assuming the leadership of a much-discouraged people, he has shown courage and efficiency. Within 18 months fifteen hundred dollars of local indebtedness that had previously piled up has been paid. Over eleven hundred dollars interest has been paid on the mortgage on so-called "dead" property.

Dr. Guy also announces the coming of Dr. E. B. Williams of the Michigan Conference to assist in a campaign of summer evangelism. Dr. Williams is a genius in dramatized sermonizing. His opening sermon, "The Tears of Jesus," is announced for Sunday morning, July 12th. Twice has Dr. Williams conducted campaigns in Minneapolis and twice has he closed his campaign in the largest white Methodist church in Minneapolis.

The week's activities include one night mass meeting in Carnegie Music Hall, a Sunday mass meeting in Soldiers Memorial Hall addressed by Clarence Darrow, ten minute daily radio addresses by Conference speakers broadcast over the radio, from station KDKA, half-hour musical programs at all night mass meetings, a sight-seeing tour of Pittsburg on Saturday, July 4, followed by a luncheon at Bellevue, Pa., and a song recital at the Friday night mass meeting in Carnegie Hall, by the celebrated Negro tenor, George Garner, accompanied by Mrs. Netta Paullyn Gardner.

A comprehensive program of daytime and round table discussions has been arranged for the delegates and visitors to the Conference, covering the major aspects of race relations in America today. The subjects include the Negro's part in politics, the problems of unemployment and aid to the Negro unemployed, the project of a Negro youth movement and other vital subjects.

Conference headquarters have been established at the Y. M. C. A., 2021 Centre Avenue, and business sessions will be held at the Warren M. E. church, Centre avenue and Watt street.

DE PRIEST'S CHANCES SLIMMER

Congressman's District Is Intact, But Facts Reveal Fight for Re-election, Chicago, June 27.—(By ANP)—Is Oscar DePriest to be re-elected, or will he be defeated and his place taken by a white man? This question naturally arises when one considers the recent congressional reapportionment which has taken place in Illinois. Although successful efforts were made to prevent a gerrymander of the district that would have destroyed all chances of electing a Negro congressman, the new district reduces instead of increasing, the chances.

The old First district from which Mr. DePriest has been elected contained only 167,000 persons and was one of the smallest in the Chicago area with ten congressmen and a population of three and one-half millions. The new districts have been apportioned to contain an average of slightly in excess of 300,000 persons. The new First district from which Mr. DePriest must be elected, has, according to the census figures of 1930, 317,500.

Mesdames Margaret M. Patten, S. Joe Brown and Attorney Gertrude E. Rush, all of whom are honorary presidents of the Iowa Federation of Colored Women's Clubs, gave impromptu talks on club work in Iowa. Mrs. Sallie W. Stewart, the honored guest, gave a very interesting talk relative to enlarging the scope and usefulness of the Federation. The meeting was presided over by Mrs. A. A. 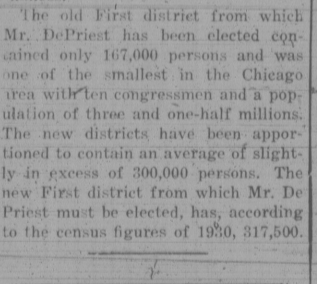

### Lawyers Prepare Appeal in Scottsboro Cases

Prosecution's Chief Witness Gave False Testimony After Beatings

New York, June 19.—The N. A. A. C. P. attorneys in the Scottsboro cases are not waiting for a decision on their motion for a new trial, made last Saturday in Scottsboro, Alabama, in behalf of the eight Negro boys sentenced to death. They are going right ahead, anticipating an unfavorable decision from the Scottsboro judge, and preparing for appeal to the Supreme Court of Alabama.

Messrs. Fort, Biddow and Ray, Alabama's foremost law firm retained by the N. A. A. C. P., under whose direction attorneys Stephen R. Roddy and Milo Moody will also continue in the cases, are now preparing a bill of exceptions and briefs, which will include the record of all procedure at the original trial, as well as all the procedure and affidavits in support of the motion for a new trial which is to be incorporated in a single bill of exceptions.

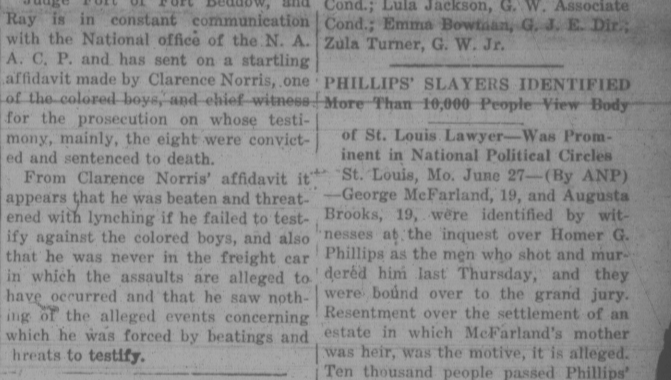

From Clarence Norris' affidavit it appears that he was beaten and threatened with lynching if he failed to testify against the colored boys, and also that he was never in the freight car in which the assaults are alleged to have occurred and that he saw nothing of the alleged events concerning which he was forced by beatings and threats to testify.

Phillips as the men who shot and murdered him last Thursday, and they were bound over to the grand jury. Resentment over the settlement of an estate in which McFarland's mother was heir, was the motive, it is alleged. Ten thousand people passed Phillips' body, which lay in state in St. Paul's A. M. E. Church. National organizations and prominent people sent condolences.

### POOR JUDGMENT

Last week a convention was held at Corinthian Baptist church. The closing meeting was held Friday night. Warm as the church was on that night, many delegates lingered in front of the building after coming out in the breeze. Some "friendly neighbor" called the police department saying that these people were disturbing the peace and the officers who came were exceedingly unscrupulous and made things rather embarrassing for the officers of the church for a while.

Further again last week a policeman on the east side arrested a man; the man escaped and the two had a pistol duel with the result that the policeman received a slight wound and a bystander was mortally wounded. Evidently the officer was so excited that he did not at first see that the man was or was not a Negro. Later the police department changed its theory and said they did not know whether the man was black or white.

As usual every strange Negro found in the city was picked up even though they did not know that perpetrator of the offense was a Negro.

The first instance was ridiculous; in fact an insult to Corinthian church. The police department of course was not responsible for the call, but a better sense of duty should have been exercised, dealing with the law abiding citizens who are not police characters.

The police department has no right to pick up strange people without reasonable suspicion that they have committed a crime, and certainly this instance was no excuse for rounding up a bunch of Negroes.

Whoever is responsible for these two instances certainly used poor judgment and are careless officers.

### THE DEED COUNTS

Saturday night it rained especially hard; many streets were flooded; Keosauqua Way was a veritable river. Cars were strung all along the way, unable to move because their engines were soaked. The situation while not serious was exceedingly inconvenient to those who wanted to move on.

Instance after instance the more fortunate fellows, whose cars were not stopped by the flood, moved up behind the cars standing in the water and pushed them blocks on their way or until the cars were able to move of their own power.

The drivers of these cars did not know whether the fellows they were pushing belonged to their church, lodge, club, race or class; in most cases whether friend or foe. "The situation was here is a fellow who needs help, I can do it and will"; a splendid thing to be sure.

If all our acts of kindness were based on this thought the world would be much better for after all it is the deed and not for whom it was done that counts.

## HEALTH TALKS

### HEAT CRAMPS

Many conditions may occur in very hot weather. Some are due to the heat alone and others to the heat plus some bodily condition which makes it difficult for the body to withstand high temperatures.

Sanstroke and Heat Exhaustion are the two common conditions which affect great numbers in cities where the population is great and those who work in furnace rooms and similar places where heat is generated are not infrequently affected. These two forms are very prostrating as a rule although mild degrees of either one occur in any locality in hot summer weather.

Heat Cramps is a condition in which the muscles have been overused when the temperature is very high—on the hottest days. The muscles cramp and there is much pain. If it is the arm which is affected the hand will open and shut sometimes involuntarily and each contraction produces much pain.

The muscles of the part affected jump and twitch against the will of the one affected. Such a condition permits no more work until it is controlled. It may be safely said that whenever this state of things exists there is something else wrong in the body—some other condition existing or all the muscle workers would be affected in the same way.

Anyone who goes through with Heat Cramps without aid will surely suffer much discomfort. The bodily condition underlying it also should not be disregarded.

### CALIFORNIA PATRIOTISM AND WISCONSIN DEMOCRACY

To the Editor: Those of us who at times feel discouraged because of unfortunate occurrences between Negroes and white people, might pause a moment and consider two incidents that have taken place of late. Although they do not mark an epoch yet small straws tell which way the wind blows.

No doubt most of us read how some white women in California objected to any non-white children being on the stage at a patriotic demonstration in which Madam Schumann-Heink was to take part. Upon hearing this, the great singer turned and crooned a lullaby; after which they joined her in singing the Star Spangled Banner. Turning to her audience she gave those objecting mothers kind but very pointed reprimand. This brings to mind a few lines from a beloved American poet—Whittier:

"Through the harsh noises of the day  
A low sweet prelude finds its way  
Through clouds of doubt and creeds of fear  
A light is breaking strong and clear.  
The fight being made by a group of students at Wisconsin University to have Negroes of outstanding ability admitted to a Forensic society brings to mind a few lines from another much loved American poet—Dunbar:

"Hed not the darkness round you dull and deep  
The clouds grow thickest when the sunnits night."

### PULLMAN PORTER WINS \$2500 FOR ARREST AND MALICIOUS PROSECUTION

New York, June 16.—Arthur Garfield Hays, of New York City, prominent attorney who was associated with Clarence Darrow in the Sweet cases in Detroit, informs the N. A. A. C. P. that his client, William J. Thompson, a Pullman porter, has won a verdict of \$2,500 against the Pullman company for false arrest and malicious prosecution, after sixteen minutes deliberation by a jury.

### WHITE'S ARTICLE ON SCOTTSBORO IN NEW LEADER SOCIALIST WEEKLY

New York, June 16.—The New Leader, socialist weekly, (7 East 15th street) in its issue of June 13, out today, prints an article on the Scottsboro cases by Walter White, secretary of the N. A. A. C. P. In the article Mr. White tells the story of the cases from the beginning and what the action of the N. A. A. C. P. has been to date.

### Springfield, Mass., June 16.—The Springfield branch of the N. A. A. C. P. has appointed an educational committee to protect the young people of the city from discrimination in schools and colleges.

New York, June 12.—Dismissal from Ohio University of Professor Herbert Adolphus Miller because of his attitude on race relations, has stimulated a number of sermons by white clergymen in the state on race relations.

### THERE ARE NO PURE RACES SAYS HARVARD SCIENTIST

New York, June 12.—That there are no pure races, "Nordic" or other, and that race mixture is beneficial, are statements made in a newly published book "Up From the Ape," by Dr. Ernest A. Hooton, professor of anthropology at Harvard university, published by MacMillan.

A news account of the book, published in the New York Times and relayed by the N. A. A. C. P., states that Professor Hooton calls "scientifically unfounded" the charges of inferiority against Negro races, says that in many cases of racial intermixture the children are taller and of greater vitality than either of the parent races, and calls a "ridiculous boast" the claim of "self-styled Nordics" that they are racially pure and superior to other racial stocks.

### YOUNG REPUBLICANS GATHER IN WASHINGTON

Washington, (C.N.S.) June 16.—In response to a call from the republican national committee more than 300 delegates and representatives met in the first National Conference of Young Republicans here Thursday and Friday, June 11 and 12.

Among the delegates were Mrs. Ophelia H. Lee Melver of Savannah, Georgia; John P. Davis, of Cambridge, Mass.; and Perry W. Howard, Jr. and Miss Doris Fisher of Washington, D. C., accredited to Mississippi.

Mr. John P. Davis, who is known as a forceful young orator was introduced by Executive Director Robert H. Lucas of the national committee, as an outstanding young Negro republican and made an impressive little talk. Mr. Davis was heartily congratulated afterwards by many young delegates who seemed anxious to cooperate with young Negro republicans in organization work.

## PATIENCE IS KEY TO DOG TRAINING

Use Tact and Kindness to Bring Out the Best of Animal's Ability.

A properly trained dog is a delight to himself and his master. He loves to do his master's bidding, and were every dog well-trained, there would be little complaint about dogs and their deeds, states the Chappel Kennel Foundation, Rockford, Illinois.

Probably 95 per cent of dogs have the ability for training and only require effort, patience and repetition to bring it out of them. The early training of a dog is most important. A dog not trained or disciplined during the first twelve months of his life, will not be nearly as manageable and dependable when grown.

Only one person should be the dog's instructor during the entire course of training. After a dog is trained, he should go through the commands for anyone who gives them properly.

The first and biggest lesson you can teach him is obedience, founded upon full confidence in you as his master. All the rest will take care of themselves as a matter of course. Causes of failure to secure obedience from a dog after weeks of training may be set down as two. The act has not been repeated often enough or it has been repeated too many times on the same day. Two or three commands a day are sufficient. But stop work only on a successful performance.

A dog does not know the difference in the meaning of words. After many trials and much work he can be taught to do so and so when a certain word is spoken. But the meaning of the word itself is beyond him. A word spoken in a kind way will make him glad and wag his tail; the same word spoken in a rough way will make him run in fear.

Another cause of poor control over a dog is failure to reward him. A dog likes to be praised and fed. The act is appreciated. A kind word, a pat on the head will usually go about as far as anything else. A bit of such food as kibbled biscuit, given at the end of each successful act helps him to feel that he is appreciated.

Simple Facts of Dog Feeding Told

If the feeding of your dog presents itself as a weighty problem, take heart! According to the Chappel Kennel Foundation, Rockford, Illinois, here is all that you need to know about his feeding:

1. Feed one heavy meal a day, preferably in the evening. Feed the light meal in the morning. Puppies require three to five meals a day, depending on their ages. Feed at the same hours each day.
2. Meat is the dog's natural diet. If you feed your dog a prepared, well-balanced meat food, with dog biscuits for variety's sake, he will need nothing else.
3. Don't feed table scraps, potatoes, boiled eggs or pork, and don't serve to soupy foods. Beware of chicken and fish bones. Dogs care nothing for sweets until taught to like them.
4. Provide plenty of water.
5. Never allow violent exercise directly after feeding.

If a dog does not take readily to biscuits, which are essential to keeping his gums hard and teeth clean, it is suggested that kibbled or broken biscuits be gradually incorporated into his regular ration until he gets used to eating them.
