"About Town" Thousands Invade Iron City For Grand Occasion

VE SAYS

Of course the lack of bathing beaches for Negroes of this city has been discussed from so many different angles, that 'tis trite to bring it up again. But repetition may help, so here goes! There are various organizations in Des Moines, boasting a colored and white membership, who ostensibly, are seeking the betterment of our race morally, mentally, physically, politically, financially, and who are pledged to uphold our civil rights as citizens. However, none have seen fit to wage war against the gross discrimination and intimidation of the Negro at our so-called municipal bathing beaches. By what mental process does the white man and our leaders arrive at the conclusion that bathing beaches are not needed for our colored girls and boys to swim in? With the exception of indoor pools, as at North and East high, the Negro is obliged to swim in sand pits—a very treacherous place, even for expert swimmers. There are too many people in these organizations who are afraid of being dubbed "agitators" by their good white friends and like puppets, how, scrape and dance at the pull of a string. These organizations soliciting the support of the race in Des Moines must—if they wish to keep faith—do something tangible locally to alleviate rotten conditions. 'Tis reasonable to assume if the Negro cannot secure equal rights at beaches owned and operated by the city, cannot frequent places their taxes help maintain, that any other fight we may wage for civil rights here, is doomed. There is little danger of our boys going to the electric chair unjustly so in Iowa, but unless we have beaches, they stand a chance of drowning like rats in the filthy mudholes and sandpits around Des Moines.

And, while we are grumbling, what became of the stoplights that were to have been installed on Keo Way? Was it our imagination or mere prattle? Methinks that our city fathers—like false prophets—have mouthed sweet vaporings into our gullible ears to quiet us. . . . June has come and gone, and the only red lights I saw on Keo Way came from a horde of lightning bugs. . . . A synthetic Harlem party was given by the Friedlichs out in the West End recently, which is still being talked about. By way of being original I'd suggest that these fair ladies stage a real Harlem Party, as is given at the Cotton Club in New York City. . . . and not only have a colored orchestra, but in true Harlemite fashion, actually invite a few colored lads and lasses in to dance, drink and hobnob with them. . . . as it were.

Thousands Invade Iron City For Grand Occasion

Pittsburgh, June 30—The Twenty-second annual conference of the N. A. A. C. P., opened last Tuesday, June 30, at the auditorium in Pittsburgh. A message of greeting from President Hoover, to Col. J. E. Spingarn, president of the N. A. A. C. P., at the opening mass meeting was read as follows: "My Dear Col. Spingarn: "On the occasion of the 22nd annual conference of the National Association for the Advancement of Colored People, held in Pittsburgh, June 30th to July 5th, I should like to extend my greetings to the members of the organization and those gathered to consider with them problems vital to the welfare of our country. Vitalness of the gross type, of which members of the colored race often are victims, is a feature of our national life which deserves condemnation and suppression. Every citizen is entitled to the full protection of the law and to absolute justice. To make that ideal an actuality is one of the strongest aspirations, as it is of the nation, and to its accomplishment the government and all good citizens will pledge their devoted effort.

"The many problems of our country require a breadth of vision and a willingness to co-operate which I have no doubt will be the spirit of your association.

A telegram of greeting was also received from Senator Arthur Capper, of Kansas, a member of the Association's Board of Directors.

NEGRO'S HOPE IS IN NEW SOCIAL ORDER NORMAN THOMAS TELLS PITTSBURGH MEET

The American Negro's hope lies in a new social order, declared Norman Thomas, Socialist candidate for president in the last election who Tuesday night addressed the opening mass meeting.

Declaring that an acquisitive society had broken down, and that the Negro had been peculiarly its victim, Mr. Thomas said that a society based upon the dignity of work and the harnessing of toil and science to the service of mankind was the only next step.

"RACE SEGREGATION MUST BE DESTROYED"—BAGNALL

That race segregation is a menace to the nation and to the world, which must be destroyed, was the statement here Tuesday night of Robert W. Bagnall, director of branches of the N. A. A. C. P., addressing the opening mass meeting.

Mr. Bagnall declared that the segregationist attitude had made Christianity in America "a gory jest as to human brotherhood" and added: "The church is strangely mute as to racial wrongs and itself indulges in racial prejudice. No white church in America would accept a Negro pastor were he Jesus Christ himself, and Negroes in numbers are not welcome in half a dozen white churches in the land."

NEGRO WOMEN ASK FULL OPPORTUNITY SAYS PALMER MEMORIAL INSTITUTE HEAD

That Negro women in America ask not charity but equal opportunity with all others for education and careers, was the statement last night of Mrs. Charlotte Hawkins Brown, head of Palmer Memorial Institute in Sedalia, North Carolina, who addressed the third day session.

"The Negro women does not ask charity, but an equal chance for self-expression with the white woman," said Mrs. Brown. "She asks respect for her judgment and intelligence. According to her opportunity and training, she wants everything that the white woman wants."

Mrs. Brown scored the practice of southern newspapers in denying to Negro women the title of Miss and Mrs. and the practice of excluding colored women from a Y. W. C. A. and chair restaurants. She paid high tribute to Dr. James H. Dillard of the Jeanes and Slater Funds, for giving colored women opportunity for leadership as supervisors in connection with the county system of education in southern communities.

"ECONOMIC GENERAL STAFF" FOR NEGROES URGED BY DR. DU BOIS, CRISIS EDITOR

A trained "economic general staff" for Negroes which would help them to organize their buying power to help in their advancement as a race, was advocated last night by Dr. W. E. B. Du Bois, one of the leaders of colored people in this country, addressing the third day session.

"The American Negro numbers about 12 million," said Dr. Du Bois, "and that means that we are much larger than either Denmark, Greece, Hungary, the Netherlands, Norway, Portugal or Sweden and very nearly the size of Egypt, half the size of Spain and one-third the size of Brazil.

"In the matter of public service agencies, the Negro through his political power and his power as a consumer, can compel to some extent the employment of colored people and courtesy and consideration in the treatment of customers.

"The people who can buy, build and maintain church edifices to the value of 60 million dollars could do the same thing with regard to homes and tenements, if they were organized and trained to do it.

"If they put their mind to it, and secure the proper training, spend a considerable part of this thousand million dollars each year in hiring themselves at decent wages to perform services which the Negro group needs. They could do this without antagonism to the white group, without any essential change of laws, and without a national organization involving army and police."

Win Case Against Restrictive Segregation in W. Va.

New York, June 26—An important legal victory has been won in the Court of Appeals of Franklin County, Ohio, against the principle of residential segregation by restrictive covenants among property owners.

The property in question was part of a plot of land in Columbus, Ohio, subdivided in 1922, all deeds to the plot containing a provision that it should be neither sold nor rented to persons of African blood and that no such person should reside in the house except as servant or employee.

Mrs. Daisy Hall Rice bought the property and paid for it, and the original grantee brought suit claiming that because Mrs. Rice was colored the restrictive covenant had been broken and that the property belonged to him. The lower court dismissed his complaint and he appealed to the County Court of Appeals which affirmed the lower court's decision.

The N. A. A. C. P. is following the case closely and should there be appeal to a higher court, will offer aid to the colored defendants.

C.M.T.C. Great Says Elliston

VISITS C. M. T. C.

Last month, Mr. Spencer Elliston, service officer of Lincoln Post, made a trip through Missouri and Kansas, visiting the U. S. Veterans' hospital at Excelsior Springs, Mo., where he found Comrades J. J. Johnson, Spanish War veteran, and W. M. Oney, Guy Harris and John Graves all of Des Moines, undergoing treatment, and with the exception of Comrade Johnson, all recuperating nicely.

He reports that Excelsior Springs is a wonderfully fine hospital and that the inmates report that they are being well treated. He was shown every courtesy by the officer in charge. He also made a visit to Ft. Riley, Kansas, which he reports is one of the largest army posts in the world, located at what is said to be the geographical center of the United States, just one hundred miles west of Kansas City on the Union Pacific Railway.

The Post is veritably a city with a population of about ten thousand and furnishes encampment grounds for the National Guard, C. M. T. C., R. O. T. C., and S. A. T. C.

Visits C. M. T. C.

The C. M. T. C. one of the few in the country for Negro boys, there being only one at this first camp only one hundred fifty. These youths were supposed to have come from the seven states which make up the 7th Army Corps Area; but only three states are represented—Missouri, seventy-five boys; Kansas, seventy and Iowa, five; four of them Harold Burrell, Edward Jackson, John Young and Sylvester Young from Des Moines and the fifth from Fairfield. More than four hundred boys enlisted and passed the required examinations, but for reasons which have not been explained, less than half that number were provided for.

The Des Moines boys were all interviewed and report that they are having the time of their lives and want their parents and friends in Des Moines to know it; and would be very happy if some of their friends could find a way to pay them a visit.

The camp is run on a regular military schedule and they are being taught all branches of the service, including close order drill, engineering, topography, physical training, citizenship, combat leadership, marksmanship, field problems, officers' duties and scouting.

Ninth Cavalry Men Instructors

Forty-five picked men from the famous Ninth U. S. Cavalry, composed of Negro troops, have been detailed as instructors and companions, each of them having to their credit from eight to thirty years of service and having been chosen for this service not only because of their high military standing; but also because of their high moral and Christian character; and they are personally seeing to it that these youngsters get plenty of good wholesome food, lots of good clean sport and attend religious services at the church of their choice.

Instructor Former Ft. Des Moines Officer

Among the most outstanding of these men are Corporal Henry L. Wilson, who saw service in the Spanish American War, was instructor during the World War and is now completing thirty years with this assignment of instructing the youth of his Race after which he will retire, very happy because of this fitting climax to his many years of service; Warrant Officer Goodman; Master Sgt. Childress, who practically runs the famous Ninth and Sergeant Johnson, an expert gunner and instructor in the Ordnance Academy where all U. S. Army Officers must come to receive instruction.

Des Moines, Ia., June 28, 1931.
To the Honorable B. M. Miller, Governor of the State of Alabama; Montgomery, Ala.
Honored Sir:

At a mass meeting of the Socialist Party of Iowa at the city of Des Moines, on the 28th day of June, 1931, the following resolution was unanimously adopted:

"Whereas: From reports issued by the National Organization of the Socialist Party of America, from items in the current press and from other sources of information we believe the facts show undue haste and racial prejudice in the conviction and condemnation of the nine young Negro men at Scottsboro, Ala., on the charge of rape.

Now, therefore, we respectfully and earnestly urge that you use such power, and influence as is vested in you as Chief Executive of the State of Alabama, to assure to these defendants complete and unprejudiced justice.

Signed: I. S. McCRILLIS, State Secretary Socialist Party of Iowa.

DE PRIEST-MILLER-JONES NON-PARTISAN GATHERING

Washington (CNS)—Answering the call of Congressman Oscar DePriest, a small group of persons, representing a variety of political, religious, fraternal and educational organizations, met at the House Office Building here last Friday and made plans for a nation-wide non-partisan gathering to be held in Washington during the first week in December of this year.

The purpose of the coming conference it was said would be to determine the needs and grievances of colored citizens in America and formulate a plan for their amelioration to be presented to the national conventions of the Democratic and Republican parties for appropriate action. Delegates from every civic, fraternal, religious and political organization among Negroes in the country would be invited to attend this conference, it was promised.

Scottsboro Attorneys Prepare Appeal

New York, June 26—With 90 days to go from the time motion for a new trial for the eight Negro boys in Scottsboro was overruled, Messrs. Fort, Beddow and Ray, Birmingham, Alabama, Attorneys retained by the N. A. A. C. P. are preparing a bill of exceptions. This will be presented by them to the trial judge in ample time.

Judge William E. Fort, of the law firm, informs the N. A. A. C. P. that both in writing and by understanding with the trial judge, his firm noted an exception to his decision overruling the motion for a new trial for the boys.

THE OTHER SIDE

A number of our leading Negro papers have been carrying on a campaign styled "Don't spend your money where you cannot work". Undoubtedly the one conducted by the Chicago Whip has been the most far-reaching for they have succeeded in making openings where others dared not undertake.

Taking its cue from the Whip—realizing of course that Des Moines does not have the concentration of Negroes in large communities as Chicago—The Bystander has urged Negroes to spend their money where it is appreciated. By appreciated is meant hiring Negro help and advertising in our Negro paper.

Just how much help out efforts have been we are not stating at this time, but what we wish to emphasize here is that "The fellow who appreciates our trade should get our business."

Last week an advertiser called our attention to the fact that he hired nineteen Negroes, advertised in our paper; his competitor did neither, charged the same price, yet got most of the business. Upon investigation, it turned out that other things were involved which caused this difference, but the situation should be rectified and this man given all of the Negro's trade. Certainly the fellow who hires none is not entitled to it.

After all every fellow has his part to play. It is not enough to ask for a square deal from the other fellow; that same fellow is entitled to a square deal from you.

Honorable John B. Hammond is trying to drive all the "near beer" out of Des Moines. Evidently he has concluded that he cannot drive the alcohol and liquor out of Des Moines—so he takes the line of least resistance. His latest job will be just about as successful as the former one and that is a miserable failure, judging from the number of drunks who show up at the Municipal Court daily.

THE RIGHT WAY

Recent news from the New York, New Jersey, Connecticut branch of the Federal Bar Association stated that several members have threatened to withdraw from the organization if Negroes were excluded.

The United States district attorney for the Southern District of New York—who has as one of his assistants, Hubert T. Delaney, a Negro—stated that he did not care to be a member of any organization to which any of his assistants were excluded. This is a splendid position to take and will do more to quell segregation and exclusion of Negroes from certain activities than anything else.

After all the members of these clubs make the rules and have the authority to change them. Furthermore, the fellow who is trying to exclude the Negro will go to any measure to carry his point even if it is necessary to make a fool of himself while many of our friends seldom protest above a whisper. Friends like the New York attorney—and we have them everywhere—

HEALTH TALKS

HEAT EXHAUSTION

Heat exhaustion occurs when the temperature is very high—too high for the body to withstand. It may occur in an apparently normal body when exposed for a long period to the sun's rays. The name is very aptly suited to the condition existing because it is an exhaustion in every sense of the word. There is prostration, profuse sweating, a feeble heart action and a temperature which is low. When the condition is coming on there is dizziness, sickness at the stomach and weakness with an unsteady gait.

Those affected are without appetite and unable to do any physical work. These are the symptoms which demand immediate attention because the outcome may be rapidly fatal if not quickly attended to.

Persons in old age are more liable to develop the condition but young persons are by no means immune and children are affected in fairly large numbers. Absurd as it may seem this condition calls for more heat which may be given in the form of a hot bath. It is important not to confuse it with another condition due to heat in which the treatment consists in part of the application of cold. If the temperature is raised cold will be needed. Persons with weak hearts or those who are susceptible should be very careful in extremely hot weather.

SPLIT IN FEDERAL BAR THREATENED ON RACIAL ISSUE

New York, (CNS)—The New York, New Jersey and Connecticut branch of the Federal Bar Association threatened to secede from the National organization at a meeting here Monday night unless it is permitted to retain as members four colored lawyers barred from affiliation under the constitution of the association.

The four Negroes are Francis X. Giles, an assistant United States attorney in the eastern New York district; Oliver Randolph, assistant United States attorney in New Jersey; Richard L. Baltimore, former assistant United States attorney in the eastern New York district, and Hubert T. Delaney, an assistant United States attorney in the Southern District of New York.

A severance from the association seemed inevitable for the branch, whose members include present and past attorneys in Federal service, officers of its metropolitan area branch, and officers of its national association, that it "would be glad" to continue affiliation if it can retain its asserted as the meeting adopted a resolution.

New York, June 12.—A young colored girl, poor and without friends, through the intervention of the Indiana State Conference won a blackmail case against a white millionaire in Marion.

Mrs. F. K. Bailey, president of the Indiana State Conference, informs the national office that the young girl, 20 years old, was arrested, charged with having written Milton Matter, a local white millionaire, a letter threatening harm to himself and his son if he did not leave \$4,500 at a specified place and time.

The Indiana N. A. A. C. P. convinced of the girl's innocence, retained a local colored attorney, J. W. Burdon, who was assisted by D. E. Bell, white attorney. After a hard-fought legal battle, the jury returned a verdict in favor of the girl, having been out only an hour.

PULLMAN PORTER WINS \$2500 FOR ARREST AND MALICIOUS PROSECUTION

New York, June 16.—Arthur Garfield Hays, of New York City, prominent attorney who was associated with Clarence Darrow in the Sweet cases in Detroit, informs the N. A. A. C. P. that his client, William J. Thompson, a Pullman porter, has won a verdict of \$2,500 against the Pullman company for false arrest and malicious prosecution, after sixteen minutes deliberation by a jury.

TWO N. A. A. C. P. BRANCHES RAISE \$1200.

THERE ARE NO PURE RACES SAYS HARVARD SCIENTIST

New York, June 12.—That there are no pure races, "Nordic" or other, and that race mixture is beneficial, are statements made in a newly published book "Up From the Ape," by Dr. Ernest A. Hooton, professor of anthropology at Harvard university, published by MacMillan.

A news account of the book, published in the New York Times and relayed by the N. A. A. C. P., states that Professor Hooton calls "scientifically unfounded" the charges of inferiority against Negro races, says that in many cases of racial intermixture the children are taller and of greater vitality than either of the parent races, and calls a "ridiculous boast" the claim of "self-styled Nordics" that they are racially pure and superior to other racial stocks.

YOUNG REPUBLICANS GATHER IN WASHINGTON

Washington, (C.N.S.) June 16.—In response to a call from the republican national committee more than 300 delegates and representatives met in the first National Conference of Young Republicans here Thursday and Friday, June 11 and 12.

Among the delegates were Mrs. Ophelia H. Lee McIver of Savannah, Georgia; John P. Davis, of Cambridge, Mass., and Perry W. Howard, Jr., and Miss Doris Risher of Washington, D. C., accredited to Mississippi.

Mr. John P. Davis, who is known as a forceful young orator was introduced by Executive Director Robert H. Lucas of the national committee, as an outstanding young Negro republican and made an impressive little talk. Mr. Davis was heartily congratulated afterwards by many young delegates who seemed anxious to cooperate with young Negro republicans in organization work.

MONROVIA LISTED AMONG 79 UNHEALTHFUL U. S. FOREIGN SERVICE POSTS

Washington (C.N.S.) June 16.—Monrovia the capital of Liberia was listed among seventy-nine cities throughout the world designated as an unhealthful post for the foreign service by President Hoover in an executive order made public by the state department Thursday.

The classification was made for purposes of listing posts, service at which would count as one year and a half annually toward retirement of foreign service officers. The designation is made each year by the president and is determined primarily by climatic conditions, such as heat.

PATIENCE IS KEY TO DOG TRAINING

Use Tact and Kindness to Bring Out the Best of Animal's Ability.

A properly trained dog is a delight to himself and his master. He loves to do his master's bidding, and were every dog well-trained, there would be little complaint about dogs and their deeds, states the Chappel Kennel Foundation, Rockford, Illinois. Probably 95 per cent of dogs have the ability for training and only require effort, patience and repetition to bring it out of them.



The Early Training of a Dog Is Most Important.

The early training of a dog is most important. A dog not trained or disciplined during the first twelve months of his life, will not be nearly as manageable and dependable when grown. Only one person should be the dog's instructor during the entire course of training. After a dog is trained, he should go through the commands for anyone who gives them properly. The first and biggest lesson you can teach him is obedience, founded upon full confidence in you as his master. All the rest will take care of themselves as a matter of course.

Causes of failure to secure obedience from a dog after weeks of training may be set down as two. The act has not been repeated often enough or it has been repeated too many times on the same day. Two or three commands a day are sufficient. But stop work only on a successful performance.

Another cause of poor control over a dog is failure to reward him. A dog likes to be praised and feel that he is appreciated. A kind word, a pat on the head will usually go about as far as anything else. A bit of such food as kibbled biscuit, given at the end of each successful act helps him to feel that he is appreciated.

Simple Facts of Dog Feeding Told

If the feeding of your dog presents itself as a weighty problem, take heart!

According to the Chappel Kennel Foundation, Rockford, Illinois, here is all that you need to know about his feeding:

1. Feed one heavy meal a day, preferably in the evening. Feed the light meal in the morning. Puppies require three to five meals a day, depending on their ages. Feed at the same hours each day.
2. Meat is the dog's natural diet. If you feed your dog a prepared, well-balanced meat food, with dog biscuits for variety's sake, he will need nothing else.
3. Don't feed table scraps, potatoes, boiled eggs or pork, and don't serve soupy foods. Beware of chicken and fish bones. Dogs care nothing for sweets until taught to like them.
4. Provide plenty of water.
5. Never allow violent exercise directly after feeding.

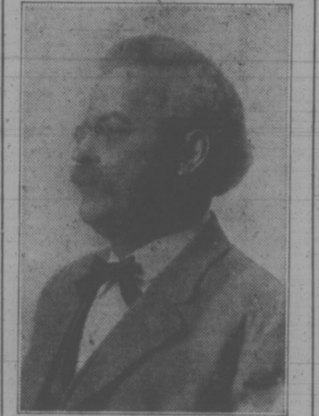
CHURCH SCHOOL A SUCCESS

Jujutsu of Chinese Origin?
"My old teacher told me," recalls Taro Miyake, Japanese exponent of Jujutsu, in an interview in the Atlanta Journal, "that Jujutsu is a development of the old Chinese method of fighting with the fingers extended. This was a very dangerous and skillful system. A man strengthened out his fingers stiffly and jabbed with them, preferably for the eyes. Failing to reach the eyes, he sought various nerve centers on the body."
"When the Japanese took up the science, more than 1,000 years ago, they began to improve it. Instead of jabbing for the eyes they gradually developed a system of leverages that would work against bones and nerve centers."

Ancient City of Bergamo
One of the most picturesque towns of Lombardy in Italy is the ancient little city of Bergamo, perched on a conspicuous hill and still remnant of the days when the Venetians made it one of their fortresses.
