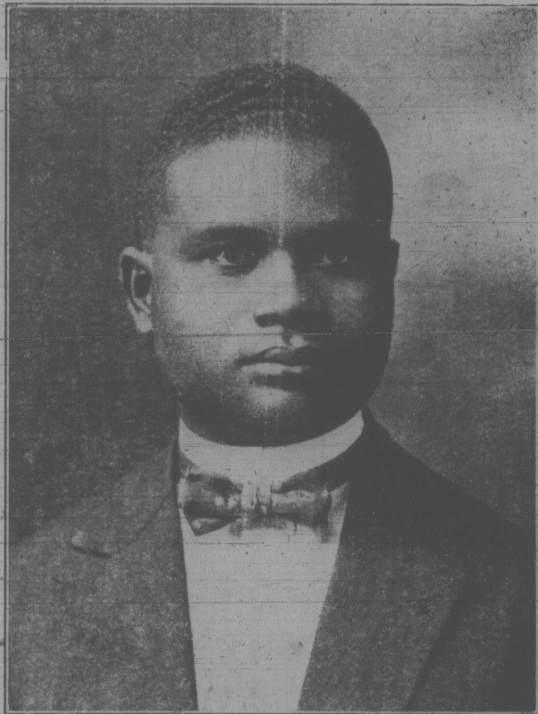

Henry Hasbrouck, Y. M. C. A. physical director, in a long distance call to Wadsworth, staff writer, last Wednesday, stated that all the boys are happy and having a fine of their lives. Three Killed As Negroes Riot in Chicago

Chicago Aug. 4.—Three Negroes were killed and three policemen injured late Monday in a riot precipitated by several hundred Negroes who protested the eviction of a family for nonpayment of rent.

The Negroes were slain, officials said, after police had been attacked with knives and pistols. The crowd was dispersed by police reserves and a number of persons were taken into custody.

Reserves Mobilized

Monday night every police reserve in the city had been mobilized in the south side Negro district as a precaution against further outbreaks.

N. A. A. C. P. REFUTES

SOUTHERN JURIST ON SCOTTSBORO FACTS

Toronto, Canada, July 31.—An attempt by a southern jurist, Judge Robert H. Sykes of Durham, N. C., President of the Commercial Law League now in annual session here, to convince Canadians that the trials of nine Negro youths charged with rape at Scottsboro early in April were impartially conducted, was sharply challenged here this week by Walter White, secretary of the N. A. A. C. P., in telegrams to the Commercial Law League and to the Toronto daily newspapers. The messages were wired from the New York office of the Association.

SCOTTSBORO DEFENSE CONTRIBUTIONS TO

N. A. A. C. P. MOUNT

New York, July 31.—From every part of the United States and from all classes of colored and white people contributions are being sent to the N. A. A. C. P. to aid in the defense of the nine boys tried at Scottsboro in April, eight of whom were sentenced to death, and whose appeals are now pending before the Alabama Supreme Court.

In making public the additional list of contributions the N. A. A. C. P. pointed out that these contributions have come from as widely separated areas as Arkansas, Alabama, Arizona, Kentucky, West Virginia, New Jersey, the District of Columbia, Texas, Pennsylvania.

ORANGE AND PLAINFIELD N. A. A. C. P. BRANCHES HOLD ENTHUSIASTIC SCOTTSBORO MEETINGS

P. defense fund for the Scottsboro cases. Cooperating enthusiastically with the New York Women's Auxiliary as joint sponsor for the affair is the famous and popular Osby Club.

Lincoln Post Men Stir Convention With Issue

NATIONAL BENEFIT OFFICIALS DECLARE COMPANY SOUND DESPITE GEORGIA RECEIVERSHIP

Washington (CNS)—Officials of the National Benefit Life Insurance Company were emphatic in their denials Saturday that the temporary receivership of the Georgia branch of the company in any way impaired their business or pointed to any possibility of the failure of the company. They vigorously declared that there was absolutely no cause for alarm. The temporary receivership, it is claimed, is only based on the alleged lack of a sufficient reserve. If there is any deficit in the reserve, officials of the present regime assured newspapermen that the necessary capital to make up this deficit would be immediately supplied.

New 'Sweet Case' At Minneapolis

New York, July 31.—3,000 whites gathered around 4600 Columbus Ave., Minneapolis, on the night of July 15, and on the following evening more than 4,000 assembled in an effort to intimidate A. A. Lee, Negro post office employee, into evacuating the home he has just purchased. So tense was the situation that at the insistence of the Minneapolis Branch of the N. A. A. C. P. through its president, Miss L. O. Smith, prominent Minneapolis attorney, it was necessary for Chief of Police William Meehan and Police Inspector Frank Bleed to take charge personally of the situation. These officials massed of squads of policemen and detectives to keep the crowd as far as possible from the Lee home.

PRIMARY BAR ON NEGROES PUT UP TO U. S. HIGH COURT

Texas Case of Special Interest in Various Southern States Filed by N. A. A. C. P.

New York, July 30.—The N. A. A. C. P. announces that on July 30 a petition for certiorari in the Texas Primary Case (Nixon vs Condon) was filed in the United States Supreme Court, asking that tribunal to review a decision of the Circuit Court of Appeals by which Dr. L. A. Nixon of El Paso, Texas, was barred from the Democratic primary. The Supreme Court is now in recess and will not pass upon the petition until October. Meantime the outcome will be awaited with interest in various Southern states.

PRINCIPALS IN BROWNSVILLE AFFRAY INVESTIGATION DEAD

Washington (CNS)—The interment at Arlington of Major General Augustus Perry Blockson, white, retired army officer and formerly major in the inspector-general's department of the U. S. Army, marks the passing of one of the few remaining principals in the so-called investigation of the affray at Brownsville, Texas, in 1906, which resulted in the discharge from the service of one hundred and sixty-seven enlisted colored soldiers of the Twenty-fifth infantry. This discharge recommended by Blockson and approved by the late William Howard Taft, then secretary of War under Theodore Roosevelt, made Blockson one of the most disliked officers among the colored enlisted men of that time.

FLORIDA WOMAN ELECTED TO HEAD NATIONAL CONGRESS OF PARENT-TEACHERS

Washington, (CNS)—Mrs. M. W. Blocker of Jacksonville, Fla., was elected president of the National Congress of Colored Parents and Teachers,

Taking note of the fact that lynchings are on the increase in America, the Iowa Department of the American Legion at its thirteenth annual session in Davenport this week passed a resolution deploring lynching and all other forms of lawlessness.

The resolution presented by Attorney James B. Morris and Spencer Eliston of Lincoln Post of Des Moines had the unanimous support of the delegates.

Robert W. Colflesh, Des Moines Attorney, was elected Commander. He had the support of Lincoln Post from the time he announced his candidacy. R. J. Laird was reelected adjutant.

The two Davenport posts—one white and the other colored—entertained the convention and the color bearers during the session were the Commanders of the two posts. Negro delegates attending were Spencer Eliston, Charles P. Howard and James B. Morris of Des Moines and Henry and R. Taggart of Davenport.

NEGRO NEWSPAPERS IMPORTANT ADVERTISING MEDIUM SAYS WHITE MAGAZINE

New York (CNS)—The American Press, foremost national newspaper trade magazine, in its July issue pointed out to its readers the importance of the Negro Newspaper as an advertising medium. In a complete analysis of the newspaper field, the magazine stated:

"Negro Journalism forms by no means an insignificant portion of the output of American presses. Altogether there are one hundred and sixty publications of all kinds listed under the special classification of Negro publications in Ayer's Directory. These papers comprise everything from dozens of weeklies whose make-up is essentially that of the ordinary daily newspapers, to monthlies and quarterlies.

"That they wield an unquestionable power is attested by the large circulations possessed by several of them, the Chicago Defender leading the list with 110,000."

WHOSE RESPONSIBILITY?

As much as we deplore the trouble which caused the loss of the lives of several people in Chicago, it tends to bring home a lesson to the leaders of the country, which ought to be considered seriously.

To be without a job hurts, to be without food and clothing is worse and even though one may say that much of this misfortune is due to the lack of foresight, it does not keep man from becoming vicious who is thus deprived. Men break down under strains such as exist today, and this is one of the big reasons why periods like the present depression should be averted.

Nobody doubts that the Communist group does have some splendid ideas; many people are not averse to some of their ideas being put into law. However we DON'T believe that the Communist or any other group can get far which uses UNLAWFUL methods to gain its purpose. A certain amount of radicals we will always have; it is true of the reactionaries. Both have their place in the scheme of things for it is the middle ground between the two where we make progress. Movements can be radical and yet stay WITHIN the law.

IOWA LEGIONNAIRES AGAINST LYNCHING

The Iowa Department of the American Legion passed a resolution at its session in Davenport condemning lynching and all forms of lawlessness. The preamble of both the national and state constitutions declare that the organization among other things was formed "To maintain law and order" and this resolution is in line with the Legion's policy.

The American Legion has the largest membership in its history—more than a million. Iowa has over thirty-six thousand. The men who fought in 1917-1918 to win the war are now organized to make better communities.

The lynch evil is a blow to the fundamentals of this nation and to have the support of the Legion in a movement to eradicate the evil is a fine point gained.

HEALTH TALKS

By Dr. H. H. London

THE SKIN

The skin is of no less importance to the individual than the kidneys but it is very seldom thought of in connection with excretion. To be clearly understood in this connection it is necessary to say that the skin would not do the work

of excretion if both kidneys were removed but it is such a help to these organs that if its function becomes impaired there is extra work thrown on the kidneys (the excretory organs proper) sometimes to such an extent that damage to them results in great or small degree depending on the amount of skin involved. Such is the case in severe burns and in extensive diseases of the skin. Tests have shown that the amount of work the skin does is out of all proportion to what might be observed or imagined. In order to maintain a proper state of health it is necessary that this portion of the system receive some care.

The complete absence of perspiration under all conditions is not normal any more than excessive perspiration under all conditions. The nervous system is quite active in this connection as it is in most all other functions of the body. Both conditions are present in certain diseases and should not be allowed to continue indefinitely. All diseases of the skin do some damage to other parts of the body and need immediate attention.

GIVE HIM A CHANCE

DISCHARGE OF SIX WHITE NATIONAL BENEFIT EMPLOYEES SAVES COMPANY \$175,000 ANNUALLY

INVESTIGATION REVEALS WHITES RESPONSIBLE FOR ALABAMA RACE RIOT

New York, July 24—Reports made by responsible parties in Alabama to the N. A. A. C. P. reveal new information concerning the race riot at Camp Hill, Alabama, on July 16. Two white men and one Negro from Chattanooga, reputed to be Communist organizers, went to Camp Hill, recently and formed an organization of Negroes ostensibly to protest against share cropping. It is revealed that these organizers wrote, or caused to be written, in the minute books of the newly formed organization that its name should be "The Society for the Advancement of Colored People".

In the subsequent trouble of July 16th one Negro was killed, a number were injured and 34 are in prison.

POLICE PROTECT GANGSTERS

New York, July 24, (CNS)—Vicious attacks have been made by a mob of gangsters against the Negro tenants of 117th St., east of Pleasant Avenue. This was formerly a white neighborhood. The extreme congestion in Harlem and the terrifically high rents are driving the Negroes to seek quarters outside the district. Landlords on the fringe of the black section are encouraging the migration by offering the houses now occupied by white tenants to Negro tenants at an increased rental.

WOMAN IN HARPER CASE GETS NEW PERJURY TRIAL

Norfolk, Va., (CNS)—Mrs. Dorothy Skaggs was granted a new trial here Saturday from conviction on charges of perjury in testimony against William Harper, a colored youth, alleged to have committed assault (criminal) upon the white woman.

Mrs. Skaggs of Portsmouth was under sentence of five years in the State penitentiary on the original conviction. Harper was convicted and sentenced to die in the electric chair last January 6 for the alleged assault, but later won a new trial and was acquitted.

Philadelphia, (CNS)—The numerous friends of the Rev. R. R. Wright, Jr., editor for over 24 years of the Christian Recorder, the official organ of the A. M. E. church, have begun booming his candidacy for one of the three bishoprics made vacant during the year by the deaths of Bishops A. J. Carey, J. Albert Johnson, and John Hurst. He has the endorsements of annual conferences of Philadelphia, New York, New Jersey, Delaware, Nova Scotia, Bermuda and New England.

Friends of the Rev. Wright point out that he had the highest vote for the position in the general conference of 1928 until he withdrew his candidacy.

ABSOLUTE MONARCHY OF BYSSINIA ENDS; EMPEROR SETS UP A CONSTITUTION

Addis Ababa, Abyssinia, July 20—(CNS)—By his own free will, Emperor Ras Tafari, Haile Selassie of Abyssinia, has stopped from the rank of absolute ruler of his kingdom and granted a constitution to his subjects, it was announced here Wednesday. Speaking from the throne at a brilliant ceremony in the palace, the Emperor announced he had decided to establish a two-chamber Parliament with responsible Ministers to carry out its decisions henceforth, he declared, he would rule Abyssinia in conformity, with the Constitution, but that "in order to prevent future disputes the crown would be secured to the present dynasty."

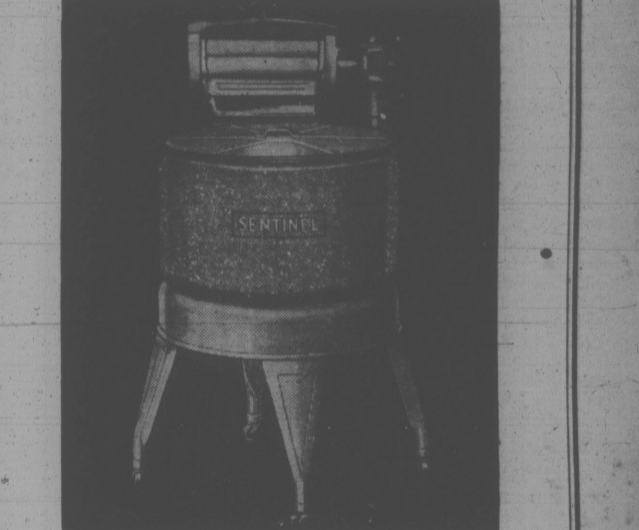

OF 18,500 NEGRO COLLEGE STUDENTS ENROLLED, 1,980 RECEIVED DEGREES THIS YEAR

Washington, (CNS)—According to an article appearing in the recent issue of the Crisis, 1,980 Negroes received degrees during the collegiate year of 1930-31, out of a total of 18,500 students enrolled in colleges throughout the nation.

Howard University of this city led the list with 222 graduates out of a student body of 2,473. Prairie View College of Texas, was second with 135 graduates out of a total of 997 students. Fisk University of Nashville with an enrollment of 473, had 101 graduates.

White Universities Ohio State University with approximately 300 Negro students enrolled had 18 graduates. Temple University of Philadelphia, its nearest competitor, with an enrollment of 189, had 7 graduates. Of the 2,063 Negroes enrolled in 62 white northern universities, 350 received degrees.

Important Changes Among the important changes in Negro colleges was the entrance of Atlanta University upon a career as a university, having no undergraduate students.

PAPER BAROMETER

Henry's Twentieth Century Book of Recipes publishes the following method of making a paper barometer: Saturate white blotting paper with the following liquid and then hang up to dry:

Cabalt chloride, 1 ounce; sodium chloride 1/4 ounce; calcium chloride, 75 grains; acacia, 1/4 ounce; water 8 ounces.

The amount of moisture in the air is roughly indicated by the changing color of the paper, rose red indicating rain; pale red, very moist; bluish red, moist; lavender blue, nearly dry; blue, very dry.
