Bulldogs Defeat Lincoln Heights

The Pearson Bulldogs, star semi-pro aggregation, defeated the Lincoln Heights A. C. on the Des Moines University field last Sunday 7 to 0, before a large crowd for their second victory in as many starts of the season. The only score of the game came in the fourth period after three quarters of fierce battling of the two clubs. A long punt fumbled by Mitchell, Lincoln Heights quarterback, rolled into the end zone, and was recovered by Bruce, Bulldog guard, for a touch-down. Jackson, right half, touched-down for the extra point. Lincoln Heights was completely outplayed by the dusky warriors; however, five times the Bulldogs carried the ball into the enemy's territory, but lacked the punch to push it over. The colored boys attempted three field goals, one was blocked and the other two fell short. Jackson was the star for the winners, with his long consistent gains; he ripped the enemy's line for considerable yardage. New York, October 16.—Latest developments in the fight to save the eight Negro boys condemned to death after mob-dominated trials in Scottsboro, Ala., are given as follows by the N. A. A. C. P.: Marc Connelly, author of the "Green Pastures," Pulitzer prize play, has thrown his support to the N. A. A. C. P. in the defense fight, sending his personal check for \$25 to aid in the legal expenses. The bills of exceptions to the Alabama Supreme Court filed for certification number 790 pages and have been called one of the most masterly presentations of this kind ever seen in an Alabama court.

Dr. Sweet Involved In Girl's Death

Detroit, Mich., Oct. 16.—The sudden death of Mrs. Genevieve Ballenger, a prominent East side society woman, here Tuesday, caused by poisoned medicine administered by her husband, George Ballenger, and said to have been prescribed by Dr. H. O. Sweet, was for several days clouded in mystery and caused considerable neighborhood gossip. Ballenger was said by some to have deliberately poisoned his wife, while others blamed the attending physician.

NAACP To Fight Southern Memorial

New York, October 16.—Unveiling of a tablet last week at Harper's Ferry, W. Va., by the United Daughters of the Confederacy with inscriptions hostile to the memory of John Brown and a speech by Dr. Henry T. MacDonald, president of Storer College, has drawn the spirited protest of the N. A. A. C. P.

The N. A. A. C. P. wrote a letter of protest to Dr. MacDonald urging him not to speak on the occasion, and citing inscriptions on the tablet unveiled, a memorial to Heyward Shepherd, a Negro slave. The tablet is to be a memorial "to all true slaves who remained faithful during the raid," and characterized John Brown as a "conniving Abolitionist with a criminal record behind him who tried to overthrow the government of Virginia and set the Negroes free," and also stating that "not a single slave joined the John Brown conspirators with the exception of one or two captured by Brown and forced to accompany him under compulsion."

Ed Cooley Shoots Wife; Gives Self Up To Sheriff

Mrs. Ethel Cooley, 1553 Buchanan Street, was shot to death Wednesday night at 8:30 by her estranged husband, Ed Cooley, coal miner, who immediately hastened to the county jail and beat on the steel doors screaming, "Let me in, let me in!" When the turnkey appeared, according to reports, he said, "I want in, you want me, I'm the one that did the shooting out there on Buchanan."

Leader To Teach In Eastern School

Mr. William Oney, Deputy Grand Master for Iowa and Jurisdiction, leaves to begin his duties as Dean of Men at Eley Wood, Mass. He will teach in the Junior College there also. Mr. Oney has made a splendid record, coming to Des Moines several years ago and working his way through school and continuing until he graduated from high school and obtained his Bachelor of Arts degree from Drake University. He has served at the head of every organization that he has his membership in and has served in every capacity in the Iowa Grand Lodge. He is the youngest Negro to hold the thirty-third and last degree and be a member of the Supreme Council of thirty-third degree Masons. Mr. Oney is a great church man, serving as class leader, steward, Sunday School teacher, normal graduate, expert Endeavor graduate, president of the Endeavor, and represented the church in various conferences as a delegate.

He was an active member of the American Legion, Lincoln Post No. 126; Omega Chapter of Kappa Alpha Psi Fraternity; Imperial Council of Shriners; Iowa Grand Lodge and the Y. M. C. A.

Mr. Oney, as a member and faithful leader, will be sadly missed in Des Moines and throughout the state. His many friends extend to him their best wishes for his success in the educational world.

Mrs. Carrie Law, Dies Following Long Illness

Mrs. Carrie Law, 102 East Holcomb Avenue, former choir director at the Corinthian Baptist Church for several years, died Wednesday after an illness of eight months. She was a resident of this city thirty years, and prominent in lodge and church circles. BISHOP ALL WET

Bishop Cannon told H. L. Mencken that prohibition is on the victory road; that on a recent trip to the south and west he never saw so much sentiment for prohibition. And while he was among Methodists all the time, that made no difference.

Bishop Cannon is in the habit of uttering less than half the truth. This was pretty well established when he reported to the House of Representatives an expenditure of \$17,000 given him to finance the anti-Smith campaign in Virginia in 1928 when as a matter of fact one man gave him \$63,000.

It is remarkable how many of the dry forces either misrepresent the situation or don't know what is really going on with regard to drinking today.

Everybody who knows or takes the time to investigate will find that alcohol is so cheap today that it is not profitable to handle it even though the seller does not run counter to the law. The supply is unending.

About the only person who believes prohibition is succeeding is the fellow who deliberately shuts his eyes to real facts, or misrepresents the situation as it actually exists.

The most dangerous Negro in the race is the fellow who tells the white people that all is well in the Negro race when he actually knows down in his heart that he is not telling the truth.

BUSINESS

Last week the Bystander discussed some of the Negro business institutions which had forged ahead and made splendid progress. On the east side, Mr. L. Fowler established "The Funeral Home Beautiful." With his son, L. Fowler, Jr., he has built a modern, well equipped institution. On the west side another funeral home, although recently taken over by Mr. T. W. Wilson, ranks among the best to be found anywhere. Both Mr. Wilson and Mr. Fowler have built institutions of which any town with twice the Negro population would be proud.

The outstanding grocery establishment is that of William Batley in East Des Moines—well stocked, well managed, splendid surroundings. L. Bowles has operated a grocery for many years—it is commendable that he has been able to continue. He is building a bigger and better business all the time.

Many other institutions, among which are the Peerless Dress Club, Hatters Lunch, Smith's Barber Shop, Williams' Restaurant in East Des Moines, are institutions which go to make up Des Moines' business colony.

These two articles are written with the idea of calling attention of our readers to the fact that Negroes are operating business institutions and need to be supported. We further desire to call attention to the fact that among the Negro group in Des Moines are contractors, carpenters, bricklayers, plumbers, electricians, etc. Because they are not employed in these capacities is no reason why they are not good mechanics, but are barred because of discrimination, union rules and practices.

HEALTH TALKS

PNEUMONIA

Pneumonia is such a serious disease and the outcome so uncertain that a ny information which might prevent it would seem to be welcome. It is stated by the late Doctor Osler that from a total of 6,335 deaths in 1909 and 1910

in the Canal Zone at Panama 2,264, or more than one-third, were due to pneumonia and that tuberculosis came second, winning from the latter disease the name of "the captain of the men of death", bestowed upon it by John Bunyan. He further states that in Johannesburg (which must be a city in Panama) the deaths among the colored people fell from 1,196 in 1912-13 to 325 in 1913-14, coincident with improvement in the sanitary condition of the dwellings. From such an observation then it is obvious that ventilation, proper heat, cleanliness of the household and personal hygiene are factors in keeping it down. It is shown that up to the sixth year it is very easy for children to take pneumonia; from the sixth to the fifteenth year not so easy, but for each year after, it increases so that the older one becomes from then the easier it is for pneumonia to develop. Exposure to cold, extreme hardship with insufficient nourishment and conditions which keep the body under its normal healthy state cause pneumonia to develop. Becoming wet in freezing weather is almost sure to cause it, unless warmth and comfort are immediately supplied. The disease occurs most frequently in the winter and spring months. Attention to these facts would do much to lower the number of cases in each locality.

An anti-prohibition writer says there are several hundred speak-easies in Iowa, but none in some of the southern states. While he tells the truth about Iowa, he is certainly kidding somebody about those southern states. However, maybe he means a prospective buyer does not have to "speakeasy" when he asks for a drink down there.

WILBERFORCE AND TUSKEGEE IN CHICAGO OCTOBER 24

Chicago, Oct. 9.—The Tuskegee-Wilberforce football game, for the past three years Chicago's outstanding sport event, which was reported last week as moving to the Ohio school's campus, will be played here Oct. 24 as originally planned.

A few weeks ago officials at both schools advised the press of the removal of the game to Wilberforce with the explanation that inability to secure Soldiers field caused the switch. The decision was somewhat of a blow to local followers of the teams and a campaign to have it played here was started immediately, with the result that Chicago does get the attraction, which will be played in Mills stadium, Lake St. at Kostner Ave., Saturday afternoon, Oct. 24.

2 COLORED STARS IN NEW PAUL GREEN PLAY ON BROADWAY

New York, Oct. 2.—Two colored actresses, Fanny De Knight and Rose McClendon, share honors in a new play about the South, "The House of Connelly," by Paul Green, which received a stirring welcome on its opening this week in the Martin Beck Theatre. The play portrays the breakdown of the old white slave-holding aristocracy of the South and is set in the year 1905. It is produced by the Group Theatre, a company of young actors under the auspices of the Theatre Guild. McClendon was one of the stars of "Porgy," "eDep River," and "In Abrahams' Bosom", Pulitzer Prize Play of 1928.

SECEDE FROM NATIONAL GOVERNING BODY

Columbia, S. C., Oct. 9.—That the Knights of Pythias of South Carolina will secede from the national body was the decision reached by some 600 members of the order in a special session of the state grand lodge here Thursday.

The special session was called by J. A. Brown, S. C. grand chancellor of the order and the discussions continued throughout the day most of which centered around the refusal of the supreme lodge to seat the two delegates from South Carolina at the Boston meeting of the order and

THE DETERMINATION OF THE STATE GRAND LODGE NOT TO PAY ITS PAST DUE NATIONAL TAXES.

For the past three or four years, according to the officers of the state body, the organization has been laboring under tax burdens placed upon it to pay for the national temple of the order, which is located in Chicago and is valued at more than a million dollars. The grand lodge is said to have collected the national tax but refused to pay it.

New York Oct. 9.—Three Negro workers have been elected members of the American Workers delegation to soviet Russia that will sail Oct. 14 to attend the 14th anniversary celebration of the Russian revolution. The delegation is being organized by friends of the soviet union, 80 E. 11th St., New York City, as an expression of solidarity between the American masses and the workers and peasants of the U. S. S. R. It will consist of 14 workers from the metal, marine and mining industries and five fraternal delegates. A mass send-off for the delegation will be held in New York, Monday, Oct. 12.

One of the delegates is a marine worker, Morris Wikman of New York, a member of the Marine Workers Industrial union. Another is J. W. Jones of the upper Monongahela bituminous coal district of Pennsylvania, who was elected by the striking miners. A third is a Gary (Ind) steel worker whose name is not yet known.

BAILEY MADE SPECIAL ASST. ATTY. GENERAL IN INDIANA
Indianapolis, Ind., Oct. 9.—Attorney R. L. Bailey, one of the best known lawyers in Indiana and the central West, has been appointed special assistant attorney general of the state of Indiana, the appointment being effective as of Oct. 1. Mr. Bailey thus becomes the first Negro man to occupy such a position in the Hoosier commonwealth. He has assumed his office and been regularly assigned to appeals and other cases.

The appointment was made through the influence of James M. Ogden, attorney general of the state. Mr. Ogden, who is an ex-president of the state bar association, a Harvard law graduate and an instructor in the Indiana College of Law, where he taught Bailey, is a man who has demonstrated his belief in fair play for Negroes on many occasions.

RECEIVES DEGREE IN MEDICINE FROM PORTUGUESE UNIVERSITY

Boston, Mass., Oct. 9.—To Dr. Aaron M. McMillan of Omaha, Neb., serving under the American Board of Commissioners for Foreign Missions, belongs the distinction of successfully completing work at the medical uni-

versity in Lisbon, and receiving from that institution his doctorate as a bona fide Portuguese physician.

Dr. McMillan, who is the son of Mrs. Sarah F. McMillan, 1029 Frederick St., Detroit is now on his way to his permanent station in Galangue, Portugues West Africa, where he will become a member of a mission station wholly manned by American Negro members, namely, Rev. H. C. McDowell of Epes, Ala., and Samuel B. Cloos of Tilden, Ala.

PATIENCE IS KEY TO DOG TRAINING

Use Tact and Kindness to Bring Out the Best of Animal's Ability.

A properly trained dog is a delight to himself and his master. He loves to do his master's bidding, and were every dog well-trained, there would be little complaint about dogs and their deeds, states the Chappel Kennel Foundation, Rockford, Illinois.

Probably 95 per cent of dogs have the ability for training and only require effort, patience and repetition to bring it out of them.

The early training of a dog is most important. A dog not trained or disciplined during the first twelve months of his life, will not be nearly as manageable and dependable when grown.

Only one person should be the dog's instructor during the entire course of

training. After a dog is trained, he should go through the commands for anyone who gives them properly.

The first and biggest lesson you can teach him is obedience, founded upon full confidence in you as his master. At the rest will take care of themselves as a matter of course.

Causes of failure to secure obedience from a dog after weeks of training may be set down as two. The first is that the dog has not been repeated often enough or it has been repeated too many times on the same day. Two or three commands a day are sufficient. But stop work only on a successful performance.

A dog does not know the difference in the meaning of words. After many trials and much work he can be taught to do so and so when a certain word is spoken. But the meaning of the word itself is beyond him. A word spoken in a kind way will make him glad and wag his tail; the same word spoken in a rough way will make him run in fear.

Another cause of poor control over a dog is failure to reward him. A dog likes to be praised and feel that he is appreciated. A kind word, a pat on the head will usually go about as far as anything else. A bit of such food as kibbled biscuit, given at the end of each successful act helps him to feel that he is appreciated.

Simple Facts of Dog Feeding Told

If the feeding of your dog presents itself as a weighty problem, take heart!

According to the Chappel Kennel Foundation, Rockford, Illinois, here is all that you need to know about his feeding:

1. Feed one heavy meal a day, preferably in the evening. Feed the light meal in the morning. Puppies require three to five meals a day, depending on their ages. Feed at the same hours each day.
 2. Meat is the dog's natural diet. If you feed your dog a prepared, well-balanced meat food, with dog biscuits for variety's sake, he will need nothing else.
 3. Don't feed table scraps, potatoes, boiled eggs or pork, and don't serve soupy foods. Beware of chicken and fish bones. Dogs care nothing for sweets until taught to like them.
 4. Provide plenty of water.
 5. Never allow violent exercise directly after feeding.
- If a dog does not take readily to biscuits, which are essential to keeping his gums hard and teeth clean, it is suggested that kibbled or broken biscuits be gradually incorporated into his regular ration until he gets used to eating them.

Favor Getting a Puppy to Buying a Mature Dog

Hints on Care and Training Given by Kennel Foundation.

Dog or puppy? The choice of one or the other must be made by everyone who contemplates adding a canine pet to his household, states the Chappel Kennel Foundation, Rockford, Illinois. While some prefer a perfectly-trained grown dog, most people are inclined to agree with Albert Payson Terhune that a puppy is more desirable. For one thing, a puppy does not cost as much

as a grown dog, and its future is entirely in your own hands.

Eating is the biggest thing in a puppy's life, and what and how he eats will either make or break him, according to the Foundation. "Little and often" is probably the best rule of successful puppy rearing. Feed four or five times a day from weaning time till four months of age and no more than four times a day at six months. Increase the ration as you decrease the number of feedings, but never serve more than just a trifle over what the puppy will eat up quickly. When the average puppy is at the end of twelve months ready to enter full doghood, he should be getting no more than two meals a day, and preferably one. If the puppy does not finish the meal provided for him, what remains must be removed in a few minutes and nothing else should be given until the next feeding hour.

By nature the dog is a meat-eating animal, but under today's domesticated conditions, fresh raw meat from the butcher's is much too concentrated a diet. Research workers who have given thought to this problem in recent years have been able to develop scientifically-balanced canned meat foods which have taken all the guess out of dog and puppy feeding. They contain all the elements necessary for proper growth and development. Both puppies and dogs especially relish those made from horse meat. A part of every puppy's ration should be some dry food which has been softened with milk or water.

This may be only a teaspoonful at six weeks, but should be increased with the size and condition of the animal. As the puppy grows older and its teeth stronger, dog biscuits or kibbled or whole form may be substituted. The biscuits afford the exercise demanded by the puppy's jaw and serve to keep his teeth clean. Teach your puppy to eat at a regular place and time. Having regular feeding times will be a big aid in housebreaking him. Make it a practice to take him out for a walk shortly after feeding.

"Dog Days" a Strain on Dogs

Suggestions for Care of Canines in Hot Weather Are Made by Foundation.

"Dog days" need be no more dangerous for Buster, Prince or Sport than any other days, states the Chappell Kennel Foundation, Rockford, Illinois, in discussing the care of the dog in hot weather.

The dog faces summer weather under two handicaps unknown to man. He has his natural coat, and perspires from limited areas of his body, the tongue, nose and the pads of the feet. Aged dogs feel the effects of heat much more than young dogs, and sick dogs more than dogs in good condition. Excess of perspiration in dogs may be eliminated if their owners would give a little extra thought and attention to quarters, exercise and diet. Some of the best practices designed to reduce the strain on dogs in warm days and prevent overheating, prostration and other summer ailments have been summed up by Dr. Edwin Reginald Blamey.

The outdoor kennel should be sheltered from the midday sun as much as possible. A better way is to keep the dog quiet and in a cool place during the heat of the day. A tiled floor or cellar floor is excellent. The room should be darkened, and care taken to see that an abundance of air is provided. Quarters for sleeping should have large windows, and the bedding reduced to a minimum. The ideal dog bed for summer is a raised frame covered with canvas. This enables the air to circulate freely beneath the body, and the animal is much cooler than if he were sleeping on a solid bed.

Both dog and kennel should be washed occasionally. Use of a small amount of disinfectant will tend to keep away flies and other insect pests which cause so much trouble during the summer.

Exercise should be cut down to a minimum or entirely stopped. If the dog is to be walked or run, it should be done in the cool of the early morning or evening. If the dog is broken to go on the street, it should be taken out only long enough to attend to its needs.

Food during the summer should be of the same well-balanced nature as

fed during the cooler months, but in somewhat smaller quantities. A dog's natural food is meat, whether it be the finest top dog or the largest hound. Meat and protein are not "heating" to the blood, and a substantial portion of a prepared meat food in the evening and some biscuits in the morning will keep the dog well satisfied. Occasionally weevil will get into biscuits made of the finest ingredients. They are not harmful to the dog, but may be killed by putting the biscuits into the oven for a few minutes or immersing them in boiling water. The addition of fresh vegetables occasionally helps to maintain physical condition but starch in any form is to be avoided. Encourage the dog to drink plenty of water by adding a little salt to each meal. Attention to diet will help to do away with periodic eczema and other summer skin complaints.

In many so-called cases of overheating, worms may really be the cause of the trouble. These should be removed by an appropriate medicine under the guidance of a veterinarian. Contrary to popular belief, rabies actually is more prevalent in winter than in summer.

N. A. A. C. P. APPEALS TO WAR SECRETARY TO STOP BREAK-UP OF 10TH CAVALRY

New York, October 2.—A last minute request to Secretary of War Patrick J. Hurley, who has just returned to the United States from a visit to the Philippines, has been sent by the N. A. A. C. P. to greet him in California, asking him to intervene and prevent the breakup and dispersal of the 10th Cavalry from its present station at Fort Huachuca, Arizona, pointing out the deep feeling this in-

justice to the colored regiments has aroused among colored citizens.

New York, October 2.—Shooting of a Negro, Will Jones and five of his children, three of them young girls, by a white farmer at Greenwood, S. C., is being investigated by the N. A. A. C. P., it was announced today. Reports which the N. A. A. C. P. is seeking to verify, state that when he was warned away from a spring, the white farmer went home got his shotgun and shot the members of the Negro family, some of whom were working in a field and some being in their home. The youngest is expected to die. The assailant, Broadus Hughes, is in jail on charges of assault with intent to kill.

New York, Oct. 8.—Atlanta University, pioneer institution of higher learning for Negroes, located in Atlanta, Georgia, has been given one million dollars for new buildings and their maintenance. Announcement of the gift from a friend of the University was made here today by Dean Sage, 49 Wall Street, president of the University's board of trustees. In order that construction work on the new buildings may serve to alleviate the present unemployment situation in Atlanta, the plans have been expedited by the architects, James Gamble Rogers, Inc., of New York City, and construction will begin soon. Mr. Sage stated. Five buildings are to be erected at an estimated cost of \$625,000, including an administration hall, women's dormitory, men's dormitory, a residence for the president and a central heating plant. Forty thousand dollars will be expended in renovating existing class-room buildings, and \$335,000 will be set aside as a building maintenance fund.

The man shot is Willie Peterson. He is not expected to recover. He is a World War veteran, suffering from tuberculosis, who has sought repeatedly to obtain admission to a government hospital. He stoutly denied any connection with the crime and stated that on the day it occurred he was too sick to leave his home. The girls originally abducted were Augusta and Nell Williams, sisters, and Jennie Wood, a friend. Augusta Williams and Jennie Wood died from the effects of the wounds they received. Nell Williams, though wounded, recovered. Peterson, was shot by Dent Williams, 25 a Birmingham lawyer, who is a brother of Nell Williams.

"These deaths result directly from germs carried by the fly from its unsanitary breeding places to man and his food," said Doctor Heidenburg. Foil Fiends by Training Dog to Eat From Own Dish

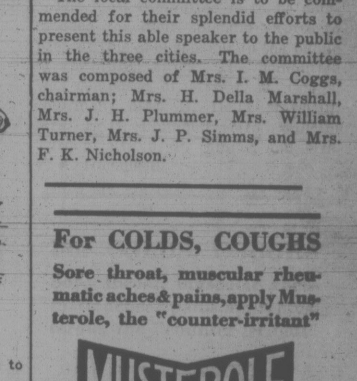
With reports of dog-haters at work in many localities, the Chapel Kennel Foundation, Rockford, Illinois, is stressing upon dog-owners the necessity of training their animals not to eat food at any other place than at their regularly appointed eating dish. There are still some animals having two legs, walking upright, classed technically as human beings, who purposely put out poisoned meat for dogs, cats and the like, the Foundation points out. All instances of this kind should be reported immediately to the proper authorities. Unfortunately, the laws do not provide severe enough penalties for these wretches. In the meantime, the wise course to follow and one that will save possible grief and heartache, is to train your dog to refuse food offered by strangers and to teach him to avoid eating at any time and place. There is no better way of teaching your dog not to accept food from strangers than to feed him a good, wholesome, well-balanced meal regularly at an appointed time each day, at the same place, and in the same utensil. A well-fed dog is more disposed to attend to his own affairs. Today, soon after he has eaten his regular meal, take your dog outside. Place some tempting morsel in front of him. Very likely he will lurch forward to seize it. Command, "No," fiercely. This may not stop him. Slap him lightly on the shoulders or hind-quarters, (never on the head, muzzle or loins), and again command, "No." Next, let a stranger offer the tempting morsel. Repeat the punishment. Then walk with him through an alley and let him run loose. Keep near him,

and the instant he moves to take a piece of refuse or garbage, command "No" and move toward him. It will not be long before the dog will understand what you are driving at, and your worries in this respect will be over for good. The day in which the dog was looked upon more or less as a garbage can has definitely passed. Nevertheless, the Foundation, a number of incidents reported recently indicate that there are still on the market dog foods which will not only sicken the animal but menace the health of the children of the household. As safeguard and protection to both dog and owner, therefore, the Foundation urges that no canned dog food be used that does not have the wording, "U. S. Inspected and Passed by the Department of Agriculture" on the label.
