Mayor Lewis Addresses Church Celebration

Entire City Mourns The Passing Of Dr. Medbury

Dr. Chas. S. Medbury, the dean of Des Moines ministers and beloved church leader of thousands, regardless of race, color, or creed, was placed in final rest at Glendale cemetery Wednesday afternoon. The city was shocked at the sudden passing of the revered University Church of Christ pastor, he died in his pulpit of heart attack on last Sunday morning as the congregation was singing the Invitational hymn.
Six thousand attended the funeral held at the University Church of Christ, while the entire city and state mourned the loss of a beloved leader. The colored citizens of Des Moines were prominent in their tribute to Dr. Medbury. Besides his wide range of varied activities with his fraternal and religious duties among his own people, he was always ready and willing to assist and cooperate with his colored brethren.
He was an active member of the Y. M. C. A., Interracial Commission, and local branch of the N. A. A. C. P. His last appearance before a colored audience was at the Corinthian Baptist Church, Sunday, April 9, where he preached the Anniversary Sermon for the Rev. G. W. Robinson.
The last rites were conducted by Rev. Paul Becker, assistant pastor, assisted by the Rev. E. G. Williams of the Westminster United Presbyterian Church, and Dr. R. H. Miller, pastor of the Independent Boulevard Church of Christ of Kansas City, Mo. Ministers and laymen from over the entire country came to Des Moines to pay their last respects to a great man.

RUTH NICHOLS, FAMOUS FLYER VISITS DES MOINES

NAACP Strikes at Greyhound Lines

New York, April 29.—One of the solicitors for the Greyhound Bus Lines walked into the office of the N. A. A. C. P. at 69 Fifth Avenue this week seeking business for his company and walked right out again—without any business.
The solicitor wanted the N. A. A. C. P. to charter Greyhound buses to send its New-York delegates to the 23rd Annual Conference in Washington next month. He was told flatly by Roy Wilkins, Assistant Secretary, that the N. A. A. C. P. could not use Greyhound buses and could not recommend them to colored people because the Greyhound Lines had established a reputation for segregating and insulting colored passengers.
In some cities where the Greyhound Lines operate, the seat reservation system is used and here Negroes are always sold the rear seats over the wheels. In other cities Negroes are forced into the rear seats by the bus drivers. On the road Negro passengers are nearly always refused food at the lunch stops of the buses. These conditions were outlined to the Greyhound salesman by Mr. Wilkins, as reasons why the N. A. A. C. P. did not care to charter Greyhound Buses.

Appeal Halts Scottsboro Executions May 13

NEW YORK, April 29.—In spite of all attempts to rush the legal murders of the nine Scottsboro boys, the Alabama supreme court was forced to grant a stay of execution from the set date, May 13, to June 24 to permit Scottsboro defense counsel to argue the appeal before the United States supreme court.
Mass protests pouring in from all over the country and from many foreign lands have frightened the lynch court into giving the stay of execution in spite of the powerful resistance of the most reactionary forces.

HAYES HONORED AT FISK UNIVERSITY

Nashville, Tenn., April 29.—Roland Hayes, famous tenor and one of the most distinguished of the Fisk university alumni, was recently awarded an honorary degree in music by the institution. Dr. Thomas Elsa Jones, president of Fisk, conferred the degree of doctor of music, the first the university has ever bestowed. The award was one of the features of the Fisk annual festival of music and fine arts.

Was Society Editor of Iowa Bystander for Three Years
Mrs. Virginia Stewart Dixon, 1310 Day Street, former society editor and columnist of the Iowa Bystander has accepted a position in the bookkeeping department of the Polk County Assessor's office. She began her new duties April 26. At the time of her resignation from the newspaper field she was also manager of the Emergency Finance Company, located at 203 Seventh Street.
Following her graduation from Keokuk, Iowa, High School in 1921 she came to Des Moines where she was employed in the law offices of Howard and Woodson and was for several years employed by Attorney John L. Thompson, now deceased, the former editor of the Iowa Bystander. For six years she was office manager of the Standard Loan and Realty Company, the only financial concern of Des Moines and the State.
Mrs. Dixon is a popular young society matron and is a member of the leading clubs of the city, among them being the N. A. A. C. P. and other civic organizations; also St. Simon's Episcopal Church.

2,000 ATHLETES PARTICIPATE IN DRAKE RELAYS

Nearly 1,000 athletes from 66 colleges and universities will make their bids for Olympic recognition when they gather here Friday for the opening of the Drake relays.
Additional high school athletes are expected to swell the number of competitors upwards of the 2,000 mark for the twenty-third running of the classic.
As usual, the Negro athletes will take an active part in the midwestern classic, the outstanding ones being Ralph Metcalfe, the sprint flash from Marquette University and John Brooks, weight man from Michigan. Eddie Tolan, dash star of Michigan, and Eddie Gordon, Jr., broad jump ace of Iowa, will be unable to participate this year due to their strenuous training for the coming Olympics in California this summer. The bulk of colored track men of the nation are competing at Penn relays at Philadelphia as it is closer to most of the southern and eastern schools.

Cleveland Host to A. M. E. Conference

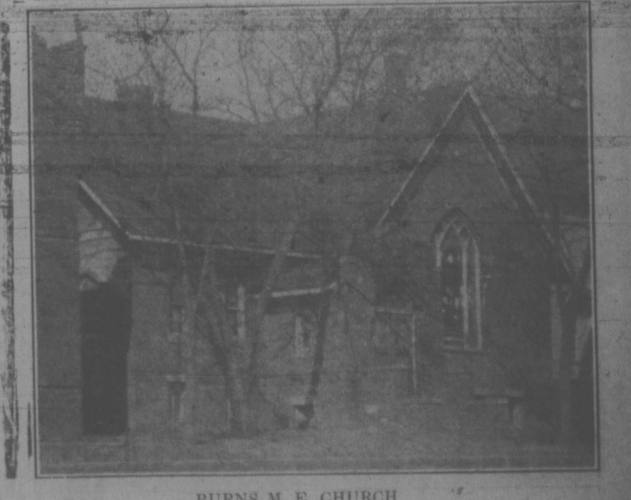
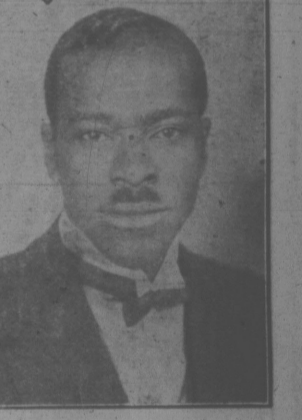
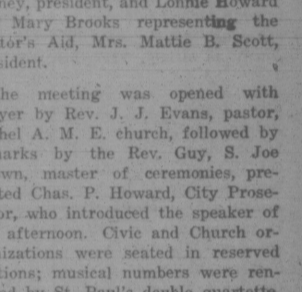
Cleveland, Ohio, April 29.—The 29th general conference of the African Methodist Episcopal church will convene here next Monday, May 2, when 800 delegates, composing the legislative body of that denomination, will assemble in the St. James A. M. E. church, 8401 Cedar Ave., of which Rev. D. Ormande Walker is pastor, and respond to the quadrennial roll call. For the first time in history of the church the elected delegates will equal in number the elected ministerial delegates from the annual conferences.
Thus the roster will disclose 360 lay delegates, 360 ministerial delegates and some 60 odd delegates ex officio, including 14 bishops, 16 general officers, 15 college presidents, 12 deans, two United States army chaplains and one Bible society representative.
This church legislative body represents a denomination of some 550,000 members, with upwards of 6,700 church organizations and 6,000 church edifices, valued at approximately \$33,000,000. As at present constituted the general connection is divided into 18 episcopal districts, each one presided over by a bishop.

Burns M.E. Church To Commemorate Founding In 1865

The membership has grown steadily for the last six years and the membership numbers around one hundred

Many years it was in the Des Moines Conference and later by an act of the General Conference it became a part of the Central Missouri Conference now the Central West Conference. It was incorporated some time after the dedication but the articles of incorporation on the 8th of August, 1900, the articles were signed by the following trustees, Dennis Barris, James Bush, John Strother, William Williams and Rev. C. W. Holmes. James Bush is the only one of this number with the church now.
The Rev. James Brett Kenna, D.D., of First Methodist Church, will preach the Anniversary sermon at three P. with their pastors have been asked to cooperate as far as possible.
The present building now owned by the congregation was purchased three years ago at a cost of \$8,000 and the total sum has been paid and the church now stands clear of all debt.

DR. CHAS. S. MEDBURY

In the death of Dr. Chas. S. Medbury, Des Moines has lost its most influential citizen. It is not often that this paper feels called upon to write an editorial on occasions of this kind, because some of the things it would say about people under occasions of this nature, even though that person might have been a good citizen otherwise, might be somewhat disgraceful with reference to his record on the Negro question.

The editor of the Bystander along with many other Negro men and women of Des Moines besides their association with him as a citizen, had many occasions in the Interracial Committee and N. A. A. C. P. meetings, to deal with many questions such as the bathing beach, theatre, restaurant and other semi-social relations between white and colored people. At no time did Dr. Medbury take any other view than that the Negro was entitled to all the privileges and he was in the forefront in the fight to secure and maintain them.

Unlike many prominent ministers, it was not his nature to be for or against a cause because some member of his church might be offended or pleased, but because it was popular. He was for a cause because it was right.

It is sometimes said that it is unpopular for a white person to champion the Negroes' cause and be popular. Dr. Medbury's life exploded that theory. The Negroes of this town have lost a friend, and the city and state too.

COOPERATION

Several of our churches have conducted anniversary exercises during the past few weeks. Some splendid meetings were held, each church had the cooperation of the other churches of the city. This was one of the most inspiring things that grew out of the gatherings.

But the situation goes back further. Those churches could not have cooperated had not their ministers approved the movement. They did. We have come a long way to be sure.

It is too often said that the Negroes are divided. Some people say it so much that many intelligent Negroes really believe it. There is nothing to it. We are just like the other folks, no more no less.

THE RELAYS

Friday and Saturday the Drake Relays occur in Des Moines. It is an annual classic which brings a large group of young men from colleges and high school to compete for supremacy in athletics.

Fortunately race or color make no difference in an affair of this kind. If an athlete can qualify he has a chance to take off the honors. This is generally true of college athletics in schools which do not draw the color line except

HEALTH TALKS "LEXS-O-GRAPHS"

TE HEART

It takes twenty-three seconds, not the half part of one minute, for the blood to make a complete circuit to the remotest part of the body and back to where it started from

and a much shorter time for it to get back to where it started from in certain regions of the body as all the blood does not go all over the body and return to a specified place as might be thought. It appears that the blood which nourishes the heart never makes a complete round of the body except perhaps under conditions of extreme exertion. From this it appears that the circulation rendered simple by its discovery still remains a something more complex than is thought. Under normal conditions the blood is circulated at a certain rate of speed slightly different for men and women. When the rate goes above or below this normal certain abnormal things occur in different parts of the body, depending on how far above or below the normal rate it goes. This rate has a definite significance or it would not be present in so many healthy persons.

The heart is very richly supplied with nerves and it is known that these nerves have a great influence on the beat of this organ. Consequently any damage or irritation to the nerves have an influence on the heart. When we take into consideration the many things that can be wrong with a heart and the fact that it is working constantly night and day it seems that so much attention cannot be given to its healthy condition.

Mrs. Minerva Caldwell-Hunter, of Moline, Ill., formerly of Des Moines, died Thursday, April 14, as a result of an auto accident three months ago. She was a prominent social worker and a member of St. Paul's A. M. E. church of Moline. She spent her girlhood in Des Moines and attend the public schools.

She is survived by two daughters, Bettie Marie and Gloria Jean, her mother, Mrs. Matilda Caldwell, Mrs. Mena Roland of Des Moines, Mrs. Etta Clark of Pocahontas, Idaho; Mrs. Mary Hatcher, Mrs. Emma Brooks, and Lillian Caldwell, of Chicago, Ill.; four brothers, Sydney and James Caldwell of Des Moines, and Fred and Alonzo Caldwell of Chicago.

Franklin A. Denison, 69, who passed away last Thursday. He was the first Negro soldier to rise above the rank of a colonel.

The war-time Colonel had a brilliant military record as former commander of the 8th Infantry, Illinois National Guard, and Colonel of the 370th Infantry, and was the first colored man to command a regiment of United States soldiers on field of

battle. He began his military career in 1898 and saw service as major in the Spanish-American war. General Denison was retired from the Illinois National Guard with the rank of Brigadier General in 1922.

GENERAL DENISON VISITED DES MOINES

After having been relieved of his command in France in the summer of 1918, because of physical disability, General Denison, then a Colonel, was invalided back to the U. S. and assigned to the U. S. General Hospital then located at Ft. Des Moines.

He arrived in Des Moines on Aug. 22nd and wandered downtown to the Army Y. M. C. A. meeting where an Emancipation Meeting was in progress in the old Union Congregational church on 10th and Park streets. Atty. S. Joe Brown, who was presiding recognized him by his shoulder bars, he being the only Negro in America wearing a silver eagle, the insignia of colonel in the U. S. Army, and invited him to the platform where he delivered what he said was his first public address since his return from the Western Front.

An impromptu reception was immediately arranged for him at St. Paul A. M. E. church, which had just been occupied; and while the balcony had not yet been seated, on the following Thursday evening, it was filled to overflowing, by Des Moines citizens of both races, many of whom sat upon the steps of the balcony in order to hear this second address delivered by this only Negro colonel who was in command of a regiment during the World War.

At the conclusion of the program a reception was held under the auspices of the Chas. Young Auxiliary of the American Red Cross, named for the only other Negro to hold the rank of Colonel in the U. S. Army; but who at that time was on leave for detached service in Liberia.

ASK 20-YEAR JAIL TERM FOR DEMANDING EQUALITY

Atlanta, Ga., April 22.—"We demand complete economic, political and social equality for Negroes," is one of the sentences in a booklet, for the distribution of which a grand jury in Fulton county is asking 20 years in prison for six working class organizers arrested here two years ago. The six organizers are two Negroes, Henry Story and Herbert Newton; two white men, Joe Carr and M. H. Powers, and two white women, Mary Dalton and Ann Burialk. They were arrested here in 1930. Powers and Carr were arrested for distributing a leaflet with a picture of a member of the colored race and a white boy clasping hands. The other four were seized at a meeting of Negro and white workers gathered to protest against lynching. All were charged with "distributing insurrectionary literature" and "attempting to incite insurrection." The latter charge carries the death penalty.

Courtroom, Geneva, Ala., Apr. 21.—The case of the State of Alabama vs. R. A. Grant, bishop in the A. M. E. church, on a charge of bastardy brought by young Ollie Glass of Hartford, Ala., went to trial here Wednesday and ended today (Thursday) after some 40 or more witnesses had taken the stand. The jury brought in a verdict after two or more hours, deliberation, of not guilty.

Two thousand men and women of mixed races and nationalities, representing the unemployed council and the communist party, marched to the Union Stockyards Tuesday afternoon and for a time it was feared the horde would storm the gates. Extreme caution had been taken by the authorities that no trouble would ensue. Besides a veritable army of policemen—on horseback, motorcycle, in automobiles and foot—militiamen are said to have been stationed inside the yards to act in any emergency. In the speeches, some of which were highly inflamed, demands were made for 10 pounds of meat a week for unemployed families, cessation of lynching, immediate relief and unemployment insurance, defense for the Scottsboro victims and that half-pay for four months be paid to female workers who are forced to stop work on account of motherhood. Throughout the long and weary march the workers, carrying a demonstration banner on their shoulders and high above their heads, kept up their victory song with the refrain, "When the Revolution Comes," ringing in the ears of the thousands of curious onlookers who flanked them on both sides of every street.
