Brookhart At the Billiken, May 11

Senator Smith W. Brookhart will deliver an address at the Billiken Hall, Twelfth and Center Streets, on Wednesday evening, May 11, at 8:15. Senator Brookhart will discuss several matters of particular interest to the Negro voters, among which will be his opposition to the confirmation to Judge Parker as a member of the United States Supreme Court and the Howard University appropriation bill. In both of these contests Senator Brookhart was aligned with the friends of the Negro and the N. A. A. C. P.

Other speakers will include former Gov. W. L. Harding and Attorney John Connolly, Jr., George H. Edmunds and Henri Hill. Musical numbers will be rendered.

Burns M.E. Church To Commemorate Founding In 1865

Burns Methodist Episcopal Church will observe its 67th Anniversary on the second Sunday in May.

C. W. Holmes. James Bush is the only one of this number with the church now.

Zions Hold Meet In Pittsburgh

PITTSBURGH, PA., May 6.—The twenty-ninth session of the General Conference of the African Methodist Episcopal Zion Church opened in Wesley Center Church, Dr. E. L. Madison, pastor, on Wednesday.

Five hundred delegates were enrolled in the conference, representing three continents, North America, South America and Africa. The membership of the denomination is 483,316. There are 11 living bishops. Dr. P. A. Wallace of Brooklyn, N. Y., is the bishop, host to the meeting. There are 24 general officers here.

Texas Voters Win Rights In U.S. Highest Court

Opinion Delivered by Justice Cardozo

WASHINGTON, D. C., May 6.—The United States supreme court decided Monday that the method used by the state of Texas in regulating party primaries so as to exclude qualified Negro voters was an infringement of the 14th amendment. The decision was close, 5 to 4.

Justices Cardozo, Brandeis, Stone, Roberts and Chief Justice Hughes declared the state legislation by which white election officials acting under powers delegated them by the state legislature prohibited our people from voting in the Democratic primaries to be unconstitutional.

The effect of the decision is to break down another bar against members of our race who have sought to vote in Democratic primaries in southern states. Qualified Negro voters in Texas must be permitted to vote in the state Democratic primary to be held Saturday as the result of Monday's decision. Failure to allow Negro Democrats to vote will make white election officials subject to damage suits for the infringement of Constitutional rights.

Communists Nominate Negro For Vice President

New York City, May 6.—James W. Ford, a Negro worker of Alabama, will be proposed as candidate for vice president of the United States, to the national nominating convention that is called by the Communist Party to meet in Chicago on May 28th and 29th. Ford will run with William Z. Foster, of New York, who will be nominated for the presidency if the state announced by the Communist Party last week is adopted at the Chicago convention.

N. A. A. C. P. WORKS TO END MURDER OF NEGRO TARINMEN IN MISSISSIPPI

New York, May 6.—Efforts are in progress by the N. A. A. C. P. to end this reign of terror in Mississippi in which Negro tarinmen have been murdered and many Negroes terrorized by whites seeking to displace colored people in jobs.

Walter White, N. A. A. C. P. Secretary, while in Washington, visited the Department of Justice and conferred with the Attorney General and other officials concerning government action against the terrorists. N. A. A. C. P. attorneys and those of the Department of Justice are seeking to discover a federal statute applicable to

Delegates and visitors are here from all parts of the country, West and South Africa, West Indies and Canada, to take part in the deliberations of the conference.

Hundreds of persons arrived Saturday and Sunday. Every Methodist church and mission was jammed with worshippers for Sunday services. St. James African Methodist church, 8401 Cedar St., is the organization entertaining the conference. Rev. Ormande Walker, pastor of the church, is official host to the meeting.

NEW YORK, May 6.—Miss Nancy Cunard (white) of London, England, daughter of Lady Cunard and heiress to the Cunard steamship fortune, has taken residence at the Gramphon hotel, 182 St. Nicholas Ave., in Harlem for the purpose of knowing more about our people and to collect funds to save the seven boys in the Scottsboro, Ala., case.

Miss Cunard arrived at the hotel from Boston, where she had spent the week-end. She was greeted by batteries of photographers and newspaper reporters who had come there to follow up the story of her many friends, written by James Whittaker in the Daily Mirror, downtown tabloid, and especially stressing her alleged friendship with Paul Robeson, noted singer-actor, who is now rehearsing for the revival of Ziegfeld's "Show Boat," to open May 16, at the Casino theater.

Interviewed at the Columbia Broadcasting company's studios, where he sang over the air in company with Helen Morgan and other stars of "Show Boat," Robeson disclaimed any more than the slightest acquaintance with Miss Cunard, and for the most part paid the rumors the slighting attention of neglect. He in no manner seemed disquieted and took the whole affair of the publicity on a man in public life who had been the object of just another silly story.

Metcalfe Ties World Century Mark; Brooks of Chicago Leaps To Victory

The 23rd Annual Drake Relays passed into history Saturday evening, with two world's records equalled, an American record broken and eight meet marks swept into oblivion, as two thousand Olympic inspired athletes from 66 schools of 14 states competed in the midwestern classic. Ten thousand fans attended the two-day track carnival at the Drake Stadium, Friday and Saturday. The Negro athletes exceeded all expectations in their stellar performances in the major events.

The brilliant feats of the individual stars, Saling, of Iowa, who equalled the world's record for the 120-yard high hurdles in 14.4, and anchored the Michigan in 1924, of 24 feet, 2 1/2 inches. The youngster leaped 24 feet, 8 1/2 inches, placing his name with the great Edward Gordon, Olympic star of Iowa, who won the same event three years in succession.

Kansas Teachers Break Record The Kansas State Teachers of Pittsburg, a formidable entry in all Drake relays had won nine college relay championships previous to this year's competition.

Madison, Kirby and Swisher, colored luminaries, assisted their teammates in annexing first and two second places in the half-mile, one-mile, and sprint medley relays, respectively.

The old record made by Butler in 1925 of 1:27.8 went flying when the crack quartet stepped the half mile event in 1:27.6. Delbert White, of the same school, heaved the discus 148.70 feet to capture first honors in the weight division. Williams, Beatty, and Spencer Shatter Penn Marks

PHILADELPHIA, May 5.—Negro schoolboy and college athletes flashed with brilliance in the 38th annual Penn Relay Carnival on Franklin Field here on Friday and Saturday.

Eugene Beatty, defending champion, former national schoolboy champ, now a student at Michigan Normal at Kalamazoo, breezed along to a time of 53.3 seconds in the 400-meters hurdlers, leading Burke, of Georgetown, by six yards. And that 53.3 set a new relay mark and was the first record to fall.

Howard Spencer, of Geneva, went over the high jump bar at 6 feet, four inches, a height which turned back the Columbia star, O'Connor, of Penn. The stick was then placed at 5 feet, 5 1/2 inches and the lanky Spencer cleared it on the third essay to equal the standard which had stood since 1917. He failed at 6 feet, 6 inches. Preston, of Lincoln, was tied for third place, with Cavenu, of Princeton, and Klein, of Penn.

George Williams from Hampton institute, winner of the javelin last year, repeated his triumph with a remarkable toss of 205 feet and two and three-eighths inches. Williams has been the best in this event for the past two years and had he been pressed might have set a new mark. He won the event leisurely.

Charles Jones, known as "Indian" Jones, also set a record in the shot-put when he hurled the 16-pound ball for an even 50 feet. Dues of Detroit, another Race lad, was second in this event.

LeRoy Dues of the City College of Detroit finished second in the shot-put with a toss of 47 feet, 10 1/2 inches. Dues recently beat both Wayne Munn and Booker Brooks in an unofficial meet.

ANOTHER VICTORY

During the past the southern states have passed laws barring Negroes from voting. The United States Supreme Court has declared them unconstitutional. Not to be outdone the Democratic State Central Committee of Texas passed a resolution denying Negroes the right to vote in the Democratic primaries.

Negroes were refused the ballot in Texas because of this rule and one Negro Democrat appealed to the Courts for relief. With the aid of the N. A. A. C. P. the case was appealed to the United States Supreme Court. Monday, the court handed down an opinion thru Justice Cardozo holding that the committee was exercising powers delegated by the State and as such had no power to make rules in conflict with the fundamental law of the land.

Almost coincidentally with the ruling the United States Senate had before it a contest from Alabama in which former Senator Heflin attempted to oust Senator Bankhead, the successful candidate in the 1930 election. Heflin based his case upon the theory that the Democratic Committee of that state had passed a resolution excluding anyone from becoming a candidate who voted for Al Smith in 1928, and that the resolution was illegal. This rule kept Heflin out of the Democratic primaries.

Senator Bankhead was seated. However, without championing Heflin's cause in the least the same rule should apply. It is dangerous delegation of power which allows a committee authority to exclude races and individuals from participation in the affairs of government as was done in Alabama.

Senator Norris of Nebraska, in a speech before the Senate, on the subject, contended that the resolution was unconstitutional, said:

"But when we say to a committee in a free Republic, an unauthorized committee—I mean a committee holding no office, holding no authority from the people—when we confer upon that kind of a committee the right to say who can be candidates and who can not, we are upon the verge of the destruction of our democratic form of government."

When any State undertakes to delegate the powers of government to an unofficial committee, moved by party considerations, controlled by all the influences that we know control parties, we ought to hesitate; we ought to stop, to look, and to listen, and see if there is not danger just ahead of us. We ought to see if this kind of government, perpetuated and continued, will not ultimately mean just what Washington said would happen, unless we took heed."

Evidently the Court, even with a 5 to 4 decision, agreed with Senator Norris' theory. Thanks to the N. A. A. C. P. again for its brilliant fight.

CANCER

Once Cancer has developed its growth is so fast sometimes nothing can be done to stop its progress. In the beginning it may bear a similarity to other tumors which do no particular harm for a long time and the person possessing growth may believe that the tumor is not of cancerous nature. This is true many times of tumors or lumps in the breast. It should be known also that tumors which are not cancerous sometimes become so after a long time.

This happens not rarely in tumors in the stomach. Tumors of the skin, especially of the lip can always be counted on to prove cancerous, with few exceptions, and these need attention just as early as any cancer anywhere. When once it has begun to spread from the confines of its birth its spread might be compared to a forest fire spreading from a spark. Perhaps not literally so quickly but very, very rapidly; as fast as any tissue growth is concerned.

After the age of forty everyone must bear the possibility of cancer in mind. Such a statement should not create a fear of the condition but an alertness which would make possible a cure when there is yet time. Examinations after this age are important for both men and women and if observed the death rate from this disease would be very much lower than it now is.

Ruth Nichols, widely known woman flyer, representing the National Council of America, flew to Des Moines last week to pick up Iowa's share of petitions, filed by local club women as a part of the plans for the World's Congress to be held in Chicago in 1933.

A banquet was tendered her at the Fort Des Moines Hotel at which our local club women were represented by Mrs. S. Joe Brown and Mrs. J. W. Tutt.

WASHINGTON, D. C., April 28.—President Hoover last Friday signed the Interior Department supply bill, carrying total appropriations of \$675,000 for Howard University and \$293,480 for Freedmen's Hospital.

The bill as approved gives Howard University \$335,000 less than the Budget Bureau estimates asked for. The House reduced the estimates to \$1,075,000. The Senate after putting back into the bill the full amount of the estimates recommitted the meas-

ure to the appropriations committee where the increases were stricken out together with two construction items totaling \$400,000.

The Items for Howard University provide \$450,000 for salaries and \$225,000 for general expenses. Freedmen's Hospital is given \$198,980 for salaries and \$94,500 for general expenses.

New York, April 29.—One of the solicitors for the Greyhound Bus Lines walked into the office of the N. A. A. C. P. at 69 Fifth Avenue this week seeking business for his company and walked right out again—without any business.

The solicitor wanted the N. A. A. C. P. to charter Greyhound buses to the 23rd Annual Conference in Washington next month. He was told flatly by Roy Wilkins, Assistant Secretary, that the N. A. A. C. P. could not use Greyhound buses and could not recommend them to colored people because the Greyhound Lines had established a reputation for segregating and insulting colored passengers.

In some cities where the Greyhound Lines operate, the seat reservation system is used and here Negroes are always sold the rear seats over the wheels. In other cities Negroes are forced into the rear seats by the bus drivers. On the road Negro passengers are nearly always refused food at the lunch stops of the buses. These conditions were outlined to the Greyhound salesman by Mr. Wilkins, as reasons why the N. A. A. C. P. did not care to charter Greyhound Buses.

She began her new duties April 26. At the time of her resignation from the newspaper field she was also manager of the Emergency Finance Company, located at 207 Seventh Street.

Following her graduation from Keokuk, Iowa, High School in 1921 she came to Des Moines where she was employed in the law offices of Howland and Woodson and was for several years employed by Attorney John L. Thompson, now deceased, the former editor of the Iowa Bystander. For six years she was office manager of the Standard Loan and Realty Company, the only financial concern of Des Moines and the State.

Mrs. Dixon is a popular young society matron and is a member of the leading clubs of the city, among them being the N. A. A. C. P. and other civic organizations; also St. Simon's Episcopal Church.

The Rev. B. H. Hunter, noted evangelist, formerly of Chicago, now of Davenport, will assist Rev. J. W. Tutt, in a series of meetings beginning Monday evening. Dr. Hunter is a graduate of the Theological Seminary of Chicago, Moody Bible Institute, and Garret Biblical Institute of Evanston, Ill.

The subjects to be used by Dr. Hunter are as follows: "The Lost Man"; "Death at the Ball"; "Knowing God"; "Jazz or Jesus, Which?" "Dry Bones"; "Your Bed is Too Short and Your Cover is too Narrow"; "A Great Day and a Great Question"; "After the Ball".

NASHVILLE, Tenn., April 29.—The Fisk Jubilee Singers, who have become famous throughout the world, will no longer exist as a paid unit of Fisk University after this year unless a radio contract for their services or some other financial guarantee is effected. This action was voted upon at a meeting of the Board of Trustees of the university held here last Saturday.

The action was necessary because of the large cost of maintaining the unit and the need for a general reduction of expenditures by the university.

NEW YORK, April 29.—In spite of all attempts to rush the legal murders of the nine Scottsboro boys, the Alabama supreme court was forced to set date, May 13, to June 24 to permit Scottsboro defense counsel to argue the appeal before the United States supreme court.

Mass protests pouring in from all over the country and from many foreign lands have frightened the lynch court into giving the stay of execution.

JOINT DELEGATION TO WASHINGTON TO PROTEST BOULDER DAM JIM CROW

N. A. A. C. P. and Bar Group to Submit Result of Investigation by Pickens

NEW YORK, May 6.—Vigorous protest against the exclusion of Negroes from employment at the Boulder Dam work in Arizona, will be made on Wednesday, May 4, in Washington to Interior Secretary, Ray Lyman Wilbur who has consented to receive a joint delegation of the National Bar Association and the N. A. A. C. P.

The Boulder Dam project which is a government job employs no Negroes whatever among the thousands of workers engaged upon it in various capacities and evidence has been gathered of the rigorous color discrimination which prevails.

ATHLETES winning 480-yard shuttle hurdles relay team, and Brooksmith, of Indiana, who broke the 20-year-old American record for the two-mile run, in 9:13.6 and anchored the winning four-mile relay team, was surpassed by Ralph Metcalfe, the sensational speed demon from Marquette, who established himself as one of the greatest sprinters of all time by his spectacular dash down the 100-yard straightaway in 109.5 to equal the world's record made by Tolan of Michigan, in 1929.
