Havana, Cuba.—Nancy Cunard, British woman of noble birth, and Ansell Colebrook, American army officer, arrived Saturday on the S. S. Orizaba, from New York for a two weeks' vacation. Both declined a welcome prepared for them by members of the leading social set in Havana.

"We hoped to reach a country where we will be less bothered than in the United States, which we left with a deplorable impression," said Lady Cunard. "We only hope to become acquainted with the more highly educated people here who are not imbued with racial prejudice as is the case in America."

Wife Vows Loyalty to Nancy's Escort

Weymouth, Mass., July 15.—With an amazing display of love, loyalty and confidence, Mrs. Gertrude Colebrooke (white) faced newspaper men who gathered at her home Thursday to inform her that her husband, Ansell A. Colebrooke, former lieutenant in the 372d Infantry, Massachusetts national guard, has sailed from New York with Miss Nancy Cunard, white heiress, for Havana. Mrs. Colebrooke declared: "If it is true my husband left for Havana with another woman it is for nothing more than business."

"I love him more today than I did years ago when we were married. He is also in love with me and our six children. Whatever is behind all this I am sure he will explain it satisfactorily."

NEGRO DEMOCRATIC FACTIONS MAKE BID FOR CONTROL OF CAMPAIGN SET-UP

Chicago, Ill. (CNS)—The question as to what group will handle the Negro end of the campaign for the Democratic Party remained undecided this week, as Jim Farley, new chairman of the Democratic National Committee, busied himself with the general set-up of campaign leaders following the Roosevelt-Garner nomination a few days ago. That there will be a Negro division similar to the one headed by Julian Rainey of Boston, Massachusetts, in 1928 seemed a certainty, however.

Montgomery Not To Be Appointed

HOOVER WITHDRAWS FROM SENATE NAME OF LILLY WHITE APPOINTEE

Washington (CNS)—President Hoover last week withdrew the name of B. B. Montgomery as his appointee to be United States Marshal for the Northern District of Mississippi from the consideration of the Senate. The move came unexpectedly after Montgomery had been approved by the Judiciary Committee of the Senate and Chairman Norris of that committee had announced last week that he was in favor of the appointment. Montgomery had been recommended by Lamont Rowlands, Lily-white patronage dispenser of the Administration since 1928.

He was opposed by Mrs. Mary C. Booze, National Republican Committee woman for the State of Mississippi, who charged him with being a Lily-white and having insulted Negro womanhood in public statements; and Perry W. Howard, National Committee man. Additional protest to his appointment was made by the N. A. A. C. P. and other civic groups.

The fight led by Mr. Howard and Mrs. Booze, resulted in the holding up for several executive sessions of the Senate, many of the Senators fearing that another "Parker case" would be precipitated.

The significance of the withdrawal by the President of Montgomery's name is great, political observers declare. They point first, that it indicates the final decision of the President to recognize the right of the twice duly elected State Republican organization, headed by Mr. Howard and Mrs. Booze, to control patronage in Mississippi in place of Rowlands; and second, that it shows the President wary of offending Negro voters on the eve of the campaign.

Convention Expenses "Haywire" WHO SHALL FOOT THE N. A. A. C. P. BILLS?

New York City (CNS)—The National Office of the N. A. A. C. P. and the District of Columbia Branch in Washington have locked horns over an indebtedness of some \$3,000 incurred in meeting the expenses of the 1932 Annual Conference held in Washington in May. The two bodies are engaged in a spirited controversy as to who shall foot the bills or out of what fund the necessary money shall be taken to meet a deficit of several hundred dollars.

It is stated that the District of Columbia branch guaranteed to the National Office \$1,500, minus such sums as the other branches would contribute to the conference fund. Despite the fact, however, that the Washington Branch has raised and sent to New York more than \$2,300 and other branches have sent in for conference expenses more than \$400 the National Office claims that the branch in Washington is obligated to pay a deficit of several hundred dollars.

The expenses of the Annual Conference amounted to some \$3,000 and the Washington Branch has suggested and made a positive request that any balance due on the guarantee be met by taking the money from the membership fund raised in the District of Columbia this year.

This request is denied and strongly opposed by the National Office on the ground that it is contrary to the rules and regulations of the Association.

Communist Ideas Gain Momentum

COMMUNIST CANDIDATES SPEAKING DAILY

New York—The Communist Party candidates for President and Vice President, Wm. Z. Foster and James W. Ford, are speaking daily and sometimes twice a day to thousands of people throughout the country, according to the National Campaign Committee. C. A. Hathaway, Campaign Manager, said today that "the audiences reached by our national standard bearers are from three to five times as large as during the campaign of 1928, and this is only the beginning of our fight. We shall poll one million votes this coming November, and will elect many candidates to office."

NEGRO LABOR ORATOR TO TOUR FOR FOSTER AND FORD

New York—Charles C. Alexander, popular Negro orator, who made the second speech for the nomination of Wm. Z. Foster at Chicago, will leave the end of this month for a country-wide tour in behalf of the Communist National ticket. Mr. Alexander was formerly head of the Negro Department of the International Labor Defense, and had toured the states of New Jersey and New York with Mrs. Montgomery, mother of Olin, one of the Scottsboro victims.

Southern Court Reverses Opinion

ARKANSAS SUPREME COURT CHANGES DEATH SENTENCE TO 21 YEARS

Little Rock, Ark., July 15.—The death sentences given Louis and Elbert Blake, father and son, of Camden, Ark., for the fatal shooting last Christmas day of Brad Polk, white plantation owner, were reduced by the Arkansas supreme court July 2, to 21 years in prison. The court found that the evidence used to convict the men was not sufficient to call for the death penalty.

Foreigners Favor Scottsboro Boys

THE SCOTTSBORO TOUR IN EUROPE IS GREATLY EXTENDED

New York, (ILL)—The tour of Mrs. Ada Wright and J. Louis Engdahl, who are arousing Europe with the Scottsboro message, may be greatly extended, it was announced today at the National Office of the International Labor Defense. Mrs. Wright, who is now in England, will proceed directly to the Scandinavian countries, Norway, Sweden, and Denmark. She will be joined there by Engdahl, who addressed huge gatherings in Berlin on July 3rd, at which the Scottsboro question and the demonstration against fascism made a joint issue for the crowds in both Lustgarten and Karlshof. In the Lustgarten, according to the New York Times of July 5, there were 150,000 persons assembled.

After the Scandinavian tour, the International Labor Defense states, the tour as now planned will include revisiting Geneva, where both Engdahl and Mrs. Wright both spoke a few weeks ago, in order that they may attend the World Congress against War to be held there early in August. From Geneva, the two Scottsboro champions will proceed to Spain, and the southern provinces of France, then go to the Balkan countries, Bulgaria and Greece.

"VOGUE" DID NOT INTEND TO OFFEND NEGROES BY USE OF WORD "COON"

New York, July 15.—Vogue magazine, one of the Conde Nast publications, did not intend to offend colored people by the use of the word "coon" in the issue which appeared June 15, according to Edna Woolman Chase, editor, Miss Chase, writing in answer to a letter from Walter White, secretary of the N. A. A. C. P., is evidently sincere, but gives a novel reason: "We used the word 'coon' as we would have used 'crooner' or 'tap dancer' or any other term for professional entertainment. It has come to signify to us a special kind of music more than an individual musician."

Gov't Still Dodges Boulder Job Issue

New York, July 15.—Although Secretary Ray Lyman Wilbur, of the Interior department, personally assured a joint committee from the N. A. A. C. P. and the National Bar Association that Negroes would be employed on the huge Hoover dam at Las Vegas, Nev., in June, the government and the contractors are still pussyfooting and no Negroes have been hired.

The daily payroll at the dam has averaged \$10,000 through the winter and has run as high as \$18,000. The government contract with the construction companies that U. S. citizens are employed, but so far only white citizens have drawn any of the huge payroll. About sixty foreigners are working at the dam.

Secretary Wilbur and the Six Companies, Inc., builders of the dam, are resting on the technicality that Negroes will be employed "when additional men are hired", in other words, when the present force at the dam is increased. However, a colored resident of Las Vegas reports to the N. A. A. C. P. that the turnover in the present force runs as high as 80 a day. The N. A. A. C. P. and the National Bar Association do not see why Negroes cannot be hired at once inasmuch as from sixty to eighty new men are taken on each day, replacing those who are dropped or who quit.

NO COLOR BAR ON NEW YORK MUNICIPAL SUBWAY JOBS, BUT—

New York, July 15.—The City of New York will not make any distinction as to race, creed or color in selecting men to run the new city-owned subway line, but just the same, Negroes will have a hard time getting jobs, because the city is insisting that previous experience in subway railways is necessary. It is not the city's fault that Negroes have no training in running subways since all subways except the new one are operated by private companies which have employed Negroes only as station porters.

UNDEFEATED BALL TEAM LOSES TO LAST PLACE NINE

Burns Springs Surprise by Downing Union, 4-3

Union has previously defeated Burns in their other three engagements and considered this game in the bag before it was played. Every man was in a strange position and this undoubtedly accounted for the many errors they made and subsequently the loss of the game.

Then, too, the winners presented a new hurler by the name of Toney, who was very effective during his stay on the mound, allowing three clean hits, and fanning seven. Lee Kemp also did a nice job of relief pitching in the last two innings, striking out five of the six men who faced him.

Melvin Carr surprised everyone by connecting for a double which he stretched into a triple. Jimmy Bright, Cason and Slim Davis did good work for Burns.

CLEVELAND SEE BLEDSOE STAR IN "AIDA"

Cleveland, Ohio, July 15.—Cleveland's second session of summer opera came to a close Sunday night at the Cleveland stadium with a magnificent performance of Verdi's "Aida," and for the first time in opera history in America the role of the captive Ethiopian king, Amonasro, was taken by a member of our group, Jules Bledsoe, hailed by Cleveland critics as the foremost colored baritone in the country.

Bledsoe gave a magnificent portrayal of the captive Ethiopian king. From the time he stepped from the center of the group of captives brought back by the triumphant Rhadames, this great singer held the vast audience of over 10,000 people in his grasp. This is the verdict of all the musical critics in and out of Cleveland who attended the colorful performance.

Even though Bledsoe is known to have sung the role of Amonasro in London several times, it had never been offered to him before in America, it is stated.

D.M. Man Insurance Dept. Head In Cleveland

Lawrence J. Chapman, formerly of Des Moines, who went to Cleveland recently, is in charge of the insurance department of the R. F. W. Realty Company of that city, according to word received here this week. Mr. Chapman is a well known musician throughout Iowa, and is noted for his waltz composition "In my Garden of Roses". He has established a music studio there also as teacher of the clarinet, harmony and piano.

CROSSSWAITH IN RACE AS LIEUT. GOVERNOR OF N. Y.

New York, July 15.—Whatever the final results may be in the state election this fall, Harlem and the Race will have contributed one contestant for an office of state-wide importance, that candidate being Frank R. Crossswaith of 95 W. 119th St., who has been nominated for lieutenant governor by the Socialist party.

Financier Accused of Embezzlement

Chicago, July 15.—Trial of Jesse Binga, former bank president, which opened before a jury in Judge John Prystalski's criminal court Monday may be in the hands of the jury the latter part of the week, it was intimated Wednesday morning. Binga is accused of having embezzled \$39,000 entrusted to his care.

More than two dozen witnesses testified against the banker during the first day of the actual trial. They charged that they subscribed to stock in a national bank which Binga claimed he was organizing in 1929, and the state charges the banker kept the money given him to buy the bank stock.

The Binga bank closed June 30, 1930, with deposits estimated at a million dollars. The closing of the Binga bank caused runs on other neighborhood banks and in rapid succession they closed until now only one remains. The Douglass National bank, the longest survivor, ceased doing business May 20.

Mr. Binga held extensive real estate interests and vied with Anthony Overton, whose bank failed and whose insurance company recently went into the hands of a receiver, for leadership in finance among members of the race. Overton was chairman of the Board of the Douglass National bank and president of Victory Life Insurance Company.

HOWARD LAW DEAN JOINS LEGAL STAFF OF N. A. A. C. P.

New York, July 15.—Charles H. Houston, Dean of the Law School at Howard University, has accepted the invitation of the N. A. A. C. P. to become a member of its National Legal Committee, Arthur B. Spingarn, chairman of the committee, announces. Dean Houston is the fourth distinguished young Negro lawyer to join the national legal staff in the last month. The others are: N. J. Fredrick, of Columbia, S. C., Louis L. Redding of Wilmington, Del., and Jesse Hespil of Toledo, O.

INCONSISTENT

Many inquiries have come to The Bystander about Camp Dodge pool—who owns it and who gets the proceeds, if any, from its operations.

Unfortunately a mass of red tape hides its legal status from the public gaze but the following is substantially the situation:

The pool is owned by the State of Iowa and is loaned to the Des Moines Playground Association for use in connection with its recreational activities. Whenever returns are had as the result of its operations are used to further the playground activities carried on by the association.

In spite of any statements to the contrary Negroes are excluded from the pool. This exclusion is a violation of the laws of the State. With a knowledge of this illegal exclusion by the playground association the State of Iowa is a party to the violation of its own laws.

Put the question this way: Suppose the Playground Association was operating a bootlegging business at the pool. Would the State of Iowa tolerate it a minute? Heck, NO. All the State agents, sheriffs and police booze squads would be put on the job, the lease of the playground association would be cancelled and an injunction would be secured immediately restraining them from operating as bootleggers.

But when it comes to human rights nothing is said or done by the State. Can you explain this? It is a continuous violation of the State laws.

NOT AGAIN

Recently President Hoover named B. B. Montgomery to be U. S. Marshal for the northern district of Mississippi. He was recommended by Lamont Rowlands, leader of the "hly-white" faction in Mississippi but is bitterly opposed by National committeeman and woman Perry Howard and Mrs. Mary Boozie, both Negroes of that state.

As soon as the nomination was sent to the senate, Mr. Hoover was notified by them that the appointment would be opposed. Pledges were secured from Senators to vote against Montgomery. Later the N. A. A. C. P. entered the battle and for a while another Judge Parker fight

HEALTH TALKS

By Dr. R. H. London

SUNSTROKE

All effects from excessive heat may be noticed with or without any derangement in the functions of bodily organs but take place more easily when some system or organ is at fault. Sunstroke or heat exhaustion may indeed occur very suddenly on very hot days when the one so affected has been in the direct sunshine for too long a time. Persons who go to the tropics are very liable to become sick with one of these forms of heat diseases and on the other hand those who live in the tropics permanently never become so acclimated that they are immune and fall victims if some care is not taken to avoid undue exposure to the sun's rays. Heat of an intensity exceeding that of the body by a certain degree is the factor in the production of this condition as it occurs in the engine rooms of steamships, for example, and in any place where there is surrounding intense heat in hot weather. The tennis court is a place where this condition might occur. A form called Heat Cramps occurs in workers in summer, there being severe pains in the legs and arms after exertion.

The first indication of a common form is headache which was the chief symptom in the son of the Shunnamite woman in II Kings, IV, mentioned by Dr. William Osler. Many cases indeed do occur in the harvest fields. If headache is kept in mind as a beginning in this condition during the summer months many cases of this severe illness will be prevented. Children unable to express themselves should be placed where the heat is least intense. Fainting in hot weather is very many times so caused and those who for any reason must be careful of a certain system, for example, the circulatory system—would be the first affected if the heat was of a certain intensity. Once affected in any way by heat the nervous system is less resistant to it whenever the temperature becomes extreme and those once affected will show nervousness or headache or excitement or some symptom when the temperature begins to rise. Permanent damage to organs sometimes occurs following an attack.

12 SENATORS ACKNOWLEDGE N.A.A.C.P. PROTEST AGAINST MONTGOMERY APPOINTMENT

New York, July 8.—Twelve United States senators to date have acknowledged the protest sent by the N. A. A. C. P. against the nomination to U. S. Marshall of B. B. Montgomery of Clarksdale, Mississippi, who had declared he did not believe any Negro woman in his state to be chaste.

A number of the senators have given assurance that they will oppose this nomination, among them being Senators Buckley of Ohio, Shortridge of California, Vanderberg of Michigan and other senators give assurance that the N.A.A.C.P. protest will have their careful consideration.

ORIGINAL INDICTMENTS IN NATIONAL BENEFIT FRAUD CASE NOLLE PROSSED

Washington (CNS)—The indictment against John A. Risher, former president of the National Benefit Life Insurance Company, Daniel Gary, his real estate partner, and Mortimer F. Smith, former comptroller of the insurance company, charging conspiracy to defraud the National Benefit Life Insurance Company of \$450,000, to which the defendants demurred on June 13, were nolle prossed here Friday.

New York City (CNS)—Benjamin Q. Davis, Junior, son of Sol. Benjamin Davis, ranking Negro officer in the United States army was admitted to West Point Friday, July 1.

The young cadet was named as a candidate to the military academy by Representative Oscar DePriest, Republican of Illinois. At that time Davis was studying at Northwestern University, where he had been attending school for the past two years, following his graduation from a Cleveland high school.

Davis is the second colored youth to enter West Point in thirty years. The other, Alonzo Parham who was admitted in June, 1929, failed in mathematics at the end of the Spring midterm in 1930.

The last colored officer to be graduated from West Point was Colonel Charles Young, Colonel Davis, who is now in France, conducting the 1932 contingent of Gold Star mothers, rose to his present position from the ranks, and did not attend West Point.

CANDIDATE FOR LIEUTENANT-GOVERNOR IS JAILED

New York (CNA)—Six days after his nomination for the office of Lieutenant-Governor of New York, the city authorities ordered Henry Shepard, Negro, marine worker and Communist candidate, into a prison cell. The arrest of Shepard was part of a wave of arrests that swept Harlem during the past ten days.

Shepard was one of a group of six who went to the Harlem relief station at 271 West 127th street to demand immediate aid for Mrs. J. Holmes, wife of an unemployed Negro worker and mother of five children, who had been evicted from her home in 142nd street.

Mrs. Holmes had made several trips to this relief station, only to be told to "come back some other time." Finally, her rent unpaid and her furniture out on the street by order of the landlord, Mrs. Holmes appealed to the Harlem Unemployment group for aid.

TRAINING GOOD ANIMALS NOT ENOUGH

MOST parents seriously attempt to be good animals. That is to say, from the standpoint of the physical care of our children we do pretty well in most particulars. Not many children starve; most are at least occasionally bathed and many still "cutor oiled." Mothers do provide reasonably suitable clothes and seek with a positive irritation for those irritating neckties and the finger rings "in mourning."

Most youngsters are fairly well schooled as such schooling goes. They can read and scribble and spell (sometimes). They can sing and dance and find amusement, but when it comes to that much more significant wise training and direction of the emotional self, it almost makes one shudder to realize the unfortunate effects average parents with the best of intentions have upon the emotional unfoldment of their children, because they know no better!

Mothers who are scrupulously careful about proper food, sufficient milk and vegetables, who would be horrified to find their precious child in soiled "undies," are often essentially responsible for a type of emotional environment in the home in those early days of youth, which, in spite of excellent physical care, gives society neurotic, irritable, nervous, inadequate youths whose chances at normal adjustment out in a big busy, selfish, thoughtless society, are pretty slim.

Physical care is basic and absolutely necessary. We would not substitute something else for it. Wise and proper feeding and sane

and sensible clothing are essential to physical health and well being and custom and common sense provide for them fairly well. Good schooling, plenty of books and wise and proper play are all essential and there is room for much improvement in all these lines; but all of these combined do not take the place of or substitute for a rational emotional training, which is the very greatest need of youth, and of us all today; a fact which is more and more evident as the whole problem of personality adjustment is better understood.

On every hand, many astounding things are being said concerning the obvious short-comings of parents and teachers and workers with youth, and there is as yet such a complete lack of understanding among even the most intelligent folk in regard to the emotional development of young boys, coupled frequently with the idea that we already know it all and are doing a good and satisfactory job, but all of these combined do not take the place of or substitute for a rational emotional training, which is the very greatest need of youth, and of us all today; a fact which is more and more evident as the whole problem of personality adjustment is better understood.

Developing good animals is not enough.

"The moth is the most destructive of the seven," Doctor Hedeburg declared. "The damage it does to woolsens and other fabrics is dreaded by every housewife. The cockroach is most repulsive—it scatters germs wherever it crawls, and spoils food with which it comes in contact.

"Dangers from infection may result from the bedbug's bite, as it is also a germ conveyor. The flea transfers germs from rodents and vermin to the human body. The ant—especially the red ant—is a robber and despoiler of foodstuffs.

"Safety from the menace of these insects can only be attained by immediate, thorough extermination at the first sign of their presence. It was declared. Doctor Hedeburg declared that a good spray is the most effective and efficient destroyer of insects, because the method exterminates wholesale and quickly."

HOUSE FLY IS MAN'S MOST DEADLY ENEMY

The germ-carrying fly has been responsible for more human deaths than all the wars and wild beasts combined. 75,000 deaths annually traced to fly

30 DISEASES ARE SPREAD BY FLIES

Germ of Tuberculosis, Diphtheria and Smallpox Are Transported by Insects.

The common house fly is the most dangerous enemy to mankind, causing more than 75,000 deaths annually, according to Dr. O. F. Hedeburg, director of the Six Research Foundation, Chicago, who is engaged in a nationwide warfare of "public enemy" insects.

"These deaths result directly from germs carried by the fly from its unsanitary breeding places to man and his food," said Doctor Hedeburg. "Deaths caused by flies are many times more than those caused by wars and wild beasts of all times.

"About 30 diseases are known to be spread by germs carried by flies. The most common are typhoid, infantile diarrhea, cholera, and dysentery. Census reports show that infantile diarrhea, better known as summer complaint, germs of which are transported by the fly, causes more deaths among children than measles, scarlet fever, whooping cough and diphtheria put together."

Other common ailments traceable to flies are tuberculosis, anthrax, eye disease, diphtheria and smallpox.

Health authorities declare that the fly can be eliminated most effectively by destroying breeding places—refuse and garbage piles, by screening windows and destroying the flies that get into the house with a good fly spray.

Research in the Foundation's laboratories has definitely proven that fly-papers, powders and swatters are inefficient as exterminators. The favored method—spraying—should be applied with a hand sprayer directed towards the walls and ceilings of the rooms. The mist drawn into their breathing pores paralyzes the flies, quickly causing their death.

Washington, D. C., July 8.—"I have this day introduced in the House a Resolution (H. J. R. ...) calling for the erection in the National Capital of a memorial to Frederick Douglass, the fugitive slave whose name will ever survive as one of America's most eloquent orators as well as one of the most profound thinkers of his time," declared Representative Emanuel Celler of the 10th New York district. "The life of Frederick Douglass epitomized the struggle of the Negro race in its rise from the abysmal depths of slavery. He saw the slaves, including himself, emancipated; but he realized that freedom brought duties and responsibilities, and created expectations which must needs be fulfilled. He taught the colored people that they must maintain a high state in the Republic and could not be mere driftwood in a stream. He fought and bled to achieve for his people equality of opportunity in industry and education.

Decatur, Ill. (CNA)—Leonidas MacDonald, 34-year-old Negro stockyard worker, was nominated for Governor of Illinois by the State Convention of the Communist Party which took place here on June 26. The nomination was unanimous, and was widely cheered by the delegates to the convention. MacDonald's running-mate will be Arthur Herby, white miner of Springfield, who was nominated for Lieutenant-Governor.

The names of MacDonald and Herby were placed in nomination by R. K. Gebert, white, district organizer for the Communist Party in Illinois, who characterized the present situation of the workers as "starvation in the midst of plenty."

COAST GUARD JIM CROW ORDER DRAWS N. A. A. C. P. PROTEST

New York, July 8.—An order issued on January 4, 1931, by the late Admiral F. C. Billard of the Coast Guard, which recently came into the hands of the N. A. A. C. P. providing that "only white men" should be considered in effecting enlistments for three ship cooks to be sent to Section Base at Cape May, N. J., has drawn a sharp letter of protest from the N. A. A. C. P. to Ogden L. Mills, U. S. Secretary of the Treasury.

In its letter the N. A. A. C. P. inquires whether discrimination is prevalent in this branch of the U. S. Government and points out that it is supported by the taxes of all citizens regardless of color. Replying to the N. A. A. C. P., Seymour Lowman, Assistant Secretary of the Treasury, states that Coast Guard regulations governing enlistment do not discriminate on account of race or color and adds: "Among the personnel of the Coast Guard there are a number of colored men, some with long, honorable and faithful service. Some of these men have been advanced to the highest enlisted rating, that of chief petty officer."

Washington, D. C., July 8.—Both Columbia lodge No. 85 and Morningstar lodge No. 40, Elks, at special meetings last Wednesday night rejected proposals that they entertain the annual grand lodge session here in August.

The proposition was that the lodges act as hosts in name only and that each of them would be given a 25 per cent share in the profits from the amusement features of the convention.

The first fire was discovered by the owner of the building, who went in the alarm, watched the fire-fighters apparently extinguish the flames, and then went home. Before retiring he telephoned a contractor to call around the next morning to see about repairing a few windows, painting the doors, and otherwise roughing up the place here and there.

At seven o'clock the next morning the contractor called upon the owner at his home and together they went downtown. Arrived where the building should have been, the contractor looked at the smoking pile of debris and then at the owner. "Just what was it you wanted me to do?" he asked, puzzled. How Volcanic Islands Act as Safety Valves

Niuafou is one of the Tonga, or Friendly Islands, situated halfway between Samoa and Fiji in one of the most restless geological areas in the world. Stretching across the South Pacific from Samoa to North Island, New Zealand, there is a huge fissure in the earth's crust. Volcanic islands, such as Niuafou, strewn along this gigantic crack, act as vents for the molten mass within the earth. The jack-in-the-box island of Falcon has popped up from the ocean's bottom at least twice, only to be washed and blown away each time by sea and wind. Only recently it has made its appearance again in larger size, acting as one of these famous safety valves for the earth's mighty internal furnace.

To passengers of steamers passing close, the island looks like any other tropical isle, green with vegetation and coconut palms. Clean white houses and thatched native churches set in grassy lawns dot the hillside. When wind and sea are quiet, landings are made in small open boats which are guided skillfully into a nook partly sheltered by fingers of lava flow. Such landings are dangerous and exciting because the boats bob up and down with the incoming rollers and scrape against the steep, jagged cliffs.—National Geographic Society Bulletin.

The palm tree was well understood to represent the Jewish people in ancient days, as indeed, it does in a sense today.—Montreal Star.

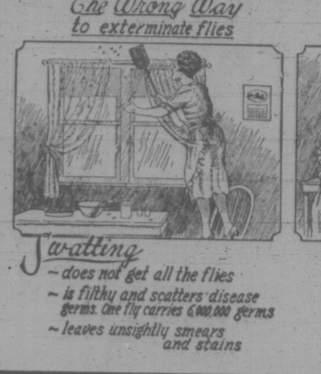
