PLAN GIANT PROTESTS ON SCOTTSBORO CASE IN EUROPE

Paris, France (CNA)—Mass protests on the Scottsboro case that will surpass the proportions of the demonstrations for Sacco and Vanzetti five years ago, were planned at a conference of the Red Aid here, in the presence of Mrs. Ada Wright, mother of two of the Scottsboro boys. The French Red Aid is a sister organization to the International Labor Defense of the United States.

Berlin, Germany—Mrs. Ada Wright, mother of two of the nine Scottsboro boys, who is now on a tour of the principal countries of Europe, was refused a visa to enter Ireland. The Irish workers are organizing mass pressure on the De Valera government in order to force a reversal of the decision.

Negroes Forced to Work for 'Free Flour'

New York—Negroes in Palm Beach county, Fla., are being forced to work for the free flour sent for distribution by the American Red Cross, according to word which has reached the N. A. A. C. P. here.

White people are given the flour without any red tape. Not only must Negroes work for the flour, but they are paid the lowest possible wage, so that they can barely earn enough each day to eat. In the town of Belle Glade Negroes are paid thirty cents a day and in South Day fifty cents a day. The bags of flour are plainly marked "not to be sold". The N. A. A. C. P. has referred the complaint to the Red Cross headquarters in Washington.

Those who visit the booth of the Des Moines Branch, N. A. A. C. P. in the Educational Building at the State Fair this year, will find it entirely different from what it was last year. Then the main feature was portraits of prominent Negroes, beautiful homes and places of business owned by Negroes in Iowa; while this year's exhibit consists largely of posters, the work of the young Negro artists Everett Wadsworth, Carl Edmonds and Cornelia Leonard.

These posters contain quotations upon the subject of "Race Relations" by prominent Americans of both races including President Hoover, Frederick Douglass, Booker T. Washington, Dr. S. Parkes Cadman, Dr. Chas. S. Medbury, Dr. Stoddard Lane, Editor Harvey Ingham, Dr. L. K. Williams, Dr. R. R. Wright, Mrs. Schumann-Heink and Mrs. Mary McLeod Bethune.

Perhaps the most outstanding feature of the entire exhibit is a life-size crayon portrait in colors of Hon. Harvey Ingham, President Emeritus of the Des Moines Branch, made by Miss Cornelia Leonard, a recent graduate of North High School, about which she has woven in a very artistic manner one of his characteristic declarations upon the subject of "Racial Equality".

Ritz District Protests Adelaide Hall

New York—Adelaide Hall, star of the musical comedy and vaudeville stage, has been offered the aid of the N. A. A. C. P. in the event any serious trouble develops over her leasing of a \$35,000 home in the exclusive Larchmont section of Westchester county, just outside New York City.

Miss Hall has leased and had her furniture moved into No. 11 Kilmer road, named after the famous young poet, Joyce Kilmer, killed in the World War. Since the announcement in the press, neighbors in the section have protested to Mayor Monroe Steiner, who told them "What can I do about it?" Unable to get any satisfaction from the Mayor, the neighbors are reported to be seeking an injunction to keep Miss Hall from occupying the home. Miss Hall is playing in Asbury Park and plans to step into her new home in a few days.

Because of the principle involved and because Miss Hall and other big time artists have been generous in giving their talent for N. A. A. C. P. benefits, the association offered its services should anything more serious than protests develop.

Methodists Can't Pay Their Bishops

New York Ministers Unpaid for July New York, Aug. 26.—The Methodist Episcopal church is unable to pay its bishops or to meet its obligations to its widows and retired bishops, it was learned here. Salaries and pensions for July were 43 per cent short and now the treasury is empty, making it impossible for any further payments until October.

Although the budget for 1932 was cut excessively and salaries were reduced, there is not enough money in the treasury to meet the obligations of the denomination. Salaries and pensions for July were 43 per cent short. The treasury is now empty and it will be impossible to make any further payment until October after the fall conference report, unless laymen advance the money. Dr. John R. Race, the treasurer, declared.

Two reasons were given for the default. One was the depression which has tightened up receipts and payments all along the line. The other was the cost of the general conference.

Some of the most prominent clergymen in the country are affected by this shortage. Several from overseas are unable to return to their jurisdictions until passage money is made available for them. Bishop Matthew W. Clair of Covington, Ky., and Bishop Robert E. Jonens of New Orleans are among those affected.

NAACP Asked To Aid In C. of C. Vote Drive

New York—The Junior Chamber of Commerce of the United States has been asked by the N. A. A. C. P. to include Negro voters in its campaign to get out 50 million votes in the fall election.

The N. A. A. C. P. was asked by the Junior Chamber of Commerce to cooperate with it in urging American citizens to use their ballots. The N. A. A. C. P. replied that its job is one of getting opportunity for Negroes to vote in the states where they are disfranchised and seeing to it that they are granted their full citizenship rights in other states of the union.

In its letter the Junior Chamber of Commerce says: "To every American, we feel, the high purpose of this project—the widest exercise of the right to vote by every qualified voter—will be self-evident. Every American should be impressed that casting his ballot is not a mere privilege but his duty."

The N. A. A. C. P. was asked to issue a proclamation which would "help

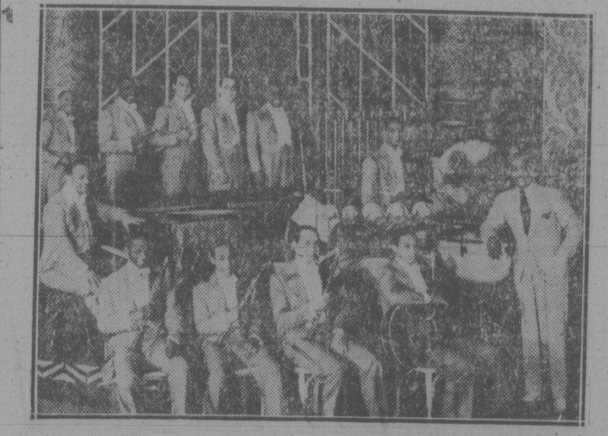

Many Visits Y Camps at Boone

In spite of the depression the 1932 camp periods for both the Crocker St. Y. M. C. A. and the Blue Triangle Y. W. C. A. will go down in history as one of the most successful of the fourteen annual outings for Des Moines youths. Sunday was visitors' day at both camps which are situated within a mile of each other and about six miles north of Boone. All day visitors arrived from Des Moines, Boone, Ames and Fort Dodge.

Impressive Flag Service

The Y. M. C. A. Camp the religious service in Chapel Point was the chief attraction during the forenoon, one hundred fifteen campers lined up on the campus near the flagpole and were given a lecture by Henry Has-Brouck, director upon the significance of both the American flag and the Christian flag. An invisible quartet, consisting of Melvin Overton, Vincent Wilson, Fred Thomas and Leo Elmore, cabin leaders, sang as the Christian flag was raised on Chapel Point, several hundred feet above the campus, so that it was just visible above the thick foliage of the trees that hid the chapel and the singers from view.

As the quartet sang the campers each carrying a hymn book and preceded by the visitors, wended their way up to the beautiful chapel which seats a hundred and fifty persons and filled it to overflowing. The service

Police Called To Quell Church Riot

DETROIT, Mich., Aug. 26.—The trouble which has been brewing at Shiloh Baptist church for the past 12 months, entering into court battles, burst forth with a fury Monday night when several cars of police were called to quell the disturbance created when a special meeting was called to oust some of the members.

The ousted members, Elliot McGill, C. H. Bell, M. J. Yopp, Joseph Johnson, S. L. Jordan, Lena Banks, J. H. Covin, Walter Johnson, M. B. Allen, Marshall Lewis and Sarah McGill, had filed a petition against the pastor, Rev. Solomon David Ross, seeking a temporary injunction to restrain the defendant from occupying the pulpit during the pendency of the proceedings, based upon a bill of complaint charging that Rev. Ross, among other things, converted \$37,000 to his own use, which money belonged to the church. Rev. J. A. Gibson was also ousted.

'100 Per Cent Americanism' Idea Practiced

Memphis, Tenn., (CPA) August 22.—The opening session of The American Legion Convention of the State of Tennessee was held today at Ellis' Municipal Auditorium. One of the first moves taken by the Convention was the refusal to allow Negro vets to sit on the main floor. They were ordered to the balcony, if they wished to sit in at the opening session.

Commander Prentiss Cooper, white, chairman of the convention, called to the platform the Post Commanders of every Legion unit in the State except the Negro Post Commanders. An undercurrent of dissatisfaction immediately permeated the group of Negro delegates. A few of them made protests, and tried to influence their comrades not to march in the parade which took place this afternoon.

It was claimed by some of the Negro delegates that this act of segregation could have been avoided, if the Post Commanders, prior to the convention, had taken the proper steps. However, one of the main ideas of the Legion is said to be "one hundred per cent Americanism", and many are of the opinion that no opportunity should be lost to demonstrate that Americanism.

Prudential Bank Gets Loan \$15000 From R. F. C.

WASHINGTON, D. C., Aug. 26.—A loan of \$15,000 was made to the Prudential bank, of which John B. Hawkins, financial secretary of the African Methodist Episcopal church, is the president, according to the first detailed report of the Reconstruction Finance corporation made public last Monday.

Chicago—Rev. Howard Branch, pastor of Greater Union Baptist church, Chicago, will succeed his father, the late Rev. E. H. Branch, as treasurer of the National Baptist Convention of America.

The Central States Golf Association held its Second Annual Tournament on the Grandview Golf Course Sunday and Monday, Aug. 21-22. The Association tournament is an annual 36 hole medal affair. The 18-hole qualifying round was played on Sunday with 20 entries from St. Louis, Kansas City and Des Moines competing. The group represented the survivors and best players of their localities. Due to the wind swept course and the high tension of the players scores were not as low as last year.

Chas. P. Howard, the medalist had an 82 and was closely pressed by Dr. Eugene Rummans of Kansas City and James L. McGuire of Des Moines, both of whom had 84's. Further back in the championship flight came Dr. R. G. Robinson of St. Louis, Virgil Walden, Roy Todd, Norman Blagburn and T. L. Howard of Des Moines.

TAX REDUCTION

We hear a lot about tax reduction. Organizations are being formed to urge it; a citizens' committee here is trying to show the taxing authorities how thousands can be saved. But about the biggest discovery they are able to make is how to reduce someone's salary or cut somebody out of a job here and there.

After all, the payroll of our county and city government does not constitute the major expenditures and the reductions in salaries will not be noticed on the tax receipt; certainly not on the receipt of the fellow who needs relief most.

Taxes will come down if other items we must pay stay down. However, because of our system public officials were drawing small salaries while others were drawing big salaries. Then too, the average public servant is called upon to donate to and buy tickets for everything that comes along and if he refuses he is not a good officer. He must finance his campaigns and in many cases donate to the campaigns of others. Whether these things are right or not, we do not attempt to say, but the system is with us and we might as well deal with it fairly.

We are not in sympathy with the campaigns conducted by most of these tax committees.

AGAINST IT

While Congress was in session this spring, Senator Reed of Pennsylvania, introduced a bill which would authorize a hospital for Negro veterans in his state. It is stated that this was done as a part of the American Legion program and was endorsed by the National Medical Association.

To send Negroes living in Iowa, South Dakota, and other far-off states across country to Pennsylvania is ridiculous. This same argument was raised in an effort to get Confederate veterans living in northern states into Union veterans' hospitals near their homes and the only reason Congress did not make the provision, the southern states objected urging that they wanted to take care of their own.

We have a hospital at Tuscarora where all Negro veterans in the country are sent. It is the north Negroes generally go to the hospital nearest their home. This is as it should be and if this bill is a part of the American Legion program we are against it; if it is the National Medical Association's program, we are against it.

THANKS

In spite of conditions, Negro boys and girls have gone to the Y. M. C. A., Y. W. C. A. and Boy Scout camps in large numbers this year. This has been made possible largely because of the fine spirit shown by many

HEALTH TALKS

ARTHRITIS

The number of bones in the body is two hundred and the number of joints therein bears a relation to the number of joints therein. There are more joints than bones because of the position in which the bones are placed in apposition to each other. A joint is formed where two or more bones come together and a joint has a definite formation, there being a pad of tissue called cartilage between the bones which makes them move smoothly against each other.

Each joint contains a small amount of fluid which is the secretion of a membrane which lines the inside of each joint cavity. The largest joints are the elbow, shoulder, knee, wrist, and ankle joint. From the standpoint of infection they are the most important because they are the most often affected when joint trouble occurs. The joints in the spine and those in the feet and hands sometimes take part in general joint affections and they are sometimes alone for a short or a long period.

Joint affections have a single meaning and that is that some material has traveled by way of the blood from some other portion of the body and this point of beginning is in need of treatment to remove this material that is causing soreness and swelling in the joint. Joint affections become as a rule very disabling and sometimes these joints become permanently fixed so that no movement can be made whatever. The joint condition must be treated to prevent this and the point which the infection came may be of more importance. Both should receive the proper attention as soon as any symptom of joint disability makes self known.

Man's "Magic Wand" Now Saves Dog

Simple Can-Opener Is Now Key to Happiness for Hungry Canines.

A generation ago bridge parties and other wifely diversions outside the home usually meant a cold snack for hubby. Then the can-opener came along, ending tag-end and left-over feeding by making a good, nourishing meal quick and easy to prepare. It soon became the queen's sceptre in the American kitchen.

Now this magic wand is freeing the family dog from haphazard table-scrap feeding, which kills thousands of pets every year, says the Chappel Kennel Foundation, Rockford, Illinois. A recent survey shows there are now more than 200 varieties of prepared dog foods on the market.

Just as a twist of the wrist now brings to our table food luxuries once too rare and costly for ordinary humans, so the canning process brings the choicest and most unusual morsels within reach of every dog.

Horse-meat, for instance, tastiest and most nutritious of all animal foods, is now included in every high-grade line of dog foods. A few years ago so little horse-meat was available that only "special" dogs, like Rin-Tin-Tin, the movie "star", choice packs of hounds and a few leading show dogs, ever tasted it. Now Mr. Average Dog is consuming huge herds of meat-horses every year, and half a dozen manufacturers are kept busy canning horse-meat.

As yet the dog lacks the legal safeguard his master enjoys in the matter of canned foods. Leading national brands are prepared as carefully as human foods, under the supervision of the U. S. Department of Agriculture, but there are many nondescript, un-inspected dog foods on the market, the Foundation warns.

It is best to avoid un-inspected products. Feeding tests show that many of them will not properly support animal life. Often they are made from cast-off meat, trimmings, or other waste by-products which are not sold for human food. Some even contain pork.

Healthy dog diets may be made at home, but the average dog owner who is not familiar with the science of canine nutrition is advised to use one of the canned, ready-to-feed preparations, because they contain the exact proportions of meat, cereals and mineral products needed to keep the animal in full health.

No Bark—No Bite

The North American Eskimo sled-dog, an extremely good natured animal, is the only one of his race which does not bark, states the Chappel Kennel Foundation. He sneezes.

"Thrill Day" Planned

Des Moines, Ia., Special: Those who crave new kinds of thrills should come to the Iowa State Fair on Saturday, August 27. The day has been designated as "Thrill Day" with a program featuring a scope of blood-curdling and hair-raising events. Among these are a head-on railroad collision between two trains traveling fifty miles an hour, a head-on smash-up between two automobiles speeding around the race track at sixty miles an hour, a railroad crossing accident in which a car is demolished by a speeding train, a motorcycle broad-jumping contest, a non-suspending automobile, an old-fashioned "loop the loop" on the bicycle, and a series of high-aerial acrobatic acts imported from Europe and guaranteed to startle the most blasé. Although the State Fair program will extend from August 26 through September 2, these features will be presented on one day only, Saturday August 27.

Washington, D. C. (C.N.A.)—A systematic terrorization of Negroes here by the police and by gangs of hoodlums, has resulted in the arrest of two patients on suspicion about 10 21, and the indictment of 11. Three murder, the others with being accessories before the fact. The police are attempting to implicate these Negroes in the death last week of Policeman M. J. Kennedy (white). The International Labor Defense has offered its services to the arrested workers, and has been accepted by all who could be reached so far. Bernard Ades, who was one of the attorneys defending Euel Lee in Baltimore, is at present in Washington preparing to fight the murder frame-ups.

Kennedy charged into a group of Negro men and women at Logan Circle. Using club and revolver, he threatened them and ordered them off the streets. He singled out one Negro for arrest, and was driving him to the corner to wait for a patrol wagon, when the workers rallied and fought for the release of the prisoner. The policeman was beaten and died later from a fractured skull. At once the white papers launched into a tirade against the Negro population of Washington.

Since the eviction of the veterans from this city, police and press have been attempting to provoke attacks on the Negroes. The police have beaten Negroes, broken up any group of two or three or more seen on the streets, and arrested scores under the "vagraney" law.

New Orleans, La., Aug. 19.—The ordinance introduced recently by Mayor T. Two hours after the adoption of the ordinance a temporary federal injunction was obtained against it by George H. Terriberry, attorney, representing the New York and Porto Rico Steamship company.

ARREST NEGRO MAN, WHITE WOMAN, FOR WALKING ON STREET

Kansas City, Mo. (C.N.A.)—For the "crime" of walking down the street together, police here arrested Henry Winston, a Negro member of the Young Communist League, and Marie Harrison, white, organizer of the local branch of the International Labor Defense. They are being held on a charge of "vagrancy".

Over a year ago, an interracial dance here was broken up by police and over 40 workers were thrown into jail. The judge searched the statute books, but failed to find any law under which interracial dances would be held illegal. He released the workers, first telling them it was "against the law of God" for the races to mix socially.

New York.—The position of the N. A. A. C. P. as to what should be the attitude of Negro voters towards senators seeking re-election who voted for confirmation of Judge John J. Parker of North Carolina as an associate justice of the United States Supreme Court "is precisely what it has always been", the N. A. A. C. P. stated here today in response to a flood of inquiries from its branches and from individuals in various parts of the country. "The issue involved in the Parker fight was fundamental", the N. A. A. C. P. statement read, and "it is fundamentally important that Negroes prove they meant business when they said that they would regard those senators who voted for Parker as betrayers of the Negro's interests and that Negroes would not support for re-election any senator who did vote to put a man with Parker's views on the Supreme Court bench."

DANCERS SCORE AT LEWISOHN STADIUM

New York (A.N.P.)—At the Lewisoahn Stadium, City college, Tuesday night the season's largest crowd, estimated at 14,000, saw an excellent performance by the Albertina Rasch dancers and a chorus of Negro singers and dancers. "Cakewalk" and "Negro Chant" were the most interesting and the finest staged numbers of the production. The former had to be repeated after its presentation.

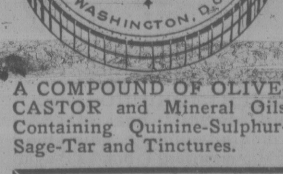

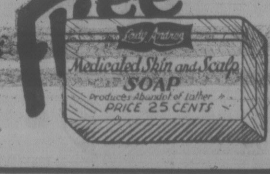
