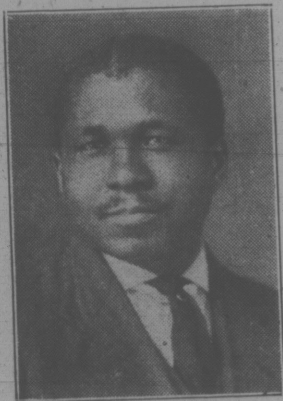


Thousands Attend Second Buxton Reunion

New York.—Negro workers in the flood control camps along the Mississippi River are being paid an average wage of ten cents an hour for a 12-hour day and a 7-day week, it was revealed in a sensational expose made public here today by the N. A. A. C. P., 69 Fifth Avenue. The Association sent an investigator on a personal tour of the camps from New Orleans to Memphis.

The flood control work is being done under U. S. Government contracts by private companies.

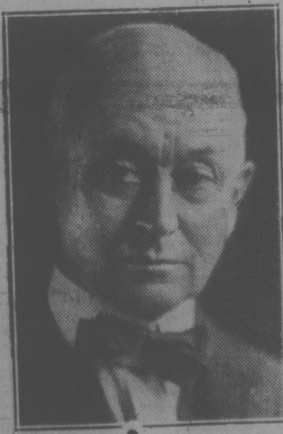
The report declares conditions of "virtual slavery" exist in the camps. Physical violence in the handling of workmen, unsanitary camp sites, irregular pay days, overcharging by means of the camp commissary system, as well as the long hours and low wages were cited as abuses found to be general.

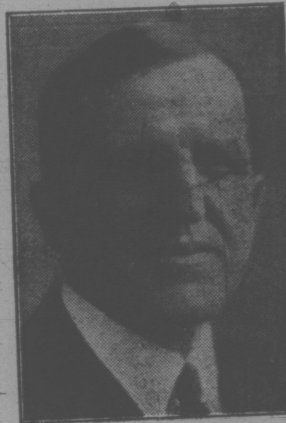

Gov. Turner Addresses Enthusiastic Gathering

Buxton, the largest mining camp in the history of Iowa, was an incorporated town with a peak population of 6,000. It was started in 1902 by E. C. Buxton, now a resident of Vermont, then general superintendent of the Consolidation Coal Co., a subsidiary of the Northwestern railroad, who moved the mining camp from Muchakinok in Mahaska county to Monroe county.

Serving the Consolidation Coal Co. as general superintendents until the closing of the mines in 1924 were Mr. Buxton, E. M. Baysor of Albia, deceased; John P. Reese of Albia, deceased; and F. S. Pfaffler of Chicago, now conducted with the company's mines at Gillespie, Ill.

The first mine worked in this field town of Buxton, and the last mine worked was Buxton No. 19, twelve

was known as Buxton No. 10, near the miles west of Lovilia and eighteen miles southwest of the original town. The site for sinking mine No. 20 had been selected and a railroad grade made when the mines closed.

The annual payroll of the Consolidation Coal Co. was several hundred thousand dollars and in 1918 exceeded \$1,000,000, the daily tonnage averaging 3,500 tons. The largest number of men employed by the company was in 1914, when 1,500 were on the payroll.

All that remains of the once flourishing town of Buxton are a few weather-worn buildings, an occasional remaining foundation of a large build-

Y Boys Make Good Records

A. camp was outstanding as many new records were made by the boys. Mr. Hasbrouk was assisted by Quentin Mease and Al Spriggs and 12 cabin leaders. The following cities were represented in camp: Fort Dodge, Perry, Oralabor and Omaha, Nebr. Troquois cabin was again awarded first prize in Stunt night show. Roy Lee, Fred Thomas and Melvin Overton, leading performers. Thorny Locust, won the second prize. Robert Coffman of Fort Dodge, and Carroll Devan were joint winners of Physical Efficiency test, conducted to determine best all around athlete in camp. Both of these boys scored a perfect percentage of 100.

Coffman was also double winner in track meet, taking the 100 yd. dash and broad jump, setting all time camp

A mining camp which has been dormant for the past ten years was brought back to life for the second time on Sunday, September 4th, when the Second Annual Buxton Reunion was set in motion by a real old fashioned meeting.

Over two thousand people were in attendance when Rev. J. J. Evans, pastor of Bethel A. M. E. church of Des Moines, delivered the benediction. By noon this number had been increased to forty-eight hundred.

During the dinner hour, the once famous Buxton Concert band filled the air with appropriate music, first playing "Home Sweet Home", then the old pep song "The Gang's All Here". Their rendition of the Iowa Corn Song was heartily applauded. Music was also furnished by Zimmerman's String Orchestra.

A short business session was held before Governor Turner delivered his address, at which Mr. E. F. Brown was re-elected president of the Buxton Reunion Club and Mr. E. F. Butler re-elected secretary.

Governor Turner congratulated the organization for what he termed a loyal spirit in keeping alive the traditions and history of the old camp. He drew thunderous applause when he insisted that he stood strongly for law enforcement and honesty in public office.

Several letters were read from those unable to attend. Mr. B. C. Buxton of Middleton Springs, Va., sent greetings, also Dr. E. A. Carter of Detroit.

New York.—Japan wants Eddie Tolan to coach its Olympic runners. Shortly after he won both sprinting races in the Olympic games, Tolan, a young graduate of the University of Michigan, received a Japanese offer. Rather, he received two-offers. One was in the form of an invitation to tour Japan and race. The other was to spend all or part of the next four years in coaching the Nipponese athletes.

Tolan's decision will be withheld for a while because acceptance of the coaching offer would automatically make him a professional.

Atlantic City, N. J., Sept. 2.—The 33rd annual convention of the Improved, Benevolent and Protective Order of Elks of the World ended here Saturday after unanimously re-electing J. Finley Wilson as grand exalted ruler for his 12th term.

Unlike previous conventions, the Elk meeting this year was poorly attended, many lodges being financially unable to send delegates. Only about one-third of the usual Elk horde was in attendance at the annual session.

NAACP Exhibit Wins First Prize at State Fair

As a distinctive evidence of the fact that the Des Moines Branch of the N. A. A. C. P. is advancing the cause of Negroes of Des Moines in particular and of Iowa in general, the State Fair Booth planned and directed by Mrs. S. Joe Brown, and which last year won second place, was this year awarded first place in the Adult Education class in competition with that of the Iowa Parent and Teachers' Association and the Iowa Library Association, which were awarded second and third place respectively in this same class.

This year's feature included posters and portraits of nationally famous Americans, drawn and designed by three Des Moines artists, Miss Cornelia Leonard, North High graduate and 1932 National Poster Contest winner, Carl Edmunds, of East High, sign writer and printer in East Des Moines and Everett Wadsworth, East High graduate and formerly of Des Moines University, staff writer of the Iowa Bystander.

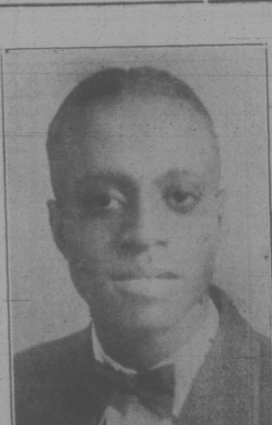

The exhibit was also greatly embellished by the production of two programs, the one on Friday the 26th, consisting of a patriotic wand drill by sixteen young girls under the direction of Mrs. Wm. E. Guy; and, the other on Tuesday the 30th, consisting of the singing of Negro Spirituals by the Burns M. E. male quartet, which so pleased the audience that they were requested by Mrs. I. H. Tomlinson, general superintendent of Educational Exhibits to make phonograph records of two of their selections, a duplicate of which record was delivered to them as a souvenir. On Thursday Misses Attrel Jett and Dorelva Mackey gave a program of music and readings.

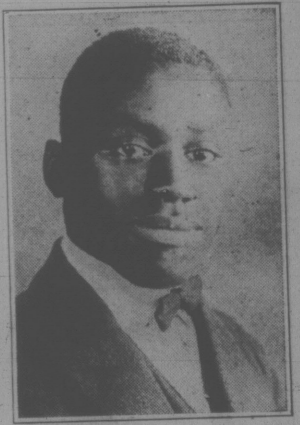
N.A.A.C.P. EXHIBIT WINS FIRST PRIZE WITH POSTERS DRAWN BY DES MOINES ARTISTS

James Ford To Speak Here

James W. Ford, vice presidential candidate of the Communist party, will speak in Des Moines Tuesday, October 4, at a meeting arranged by the party's local election campaign committee.

Ford's running mate for president, William Foster, will speak in Des Moines Wednesday evening at East High school.

At the Communist national convention in Chicago May 28, Foster and Ford were nominated by acclamation. Ford, whose grandfather was lynched, is the first member of his race to be nominated for the vice presidency.

Platform

The Communist platform contains six main points demanding unemployment insurance, an end to "Hoover's wage cutting policy", emergency relief for impoverished farmers, equal rights for Negroes "in the black belt" and elimination of "capitalist terror" and "imperialist war."

To Organize Junior Negro Republican Voters League

The National Young Republicans League, through its chairman, George Olmstead, former president of the United States Junior Chamber of Commerce, has asked the Negro Republican Voters League, through its Chairman J. G. Browne, to supervise the creation of a similar organization among the young Negro voters of Iowa, to be a part of and affiliate with this nation wide movement. The Young Republicans League will constitute an independent body controlled by officers elected from, and by its own members. All voters up to 35 years of age are eligible for membership.

This is a glorious opportunity for young Negro men and women of America to assert an influence in politics. This is a chance for young men

and women of intelligence and ability to prove their worth and establish themselves as able useful citizens in their respective communities.

The young Negro men and women of Des Moines are especially fortunate in that the head of this great national innovation is a Des Moines man which gives to them a direct personal contact hard to obtain by those less fortunately located, and the officers of the Negro Republican Voters League will see to it that every advantage possible will be utilized.

Applications have come already from ambitious youngsters and as soon as a few minor details are worked out, a call for organization will be made.

THE BUXTON REUNION

The former residents and friends of Buxton in Monroe county are holding a reunion and picnic at the old camp Sunday, the 4th. Last year hundreds of visitors attended the first reunion and this year a larger crowd is expected.

Buxton has sent out a number of prominent citizens who have become familiarly known throughout the country. Many stand today as some of our most prominent Iowa citizens.

Reunions are helpful in that they reassemble old friends and former neighbors, provide recreation, means of discussions about what was, is and will be—all of which are worth while. The 1932 reunion is bound to make further history for Old Buxton and its people.

THE STATE FAIR

The annual Iowa state fair has closed. It is easily "Iowa on Parade", for while the merry-go-round, minstrels, circus stunts and side shows provide fun for many the exhibits of farm and home life are by far the most interesting. Many who have never witnessed the fair cannot imagine what wonders people can work with the simple things about them.

Whether city people give much attention to the farm exhibits or not we do not propose to say. But if they took the time they could but come to conclude that farm life is quite beautiful after all and that contrary to the gloomy pictures painted, the farm is a pretty good place to be.

DIFFICULT BUT NECESSARY

The more we come in contact with white people, the more we realize that they need much education about the Negro. They not only need to know that the Negro is human but also that his aims and ambitions are the same as those of other races.

Anyone who saw the N. A. A. C. P. exhibit at the state fair and observed the white people who came to see what it was all about must have been convinced that not only do they know little but their means of getting information about the Negro were either nil or in many cases the wrong sort.

Most of the visitors were from small towns where few, if any, Negroes live. Their libraries, schools and newspapers carry comparatively nothing worth while about Negroes. Generally they know the Negro as the porter "Tom" or "Jim" who worked at the hotel or for the leading citizen of the town. They naturally have come to conclude that that status is where the Negro belongs.

HEALTH TALKS

SORE THROAT

Soreness in the throat occurs at any time but most commonly in the fall and winter months and not uncommonly in the spring when the weather breaks. It occurs at any time when there is a quick change in the weather taking us off our guard so to speak. We notice first a little soreness when swallowing food or water and as the material goes into the oesophagus on the way to the stomach there is a sensation which remains for a second and we know then that some change has occurred within the throat. It makes no difference what the disease is that is beginning here it always begins in this way with some soreness or with some difficulty on swallowing.

Scarlet fever, diphtheria, tonsillitis of whatever variety. Tuberculosis of the throat and inflammation of what is called the pharynx from whatever cause all begin in this way. There is not much tendency now for anyone to neglect this soreness and I am quite certain that most everyone now takes this soreness seriously, and begins gargles or something in the effort to prevent a more serious condition.

The realization that some of the above mentioned conditions can very speedily take place here and cause very serious illnesses makes us take notice and do something to prevent serious conditions here. Some conditions in the throat do not yield to these measures so commonly resorted to. Sometimes tumors begin in the throat and in the beginning show no features different from any ordinary sore throat. It is always a wise thing to have the throat looked at in any soreness here lasting any ordinary period for in this way serious diseases of the throat will be prevented.

WASHINGTON, D. C., Aug. 26.—A loan of \$15,000 was made to the Prudential bank, of which John R. Hawkins, financial secretary of the African Methodist Episcopal church, is the president, according to the first detailed report of the Reconstruction Finance corporation made public last Monday.

Memphis, Tenn., (CPA) August 22.—The opening session of The American Legion Convention of the State of Tennessee was held today at Ellis Municipal Auditorium. One of the first moves taken by the Convention was the refusal to allow Negro vets to sit on the main floor. They were ordered to the balcony, if they wished to sit at the opening session.

Commander Prentiss Cooper, white, chairman of the convention, called to the platform the Post Commanders of every Legion unit in the State except the Negro Post Commanders. An undercurrent of dissatisfaction immediately permeated the group of Negro delegates. A few of them made protests, and tried to influence their comrades not to march in the parade which took place this afternoon.

It was claimed by some of the Negro delegates that this act of segregation could have been avoided, if the Post Commanders, prior to the convention, had taken the proper steps. However, one of the main ideas of the Legion is said to be "one hundred per cent Americanism", and many are of the opinion that no opportunity should be lost to demonstrate that Americanism.

New York—Negroes in Palm Beach county, Fla., are being forced to work for the free flour sent for distribution by the American Red Cross, according to word which has reached the N. A. A. C. P. here.

White people are given the flour without any red tape. Not only must Negroes work for the flour, but they are paid the lowest possible wage so that they can barely earn enough each day to eat. In the town of Delle Glade Negroes are paid thirty cents a day and in South Day fifty cents a day. The bags of flour are plainly marked "not to be sold". The N. A. A. C. P. has referred the complaint to the Red Cross headquarters in Washington.

Man's "Magic Wand" Now Serves Dog

Simple Can-Opener Is Now Key to Happiness for Hungry Canines.

A generation ago bridge parties and other wifely diversions outside the home usually meant a cold snack for hubby. Then the can-opener came along, ending tag-end and left-over feeding by making a good, nourishing meal quick and easy to prepare. It soon became the queen's sceptre in the American kitchen.

Now this magic wand is freeing the family dog from haphazard table-scrap feeding, which kills thousands of dogs every year, says the Chapel Kennel Foundation, Rockford, Illinois. A recent survey shows there are now more than 200 varieties of prepared dog foods on the market.

Just as a twist of the wrist now brings to our table food luxuries once too rare and costly for ordinary humans, so the canning process brings the choicest and most unusual morsels within reach of every dog.

Horse-meat, for instance, tastiest and most nutritious of all animal foods, is now included in every high-grade line of dog foods. A few years ago so little horse-meat was available that only "special" dogs, like Tin-Tin, the movie "star", choice packs of hounds and a few leading show dogs, ever tasted it. Now Mr. Average Dog is consuming huge herds of meat-horses every year, and half a dozen manufacturers are kept busy canning horse-meat.

As yet the dog lacks the legal safeguard his master enjoys in the matter of canned foods. Leading national brands are prepared as carefully as human foods, under the supervision of the U. S. Department of Agriculture, but there are many more "dip" un-inspected dog foods on the market.

It is best to avoid un-inspected products. Feeding tests show that many of them will not properly support animal life. Often they are made from cast-off meat, trimmings or other waste by-products which are not sold for human food. Some even contain pork.

Healthful dog diets may be made at home, but the average dog owner who is not familiar with the science of canine nutrition is advised to use one of the canned, ready-to-feed preparations, because they contain the exact proportions of meat, cereals and mineral products needed to keep the animal in full health.

PLAN GIANT PROTESTS ON SCOTTSDORO CASE IN EUROPE

Paris, France (CNA)—Mass protests on the Scottsboro case that will surpass the proportions of the demonstrations for Sacco and Vanzetti five years ago, were planned at a conference of the Red Aid here, in the presence of Mrs. Ada Wright, mother of two of the Scottsboro boys. The French Red Aid is a sister organization to the International Labor Defense of the United States.

Berlin, Germany—Mrs. Ada Wright, mother of two of the nine Scottsboro boys, who is now on a tour of the principal countries of Europe, was refused a visa to enter Ireland. The Irish workers are organizing mass pressure on the De Valera government in order to force a reversal of the decision.

DETROIT, Mich., Aug. 26.—The trouble which has been brewing at Shiloh Baptist church for the past 12 months, entering into court battles, burst forth with a fury Monday night when several cars of police were called to quell the disturbance created when a special meeting was called to oust some of the members.

The ousted members, Elliott McGill, C. H. Bell, M. J. Yopp, Joseph Johnson, S. L. Jordan, Lena Banks, J. H. Covin, Walter Johnson, M. B. Allen, Marshall Lewis and Sarah McGill, had filed a petition against the pastor, Rev. Solomon David Ross, seeking a temporary injunction to restrain the defendant from occupying the pulpit during the pendency of the proceedings, based upon a bill of complaint charging that Rev. Ross, among other things, converted \$37,000 to his own use, which money belonged to the church. Rev. J. A. Gibson was also ousted.

New York—Adelaide Hall, star of the musical comedy and vaudeville stage, has been offered the aid of the N. A. A. C. P. in the event any serious trouble develops over her leasing of a \$35,000 home in the exclusive Larchmont section of Westchester county, just outside New York City.

Miss Hall has leased and had her furniture moved into No. 11 Kilmer road, named after the famous young poet, Joyce Kilmer, killed in the World War. Since the announcement in the press, neighbors in the section have protested to Mayor Monroe Steiner, who told them "What can I do about it?" Unable to get any satisfaction from the Mayor, the neighbors are reported to be seeking an injunction to keep Miss Hall from occupying the home. Miss Hall is playing in Ashbury Park and plans to step into her new home in a few days.

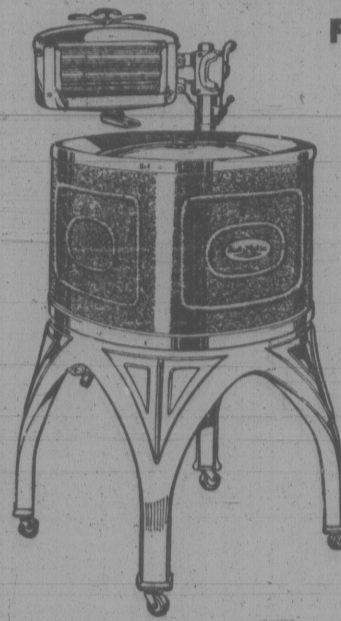

New York, Aug. 26.—The Methodist Episcopal church is unable to pay its bishops or to meet its obligations to its widows and retired bishops, it was learned here. Salaries and pensions for July were 43 per cent short and now the treasury is empty, making it impossible for any further payments until October.

Although the budget for 1932 was cut excessively and salaries were reduced, there is not enough money in the treasury to meet the obligations of the denomination. Salaries and pensions for July were 43 per cent short. The treasury is now empty and it will be impossible to make any further payment until October after the fall conference report, unless laymen advance the money. Dr. John R. Race, the treasurer, declared.

Two reasons were given for the default. One was the depression which has tightened up receipts and payments all along the line. The other was the cost of the general conference.

Some of the most prominent clergymen in the country are affected by this shortage. Several from overseas are unable to return to their jurisdictions until passage money is made available for them. Bishop Matthew W. Clair of Covington, Ky., and Bishop Robert E. Jones of New Orleans are among those affected.

JUNIOR CHAMBER OF COMMERCE ASKED BY N. A. A. C. P. TO INCLUDE NEGRO WORKERS

New York—The Junior Chamber of Commerce of the United States has been asked by the N. A. A. C. P. to include Negro voters in its campaign to get out 50 million votes in the fall election.

The N. A. A. C. P. was asked by the Junior Chamber of Commerce to cooperate with it in urging American citizens to use their ballots. The N. A. A. C. P. replied that its job is one of getting opportunity for Negroes to vote in the states where they are disfranchised and seeing to it that they are granted their full citizenship rights in other states of the union.

In its letter the Junior Chamber of Commerce says: "To every American, we feel, the high purpose of this project—the widest exercise of the right to vote by every qualified voter—will be self-evident. Every American should be impressed that casting his ballot is not a mere privilege but his duty."

The N. A. A. C. P. was asked to issue a proclamation which would "help muster the greatest vote in our country's history."

Walter White, Secretary of the N. A. A. C. P., expressed the hope "that the Junior Chamber of Commerce will include in its campaign efforts to see that all American citizens are granted the right of franchise under the constitution." "The aim of the N. A. A. C. P.," Mr. White stated, "is not to induce Negroes to vote but to force election officials to permit Negroes to exercise the right of franchise. We suggest that the U. S. Jun-

ior Chamber of Commerce should include in its campaign efforts to see that all American citizens are granted the right of franchise under the constitution."

COOKED FOOD BEST FOR DOGS, TESTS PROVE

Raw meat, sometimes advocated for dogs simply because it was their "natural" food in the wild state, has no greater food value and is much harder to digest than meat which is lightly cooked, according to Dr. W. M. Clifford, famous British nutritionist.

In an exhaustive series of tests, Dr. Clifford proved that cooking to the level of a "rare" roast destroys the anti-enzymic compounds in the meat, while no food value is lost because the hardening effect of heat on proteins has hardly come into play.

The experiments have aroused wide attention, the Journal of the American Medical Association declaring that "now the raw meat propaganda is meeting with experimental rebuff."

"This, coming from an authentic source, ought to impress veterinarians who think raw meat is the perfect food for the dog," comments the North American Veterinarian.

Changes in food during digestion are caused by mysterious organic compounds called enzymes, which break down the compounds in food, the Chappel Foundation explains.

Raw meat, Dr. Clifford found, contains "anti-enzymes" which directly oppose the digestive process. Heat destroys these properties, so even over-cooked meat is more rapidly digested than raw meat.

The sanitary value of cooking meat has long been recognized. All agree that it is one of the greatest safeguards against entry of germs and parasites through the mouth. Tape-worm in dogs is almost always contracted from raw meat.

"It has been said that because the dog originally was a wild animal, raw meat is his natural diet," says the Chappel Foundation. "But the dog was domesticated centuries ago, at a time when man himself probably lived chiefly on raw flesh torn from the bones of freshly killed animals."

"Science is constantly finding new ways in which the dog's constitution resembles our own. For them, as for us, the ordinary foods are one-sided in composition. One has too much of certain essential food elements, and not enough of others. So to get a 'square' meal we have to eat several different articles."

"Most people who take an interest in their dog's welfare now buy correctly balanced kennel foods, mixed and canned under government supervision. This is, of course, the safest way, and it is the only way the average person is able to get horse-meat, which is the most perfect meat for dogs."

"One meal of a prepared ration in the evening, plus an occasional fresh meat biscuit or two during the day, and plenty of fresh water, will meet all the dog's dietary requirements for health, strength and a well-conditioned body."

N. A. A. C. P. ASKS NEGRO BE INCLUDED IN HOOVER DAM WORK IS PROBED

New York.—A study of the discrimination against Negro workers at the new Hoover Dam is asked by the N. A. A. C. P. and the National Bar Association if a "thorough investigation" of work at the dam is started by Senator Tasker L. Oddie of Nevada. Senator Oddie, now in Nevada, has wired a protest to the department of the interior against the payment of workers in script and the alleged forcing of them by this method to trade only at company stores, since company stores are the only ones accepting script at full value.

Senator Oddie stated if the practice was not stopped he would demand a "thorough investigation" of the methods of contractors at the dam. The N. A. A. C. P. has written Senator Oddie asking him to include an investigation of the treatment of Negroes if a wholesale probe is started.

CONVALESCENT DOG NEEDS EXTRA CARE

"Yes, the operation was successful, but unfortunately the patient died." Too often a person on the very threshold of recovery from a dangerous illness will suffer a "relapse" which proves fatal. This is not confined to human beings. It is one of the most frequent—and unnecessary—causes of death among dogs.

The reason is that a dog's inherent grit and fighting spirit may be mistaken for strength, explains the Chappel Kennel Foundation. He is permitted to get out and "stear around," wasting what little energy he has, when he should be still confined to rest and quiet, sunshine and simple feeding.

Much chronic stomach trouble in canines, especially that which follows distemper, is caused by a too hasty return to heavy diet, in the mistaken belief that it will enable the patient to recover his strength quickly.

The old idea of taking away meat in fever cases, because it was "heating to the blood," has been discredited. Meat is a natural part of the dog's diet at all times, and contains nitrogen, without which waste tissues cannot be repaired. Horse-meat, because of its soft, easily digested tissue and high nitrogen content, is generally recommended for convalescent dogs and dogs with skin trouble.

Clean, Dry Bed Essential Part of Humane Dog Care

"Let the pup be your furnace man." If you like, but don't make him live in the basement with the furnace, advises the Chappel Kennel Foundation, Rockford, Illinois.

Any old place used to be thought good enough for the dog to sleep. Now, most dog owners realize that a little attention to sleeping quarters will do much to safeguard the animal's health.

The dog that stays in the house is confined to a corner in the kitchen or some other convenient place that is free from dampness and draughts. For small types, a turkish towel makes a nice mattress; a large dog may be given a washable rug.

The dog's bed should be off the floor. If he lives out-of-doors, his kennel should be sufficiently large and light, but free from draughts. Although animals can withstand cold, depending on the length and thickness of their coats, draughts and dampness are often fatal. The sleeping bench should be removable, so that it may be taken out in the open occasionally and washed with water and a disinfectant.

A good kennel, with a hinged roof to facilitate cleaning, can be built at low cost by a carpenter, or by any man or boy who is "handy with tools." If possible, it should be placed under a shed or other protection, facing south or east. It may stand on any kind of soil but sand, which is ideal breeding ground for fleas.

Keep the kennel clean if you want a healthy dog. Give it a limewash frequently, using a little disinfectant in the lime water. The bedding should be stirred daily and changed at least once a week. In summer, he will sleep best either on pine shavings or on bare boards. For winter, cut straw makes a warm and comfortable bed.

Next to injudicious feeding, bad housing probably causes more weakness and disease than any other cause. A clean, dry, draught-proof bed, a balanced ration and a thorough brushing once a day are all most dogs need to be healthy, happy and handsome.

Most of the Foundation's experimental breedings are for purebred dogs, and these need, especially, the best care. This method is the most exact, because there is no waste, and the least bothersome, because the dog is ready to serve, and the best because the product is government inspected, and the best because the ration is scientifically balanced.

SPRAYING MOST EFFECTIVE WAY TO DESTROY FLIES



SCIENCE FROWNS ON SWATTING FLY Urges Use of Insecticide to Kill Fly as Well as the Germs He Carries.

Leading health authorities declare that a single fly can carry 6,000,000 germs and that of this serious health menace they warn that the appearance of flies in the home is a danger signal to be quickly heeded by the careful housewife.

Dr. O. F.
