Ruby Bates 'Disappears' On Eve Of Trial

Interrupts Sermon On 'Brotherly Love'

Atlanta, Ga., March 10—Mobs are now being formed in churches in Georgia. This came to light last Sunday when the Rev. A. C. Peacock, pastor of the Central Christian church, stopped in the midst of his sermon on "Brotherly Love" and told his congregation to arm themselves and follow him. The object of the pastor's search was Rader Davis, a Negro, who had been "seen" with a shotgun. A posse of church worshippers, led by Rev. Peacock, encountered Davis in the west end section of the city. Without attempting to place him under arrest, one of the deacons opened fire and wounded Davis. Surprised by the sudden attack, Davis dropped his gun and attempted to flee. Two others of the church leveled their automatics at him and fired. He fell, wounded in the leg. When questioned it was found that Davis had previously loaned the gun to a friend who had been hunting. He was in the act of carrying it to his own home when attacked. Rev. Peacock, who is a deputy sheriff, returned to the church after sending Davis to the police station without administering medical care and finished his sermon on "Brotherly Love."

Why Have A Negro News- Paper In Des Moines

Local Citizens Should Support Own Enterprise

It has come to the attention of the management of the Bystander that Des Moines agents for newspapers of other cities are working vigorously in opposition to the local enterprise and are urging the subscribers to withdraw and cease their support and assistance to the Bystander and spend their money toward the aid of the foreign paper which generously gives a space of about one hundred words to news of this city.

Leading Citizens Negligent
The Bystander feels that race pride is all right and that all the available assistance and cooperation should be given to a Negro institution, however, when leading local RACE citizens work to the downfall of their own local business upon which they directly or indirectly depend, conditions are really appalling. This disloyal attitude of the Des Moines citizens would not be so glaring were it not for the fact that a newspaper of high caliber is published right here in town.

Bystander Has Same News
Recent survey shows that the Bystander compares very favorably with most of the larger newspapers in the metropolitan cities where the Negro population is many times greater than the entire population of the whole city of Des Moines. The N. A. A. C. P. Press Service, Capital News Service, Southern News Syndicate, Associated Negro Press, Crusaders News Agency, W. B. Ziff & Co. and other releases supply the latest news and advertisements of Negro interest to the local paper.

Best Interest to Local Readers
Realizing that a newspaper is an asset to the community as well as a necessity, the management is stretching every effort, notwithstanding the depression and financial collapse, to publish a creditable news journal each week. Complete reports of national and local interest are found in the columns of the Bystander. The staff takes pride in "playing up" or giving "writeups" for the achievements and progress of the race and especially local people. Current events, athletics, education, society, churches, and business, all have their share of publicity, with crime news at a minimum.

Negroes Employed
With the whole-hearted support of the Des Moines public whom the Bystander serves, the employment of Negroes is maintained. Although small, the local newspaper supplies regular work for printers, reporters, editors, stenographers, etc., as offered in the journalistic field. A larger business institution should be encouraged instead of retarded, as an incentive to the many Negro graduates that finish school each year. Unless there are Negro enterprises here to provide an outlet for the chosen professions and training of aspiring ambitious Negroes, there is little hope that Des Moines will ever establish its rightful place in the eyes of the Negro world as a progressive city.

"You Don't Print It Like We Write It"
The Bystander staff edits the news as all other newspapers do. No journalist will agree to print news matter until it is edited and rewritten in newspaper style; everybody was not trained to be writers and reporters, consequently, it is a narrow policy for people to criticize a staff for the disposition of its news copy to the best interest of its readers. Daily papers are even more strict in their rules of publishing articles, as many colored citizens have found to their deep disappointment.

Scottsboro Accuser 'Hunted' By Police

SCOTTSBORO, Ala.—A surprise motion by Irving Schwab, defense attorney employed by the International Labor Defense to squash the indictment against nine Negro boys charging an attack on two white girls, delayed action on another motion for a change of venue, as cases of seven of the boys were called for trial Monday.

Huntsville, Ala.—Police Tuesday launched an investigation of the apparent disappearance of Ruby Bates, one of the state's principal witnesses in the Scottsboro case, who repudiated her rape testimony in a letter to a boy friend last month, after the report the girl was missing gained credence.

Officers said they learned the girl left a week ago and had not been seen since, but they thus far had not been able to uncover a trace of her.

Case to Decatur
The death sentences have been reversed, and a change of venue for a new trial ordered in Scottsboro, Ala., Tuesday. Attorney General Thomas E. Knight Jr., of Alabama, opposed the change.

Judge A. E. Hawkins at Scottsboro granted the change of venue and designated Decatur, 75 miles west of Scottsboro, as the site for the trial, to be in June.

AMERICA WILL WIN

The bank crisis has hit everybody. Few people can explain the cause. For those who desire a clear explanation in concise language easily understood by the average citizen, it would be well to read Mark Sullivan's article in the daily newspapers of March 8, "Still on the Gold Standard."

In spite of the colossal collapse of our banking structure and the holidays proclaimed by the state governors and President Roosevelt, the public has been patient, quiet and reasonable exhibiting a patriotic desire to co-operate to the end that nobody will suffer unduly. This attitude is as unique as the financial situation.

But America is going to pull out of this situation and in order to do so it is going to require great ingenuity on the part of those upon whom the responsibility rests and the co-operation and confidence of the American people. America has met the crises which have befallen its citizens in the past with courage and ability and have won. There is no reason to doubt that this one will be an exception to the rule.

OUR SCHOOL SYSTEM

It is easy to criticize, but often difficult for others to do the job as well as those being criticized. Thursday, the school election will be held. While few speeches have been made so far, the situation will warm up as the time draws near.

What do the candidates offer? Are they for a continuation of our present system or do they propose a radical change from the situation as it stands? This the voter must determine in making his decision to vote.

We know that our school system stands A-1 today. Here and there some inequalities may exist, but what system is perfect? What business is perfect? None. And for this reason we are forced to the conclusion that our present system is good. Uphold it.

FARM AID

The Bystander has stated editorially on many occasions that the Negro was not only interested in a good farm bill, but also one from which Negro farmers may have some benefit.

Last week most Negro weeklies carried a story of amazing injustice and peonage unearthed by a United States attorney. It said:

"The practice of enforced labor and conspiracy is alarmingly prevalent in many cotton farming states. Armed with many specific instances of peonage, General Maddox will go to Washington at an early date to make his report. Just what tactics the government will resort to punish the plantation owners hinges on the Washington conference."

It will be difficult for the domestic allotment plan or any scheme of farm relief to be of any help to Negro share croppers as long as these conditions exist. So it will be important to the Southern farmer that the scheme operate from Washington with little authority vested in local officials.

ARTERIAL DISEASE

The purpose of the arteries is to carry blood to the lungs where oxygen is taken up for use by the tissues and organs. After the blood is sent back to the heart from the lungs by way of the pulmonary veins the blood bed stream is again constituted of arteries and every tissue and part receives its fresh supply of blood from arteries which become smaller and smaller as parts, tissues and organs are entered. Arteries are formed of tough material being next to bone in this respect susceptibility to harmful influence increases as the size of the artery diminishes. This holds good for almost every part of the arterial system there being one exception with which we are not here concerned. Which is to say that damage to the smaller arteries does not come about through pure weakness in the arteries themselves but through conditions which occur because of the small caliber of the arterial tube.

For instance a terminal artery will become plugged up by a particle which shuts off the circulation to the part so supplied. But such a particle would traverse the whole length of the larger arteries without a symptom and without becoming attached. These processes involving the lining of the arterial walls cause narrowing over quite an area but always cause symptoms first in the smaller arteries. Arterial changes for the most part insidious and a decided alteration has always taken place before any symptom has shown itself, explaining the frequency of paralysis which in some cases has not been preceded by even such an unreliable symptom as headache.

Because of this symptomless, insidious and frequently disabling and progressing course of arterial disease, knowledge of the existence of any condition causing arterial damage is necessary. Such a knowledge will prevent many paralytic conditions and practically all conditions which are caused by involvement of the smaller arteries.
