**WORKERS SEEK BETTER WAGES; SHOT DOWN**  
BIRMINGHAM, Ala., May 18.—Four Negro ore miners were slaughtered last week in a general attack upon the 8,000 now on strike against slavery wage disputes in this city.  
The four, George Bell, W. H. Ford, Rich Foster and Henry Whitt, were murdered by officers hired by the Tennessee Coal and Iron corporation. Bell and Ford were shot down Tuesday, Foster and Whitt, Thursday.  
**Many Are Wounded**  
Twenty or 30 more ore miners have been wounded. Machine guns have been set up around the company towns and around the mines, threatening the striking miners. Militia has been called out to support the mine officers. About 75 per cent of the strikers are Negroes.

#### Rev. Riley Begins Pastorate at Burns

**FORMER INDIANA MAN GETS DEGREE FROM FRANKLIN INSTITUTE**

Rev. S. M. Riley, Jr., youthful pastor of Burns M. E. Church, has been in the ministry for nine years, he told the reporter in an interview Wednesday. Born in Greenwood, S. C., he was graduated from Bristol High School, Bristol, Indiana, in 1922.  
He received his early education at De Pauw University of Greencastle, Indiana, receiving his A. B. degree in 1925, and later from Garrett Biblical Institute with B. D. degree awarded in 1930. He was conferred his Master's degree from Franklin Institute of New York City in 1927.  
**Star Athlete**  
During his school career, Rev. Riley won major letters in football, baseball, basketball and track, receiving many honors for his athletic prowess. Catcher on the varsity nine, guard and halfback on the eleven, and center on the quintet, were some of his accomplishments. A star track man at De Pauw, he ran the hundred in .09.9 and was the state's second best quarter miler with the time of 48.8. He also plays an excellent game of tennis.  
Ralph Metcalfe, Marquette's speedster, was coached by Rev. Riley when he attended the South Park M. E. Church in Chicago while a member of the Sunday School track team in 1928-29 where Rev. Riley was assistant pastor and athletic director.  
**Headed Denver Clubs**  
Coming from Akron, Ohio, Rev. Riley served two years as pastor of the Scott M. E. Church at Denver. While there, he was president of the Alpha Phi Alpha fraternity, member of the executive committee of the City-wide Ministerial Alliance (white and colored), and other civic organizations. He married Miss Varina W. Lane of Akron, Ohio, Sept. 5, 1932; she is a native Floridian, and also lived in Atlanta. They are residing at the parsonage at 913 Crocker Street.

**DEPRIEST INVESTIGATION DELAYED BY PRIMARIES**  
WASHINGTON.—(ANP)—The investigation by a house committee into the refusal of Representative Lindsay C. Warren, chairman of the accounts committee, to give service to colored patrons in the house restaurant, authorized under the DePriest resolution passed in the House May 2, will not begin until sometime after May 15, it was learned this week.  
The delay in the committee's start of the investigation was laid to the fact that two of its members were tied up in primary elections. The two committee members who were said to have been involved, are Representatives Francis F. Walter, Democrat of Easton, Pa., and Louis T. McFadden, Republican of Canton, Pa. Both are candidates for renomination.

#### To Strive for Goal of 400 in '34

The local branch of the N. A. A. C. P. is sponsoring its annual spring membership drive this month. Mrs. Lillian Scales, membership chairman, is in charge of the campaign for four hundred new members. A. P. Trotter, president, stated this week. In connection with this drive with others in progress throughout the United States, the history, achievement and purpose of this nationwide organization is published for the information of the Negro public and for the interest of prospective members. This bulletin is issued by the National office at New York City.  
"The N. A. A. C. P. began when a small committee was organized in 1909 following terrible race riots in Lincoln's home city, Springfield, Ill. White and colored, northern and southern, leaders of public opinion felt both races must organize and co-operate to bring about better understanding, full opportunity and justice. In 23 years the N. A. A. C. P. has grown from a small committee to a nationwide organization, feared by oppressors, turned to by those in need of help and defense, the Negro's most powerful weapon for continued emancipation.  
The following reasons, important to 14,000,000 Americans, are why the N. A. A. C. P. exists: Lynchings; 10 in 1932. From 1882 to date—5024; Peonage; Jim Crow on railroads and buses; Disfranchisement; Denial of opportunity to work; Injustice in courts of law; unequal distribution of public funds for education; discrimination, segregation in public places.  
Common justice and equality of opportunity for the Negro are as essential for white America as for black America. The N. A. A. C. P. exists to defend and champion the full civil, legal and political rights of 14 million colored Americans and to obtain for them full equality of opportunity with all other citizens."

#### President Hears Anti-Lynch Bill

**WALTER WHITE GRANTED WHITE HOUSE INTERVIEW**  
WASHINGTON.—(CNS)—President Franklin D. Roosevelt granted an interview Sunday evening, May 6, at the White House to Walter White, secretary of the N. A. A. C. P., who presented him with the latest developments in the campaign for the passage of the Costigan-Wagner anti-lynching bill.  
Mr. White urged upon the President the necessity of the bill being voted on at the session of congress.

WASHINGTON.—(CNS)—The National Conference on the Education of Negroes, the first of its kind ever held, ended Saturday, May 12, after a three-day session during which Negro educators from all parts of the country conferred and discussed problems with prominent administration officials. The conference was called by Secretary Harold Ickes, of the Department of the Interior, to consider the fundamental problems in the education of Negroes. Mrs. Franklin D. Roosevelt who spoke to a large audience in the Bureau of Commerce auditorium at the second session of the conference Friday, May 11, predicted that "we shall all go down together unless we all go ahead together."  
Mrs. Roosevelt addressed the session presided over by Dr. Mordecai W. Johnson, president of Howard university. She was presented to the conference by Dr. George F. Zook, United States commissioner of education. Tarlier President Roosevelt had expressed his wish for the success of the conference both from the viewpoint of the Negro race and the nation as a whole. The President's message was contained in a letter to Dr. Zook which was read by Dr. Ambrose Calver, senior specialist in the education of Negroes, who had general charge of the conference.

#### Julius Taylor, 70, Noted Editor, Dies

**ESTABLISHED CHICAGO'S FIRST NEGRO NEWSPAPER**  
Chicago—Julius F. Taylor, veteran Chicago newspaper man, 70 years of age, died Thursday, May 10th, at the home of Mr. and Mrs. Harris B. Gaines, 3262 Vernon avenue, Bohn in Virginia, he moved to Salt Lake City in 1895 and started what was later destined to be Chicago's first Negro newspaper, the Broadaxe.  
In 1899 he moved this publication to Chicago, where it was published weekly from that date (without missing a single issue), until illness and failing fortunes in 1931 forced him to lay aside the pen that had for so many years affected, created and influenced the political, civic and social life of this community.

#### Pearl Gray Faces Ten-Year Sentence

**P. O. CLERK AND SOCIETY MATRON CONVICTED OF PILFERING MAIL**  
Washington.—(ANP)—Convicted of embezzlement and conversion of money taken from "dead" letters, Mrs. Pearl Gray, socially prominent Washington matron and former postoffice employe, faced a sentence of from one to ten years in jail this week.  
The verdict, delivered by a jury of twelve white men last Thursday afternoon, climaxed a dramatic two-day trial sparkling with spirited verbal flashes and featuring many of the most prominent citizens of the nation's capital as witnesses for the defense.

#### Death Takes French Leader

**DIAGNE, FRANCE'S ONLY BLACK DEPUTY, DIES**  
Paris.—(ANP)—Blaise Diagne, Senegalese deputy in the French parliament, died Friday, May 11. He had been ill for several months, having retired from the chamber of deputies last winter to rest at his country estate. M. Diagne received worldwide notice in 1931 when he became the first Negro to sit in a French cabinet, having been appointed undersecretary of state for the colonies by Premier Laval.  
During the World War he was French high-commissioner for Senegal and had charge of the recruiting of Senegalese soldiers to fight for France. His services received tributes from former Premier C. L. de Lasteyrie and former War Minister Poincaré. Diagne is the only Negro to ever win the Goncourt prize in literature. His novel, "Batouala," was awarded the prize in 1921.

**"IN ABRAHAM'S BOSOM," WELL PRESENTED**  
"In Abraham's Bosom," Pulitzer prize play, was presented Monday evening at the Jewish Community Center to a large and appreciative audience. Jack Smith played the title role, supported by Marie Knowling and Margaret Ward.  
The play concerned a Negro idealist whose ambitions exceeded his possibilities. The tragic ending of Abraham was impressive; Everett Newcomb and Hunter Matthews, contributed excellent portrayals of the parts.

#### Negro Taxi Driver Is Held for Murder

**PUNCHED BLUE BLOOD WHO CALLED HIM "DIRTY NIGGER"**  
New York City (CNA), May 12.—John Porter, 26, Negro taxi driver, was arrested Friday and held for a hearing on charges of homicide after he had punched Tyler C. Gronson, a wealthy clubman, for threatening him and calling him a "damn dirty nigger." According to the police report, Gronson, who had insulted him and then tried to attack him, had been fatally injured by Porter, who hit him in the jaw after Gronson and a friend who was riding in Porter's cab asked to be let out.  
On the sidewalk, the rich broker and clubman kept calling him "dirty nigger" and advanced threatenly at Porter. Both white men, southerners, were drunk, witnesses said. Gronson was punched in the jaw in the ensuing scuffle. Refusing medical aid, he died several hours later at the hospital. Porter is held on \$5,000 bail for a hearing May 19th in homicide court.

# Communists Banned for New Alabama Mining Trouble

## COME REDS FOR THE TROUBLE

Miners Turn World Newsman Back from Area; 2 Negro Workers Shot in Fray

SITUATION IS TENSE

BIRMINGHAM, Ala., May 10.—Alabama National Guardsmen were placed in charge of the Red Mountain mining sections Wednesday after a fierce clash between strikers and deputies in area Tuesday night. Two Negroes were killed and six deputies were shot in the skirmish. The dead are W. H. Ford and George Bell, both striking miners who were found dead beside the highway after deputies opened fire with a Thompson sub-machine gun into a crowd of miners.

The deputies claimed that they were fired on from ambush while they were rushing into the area on a gasoline car. A group of miners, assembled along the highway leading into the Iakodah mines, were armed to the teeth, according to the deputies' story. One white miner was shot in the thigh. Allen Hedden, white, a miner of the Woodward company, received wounds in the leg. A reporter of The Birmingham World was forced to stop after driving near the scene of the firing by logs across the road. He was not fired upon, however, and after being recognized by the miners was allowed to turn around and come back to the city. He reported an orderly crowd blocking the roads to prevent anyone entering the area.

Three Negroes brought to the Hillman hospital for treatment stated that they were sitting on the railroad when a squad of deputies fired into their midst without warning. Those treated were James Marshall, Dan Mayfield, and Josh English. They all denied any participation in the alleged shooting by the deputies. Blame for the hostile attitude of the miners was placed on Communist agitation in the mine area and that the men were told to fight for their rights. Immediately following these charges a special squad of policemen were appointed to break up Communist activities in the district. Five white men and a Negro woman were arrested and charged with being the brains of the local branch of the Communist party in this district.

The commanding officer of the National Guard, Gen. J. C. Persons sent a troop of guardsmen into the area to quell the disturbance immediately after he was notified of the shootings. The men were armed with rifles, machine guns and tear gas bombs. No further disturbances were found by the troop. The situation remains tense and turbulent and telegrams have been sent to William Green, president of the American Federation of Labor; General Hugh Johnson; Frances Perkins, secretary of Labor; and T. B. Brown, president of the International Smelter's Union, stating that the deputy sheriffs have fired murderous machine guns into unarmed and defenseless pickets, asking for immediate government action by V. C. Finch, Alabama representative of the American Federation of Labor.

The telegram further charges that there was no gun fired other than that of the deputies and that they were shooting innocent men without cause. An investigation was asked for by the miners union to prove their contentions.

## CME LEADERS BEG MOB BILL ACTION

ST. LOUIS, (ANP)—The General Conference of the C. M. E. Church in session here at the Seruges Memorial Church, Cook and Spring, in no uncertain terms spoke out against lynching. Dr. C. H. Tobias, of New York City, presented a resolution which was unanimously adopted. A committee was appointed composed of the following persons, to send a telegram to the President of the United States, concerning the Costigan-Wagner bill against lynching, which were C. H. Tobias, J. A. Martin, H. H. Humphries, J. A. Starks, J. D. Miller.

The telegram is as follows: "The General Conference of the Colored Methodist Episcopal Church in America now in session here sends greetings and prayer. God's richest blessings upon you. We remember with deep appreciation your strong word against lynching addressed to the Council of Churches and now that the Costigan-Wagner Anti-Lynching bill is before the Senate we earnestly urge you to use your personal influence to have the bill brought to a vote before Congress adjourns."

## Rev. Gholston Veteran A.M.E. Leader Dies

ATLANTA, Ga.—Funeral services for the Rev. G. W. Gholston one of the oldest settlers of Doraville, Ga., who died Thursday afternoon at his home, will be held Sunday afternoon at the Mt. Carmel A. M. E. church at that place.

Rev. Gholston, who was 78 years old, was one of the veteran ministers of the A. M. E. connection and noted for always raising his quota. For six years he was pastor of the New Hope A. M. E. church at Buckhead, Ga. Other pastorate has included churches at Doraville and Winder, Ga. Both Bishops Flipper and Fountain have expressed keen regrets at the passing.

At the time of his death he was a trustee of Morris Brown college. The pioneer minister was the father of several well known churches, the Rev. T. T. Gholston, pastor of the Travelers Rest church of this city, H. A. Gholston, a great worker and member of the Senior Steward Board at Big Bethel A. M. E. church, and J. F. Gholston, trustee of Cosmopolitan A. M. E. church and David Gholston, Detroit, Mich.

'Black Cabinet' Author Says ANP Changed His Article on Clark Foreman

## STATES REAL VIEWS

WASHINGTON (Special)—Charging that two thirds of the article on "Clark Foreman, White," appearing in papers throughout the country as the sixth in a series on "The Black Cabinet in the New Deal" was not written by him, unauthorized by him and contrary to his views on the matter, Eugene Davidson, Chief of the Washington Bureau of the Associated Negro Press has severed his connections with that organization.

The column, originated by Captain Davidson and subtitled "The Inside of the Outer Circle" was released by the Associated Negro Press Articles have already appeared on Robert L. Vann, Henry A. Hunt, and Eugene Kinckle Jones.

According to Mr. Davidson, the Associated Negro Press wrote him that they were holding the Foreman article to await his (Davidson's) judgment as to the advisability of releasing it. Davidson immediately replied saying that he thought it had no policy not to release the Foreman article. "Because Foreman had behind him powerful influences," he said, "I might be concluded by some that the influences are able to reach the Associated Negro Press."

Without awaiting that answer according to Davidson, the leading paragraphs of the Davidson article were used, two thirds of the original article omitted and article played the "Adviser" as the whole release under the name of Eugene Davidson. The article appearing last week on Clark Foreman was laudatory and sympathetic, while the original Foreman played the "Adviser" as "a dangerous leader for the colored race." The printed article sought to justify the position of Foreman as being worthwhile; the original Davidson article called "the appointment of Clark Foreman a mistake which leaves the race a little better off and which leaves Dr. Foreman in a pitiable position."

According to Davidson the following wire was sent to the Associated Negro Press when the article appeared in print: Release under my name of portions of Foreman article not written by me and contrary to my views, unethical, unfair, and definitely libelous. In justice to myself must use every means to protect my name. Regret a break in relations so am suggesting issuance of alternative: Release for next week portions of article omitted with explanation that last portions of this week's release not written by me. Kindly accept or reject this proposition by 3 p. m. Saturday.

Davidson says he received no answer to this wire. He immediately sent to Chicago his resignation from the staff of the Associated Negro Press.

The censored portions of the release are as follows: Clark Foreman is still on the payroll of the Rosewald Fund, as his secretary. Dr. Weaver said partly by the government and partly by the Rosewald Fund. The other office assistant is paid by the government. The appointment of Clark Foreman was not entirely satisfactory to the race. The N.A.A.C.P. sent a protest to the Department of Interior and newspapers throughout the country protested vigorously against the placing of a white man in a position of advisor on Negro affairs. But certain so-called leaders of the race had agreed that their race should be led by a white man—and there he is. The appointment of Clark Foreman was a mistake, a mistake which leaves the race but little better off and which leaves Dr. Foreman in a pitiable position. The time has come in the history of the race when it is never necessary to go out, the race to find men sufficiently educated and efficiently efficient and patriotic to advise on Negro affairs. The few colored persons who still believe that a white man is needed to properly advise either the race or others on the race, deserve the hearty condemnation of legal Negroes—even white men. Within themselves, condemn such weaklings. Dr. Foreman, himself, was hesitant about calling the names of the colored men who selected him. He said he would rather for the information to come from them. Moreover, no white man can properly feel the needs and aspirations of the race. Few white

## Shot In Back By Lover, Woman Says "Accident"

MEMPHIS, Tenn.—Sally Reed, 27, of 159 Gobeil alley is at General hospital with a severe bullet wound in her back as a result of what she told police was an accidental shooting Tuesday evening at her home. Despite the fact that Miss Reed claims the affair was not caused by a quarrel, police are seeking George Owens, her lover, who fled after the shooting.

According to her story to police Owens, whom she said lived with her, brought home an old pistol Monday. On Tuesday evening he asked her for the weapon and when she gave it to him, he started loading it.

At that time, Miss Reed, stated she sat down to fix her hair with her back to Owens. An instant later she said she heard a loud explosion and felt a sharp pain in her neck.

As she staggered up from her chair Owens grabbed his hat and ran out of the door. Neighbors, hearing the shot, called police. Two instances of the way his mind works on the race question are pertinent. When the selection of four men to do the preliminary work on a survey of white collared Negroes, one chosen, I believe by Dr. Foreman, was Dr. Sanders an Armenian. Shortly after the appointments Dr. Foreman said to me that the fact that an Armenian was in his office should quiet criticisms that he was in favor of segregation. The speaker also revealed how she built Packard and Rockefeller halls after returning north to secure funds from a friend.

In contrast to the aggressive Miss Packard Miss Finley pictured Miss Giles as soft and gentle, as the summer winds, appealing to all who met her. Miss Giles was credited with beautifying the building and grounds and organizing the teachers' department. To the third member of the "rearing trio" Miss Tapley, she accredited the making of Spelman from a normal school into a college.

After paying tribute to graduates who have gone forth into various fields, and succeeded, Miss Finley defined the Spelman spirit as "service to humanity, at any place, at any time without thought of self."
