Des Moines Boy Returns from China

Harold L. Bennings, son of Mr. and Mrs. Walter A. Bennings, 1145 Enos Avenue, who has been in Shanghai, China, since December, returned home Sunday morning for a two months' stay. He was graduated from North High in 1930 and went to Seattle, Washington, the following year. Bennings was appointed captain of the Negro Crew of the Alexandria steamship lines which sailed for the Orient last winter. He toured the eastern part of Asia, Japan and several Pacific Islands.

He visited with Everett Wadsworth at the Bystander Monday afternoon where he recounted his experiences in the far East. "China is a beautiful country, but the war has left much misery and want in many communities," he said. He told of the miles and miles of war torn desolation and the destruction of the Great Wall of China. "Race prejudice is practically unknown there," state Bennings. "Every nation in the world is represented in Shanghai and there is no difference. A Negro is either worshiped as a God or a devil."

Bennings has traveled the entire Pacific Coast of the United States from Alaska to Mexico working on steamers and in the railway service. He will return to Seattle for a world cruise with the same company.

Editor Center of Bitter Criticisms

EDITOR'S STAND ON SEGREGATION OPENED RIFT WITH THE N. A. A. C. P.

New York—The rift between Dr. W. E. B. DuBois and the N. A. A. C. P. has widened into a chasm with the resignation of the veteran editor of The Crisis from the association according to information that was made public Tuesday, June 12. J. E. Spingarn, chairman of the board has authorized the resignation of Dr. DuBois:

Break Came in January

The struggle between Dr. DuBois, who is regarded as one of the greatest scholars among American Negroes, and other elements in the leading militant Negro group has been the source of much interest for some time. It began in January, when Dr. DuBois, in his editorial column "Postscript" in The Crisis, took a stand favoring voluntary Negro segregation. This stand was opposed by many board members.

Dr. DuBois' position is that in his youth he had hoped that with the advent of Negroes no longer underprivileged, white discrimination would cease, that it had not ceased but grown stronger, and that the only thing to do now is to stop crying out against discrimination and face facts. His way of facing facts is to advise the Negroes to be as nearly independent as possible, with their own shops, schools, banks, insurance companies, hospitals, and everything else wherever feasible. For the past two years Dr. DuBois has been teaching as guest professor, at Atlanta university.

Board Objects to His Policy

A vote taken by the board of directors at its May meeting precipitated Dr. DuBois' action according to the text of his resignation. The board went on record as favoring the policy that no salaried officer of the association should criticize the policy, work or officers of the association in the pages of The Crisis, and that any such criticism should be brought directly to the board and its publication approved or disapproved. "I have not always been right," the editor says in his resignation, "but I have been sincere, and I am unwilling at this late date to be limited in the expression of my honest opinions in the way in which the board proposes."

Mississippi Adds 2 to Lynch Total

WILKINS PROTESTS BARBARITY TO PRESIDENT AND DIXIE SENATOR

New York—Immediately after word was received here that two more men had been lynched in Mississippi Friday night, Roy Wilkins, assistant secretary of the N. A. A. C. P. sent wires to President Roosevelt and to Senator Hubert Stephens of Mississippi. Mr. Wilkins was spurred to activity, not only because of the heinousness of the crime, but also because much of the opposition to the Costigan-Wagner anti-lynching bill has come from Mississippi. Senator Stephens was reported in the press to have stated that the bill would only be passed "over his dead body." He is one of the chief obstructionists who seeks to keep the bill from coming to a vote at this session of congress.

In his wire to President Roosevelt, Mr. Wilkins directed attention to the opposition of Senator Stephens to the anti-lynching bill and urged upon the President the necessity of insisting upon a vote on the bill prior to adjournment of the present congress. The lynched men identified as Isaac Thomas and Joe Love were taken by a mob when they were being transported from Greenwood to Clarkwood, Miss., by officers. The mob disarmed the officers and hanged the Negroes from a railroad trestle. Officers said the pair confessed to an attempted attack of the wife of a Sledge, Miss, plantation manager. The lynching occurred near Alligator, Miss.

Washington Okays Cafe Discrimination

RESTAURANT CLOSED TO PUBLIC; OPEN ONLY TO CONGRESSMEN AND GUESTS

Washington (AP)—That there is not, and never has been, any policy of racial segregation as such in the restaurant of the Capitol building here was the startling conclusion reached by majority members of an investigating committee appointed recently to look into the alleged jim-crow policy of the house restaurant. Representative Lindsey Warren, chairman of the House Committee on Accounts, is said to have issued orders to the effect that no colored persons should be served in the restaurant except when accompanied by Representative DePriest.

Overlooking much of the evidence brought before them and carefully evading the real issue by drawing up their report so that it pertained only to the members' dining room, rather than to the room that is supposedly open to the public, but from which colored persons have been systematically barred for the past several months, majority members of the committee, headed by Representative Miller of Arkansas, reached the following conclusions:

"The committee on accounts has delegated to its chairman, Mr. Warren, the duty of making and enforcing rules for the management of the restaurant. The restaurant was established for the use and convenience of members of the house of representatives. It is not a public restaurant nor was it intended by the house that it should be operated as such. It is now operated, as it has been since it was first established, for the use and convenience of the members of the house and there has been no discrimination in serving the members of the house or their guests."

Two Local Negroes Pass State Bar Examinations

Out of a class of 69, fifty-eight candidates passed the state bar examination held last week at the state house.

J. Nelson Thompson, 1919 Tenth St. and Melvin Carl, 827 Ninth St., Negroes, were among the successful ones that can now be addressed as "attorney-at-law" Nelson Thompson. Mr. Thompson, formerly of West High, graduated from Drake University in 1929. He played in the band and orchestra for five years and received his degree from the College of Liberal Arts.

LOCAL NEGRO DEMOCRATS TO MEET HERE JUNE 26

President Quentin Mease of the Roosevelt Negro Democratic Club announces an open meeting at the Negro Community Center Tuesday, evening, June 26. At this time candidates for public office in the fall elections will be invited to speak.

As a feature of the club's activities Mr. Mease states that the fourth Tuesday in each month will be devoted to public questions. Music will be included in the evening's program.

Chas. Ruff and the late Atty. H. R. Wright established "The Monitor" shortly after 1909 but it was short lived. The "Avalanche" edited by A. S. Barnett and located in Iowa Loan and Trust Building was founded in 1892 but died a slow death after "The Iowa State Bystander" came into being. He is now living in Chicago with his brother, Ferdinand Barnett, former assistant state Attorney General.

Four Negroes on Center

The Bystander sponsored an excursion to Savannah, Mo., in July of its first year, Mr. Ruff said. The population of Des Moines at that time was about 60,000 with colored people numbering about 1,500. Only four Negro families lived on Center street from the river to Woodland cemetery! They were Archie Brown, 1210 Center, Walter Birney, 1212 Center, William Coalsen, and Wilson Hughes, Twenty-first street. Mrs. Birney, now Mrs. Alex Wilburn, is the only one surviving.

Retired

"I came out on a strike for the eight hour day in 1908 and have never returned to the printing game since," concluded the veteran journalist. Mr. Ruff, retired, is active in local politics and municipal affairs, and has a variety of friends and acquaintances reaching from coast to coast.

Morris Succeeds Thompson

John L. Thompson, '99 graduate of Drake University took over the paper in 1909 and bought the Ruff brothers' interest, where he remained as publisher until 1919, at his death in 1930 he had resumed his law practice. Attorney James B. Morris, present editor and publisher, assumed charge in 1920. Mr. Morris, World War veteran, had just returned from France with the 366 Infantry overseas, where he was cited for bravery as lieutenant.

The young attorney, a graduate of Hampton Institute and Howard University, was born and reared in Georgia. He is probably one of the best known attorneys and influential persons in the state. Mr. Morris is a recognized leader in the community and is esteemed as one of the higher type Negroes in the country.

Three Churches

St. Paul's A. M. E., 2nd and Center, East Side, Colored Baptist, 2nd between Court and Walnut, and Burns M. E., E. 6th and Des Moines, were the three Negro churches. Sam Mash, Willie Foster and I. E. Williamson, Dr. E. F. Johnson, deceased, and Dr. Edwards, now living in Omaha, were the Negro physicians. Three colored policemen were Clay Lewis, George Taylor and Ira Lewis, all deceased.

Negro Printers

No five story buildings other than hotels and public buildings graced the Iowa's capital city skyline before the war with Spain. The Register and the Leader, morning papers, and the Capital and the News, evening, were the dailies. Four Negro printers worked at the Register, Sam Burroughs, Ed Newsome, and the Ruff brothers. Luther Bledsoe, employed by the Pumphrey Linotyping Company, was the first Negro operator in the city. He died in 1910 in Chicago, while working at the Record-Herald.

Lots of Work

"Work for colored people was plentiful then," Mr. Ruff told the writer. Negroes had the exclusive barber business and all hotel waiters were colored. The rich people who lived in the loop employed only Negro chauffeurs. The hotel head porters were Tom Blagburn, Savory; Dick Windsor, Kirkwood, and Charles Topson, Aborn, later the Iowa House.

Douglas Miller, now at the State House, was head waiter for the Savory, Firman Brown, Kirkwood and

Horace-Louis, Aborn, Alex Wilburn, now retired fireman, G. L. Holt, now A. M. E. minister, I. E. Williamson and Miles Bell were the four Negro mail carriers.

Street Cars

In general, Mr. Ruff told of the three colleges, Highland Park, Drake and the Baptist, and East and West, the only high schools in the city. The Central Fire Station, located at the present site of the city market, had two horse-drawn fire apparatuses. The electric cars had just been installed shortly before, he said. Valley Junction was unknown then, as the Rock Island yards were located at Stuart.

BATTERING DOWN THE BARRIERS OF PREJUDICE

The Fight on Parker; Mobilizing the Vote

On April 19, 1930, the Greensboro (N. C.) Daily News quoted a speech by Judge John I. Parker, the Republican candidate for Governor of North Carolina, in which he stated that the Republican State Convention, when it accepted the nomination of Judge Parker, was doing so on an understanding that the North Carolina constitution in 1901, which provided for the payment of a poll tax, for literacy tests and for the inclusion of a grandfather clause, all these clauses of the amendment being designed to eliminate Negroes from voting. Though the grandfather clause had been held unconstitutional by the U. S. Supreme Court in 1915, as a result of litigation in which the National Association for the Advancement of Colored People had taken an active part, Judge Parker expressed his approval of this clause in the North Carolina constitution, saying:

"The Republican Party in North Carolina has accepted the amendment in the spirit in which it was passed and the Negro has accepted it. I have attended every State Convention since 1908 and I have never seen a Negro delegate in any convention that I attended. The Negro class does not desire to enter politics. The Republican Party of North Carolina does not desire him to do so. We recognize the fact that he has not reached the stage in his development when he can share the burdens and responsibilities of Government. The participation of the Negro in Politics is a source of evil and danger to both races and is not desired by the wise men in either race or by the Republican Party of North Carolina."

Ten Years Later
In March 1930, exactly ten years after this speech, the philosophy of the unconstructed South, Judge John I. Parker was nominated by President Hoover to fill a vacancy on the United States supreme court. Having been chosen, six cases affecting the fundamental citizenship rights of Negroes and knowing this august body to be the most vital bulwark of such rights, the Association of

White Citizens' League, which had once realized the danger of having an Negro on the supreme bench, a man holding such reactionary views as those of Judge Parker. The national office telegraphed Judge Parker on March 26, 1930, asking if the Greensboro Daily News had correctly quoted Judge Parker's speech. Judge Parker failed to reply to the N. A. A. C. P. then urged President Hoover to withdraw the nomination, citing as precedent the withdrawal of President Taft of the nomination of Judge Hoek on February 3, 1912, after protest by the Association.

President Hoover ignored the Association's complaint, however, because he was evidently committed to the ill-white policy, as evidenced in his "Elihu Root" message to Congress, in which he declared that the Negro should be segregated, to placate southern white sentiment and win support for the Republican party in Dixie by sacrificing the Negro and his rights as an American citizen. The N. A. A. C. P. then began an active campaign to defeat Judge Parker, to elect a Negro to the Supreme Court. When a sub-committee of the Senate, judicial committee took up the nomination, Walter White appeared before it on April 3, presenting a memorandum setting forth the rights of Negroes and the appointment of Judge Parker, saying it constituted an open, shameless flouting of the fourteenth and fifteenth amendments to the Constitution, and holding that a man who had political connections with the Ku Klux Klan, and who had advocated amendments to the Constitution to put to rest the highest tribunal of the nation.

Swinging Into Action
It being evident that President Hoover intended to appoint Judge Parker, the N. A. A. C. P. decided to secure confirmation of Judge Parker's appointment by the N. A. A. C. P. began mobilizing back and forth on the pending fight. The national office communicated with the N. A. A. C. P. branches in the Negro world with all church, fraternal and other bodies, with prominent individuals black and white, and with national leaders. In response to this appeal, an avalanche of telegrams, telephone messages and letters cascaded upon senators from northern and southern states. Senator after senator, hastened to assure the N. A. A. C. P. that he would oppose Judge Parker's confirmation. As a direct result of this mass protest, the Senate Judiciary Committee voted 19 to 9 to report against confirmation of Judge Parker's nomination.

Armed by this militant opposition, the Hoover administration intended to force the issue by means of a veto. However, to succeed in this, the Governor of North Carolina designated Negroes had voted for Parker in 1928. This the Association of White Citizens' League had been to the point where Negro leaders' promotion of their program, promptly abandoned to the press. RACE PROBLEM IN SOUTH AFRICA IS DIFFERENT

CAPE TOWN, South Africa.—(Special to ANP)—The black man's labor had been and is still the life blood of civilization in South Africa. Without black labor South Africa would tumble to pieces. This is the opinion of Dr. A. J. M. O. C., one of the speakers at the "South African Race Problem" conference, which is being held at the Spelman College campus, and the students and staff are being housed in the dormitories of Spelman College.

In connection with the session, a series of lectures is being conducted at the Gannon Theological Seminary where pastors and other religious workers, irrespective of denominations, are being offered courses in the fields of Bible study, sermon building, missions, religious education, organization of church activities, English, economic conditions, health, and sanitation. Registration for this institute will open today in Third Hill Hall on the Gannon campus.

Distinctly low, on the other hand, are the wages of a native throughout the country. What ever they receive, however, is found strictly in accordance with the law of supply and demand. Except for about 14,000 natives in the Cape Province, who under an old law relating to educational and property qualifications have the right to a parliamentary vote, the native races in South Africa are voteless. The Coloured people, except in Cape Province, where they have full rights, are also voteless.

Dr. Wright, who is the official editor of the Christian Recorder, the official organ of the African Methodist Episcopal Church, and the oldest Negro newspaper in America, having been published continuously since 1852. Dr. Wright was appointed editor of the Christian Recorder in 1909 by the Publication Board of the A. M. E. Church in the capital town of N. T. J. Johnson in the same year. CHEAT 62,000 NEGRO COTTON GIN WORKERS

Call Them "Farmers" To Dodge NRA Pay Boost, Protest Says
New York—Classification of 62,000 Negro workers in cotton gins as agricultural workers denies them any benefit under the NRA, according to letters of protest mailed this week from the N. A. A. C. P. to Secretary of Agriculture Henry A. Wallace and officials of the Agricultural Adjustment Administration. The letters signed by Roy Wilkins, assistant secretary of the N. A. A. C. P., declare that the work in cotton gins is highly mechanized and that the labor in the gins is actually industrial labor and should have NRA pay. From September 11, 1933, until May 8, 1934, the association contends, this labor was recognized by the NRA, the AAA, and the National Ginners conference as industrial, but on the latter date the ginners suddenly changed their minds and passed a resolution stating that gin labor was not industrial, whereupon their application for a code agreement under the NRA was withdrawn.

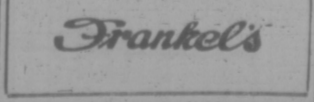

Those advocates of segregation who do so as a matter of expediency forget that occasions of this kind are bound to arise; that those favoring segregation take these same arguments "for expediency" to sustain their point that segregation should prevail on all occasions.

Responsibility for the action of the committee must be placed squarely on the democrats—not all southern democrats at that. However, all hopes are not lost because the republicans submitted a minority report and Mr. DePriest will make an effort to have it adopted instead of the majority. Some democrats will support it. Fortunately, these votes get the Congressmen on record as well as serve to show the outside world that we lie when we boast of our freedom and equality.

Mr. Garton reports conditions practically the same in Europe as here at home. Many people being unemployed and receiving help from charity.

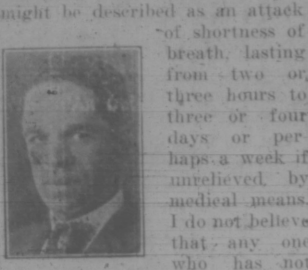

Health Talks

Dr. H. H. London

ASTHMA



Asthma is a disease which might be described as an attack of shortness of breath, lasting from two or three hours to three or four days or perhaps a week if unrelieved by medical means.

I do not believe that any one who has not suffered from an attack of this kind can ever understand just what agony the sufferer undergoes until the attack is relieved.

A good many sufferers have attacks in rainy weather or on changing beds, or on changing climates, as in traveling from one state to another, and many have attacks at any time, regardless of weather or change of climate, which seems to be due to a sensitivity to feathers contained in pillows or mattresses or to a sensitivity to certain foods.

In any case of Asthma there is always a doubt as to just what is the agent which precipitates the attack. But this can be determined by a series of tests which permits a positive diagnosis and a course of treatment which is sure to bring about a cure.

As far as an attack is concerned, it can be relieved within a half hour, but the treatment for permanent relief entails a series of treatments, lasting three or four weeks. Asthma, in appearance, calls for a watchfulness for any symptom of beginning Asthma in the offspring, for timely treatment in the offspring will ward off disabling and miserable periods.
