NAACP Asks Congress To Probe NRA and AAA Treatment of Negro Race

Two Scottsboro Boys are Granted Another Stay of Execution

Montgomery, Ala.—The Alabama supreme court granted a stay of execution Monday to Heywood Patterson and Clarence Norris, two of the nine defendants under death sentence in the Scottsboro case, upon receipt of application for a rehearing in their appeal.

The two youths were sentenced to die in the electric chair August 31. The supreme court on June 28 affirmed the death sentences imposed by a circuit court jury last December.

The court does not convene in regular session until October 1. Should the court reaffirm the death sentences the case will be appealed to the United States supreme court, a statement with the application said.

Judge Jordan Nominee For 9th District Bench

Municipal Judge Russell Jordan was nominated Thursday for sixth place, vacated by Judge A. A. Herrick, who is not a candidate, as a republican candidate for judge of the Ninth Judicial District.



Judge Jordan served as assistant county attorney under Vernon E. Seeburger. Following his private law practice later, he was elected judge of the municipal court. He is very popular with the Negro lawyers and local colored citizens.

Judges Joe E. Meyer, O. S. Franklin, Loy Ladd, Frank S. Shankland and J. J. Halloran the present judges were the other nominees of the convention.

Bishop Ransom is Called for Trial

New York.—Bishop David H. Sims has been called by the senior bishop of the A. M. E. church, the Rt. Rev. H. B. Parks, of Oakland, Cal., to return from his post of duty in South Africa to stand trial before a church court on charges filed by his wife before the Bishop's council at its meeting in Jackson, Miss., last winter. According to the most reliable information, the prelate, formerly president of Allen university, Columbia, S. C., had not yet arrived in America.

As the same reports have reached this city that the Rt. Rev. Reverdy C. Ransom, another bishop and chairman of the trustee board of Wilberforce university, will have to clear himself of a complaint filed by the Detroit A. M. E. Laymen's movement last February 14, and that the regular disciplinary body has been appointed to weigh the Detroit accusations. The date for neither of the trials is now known.

All-Negro Town to Use Ballot to Win Celebrate Founding

BOLEY, OKLA., 30 YEARS OLD IN SEPTEMBER

Boley, Okla. (ANP).—On to Boley for the thirtieth anniversary jubilee and homecoming celebration" will soon be on the lips of every Negro in the state of Oklahoma and the southwest, if the present plans of the 1,000 or more Negro citizens of the first all-Negro town in the United States are realized.

The object of the celebration is to commemorate the founding of Boley on September 22, 1904. Further, the city council hopes to create a renewed energy and civic pride among its citizens and to promote a more friendly relationship with members of their race everywhere.

The committee of 100 citizens of Boley has pledged to make the event the greatest affair ever conducted in the state of Oklahoma, and committees will enlist forces from every county in the state with the hope of bringing not less than 10,000 former residents and visitors to the town for the conclave.

Justice, Says Group

Oklahoma City, Okla.—Resolutions condemning the administration of New Deal policies as they affect Negroes, charging officials with meeting the appeals of colored people with indifference, and demanding a congressional investigation into the treatment of Negroes under the NRA were adopted here at the 25th annual conference of the National Association for the Advancement of Colored People.

Turning more than ever in its history to consideration of the economic plight of the colored people, the association in its resolutions, scores the administration of the federal farm program and asks the AAA to improve the lot of sharecroppers and casual farm labor.

A. F. of L. Scored

No discrimination in the employment of skilled and unskilled workers on building construction and other projects financed wholly or in part with federal funds, is demanded. Negroes are urged to join labor unions and seek to improve their lot as workers by collective bargaining while at the same time the leadership of the American Federation of Labor and the railroad brotherhoods are condemned for "continuing to weaken the labor movement by indifference to the exclusion or segregation of Negro workers from its local and international unions."

Lynching was once more denounced and a federal anti-lynching law asked of the next congress, with the assertion that in the last congress "small bloc of wilful obstructionists in the senate from states with the worst lynching records, under the unanimous consent rule of the senate, had prevented a vote on the Costigan-Wagner anti-lynching bill."

Opposed to Segregation

The resolutions endorsed unemployment insurance, old age pensions and the child labor amendment, called upon the U. S. department of labor to investigate the wages, hours and working conditions of domestic employees; affirmed continued opposition to all forms of segregation; condemned further prosecution of the Scottsboro cases; urged Negro citizens "everywhere to qualify, register and vote; and to combat every effort to prevent Negroes from voting by means of so-called 'white primaries' or in any other fashion."

Tuskegee Report Shows 6 Lynchings First Half of '34

According to the records compiled at Tuskegee Institute in the Department of Records and Research during the first six months of 1934 there were six lynchings. This is 2 less than the number 8 for the first six months of 1933; and 1 more than the number 5 for the first six months of 1932.

All of the persons lynched were Negroes. The offenses charged were: wounding—a man in altercation, 1; rape, 1; attempted rape, 2; associating with white woman, 1; striking man, 1. The states in which lynchings occurred and the number in each state are as follows: Florida, 1; Kentucky, 1; Mississippi, 2; Tennessee, 1; and Texas, 1.

ANDREW McCLOUD VICTIM OF LOUISIANA LYNCH MOB

Bastrop, La.—It's getting to be a habit in "dear old Dixie", Andrew McCloud, 26, was lynched here Monday night which "stormed" the county jail. He is said to have "confessed" to an attack on a young white girl. No investigation has been planned.

After stripping the man of his clothes, the "human savages" proceeded to the public square where they tied the victim to a tree as thousands of men, women and children cheered. A rope was strung around his neck and McCloud was placed on top of an auto and pushed off.

The first rope broke and the body fell to the ground; as the lynchers sought the second rope, one fend rushed up and slashed the dying man's throat. The body was hung the second time from an oak tree in the public square. District Attorney G. W. Hawkins is quoted as saying that he sympathized with the mob's attitude.

Landers May Not Die in Chair July 30

New York, July 13.—Mrs. Addie Exum, 40, of Port Richmond, L. I., who spent ten months in the shadow of the electric chair at Sing Sing for the murder of her husband in concert with the handsome Fisk student and athletic star, Lovell Landers, was freed on Monday last when Judge Thomas F. Cosgrove dismissed a first degree murder indictment against her.

The action of the court in freeing Mrs. Exum may result in the freeing of Landers who is awaiting execution for the killing of Mrs. Exum's husband in an insurance plot last year. He is scheduled to die July 30 unless Gov. Lehman intervenes.

An Italian girl who had been Landers' sweetheart testified that Landers had confessed his part of the killing to her and that he received \$400 for the job. The defense contends that the girl made up the story out of revenge for Landers throwing her over for a Negro girl.

U.S. Marines from Haiti in 6 Weeks F.R. Tells President

TELLS-ISLAND CITIZENS OF NEW PROGRAM

Cape Haitien, Haiti, July 13.—In his address last Thursday at the Union Club, to which he came ashore from the cruiser Houston which is taking him to the Pacific on his vacation, President Franklin D. Roosevelt spoke as follows, addressing his remarks mainly to President Vincent, who sat near him.

"Mr. President, I am very happy to come back to Cape Haitien. I shall always remember as long as I live the week I had the privilege of spending in the Republic of Haiti, I am glad to come back, especially at a time when the relationship between the Republic of Haiti and the United States will be restored to a basis of complete independence.

Praises Vincent

"I am glad that as a result of the visit of President Vincent to Washington, as he has so well said, two out of three points which we considered have already been consummated or are about to be consummated."

"Very soon, within a month or six weeks, I think, the last Americans who have served here with the Garde de Haiti and with the Marines will leave the Republic of Haiti. That is not all. I am very hopeful and very certain that when these Americans leave, your shores you will think of them with a spirit of friendship, and that you will be happy in the days to come remembering that they tried to help the people of Haiti.

Advocates Friendship

"And so when they go, Mr. President, I am certain also that you will carry on the same spirit of friendship between our peoples which must always exist in the future.

Christian Youth Council Names Negro as President

NEGRO WORKER TO HEAD COUNCIL

Negro Named President of Christian Youth Council of North America

MEET IN WISCONSIN

CHICAGO—(ANP)—Martin L. Harvey, Director of Christian Education of Youth for the A. M. E. Zion church, was elected president of the Christian Youth Council of North America at the close of its quadrennial session at Lake Geneva, Wisconsin, July 1. Mr. Harvey is also serving his second term as president of New York State Youth Council, the first member of the race to hold that position.

Other officers elected were Charles Hart (white) vice president, of Columbus, Ohio, representing the Methodist Episcopal church; Miss Jean Ross (white), second vice president, from Bloomfield, Ontario, Canada; Miss Frances Frazier (white), recording secretary, of Portland Oregon; and Miss Bess-Hunter Robinson, corresponding secretary of Chicago, Illinois, and representing the Christian Education Department Staff of the A. M. E. Zion church.

The Council composed of 150 young people and leaders, representing ten million Christian young people in the United States and Canada, worked on the youth program "Christian Youth Building a New World." The work of the Council was shared in by a large number of denominations, state councils, the Churches of Canada, the Federal Council of Churches of Christ in America, the International Society of Christian Endeavor, the Y. M. C. A. and Y. W. C. A. and the International Council of Religious Education.

The findings of five special commissions, which had been studying the essential problems facing youth in building a new world, were adopted at the closing session of the Council. The Commission of Friendship Between the Races, declared that "Although we recognize there are sociological problems connected with intermarriage, we understand that there are no biological reasons against it. We are opposed to legislation against it and social ostracism and persecution because of it." It urged that Christian youth groups should not hold conferences and meetings in cities, camps and hotels where complete fellowship across racial lines was prohibited. It also urged that Christian youth should boycott stores, restaurants, hotels and the like that practiced racial segregation and discrimination. In its closing statement of conviction, the commission declared that "the brotherhood of men will come only when we thoroughly recognize and appreciate the distinct values of each cultural group. We recognize and accept this as our own Christian, responsibility and task in the problem of friendship between the races."

Negro Letter Carriers Out Of High Jobs

SAVANNAH, Ga.—(Special)—Outnumbered by the number of white delegates in attendance for the first time since the Georgia Association of Letter Carriers was re-elected in 1928, Negro letter carriers were elected to office at the 1934 session of the organization.

M. P. Ott of Rome was re-elected president of the state association while Valdosta was named as the 1935 convention city. Among those speaking at the meeting were Alfred A. Ball and T. J. Brady of the Savannah postoffice, H. T. Tait of Columbus, and John P. Morgan of Nashville, Tenn., an officer of the National Association of Letter Carriers.

Other officers elected were L. H. Chambers of Atlanta, who succeeded John McIntosh, colored, of Savannah as vice president; W. M. Stockton of Columbus, who replaced J. W. Reece, colored, of Atlanta as secretary; a post Mr. Reece was held for nearly 7 years; and E. E. Smith of Cordele, who displaced E. P. Monroe of Valdosta as treasurer.

M. E. Davis, Dalton, who was a lone white representative on a board of trustees was retained in his old place while two other Negroes, E. E. Collins of Augusta and E. J. McDonald of Valdosta were named to serve on the board with him. Negro members on board who lost out at the election were N. A. Stranahan, of Union and W. H. Killian, of Atlanta.

FIGHT FOR CHURCH NOTES

Whitney Central Officials Interviewed, Admit Legal Proceedings Started

NEW ORLEANS, La., July 6.—Rev. R. W. Coleman, pastor of the First African Baptist church, left for Palestine Sunday night via New York. The pastor was given a rousing send off by his congregation as the iron horse steamed away.

Superstition, Not Lynch Try at Inquest, She Says

LOS ANGELES (WS)—When Mrs. Emily Martin, sister of Arthur Fitzgerald, threw a rope around the neck of Robert Fuller, pool room attendant, who killed her brother, it was not done with the intention of lynching him, but on account of a Louisiana superstition. According to reports in this city if the rope can be placed on the killer's neck, he will pay the supreme penalty for his crime.

The courtroom, at the corner was thrown into a mild uproar here last week when Mrs. Martin threw the rope around Fuller's neck. This action was thought to be an attempt to take Fuller's life after he had been found guilty of homicide.

Fuller's version of the killing is that he shot Fitzgerald in self-defense. The latter is said to have been using profane language in the pool hall, and when Fuller asked him to stop he threatened his life. This story is substantiated by witnesses and others assert that the killing was done in a wanton spirit.

Fitzgerald was a member of one of the best families in Los Angeles and has been here from some time. He is from Louisiana and is survived by a wife and children as well as a host of other relatives.

MRS. MC CULLOUGH AND BROTHER KILLED WHEN TRUCK HITS CAR

Prominent Memphis Widow and Brother Were On The Way Home After Visit At World's Fair In Chicago When Accident Occurred

HIGHWAY NEAR KANKAKEE, ILLINOIS SCENE

MEMPHIS, Tenn.—Mrs. A. M. McCullough, wealthy widow of the late A. M. McCullough was killed instantly as was her brother, Roy Bolton of Gary, Indiana, when the car in which they were returning to Memphis was struck by a heavy truck near Kankakee, Illinois, a telegram from Mrs. Stewart Taylor, 940 McDowell, revealed Tuesday.

The news came as a great shock to Mrs. McCullough's friends here. Mrs. McCullough had been in Chicago taking in the World's Fair and visiting with her brother, Mr. Bolton, and her sister, Mrs. N. E. Perkins, the latter formerly of Memphis. She had been in Chicago for two weeks and was being driven back here by her brother in his Chevrolet sedan at the time of the accident.

According to meagre reports received here, the sedan was struck when a huge textile truck met the smaller car head on, crushing Mrs. McCullough, and her brother, both of whom were riding in the front seat. Mr. Bolton is said to have been driving.

Mr. McCullough, the widow of one of Memphis' most widely known sporting men, had continued her husband's business, the Panama CAB company, and the Panama Club at 351 Beale avenue since his death in 1929. For the past year the taxi business was managed for her by Buster Davis.

McCullough, or "Mister Mack" as he was known by thousands of night life devotees here before his untimely death, was reputed to have been the wealthiest sportsman of his race in the state. His place on Beale was the rendezvous for the major portion of the club life here and his patrons included people of both races, it is said.

McCullough bought the Panama, famous wherever the gambling gentry forage for, from his partner,

Tom Dockery, many years ago. Under his astute management, the place made money. At one time his fleet of 12 cabs also proved to be a mint, and even until his death the cab company was a big money maker.

The fate of almost everyone connected with the Panama seems to have been one ending in violence. Mose Dandridge, an associate of McCullough, was killed by a bullet from the gun of a man who was struggling with another man. Dandridge tried to separate them and was killed. That was in 1927.

WOMAN FREED IN ODD MURDER

JACKSON, Miss.—(A. N. P.)—Judge W. T. Horton in police court last week dismissed a murder charge against Mrs. Beulah Courtney, growing out of the death of her husband, Howard, who was slain during a quarrel at their home two weeks ago on Valley street. The court concurred with the opinion of County Prosecuting Attorney W. R. Newman and City Attorney Walter Capers Newman told the court that the evidence in the case would not sustain the murder charges.

Courtney met his death in a peculiar manner. His wife threw an oil lamp at him during the quarrel in which he allegedly threatened to kill her and the missile broke against his head, the glass severing the jugular vein in his neck. He stumbled a few feet and then fell to the floor, dying before aid could reach him.

Perhaps Bill wants to know more about motormen and firemen and what they really do. Mrs. Kuh's books for small children will help him out there. Perhaps he would like "How It All Began," a book that is delightfully written and illustrated by Janet Simmley. It will tell Bill how primitive man watched the lightning and found he, too, could make fire by twirling two sticks around together. Later man found other ways of heating and lighting and at last we got our matches, gas, oil and electricity. The book goes on, in the simplest fashion, to show the beginnings of messages, of travel, clothing, houses. It is a thrilling sort of real fairy tale that particularly appeals to boys like Bill.

Travel Stories Are Good.

What happens to a real letter after it gets posted may also interest some of our very youngest readers. William Siegel, a Russian artist, tells a simple story about that in "Around the World in a Mailbag." Bob and Betty's letter to their father doesn't reach him in San Francisco. The pictures make this book especially attractive.

Presentation Speech Made By Wm. Pickens at Oklahoma City

Oklahoma City (ANP)—As the presiding officer at the Friday night meeting of the N. A. A. C. P. conference when the Spingarn medal was being awarded to W. T. B. Williams, dean of Tuskegee institute, William Pickens, field secretary, pointed out that one of the chief services of the medal award is to help rescue colored Americans from the "inferiority complexes" into which nearly every other thing in America tends to lead them.

He pointed out that segregation and "Jim Crow" tend to mark everything "for colored people" as inferior; that stubbornly prosecuted cases like the Scottsboro case and the Jess Hollins case (in Oklahoma) "are really persisted in by the prosecution, not because of mere vengeance against the individuals involved, but to prevent the Negro population from ever getting the notion that they can have their way against the great white world, whether the Negro be guilty or innocent,—to drive it into the Negro's nerve-system that he is really helpless,—that he might as well surrender when the white man is opposed to him.

Oklahoma City, Okla., July 1—Calling for an "unending" warfare upon segregation in all its forms and particularly upon lynching, Walter White, secretary of the National Association for the Advancement of Colored Peo-

ple, closed the twenty-fifth annual conference here Sunday with a fighting speech. The N. A. A. C. P. secretary said: "There can and will be no solving of the race problem, nor even any appreciable amelioration of it as long as this chasm of misunderstanding, of suspicion, of hostility, which segregation perpetuates and increases, exists."

Mr. White hailed the growth of liberalism on the race question in the South, declaring that young southern whites would be replacing in a few years, the older generation which has battened on race hatred and bigotry. It is the duty of Negroes, especially in the South, he said; to increase the number of those whites who are above race prejudice. Formal announcement that the fight for the passage of the anti-lynching bill would be continued in the next congress and pressed without pause was made by the N. A. A. C. P. executive as he cited eight lynchings of 1934, six of which he declared were staged after it became fairly clear that congress was going to side track the Costigan-Wagner bill.

Washington, D. C., July 6—Before leaving the White House for a month of relaxation in tropical waters, the President failed to make a recess appointment of any of the candidates seeking the judgeship now held by Judge James A. Cobb on the Municipal Court of the District of Columbia.

Wages in the camps are now being paid weekly, whereas they once were paid monthly and often not then, Mr. White said. The minimum wage and 30-hour week are strictly enforced and no deductions are made for commissary purchases which are not made. The three men are checking also on the treatment of Negro farmers and sharecroppers under the AAA and the TVA.

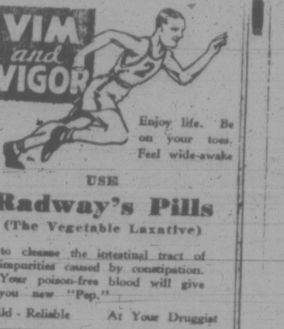

MAACP Tells About Defense of Soldiers

Stirring Chapters from the Twenty-five Year History of the National Association for the Advancement of Colored People.

As shown by its long and victorious fight for the imprisoned 24th Infantrymen, the Association has been ever alert to defend the Negro soldiers.

In 1914, it won freedom, after only six months imprisonment for one Private Anderson of the 25th Infantry, then in Hawaii, who had been sentenced by court martial to five years imprisonment for burglariously entering an army officer's home.

On February 22, 1916, it presented the Spingarn Medal to Major (later Colonel) Charles Young, U. S. Army, for distinguished service in developing the constabulary and the roads of Liberia. This recognition prepared the stage for the active part played by the N. A. A. C. P. in behalf of the 400,000 Negro officers and men who served during the World War and afterward.

It came to the defense of colored officers and men forced from Pullman cars and jailed in the South, and sought to make the War Department take active steps to prevent the outrages.

In April, 1918 it protested against the infamous order of Major General C. B. Calhou, advising colored officers and men at Camp Funston, Kansas, not to "go where they were not wanted" irrespective of their citizenship rights, to avoid alleged encouragement of race prejudice.

Nation-wide denunciation by press, individuals and organizations followed the Association's expose and War Department officials condemned the order.

Its protest to the War Department in September, 1918, brought prompt repudiation of a ruling that Negroes in the Students Army Training Corps should be residentially segregated and trained in distinctly Negro colleges.

Two months later it succeeded in having Col. Charles Young recalled from premature retirement, in spite of marked opposition, and assigned to active service at Camp Grant, Ill.

Although Surgeon General Gorgas strongly opposed their claims, several colored nurses who had been banned by the Red Cross, and the Army, were assigned to a few camps after the Association had waged a fight in their interest. They were, however, uniformly rejected for over-seas service because of lack of segregated quarters for them, which the War Department deemed necessary in accordance with its traditional Jim Crow policy.

Colored physicians and dentists found it equally difficult to get assigned to service as professional workers. Despite frantic public appeals for medical and dental men they were refused, although afterward these same men were drafted and sent as privates to the National Army. The Association finally prevailed upon the Surgeon General to assign colored medical officers to duty but they were placed only with Negro regiments.

An effort in October, 1918, to halt denial of the right to vote to Negro soldiers in Southern camps failed because of the refusal of War Department and the President to act in the matter despite personal conferences between N. A. A. C. P. officials and army authorities.

After the War the end of the war did not end the Association's fight on behalf of the soldiers. When in 1919, the family of a Negro soldier who had died in France found it impossible to secure his War life insurance, the Association took up the case, got considerable correspondence, got the matter adjusted and the man's family has received \$57.50 monthly ever since. The N. A. A. C. P. set forth many similar cases, where color discrimination was evident.

During the same year the Association sought to have colored officers who desired to remain in the service assigned to the regular army.

Personal representation was made to War Department officials and the Senate Military Affairs Committee, but without success. In 1920 an effort was made to secure provision for a proportionate number of colored officers and men in the army.

The newly formed American Legion was bought in 1919 to make a requirement upon state branches to regard to the admission of colored men. The Legion dodged the issue by giving each state organization the right to establish membership requirements.

The national office during the army demobilization handled many complaints of discriminatory treatment accorded colored soldiers in camps on trains in their home towns and by the Red Cross. Among the most active branches in this work were those of Columbus, O., Gary, Ind., Wilmington, Del., Nashville, Tenn., Chicago, New York City and Rockford, Ill. Many branches in various parts of the country held picnics for returned soldiers. The Annapolis, Md., branch fought to save

The McCallites had proposed that a primary board of two McCall members and two Church members, and an independent member be set up with membership denied specifically to Church, Lester Brenner and George W. Lee.

The telegram which refused the proposal was signed by C. H. King, Mrs. Elizabeth Scott, Joseph Marks, Mrs. Finis Wilson, Winsted Johnson, L. A. West, Lester H. Brenner, G. W. Lee, Billy Walsh, R. R. Church, George Klepper, Seneca B. Anderson, D. W. Marks, E. E. Pass, J. R. Wright and Dave Hanover.

The McCall forces thought they had again won a victory when the court issued a writ some time ago requiring the state board to appoint certain men, all McCall followers to the Shelby County board, or to show cause why this was not done, but this, according to opinion in some of the state "best legal minds, was just "one of those things."

Urban League Seeks to Aid Negro Worker

ATLANTA, Ga.—The Atlanta Urban League is in receipt of "ABC of Labor Problems," Primer for Negro Workers, the first in a series to be issued by the Worker's Council Series of the National Urban League.

It was in the spring of 1934 that the Department of Industrial Relations of the National Urban League realized the utter impotency of the Negro workers as a group to secure satisfactory recognition of their particular problems by the labor set up of the NRA, and realizing that in practically all sections of the country Negroes were either disproportionately out of employment; or, where employed, were in the least desirable jobs; and realizing that the only hope for increasing the organizing power of the Negro workers was to increase their class consciousness, and encourage them to become social and political workers, organize what is known as Workers' Councils.

These Councils are to be a kindergarten of labor education an organization through which the Negro worker might make his cause one with that of the masses of the American working population.

In its message the "ABC states that for 68 years the Negro worker has been appealing to America for a new deal in its treatment of the Negro. It also points out that although the cause of labor is getting much consideration, that the cause of the Negro worker has not been one with labor's general aims and appeals to the NRA and AFL have fallen short of the desired goal.

Because of this, the Urban League is sponsoring these Workers' Councils not as Negro labor unions but as active, aggressive units through which all Negro workers may gain full recognition within the regular unions, of the craft or industry, increase their power for collective action through which they may secure equal pay for equal work and participate in general program for the improvement of the status of all workers, white and black.

LYNCHINGS DECREASE

The lynch record for the first six months in 1934 shows a decrease over the same period in 1933.

There is just one reason why this is true. The N. A. A. C. P. made a vigorous fight to secure the passage of the Costigan-Wagner anti-lynching bill during the last session. It was defeated only after Senators Haey Long of Louisiana and McKellar of Tennessee blocked its passage. No doubt these Senators passed the word on to their good citizens to keep quiet until the threat blew over.

If lynchings decrease upon threat of the passage of anti-lynching legislation, it is reasonable to assume that the evil will be reduced to a minimum if such a law is enacted.

REPUBLICANS MUST CHOOSE

The republican state convention meets in Des Moines next week. Important on the program will be the nomination of a candidate for lieutenant governor, attorney general and secretary of agriculture; also the adoption of a platform upon which the campaign will be made.

Leaders might as well understand that a constructive program must be adopted; one that not only criticizes the democrats but offers something definite instead. Workers must unite behind their candidates if any degree of success is obtained in November.

The Bystander repeats its already often stated complaint that Negro voters have not been given fair consideration at the hands of republicans for several years. It made that complaint to Dan Turner when he was governor and while at times he said he recognized that such injustices existed, nothing was done about them.

We want to know now what the situation will be in the future. We want assurance not only from Turner but the other candidates who have much patronage at their disposal and can pass it out to whom they please. We insist that public institutions ought to take the lead in giving Negroes fair consideration in matters of employment because private institutions do not and cannot be forced to do so very well. In this matter we have the ballot; let's use it to advantage.

LABOR STRIFE

We are having a lot of labor troubles today—altogether too much. Much of it can be easily traced to some of our public officials who have been so anxious to make themselves dictators that they have failed to take into account the capacity of individual business institutions.

Here in Des Moines a few agitators with nothing at stake are making unreasonable demands upon relief agencies—insisting that they pay out more money than they actually have. Most people will admit that those agencies have done a pretty good job under the circumstances; that nobody who has made an effort has been allowed to go hungry and most people have been pretty well sheltered.

This agitation has been going on a long time; it will continue. The Bystander does not believe we are going to get very far by

Gentlemen: I have just been furnished a copy of the article appearing on the front page of your issue, June 22, 1934, and of the editorial on the back page of the same issue, the first being entitled "Negro Girls Are Barred From Y. M. C. A. Pool," and the second, "Poor Leadership."

I very deeply regret that you have seen this as an occasion to print this article in the form as set up and also the editorial. If these had been set out as news items, there could not possibly be any right on our part to object, as we have no disposition to avoid the facts.

However, your article is quite unfair, particularly to Mr. Frank Dillon, the new Y. M. C. A. secretary. The decision in this matter was not made by Mr. Dillon, and there is no reason why and there is no excuse for any complaint that he is "southern."

The Y. M. C. A. in Des Moines has done and will continue to do all that it can to create a happier interracial relationship between the Negro and the Caucasian races. The differences that exist are unfair prejudices, but in spite of that they are in too many of the people ingrained. They can not be eradicated except by a gradual process. The gradual process may be unfortunately slow, but as long as it is gradual and continuous, it is at least approximately an ultimate solution of the differences.

I have no quarrel with the natural impatience of the Negro at the delay in arriving at a solution, but it requires years of experience before one can realize that only by patient, continuous, unrelenting application to the task with contentment as long as progress is being made, the best results will be achieved. It is the purpose of the Y. M. C. A. in Des Moines to make progress certain and continuously progress in the adjustment of the interracial relationship. That can only be done by patient, tolerant progress. We have nothing but the highest respect for the excellent ladies of the Negro race. There is nothing but the highest regard due them for their character attainments, the same as among the whites, but we feel it is imprudent to raise an issue at this time in the cominging of the Negro girls with the white boys in the Y. M. C. A. pools.

Certainly, we may be mistaken, but it is equally certain that we are to be credited with having given the subject earnest attention with a desire to solve the problem and not in any sense motivated with antagonism or disparagement of the high character of the girls.

At least give us credit for having used our best judgment regardless of whether that best judgment was very good. We can only make progress by maintaining a sympathetic attitude for your people, and in spite of your article and editorial you will continue to have our sympathetic attitude, but we do think your article will unduly raise a question and issue that should not be in the picture.

METCALFE LEADS OPPONENTS TO TAPE IN BOTH 100- AND 200-METERS CHAMPIONSHIPS

Milwaukee (ANP)—High scorer in Saturday's finals of 47th Annual National A. A. U. championship meet here at Marquette university stadium, Ralph Metcalfe, husky speed demon which, on past performances by others, has no basis for comparison. He has won the National Collegiate, National A. A. U. Central Intercollegiate and Drake relay dash titles for the past three years. Nosing out the bid of Jesse Owens, Ohio State university freshman flash, by a scant half yard, Metcalfe scampers home in the 100 meters in 10.4, tying the record for the event set by Eddie Tolan of Michigan in 1932. Eulace Reacock, Shore A. C., Elberon, N. J., another septa runner, came in third.

Metcalfe, Marquette's captain, achieved the distinction of winning both the 100- and 200-meter races for the third successive year, tying the record of Bernie Wefers, coach of the New York A. C., who in 1905, 1906 and 1907 won both the national A. A. U. sprints. Metcalfe had a romp of it in the 200-meter dash, around one turn, winning in 21.3. The former Chicago prep then rounded out his busy afternoon by anchoring the Marquette university 400-meter relay team which set a new A. A. U. record of 4:14.0 seconds. Metcalfe was in second place when he grabbed the stick from Jimmy Jessel, but he zoomed for a one-

yard victory. Owens, who was denied in his effort to wrest sprinting honors from Metcalfe, established himself as the National A. A. U. broad jump champion with a leap of 25 feet, 7 and 8-10 inches. John Brooks, former University of Chicago "one man track team," placed third to the sensational Ohioan in this event. Brooks represented the Chicago Parks system.

Cornelius Johnson of Compton, Cal., Jurior college, the colored high jump luminary, was forced to share national honors in that event with Walter Marty, white, of the Olympic club, San Francisco. The two were tied at the meet, breaking height of 6 feet 8-5/8 inches. This eclipses the old mark in the event of 6 feet 7 inches established in 1933 by Johnson and also ties the accepted American record established by Marty in 1933 and breaks the accepted world's record of 6 feet 8 and 1-4 inches set by Harold Osborn in 1924.

Former Crisis Editor Says Resignation Dates from July 1

New York—In an open letter addressed to the board of directors of the N. A. A. C. P. Tuesday, June 26, Dr. W. E. B. DuBois, former editor of the Crisis and veteran member of the military organization, repeats his determination to sever his connection from the association and says that he can go no further with the organization. His resignation is to date from July 1, he says.

The board met June 11 at which time the matter of Dr. DuBois' resignation was scheduled to have been taken up. Following the information given out was that "no action had been taken."

'Resignation Must Stand'

At the June 11 meeting a committee of reconciliation was directed to get in touch with Dr. DuBois and action on his resignation was postponed.
