## NAACP Tells Roosevelt of Recent Lynchings

### Rev. G. W. Robinson is Re-elected Moderator of the Iowa Baptist Association Iowa Negro Republicans Pledge Support to Party in Fall Elections One-a-Week Since June, Cites Secretary Wilkins

"FAIR DEAL"

J. G. Browne Re-elected Head

The Negro Republican Voters League of Iowa, met in a statewide convention Monday in the state Republican central committee headquarters with thirty-five delegates present representing every town of any importance to the Negro group. The meeting was called to order by chairman J. G. Browne and report was read by Harry E. Wilson, secretary. The following committees were appointed and reported; executive, steering, time and resolution. Talks were made by Secretary George Lloyd of central committee, and Wallace, chairman of Polk County Central Committee.

The meeting adjourned to attend the East Des Moines Booster picnic at Union Park, former Governor Dan W. Turner was the main speaker to an audience of 1500 persons. He was introduced by Rep. C. C. Dowell. After pledging a "fair deal" to the Negroes of Iowa in a brief address, State Senator Beardsley of Clarke County and Mrs. Agnes Samuelson, state superintendent of public instruction, followed with speeches. Several county candidates were present. Due to an attack of tonsillitis, the former governor was obliged to shorten his talk and his other speaking engagements for the week.

The following officers were re-elected: J. G. Browne, Des Moines, Chairman; Mrs. Mable Fletcher, Council Bluffs, co-chairman; Harry E. Wilson, Des Moines, secretary and J. O. Winston, Ottumwa, treasurer. The following resolutions were unanimously adopted by the colored G. O. P. and forwarded to the state central committee and the newspapers:

**Report of Resolutions Committee**  
WHEREAS, we feel that the Democratic administration has not materially improved our economic and social condition, and

WHEREAS, we feel that the State of Iowa needs the Republican party to control the government of the State in order to relieve our present situation, and

WHEREAS, we feel that the Republican party has a more sympathetic understanding of the position and condition of the Negro,

**BE IT RESOLVED:** That the Negro Republican Voters League of Iowa squarely endorse the program, platform and policies of the Iowa State Republican organization and pledges its fullest support in its efforts for victory in the coming election.

That we pledge our support to the Republican State Ticket and to the various candidates from township trustee to governor.

That feeling that patronage is the proper reward for the work and struggle in attaining victory, we urge upon the State Central Committee and the elective officers in the State that the Negro voters be given more and better consideration in the matter of patronage and in sharing in the rewards of victory.

That this organization shall extend all of its energies from now until November 6th to the end that the "Grand Old Party" shall be victorious.

Chicago. — Three stitches taken directly into the heart muscle of Elice Wright, 28-year-old Negro, probably saved his life Tuesday. Wright had been stabbed in the heart with an ice pick.

Under a local anesthetic the wounded man looked on as Dr. George Luther Davenport made an incision in the patient's chest wall and drained blood from the heart's sac. Three stitches were then taken, sewing up the ruptured heart.

## Negro Lynch Prey Shoots Into Mob

FUGITIVE OPENS FIRE AS 500 SEEK TO TAKE HIS LIFE; ONE DEAD

Carbon Hill, Ala.—(ANP)—Sam Holly, an escaped convict, was fatally shot in the back by a white man, Thomas Wakefield, near here Friday, after a mob of 500 lynchers, aided by bloodhounds, had scoured Marion and Fayette counties for him for two days.

After he had escaped from the convict camp, Holly was seized by Police Chief T. T. Beasley of Wakefield. He stabbed Beasley, took his gun, and fled again. Then the white farmers left their fields and the workers left their shops to make up the posse to pursue the fugitive.

When they first came upon him, Holly fatally wounded one of the possemen, Ernest Long, an employe of the Alabama Public Utilities company. Chief of Police Beasley is in a hospital at Army, Miss., in a critical condition. Ernest Long will not be able to answer when called for the next mob.

CANDIDATE DIES FROM "WEAK" CURRENT IN "ELECTRIC" CHAIR

Camden, N. J.—The shadow of the home-made "electric chair" in which Samuel A. Wilson, 32, was killed at an initiation held here by the Pride of Camden Elks at their home, 749 Kaighn avenue, extended across Jersey to the impending session of the grand lodge in Atlantic City, as effects of the tragedy were estimated here this week.

Efforts to learn whether the chairs were a standard part of initiation practices in the lodges met with one declaration that a number of years ago such chairs had been ordered abolished by Grand Exalted Ruler J. Finley Wilson.

## Crocker Y Camp Closes Successful Period at Boone

88 Boys Enjoy Outing

Eighty-eight boys and leaders returned to Des Moines Wednesday morning, after spending eight days at the Des Moines "Y" Camp at Boone, Iowa, during the Crocker "Y" period. Boys from all sections of Des Moines, Valley Junction, Ames and Omaha, Nebraska, were included in the camp enrollment. Hundreds of visitors swarmed over the grounds on Sunday morning and afternoon, many being present at the services on Chapel Point, at which Dr. E. T. Scales was the speaker. The address given by Dr. Scales was declared by many to be the finest ever heard from this sacred spot during the past sixteen years. The subject of Dr. Scales' talk was "Little Black Boy, What Now?"

The program on Chapel Point was presided over by Bobby Hyde, fourth degree and honor camper, and was assisted in the presentation by Quentin Mease and Henry HasBrouck, camp directors, and the quartette composed of Vincent Wilson, Orlando Anderson, Harold Carr and Bobby Parker. The afternoon program was topped off by a general swim by both campers and visitors, and a ball game between the Crocker "Y" leaders and Fraser, which the latter won 5 to 1. In the evening, a treasure hunt and water carnival were staged.

Numerous honors were won by the boys of this period in various phases of camp activities. Bobby Hyde, awarded the three star fourth degree monogram plaque, completing the series of degrees given yearly for achievement in the camp program. Harold Carr and Albert Thomas, who

completed the monogram circle last year, won a leg on the Junior leader's shield, and need only one more for permanent possession. Seventy-one other boys also were awarded various camp monograms, ranging from the "Y" series to the fourth degree circle plaques.

Certificates of achievement for proficiency in such activities and sports as: Nature lore; leather art, wood and metal craft; baseball and volleyball; golf; tennis; horseshoes; boating; ping pong; drama, and citizenship. ### WILL HEAD TEACHERS

BALTIMORE.—(A.N.P.)—Garnet C. Wilkinson, first assistant superintendent of public schools in Washington, D. C., was elected president of the National Association of Teachers in Colored Schools at the 31st annual session held here July 31 to August 3.

Other officers of the NATCS for 1934-35 are: I. T. Gilliam of Arkansas, first regional vice-president; W. R. Wood of Alabama, second regional vice-president; C. A. Johnson of South Carolina, third regional vice-president; W. H. Foy of Kentucky, fourth regional vice-president.

E. P. Davis of Washington, fifth regional vice-president; E. G. West of Oklahoma, sixth regional vice-president; W. D. Miller of Virginia, treasurer; and W. W. Sanders of W. Virginia, executive secretary.

The convention was welcomed by Honorable David C. Winnebrenner, 2nd, Secretary of State, acting for the governor of Maryland, who is in Europe on vacation.

Mayor Howard W. Jackson, Dr. David E. Wiggins, superintendent of Public Instruction, Baltimore, Mr. John O. Spencer, white president of Morgan College, Carl J. Murphy, president of the Afro-American, Joseph G. Parks, executive secretary of Teachers in Colored Schools, and Mrs. M. W. Blocker, president of the National Congress of Colored Parents and Teachers, Jacksonville, Fla.

Response was made by Dr. John W. Davis, president of West Virginia State College, Institute, West Virginia, J. W. Scott, president of the National Association of Teachers in Colored Schools, who gave his annual address on the opening night.

Speaking before a secondary school department session on Wednesday, Dr. R. P. Daniel of the department of psychology at Virginia Union University at Richmond, warned the teachers against making selections of students who fall into categories of very light or very dark for special rewards or penalties.

**No Special Jobs**  
He urged the educators present to get their charges away from the belief that there are such things as special jobs for colored people. "Special jobs for colored people," he asserted, "are a relic of the past, a relic of the days when the colored people were regarded as inferior to the white people."

"A determined effort is being made to improve the conditions of the colored people," he said. "The health service, the social service, the combined meeting of the departments of college and health at Washington Junior High School, Dr. J. S. Clark, president of Southern University, Baton Rouge, La., presided at the meeting. The Thursday meeting included discussions of 'Personal' Proceedings in the Small College' by Dr. R. S. Crossley, president, State College, Dover, Del., 'A Statement of College Objectives to Meet the Demands of a New World' by Dr. John W. Davis, president, Virginia State College.

Dr. A. Wilkinson, president of the high school at Va. State College, who discussed 'Major Implications of the National Survey of Secondary Education for Colored People' said:

"If we would show figures of the delinquency costs of colored people, the health costs and charity costs, in relation to the inadequate expenditures for education, we might get more response."

As to the availability of high school education to colored children, Mr. Wilkinson stated that the percentage of colored children in high school age in sixteen Southern states, and one colored teacher to every sixteen white pupils of high school age in sixteen Southern states, and one colored teacher to every two hundred and eleven white pupils of high school age in sixteen Southern states, would be required to equalize the ratio.

Further, the costs of colored teachers salaries per person of high school age in sixteen Southern states is \$2.16, and for white \$11.97. To equalize these would require an additional annual expenditure of \$9,957,844 for colored.

## CONFERENCE OF STUDENTS CLOSES IN CHICAGO

Chicago.—(A.N.P.)—Public exercises featured the close of the National Conference of Students held here, when Dean William Pickens addressed an open meeting Sunday evening at the Y. M. C. A. on the subject "Youth's Contribution to Tomorrow's World." During the course of the address Dean Pickens urged youth to maintain self-confidence, cultivate enthusiasm in connection with their various pursuits in life, and go forward with a determination to succeed in spite of obstacles, whether they be on account of racial identity, or otherwise.

The veteran author and scholar called upon youth to throw off the fads and frills connected with our present social order and give conscientious attention to the practical problems of life. A capacity audience was present to hear Dean Pickens.

During the first four days of the conference, the sessions of which were held at the Good Shepherd Congregational Church, the following speakers also addressed the confab: Dr. Chambliss H. Tobias, Senior Secretary, National Council Y. M. C. A., New York City, whose subject was "The Piece of the College Man and Woman in the Community"; Prof. Paul H. Douglas of the University of Chicago, whose subject was "What the New Deal is Trying to Accomplish"; President H. C. Tronholm of the Alabama State Teachers College, Montgomery, Ala., who dealt with "Education for Living in the Modern Age"; Prof. Leonard S. Cottrell of the University of Chicago, whose subject was "The Prediction of Accidents in Marriage"; and Dean William Pickens, who also spoke at the Illinois Hotel House of a Century of Progress on the subject, "A Century of Progress of the Negro Race."

He was employed in the Department of the Interior, and upon his retirement was appointed librarian of the Central Y. M. C. A. of Washington.

He is survived by his widow, Mrs. Alice Ruston Howard, three sons, William K. and Alden R. Howard of this city, and Harvey E. Howard of Portland, Oregon, and a daughter, Mrs. W. A. Moon of Oakland, Oregon, two brothers and two sisters.

He also stated that the Negro had made a mistake at present if he cuts himself off here and there, and that he should have contact with other races in schools, churches and welfare agencies. ## The Home and That Boy of Yours

By F. H. CHELEY

### TRAINING GOOD ANIMALS NOT ENOUGH

MOST parents seriously attempt to be good animals. That is to say, from the standpoint of the physical care of our children we do pretty well in most particulars. Not many children starve; most are at least occasionally bathed and many still "castor oiled." Mothers do provide reasonably suitable clothes and seek with a positive irritation for the black ringed "k" and the finger nails "in mouling."

Most youngsters are fairly well schooled as such schooling goes. They can read and scribble and spell (sometimes). They can sing and dance and find amusement, but when it comes to that much more efficient wise training and direction of the emotional self, it almost makes one shudder to realize the unfortunate effects average parents with the best of intentions have upon the emotional unfoldment of their children, because they know no better!

Mothers who are scrupulously careful about proper food, sufficient milk and vegetables, who would be horrified to find their precious child in soiled "undies," are often essentially responsible for a type of emotional environment in the home in those early days of youth, which, in spite of excellent physical care, gives society neurotic, irritable, nervous, inadequate boys whose chances at normal adjustment out in a big busy, selfish, thoughtless society, are pretty slim.

Physical care is basic and absolutely necessary. We would not substitute anything else for it. Wise and proper feeding and sane

and suitable clothing are essential to physical health and well being and custom and common sense provide for them fairly well. Good schooling, plenty of books and wise and proper play are all essential and there is room for much improvement in all these lines; but all of these combined do not take the place of or substitute for a rational emotional training, which is the very greatest need of youth, and of us all today; a fact which is more and more evident as the whole problem of personality adjustment is better understood.

On every hand, many astounding things are being said concerning the obvious short-comings of parents and teachers and workers with youth, and there is as yet such a complete lack of understanding among even the most intelligent folk in regard to the emotional development of young boys, coupled frequently with the idea that we already know it all and are doing a good and satisfactory job, that it will take a tremendous campaign of education to open our eyes to the perfectly marvelous unexpressed possibilities of youth whom once we know better how to train wisely and effectively this hidden self, the emotion. The significant factor here all is that it is essentially a home job. It must be done before school and work and social contact begins, so that it is essentially a parents' job.

Developing good animals is not enough.

# WHY DO WE HAVE THESE BARRIERS OF PREJUDICE

## Cultural Achievement Given Recognition

Winning Chapters from the 25-Year History of the National Association for the Advancement of Colored People

While scoring victories against the forces of race prejudice, the N. A. A. C. P. has likewise addressed itself to the task of stimulating cultural achievement and group appreciation among colored people.

Following closely upon its organization, the Association set the services of Dr. W. E. B. DuBois of Atlanta University, as director of publications and research began in November, 1909, the editing of The Crisis, official organ of the N. A. A. C. P. This magazine, the first of its kind to have wide circulation, each month recorded the achievements of colored people everywhere and served as an unfettered forum for the expression of opinion on racial and interracial matters. It has been the chief medium for acquainting Negroes with their progress and for their respect for themselves and their abilities.

In addition to featuring articles on literature, education, and other accomplishments of college graduates, the magazine has published many timely and beautiful photographs and many essays, as well as the first Negro publication to feature art work, stories by colored writers and in 1924 Mrs. Arny Spang, life member of the Association, through The Crisis, aggregated \$300 for the field of artistic contributions of Negro descent in order to encourage their aptitude for art and expression. These prizes were awarded October 23, 1925, at the International House, New York City, to the writers of two plays and several stories and essays. The Crisis during its 24 years' existence has sold nearly 10,000,000 copies in all parts of the world, mainly to colored people.

In 1924, under the direction of Secretary William Pickens, the Association began the very first contest designed to stimulate interest in the health, hygiene and proper care of the parts of the race. The idea immediately caught on in many parts of the country. The contests were immensely popular and financially successful. During 1925 alone 100,000 contests were held in 1925 for the Association. The grand prize of \$12,712.50 going to the national office. These contests have done much to bring to the Negro the great importance of safeguarding the health of rising generation and engendering a deeper appreciation of the and charm of Negro children.

In 1926, Dr. DuBois helped edit the Krigwa Little Negro in Harlem, New York City, staged five plays and won the national "little theatre" contests. This stimulated similar activity throughout the country and today there are such "little theatre" groups in many cities and Negro colleges.

The Spingarn Medal Awards. No effort to stimulate cultural activity among Negroes has been more successful and more widely publicized than the Association's annual award of the Spingarn medal. At the annual conference in April, 1926, in Philadelphia, Dr. Spingarn, now president of the nation, gave a gold medal, worth more than \$100, to be given to the highest and noblest achievement of an American Negro in the preceding year. The award is given to the person or persons who have made the greatest contribution to the advancement of the race in the preceding year. The committee of awarding the medal, its decision is final.

## MRS. DANCER WON'T NAME HER RIVAL

Divorce Contemplated as Courier Writer is Freed After N. Y. Detention

SHE HELPED RELEASE NEW YORK (Co-op) — Declaring that she would not name another woman in her contemplated divorce from Maurice Dancer, promoter of the NAACP benefit performance who was recently arrested on a complaint of embezzlement of funds, Myrtle Passon, Dancer's reported estranged wife, took the lead in helping to secure his release.

Dancer was dismissed Friday morning when he was arraigned before Magistrate Harris, who was informed that the charge would not be pressed.

The magistrate, sitting in Harlem Court, declared that the police had no evidence against Dancer, other than a telegram purportedly sent by Chief of Police Wheeler of Pittsburgh, saying that the man was wanted for embezzlement.

No details of the charge, not even the alleged sum concerned, were mentioned in the wire. After scoring the department for arresting the defendant on such flimsy evidence, Magistrate Harris informed the arresting officer, Detective O'Connor of the 123rd Street station that he would release Dancer unless more evidence was secured against him.

Dancer, who has been in charge of Pittsburgh Courier benefits for the N.A.A.C.P. in New York City, Pittsburgh, St. Louis and Philadelphia, during the last two months, denied, through his attorney, Vernon C. Reddick, 200 West 135th Street, that he was a fugitive from justice, as intimated by the police, and stated that he had merely returned to New York after the Philadelphia benefit on July 22 in order to secure certain receipts.

It is reported that Dancer's recently estranged wife, Myrtle Passon, a registered nurse, who said she is contemplating separation action against him, took the initiative in the fight to free him.

Mrs. Dancer visited Ethel Waters, star of "As Thousands Cheer," who appeared on the stage of the benefit program, and secured a statement allegedly signed by Pearl Wright, Miss Waters' secretary, to the effect that the noted star received \$100 for appearing on the Philadelphia program and \$250 for her part in the Pittsburgh venture.

## Race Youth Shot Dead by Ofay Braddock Cop Who 'Fired to Scare'

PITTSBURGH, Pa.— An innocent and harmless twenty-year old colored youth lay dead on a cold slab in the Allegheny County Morgue here Monday morning.

His brief and innocent life was cut short by a slug from a white policeman's gun.

The Braddock cop, Patrolman Ben Manson, 28, who ended the mortal being of Mrs. Jefferson's son, William, 20, of 1214 Wood Way, Braddock, gave his superior officer the meek excuse that he "fired to scare" a group of young men.

This justification of the killing being "too thin," the white killer-policeman added that he "shot in the air to scare the gang" and that as the gang began to run, "a bullet glanced from the curb" and struck the Jefferson boy.

This is another instance in which white race-hating policemen, vested with a little authority of the law, fatally use it on innocent Negroes. In not a few instances, men and women of the race have been deliberately shot down and murdered by grudge-bearing policemen who give the old excuse of "firing in the air to scare" them.

Time and again, Negroes sit idly by as if content with the excuse which they in almost every instance know to be false and given only as a means of shielding the real motive behind the killing.

In a few cases, however, it is true that some member of the race is accidentally shot by a policeman, but in the overwhelmingly majority of cases, the shots that are "fired into the air to scare" the victims, find their true marks. The result is a motionless blood spattered figure, gasping for his last breath.

## New Workers' Council Is Organized By Urban League

PITTSBURGH, Pa.— Pittsburgh is keeping pace with other sections of the country in its promotion of a Workers' Council and a Workers' Institute in line with the labor program of the National Urban League. The Pittsburgh group was organized last June under the direction of the Industrial Department of the Urban League. Since that time more than a half dozen meetings have been held in the auditorium on the third floor of the League building at 42 Fernando street.

The workers have elected their own officers. They have an executive committee which includes the officers and representatives from nearly a dozen different trades. There are Carpenters, Plasterers, Painters, Brick and Stone Masons, Electricians, Hoisting Engineers, Hotel waiters, Lathers, Janitors, Plumbers, Boilermen and one electrical Engineer. Nearly 100 men have enrolled in the Council and aside from their immediate purpose, which is to get a more equitable share of skilled workers on emergency projects.

The workers are planning to promote an educational institute. This Institute will hold forums for the discussion of problems based on their experience as workers. Upon these experiences their plans and activities for the future will be based.

Every skilled Negro worker in Pittsburgh, regardless of whether he is a union or a non-union worker, should become a member of this Workers' Council. Many of the members are already union workers, and in no sense are the aims of the Council opposed or contrary to the legitimate aims of organized workers, white or black.

### PICKING LEADERS

An interesting article "Why Forrest B. Washington resigned his post in the Federal Relief Administration" has appeared in many papers. Nobody seems to know the reason definitely but most of them hint his bold attempt to secure justice for the Negro race runs counter to the policy that Negroes who hold these jobs must be "yes" men. Quoting from the Capital News Service dispatch we find this statement:

"Some days ago it became known that immediately following Mr. Washington's notice to the 'insiders' that he was going to resign, a hurried meeting was called and held in room 2814, commerce department building, to discuss the matter. Among those reported to have answered the call were Dr. William J. Thompson, Lieut. Lawrence A. Oxley, E. Kinckle Jones, Victor Coads, J. A. Morehison and Robert L. Vann.

"It is charged that Vann tried to break up the meeting when it became known that some of those present were like Mr. Washington, very, very much dissatisfied because of the indifference and complete apathy on the part of the administration toward doing anything tangible for the masses of the colored people, despite numerous recommendations and surveys which have been made at the suggestion of administration officials for the past 15 months."

The inference here is that Mr. Vann, as assistant attorney general, is charged with the duty of keeping Negroes satisfied. In fact it is a part of his job. This situation merely emphasizes the importance of having a spokesman who is not a candidate for a job. His hands are tied from the start and if he is fortunate enough to land a job he is tied tighter than ever.

A group can progress only in so far as it can operate without being hindered by force whether economic or otherwise. Evidently this is just the situation in Washington with these Negro office holders.

### MAKING MARTYRS

When three men arrested for criminal syndicalism were being detained at the Polk County jail because of their inability to make bonds, the Bystander stated editorially that the incident made radicalism grow faster than anything else.

A few days ago Angelo Herndon of Atlanta, Georgia, a Negro leader of the Communist group, was released on a fifteen thousand dollar bond from the prison in Georgia to which he had been sentenced to a fifteen year term on an antiquated statute made to catch those against whom no other charge could be made.

Herndon was sent to New York for advertising purposes as may well be seen from a paragraph describing a communist demonstration:

"Herndon dramatically appeared in the middle of the meeting. The people rose to their feet. They sang the 'Internationale' twice. They cheered and greeted Angelo Herndon with all the fervor in their hearts. Here was their courageous working class leader in person. It was a fitting reception for a Negro youth who had hurled the challenge of the Georgia lynch court back at its teeth, when he stated at the trial, 'You may do what you will with Angelo Herndon... but there will come thousands of others to take his place fighting the battles of the Negro masses and white workers of the South.'"

### A Minister's Viewpoint on Teeth

Q. I read your column about the "Evolution of Teeth" and find that I must disagree with you. The doctors and other scientists have continued to argue the facts of evolution, but none of them has a conclusive proof as to the origin of man. I defy you or anyone else to show me where one animal or man can progress from a lower to a higher species of life.

I have read numerous articles concerning two of the theories of evolution, namely, the "Vitalistic and Mechanistic," and neither accounts for the energy which first instilled the breath of life in man or animal life. If you as a doctor have read anywhere of such life-giving energy other than that given by God, would you kindly advise me. In case there is no such proof established, will you be man enough to admit that this evolution or evolving was a plan of the Lord's and that God created man as we are taught in the first books of the Old Testament as recorded in the Holy Bible. A. I regret very much that the article mentioned above was misunderstood enough to lead the Reverend to believe I was proving or attempting to prove the facts of evolution. Upon referring to the issue of that week, I find that I merely mentioned the possibility of there being a similarity in the evolving of tooth structure as there are other instances recorded for the various organs of the body.

Q. Is it true, doctor, that every mother loses a tooth or each baby she has? I see lots of women who have had good teeth before having children; then their teeth get so bad until I just want to know whether or not my mother is right, as she always says that every baby causes a dead tooth. S. S.

A. There is no necessity for a mother to lose any teeth. The mother should see her physician at the beginning of pregnancy and follow his diet instructions and other advice. Then, too, she must have her teeth thoroughly cleaned and either filled or extracted, as the dentist finds necessary.

Q. I have tried to have my teeth pulled, and each time I get terribly sick from the use of the needle and sometimes faint. Isn't there some other way than this to get the teeth out? O. D.

The lynching had been well planned as all roads to the court house were blocked. Jones was taken from two deputies while being brought here from Tupelo, and Houey was taken from two other deputies while being brought from Holly Springs. The two mobs converged near Michigan City and hanged the two prisoners from the same tree. Their bodies were left suspended until Sheriff R. H. Hudspeth ordered them cut down. A "rigid investigation" is promised.
