Race Is Unaffected By Textile Strike

WASHINGTON, D. C.—The present nationwide strike in the textile industry has drawn attention to the fact that practically no Negroes were directly affected by this strike for the simple reason that no Negroes are members of the unions in this industry, although it employs more people than any single industrial organization in the country.

Statistics compiled here by Charles E. Hall, statistician of the Department of Commerce, shows that of the 814,371 employees of the various groups in this industry, only 7,238 are Negroes, or only 0.9 percent.

Although most of the cotton mills are in North Carolina and South Carolina, the silk mills are located mostly in the vicinity of Paterson, N. J., and the woolen and worsted mills are in New England.

TOTALS MORE POINTS THAN GLENN CUNNINGHAM New York.—(ANP)—According to Associated Press dispatches from Tokio, Japan, Ralph Metcalf, Marquette university's world champion sprinter, led his team mates in garnering points in the two-day track and field meet against Japanese in Tokio, Saturday and Sunday. Americans won the meet 84 points to 75.

Metcalf was first in the 100 and 200-meter runs and anchored 400-meter relay team to first place. His point total was higher than that of any of the other Americans. At the end of the first day's competition, the Americans led by only one point, the Japanese having captured the 5,000-meter run, the broad jump, high jump and the javelin throw.

BLACKS AND WHITES IN AMERICA WILL MERGE SAYS BRITISH LORD Aberdeen, Scotland.—"Before many centuries have elapsed there will not be a single person of America without a certain portion of Negro blood," said Lord Raglan, chairman of the Anthropological society, before the British Association for the Advancement of Science which is meeting here.

Lord Raglan said that the black and white races of America will merge into one. He added that many persons who believe themselves to be white would "find what they didn't expect to find" if they visited their ancestral homes in Georgia.

Mary M. Woodson National Church Leader Flays New Deal in Annual Address

Oklahoma City.—(ANP)—Dr. L. K. Williams and his entire cabinet of officers were re-elected by the National Baptists convention during its annual session here Saturday. New York was selected as the meeting place for the 1935 convention. Daytona Beach and Los Angeles both contended for the meeting but waived their invitations in favor of New York.

Striking a responsive chord in the convention ranks, Dr. Williams, Chicago, president of the National Baptist Convention, Inc., slashed into the New Deal program of President Roosevelt here Wednesday afternoon in his annual address. The government's program was characterized as a "costly venture" and the speaker added, "Unless it succeeds, I fear we shall have a darker and a more distressful period than we have now."

Enforced Idleness

Out of the nation's 16,000,000 unemployed, Dr. Williams stated that 5,000,000 were Negroes, and he pointed out that while the Negro represented one-tenth of the population, one-third of the number were on the relief rolls. He said that this was a "galling and enforced idleness" for which the Negro needs no condemnation. He presented records to show that the Negro was barred from labor unions which placed in the ranks of a scab, and the codes had barred him from other positions.

Wants Groups to Unite

Indicating that the Boy and Morris "wings" may eventually unite, Dr. Williams made the following statement: "This year the brethren who left us in 1916 are meeting in this state, in Muskogee. They are our friends and brethren. All of us profess to be Christians and if we are, we shall not court ungodly divisions. Let us send greetings to the brethren at Muskogee, and also ask them if they would respond to efforts that would bring about the reunion of our beloved forces. May we go on record as favoring such a course, and direct the secretary of this convention to so inform our brethren in session in Muskogee."

UNINCORPORATED BAPTISTS AGAINST PLANS FOR MERGER

The community paid its last respects on Tuesday afternoon at the funeral services of Mrs. Mary Montague Woodson, widow of the late Attorney George H. Woodson, which were held at the St. Paul A. M. E. church, with Rev. J. A. Alexander, pastor, officiating. The remains were in charge of the Tug W. Wilson Funeral Home and interment was at Glendale cemetery. She died early Friday morning at the Mercy hospital from a sudden heart attack, after an illness of three weeks.

Bar Members Pall Bearers

The pallbearers, all members of the Negro Bar association, which was established by Attorney Woodson, were: J. B. Morris, S. Joe Brown, Lawrence Oliver, Melvin Carl, Nelson Thompson and Mrs. Gertrude Rush. In the quiet assemblage who came to pay final honor to Mrs. Woodson were Hubert Utterback, former judge of the supreme court, and Mrs. M. L. McCoy, of the Central Y. W. C. A.

The Rev. T. L. Griffith of the Second Baptist church of Los Angeles, California, former pastor of Corinthian and Union Baptist churches here, read the scripture. Condolences and obituary were read by Attorney Brown, Mrs. Ethel Bommer of Chicago and Mrs. Jobourness Kelso, St. Paul church choir director, gave vocal solos.

"Mary Montague Woodson gave her very soul to the work of the Y. W. C. A. in protecting colored girls and Negro womanhood of the city," said the Rev. G. W. Robinson of the Corinthian Baptist church, in eulogizing her life. She loved her church and Des Moines lost a first class citizen, he said. The Rev. Alexander said in his sermon, "Although feeble in the latter years, she gave to the community life a helpful and constructive service down through the years."

Came Here in 1886

Mrs. Woodson was born in Lyon county, Missouri, September 1, 1866, moving to Des Moines in 1886. She received her academic training here, joining St. Paul A. M. E. church, which membership she held until death. In 1906 Mrs. Woodson moved to California, returning to this city in October, 1921, where she was married to Attorney G. H. Woodson. His death occurred July 7th of last year.

During the latter years of her life, Mrs. Woodson dedicated her interests to the young people. The Y. W. C. A. was the center of her many activities, where she served as the chairman of the committee of management for ten years. She aided the educational advancement of one of her cousins, G. Fred Stanton, Jr., of St. Louis, Mo., now of Washington, D. C., who resided at her home on Madison street for

Princess Anne, Md.—(ANP)—Hardly a single colored person was left in this little eastern shore town, scene not long ago of the lynching of George Armwood after a race riot which broke out here late Saturday night.

Efforts on the part of the white populace to drive out every Negro in the city appeared successful as the smoke of battle cleared Sunday morning. The ramshackled colored section was a deserted village, its streets cleared of pedestrians and traffic and its business houses closed.

The trouble started about 11:30 Saturday night, when a Negro allegedly cursed a white man and the two became involved in a street brawl. By midnight the entire town was aflame with mob violence, and a pitched riot between 200 whites and 500 Negroes was in progress.

The Princess Anne police force of three men, headed by Chief Marion Austin, made no effort to halt the proceedings. They were reported by chief Austin to be "powerless under the circumstances." A call for state police was sent to Salisbury, 15 miles away, but they arrived too late to be of much assistance.

Governor Albert C. Ritchie sent troops to the scene of the lynching and made the state soldiers arrest several men charged with leading the mob. Hostile crowds attacked the troops and were repulsed with tear gas. The men who were arrested later were released on writs of habeas corpus.

The following editorial appeared in the Des Moines Daily Register in commenting on the Associated Press story of the event:

JUST A BIT OF MOB LAW IN U. S. A. That news dispatch, be it observed, was from the United States of America, not from Germany; Italy, Russia, Poland or the sovereign state of Nepal. It illustrated a race problem, a color prejudice, a caste system, a spirit, a flouting of law and the civil liberties such as, when we perceive them in other countries, lead us to question the degree of those other countries' civilization.

The mere fact that it is so common with us that we hardly even bother to read about such incidents does not make it look any better in the eyes of the rest of the world. Until we rid ourselves of these "weaknesses" perhaps it behooves us to be a little less supercilious in telling oppressors of racial minorities in other lands "where they get off at."

Mystery Seen in "Lost" Documents

WHITE QUERIES KEENAN ON "MISSING" PAPERS

VOTE BAR AFFIDAVITS

New York, Sept. 14.—According to Walter White, secretary of the N. A. A. C. P., a first class mystery has developed in connection with the "loss" of the 20 affidavits of qualified Negro Democrats of Texas, testifying to their exclusion from the July 28 primary election in that state. On last Tuesday he wrote to Joseph B. Keenan, assistant attorney general of the United States, urging inquiry into the strange "disappearance" of these valuable documents.

Where the 20 affidavits are at the moment, says Mr. White, is a puzzling question that can only be answered by Mr. Keenan, U. S. District Attorney W. R. Smith of San Antonio or the post office department. On August 10, following receipt of the documents from the N. A. A. C. P. national office, Mr. Keenan wrote Mr. White that "these affidavits have been forwarded to the United States Attorneys for the Eastern, Western and Southern Districts of Texas, respectively, for investigation and consideration."

CHICAGO—One of the things which Columbia Broadcasting Listeners do NOT get to enjoy when they tune in on Earl Hines, is a glimpse of the floor show. And it might be emphatically written that no matter how much they may be intrigued by the strains of the much publicized Hines band without the opportunity of being present or the benefit of television, the listeners are missing one of the finest floor shows being staged anywhere in America.

This trick of producing a floor spectacle without the benefit of scenery, props and adequate lighting effects, but turning out a production so finished that it would seem ready to grace the boards of a \$500 top theatre, must be more than a matter of "Mr. Harper has won the right to be crowned impresario and one might easily visualize his name rising high in the annals of entertainment if they were of different hue and had financial backing of the right proportion.

ALMA SMITH AND RHYTHM

Mills Plans For Short Tour Out

LONDON.—Duke Ellington and his crack orchestra have been refused a permit by the ministry of labor to come to England on a new tour. This official announcement is made from the office of the ministry of labor.

Application had been made by the Paramount company and Ellington was to have fulfilled variety, concert and dance hall engagements in this country.

Tentative arrangements had been made for the band to play for a fortnight on stage of the Plaza cinema, Lower Regent street, commencing September 17, and to follow with a four weeks' provincial tour of Paramount theaters doubling one-night stands at dance halls, plus Sunday concerts.

The bookings had been negotiated by Harry Foster of Foster's agency direct with Irving Hills, who controls the band in America. The decision of the ministry of labor is doubtless foreshadowing a new policy in the consideration of applications for such permits.

There is still no objection to a band like Ellington's being booked for pure variety work, but the financial demands of such an organization make it imperative that the bookers should be able to cover part of their costs through additional engagements in ballrooms and concert halls. It is evidently not an economic possibility to book such a band for music halls only, and it is now very unlikely that the Ellington aggregation will ever be heard in England again.

Moreover, the ministry of labor is probably very averse to allowing foreign band acts to creep into British cinema shows since there is a marked and happy tendency for many super cinemas to form their own resident British stage bands, with the further possibility that smaller houses may follow suit in a lesser scale.

The prospects of stimulating employment for British musicians in this field are not to be lightly jeopardized by the importation of expensive foreign orchestras which would certainly suggest in the cinema managements that the steady maintenance of resident British bands would overlap and prove a wasteful indulgence.

On the question of dance hall dates the ministry no doubt feels uneasy, too.

Since the authorities put the bar up to foreign bands for resident dance hall work, British orchestras have established themselves firmly in all available jobs, and the least precedent in the favor of foreigners might quickly lead to more and more applications from ballroom proprietors for permits to import foreign attractions.

These alleged acts are held to have been responsible for the cool reception given the Mills Brothers when they arrive here and have served to place the colored American performer in ill repute.

SHOOTING IS CLIMAX TO QUARREL

Piano Player Wounds Torrid Trumpeter in Beer Garden

A TWO DAY FEUD

ATLANTA, Ga.—A quarrel of several days' standing, allegedly motivated by professional jealousy, ended Sunday afternoon with Karl Burns, 25, of 1059 Windsor street being admitted to Grady hospital with his right leg fractured by a bullet while police were combing the Pittsburgh section in search of Frank Berry of a Sims street address.

Burns is the sensational trumpet player with Neal Montgomery's orchestra. According to Burns, the disagreement between he and his assailant started several days ago, at a house party, where Berry had been employed to play the piano.

Burns was present, he said, and several guests begged him to play a number and during the intermission, he complied with the request, only to draw Berry's ire. Berry, so Burns declared, called him outside following the dance and drew a knife, but was knocked down before he was able to use it.

Burns said he entered a beer garden at 740 McDaniel street Sunday afternoon, and was seated at a table when Berry stroled in, and without warning opened fire with a .45 calibre automatic pistol.

The bullet grazed Burns' right hand and entered his right leg, shattering the bone. The bullet lodged in the wounded leg doctors at the hospital said.

Berry, who escaped before Radio Patrolmen Nance and Bowman arrived at the scene of the shooting, was described as being tall, brownskin and wearing a black suit and a bow tie. Burns is a well-known in the East as he is in Atlanta, having played in several nationally known bands.

WAS STABBED 21 TIMES

Ford to Run Again; Eyes Congress Now

NEW YORK (ANP)—According to an announcement from campaign headquarters the Communist party at 50 E. 11th street, James W. Mrs. Burroughs, who was a candidate for City Comptroller in 1933, is prominently identified with the Communist movement here, being dismissed from the school system for working actively for the defense of the Scottsboro boys. She led a large delegation of teachers to the board of education to demand reinstatement of Isidore Rosenberg, a white teacher, who was expelled for acting as chairman of a teachers' salary committee. For this action the militant woman was expelled. Since leaving the public schools, she has acted as chief of the Harlem Workers School.

He became the pastor of the Angelic Baptist Academy in Boylston, New Jersey, at the age of 32, serving there for six years. He later resigned to accept the Mount Sinai Baptist church in Newark, New Jersey, spending five years at that charge.

Eight months ago he resigned to become pastor of the Ebenezer Baptist church here, and, in that time has increased the membership by 173 new members and raised several thousand dollars without church members. During the course of his evangelistic work he has gained more than 14,000 converts throughout the United States, having conducted revival services in the leading churches of both races.

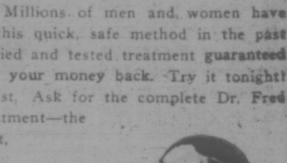

POLITICAL ADVICE

The political campaign among Negroes will be different this fall than that of Republicans and Democrats plan definite organizations.

In spite of the fact that the campaign may be somewhat bitter, there is no reason why Negroes should fall out among themselves or become enemies for the balance of their life over something which might occur in the campaign.

White politicians scrap; sometime they grapple at each others throats but when the campaign is over they gather around their business tables; in their clubs, etc., and are friends just the same.

As to issues in the campaign, one is common to both groups; the Negro's share of the jobs at the disposal of successful candidates must be increased. It is further important that now is the time to talk about that increase, for once elected most people are simply a few more voters in the estimation of one who has the office.

WE CAN HELP

In a great many cities Negroes are conducting boycotts against stores located in their neighborhoods which procure most of their trade from Negroes and at the same time give Negroes none of their work or confine them to janitor and porter jobs.

While many have been successful from the standpoint of gaining their objectives yet there is some division among results amount to a gain or loss. Leaders as to whether the net for instance Negroes working in stores in districts where there is no Negro trade have been known to lose their jobs in retaliation for the boycott. There is no accurate data on the subject and whatever conclusion one may draw is mere conjecture at this time.

Essentially, everybody is in business for profit and in order to make a profit all the trade available is desired. Dollars of Negroes spend as freely as those of President Roosevelt—there comes a time when the Negro finds it inconvenient to spend his dollars—but the value is there just the same.

Here in Des Moines we have two classes of stores: those which hire no Negroes in any capacity nor advertise in the Bystander and those which do one or both. By all the rules of the game those stores which are fair enough to return to the race some of the money—Negroes spend with them should be favored with the Negroes trade.

This can be done very easily and without any noise or boycott and eventually known to the owners who are bound to appreciate it. Recently a young man told the Editor of the Bystander that he planned to buy an overcoat and that he had selected it from a certain store. After calling attention to the fact that this store, although doing business in Des Moines for ten or twelve years had never hired a Negro to even wash the windows and the further fact that there were a number of stores selling good overcoats at reasonable prices who hired Negroes, this young man decided to buy from one of these favorable stores.
