Troops Armed for Ethiopian-Italian War Threat

MADDOX "NOT GUILTY" IN W. A. SCOTT CASE Situation is Very Grave, Say World Statesmen

Brother-in-Law of Slain—Atlanta Publisher Is Freed by Jury

Atlanta.—The slaying of W. A. Scott, publisher, from ambush more than a year ago returned to its unsolved state when a jury acquitted George Maddox, Jr., brother-in-law of the newspaperman, Saturday night, February 9, after one of the longest trials ever held in the state of Georgia in which Negroes were the principals. The trial lasted for nearly a week in the courtroom of Superior Judge G. H. Howard. The case went to the jury Saturday afternoon. The jurors deliberated for three hours. Maddox, a dining car waiter, who returned to Atlanta from Chicago where he was living at the time he was indicted, is the brother of Mrs. Agnes Maddox Scott, fourth wife of the publisher. The state, represented by Attorney Reuben Garland, claimed that Maddox killed the publisher because he did not want Scott to marry into his family, Maddox based his defense on the alibi that he was visiting a young woman at the time of the crime. The trial began Tuesday, Feb. 5. Scott was fatally shot on the night of January 30, 1934, as he left his garage after putting up his car. He died at the Spelman college hospital on February 7, eight days after the shooting.

FUNERAL SERVICES FOR MCGUIRE SATURDAY

Ernest E. McGuire, age 64 years, 827 Thirteenth street, died Thursday morning, following an illness of two months. Mr. McGuire was a dyer by trade and had lived in Des Moines for the past forty years. He first learned his trade at the Troy Cleaners and Dyers, and later went to work for the Artistic Cleaners and Dyers until a short time before taking ill. Surviving relatives besides the widow are Mrs. Sadie McGuire of the home and one brother, Archie, of Des Moines. Mr. McGuire was a member of St. Paul A. M. E. church. Funeral services will be held from the chapel of the Johnson Funeral Home at 11 a. m. Saturday. The casket will not be opened. Rev. John Alexander officiating. Interment at Glendale cemetery.

W. Tyrrell, 1137 38th St. last Thursday. The affair being the one hundred fiftieth anniversary of the birth of Frederick Douglass. Mrs. Brown devoted much of her address to portraying the life and work of this first great American Negro, which information was well received by the large assembly of ladies of the other race.

New Features Announced For 1935 Cooking School

Plans for the Bystander second cooking school and homemakers' institute to be held March 6, 7 and 8 at the Billiken hall, Eighth and Center streets, are progressing rapidly. Hundreds of inquiries have poured into the office by phone and letter since the announcement was made last week. The three day sessions will be in charge of Luther H. S. Browne, culinary expert, assisted by Mrs. Clara Johnson, home economics director. Mrs. Johnson will conduct the daily demonstrations of recipes, kitchen aids and household hints. "In addition," Mr. Browne said, "an exhibit of plain sewing will be displayed. A new feature of hair dressing demonstration by four beauty culturists will be presented, showing the latest in the finer wave, Marcel and other styles," he stated. Through the co-operation of local merchants, manufacturers and advertisers, prize baskets will be awarded each night. These business firms are furnishing the equipment and the culinary supplies. Local and national dealers are planning to install display booths advertising their products.

Of special interest have been the consideration of Race Relations week, National Negro Health week, Easter and Lent, Music Week, Mothers' Day, Thanksgiving, Christmas, child labor and lynching.

Permanent roomers, transient guests, emergency sleeping accommodations, use of the telephone, typewriter and other equipment, and employment placement are numbered among the services of the association. Others have come in to read, rest, dress or meet their friends. Thirty-two different individuals and organizations have used the building for group activities. Several of these are regular weekly or monthly affairs. Program help has been given to ten groups.

Negro History, Art Exhibit at Library

In honor of National Negro History Week, February 10-16, the Des Moines public library has arranged an interesting exhibit of a selected list of Negro works in drama, music, poetry and art. It is prominently displayed in a glass case in the main lobby in front of the entrance to the reference room. Among the magazine clippings and books are shown souvenir programs of the Des Moines appearance of Paul Robeson, actor and singer, and the "Green Pastures," Pulitzer prize play, a frontispiece of selected speeches by Booker T. Washington, and "De Lawd," Richard B. Harrison, receiving the Spingarn medal in 1930 from the then Lieut. Gov. Herbert Lehmann of New York. Masterpieces of Paul Lawrence Dunbar, Langston Hughes, James Weldon Johnson, Robert R. Moton, W. E. B. DuBois and other writers may be viewed. Volumes of "The New Negro," by Countee Cullen; "Negro American, What Now?" by Jas. Weldon Johnson; "Southern Road," by Sterling H. Brown; "Black Christ," by Countee Cullen, and drawings by E. Simms Campbell complete the worthwhile exhibit.

Large Crowd at Citywide Program

Vigorously scoring Negroes who try to be "white" and condemning white Christian leaders who only "talk" of better race relations, Rev. S. M. Riley, Jr., of Burns M. E. church, addressed the citywide program Sunday afternoon sponsored by the Des Moines Inter-racial commission at the Corinthian Baptist church. "The new Negro can not believe in Christianity and racial good-will unless it is manifested in action by the leaders rather than just mere words," he said. An audience of three hundred heard relationship between the races discussed by the two speakers. "Race relations and nationalities are emphasized too much," the Rev. Harry Shifler of Highland Park Presbyterian church. The second speaker said, "Human interest should be stressed more for the human family of which we all are."

War Considered Imminent as Protest to Geneva Council is Unheeded

Addis Ababa, Ethiopia—Feb 16—The threat of war between Italy and Ethiopia loomed largely on the international horizon, this week as Premier Mussolini of Italy ordered the mobilization of some 250,000 troops and placed naval and air equipments in readiness for action. The move was said to have been made as the result of a series of alleged border attacks by Ethiopians, colonial neighbors of Italy in Africa. No ultimatum from the Italian government to the Ethiopian capital, Addis Ababa, is reported to have been sent as yet, but the situation is viewed as one with grave potentialities by international statesmen. Advice from Rome emphasized the fact that no troops had left Italy and added that troop concentrations for the time being would be confined to two divisions amounting to about 30,000 men. An Italian air fleet was reported to have taken off from Cyrenaica for Eritrea and Italian Somaliland and thirty more in Eritrea. Troop movements on Italian soil were said to be still in progress, at last reports, several units having left Rome for Catania. The protest against Ethiopia which sort would be attempted by Mussolini's order for mobilization was against a reported clash of Ethiopian and Italian colonial troops on January 29th last. This was the most serious of a number of successive incidents which caused both nations to protest to Geneva. Several soldiers on both sides were reported killed in an official communique of the Italian Government.

REPRIEVE HALTS HANGING OF MISSISSIPPI TRIO AS NEW APPEAL IS MADE New York, Feb. 15.—Ed Brown, Yank Ellington and Henry Shields, Dealb, Miss., condemned to hang February 8th for the alleged murder of Raymond Stewart, a white farmer, were granted a reprieve by Governor Conner until February 21, the N. A. A. C. P. announced this week. This reprieve will give the trio's lawyers time to file a writ of error and the state supreme court to consider it. This failing, an appeal will be made to the supreme court of the United States. The three men were convicted on the basis of a "confession" forced from them by beating and torturing, a procedure roundly condemned by Supreme Court Justice W. D. Anderson in a dissenting opinion. There was no other evidence against them. The N. A. A. C. P. has agreed to furnish money for the expense of an appeal to the United States supreme court. The lawyers in the case are Attorney John A. Clark of DeKalb and ex-Governor Earl Brower of Jackson, Mississippi. News that the three condemned men might escape the noose reached Meridian, where they had been held in the county jail since the slaying a year ago, and murmurs of a possible lynching arose. Acting on an order from Judge W. W. Magruder of Starkville, Sheriff B. M. Stephens rushed the trio to Jackson last Sunday, where they were lodged in the strong Hindu county jail. Judge Magruder expressed the view that the removal would be "expedient to the public welfare."

Costigan-Wagner Measure Needs Aid of All Voters

KEY POLITICAL OFFICERS ASKED TO SUPPORT ANTI-LYNCH BILL New York, Feb. 15.—A call to colored voters to secure endorsement and backing for the Costigan-Wagner anti-lynching bill from key political officials, such as ward committeemen, district leaders, county committeemen, county and state chairmen, was issued today by the National Association for the Advancement of Colored People. The association declared the support of these officials would have much weight with congressmen and senators. It urged its branches and colored voters everywhere to call upon their local political dignitaries in person or by letter, asking them to write senators and congressmen from their states urging passage of the bill. Colored people also were urged to secure endorsements from local labor organizations and influential business men in their communities to be forwarded to Washington.

Noted Church Club Fetes it's Founding

A banquet was given by the members of the S. L. Birt club, celebrating its seventeenth anniversary. The banquet was served in the dining room of St. Pauls A. M. E. church. The color scheme of the evening was pink and white. The table was beautifully decorated with sweet peas and roses. Each guest was furnished with a place card on which was printed the program for the evening. Mrs. Margaret St. Patton presided over the program. The history of the club was read by Mrs. Essie Davis. "The S. L. Birt club was organized in February, 1918, under the administration of the master-builder of St. Paul Church, Rev. S. L. Birt," said by Mrs. Izora Mackey. The club is one of the most outstanding clubs of the church, having raised at one time \$452.00 from its famous baby contest, she said. Musical selections were rendered by Mrs. Sophia Nichols and Miss Doraelva Mackey. Mrs. Mackey spoke on the high lights on the life of Rev. Birt who "gave the best of his life so that it might be possible for the people of St. Paul to have a presentable place in which to worship." Rev. Birt died February 14, 1929. Lights of New York

Dr. William Woodward, who has a bookshop up in Yonkers, is reading the Bible through. That is nothing novel for him. He has done it fifty times before. His celebration of his seventy-seventh birthday was to read the book of Ezekiel for the fifty-first time. Doctor Woodward began his Bible reading when he was a student in Newton Theological Institute away back in 1873. By 1924 he had read it through forty times. Then he resolved that since in 1934 he would complete a half century as a Mason, he would read the Bible through fifty times by then. He did it and then started another reading. Usually he reads only in his leisure time. But once he read the Bible through in 18 days, often devoting 12 hours to it. He regards the Bible as the word of God and literally true throughout. If there were fewer hypocrites in the Christian church there would be fewer charges of inaccuracies in the Bible, he holds.

There are throughout the country several dozen of these experiments, the greatest of which, of course, is the Tennessee Valley Authority. That agency, wholly government-owned and operated, is developing and distributing electric power on a gigantic scale. It is rapidly driving out all private enterprise having to do with or built up around the power business.

Further than that the TVA lately announced the organization of a subsidized corporation which will sell electrical household equipment to whomsoever will buy. Sales of washing machines, irons, vacuum cleaners and other such equipment are being made on the installment plan, much to the chagrin of local dealers handling such merchandise.

Vast Sums Expended.

The federal government is backing a hundred million dollars or more in bonds of the TVA and it is paying the governing board and its personnel. The dams in the Tennessee river were built at government expense. Public Works Administration funds are being expended in a score or more localities in the construction of dams and hydro-electric plants. Public Works officials in Washington repeatedly have called attention to the vast supply of electric power to be developed from these government plants and all of it will be sold in direct competition with the products of private industry.

In addition to the utility phases in which Public Works Administration money has been spent—money borrowed by the federal government—funds are being used in the building of whole towns, such as Roadville, West Virginia, and in numerous other experiments of a government ownership character. Definite Statements sought.

With all of these circumstances confronting them, according to the word reaching Washington, an increasing number of voters are reported to be asking the candidates in their areas how they stand. The Home and That Boy of Yours

TRAINING GOOD ANIMALS NOT ENOUGH

MOST parents seriously attempt to be good animals. That is to say, from the standpoint of the physical care of our children we do pretty well in most particulars. Not many children starve; most are at least occasionally bathed and many will "custor oiled." Mothers do provide reasonably suitable clothes and seek with a positive intention for the black ringed sock and the finger nails "in mourning."

Most youngsters are fairly well schooled as such schooling goes. They can read and scribble and spell (sometimes). They can sing and dance and find amusement, but when it comes to that much more significant wise training and direction of the emotional self, it almost makes one shudder to realize the unfortunate effects average parents with the best of intentions, have upon the emotional unfoldment of their children, because they know no better!

Mothers who are scrupulously careful about proper food, sufficient milk and vegetables, who would be horrified to find their precocious child in soiled "undies," are often essentially responsible for a type of emotional environment in the home in those early days of youth, which, in spite of excellent physical care, gives society neurotic, brittle, nervous, inadequate boys whose chances at personal adjustment out in a big busy, selfish, thoughtless society, are pretty slim.

Physical care is basic and absolutely necessary. We would not substitute something else for it. Wise and proper feeding and sane and sensible clothing are essential to physical health and well being and custom and common sense provide for them fairly well. Good schooling, plenty of books and wise and "proper" play are all essential and there is room for much improvement in all these lines, but all of these combined do not take the place of or substitute for a rational emotional training, which is the very greatest need of youth, and of us all today; a fact which is more and more evident as the whole problem of personality adjustment is better understood.

On every hand, many astounding things are being said concerning the obvious short-comings of parents and teachers and workers with youth, and there is as yet such a complete lack of understanding among even the most intelligent folk in regard to the emotional development of young boys, coupled frequently with the idea that we already know it all and are doing a good and satisfactory job, that it will take a tremendous campaign of education to open our eyes to the perfectly marvelous unguessed possibilities of youth when once we know better how to train wisely and effectively this hidden self, the emotion. The significant fact after all, is that it is essentially a home job. It must be done before school and work and social contact begins, so that it is essentially the parents' job.

Developing good animals is not enough.

Phoenix, Fabulous Bird, Said to Live in Arabia

The phoenix was a fabulous bird that was said to live in Arabia, and of which Herodotus gives the following account in that part of his work which treats on Egypt: "The phoenix is another sacred bird, which I have never seen except in effigy. He rarely appears in Egypt; only once in 500 years, immediately after the death of his father, as the Heliopolitans affirm. "If the painters describe him truly, his feathers represent a mixture of crimson and gold; and he resembles the eagle in outline and size. They affirm that he contrives the following thing, which to me is not credible. "They say that he comes from Arabia, and bringing the body of his father enclosed in myrrh, buries him in the temple of the sun, and that he brings him in the following manner: "First he molds as great a quantity of myrrh into the shape of an egg as he is well able to carry; and after having tried the weight, he hollows out the egg and puts his parent into it, and stops up with some more myrrh the hole through which he had introduced the body, so that the weight is the same as before; he then carries the whole mass to the temple of the sun in Egypt. Such is the account they give of the phoenix. "The popular version is that, on arriving at the age of five hundred years, the phoenix built a funeral pile of wood and aromatic gums, and lighting it by the fanning of his wings was consumed to ashes, out of which arose a new phoenix.

Lloyd's Formed in London in Seventeenth Century

Lloyd's is an organization of underwriters formed in London in the Seventeenth century, but not incorporated until that was done by act of parliament in 1871.

The organization takes its name from that of Edward Lloyd, who kept a coffee house in Tower street, London, about 250 years ago. In his place underwriters met to transact their business. It became their headquarters and there they remained until 1774, when they removed to the Royal Exchange where they have been ever since.

Refrigerator Invented

One of the first refrigeration machines was invented by Dr. John Gorrie, who obtained his patent in May, 1851, for a mechanical refrigeration machine, in which the air was compressed in a cylinder and delivered to a chamber which was immersed in the cooling water. Gorrie was a native of South Carolina but settled in Apalachicola, Fla. His interest in the matter arose from his vision of the artificial cooling of rooms for the comfort of patients, and his first machine, made in 1844, was designed for air cooling. An ice-making machine of the vapor compression type was invented by Jacob Perkins in 1834, a liquid being employed that could be alternately liquefied and vaporized.

First Wooden Indians

An authority on wooden Indians says: "Wooden Indians are not indigenous to American soil. As early as the reign of James I the wooden Indian was a familiar sight in England. Of the early wooden Indians in America, an odd, cup-like Pocahontas that stood guard on Hancock street, Boston, dates from 1730. The pioneer authenticated appearance of a cigar store show figure was in 1770, when Christopher Demuth opened a tobacco shop in Lancaster, Pa. This figure was not an Indian but a delicate miniature-type gentleman extending a snuff-box invitingly."

Minister Without Portfolio

A minister without portfolio refers to a member of the cabinet of the European parliamentary type. The cabinet as a whole is formed by the prime minister at the request of the president of the king, and it includes the heads of the regular departments corresponding to the members of the cabinet of the United States. It may also include cabinet ministers who do not head any given department, but who may assist the premier in any cabinet matters. Such a minister has equal rank with other cabinet ministers, but is not an executive as the head of a department.

LYNCHING MUST BE INCLUDED

Speaking over a nationwide radio hookup Tuesday night, Senator Wagner, co-author of the Costigan-Wagner anti-lynching bill now pending in the senate, said: "No federal attack on crime is complete unless a lynching is contained in it."

Senator Wagner and the people who want to be fair have arrived at this conclusion after giving the states a full opportunity to deal with the situation and the demonstration of an utter lack of their ability and willingness to do so. Officials in Washington including the attorney general and the president know this. The great question is whether they will be bold enough to agree with Senator Wagner and put that knowledge into law and then enforce that law.

The Lindberg case is over, for a while; Bruno has been condemned to die. The public says it was a horrible crime and most people feel that the defendant got what he deserves.

As bad as it may seem, The Bystander cannot help but feel that the public is too prone to work itself up over kidnapping cases while right under their noses, crimes are happening daily which are equally as bad; which take innocent lives of men who, although not babies, are as powerless to help themselves as Chas. Lindberg, Jr. was. The rich with untold protection around which ought to make them safe; the poor powerless because outnumbered by brutes and without wealth.

Yes, the public is worked up but not to protect the lives of innocent men killed by mobs; to punish those who take the lives of many innocent people. Kidnappers and murderers should not go unpunished; lynchings should not go unpunished. The failure to punish one makes more of the other. In other words we cannot eradicate crime by attacking one set of criminals and ignoring the other.

TESTING THE LEAGUE OF NATIONS

Trouble has been brewing between Abyssinia and Italy for some time. In fact during the latter part of the last century these two countries engaged in several clashes with the result that the black republic got the best of the fighting. While Italy employed a fine army and modern warfare far in advance of that of Abyssinia, the hilly conditions on the part of the Italian army coupled with the determination of the Ethiopians to wipe out the invaders made them winners. Italy has never gotten over it.

In a country like Abyssinia, the central authority is almost powerless to control its own bandits and outlaws. They are the ones who killed Italian soldiers on the borders then which caused the trouble. The same situation is true today.

However Italy uses this as an excuse to go into Abyssinia ostensibly to repair wrongs and to protect their soldiers from being killed by these bandits; but in fact for the purpose of getting control of this country.

It is generally known that Abyssinia asked the League of Nations to settle the dispute but this august body has seen fit to tell these countries to settle

LOSE OR MOVABLE TEETH OF CHILDREN

The inability of the child's first set of teeth is an indication that the permanent teeth are trying to force their way through the gums. This pressure has been exerted for a year or more and has resulted in the slow dissolving away of parts of the roots of the baby teeth. As this cost dissolution progresses the crown of the tooth is loosened and the child begins to move the tooth. After awhile the tooth may just be worked out of the socket but if not then, it is advisable to have the dentist extract the tooth. Don't overlook the fact that some children's abscessed or diseased teeth may be loose and of course they should be extracted as the poisons continually passing into the blood stream and digestive tract result in a backward, sluggish child.

I don't know whether you can tell me what I want to know or not because I may not explain it in this letter so you could understand it. But I have had a tooth aching me very bad for three or four days and no dentist would pull it out when I wanted it out. Please do you best to explain why they failed to take it out.

Ans. I agree with you that your question is difficult for me as I don't know the condition of your gums and face at the time—nor the state of your general health. Of course, if the area was swollen so that it prevented the injections of the anesthetic then unless gas was given you, one wouldn't extract the tooth. Also your heart or throat may have been the reason for the dentist's delay. However, you ask the dentists whom you saw and I feel that they will gladly explain it to your satisfaction.

Dear Dr. Dean:

Can I have a silver filling put back in a cavity if the other filling comes out.

Ans. A silver amalgam can be replaced only after the tooth has been thoroughly cleaned out of all possible decay if the filling has been out for some time. However, if the filling has been out only a few days then it is easier to refill.

POLLAK, FRAENKEL, LEIBOWITZ AND CHAM-LEE IS NEW COUNSEL

Four Will Plead in Supreme Court Washington, D. C., Feb. 8.—Counsel in the Scottsboro case, which is to be argued shortly before the United States supreme court for a second time, have reached an agreement, it was learned last Wednesday.

The clerk of the supreme court has been advised that Walter H. Pollak and Osmond K. Fraenkel of New York, who successfully argued the case when it was before that tribunal the first time, will withdraw as counsel for Clarence Norris, one of the two convicted youths.

Loebwitz in Case

Samuel S. Loebwitz of New York and George W. Chamlee of Chattanooga, Tenn., who represented the defendants in the second and third trials of the case in Alabama courts, will be substituted. Mr. Pollak and Mr. Fraenkel will remain as counsel for Raymond Patterson, the other convicted youth, before the supreme court.

A motion to substitute counsel in the Norris case was filed with the supreme court by Mr. Loebwitz and Mr. Chamlee on January 21. The motion contained the petition of Norris asking for the substitution of Mr. Loebwitz and Mr. Chamlee as his attorneys in place of Mr. Pollak and Fraenkel and requesting the supreme court to enter an order to that effect. The petition was dated at Montgomery, Alabama, January 12, and was witnessed by a notary public.

Evolution of Letter "E"

The fifth symbol in the English alphabet is in the same position as the corresponding symbols in the Phoenician and Greek alphabets and the other alphabets descending from the Phoenician. In the Semitic languages, which had no vowel sounds, the E symbol originally was an aspirate. In its earliest form the letter resembled an E turned backward, with the upright stroke extended below the bottom of the cross strokes.

In some of the earlier Greek alphabets the letter appeared almost as it does today, with the difference that the upright stroke was prolonged above and below the cross strokes. In other early forms of the letter the cross strokes were diagonal to the upright. In early Latin the symbol sometimes was in the form of two parallel perpendicular strokes of equal length. Both the long and short E sounds were represented by the symbol in the early Greek and Latin alphabets. In Corinth and other cities under its influence the symbol E was very similar to the letter B in the modern English alphabet.

The Ionian Greeks, who had lost the aspirate sound for E, were the first to use the symbol H to represent the long E sound. Documents in Athens for the year 408 B. C., when the Greek alphabet was adopted officially by the state, show the letter E written with an I after it to represent the sound now called the "spurious diphthong."—Chicago Tribune.

Alexandre Dumas Holds Record as Book Writer

Alexandre Dumas the Elder (1802-1870), French dramatist and novelist, was the most prolific author of all times, notes G. R. Turner in the Kansas City Times. One thousand two hundred volumes are filled with his published writings, an average of one volume every twelve days for forty years. In one year alone, 1846, his facile pen produced not only sixty volumes, but in addition he found time to write four newspaper serials and to dramatize all the plays for a theater under his management.

So voluminous was this great Frenchman's literary output that often he has been criticized on the grounds that he employed less successful authors to write under his name. But, although he often collaborated with others, not a shred of evidence exists to prove that he was aided by ghost writers. His fame justly rests on his highly creative intellect and his amazing industry.

An interesting anecdote, in this connection, is illustrative of Dumas' ability to concentrate always upon something new. On a certain occasion, after an illness, he was convalescing in a little Swiss village. A book in the library of his host absorbed his interest and he read it avidly from cover to cover. Curious to learn who wrote it, he turned to the title page and learned, to his amazement, that he himself was the author!

Carry Young in Pouch

Opossums are marsupials, their young being born so early and undeveloped they are carried in a pouch on the mother's abdomen until developed. Born half an inch long, like kangaroos and mice, their mothers drop them into their pockets, where they grow. Throughout the Jurassic and Cretaceous periods the mammals were probably all small, of the low order of monotremes or marsupials, carnivorous and insectivorous. No herb eaters lived before the Eocene, perhaps. Of very ancient lineage, living through many depressions and perilous ages, the opossum has learned that "reigning death" is a good weapon of defense.

Obsidian Natural Glass

The Indians of early days often made their arrow heads of a natural glass known as obsidian, a variety of lava which is partially transparent and is very hard, brittle and sharp-edged. Obsidian is a variety of cooling ranging from black to gray, but the color of one specimen is usually uniform. In the United States the natural glass is found in Yellowstone park principally, although it is also found in other regions. It is rather widely distributed throughout the world, wherever volcanic action has occurred.

Fresh Water in Panama Canal

Fresh water from Gatun lake and the streams which feed the Madden dam and other reservoirs serve the Panama canal locks. The upper reaches of the canal are high above sea level while the water in the Atlantic and Pacific oceans is at the lowest level. It has cost millions to build and operate the dams and reservoirs. It is not necessary to have fresh water although fresh water is lighter and exerts less pressure on the lock gates. Fresh water is used because of its availability in relation to gravity.

Balloon "Birds" Aid Flyers

Huge balloons in the form of grotesque birds are used by the British army air corps in training flyers. These air "ghosts" demonstrate how wind currents act and how pilots of them blunder into the ground from a plane perspective. The balloons show vividly the upward and downward air and its direction. They also help to show the sun's position and the ghosts' course while flying. Popular Mechanics Magazine.

Four Negro Colleges Aiding Anti-Lynch Bill

New York, Feb. 8.—Four leading Negro colleges are now aiding the fight or the passage of the Costigan-Wagner federal anti-lynching bill, according to Miss Katherine Gardner, Department of Race Relations of the Federal Council of Churches of Christ in America.

Students of Shaw university have sent over 100 letters to President Roosevelt, as have the students and faculty of Barber-Scotia college. Talladega college students have circulated a memorial, while the Howard university student council of the college of liberal arts has likewise taken action.

Miss Gardner complained some time ago that sixty-four out of sixty-five of the heads of Negro colleges had taken no action on the federal council's appeal to push action on the bill by petitioning President Roosevelt and members of the senate and the house of representatives.

MISSISSIPPI JUDGE SCORES SAVAGE TORTURE OF CONDEMNED NEGROES

N.A.A.C.P. Rushes Legal Aid to Halt Hanging of Three New York, Feb. 8.—In a strangely worded dissenting opinion, Justice Anderson of the Mississippi Supreme Court has roundly condemned the conviction of Henry Shields, Ed Brown and Yank Ellington, three Negroes accused of murdering Raymond Stewart, a white farmer. They are sentenced to die February 8.

AKA Ballyhoed Ball, Blinded Man

It is said to have been the greatest military array ever assembled for the protection of a prisoner in this state. James Coyner was found guilty of the slaying and mutilation of Mrs. Aurelius Turner by a jury in Bolivar county court here Monday, and sentenced by Judge William A. Alcorn to be hung on March 5. Although the exact length of duration of the trial is not known, it is believed to be one of the swiftest in this history of Mississippi justice.

Coyner, who is also charged with killing the woman's husband at the couple's farm house with an axe on December 8 of last year, was brought here from Jackson, Mississippi, Sunday under heavy guard. The extraordinary precautions which were taken included placing him in a steel-plated baggage car between four other coaches, and then filling the car up with national guardsmen carrying rifles with bayonets fixed.

Governor Connor ordered out 600 state militiamen, who patrolled the route and remanded every approach. In the court room, which was filled mostly with men, soldiers with fixed bayonets sat in the witness chairs between the court and the spectators, and outside, machine guns and barbed wire were set up around the building. The town remained peaceful, however, and there was no disorder.
