Leroy Eubanks, 16, is Sentenced Twenty Years BENNIE MOTEN, ORCHESTRA LEADER, DIES Youth Convicted of Police Killing March 2, Changed Plea to Guilty, 2nd Degree

REMOVAL OF TONSILS FATAL TO MUSICIAN

Kansas City, Mo.—Bennie Moten, nationally known dance orchestra leader, died Tuesday morning at Wheatley-Provident hospital following an operation for the removal of his tonsils. This 41-year-old rotund band leader was a favorite among both white and colored dance fans from coast to coast and was famous for his "stomp" rhythm that had wide appeal.

Born in Kansas City, Mo., November 13, 1893, he was graduated from Attucks school and attended Lincoln high school but did not finish. He chose music as his career and began early in his profession as a musician.

Charter Member of Local Kansas City Musicians local No. 627 in Dan Blackburn's band.

Later he organized his own orchestra with three instruments. He secured engagements in local theatres and played dance engagements in Kansas City and nearby towns. As his orchestra grew his popularity spread. He was director and played piano. Bennie also was the composer of several dance hits.

On tours east Bennie Moten's orchestra attracted large crowds in New York, Philadelphia, Baltimore, Chicago, Cleveland and other well known amusement centers. His orchestra made several recordings for Victor and Brunswick phonograph records. In Kansas City he is considered the dean of orchestra leaders as his band is the first large dance orchestra to originate in this section. Many musicians who are now playing in large and well known eastern orchestras got their start with the Moten organization.

Featured Over NBC When the orchestra played in Cincinnati a few years ago it was featured nightly over the National Broadcasting company's network. He became popular with radio listeners instantly. Two years ago when a nationally circulated newspaper conducted a popularity poll to determine the most popular band, Bennie Moten's outfit stood high on the list.

Last week his orchestra left for Denver to fill an engagement at the Rainbow Gardens. Bennie was to have joined them after he had recovered sufficiently from the operation.

Negro Preps in City Indoor Meet

North High successfully defended its title the second year by winning the city high school indoor meet at Drake field house with a score of 82. Roosevelt High placed second with 50, East scored 37 points and Lincoln finished with 16. Records fell in the two mile relay, low hurdles, pole vault, shotput and broad jump, while marks of the 50 yard dash and two-thirds mile relay were equalled.

Archie Lucas North's Negro captain, lost a close race in the 50 yard dash to Warner of Roosevelt with the time of 05.5. Lucas anchored the victorious two-thirds mile relay to equal the 1934 mark of 2:20.1. He also placed fourth in the broad jump.

East High was victorious in the sophomore two mile and mile relays. Stanley Beverly and Albert Thomas were the colored members of quartet. Herman Wadsworth placed third in the high jump with a mark of 5 feet, 5 inches. Ozzie Louis was anchor man for the North's mile relay team, which won the event in the time of 3:51.2.

High Court O.K.'s Colored Vote Ban

SUPREME COURT UPHOLDS PRIMARY RULE IN TEXAS

Washington—The method used in Texas to bar Negroes from voting at Democratic primaries by restricting membership in the party to whites was sustained Monday, April 1, by the supreme court of the United States.

The action of the Texas Democratic convention in May, 1932, in limiting party members to white citizens qualified to vote under state laws was challenged by R. R. Grover, a 44 year old Harris county Negro.

In 1932 the supreme court held invalid a Texas statute which prohibited Negroes from voting in Democratic elections. Since then the same results have been sought by action of the Democratic party organization. This decision does not affect Negroes' voting in the general election, but only prevents them from participating in the primaries which nominate the Democratic candidates.

LEIBOWITZ DOUBTS RETRIAL OF FAMED CASE

The Scottsboro boys who have won the right to a new trial by decision of the United States supreme court Monday, will never be tried again unless the state of Alabama revolutionizes its jury system, Samuel S. Leibowitz, counsel for the defense, said Monday night at his offices, 225 Broadway.

"Any grand jury which indicts them will have to have Negroes on its roll, and any jury which tries them will also have to be drawn from a roll in which every qualified Negro in the county is listed," he said.

Mr. Leibowitz said he planned to go to Birmingham in a few days to expedite the release of all the defendants, and to see what further action against them was contemplated by the counties in which they were indicted, and in which Haywood Patterson and Clarence Norris, two of the defendants, were three times convicted.

Doubts Another Trial

He indicated strong doubt as to whether there would ever be another trial, and said it was probable that an airplane would be used to bring the Negroes north from Alabama, after their ultimate release.

"No words can express how much that decision by the supreme court means to me," Mr. Leibowitz said. To me it was the climax of three years of nursing that case like a baby.

Chief Justice Charles Evans Hughes delivered the opinion Monday, April 1, setting aside the death sentences of Clarence Norris and Heywood Patterson.

Chief Justice Hughes said there was no controversy as to the constitutional principle involved—that if Negroes are excluded from jury service, equal protection of the laws, to all does not result.

ALABAMA PREPARES TO RUSH RETRIAL OF SCOTTSBORO BOYS

Montgomery, Ala.—Lieutenant Governor Thomas E. Knight, who as attorney general prosecuted Haywood Patterson and Clarence Norris, whose sentences were set aside Monday by the United States supreme court, moved to seek new indictments to prosecute the case to their "conclusion," he said.

No action can be taken before the high court's decision is returned to the Alabama supreme court.

The news of the supreme court's decision brought joy to eight of the Scottsboro defendants, but the ninth, Patterson, greeted it with shouts of derision.

"You must think I'm drunk to believe that," he said. Later when it was impressed upon him that it was true he broke into loud laughter from his cell in death row in Kilby prison, shouting, "A new trial, a new trial. That is good news and I'm mighty happy."

MAID-WELL GARMENT COM. PANY CLOSES DOORS

Forrest City, Ark., April 5.—The Maid-Well Garment company of this city, against which attorneys acting for the N. A. A. C. P. have filed suit on account of back pay due colored and white women employees under the NRA regional labor board forbade it indefinite period.

The company announced that it was forced to shut down when the SRA regional labor board forbade it to use the blue eagle. The blue eagle was taken away from the plant after complaints had been filed in Dallas, Texas, by John P. Davis, who made a personal investigation at Forrest City for the N. A. A. C. P. and the employees.

Crocker Awards Athletic Laurels

Before the largest crowd ever to attend in the history of the event, the annual Crocker athletic carnival was staged at West High gym last Friday night. The program was featured by two basketball games between the Moose lodge and the Crocker "Y" Big Five and the Central "Y" Leaders and the Crocker "Y" Stars, plus four boxing bouts, a wrestling exhibition, a ping pong match and the awarding of trophies to numbers of the winning league teams.

The Big Five ran up against a tangle in the Moose lodge quintet and dropped a hard played contest by a 28 to 22 score. The unerring aim of the visitors from the free throw line enabled them to register a victory over the "Y" boys, dropping in every one of their ten attempts. The Crocker "Y" Stars concluded a brilliant season by outscoring the Leaders, from the Central "Y," 31 to 16, in the preliminary game on the program.

Wayland Heath and Sam Taylor drew in four rounds in the main event of the boxing matches. Les Jefferson decisively outpointed Clarence Strothers in a three rounder and Buddy Tymony decisively Johnny Danforth in another three round affair.

In an exhibition wrestling bout, Allen Ashby won the Judges' nod over Bennee Elmore. Chuck Houseman defeated Walter Newsome in the ping pong exhibition, 21-14, 22-24, 21-18.

Gold basketballs were presented to members of the Corinthian Baptist team, winners of the senior league championship, and the "Y" Stars Intermediate league champs. The Flying Aces received gold medals for winning the junior championship. A bronze and walnut plaque was presented to Corinthian by A. P. Society Honors Negro Movie Star

LONDON PAYS \$50 A SEAT TO WATCH ROBESON PICTURE

London, England, April 5.—Paul Robeson became Europe's number one movie actor this week when fashionable West end broke down doors to witness a premiere of his "Sanders of the River" at \$50 per seat.

This, according to critics, is the highest price ever paid to see a picture. Many Americans were among those buying seats to the premiere, which grossed \$85,000. The film stars, Paul Robeson and Nina Mae McKinney, U. S. movie and stage actresses, are said to be at their best.

Leroy Eubanks was sentenced to twenty years Friday morning in Judge Jordan's court. Following the testimony of several character witnesses, the defendant changed the plea of not guilty of first degree murder in the slaying of Capt. Steve Howard to second degree to which he pleaded guilty and was immediately sentenced after the jury had been dismissed.

BARKER ALLEGED HOW- ARD SLAYER DIES

LeRoy Eubanks, 16, indicted for first degree murder in the slaying of Police Captain Steve Howard on March 2, went on trial before District Judge Russell Jordan on Tuesday morning. Carroll (Chance) Barker died the same day at the Broadlawn General hospital of wounds suffered in an allegedly attempted holdup of the Bonnie cafe March 15.

He was charged with the murder of the officer at the Unique tavern holdup, with Eubanks as his accomplice. Barker died maintaining his innocence and denied connection with either of the crimes.

County Attorney Carl Burkman and his assistant, C. Edwin Moore, are prosecuting the case. Police say Eubanks confessed that he was in the robbery, but Barker fired the shot that killed Howard. Charles P. Howard, defense attorney, will plead for the youth, as he believes that Eubanks was influenced by Barker.

Relatives Contest Will of Late Funeral Director

MRS. LENA WILSON WINS HUSBAND'S ESTATE

Mrs. Lena S. Wilson, former wife of T. W. (Tug) Wilson, funeral director, who was fatally injured last October, was awarded her late husband's estate in a direct verdict Tuesday. The will had been contested by ten immediate relatives of the accident victim: Arthur and John Wilson, brothers; Mrs. S. Joe Brown, sister, all of Des Moines, and another sister, Mrs. Ione Coleman, of Kansas City. S. Joe Brown was attorney for the Wilson estate.

The will, made November 7, 1932, prior to the divorce Mrs. Wilson obtained in 1933, was never destroyed. By its terms she received the funeral home, at 811 Fourteenth street, now operated by Montrose Johnson and Bonnie Herndon, insurance and the home on Fifth avenue. A property settlement was made when the divorce was granted.

Planned Remarriage

Wilson was on his way to meet his former wife for a remarriage when he met his death, evidence showed. After a year of separation resulting from a disagreement in 1932, the former Mrs. Wilson went to California, later returning here, when she obtained her divorce late in 1933. She had resided in Chicago since that time.

In the fall of 1934 plans were made to remarry after a reconciliation. Returning to Des Moines by motor Sunday, October 21, Mrs. Wilson ran out of gas between Colfax and Newton. In answer to a telephone call, Mr. Wilson decided to drive to her assistance. Early Monday morning his seven passenger Cadillac sedan failed to make a turn and struck a bridge, overturning one-half mile west of Colfax on highway No. 6.

Lived Five Days

Found by a passing motorist, C. C. Harken, of Waterloo, the injured man was taken to Colfax sanitarium and later moved to the Mercy hospital in

Des Moines, where he died Friday, October 26, from a blood clot on his brain and internal injuries.

The contested will was read December 14, 1934, and set for probate in January, 1935, and said in part: "Unto my beloved wife, Lena S. Wilson, I do hereby give, devise, will and bequeath all my property. Whatever real, personal or mixed, whatsoever or whosoever of every description, I do nominate and appoint my wife, Lena S. Wilson, attorney-in-fact of Polk county, state of Iowa, to be executor of this, my last will and testament." Signed, Tug W. Wilson. This document was witnessed by S. Joe Brown and H. L. Pope.

The Navajo Indians have been noted for liberal marriage and sex traditions, and through the custom of bequests the women have gained ownership of perhaps half of the tribal wealth. Ownership of her goods remains in her hands even following marriage, in contrast to usual Indian practice.

Usually he reads only in his leisure time. But once, he read the Bible through in 18 days, often devoting 12 hours to it. He regards the Bible as the word of God and literally true throughout. If there were fewer hypocrites in the Christian church there would be fewer charges of inaccuracies in the Bible, he holds.

By no means does Doctor Woodward spend all his spare time in Bible reading. He likes to walk. An evening stroll of ten or twenty miles is nothing for him. He has walked from Fall River, Mass., to Newport, R. I., and from Old Orchard to Portland, Maine, as well as from Springfield, Mass., to Hartford, Conn. One time he felt an urge to walk a distance equivalent to around the world at the Equator. So he equipped himself with two pedometers, one American and one French make. In one hundred months he had covered twenty-five thousand miles—and worn out both his pedometers.

ROOSEVELT'S AIDE IN- SULTS NEGRO WOMAN

New York, N. Y. (CNA)—Colonel E. W. Starling, recently appointed chief of the white house secret service detail, insults and caricatures Negro women. This was unwittingly revealed by Ray Tucker, author of an article in the New York Times Magazine of March 17th, entitled "The Man the President Must Obey." The article, intended to be an eulogy of the "sterling" qualities of Colonel Starling, is, in reality, a boomerang, exposing the anti-Negro attitudes of both Colonel Starling and Ray Tucker.

To illustrate the "affability" of "The Man the President Must Obey," Tucker relates an incident which occurred in the lobby of the white house. A Negro woman had sufficient money for bus fare to Georgia, but not enough for railroad fare. When she attempted to have the president secure a reduced railroad rate, Colonel Starling remarked: "Listen, mammy, you know that down south you're glad to ride in a cart behind a mule. Get along to that nice, comfortable bus and don't you worry the president."

Such is the remarkable "affability" of Colonel Starling, "The Man the President Must Obey," Ray Tucker, author of the article, referred to the Negro woman as a "Negress."

Early Warriors Made Use of Both Bow and Javelin

Early warriors not only employed the spear or javelin as a missile, but used bows and arrows with even more deadly effect. The bow was invented in prehistoric times, flat arrowheads found throughout Europe and Asia indicating an age of from 25,000 to 50,000 years or even greater for that weapon. First wars of which we have any record, writes John A. Menough in the Chicago Tribune, had opposing armies shooting at each other with bows and arrows, yet as old as the bow possibly can be, it is comparatively modern beside the first missile hurled by the basaltic cave man.

Obsidian Natural Glass

The Indians of early days often made their arrow heads of a natural glass known as obsidian, a variety of lava which is partially transparent and is very hard, brittle and sharp-edged. Obsidian is of a variety of colors ranging from black to gray, but the color of one specimen is usually uniform. In the United States the natural glass is found in Yellowstone park principally, although it is also found in other regions. It is rather widely distributed throughout the world, wherever volcanic action has occurred.

Fresh Water in Panama Canal

Fresh water from Gatun lake and the streams which feed the Madden dam and other reservoirs serve the Panama canal locks. The upper reaches of the canal are high above sea level, while the water in the Atlantic and Pacific oceans is at the low level and the locks must be fed from the highest level. It has cost millions to build and operate the dams and reservoirs. It is not necessary to have fresh water, although fresh water is lighter and exerts less pressure on the lock gates. Fresh water is used because of its availability in relation to gravity.

Balloon "Birds" Aid Flyers

Huge balloons in the form of grotesque birds are used by the British army air corps in training flyers. These air "ghosts" demonstrate how wind currents act, and when one of them blunders into the backwash from a plane propeller, the directions show vividly the action of the air and its direction. Five balloons might serve the same purpose as the ghosts amuse while instructing. Popular Mechanics Magazine.

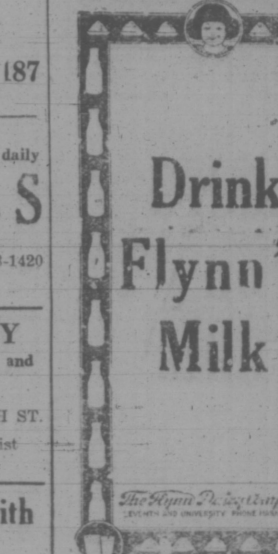
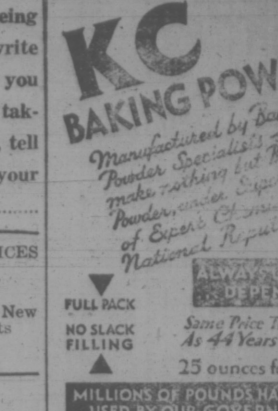

JUSTICE MAY PREVAIL—EVENTUALLY

The Supreme Court of the United States in its decision reversing the Scottsboro case again and remanding it to Alabama for another trial ruled that the systematic exclusion of Negroes from jury service was a denial of a fair trial as guaranteed by the constitution. Of course the court does not say and no one has ever contended that Negroes must be on all juries but it did say that the fact they were excluded shows that the jury list had been tampered with.

The most disgraceful angle of the record in the case was the fact that when the attorneys for the State of Alabama realized that their side of the appeal was in danger, names of Negroes were forged to the jury list in order to defeat the allegation that they had been excluded.

Justice Hughes further stated that for ten years Negroes had not been called for jury service although qualified Negroes were in the community subject to jury duty. This he said showed a systematic exclusion of Negroes from jury service.

It might be well to state at this time that Polk County, Iowa, is not altogether free from this complaint for no Negro has been called for Grand Jury service here for more than twenty years. According to Mr. Justice Hughes' ruling—and it is entirely correct—it is prima facie evidence that definite plans have been made to exclude Negroes. Alabama seems determined to obstruct justice to these Negro boys.

OUR LIQUOR PROBLEM

Facts brought out during an investigation of the Iowa Liquor control commission show that there is a woeful disregard for the law and common sense in the conduct of the state liquor business.

To the average citizen these disclosures are not new for they have been common gossip for many months.

The liquor traffic is hard to handle. Anybody will admit that and for this reason mistakes are bound to be made; irregularities are bound to occur. The number of them will depend upon the type of public servant selected to enforce the law.

However the Bystander believes that so far the liquor set up in Iowa is the best that has been devised yet. The trouble has been that neither the spirit nor the letter of the law have been followed.

Most laws are broken and yet we don't repeal them for that reason. Neither should the present liquor law be repealed. Such amendments as experience has taught should be passed and the system given a fair trial by men who will carry out the intention of the legislature.

NEGRO HEALTH WEEK

Negro Health Week is being observed throughout the nation. The late Dr. Booker T. Washington recognizing the importance of improvement in the Negroes health established it several years ago.

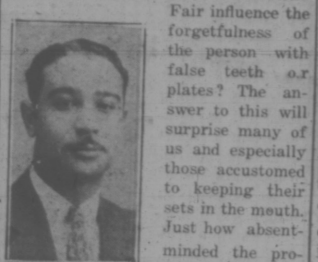

MAYOR ACTS TO PREVENT FURTHER TROUBLE

New York, March 29.—(Special)—The responsibility for the bloody riot here last week—the worst to occur in this section of the country in twenty-five years—falls squarely on the city administration and the New York police department.

A committee composed of members of both races, appointed by Mayor F. H. La Guardia, investigating the cause of the racial clash, is being told the true facts in the case.

Blame Lack of Relief

It is the consensus of opinion that the real reason for the rioting was the terrible unemployment situation among our people in Harlem, together with the lack of relief, discrimination and starvation of the Negro people, plus the vicious police hounding and persecution.

In a proclamation issued the day after the rioting, Mayor LaGuardia promised a sweeping investigation into the causes of the riot and said he would see that those responsible for the trouble were prosecuted.

In the latest hospital checkup, it was found that two persons were killed and at least a hundred or more were injured in the hand to hand fights. Five hundred thousand dollars worth of damage was done to the stores in the business district, it is said.

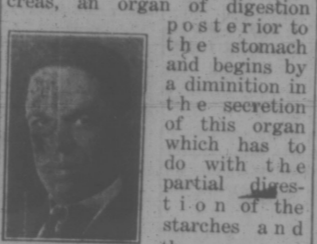

Governor Refuses Troops

Grimley, was told to discredit any report that it was the reds who were directly responsible for the trouble.

Reds Not To Blame

The Harlem disturbance can be laid to economic causes and poor housing conditions, one leader said. The false report that 16 year old Lino Rivers, a Porto Rican youth, had been killed in the S. K. Krays 5 and 10 cent store was sufficient to start the fireworks.

That the unemployment situation may have had something to do with the outbreak is evidenced by the fact that between 55 and 65 per cent of the people of Harlem are jobless and that the relief given colored people is about one-third of that given in other sections of the city, and as a consequence they live in misery and poverty.

The committee was further told that the relief for a family in Harlem is \$31 per month lower than for families in other sections of the city.

TO HEAR DAWSON'S NEGRO SYMPHONY PLAYED IN DIXIE

Tuskegee Institute, Ala.—The Birmingham Civic Symphony orchestra will present William L. Dawson's Negro Folk Symphony No. 1 at its regular concert in Birmingham on Tuesday, April 2. This will be the first presentation of the symphony since performances were given by the Philadelphia Symphony orchestra in Philadelphia and New York, under the direction of the eminent conductor, Leopold Stokowski.

The fact that the Birmingham Civic Symphony orchestra, now in its third season, has included the symphony by the promising young conductor, William L. Dawson, is of especial interest in Alabama for the reason that the composer is a native of the state, coming from Anniston, and is now director of the school of music at Tuskegee institute.

ABYSSINIANS SEND NOTES TO LEAGUE OF NATIONS ON CONTROVERSY

Addis Ababa, Ethiopia.—A dispatch cabled to the New York Times and associated newspapers on Tuesday stated that another Italian-Ethiopian incident, different from previous ones, had occurred in Eritrea. On midnight, March 23, three Italian soldiers were said to have encountered armed Abyssinians 300 yards on the Italian side of the frontier.

One Italian private was mortally wounded. One Abyssinian was killed and left behind with sixty rounds of ammunition in the hasty retreat. Lack of ability on the part of the emperor of Abyssinia to control his chieftains in outlying sections is blamed for the latest trouble, the dispatch said.

New York.—(ANP)—Foreign correspondence and Ethiopia's notes to the League of Nations disclose that Emperor Haile Selassie and his aides are showing Mussolini, the Italian dictator, who threatened Ethiopia's sovereignty through a large scale show of troops, some plain and fancy diplomacy that, if Italy's threats are carried out in the end, will cause Italy's aggression to stand out in history as one of the most wanton acts ever recorded in the relations of nations.

In interviews from Addis Ababa, reported in England by Harold Pemberton in the Daily Express and in United States newspapers through the Associated Press, the emperor has made it plain that Ethiopia does not intend to be bullied, intimidated, nor swayed from its course by Italy's war-like actions, although his intentions are to exhaust every available peaceful means to come to an agreement with Italy.

N. A. A. C. P. PROTESTS ITALIAN MOVES AGAINST ETHIOPIA

New York, March 29.—In a letter addressed to Secretary Cordell Hull of the state department on the Italian-Ethiopian situation, the N. A. A. C. P. voiced an appeal "on behalf of the continuance of the status quo and the maintenance of peace."

The letter declared the association "has begun to fear that a situation is shaping itself in which Abyssinia and neighboring territories in Africa will become a theatre for European aggrandizement and discord."
