Homer Harris Is Chosen Iowa Football Captain

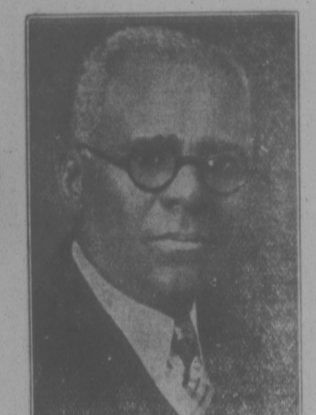
Former Gov. Lowden's Plantation to Be Made Arkansas Farm Colony First Negro in Hawkeye History to Be Honored As Leader in Big Ten

J. B. WATSON, COLLEGE HEAD, TO MANAGE HUGE TRACT

Hot Springs National Park, Arkansas—(Special)—Last week national interest was again focused on the farm tenancy question when it was announced by J. B. Watson, president of Arkansas State A. M. and N. college, that one of Arkansas' largest plantations will be divided into tracts of twenty acres or more to form an Arkansas first privately owned Negro farm colony.

President Watson, only Negro on the Arkansas Farm Tenancy Commission, appointed by Governor J. M. Futrell, was here attending the commission's third meeting and made the announcement concerning the colony after a conference with Frank A. Lowden, former governor of Illinois, who for almost two decades has owned and operated the extensive 13,000 acre tract at South Bend, Arkansas, known as the Lowden plantation. For a year the property has been in the custody of President Watson and three associates: T. G. Dalton, C. B. Tracy and J. E. Clayton.

President Watson, who will manage the colony, said 150 families—mostly sharecroppers from Arkansas, Louisiana and Mississippi—would be moved onto the plantation. It will be divided into small tracts, with the colonists being allowed to purchase one or more tracts. Most of the land is now under cultivation, but a part is in woodland. The colonists will be encouraged to buy both kinds of land and to work out a forestry program in connection with their farms. The tracts will be sold, it was announced, at terms much more reasonable than those paid by the resettlement administration for its tracts bought in the state of Arkansas.

BOY 17 FOUND HANGING FROM R. R. TREESTLE

Mob Joins in Big Pre-Xmas Celebration

Washington, D. C., Dec. 11—The United States was asked this week to probe the lynching of 17-year-old J. B. Grant, who was found hanging from a railway trestle on the outskirts of Laurel, Miss., Saturday. It is believed the United States will take a hand in this matter the same as it did in the peonage case in Arkansas which resulted in Paul D. Peacher, city marshal of Earle, Ark., being fined and sentenced to prison.
Laurel, Miss., Dec. 11—(Special)—Dixie whites staged a pre-Christmas celebration here Friday when the whole town turned out to join in the lynching of a seventeen year old youth, J. B. Grant. It was by far the most spectacular and gruesome event of its kind to be seen in these parts.

After riddling the youth with more than a hundred bullets, the body was tied to an auto and dragged through the streets, where thousands of white men, women and children cheered madly. At intervals along the route the car dragging the body halted so that little children, using their parents' firearms, could pump lead into the inert form.

Taken to the public square, speeches were made upholding white womanhood. "This is an example of what happens to darkies who forget their places," said one member of the mob. The cheers from the mob resembled that of a football crazed crowd.

When it was apparent that the crowd had grown weary of its three hour celebration, young Grant's body was taken to the outskirts of the town and hanged to a railway trestle.

Principal Removed For Cruelty to Boy

HARLEM WINS VICTORY IN CHILD BEATING CASE

New York, Dec. 10—(CNA)—Harlem's iron determination and persistent protests bore fruit this week with the removal of Gustav G. Schoenchen, white principal of P. S. 5, Edgemoor avenue and 140th street. Schoenchen's removal, demanded by the community under leadership of the permanent committee for Better Schools in Harlem, was caused by his brutal beating of Robert Shelton, a 14 year old Harlem schoolboy, on October 21st.

Another victory was won this week when Frank Shelton, 21, a brother of the beaten boy, was freed by Magistrate Peter A. Abeles in Washington Heights court of a charge of disorderly conduct. The elder Shelton boy was arrested for picketing P. S. 5. Schoenchen is still facing trial for assault in special sessions court, to which the case, after many delays and postponements, was finally referred by Magistrate Abeles.

Civil Service Head Decides to Be Fair

MOBILE POSTMASTER APPOINTS NEGRO

Mobile, Ala., Dec. 10—Postmaster William B. Taylor has finally appointed a colored carrier here, after considerable agitation on his part to white men on the civil service list. The colored carrier was appointed November 25. He was number one on the list, but had been passed over twice by the postmaster September.

After Postmaster Taylor passed who has named two white men since over colored men in the first and third positions on the list, a protest was sent to the postoffice department by the N. A. A. C. P. in New York. The postmaster, however, appointed a second white man when a vacancy occurred November 1, ignoring the colored men in number one and number two positions. When the third vacancy occurred, a colored man was chosen.

COLORED CCC BOYS ON 100 PROJECTS

Washington, Dec. 10—(C)—About 60,000 colored CCC boys have worked on one hundred national and state park recreational and historical sites throughout the country during the past three and a half years, according to the emergency conservation work.

Raleigh, N. C., Dec. 10—(C)—December 11th became the new death date for Martin Moore as North Carolina supreme court affirmed his sentence on Wednesday. Moore was convicted of slaying Miss Helen Clevenger in Asheville last July.



Ohioans Seek Decision Change

ASKS REHEARING IN CIVIL RIGHTS CASE

Cleveland, Dec. 10—An application for rehearing in the case of Sissle versus Harvey has been filed in the Ohio supreme court by attorneys acting for Mrs. Ellen Sissle of this city. The Sissle case attracted nationwide attention when the Ohio supreme court recently refused to review an appeal from the opinion of the court of appeals of Cuyahoga county. Mrs. Sissle was denied service in a dress shop operated by Harvey, Inc., located in the Terminal Tower building, and in a lower court under the Ohio civil rights law and was awarded damages of \$100. The dress shop appealed to the Cuyahoga county court, which reversed the decision on the ground that the dress shop was not a place of public accommodation, and, therefore, did not come under the civil rights law. Mrs. Sissle's lawyers, Chester K. Gillespie and Norman L. McGhee, then asked the Ohio supreme court to review the case, which the court refused to do. The new petition is an effort to get the court to reconsider its decision and review the case.

Jesse Owens Sees After His Parents

BUYS THEM HOME WITH EVERY IMPROVEMENT—GOES TO HOLLYWOOD

Cleveland, Dec. 10—(Special)—Part of that which an admiring world gave him went to Jesse Owens' mother, it was revealed here this week. Owens used part of the \$50,000 he has earned since his return from the Olympic games at Berlin to buy his parents, Cleveland and Emma Owens, an eleven room house, with hardwood, up-to-date plumbing fixtures and a two car garage.
"It was certainly gratifying to me to see how happy mom is now," beamed the famous athlete who in November admitted he had deserted the ranks of the amateurs. The sprinting star who holds more world records than any track man in history, announced his intention to go to Hollywood, where he is to fulfill motion picture and radio contracts.
"We're starting to look around at building lots here," said 21 year old trim Mrs. Jesse Owens. "We want to have a house built to our specifications."

Investigation Exposing Virtual Slavery Racket

PEONAGE IS UNCOVERED IN FLORIDA CAMPS

Jacksonville, Fla., Dec. 10—Harrowing tales of a whole community held in virtual slavery on a turpentine farm where the pay was fifty cents a day were told to investigators for the International Labor Defense, the National Negro Congress, the National Association for the Advancement of Colored People and the writer, in a sweeping investigation into peonage conditions in Florida last week.
According to several of the modern day slaves who were questioned, no one dares to leave the camp for fear of being instantly shot and presumably killed or badly injured. They are forced to spend their fifty cents a day wage in the "company" commissary, where prices are double those in the city.
The investigations resulted from the falling a few days ago of four white men accused by two Negroes of forcing them back to work at the points of guns when they attempted to go elsewhere seeking a living wage.
One of the most astounding disclosures was that the Barker camp, tired of paying even fifty cents a day, was instrumental in the withdrawal of dozens of young boys from the public school, to work chopping pine trees at 25 cents a day.

History to Be Honored As Leader in Big Ten

For the first time in Iowa's gridiron history of over fifty years, a Negro was chosen as captain of the football team. Homer Harris of Seattle, Washington, a brilliant end for the Hawkeyes since 1935 was elected to pilot the 1937 eleven at the annual players' banquet at the Memorial Union at Iowa City, Monday night. There is no record of a colored athlete ever selected in the Western Conference circles to lead a Big Ten football team. In other lines of sports, however, septa stars have captained their squads.

Only last week, the spectacular wingman nosed out his teammate Ozie Simmons, as candidate for the 1937 Chicago Tribune most valuable player award. Members of the team gave him twelve votes for the honor. Harris was the first member of his race ever to be nominated in Big Ten football since it was instituted years ago.

Inspiration and Spark Plug
Members of the team, also Coach Ossie Solem, declared Harris' dependable performance made him the best man on the squad and was the inspiration and spark plug even in the face of certain adversities. The Seattle youth was a bear at catching passes, deadly tackler and a clean fighter, according to the consensus of opinion from opponents.
A recent news release tells that "just before Iowa played Purdue, a game which the Tall Corn boys lost by two touchdowns, Harris, seeking to revive a fighting spirit on the squad circulated a petition in the dressing room which pledged every player to give his best on the field."

Bronze Giant
In describing Harris, critics say he is a shifty, heady player and has been rarely knocked off his feet by blockers. They say he could diagnose a play quicker than any man in the Big Ten and was the fastest man in the conference under punts. As a punter he averaged forty yards. The lanky athlete is also a track star winning the state shot put championship in 1936.

The Iowa captain is a bronze, good looking giant standing six feet two inches and weighs 195 pounds. Very bashful in manner, and reluctant to talk about himself, he is considered "exceedingly handsome." Studying a pre-medical course, he is a junior at the university. During his prep school days, Harris was, for three years, all-state tackle for Garfield High in Seattle, and one year he was named on the all-coast selection.
Started to Go Home
Homesickness this summer almost deprived Iowa of one of the greatest players of all times. Interviewed this past spring in Des Moines by your writer during the Drake relays of which he was a member of the Hawkeye shuttle hurdle relay team, Harris expressed a desire to go back to Washington.
"I would like to go home this summer. I'm beginning to long for the hills, mountains and pine trees," he confided almost in earnest. This climate was most distasteful, he said, and would even consider attending a school closer home, maybe in California and not return to Iowa to finish his course.
"You won't want to do that, Harris, you're one of the best Iowa has had in many years," your writer told him. "We'll be seeing you at the homecoming this fall!" Your writer's conclusion was correct when it was later stated that "a little pressure exerted in the right direction would bring the grid ace back to the Hawkeye lineup this fall."
Wilkins of the Crisis
Much controversy and indignant comment arose last year over the fact that Simmons, whose three years of scintillating deeds are known throughout the nation, was not elected to lead this year's Hawkeye team. To quote Roy Wilkins of The Crisis in the December issue, who says, "No-

one knows the truth of the situation at Iowa; but it is a safe guess that Oze's difficulties began in November, 1934, when he ran wild against Northwestern and the Wildcats' coach publicly admitted that Simmons might become greater than Red Grange.
That kind of publicity at the beginning of a career is not so good for a colored lad and it probably had a bad effect on his teammates. Anyway, Oze has not had smooth sailing. He remains a great backfield ace in spite of the hard way he has had to go...

Man Disappears, Official is Silent

ARKANSAS GOVERNOR DENIES WEEMS LYNCHING

New York, Dec. 10—In response to an inquiry by the N. A. A. C. P., the office of Governor J. M. Futrell of Arkansas has replied that it has no evidence of Frank Weems. Weems is a Negro sharecropper who disappeared about a year ago under circumstances which led to the belief that he had been lynched by night riders or hired thugs of plantation owners. Weems was active in the organization of the Southern Tenant Farmers Union and it is believed that this activity was responsible for his disappearance.
Protests by the S. T. F. U. led the sheriff of the county and Governor Futrell to announce that Weems was not dead and that they would produce him at the proper time. Months have passed and nothing has been heard of Weems, hence the inquiry by the N. A. A. C. P. The N. A. A. C. P. has written Governor Futrell again, asking if his office has any evidence that Weems has not been lynched; and if his office has any evidence that Weems is alive.

Lesson for December 13

JOHN'S VISION ON PATMOS

LESSON TEXT—Revelation 1:4-18.
GOLDEN TEXT—Fear not; I am the first and the last... behold, I am alive for evermore. Revelation 1:17, 18.
PRIMARY TOPIC—When John Saw Jesus Again.
JUNIOR TOPIC—Jerusalem, the Golden.
INTERMEDIATE AND SENIOR TOPIC—Living to the Ever-living Christ.
YOUNG PEOPLE AND ADULT TOPIC—The Living Christ Among the Churches.

The first chapter of the Revelation, while it is an introduction to the entire book, is worthy of study by itself as a glorious revealing of Jesus Christ, his person and work. Some will wish to use the chapter as a preface to the study of the solemn and instructive messages to the seven churches of Asia which are found in chapters 2 and 3; but for most schools it will be better to concentrate on the messages of the chapter itself.

I. His Person.
While many of the characteristics of the Son of God are here presented, two are particularly emphasized. 1. His eternity (vv. 8, 11, 17). Jesus Christ is presented in verse 5 as the faithful witness and first begotten of the dead, "who is the ruler 'over all the kings of the earth.' The followers of Christ have a glorious captain and leader. The kingdoms of all the earth are his by right. Some day he will rule in fact and in person.

The infinitely beautiful description of our Lord in verses 13 to 16 is almost beyond interpretation. Have you seen him in his majesty and glory? The one who is "in the Spirit on the Lord's Day" can still see "him who is invisible" (Heb. 11:27).

II. His Work.
1. His victory (v. 18). He died for our sins but "was raised again in his justification" (Rom. 4:25). We have not a dead, but a living Saviour. He has "the keys of death and hell." The one who follows a human leader parts with him at the grave. But he who follows Christ "in the midst" when he passes over into the next world, for he is there, and he has the keys of all authority, not only in this world but also in that which is to come.

III. His Love (v. 5).
How deep and rich was his love toward us. It sent him to his cross. His redemption (v. 5). He "washed us from our sins in his own blood." We read in Hebrews 9:22 that "without the shedding of blood there is no remission." The cults and creeds which deny or ignore the need of cleansing in the blood of Jesus Christ may be religious but they are not Christian.

IV. His fellowship (v. 13).
The handclaspers are churches and the stars are God's messengers. They are not stars in the world; they are "in the midst." Do we recognize his presence? 5. His return (v. 7). "Behold, he cometh with clouds." How can anyone read the New Testament and fail to see, and to teach and to preach the Lord's return? He is coming again. What is our duty in the light of his coming? a. To live lives of purity and Christian nobility. (Head J. John 3:3, and compare vv. 1 and 2.) b. To be diligent in sacrificial service. "Occupy till I come" (Luke 19:13) is the command of the one who "went into a far country to receive for himself a kingdom and to return" (Luke 19:11).

War of Postal Systems, a Most Curious Episode

The entry of the Low countries into the Holy Roman empire in the Sixteenth century brought on one of the most curious episodes in the history of mails, a war between the local carriers supported by the townspeople and the Imperial post which had come in with the Spanish army, relates a writer in the New York Herald-Tribune. The industrial cities of the Netherlands were at this time the richest in Europe and over the centuries had obtained a large measure of local self-government which included the operation of a primitive courier system to serve the needs of the merchants and guilds. The postmen were appointed by the burghmasters and operated over individual routes for their own profit. These routes, which were traveled on foot, horseback or by boat, connected all of the towns of the Netherlands and extended to the industrial centers of England, France and Germany. The mails carried were considerably and the Imperial post immediately set out to obtain the business, but this the townspeople stoutly resisted. The carriers were their concessionaires and they would not see them interfered with. When requests to have the Imperial post suppressed failed, the towns took things into their own hands and attempted to forcibly oust it. The Imperial postmen were seized and their mails turned over to the local carriers, and when government officials tried to break up the local posts, they were set upon and beaten by the mobs. This curious little "war" at times reached sizeable proportions. Troops had to be called to quell the riots and after one severe outbreak in Antwerp five of the rioters were hanged. The end of this postal war came only with the complete independence of the Netherlands.

Leyden, Land of Liberty

Holland never erected a Statue of Liberty at the entrance to its principal city, notes a writer in the Boston Globe, but long before the American "land of the free and home of the brave" became important on the map, Holland was the European "Land of Liberty." Here John Robinson kept the light of religious liberty burning and induced his parish of "Pilgrim Fathers" to embark on the Mayflower in 1620. Here is the "High School" started by William, Prince of Orange, in 1575, which in a few years became the most famous university in Europe. Niebuhr in his Roman history says that "no locality in Europe is so memorable in the history of science as its venerable halls." When the English and French were persecuted in their own lands, Leyden was their refuge. Leyden is the only place on earth that ever refused to be executed from the guillotine. When its prince in 1574 wanted to reward the inhabitants for their gallant conduct in a siege, he offered exemption from taxation of a university. They chose a university.

The Coney is a Strange One

The hyrax or coney, an animal about the size of the rabbit, is rodent-like in general appearance, having long front teeth and pointed muzzle. However, he does not have the usual five toes and strong claws of the other members of the gnawing family and anatomically resembles more closely the elephant and rhinoceros than any other species living, says Nature Magazine of Washington. The toenails are short and rounded like those of the huge pachyderms. The large front teeth, at first glance resembling the strong gnawing teeth of the squirrel, are not flat and chisel-shaped, but instead are three-sided and pointed like the fangs of the great cats. These upper teeth grow throughout the animal's life as do elephants' tusks. In structure, the coney's teeth of both jaws resemble those of the rhinoceros and its extinct relative, the palaeotherium.

Antigua, Guatemala

Antigua, Guatemala, is a city of ruins. It is a dead city, a city of memories, a thing of the past. There are many homes, shops and stores and a certain amount of buying and selling. But the ruins dominate all. Antigua was not the first capital built by the Spaniards. Tecpan, short-lived, for the Indians drove out their enemies, was the first. Ciudad Veja was the second and became extremely unpopular when Alvarado ordered 800 Indians to bring, daily, each a reed full of gold dust, punishing with slavery anyone who failed to obey.

Strange Sea Fish

One of the strangest fishes ever taken out of the sea was a hundred-pound bass-shaped animal caught by rod and line off Tahiti in 1928. With the exception of the teeth, every part of it—scales, eyes, flesh, bones and even its blood—was as green as grass.—Collier's Weekly.

Add to the season of dizzy spears and crazy dope spills, the election of a Negro as captain of Iowa university's 1937 football team and you get a good idea of just how cockeyed the gridiron picture really was this fall. The election of Homer Harris came as a surprise to every one. Your correspondent happened to be in a group of white sports writers when the news came through. They all expressed surprise and the report, coming so suddenly, left them no time to conceal their emotions. Many varied were the expressions that came before the speakers could get phrasing arranged. The main seemed to be that Harris would make a brainy leader. We all hope that, but the wish of these white men meant that it would not "go to his head." Why should the captaincy affect our boy any more than it would any other boy who happened to win it? You answer that one.

In this same bunch that night your humble servant was put on the grill about our opinion of Ozzie Simmons and his post-season activities. Most of those present resented the statements Simmons had made about the lack of intelligence of our high school and college athletes. We took the stand that anyone who becomes a news figure is too often asked for statements about something he knows nothing about and the statements are printed probably with a few extra trimmings. Whatever Ozzie said was no more than what was asked for, whether it was good taste or not.

Negro Players of Southern Colleges

There was another matter that occupied our attention. It was not mentioned during the season, but a check of records shows that a Negro back, Williams of New York university, played an entire game against North Carolina State and was treated just like any other man on the field. Don Keller of Western Reserve beat West Virginia. Then they say that southern schools object to the presence of our boys against their teams. It has long been established that northern school officials themselves are the first to mention keeping their Negro players out of the games with southern schools. Where this falling over backward in defense to an old southern custom is not done, nothing is said or comes of it.

High Schools

For the first time in many years no Negro boys made the all-state high school team. Harold Nash of Clarinda, made the third team and Al Thomas of East got honorable mention.

North high opened their basketball season with Jack Howard as a star.

ROSENWALD FUND HAS

\$7,000,000 LEFT

Chicago, Dec. 3—(C)—President Edwin R. Embree of the Julius Rosenwald fund announced Monday that they left \$7,000,000 left of the fund established by Julius Rosenwald in 1917. LIFE TERM MANDATORY FOR EACH IN DEATH OF NEGRO

Detroit, Mich.—Five members of the Black Legion, charged with the "thrill killing" of a Negro World War veteran, were convicted of first degree murder Saturday night by a jury in recorder's court. Recorder's Judge Donald Van Zile said he would pronounce the sentences Friday.

Three of the defendants, Harvey Davis, John Bannerman and Ervin D. Lee, already are under life sentence for the Black Legion "execution" of Charles Poole last May.

The other defendants are Charles Rouse and James Roy Lorraine.

Seven Hours

The mandatory penalty is life imprisonment. The seven women and five men jurors reported their verdict seven hours after beginning deliberations.

The convictions in the Coleman case mark the second major victory for the state in its campaign to wipe out the black-robed cult, whose members swore to a blood oath of "Americanism" and hatred against Jews, Negroes, Catholics and Communists.

May, 1935

They were convicted Saturday night in the fatal shooting of Silas Coleman. Coleman was slain near Pinckney, Mich., May 25, 1935, and his body dumped in a swamp.

Dayton Dean, two-gun "trigger-man" of the Black Legion, also under a life term for the Poole killing, testified Coleman was shot because Davis, a "colonel" in the secret order, wanted "some target practice."

"Beaten White Man"

Dean declared Coleman was taken from Detroit to Pinckney. "He (Davis) told us he had a Negro who had beaten up on a white man," Dean related from the stand.

"We were at a Saturday night party at Davis' cottage with our wives and all of us left, leaving the women behind, to shoot Coleman.

"Coleman was taken out of an automobile and when he learned he was to be killed started running. Several shots were fired and he fell dead."

OPPOSITE COLORED GOLF CLUB IN WESTCHESTER

Millwood, N. Y., Dec. 3—(C)—With dramatic suddenness, this town began seething over the race issue Saturday when it was learned that

colored people are to have a \$175,000 golf and country club near here. Protests were filed with the town council. The proposed club is near estates owned by Gerald Swope of General Electric, and Major Edward Bowes, of radio fame.

Robert T. Wood, a member of the town council, said he didn't see how colored people could be prevented from using the property so long as they broke none of the rules governing a country club.

"Safety First" Creatures

Many creatures pretend to be what they are not, in order to avoid being seen and captured by their foes. An example is the stick insect, says 'The Bits Magazine. Less known is the caterpillar of the peppered moth. When these caterpillars have stripped a twig of its foliage, they would be very conspicuous on the bare plant, so they stiffen themselves and pretend to be parts of the twig.

Processing

Processing means to subject (especially raw material) to a process of manufacture, development, preparation for the market and so on; to convert into marketable form, as live stock by slaughtering, grain by milling, cotton by spinning, milk by pasteurizing or fruits and vegetables by sorting and repacking. A processing tax is a tax levied on these operations.

The Eastern Star

The Order of the Eastern Star, composed of members of Masonic families, apparently originated in France in 1774. It was organized in the United States in 1778 in New York city by French officers. On May 18, 1783, members of various chapters met in Boston, Mass., and formulated a ritual. It is said that General Lafayette was greatly interested in the formation in the United States of the organization.

Largest Quarry in U. S.

The largest quarry in the United States is in Ohio, a sandstone quarry near Amherst, where there are also a number of others. "These shocking occurrences went on in Aberdeen well into the Seventeenth century, although the last person to be tried by a lord of Justiciary was brought up at Dumfriesshire Circuit court as late as 1709 and the very last person to undergo trial for witchcraft in Scotland was an old woman who was brought before the deputy sheriff of Sutherland and condemned, at Dornoch, in 1722.

"Not everybody in Scotland was pleased by the cessation of witch burning, and the repeal of the statute of King James authorizing the same, 1735.

"In 1743 the noted Erskine Secceders from the Church of Scotland—declared that 'the penal statutes against witches have been repealed by Parliament contrary to the express law of God'; and more singular still, even in 1815 Rev. James Paterson, M. A., minister of the Associate Congregation of the upland parish of Midmar, Aberdeenshire, felt it necessary to issue a pamphlet, 'A Belief in Witchcraft Unsupported by Scripture.' It was printed by Chalmers, of the (still existing) Aberdeen Journal, a strange production, very rare, but an item in the local collection of this library."

New York, Dec. 10—The forces which have campaigned since 1934 for a federal anti-lynching law are being co-ordinated by the N. A. A. C. P. for a new drive to secure the passage of federal legislation against lynching in the Seventy-fifth congress, which meets in January.

The present activity of the N. A. A. C. P. is to perfect the strategy of the drive in the new congress so that work can begin promptly as soon as congress convenes.

SUBSTANTIAL EXPERIMENTS

The Dunbar National Bank, located in Harlem in New York City, announced that it is paying to Christmas savings depositors \$56,000. This represents an increase of \$8,000 and 350 more depositors over 1935. The bank is rated as a sound financial institution.

John D. Rockefeller, Jr., is the principal owner, but seventy-five per cent of the employees are Negroes. This institution is cited as one of the most outstanding examples of interracial cooperation in the country.

The Rockefeller interests have contributed vast sums to Negro education but this is one of the few institutions where a philanthropist has established a project where men and women may put into practice what they learned in the schools supported by philanthropic people.

Recently ex-Governor and Mrs. Frank O. Lowden of Illinois have started an unusual experiment in Arkansas whereby Negro farmers, mostly sharecroppers, may purchase tracts of land on a basis lower than that offered by the federal resettlement administration. The manager of the project is a Negro college president who is a member of the Arkansas farm tenancy commission appointed by the governor of that state.

IOWA UNIVERSITY COMES THROUGH

The Iowa University football squad, evidently acting with the approbation of the Coach Solem and the athletic committee, named Homer Harris, a Negro, captain to pilot the team next year. Harris is an outstanding player, is well liked by his teammates and will make a valuable leader.

The Bystander has made inquiry among a number of leading as well as the so-called ordinary white citizens in Des Moines and in each instance they have hailed Harris' selection not only a good one for the team but also state that it is an indication of a growing spirit of racial tolerance at the University.

The Bystander criticized the failure to select Oze Simmons captain for 1936. However, it is equally desirous of commending Coach Solem and the squad for overlooking color in this instance and arriving at a decision on its merits. After all this is what any Negro wants and ought to expect.

IT IS WELL TO SPEAK UP

During the recent political campaign, The Bystander criticized the Social Security Act because the job insurance section excepts from its operation more than fifty per cent of the gainfully employed Negroes of the country. This is a most unfortunate part of the law for the same provision eliminates millions of whites also. Last week The Pittsburgh Courier editorially condemned this section of the law and urged that the provision be changed at this session of congress eliminating these rank injustices. The Courier supported the New Deal during the election and of course was silent on this great question even though those for whose benefit the paper is published were vitally in-

terested. This of course is politics. However it is encouraging that The Courier is calling this matter to the attention of the Democrats now, and are insisting that the injustice be eliminated. After all if it has any influence with those for whom it fought it ought to be in a better position to get results than the fellow who was on the other side of the fence.

NEW GARB SHIELDS SOLDIER FROM GAS

Entire Body is Protected by French Invention.

Paris.—The French army has perfected a garment which protects every inch of the entire body against a gas attack.

This was the statement of Professor Andre Kling, inventor of tear gas, and father of the gas mask, when interviewed here. "Gas-masks today are only a secondary protection," he said, "Military science has gone so far that liquid poison may be rained upon a city—poison which burns and destroys living tissues.

"In order to fight that, we have perfected a garment which will protect the individual from head to foot. These would be distributed to front-line soldiers, but it is manifestly impossible to provide such a garment for every member of the civil population."

Kling, who is director of the Municipal laboratory of Paris and president of the sub-commission for the protection of the civil population of the Seine, continued:

"Originally poison gases were directed only against the lungs, but now, that they have been perfected to the stage where they will destroy skin and living tissues, the task of protection has become more difficult."

It was Professor Kling, who, three days after the first German gas attack, which occurred at five in the afternoon, April 22, 1915, and which killed 5,000 men and burned out the lungs of many thousands more, invented the original gas mask.

Streets Paved With Tin

Cans Found to Be Successful
West Palm Beach, Fla.—Tin cans are a reality, not a name, in West Palm Beach.

For nearly ten years Superintendent D. D. Howard of the department of streets and public improvements has been utilizing discarded tin cans for street building purposes, collecting the cans from the city incinerator.

The cans take the place of about half the amount of crushed rock that would otherwise be used in the street base, saving half the cost of the road-bed.

According to Superintendent Howard they make excellent streets, and throughfares with a foot thick layer of tin cans rolled down to half that thickness are holding up as well as those surfaced entirely with rock.

Six months after the cans are spread over the roadbed and rolled, the tin undergoes oxidation and the cans are transformed into a firm, hard mass. The plan originally was used in California.

Health Talks

PEPTIC ULCER

A peptic ulcer is a round perforating ulcer that occurs in the stomach or the upper part of the intestinal tract to which acid gastric juice has access.

The actual causes is not known, but many things are thought to be contributory in its cause, i. e., hyperacidity, irritating foods, excessive smoking of tobacco, body burns, mouth infections and injuries.

Pain is the most constant symptom. It may be sharp or dull sometimes radiating to the back on a level with the tenth rib. Sometimes it is only a sense of uneasiness or a burning sensation near the stomach. The pain may occur from ten or fifteen minutes, to two three hours after taking food. Food will sometimes aggravate the pain but most often the patient is greatly relieved with a full stomach as the food helps to dilute the acid in the stomach.

Indigestion is another constant symptom. It usually because of pain and indigestion, that the sufferer seeks a physician's advice. Nausea and vomiting may occur at intervals. The patient frequently vomits acid material and undigested food particles, and occasionally bright red blood.

Patients suffering with peptic ulcer should be constantly under the care of a physician. Treatment is usually medical but sometimes requires surgery. Sufferers of this condition should follow a strict dietary regime.
