JIM CROWD IN RELIEF

Negroes Suffer and Die in Angry Flood Waters

Eleven Negro Students Graduate from Des Moines High Schools Rescue Boats Refuse Aid To Colored, Left to Fate As They Scream for Help

Colored Race Shouldn't Suffer For Green's Murder Charge, Protest Leading Journalists

New York, Jan. 28—Prompt condemnation of the wholesale firing of Negro apartment house and domestic workers because of the murder charge against Major Green, a colored porter, was registered by New York daily papers and columnists this week.

Following the alleged confession of Green last week to the brutal murder of Mrs. Mary Robinson Case in the Jackson Heights section of New York City, the charge was made by a group of Brooklyn colored citizens that hundreds of colored people are losing their jobs. This charge brought forth an editorial in the New York Herald Tribune on January, entitled, "Color, Crime and Trouble." The Tribune declared:

"Because he is a Negro there seems to be a most unfortunate and unfair disposition in this city to assume that his alleged crime was a racial crime, that it was one to which he was predisposed as a Negro and, therefore, to inflict punishment for it upon other members of his race. If there is any such movement under way in New York City, it should not only stop abruptly, but should go into reverse; for any such inclination is truly unfair.

Let us remember that an overwhelming majority of our colored folk in domestic and similar services very badly need their jobs and hold them by faithful and courteous service. Do not be unfair, unkind or stupid enough to visit your resentment upon good citizens of darker complexion for no other reason than that the suspect in this case is a colored man."

Also condemning the practice of blaming the whole Negro race for a crime supposed to be committed by a colored man was Dorothy Dunbar Bromey, columnist on the woman's page of the New York World-Telegram.

Seek Civi. Honor For Major Wright

Philadelphia, Pa.—This year there has been a serious movement on in Philadelphia to secure for Major R. B. Wright, Sr., the Bok award. This award goes annually to the "most distinguished citizen" of the Quaker City. A number of church organizations, business organizations and several outstanding leaders in the colored group, and many white people of prominence, including some modest but influential Quakers have endorsed the founder and president of the Citizens & Southern Bank and Trust company, and the founder and president of the Haitian Coffee and Trading company, former college president and father of a bishop for the chief honor of the people of the second American city.

FOUR SLAYERS—THREE COLORED—DIE IN ELECTRIC CHAIR

Ossining, N. Y., Jan. 28—(ANP)—Four convicted murderers, three of them colored, walked "the last mile" in Sing Sing prison Thursday night, and met death in the electric chair. The Negroes were Chester White, 35, Charles Ham, 28, and Fred Fowler, 18. The white man executed was Italian John Fiorenza, slayer of Nancy Titterton, author, in New York City.

Pensacola, Fla., Jan. 28—Protest has been lodged with the postoffice department in Washington because the postmaster at Pensacola, Florida, has passed over the name of Chauncey A. Borrass eight times in making appointments. Mr. Borrass is No. 1 on the civil service eligible list. Despite this fact eight appointments of men farther down on the list than he have been made by the postmaster.

CONSTRUCT GALLOWES FOR MURDERER OF COLORED FARMER AND HIS SON

Water Valley, Miss., Jan. 28—(ANP)—Following Governor Hugh White's refusal last Saturday to intercede in the scheduled execution on February 11th of William Clark Mitchell (white), construction work has started on the scaffold on the court house lawn in Coffeeville. Mitchell was convicted of robbing, clubbing and burning the bodies of Lewis Bryant, prosperous colored farmer, and his ten-year-old son, Cool, and if executed, Mitchell will be the second white man in the history of the south to pay the supreme penalty for the murder of a Negro.

Commencement exercises for the 192 graduates of East High and the 160 from North High included five Negro students. From each of these two institutions one finished in the Roosevelt High class of 113; Lincoln High graduated sixty, and extension class one, but there were no colored.

The extra-curriculum activities offered were varied; athletics and music proved to be the best inspiration for the colored January graduates of 1937. There were many events in the school life in which he was a large contributor.

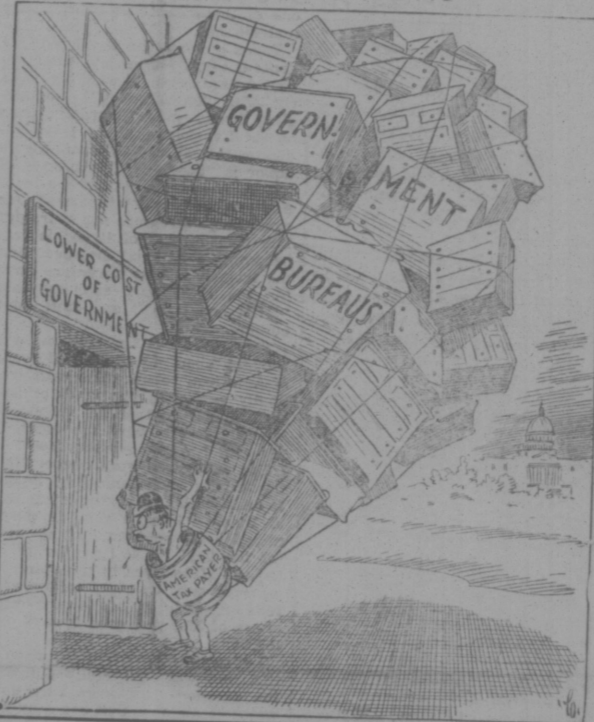

Governor White's refusal to interfere with the execution followed the decision of Dr. C. D. Mitchell, superintendent of the state hospital for the insane, who has had Mitchell under observation, to determine whether or not he was incompetent. The doctor's conclusion was that Mitchell was "fully responsible for his acts."

NAACP Sends Letters to Solons

CONGRESS SUPPORT FOR NEW ANTI-LYNCHING BILL ASKED

New York, Jan. 28—Letters are going forth this week from the N. A. A. C. P. asking congressmen to support the new, revised federal anti-lynching bill which will be sponsored in the 75th congress by the association.

A digest of the new bill, with notations on how it differs from the Costigan-Wagner bill, is being sent the congressmen, so they will know what the provisions are. The new bill was drafted and passed upon last week by a committee of eminent lawyers interested in this type of legislation.

The constitutionality of the new bill is supported by memoranda from Karl N. Lewellyn, Betts professor of jurisprudence at Columbia university, and by Charles H. Tuttle, prominent New York lawyer and one time candidate for governor of New York.

SCHOENCHEN DENIES CHARGES OF BRUTALITY

New York, Jan. 28—(C)—Gustav Schoenchen, former principal of P. S. 5 in Harlem, was acquitted of assaulting Robert Shelton, 14, last October 21, due to "insufficient proof" before Justices Hackenbusch, Erady and Renaud in special sessions in supreme court building last week.

Schoenchen, who allegedly beat Shelton almost into insensibility, declared on the witness stand: "I did not strike him. I never kicked him. I did not call him vile names."

Tallahassee, Fla., Jan. 28—(ANP)—Florida State A. and M. college was quiet Wednesday following a two day strike begun Sunday by students in protest over the food served in the campus dining hall.

The strike began at breakfast on Sunday morning. Students refused to attend Sunday religious services and remained away from classes Monday. But the student council, opposed to the demonstration, stepped in and influenced the strikers to return to classes Tuesday.

'Ole Man River' Keeps on Rollin'

LOUISVILLE, Ky., Jan. 28—(Special)—The ugly specter of race hatred has reared its head above the angry waters in the flood-area, and this week finds thousands of our people, who were washed from their homes by the waters of the mighty Ohio river themselves its victims.

Jim Crow tactics are being used in the manner of housing the refugees and in many cases the motor boats are actually refusing to pick up Negroes, leaving them to die in the flood.

In the refugee camps hundreds of our people are huddled together like cattle and it is safe to say that before the flood waters have receded, many of them will have died as result either of exposure, the flu, pneumonia or typhoid.

No Discrimination A section of the Jefferson Armory, in the heart of Louisville's downtown district, has been set aside for "Colored Only." Cots have been furnished by the American Red Cross.

Although Red Cross officials say there will be no discrimination in the flood area, it is a known fact that those in charge here are drawing the color bar. They are giving the best of everything to the whites.

The entire colored district is now under water. The flood has reached the second floor of the Allen hotel at Twenty-fifth street and West Madison. Chestnut, Madison and Walnut streets, the main thoroughfares in the district inhabited by colored people, are completely under water.

Whites Only The Masonic Temple has thrown up the color bar. A call was issued on Monday night asking that only white refugees be brought in. Three truck drivers were dismissed because they picked up Negroes who were marooned on house tops.

Even in the rush to get to safety, the truck drivers refused to place colored refugees in trucks bearing whites. The situation is deplorable.

Colored Ward There is no sign of life in Louisville. All electric power has been drowned out and virtually all means of communications closed. The city's 350,000 residents, two-thirds of them, have been driven from their homes by the rising waters of the mighty Ohio river.

There is no gas and most of the homes are without heat and food. Drinking water is running low and a warning has been issued to boil all water to prevent the contracting of typhoid. Hundreds are in the hospitals. The "Colored" ward of the City hospital is overcrowded and it has been necessary to add more beds in another Jim Crow section of the hospital.

Prison Riot The radio patrol boats, which are manned by both police and volunteers, all but ignore Negro refugees and in many cases it is necessary to make four and five calls before the people are rescued.

Added to the already deplorable situation was the uncalculated shooting down of fifteen convicts in prison at Frankfort, Ky. The majority of the inmates were colored and because they begged to be allowed to escape the onrush of the flood waters, they were shot down in cold blood.

EIGHT DIE IN CINCINNATI WATERS

Cincinnati, Ohio, Jan. 29—(S. S. Jal)—This city is a swirling Venice and three-fourths of its population face imminent danger of disease and flood.

Flood ravaged Cincinnati's supply of drinking water has already become polluted—even that which is being rationed out for drinking and cooking. Every effort is being made to halt what threatens to be an epidemic of flu, pneumonia and typhoid.

Eight persons are known to be dead. Three of this number are Negroes. They were unidentified. Only food stores, drug stores and eating places operated as the river rose to an unprecedented mark of the eighty foot crest predicted officially for Friday.

Property damage has already been estimated at seven million dollars and twenty-five square miles were under water.

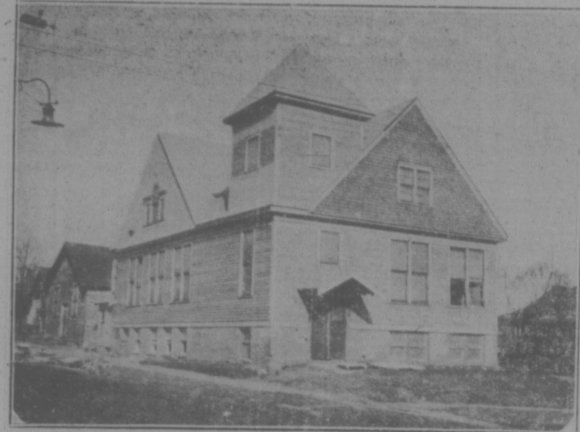

Lesson for January 31

FINANCIAL COST OF ALCOHOLIC BEVERAGES
LESSON TEXT—Proverbs 21:17; 23:20, 21; Matthew 24:45-51; John 6:26, 27, 33.

Temperance Sunday brings a greatly needed opportunity to consider the entire question of intoxicating liquors. When the prohibition amendment was under fire the proponents of repeal contended that it would reduce taxes, cut down employment, eliminate bootleg liquor, return men and women to temperate and decent habits. It is worthwhile noting that not a single one of these expected benefits has materialized.

Taxes on liquor have not reduced general taxes. After all, what decent American would want his taxes cut with "blood-money"? Bootlegging thrives more flagrantly than ever. Evasion of liquor taxes indicates that about half of America's liquor is "bootleg." The specter of unemployment still stalks the land. And are our people temperate? One could laugh if it were not so tragic! The consumption of liquor is fast becoming a national disgrace. And the tragedy is that Christians have for the most part slyly said "What can I do?" and have done nothing.

The repeal of prohibition was brought about by the indifference of American voters. The issue was finally settled by the votes of less than 23 per cent of the registered voters. Where were the other 77 per cent? Where are they now?
But our lesson goes deeper than the matter of intoxicating liquor. It deals with two contrasted modes of living. What a man is determined to do, he will do. If he lives for the flesh he will pander to his tastes. If he lives in the Spirit he will not only be right in his attitude toward liquor but toward every phase of life, yes, even toward eating.

Let us consider these two ways of life—and weigh carefully our own life decision. In which way do I walk? Remember that one may live to the flesh even though he is not a winebibber. It is a matter of heart interest and relationship to God.

I. Living in the Flesh.
The word flesh in Scripture does not refer to our physical flesh and blood, except as it is dominated by self-will. But when self-will rules the body, and God's will is ruled out, a man lives in the flesh.
Our lesson gives a terrifying picture of such a life. It makes a man a senseless lover of pleasure for pleasure's sake (Prov. 21:17). He is a lover of wine, a glutton (Prov. 23:20, 21), careless (Matt. 24:48), disorderly and unfaithful (v. 49), and a professed follower of Christ because of what it brings him (John 6:26). His end even in this world is disgrace and poverty, and in the world to come, eternal judgment (Matt. 24:51).

II. Living in the Spirit.
"They that are Christ's have crucified the flesh with the affections and lusts" (Gal. 5:24). They are therefore admonished to "walk in the Spirit," that is, to submit their lives to the control and guidance of the Spirit of God. In other words seek God's will, not self-will.

What kind of men and women are those who live in "the spirit"? A re-reading of our lesson texts reveals them as, wise, faithful, diligent, temperate, not following the Lord because of any gain to themselves.
What is their reward? In this life they are entrusted with more work for their Master (Matt. 24:47). The reward for Christian work well done is more work. So if you are lazy, do not begin. But if the fires of holy ambition to serve him burn within your soul, go on, and he will lead you further on until at last in the world to come you will have the all-sufficient reward of his "Well done, good and faithful servant."

IGNORANT POLICE OFFICERS

At the trial of a civil rights suit in Burlington recently, it was disclosed that a policeman forcibly ejected a Negro woman from her seat in a theatre at the request of the management because she refused to move into a section "reserved for Negroes."

Experience in similar suits shows that the theatres deny using force or intimidation against Negroes and in many instances succeed in proving to the jury that they are innocent of any wrong doing.

Unfortunately some of our policemen are so ignorant that they don't know that they themselves are violating the law when they aid theatre managers in their effort to discriminate against Negroes; and this despite the fact that these officers are employed to help enforce the law.

Laws cannot be enforced successfully when the public is opposed to them, but it certainly ill becomes a police officer to help break them, whether civil rights, intoxicating liquor or any other law.

The good citizens of Burlington ought to see their chief of police and get this officer fired. And if they can't do this work and vote against the person who appoints that chief of police to office. There are more ways than one to accomplish the desired end in these cases.

FOR THE SAKE OF EXPEDIENCY

Already propaganda is being circulated in which the writers argue why Joe Louis should not become champion. Some of the objections are so trivial that they just as well go unnoticed; others though unimportant have a lot of weight with some people.

Examples of these objections are: Negroes will antagonize white people to the point where race conflicts occur and cite the fact that white people passing through Harlem after the Louis-Baer fight were insulted and jeered; that fist fights and riots occurred in many parts of the country when Jack Johnson won the championship.

Of course these are unfortunate and should not occur; Negroes as well as whites are responsible for them. But we just as well get accustomed to Negro champions now as any other time and if it takes a few cracked heads in order to get the public accustomed to the situation, then let them be cracked.

If Jess Owens had never competed with white men he would not be the champion of the world in his class. He would be the champion of Negroes. The trouble with these arguments is that they take the position that the best way to improve racial conditions is to keep white and Negroes apart. Experience in communities where complete separation of the races exists disproves that position.

No, Joe Louis should fight the leading white man available and then let the best man win. The public soon gets accustomed to champions.

SCIENTIFIC BUT HELPLESS

It would be hard for people living in other sections to imagine flood conditions this season of the year as they exist in the Ohio river valley where it is not for modern science, which has given the wire photo, radio and other fast methods of communication, enabling the public to get a vivid picture daily of just what is happening.

This calamity places a tremendous burden on these communities; however, improved methods of communication make it easier to appeal to the public for help. All races and classes are in dire distress, calling for heroic efforts, not only of rescuers, but also the provision of food, clothing and necessities for the suffering and the prevention of the spread of disease.

But in spite of our science and inventions the floods prove just how helpless we are. On the other hand, assistance given these sufferers by people throughout the country demonstrates that this world is not so bad after all; that people are interested in their neighbors, even though hundreds of miles away.

Health Talks

HOW GOOD IS THE SLEEPING TABLET I USE?

Many people are accustomed to using sleeping tablets and headache tablets recommended by their neighbors without knowing the danger attached. With the recent introduction of preparations containing barbituric acid and its allied compounds there has been an increase in poisoning from these substances; largely because the laity can purchase them without the physician's prescription.

Indiscriminate use of drugs for headaches, nervousness and insomnia should be discouraged. Persons suffering from an overdose of the various drugs containing barbituric acid develop a deep sleep with a peculiar type of breathing and a rapid heart cyanosis (a bluish discoloration of the skin surface) and sometimes delirium and coma. Large groups of people have peculiar susceptibilities to these drugs and may develop some of the milder symptoms such as: headaches, dizziness and indistinct vision. Prognosis of these cases depend upon the amount of drug taken.
