Local Opinions Divided on President's Proposed Judiciary Changes

Is First Negro in History To Be on Federal Bench

Southern States Say "Yes" With 65 Percent Majority

New York, N. Y., Feb. 11—Public opinion in America favors the enactment of a federal anti-lynching law by a vote of 70 per cent to 30 per cent, according to a poll taken by the American Institute of Public Opinion (only national poll to predict Roosevelt re-election) and released in leading Sunday newspapers January 31. The most astonishing thing about the poll is that it found 65 per cent of its voters in the southern states in favor of an anti-lynching law. The question asked in the poll was: "Should congress enact a law which would make lynching a federal crime?" Seven out of ten answered "yes."

The strongest vote in favor of the law was in the east central states, where 77 per cent favored it and only 23 per cent opposed it. The greatest opposition to it was in the "acific coast states, where 59 per cent favored a federal law and 41 per cent did not. The opposition to a federal law on the Pacific coast is attributed by the directors of the poll to the fact that the vote was taken at the height of the nation's indignation over the kidnaping and murder of ten year old Charles Mattson of Tacoma, Washington. The Pacific coast states were particularly bitter over this brutal crime and were in a mood to regard the question of lynching emotionally rather than rationally.

Residents Protest Colored Tenants

NEW YORK COURT MUST PASS ON WHAT IS A NEGRO

White Plains, N. Y., Feb. 11—(ANP)—New York's supreme court justices must solve the problem of what is a Negro and whether residential segregation is legal following a case brought up last week before Justice Raymond E. Aldrich with Arthur Garfield Hays, legal counsel for the N. A. A. C. P. and widely known lawyer, asking the question. The suit involves Mrs. Marion A. Ridgway, white, of Port Hill road in the fashionable Edgmont hill section of Greenburgh, who wants an injunction restraining Mrs. Pauline T. Cockburn from occupying a house a few doors away. Mrs. Ridgway points to a dead covenant restraining Negroes or persons of Negro blood or persons of Negro blood from owning or occupying property in the development except as servants of a white family.

CRIPPLED CHILDREN'S UNIT ESTABLISHED AT TUSKEGEE INSTITUTE

Montgomery, Ala., Feb. 11—(ANP)—An orthopedic unit for the care of Negro crippled children has been established at the John A. Andrew Medical hospital, Tuskegee Institute, and the authorization of the crippled children's division of the state department of education and the state board of health of Alabama.

ABRAHAM LINCOLN HAD HIS TROUBLES ALSO

Abraham Lincoln, the man whose birthday is nationally observed February 12th, had judicial troubles, too. Since the beginning of United States government history, the supreme court, with John Jay as first chief justice, has been defied, threatened and even suggested abolishment. President Lincoln defied high tribunal during the civil war, when he ordered an officer to ignore a grant of habeas corpus which would have released a military prisoner.

In the emergency war measures which he believed were supreme, the "Saviour of the Union" used his own judgment, in which indignant Republicans supported. Chief Justice Taney ruled that the president "cannot suspend the privilege of the writ—nor authorize any military officer to do so."

The following opinions were received at random in answer to the reporter's query as to President Roosevelt's plan to "reform the supreme court" and make other changes in the judicial branches:

Claude Frye, photographer, 1413 Park street—"I think it will be O. K. if the president can put it over. Those men are getting too old to run the country."

Gilbert Russell, barber, Hardways Tonsorial Parlor—"I have listened to the president's addresses and read articles in the newspaper; personally I believe that minds and bodies degenerate at a certain age and that judges over 70 years of age should retire. But since we have always used this policy of elderly judges, I see no reason to make a change now. I see some of his points in his changes, but surely he must be using his own enforcement."

Miss Alsie Brown, 913 Crocker, Drake student—"I believe President Roosevelt is wrong. Why make over the judiciary department as long as it is"

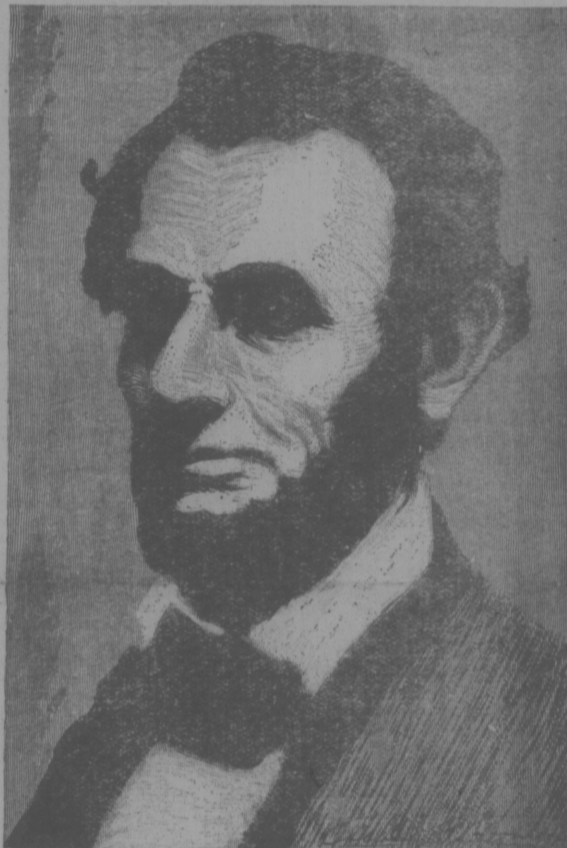

GREEN TRIAL OPENS

New York, Feb. 11—(C)—The Major Green trial for the murder of Mrs. Mary Case was ready for trial Monday morning in Long Island City, defense counsel it was said, were basing their hopes on disagreement which might arise over two alleged "confessions" by Green, one written and one oral.

The written confession, it was intimated admitted that Green entered the Case apartment only with robbery intent while police were said to be trying to bolster up the alleged oral confession of murder.

NO DISCRIMINATION REPORTED IN SOUTHERN ILLINOIS FLOOD RELIEF

Villa Ridge, Ill., Feb. 11—(ANP)—Thrown into the spotlight as the temporary home for flood refugees from the Ohio river area of southern Illinois, this little agricultural center has been caring for both black and white victims of the disastrous flood, and with no reported discrimination in the administration of relief by the Red Cross.

Every school, home, church and other building has been used to house refugees; food, clothing and medical help have been given to flood sufferers thus far in this section without regard to race or color.

500 NEGROES FORCED TO FLEE OSCEOLA, ARKANSAS

Osceola, Ark., Feb. 11—(ANP)—More than 500 Negroes have been transported by box car from this flood swept area to Blytheville, Ark., until high waters subside. Still others were sent to Memphis. Trains and buses were chartered by the government for the removal of people of both races to higher ground.

N. A. A. C. P. FEARS DROWNING CONVICT LEVEE WORKERS

New York, Feb. 11—A telegram expressing the fear that convicts chained together and working on the levees in the flood area may be drowned wholesale in the event of a break in the levees was sent by the N. A. A. C. P. this week to Governor Gordon H. Browning of Tennessee.

Year's First Mob Party Whitewashed

SHERIFF PERFORMED DUTY FEARLESSLY REPORT OF INVESTIGATORS

Abbeville, Ala., Feb. 12—The special grand jury instituted by Governor Bibb Graves, met here this week to investigate the lynching of 19-year old Wesley Johnson, who was accused of assault on a white woman.

The jurors were in session but a few moments before they reported an elaborate statement, exonerating Sheriff J. L. Corbett, declaring that he performed his duty promptly and fearlessly.

Abbeville, Ala., Feb. 11—(CNA)—Wesley Johnson, 22 year old youth, was taken from county jail last week and lynched by a mob of approximately 100 white men. According to Sheriff Louis Corbett the mob came to the prison, covered the sheriff and his jailer, and dragged young Johnson out. Sheriff Corbett said he recognized several members of the mob.

At Montgomery, Governor Bibb Graves ordered Attorney General A. A. Carmichael to make a "thorough investigation" and to "bring impeachment proceedings against any official if found warranted." Johnson's bullet-ridden body was found swinging from a limb in a woodland not far from Headland, near Abbeville. The usual southern charges were preferred against him, attempting to assault a white woman, one Mrs. Rupert Barnes.

Burkman Speaker For NAACP Meet

Carl Burkman, county attorney, will be the principal speaker at the Lincoln-Douglass celebration of the Des Moines Branch, N. A. A. C. P., which will be held at St. Paul A. M. E. church Sunday evening, February 12th at 8 o'clock.

The Junior department will have charge of the program following an all day demonstration against lynching as is being done by branches all over the country. All young people and organizations are invited to take part in the appeal. Anti-Lynching buttons will also be sold. George Stewart, is the president of the Junior Association.

Guy Smith will read the history of lynching and the music will be furnished by the Junior Community chorus. Miss Dorothy Wheels will preside.

Washington, D. C.—For the first time ever recalled in the nation's history a Negro was named federal judge. President Roosevelt nominated William H. Hastie, 32, lawyer, with a salary of \$10,000 a year as judge of the Virgin Islands. It is a life time term.

The new U. S. official is assistant solicitor in the interior department, an honor graduate of Amherst College and Harvard Law School. He succeeds George P. Jones of Minnesota, to whom President Roosevelt gave a recess appointment last December.

The native Tennessean, who was born in Knoxville, will have an area of 133 square miles. More than 95 per cent of the 22,000 population is wholly or part Negroes, according to censors reports.

Walter White, executive secretary of the N. A. A. C. P., was appointed on the advisory board of the Virgin Islands in 1933. He resigned shortly after in protest to President Roosevelt's failure to press the anti-lynch bill.

The late George H. Woodson, Des Moines attorney, was named by President Harding in 1922 as a member of the board to study conditions there. The value of the island to the U. S. has been a controversial subject for many years; President Hoover called it a "poorhouse" which aroused the ire of many Americans.

Richmond, Va., Feb. 11—The campaign for enactment of a federal anti-lynching law received valuable and important assistance this week when the Richmond Times-Dispatch, influential morning paper of this city, carried an editorial in its February 2 issue openly and unequivocally endorsing a federal anti-lynching bill.

"FATHER OF WATERS" HELD WITHIN BANKS BEFORE MAJOR RISE

Estimate 750,000 Homeless—Property Loss \$300,000,000
The government's 21 million flood trap, a vast southeast Missouri basin, neared its climax of its first major test this week, as the coast guards in Cairo, Illinois, with fifty-five boats from the Atlantic seaboard ordered all night watches.

Newly flushed from Cairo to the Gulf of Mexico last night as the Mississippi river billion dollar levee system recorded no major breaks in the constant inching to the sand bag raised level of the mud-laden waters. JESUS THE GOOD SHEPHERD

LESSON TEXT—John 10:1-16.
GOLDEN TEXT—I am the good shepherd: the good shepherd giveth his life for the sheep.
PRIMARY TOPIC—A Good Shepherd.
JUNIOR TOPIC—The Good Shepherd.
INTERMEDIATE AND SENIOR TOPIC—How Jesus is Like a Shepherd.
YOUNG PEOPLE AND ADULT TOPIC—Jesus Our Good Shepherd.

The blind man who had been healed had been cast out of the synagogue because he had given the glory for his healing to Jesus Christ, (see ch. 9). The door to that which stood for all that was sacred to him had been closed. Whether should he turn? Look! here comes someone seeking him. It is Jesus, who now declares that the door which men had closed was no true door at all, for he says, "I am the door of the sheep." Those who professed to be shepherding the flocks and who had cast this poor man out were but hirelings. Now he speaks to the One who says, "I am the good Shepherd."

Someone has suggested that the parable of the good shepherd presents the whole day in the life of the shepherd and his flock, morning, noon, and night, and typifies the ministry of Christ on our behalf in the varying circumstances of life.

Flocks were sometimes kept in the field at night, as was the case on the night when Jesus was born in Bethlehem. But ordinarily they were brought into a sheepfold where many flocks gathered for protection. Thieves would climb the wall to steal sheep, but the shepherd, when he came in the morning to lead forth his flock, entered in by the door. He called out his flock by name and they knew his voice.

It is said that only a sick sheep will follow a stranger, which may explain why so many false imps of our day appeal to the sick and lead them away from the Good Shepherd.

Do you know his voice? Have you responded to his call? Will you follow him? Decide now.

Perhaps the sheep need to enter the fold to rest, if so he is the door. But they may wish to go out to the pasture—again he is the door. Belonging to Christ is not bondage. If any man enter in by Christ, the door, he is free to go in and out, to feed pasture, to live for and to serve him.

"The Door." What a striking figure! It is a means of entry, the only way in. Every door has two sides, and the side we are on determines whether we are inside or outside—saved or lost. Children used to sing, and still do:

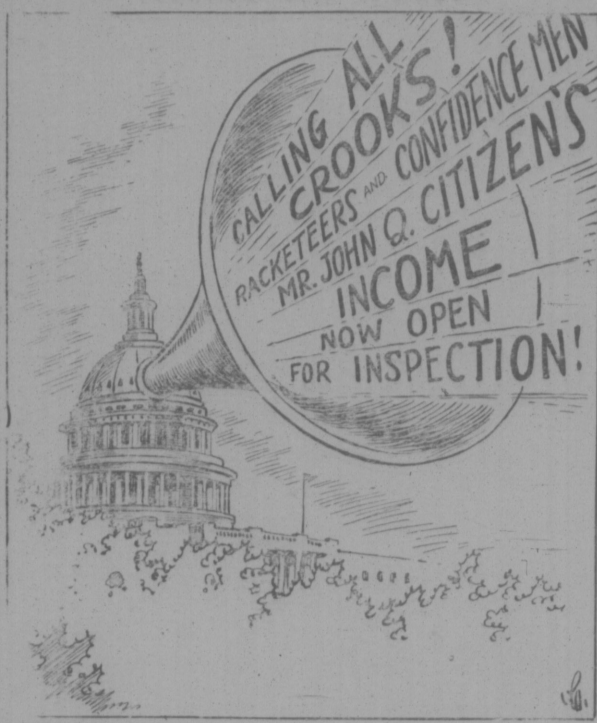

REVISED VERSION OF COSTIGAN-WAGNER MEASURE TO PERMIT FEDERAL ACTION
 Washington, Feb. 4—A new federal anti-lynching bill, which is really a revision of the well known Costigan-Wagner anti-lynching bill, was introduced in the house of representatives this week under the sponsorship of the N. A. A. C. P. It will be introduced in the senate next week by Senator Robert F. Wagner, of New York, and a co-sponsor. The N. A. A. C. P. has requested representatives who are friendly to this legislation to introduce identical bills in the hope of arousing greater support for the measure in the house.

One of the objections which has been raised to the old bill was that it might be interpreted as applying to gang and racketeer killing and to classes between factions in labor disputes. The new bill expressly provides that the term "lynching" shall not be deemed to include violence occurring between members of groups of law breakers such as are commonly designated as gangsters or racketeers, or violence occurring during the course of picketing or boycotting incidental to any labor dispute.

The new bill also broadens the Lindbergh federal kidnaping act to include interstate kidnapings and lynchings such as the Claude Neal lynching. The new bill, like the Costigan-Wagner bill, is not simply confined to those in the custody of peace officers. It covers cases in which victims are hunted down and lynched by mobs or so-called posers before they are ever arrested and

formally charged with a crime.

The new bill does not attempt to punish private individuals, but concentrates on punishment of peace officers and state prosecutors who fail to protect prisoners before lynching or to prosecute the members of the mob after a lynching has taken place. It still provides for civil damages against the county or counties in which lynchings occur. The new bill also differs from the Costigan-Wagner bill in that it provides definitely for the conduct of an investigation of a lynching by the federal bureau of investigation, better known as the G-men.

Senator Robert F. Wagner of New York will speak February 12th from 6:15 to 6:30 p. m., eastern standard time, in support of a federal anti-lynching bill over the blue network of the National Broadcasting company, whose chief station is WJZ of New York.

Senator Wagner, co-sponsor of the Costigan-Wagner anti-lynching bill in the last congress, is to sponsor a revised federal anti-lynching bill in this congress. The senator will talk from Washington, D. C., for the network.

Chicago, Feb. 7—(ANP)—Bishop John A. Gregg, presiding bishop of

the Chicago area, assisted by the district's presiding elders, pastors and church members, has launched a drive to be known as the Chicago Conference Sesqui-Centennial campaign, in commemoration of the 150th anniversary of the A. M. E. church. This initial drive promises to develop into a four year plan, by which all A. M. E. church mortgages will be wiped out or materially reduced and the work in general greatly extended.

Hospitals and pools for crippled children are being built by WPA workers in many states, and all will be opened to colored as well as to white patients.

 Chillicothe, Mo., Jan. 28—(ANP)—Withdrawal of a bill which would impose a jim crow law in Missouri providing for separate coaches for Negro travelers on railroad trains was announced last week by its sponsor, Paul E. Turner, representative from Buchanan county.

With more than \$300,000,000 in property damage, 760,000 persons homeless, 150 officially dead, and 200 reported found dead in the Louisville, Ky., area alone, Mississippi levees are being strained to the highest pitch as water from the Ohio recedes at present from Pittsburgh to Paducah, Ky.

NEW YORK ADOPTS "WELFARE OF MAN" AS THEME OF FAIR
 \$125,000,000 Exposition to Depict Building the World of Tomorrow

New York—The New York World's Fair of 1939, according to Grover Whalen, President of the Fair, will be a \$125,000,000 show, will have a theme—"Building the World of Tomorrow."

This was announced for the first time by Mr. Whalen, following the adoption of the theme and the design by the Board of Directors.

"The Theme," said Mr. Whalen, "encompasses the well-being of man, the betterment of life. It will be carried out in our exhibit zones, in our amusements, and in a beautiful 'Theme Tower.' We will display to the visitors all the goods, all the materials, all the resources and powers man has amassed, to the end that by studying them, one may learn how to plan and to attain

a more admirable future."

The design, a simple and practical one that is motivated by consideration for the hundreds of thousands of people expected every day, divides the main section into ten zones. These zones will display exhibits of clothing, shelter, the arts, the basic industries, health, sustenance, recreation, government and co-operation, education, and public and social services. Each exhibit will be allocated to its proper zone. There will be no haphazard or scattered display. For the first time, visitors need not walk all over a fair grounds to see what they want to see, and only what they want to see.

Focal Exhibits
 In each zone there will be a focal exhibit to explain, in dramatic fashion, the nature of the sector, its history, and its potential future.

The zones will be laid out around the "Theme Tower," in the heart of the main section, a 250 foot structure that will dominate the park. In this tower will be a panorama to show what strides America has made in the 150 years that have passed since George Washington strode into New York's old Federal Hall and took the oath of office as our first president.

The opening of the Fair, April 30, 1939, commemorates the 150th anniversary of that day.

This panorama will also show the interdependence of the 48 states born of the 13 original Colonies, and the interrelation of the big cities and the country districts of the United States.

The site of the Fair, Flushing Meadow Park, will be a permanent park after the Fair is done. It comprises 1216 acres—twice the space ever before given over to a Fair.

The work of converting the site into a Fair Grounds and a park requires engineering and artistic skill of the highest, the employment of hundreds of men, and the expenditure of millions of dollars.

Great mounds of debris must be shifted. Great depressions must be filled in. A river must be canalized and its tidal inlet dammed. Two great swamps must be dredged and made into beautiful lakes. Six thousand trees or more must be planted, tens of thousands of shrubs, millions of flowers. Roads must be built—and bridges must be built to span them. Sewers must be installed.

Cost to Run \$125,000,000
 The Fair officials estimate that \$125,000,000 will have been spent before the first visitor is admitted to the grounds. The city and the state of New York and the Federal government are spending millions, and the buildings they erect will be permanent. The Fair Corporation will spend \$30,000,000. Exhibitors, concessionaires, commercial groups, and other governmental agencies will spend at least \$50,000,000. The city, state and Federal governments will expend about \$35,000,000 for buildings, exhibits and collateral improvements.

Mr. Whalen believes that at least 50,000,000 people will visit the Fair in 1939, and arrangements are being made to handle them all in comfort. Eight hundred thousand people can be well cared for on any one day.

Three subway lines, the Long Island

railroad, buses and autos will be used to bring 100,000 people to the Fair Grounds every hour when arrangements are completed; though, in order to do this, it will be necessary to extend one subway system a distance of two miles.

Roads are being built, extended, or widened, for the streams of cars that will pour into the park from the Triborough and Queensborough bridges. There will be a huge bus terminal, parking spaces for 30,000 autos and facilities for trailers.

A boat basin is being prepared in Flushing Bay; and plans are under way to dredge a channel in the harbor for the use of deep-draft ships that will bring Fair visitors from all parts of the world. There is also some discussion as to the advisability of developing an airport for those coming to the Fair by plane.

Comfort the Keynote
 There will be buses inside the Fair Grounds as well as outside so that those who do not wish to walk may have cheap transportation to any part of the grounds they desire to visit. There will be thousands of tree-shaded benches for those who are weary. There will be restaurants and amusements of various kinds all over the 1216 acres. Beside this there will be a mile-long stretch of amusements east of the main lagoon—amusements that will not imitate Coney Island or Broadway.

An amphitheatre for opera, plays of all kinds, and other forms of entertainment will be built on the shore of the big lagoon. And there will be water sports on the lagoon.

A children's village, a "Hall of Nations"—for the Fair will be international in flavor, and most every government in the world will be represented—and other buildings, have been submitted to the Board of Design. But as yet the style of architecture to be employed has not been decided. A competition open to all the young architects of Greater New York may establish the style. It is the opinion of the board that most of the structures will be of only one story, and will depend upon beauty and originality instead of height.

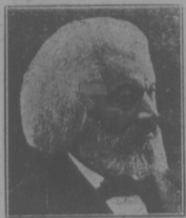

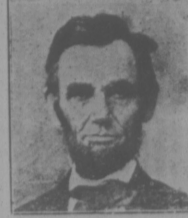

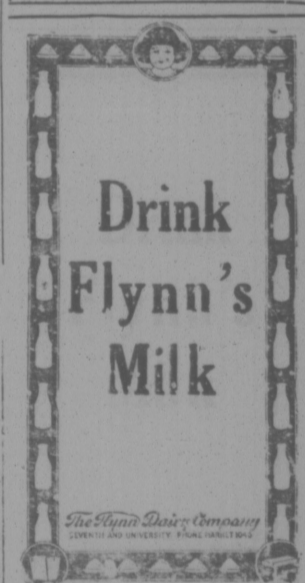

BEARS VIGILANCE

The American Red Cross has promised the N. A. A. C. P. that there would be no discrimination in the administration of relief to flood sufferers. It is encouraging that the officials should take this stand and yet under all the rules of decency it is the only possible one.

However, experience as shown that as a rule those at the top of big movements take the high ground on questions of discrimination but invariably the difficulty arises in the administration which in the final analysis must be left to the average fellow in local communities. A splendid example of this is the position taken by President Roosevelt and Administrator Hopkins and yet anyone who knows the fact admits readily that the admission of the chiefs higher up are not being kept. This is true not only in the South but in the North—here in Des Moines.

The Bystander makes this observation to show that a close watch must be kept by local groups to see that Negroes are given the same consideration as others for experience has shown that this is the correct thing to do notwithstanding the policy of fair play announced by those at the top.

ENLAFGE TE COUNT, NO.

Unfortunately the controversy over the United States Supreme Court is not being discussed by the average citizen on the fundamentals of our system of government. It is results in the final analysis may not be just what ought to be done.

There is no question that President Roosevelt wants a court which will interpret the law as he wants it done. He wants the judiciary as well as the legislative branch of the government to do the bidding of the executive branch. This The Bystander believes is wrong and contrary to our theory of government.

There have been times when the legislative and executive branches of state and national government have been drunk with power; when they trampled upon the rights of minority groups without valid reason. But the only steady influence has been our courts. They have protected rights of minorities; generally they have kept rabid legislators and wild executives in line with the fundamentals of our system of government; within the rules of common decency toward minority groups.

No, The Bystander is opposed to a wholesale enlargement of the Supreme Court. If President Roosevelt does it successive executives will do likewise and there is not telling where such a course will eventually lead.

THE FIGHT MUST GO ON

One cannot think of the rights of the Negro without thinking of Abraham Lincoln and his contemporaries. Among them was Frederick Douglass. This week we celebrate Lincoln's birthday, February 12 and that of Douglass February 14th. Consequently it is especially fitting that the N. A. A. C. P. should have chosen February 12 as a day for demonstrations against lynching.

Few can people justify lynching, yet in spite of the heroic campaigns fostered in and effort to secure the passage of a federal anti-lynching law, methods have been found to block it. In fact it is conceded that on more than one occasion a sufficient number

of legislators has been ready to vote such a law but a willful few has succeeded in blocking the will of the majority.

While lynching is a national question, the fact the Negroes are the greatest sufferers tags it a Negro problem. For that reason, Negroes and their friends are forced to carry most of the responsibility involved in putting it down. The demonstration against lynching provides several methods one may use to assist in the campaign calling for money, time and influence. Few people have all of these requisites, but most have one or more so it behooves interested citizens to attend the Lincoln-Douglass celebrations and render whatever assistance they may have to help the cause.

The Lie Story of Negroes of Note

FREDERICK DOUGLASS

But now came a sunny period in his life. He was sent to live in the home of a family in Baltimore. They were kind and considerate, for a white.

When he first went there the mother of the family took quite a liking to him. One day while listening to her read from the Bible she thought as to Fred that he might learn to read. He did the boldest kind of a thing. He asked her to teach him. She did something bolder. She consented.

Needless to say this little lad learned rapidly. A good thing. When the master found out about his wife teaching a slave to read he was furious. He put a stop to it at once, but it was too late. He already had the key that unlocks the secrets of the alphabet, so from that time on he devised his own methods of learning.

One of his tricks was to write words on fences and such places, then to challenge the white boys to find mistakes in the words. Somehow he got hold of a spelling book. While polishing shoes on the streets of Baltimore he earned a little money and bought a book of orations. Probably this book marked an epoch in his life.

The sunny days in Baltimore were soon to end. Dark, forbidding clouds began athering in his sky.

It is always difficult for a person to make sudden, radical changes in his standard of living, no matter how bad the change may go. Fred had become accustomed to a rather refined mode of life while in Baltimore. Now, through financial reverses and other changes, he found himself hired out as a field hand on a plantation some miles from Baltimore.

The man who ran this place seemed totally unaware that his slave had any feeling at all. One day when it seemed that things had become unendurable, young Douglass (now about eighteen years old) went to his former master to appeal for relief. To his surprise and bitter disappointment his master made it clear to him that he was not in the least concerned about his welfare. There was nothing to do but return to the plantation and face what he knew was coming.

Now his troubles had multiplied. He had gone away without permission. He knew this was a serious offense. He also knew that the penalty was a severe beating. He didn't know what to do. But he knew there was one thing he was not going to do. He was not going to take a beating.

When this man, who was noted for taming unruly slaves came toward the boy to beat him, the tables suddenly turned and this time the slave was doing the beating—along with merciless kicking.

Health Talks

IS YOUR CHILD'S DIET ADEQUATE?

As a guide in designing the diet of a healthy child of school age, the following ingredients have been specified as a desirable basic daily intake, to be supplemented by other foods:

- 1 qt. of milk
- 1 or more eggs
- 1 oz. of butter
- 3 tsp. cod liver oil
- 1 orange, tomato, or apple
- 2 servings of vegetables one of a fibrous nature
- 1 serving of meat, fowl, fish or liver
- Milk is the only practical food source of calcium. The normal child needs 1 1/2 pts. of milk daily to meet adequately the calcium demands of his growing body. Milk is also an important source of protein and of vitamins B and G.

Cod liver oil offers an adequate source of vitamin D. Fruit and vegetables supplement the mineral intake, provides bulk necessary for the regulation of intestinal elimination and constitute important sources of vitamins A, B, C and G. One raw vegetable or fruit should be included in each day's food allowance.

Eggs offer a desirable type of protein, together with other organic and inorganic substances of value to the rapidly growing body. Meats are essential because of their content of proteins which are similar in value to those of the human body. As much care should be spent in planning a child's diet as would be spent planning a diet for a sick individual.

Mothers should realize the necessity of feeding children what they need and not what they want. Children should not be permitted to form likes and dislikes for food while very young. Give them all foods that are necessary to promote health and growth.

Participation in the Centennial, to return the exhibits in the Hall of Negro Life to the exhibitors seems to confirm the rumor that the federal government has denied the Negro participation feature in the Pan-American Exposition at Dallas for 1937. It is reported that the Negro building will be demolished and an amusement building erected in its stead.

Detroit, Mich.—Eddie Tolan, Detroit Negro, who was the world's fastest runner until he lost the title last summer to Jesse Owens, has become a member of the staff of the National Youth Administration in Michigan, it was announced recently.

The former Olympic title holder in the 100 and 200 meter dashes took up his new duties this week in the division of Negro activities of the Detroit office of the NYA. He will be connected with the vocational guidance and placement service.
