DIED TRYING TO SAVE CHILDREN FROM DROWNING
Washington, June 17—(ANP)—Memorial services over the remains of Sterling Calhoun, who lost his life nearly two years ago, were held at Lincoln Memorial cemetery. Calhoun tried to rescue Mary and Richard Kerns, aged 14 and 10, who drowned in the Anacostia river July 10, 1935. The Carnegie Hero Fund established a fund for his widow.

JURY REBELS—PRISONER TO GET NEW TRIAL

Montgomery, Ala., June 17—(ANP)—Instead of sending a prisoner to the chair, color prejudice has merely brought a new trial for Walter Davis, convicted slayer of R. D. Mathis, white, a policeman. Defense lawyers and Solicitor Temple Seibels agreed as the trial opened Monday that Davis would plead guilty and draw a sentence of life imprisonment. Judge Eugene W. Carter instructed the jury, which contained three city employees, to that effect.

But after thirty minutes' deliberation the jury decided to ignore the court's instructions and come in with a verdict of murder in the first degree, which makes a death sentence mandatory. Because it had ignored his instructions, the jury was discharged and the verdict set aside.

Chicago Policemen Swing Clubs Again

DELEGATION TO GERMAN, ITALIAN CONSULATES BEATEN UP BY GUARDIANS

Chicago, June 17—(AWF)—A delegation of forty men, women and children, representing the American League Against War and Fascism, was beaten up by a detective squad armed with riot sticks on June 5th after the delegation had complied with a police order to disband.

The delegation had planned to picket the offices of the German and Italian consulates in protest against the German and Italian intervention in Spain.

This act of violence of the police followed by a few days the police attack on another peaceful picket line which planned to parade before the gate of Republic Steel. Eight men were killed on that occasion, now coming to be known as the Memorial Day massacre, and about 100 were gassed and wounded by police fire.

WARNS CONGRESS OF JIM CROW WAGE DIFFERENTIAL

Washington, D. C.—The president has sent to congress a message urging the passage of a bill covering minimum wages and maximum hours for labor, as a means of "extending the frontiers of social progress." Senator Black and Congressman Connery immediately introduced a bill in their respective branch of congress in keeping with the president's message, and made plans to rush its passage as one of the "must" administration bills for the current session.

The Black-Connery bill would permit industry to pay lower wages to Negroes than to white men doing the same kind of work, and facing the same cost of living, forcing them into legalized economic slavery. On the other hand, any requirement in the bill that all persons, regardless of race or color, doing the same kind of work, be subject to the same wages and hours, would mean the immediate discharge of Negroes rather than pay them a deprecating wage, driving them into the already overflowing relief rolls of the various states and municipalities.

Support for the principles of the Black-Connery wage hour bill, coupled with a warning against the differential wage system that might encourage discrimination against half a million Negro workers, was voiced by John P. Davis, national secretary of the National Negro Congress, at a hearing on the bill before the joint senate-house committee.

Davis declared that unless certain changes were made in the bill as it now stands, the measure "might result in even greater discrimination against Negroes than we saw under the NRA."

HIT WHITE MAN IN OKLAHOMA, FINED \$10

Muskogee, Okla., June 17—(C)—Because he struck a white man who used his wife's name profanely, Jesse Gale was fined \$10 and costs, totaling \$40, in city court Wednesday by Judge Cavender. The white man went to the hospital. Attorney J. Bernard Smith, editor of the Oklahoma Independent, defended Gale.

Attorney Smith objected to the use of the epithet "nigger" in court, but Judge Cavender ruled it was not an insult, as Negroes used the word themselves in referring to each other.

SELASSIE SUES MUSSOLINI IN FRENCH COURT

Paris, France, June 17—(ANP)—Suit against Benito Mussolini and Italy to establish his right to sell his holdings in the Adlis Ababa railroad was filed by Haile Seassie, fugitive emperor of Ethiopia, in the French law courts Wednesday.

Selassie argues that he is still the government of Ethiopia as far as the railway goes, because France has not recognized Italian sovereignty. The shares are worth about \$1,350,000.

SAWS IT CAN FIND NO ERROR IN TRIAL RECORD

Montgomery, Ala., June 18—The Alabama supreme court this week upheld the seventy-five year sentence imposed on Heywood Patterson, one of the nine Scottsboro boys, who was twice saved from death sentences. Immediately attorneys for the youth announced they would appeal the case to the United States supreme court.

The court held it had found no reversible error in the trial record. Four justices concurred in the decision. The United States supreme court has set aside convictions on two previous appeals.

Patterson and eight other youths were accused of assaulting two white women at Scottsboro, Ala.

Gavagan Measure Victory Predicted

ANTI-LYNCHING BILL REPORTED BY COMMITTEE

Washington, June 17—The anti-lynching bill was reported favorably by a sub-committee of the senate judiciary committee here yesterday. The chairman of the sub-committee is Senator Frederick Van Nuys of Indiana, who is co-sponsor with Senator Robert F. Wagner of New York of anti-lynching legislation in the senate. A favorable report from the full judiciary committee is expected in the next few days.

The favorable report from the committee came just as Senator Wagner had issued a statement to the newspapers predicting the passage by the senate of an anti-lynching bill at this session of congress. The Gavagan bill, passed by the house April 15th by a vote of 277-119, is before the senate for consideration. As soon as the report is received from the full judiciary committee, efforts will be made to get a date for a debate and vote on the senate floor.

CATHOLICS MAY CANONIZE MARTIN DE PORRES

Chicago, June 17—(C)—Father N. F. Georges is making a trip to Lima, Peru, to investigate the life of Blessed Martin de Porres, colored candidate for canonization as a saint of the Roman Catholic church, at the formal request of the Peruvian government that the Vatican recognize Blessed Martin as the nation's second native saint.

IMPROVED SUNDAY SCHOOL LESSON

Lesson for June 20

JOSEPH'S KINDNESS TO HIS KINDEED

LESSON TEXT—Genesis 46:1-7, 28-30; 50:20-26. GOLDEN TEXT—And be ye kind one to another, tenderhearted, forgiving one another, even as God for Christ's sake hath forgiven you. Ephesians 4:32.

A happy ending—yes! Modern writers may look with disfavor on it (and perhaps rightly so, for most of them write about life apart from the fellowship with God).

But someone may object that the lesson for today closes with the last words of the book of Genesis, which are "a coffin in Egypt."

Our lesson centers around the last of our patriarchs, Joseph, and his kindness to his father and his family. The highest official in the land of Egypt (save for Pharaoh himself) proves his inherent greatness by forgetting position and power, except as they enable him to be a loving son and brother.

I. Founded on Fellowship (Gen. 46:1-4). Jacob, having heard from his sons that Joseph was in Egypt, and having thus learned of their treachery and deceit, came at last to realize that his beloved Joseph is alive.

II. Evidenced by Thoughtfulness (vv. 5-7). Joseph had arranged for Pharaoh to send wagons to bring his aged father, the women, and the little ones.

III. Manifested in Love (vv. 23-30). Joseph kissed his father whom he had gone out to meet, and held him close and wept for joy.

IV. Imparted by Faith (50:24-26). Jacob had been gathered to his fathers; time had gone on its relentless way, and Joseph is about to die.

Hope Ah, what thoughtful, loving provision God hath made for us in the gift of the angel of Hope! There is no path so dark but we may see the glimmer of her shining wings.

Residential Jim-Crow Is Upheld by N. Y. Justice

COCKBURNS TO APPEAL COURT DECISION

White Plains, N. Y., June 17—(CNA)—Arthur Garfield Hays, counsel for Captain Joshua Cockburn and his wife, Pauline, indicated this week that he would appeal from the decision by Supreme Court Justice Leo Parsons Davis, ordering the Negro couple to vacate the \$20,000 home they built last year in the fashionable Edgmont Hill section of Greenburgh.

In his decision, Justice Davis ruled that deed covenants prohibiting persons of Negro blood from owning or occupying homes in the district were valid and not in conflict with the United States constitution and the Fourteenth amendment. Justice Davis granted an injunction to Mrs. Marion A. Ridgway, wealthy white woman, requiring the Cockburns to move from their new home adjoining her property.

The judge ruled that the Cockburns are Negroes, despite the fact that Mrs. Cockburn can easily pass for white. He held that an octoroon is a Negro. Judge Davis' ruling brought back memories of his famous act in having Alice Rhinelander "strip" before a jury to show that her skin was dusky, in an effort to prove she did not deceive Kip.

SEEK TO PREVENT HIS OCCUPYING HOME IN EXCLUSIVE DISTRICT

Chicago, June 17—(ANP)—Suit for \$100,000 was filed against Harry H. Face, president of the Supreme Liberty Life Insurance company and nationally known business and fraternal executive, in the circuit court here

Monday, by whites of the Washington Park district, an exclusive residential section into which Mr. Face and his family recently moved.

Mr. Face is preparing to defend himself against the suit, which is sponsored by a group of white protective associations notoriously inimical to the best interests of Negroes. These whites, who live immediately east of the colored district on Chicago's south side, have sought through the years to prevent the further encroachment of Negroes upon the territory which they occupy.

Restrictive covenants are in effect in most of the desirable districts in Chicago and are growing rapidly in other cities throughout the country. Negroes in Chicago thus find themselves hemmed into the so-called "black belt."

WHITES RESENT HIS MOVING INTO "THEIR" DISTRICT

Chicago, June 17—(ANP)—Van-dias, presumably white neighbors, stoned the home of Carl A. Hansberry, realtor, Tuesday, after he and his family had moved into a new home which he purchased at 6142 Rhodes avenue, in the Washington Park district here.

Hansberry had defied the restrictive covenant which was adopted by the owners of property in the district which lies next to the main colored residential section of Chicago, extending from Sixtieth to Sixty-third streets and from South Parkway to Cottage Grove avenue.

W. L. BELL ONLY NEGRO TO NAT'L YOUTH CONGRESS

William L. Bell, 1207 Center street, was recently elected a delegate from

the Des Moines public youth forum to attend the National Youth Congress, to be held in Milwaukee on July 2-5. Mr. Bell will be the only Negro delegate out of approximately fifteen representing Iowa.

Washington, D. C., June 10—With a report on the Gavanon anti-lynching bill slightly delayed due to the war Memorial holiday week-end, the senate today was still marking time on the measure, although it is freely predicted that some action will be taken this session.

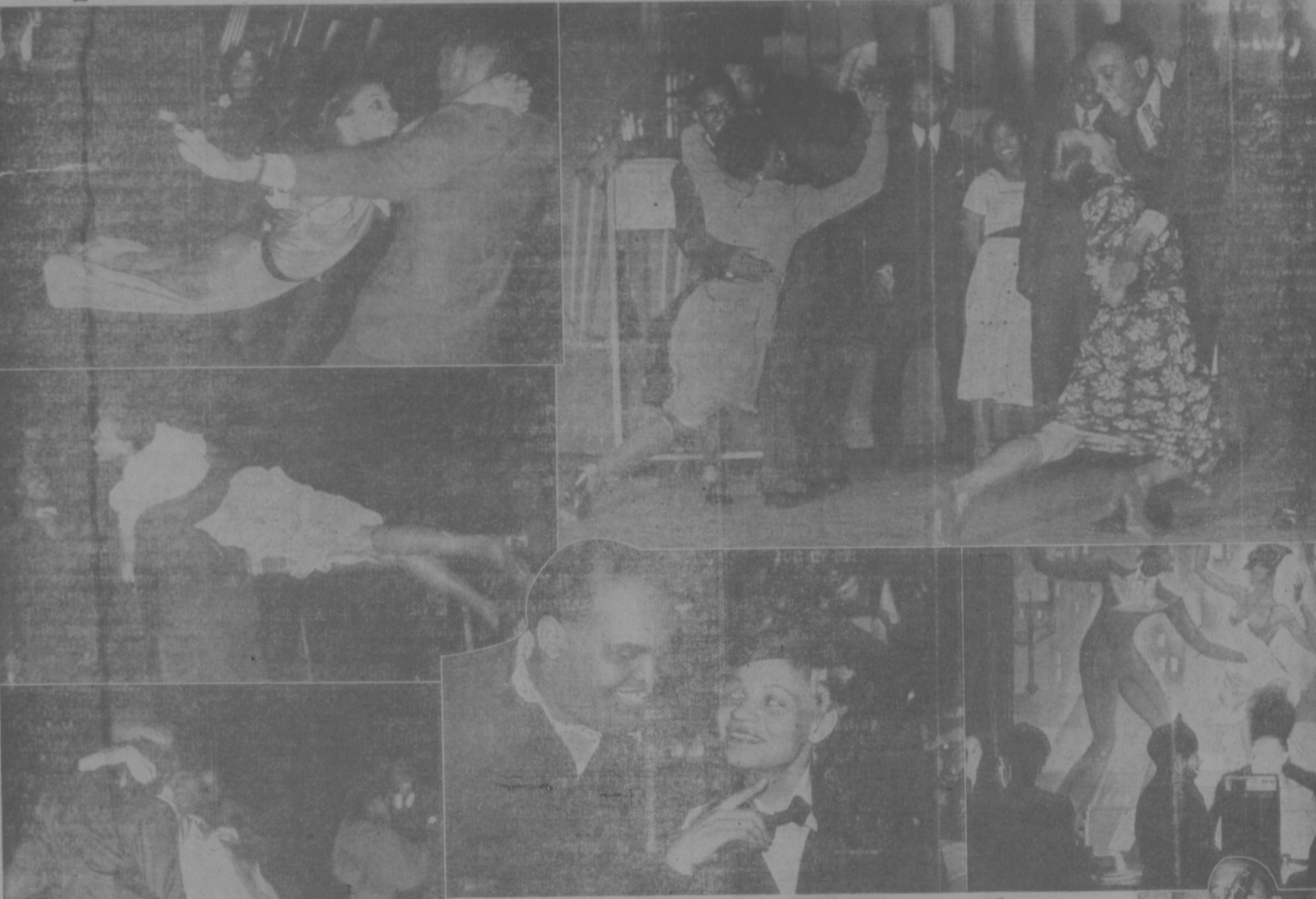

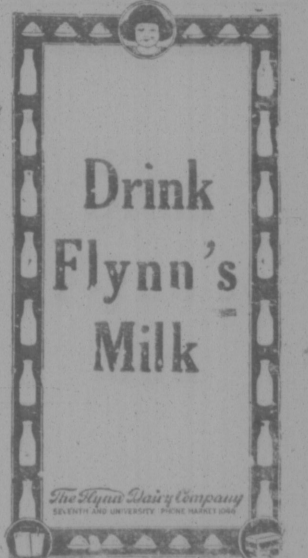

GOOD ADVICE

The NAACP has issued a memorandum to the press, organizations and its local branches urging them to admonish Negroes throughout the country to refrain from any demonstrations liable to cause race friction...

Indeed, this is a timely warning for past experience has shown that people with the best intentions do foolish things or with reckless disregard for other people.

Some white people will be mad and disagreeable should Braddock lose; some Negroes will have the same disposition should Louis lose. So it will not take a great deal to set off a commotion which may cause trouble.

There are those who say this fight should not have been scheduled just for this reason. Of course the Bystander does not agree with them for an opportunity for a fellow to reach the top cannot wait for every citizen to be educated to the point where he can control his temper.

Let there be no disturbance. Much will depend upon the level headed citizens of each community to insure his result.

THE PROBLEM INCREASES

The fact that the largest group of Negroes in history graduated from the public schools of Des Moines last week is just an added reason why a more determined effort should be made to open more and better avenues of employment to the Negro group.

These young people qualify with the white group as far as the high school course carries them and as young people are being considered for employment, they should have their chance.

All high school graduates will not go to college. But this is no reason why they should fail to continue to broaden their sphere of knowledge. Most places have libraries with an abundance of books of every description. No fees are charged for them. Consequently there is no excuse for being unprepared to offer.

There is too much of a disposition in the part of some institutions even a which they or their parents have a financial interest to keep Negroes from securing employment. The fact that many employees, laid off in the last few years must be provided for before new ones are taken on, should not stand indefinitely as a reason for the failure to hire Negroes.

Of course there is just one way to improve this situation and that is the conduct of a continuous intelligent campaign for jobs and the well prepared group of young people who can qualify when the opportunity comes.

BEARS WATCHING

David Lawrence, noted Political writer, says that the south has been given reasonable assurance that should the proposed Black-Conerney age and hour bill become a law, differentials in wages between that of whites and Negroes would not be disturbed.

Mr. Lawrence is one of the most able writers today, is well equipped to gather reliable information and as nobody has denied his assertion. If this is true then the Negro por-

tion of President Roosevelt's forgotten man is being sold out. Everybody knows that under the NRA the operation of the law was so arranged that about the only benefit it gave Negroes was shorter hours. And after all what we need most is more money.

We have known all along that this differential in wages between the black and whites existed in many quarters, but in no other instance has the government placed its stamp of approval on this pernicious practice.

The Bystander has not decided whether the legislation is sound or not. It has suspicions and if the statements quoted by David Lawrence are correct then we are sure to be counted on the other side.

CHILDREN IN COURT

Judge Malcolm Hatfield June 17—The sixteen year old boy who was arrested for automobile banditry today confessed his guilt in court. At the conclusion of the trial the judge drew the father and mother aside and said: "In the past you have been too lenient with your son. You have pleaded where you should have commanded. You coaxed and humored this child when your own experiences in life should have directed the course for him to follow. As a result he frankly admits that he lost respect for your judgment and followed out his own wishes. Now the state is forced to step in and take over the responsibilities which you, as parents, neglected to enforce."

Editor Bystander:

Again I am compelled to take issue with you in the matter of labor unions. In your issue of June 3rd you make some amazingly inaccurate statements relative to the unpleasant strike situation in Chicago. It is not true that the strikers marched to the plant bent on "closing" same by violent means. Neither is it true that the strikers even reached the plant. The facts are these. The strikers were exercising their legal rights under the laws of Illinois, by picketing, advertising and proclaiming the fact that a strike was in process of developments at this particular steel plant.

And, Lo; and Behold; when about three city blocks away from the plant, on the public street, marching peacefully along, these strikers were attacked by an army of police, who proceeded to manhandle, club, gas, and otherwise assault them. Thereupon the strikers armed themselves as best they could by picking up anything available and defended themselves as best they could.

As editor of the Bystander, you are familiar with the "kept" press in its play-up of "news." You know quite well that such things are played up usually along inflammatory lines, to make good reading. You have seen it done with the race you represent. And why you would take every evil report you get about organized labor as being true is beyond me.

Truly, it seems to me, when it comes to the battle of capital and labor, the Iowa Bystander is first, last and always against the workers, and 100% for the employers.

To be consistent you should stop complaining of mobs which lynch and burn Negroes at will. Because, the newspapers always state that the Negro "confessed" his guilt. Since you are bent on using the newspapers for your authentic guide in condemning the labor movement, you should likewise take the southern press statements on rape stories.

Health Talks

TETANUS

Lockjaw is caused by a germ that produces a toxin that has a special affinity for the central nervous system. The germ can live for months without oxygen; it is found in the soil and frequently on rust covered nails. The organism gains entrance to the body through wounds, especially penetrating ones such as those due to a nail or other sharp objects. It receives penetrating wounds or cuts outdoors should consult their physician about receiving a prophylactic dose of lockjaw serum to prevent the disease from occurring. Rarely does a case develop without any history of injury. The disease usually develops from one to three weeks after an injury the victim frequently forgetting the injury that previously had occurred. Among the first symptoms to occur are, a tired feeling, slight fever and stiffness of the jaws. The symptoms progress rapidly becoming more and more severe with the patient finally developing convulsions, coma and frequently death ensues. This disease is easily prevented but very difficult to cure.
