## Third American Negro Dies Fighting on Spanish Loyalist Front

## 75 Years for Patterson

### Cas Explosion From Lighting of Match, Probe Reveals

INVESTIGATE DISASTER

Birmingham, Ala., Oct. 28—W. B. Hillhouse, state mine inspector, investigating the recent Woodward Iron Co.'s Mulga coal mine disaster, which killed twenty Negroes and fourteen white men, declared this week that the gas explosion resulted when a match was struck to light a flame safety lamp.

Ivan Fox, 38, the only man to emerge from the mine alive, died at Bessemer hospital of burns and gashes, without being able to utter a word in explanation of the disaster at the state's "unluckiest mine."

N. A. A. C. P. HITS WAGE BILL DIFFERENTIALS

Clayton Powell, who held the charge for twenty-nine years. He was educated in the public schools of New York and at Colgate and Columbia universities.

He received his theological training at Union seminary and was ordained to the ministry in 1929. In 1933 Young Powell's marriage to Miss Isabelle Washington, former night club dancer, created a sensation, but Mrs. Powell is now an active worker in the church.

### F.P. Cone Believes in 'Hanging Them on Nearest Lamp Post'

ALSO ADMITS STATE HELPLESS TO CURB MOBS

Welcomes Federal Action

New York, Oct. 28—In an amazing statement here October 21, Governor Fred P. Cone, of Florida, put his personal approval upon lynching. A delegation of representatives of liberal and church organizations went to the Waldorf Astoria to question Governor Cone about the failure of Florida to prosecute the six Tampa policemen who flogged Joseph Shoemaker to death in December, 1935.

Governor Cone astounded his visitors by saying: "Anybody comes down to Florida and tries to overthrow the government of the United States, they ought to be rode out of Florida on a rail. . . . They ought to be hung to the nearest lamp post."

David Clendennin, of the Workers' Defense League, looked at Governor Cone in amazement. "Mr. Governor, you as an executive of the state of Florida approve of people taking the law into their own hands?" he asked. "Any people like that ought to be hung to the nearest lamp post," the governor repeated. "Would you take part in such a thing?" Mr. Clendennin asked. "Anybody came down to my house and I didn't want 'em, I wouldn't go to the law," said the governor. "I'd take the law into my own hands."

After explaining that Florida had done everything it could do in the Shoemaker case, Governor Cone, in answer to an inquiry, said he would welcome federal agents into Florida to look into the case.

### More Elixir Deaths

NEGRO FATALITIES LISTED

Chicago, Oct. 29—(CNA)—Four Negro and nine white venereal patients died last week after using a "proprietary elixir" of sulfanilamide, prescribed in venereal diseases.

All of the Negro fatalities occurred in East St. Louis, where another Negro was reported dying. Eight deaths were reported from Tulsa, Okla.

The drug has been recalled by the manufacturers, but it is feared that many more fatalities will occur before it is taken off the market.

Chicago, Oct. 28—(ANP)—Applications for Julius Rosenwald fund fellowships to be awarded in 1938 are now being received and will be accepted until January 15, 1938, it was announced this week by Ed. R. Eubank, president of the fund. Although many applicants are interested in advanced university work, fellowships are also given for qualified persons in the professions, fine arts, agriculture, journalism, creative writing, education, business or public service.

Raymond L. Paty, the fund's director for fellowships, will enter detailed correspondence concerning candidates or other aspects of the program, it was announced. Application blanks may be secured from headquarters of the Julius Rosenwald fund at 401 Ellis avenue, Chicago.

### Steel Plant Fills Strikers' Places With Negroes

REPUBLIC COMPANY MOVES EMPLOYEES NORTH, OUSTING CIO EMPLOYEES

Youngstown, Ohio, Oct. 28—(ANP)—Negro skilled workers are being transferred here from the Republic Steel Mills in Alabama to fill the vacancies left by the CIO sympathizing employees. For the past month the company has been checking files and fully examining all "foreign origin" workers in an effort to postpone or forestall any future strike.

Finding too few competent foreigners, the mill heads determined to transfer Negroes here since they had no major part in the recent strike. Alabama Negroes checked in lately and were assigned to jobs not frequently given to local colored employees. Dark faces so commonly seen on the ore piles are now seen in cranes, behind expensive machinery, and in skilled labor departments.

### HERNDON'S BROTHER KILLED IN ACTION, COMMANDED UNIT

Madrid, Oct. 28—(CNA)—Milton Herndon, brother of Angelo Herndon and commander of a machine gun company of the Abraham Lincoln battalion, was killed in action against fascist troops on the Saragossa front in Spain last week. A wireless message from Loyalist Spain, made public this week by the friends of the Abraham Lincoln battalion, 125 West 45th street, New York, said that the brother of the famous youth leader was fatally wounded during the recent Loyalist offensive against the fascist rebels and their Italian and German allies.

A member of the Young Communist League, of which Angelo is national chairman, Milton, 29, went to Spain six months ago to join the International brigade, composed of black and white anti-fascists of all countries. He was soon promoted to commander of the Frederick Douglas machine gun company and was active in many engagements at the front.

Milton Herndon was the third American Negro member of the Abraham Lincoln battalion to be killed in action. The other two were Alonzo Watson, killed on the Jarama front on February 15th, and Oliver Law of the Tom Mooney machine gun company, killed at Brunetta last July. All three had received citations for bravery under fire. At least 100 American Negroes, as well as many Negroes from the West Indies and Africa, are fighting in the Loyalist armies against the fascists. Forty per cent of the Americans have received officers' commissions.

WASHINGTON, D. C., Oct. 28—Without the help of Justice Black's vote the Supreme court of the United States decided with Alabama in the famous Scottsboro case. Heywood Patterson must serve 75 years in penitentiary. The court held that the latest trials in the noted case did not infringe upon the Constitution. Twice before, it saved Patterson's life by reversing death sentences.

Four of the Scottsboro boys are now at liberty, having been freed the trials were too expensive and that the trials were to expensive and that they were to a degree of bankruptcy the county. The four boys are Olen Montgomery, Willie Robertson, Roy Wright and Eugene Williams.

In 1932 when the Patterson appeal was taken to the Supreme court, it held that he and other defendants had not been provided with adequate counsel. Three years later it ruled that Negro members had been "systematically excluded" from the juries, which indicted and convicted him.

At the last trial, two Negro members were qualified for jury service in the Clarence Norris case, but were turned down by the state after preliminary questioning.

The decision of the Supreme court came as a surprise to counsel for Patterson. It is believed that the court "tired" of the case, and decided in conference to virtually end it.

Associate Justice Hugo Black who has confessed his Klan affiliation, took no part in the procedure. By withdrawing from consideration of the Scottsboro case, Justice Black forestalled a threatened challenge of the validity of his appointment to the Supreme court.

The only appeal now open to Patterson and the other defendants for their freedom is to Governor Bibb Graves of Alabama.

Sealed

The five boys now remaining in jail, and whose fate was practically sealed with the recent Supreme court decision are: Andy Wright, given 99 years; Charlie Weems, convicted last July and given 75 years; Clarence Norris, sentenced to die; Ozie Powell, serving 20 years for assault with intent to kill; and Heywood Patterson.

They were accused, along with the four boys now at liberty, of attacking Victoria Price and Ruby Bates, two jungle camp prostitutes, on March 25, 1936.

## No Race Problem In Sweden Says Anders Hedberg

CO-OPERATIVE HEAD IS INTERVIEWED HERE

No race problem faces the Swedish government and even if there were more Negroes in that country, no prejudice would develop, believes Anders Hedberg, co-operative leader, of Stockholm, who spoke before members and friends of the Co-operative Services, Inc., at Drake university on Thursday, October 21.

Mr. Hedberg, making a tour of the U. S. with Mrs. Hedberg, was interviewed at the Hotel Kirkwood on Friday morning. He was very enthusiastic about the responses of the American Negroes to his movement, which he started in 1931. "Colored people in Chicago, especially, heartily supported our ideas," Mr. Hedberg added.

Taking over the electric light bulb industry in Sweden, which had developed into a high price commodity as result of electric current at practically no cost there, Mr. Hedberg, known as a "trust buster," has succeeded in cutting prices in the milling and rubber and reducing unemployment to zero.

The Des Moines organizations include a co-operative oil station and a grocery store. Spencer Elliston, Bystander advertising and promotion manager, has sponsored a similar branch two years at a community near Ankeny, Iowa, where he operates the White Rock chicken farm.

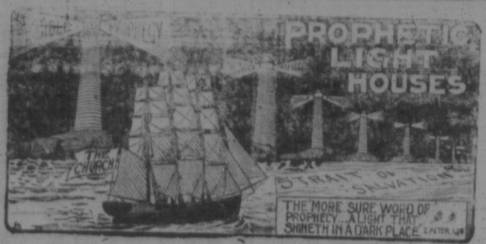

JUNIOR TOPIC—The Greatest Law. INTERMEDIATE AND SENIOR TOPIC—Why Is It Wrong to Drink Alcoholic Beverages? YOUNG PEOPLE AND ADULT TOPIC—The Moral Issue in the Drink Problem.

The title for our lesson is well chosen—"The Moral Issue in the Drink Problem."

First, let it be clear that there is an issue. Those who have business, social, or political connections with the liquor traffic would like to have us believe that the repeal of prohibition settled the matter once for all. But let us be sure of this fact—the liquor problem is at our very door, and it must be met.

In the second place, many would have us think that the matter of drunkenness is a social, political, or even a physical problem, without any moral implications whatever. But those who are informed know that even the supposedly innocent beer is inextricably tied up with vice and crime.

The word millennium is not found in the Scriptures. It is of Latin derivation and means a period of one hundred years. A decade is ten years, a century is a hundred years and a millennium is a thousand years.

With the return of beer will come open prostitution and gambling. His words were true. I. Drunkenness Is a Work of Darkness (Rom. 13:12-14).

Just as there are darkness and daylight in the physical universe, so there are two contrasting spiritual realms of darkness and light. Men "loved darkness rather than light because their deeds were evil," according to the Lord Jesus (See John 3:19). This spiritual realm of darkness is directed by "rulers of the darkness of this world" (Eph. 6:12), and their purpose is "spiritual wickedness." With the "works of darkness" the believer is to "have no fellowship" (Eph. 5:11), but is to "reprove them" and bring them into the light where their true nature is made manifest (Eph. 5:13).

"God is light, and in him is no darkness at all," and those who have fellowship with him "walk in the light" (See 1 John 1:5-7).

Drunkenness is a work of darkness. It separates man from God and makes him fear the glorious light of his countenance. The solution for that awful condition is revealed in v. 14. "Put ye on the Lord Jesus Christ."

II. Drunkenness Is a Work of Unrighteousness (I Cor. 6:9-11). No drunkard "shall inherit the kingdom of God" (v. 10), and the man who takes his first drink has put his foot on the path that leads to the drunkard's grave. Of course no man plans to go that far, but the fact is that such is the tragic conclusion for hundreds of thousands of men and women—damned for time and eternity by drink.

Again in this passage we have the answer to our problem. Not reformation, not education, not culture (desirable and useful though we recognize these things to be), but being "washed," "sanctified," and "justified" in "the name of the Lord Jesus and in the Spirit of God." Try that on your town drunkard. Thank God, it works!

III. Drunkenness Is a Work of the Flesh (Gal. 5:16-24). The flesh—that is our bodies ruled over by self-will as opposed to God's will—is revealed in the Scriptures to be thoroughly bad, and in opposition to God. Consider the appalling list of the works of the flesh in verses 19 and 20. And note that in the midst of them stands drunkenness.

It is the lowest in man that responds to intoxicants. Little wonder that the Brewers' Journal came out right after the election of 1932 with the statement that "not one-tenth of one per cent of American youths know the taste of real beer. We must educate them." In other words the normal taste of an intelligent person would revolt at the stuff, but once give it a chance to stir the lusts of "the flesh" and the victor is sought.

Once again, note the antidote—live in the power of the Holy Spirit, and the flesh with its lusts is crucified (v. 24). How shall we have the Holy Spirit and his power in our lives? By taking the Lord Jesus Christ as personal Saviour.

Words Without Action Few men succeed how much mere talk fritters away spiritual energy—that which should be used in action, spends itself in words.

## LONG FIGHT NEARLY ENDED

Leavenworth, Oct. 21—Robert Tillman, former member of the Twenty-fourth infantry, who was sentenced to Leavenworth prison as a result of the Houston riot of 1917, has been released from prison. The adjutant general's office of the war department advised the N. A. A. C. P. of New York on October 12th that the unexecuted portion of Tillman's sentence had been remitted and he is a free man.

**SUPPORT OUR COMMUNITY PROJECTS**

The Y.M.C.A. drive closed last week and while the city-wide campaign fell short of its goal, the Crocker Street department passed its quota. The Y.M.C.A. can do a lot of good. And while the Bystander can never feel wholehearted about the general Y.M.C.A. set-up in Des Moines because of their neglect of the Negro work, the organization should be supported pending the fight that must be made for a better deal for the Negro work at the hands of the present management.

The annual Roll Call of the Red Cross is in progress. Most people know the service this organization has given all over the world; Des Moines people should congratulate themselves upon a loyal chapter which gives liberal service to Negroes without discrimination of any kind. It is encouraging to have such a chapter.

Next month the Community Chest drive will be in progress. The program of this organization is varied and takes in a great many groups. Among them are the Y.W.C.A. which has gone a long way toward making the Blue Triangle branch a real part of the organization; the West and East side community centers which while entirely inadequate to fill the needs of their constituency do a fine job and get splendid help and cooperation from the chest.

Of course there are other agencies in the chest many of which serve all without regard to race or color. And while it is not our purpose to help such institutions only where Negroes are involved, it is well to point out the high lights among those deserving commendation.

Let everybody give something. These projects are community responsibilities.

## LABOR AT WAR

Efforts are being made by the AFL and CIO to bury their differences and work together on a united front for the cause of labor. Already their respective peace delegates have disagreed and the party has been set over to meet again in November. The great obstacle is the inability of either of the leaders of the two factions to agree to play second fiddle.

And this makes us chuckle and proceed to think of some of our white friends who accuse the Negro of more division among themselves than any other group; who fall to follow their leaders because of jealousy more than any other group. We never agree with them in the least recognizing as in the case of organized labor that we are all subject to the same lust for power as the leaders of any other group—that by and large human nature is just the same in black as well as white skins.

Frankly, we hope the two organizations don't get together. For in one a few select people are protected; in the other every worker in an institution is protected. And after all the fellow lowest down needs more protection than the one higher up.

## A NEED FOR THE PRESS

Mrs. Franklin D. Roosevelt spoke at a meeting in New York City last week held in the interest of the Crisis, official organ of the N.A.A.C.P. She spoke on "The Relation of the Press to Politics." We quote from a news story of a part of that address: "She spoke repeatedly of the good of the press and the necessity of or-

ganizations catering to the newspapers, be they political or otherwise. She also advised her listeners to pay strict attention to the plea that the press is the one organ through which minority groups may make their wishes and sufferings known."

Class papers representing minority groups are very necessary for the big metropolitan dailies, for the smaller papers of a general nature for that matter, are unable to devote much space to individual groups due in part to the lack of space and very often to the fact that they find it does not help their advertising sales.

A town without a Negro paper is bound to be backward in its treatment of the Negro group; there is no provision for other groups to learn the Negro's problem from his own point of view.

This was indeed a timely message; one that would do good in any territory where class papers are in circulation.

## What Others Say

### "ONE THING NEEDFUL"

As stated in last week's article, One Thing Needful is still before us. It is still Unity, unity, unity. All our strength lay in our union; all our weakness in our discord. We need an organization that will reach out and meet the needs of the masses. An organization that is big enough to control its own business, instead of a FEW controlling it. We need unity in spirit, and in action. We are great on talking U N I T Y. We can use beautiful language and swelling phrases coined into a flow of voice, but to put in action the thing we preach, is ONE THING NEEDFUL.

## Health Talks

By Dr. C. E. Bradford

### MORE ABOUT VITAMINS

What are they? They are organic food substances found in various foods we consume, but only very small quantities (Milligram) are necessary daily for body growth and to maintain normal functions of tissues. Their purpose is to control the utilization of various food-stuffs, such as, fats, carbohydrates, proteins, water and minerals.

One vitamin cannot replace another and all of them must be in sufficient quantity for normal body functions. The exact number of vitamins is not known, but to date, six vitamins have been studied carefully; they are vitamins A, B<sub>1</sub>, B<sub>2</sub>, (G), C, D, E. Infants, because they are unable to digest all kinds of foods and expectant mother who require large amounts of vitamins both frequently require extra vitamins added to their diet either in the form of a drug or some special food that is high in certain vitamins. Children who develop vitamin deficiency diseases must have an increased dose of vitamins in the same manner if they are expected to recover. Because of the ill effects derived from lack of proper vitamins special study should be given to the diet of infants, children and expectant mothers.

## "OPPOSE PLAN TO PLEASE SOUTHERN JIM CROW"

New York, Oct. 21—Now that the special session of congress has been called definitely for November 15th, for the primary purpose of enacting an agriculture bill and a wages and hours bill, the N. A. A. C. P. sounded again a warning for colored people to be on guard against attempts that are sure to be made to draft a wages and hours bill more acceptable to the south than the one introduced in the last session. The wages and hours bill, as drafted and introduced by Senator Black and Representative Connery, was fought bitterly by congressmen from the deep south, who are afraid the bill will benefit Negro workers in Dixie. The N. A. A. C. P. has joined with those who are opposing any geographical wage differential on the theory that just as was the case with the N. R. A. geographical differentials in wages will be used to enforce what are in reality racial differentials.

The American Federation of Labor convention in Denver last week went on record against wage differentials in the wages and hours bill. On October 14th Walter White, N. A. A. C. P. secretary, telegraphed John L. Lewis, chairman of the Committee for Industrial Organization, which is holding its convention in Atlantic City, urging the C. I. O. to pass a resolution "opposing any geographical differentials."

## BETTER JOBS FOR SUBWAY WORKERS ASKED BY N. A. A. C. P.

New York, Oct. 21—A request that Negro employees of the Interborough Rapid Transit subway system be given better jobs than porters and elevator operators was sent to the first annual conference of the Transport Workers union here by the N. A. A. C. P. last week.

## SELASSIE SEEKS RAILROAD STOCKS

Paris, Oct. 21—(C)—A solicitor acting for Emperor Haile Selassie of Ethiopia applied to the civil courts Tuesday to have 8,000 shares of the Ethiopian railroad, which were registered in the name of the "King of Kings," the title assumed by Selassie when in Ethiopia, transferred to his own name.

Italian authorities claim the stock of the French built railroad, since Selassie left the country. The action was postponed.

## WAR DEPT. TOLD OF DISCRIMINATION AGAINST NEGROES

New York, Oct. 21—Following up the Chicago speech of President Roosevelt, in which he scored the ac-

tivities of aggressor nations and implied that democracies and peace loving nations must be prepared to enforce peace, the N. A. A. C. P. has written Secretary Harry H. Woodring, of the war department, and President Roosevelt, urging the removal of all discrimination in all branches of the military and naval services of the United States.

The N. A. A. C. P. letter warned that in the event of a war crisis, the Negro citizens of the nation would not endure the humiliation and insults which were heaped upon them and that their soldiers at the time of the World War.
