HERRING VOTES WITH SOUTH TO SHELVE ANTI-LYNCH BILL

Dr. C. R. Bradford Re-Appointed County Physician, Pay Raised

After a year's service, Dr. C. R. Bradford, 404 E. 5th Street, physician and surgeon, was reappointed as county physician by the Polk County board of supervisors last week.

The renewal contract issued to Dr. Bradford called for a raise from \$1,200 to \$1,500 per year. The salaries of the other three doctors remained the same as 1937. They are Drs. Rodney P. Fagen, Floyd E. Burgeson and C. H. Carryer.

Dr. Bradford was the first Negro in the history of Polk County to be named to this position. All of the indigent Negro patients out of the more than 6,000 colored people in Polk County are served by him.

A graduate of Meharry Medical college at Nashville, Dr. Bradford was interne at the General Hospital No. 2 at Kansas City, Missouri, before coming to Des Moines in 1933.

A widely known authority on medical history and health problems of the Negro race in the nation, Dr. Bradford is much in demand as a speaker. His column "Health Talks," a weekly feature in the Iowa Bystander, is read by hundreds.

Belonging to the N. A. A. C. P., Boy Scout committee, Lincoln American Legion post, and a member of St. Paul A. M. E. church, are some of his civic affiliations. His wife, a former Kansas City nurse, is attending Drake University.

Wagner Demands Vote on Measure

Washington, D. C., Feb. 10.—A demand for a vote on the anti-lynching bill was made here last week by Senator Robert E. Wagner, co-sponsor of the Gavagan-Wagner-Van Nuys anti-lynching bill, in a speech in which he vigorously defended the constitutionality of the measure and cited the duty of the federal government under the 14th amendment to the Constitution to protect citizens in their right to due process of law.

Senator Wagner's speech was the first formal one on the bill itself and the second that has been delivered for it since the filibuster began January 6. Senator M. N. Neely, of West Virginia, spoke 30 minutes for the bill on January 27.

Senator Wagner emphasized the provisions of the 14th amendment that "no state shall... deprive any person of life, liberty or property without due process of law; nor deny to any person within its jurisdiction the equal protection of the law."

The Rev. H. L. Overton, for eight years pastor at Burns M. E. church, 811 Crocker st., here, now of Scott M. E. church in Denver, Colorado, visited in Des Moines this weekend. He delivered the morning and evening sermons at Burns Church Sunday to capacity audiences. Visitors from other churches packed the auditorium.

Seriously injured in an auto crash two years ago, he left Des Moines to live with his parents in Denver where he has fully recovered. Overton has been attending school nine months.

ANTI-LYNCHING BILL INTRODUCED IN MISSISSIPPI LEGISLATURE

Jackson, Miss., Feb. 10.—(A. N. P.)—An anti-lynching bill that would make mob members liable to charges of murder was introduced in the Mississippi legislature Wednesday by Rep. Hilton Waits of Greenville, who asked assemblymen to enact a statute of their own "to checkmate federal intervention in state's rights."

Waits, who also said the bill was designed to show the North that Southern states "could handle their own affairs," defined lynching as "any act of violence by a mob which shall result in death."

Suit Dismissed Against Louis

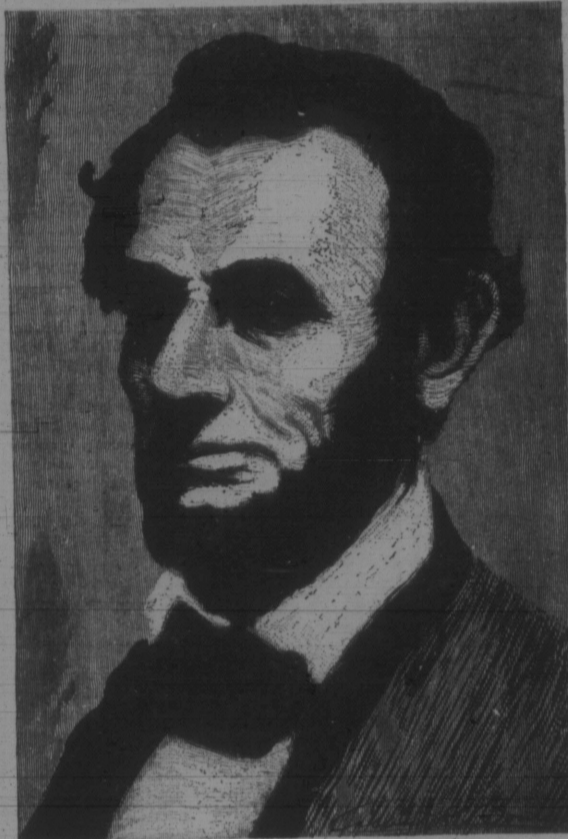

"Four score and seven years ago, our fathers brought forth upon this continent a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal. Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battlefield of that war. We have come to dedicate a portion of that field as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this. But in a large sense we cannot dedicate, we cannot consecrate, we cannot hallow this ground. The brave men, living and dead, who struggled here have consecrated it far above our power to add or detract. They will little note, nor long remember what we say here, but it can never forget what they did here. It is for us, the living, rather to be dedicated here to the unfinished work which they who fought here have thus so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us—that from these highly resolved and devoted dead shall not have died in vain, that this nation, under God, shall have a new birth of freedom—and that the government of the people, by the people, for the people, shall not perish from the earth."

Race Relations Day Sunday

The fourteenth annual observance of Interracial Sunday will be held by the Des Moines Interracial Commission at the citywide program at St. Paul A. M. E. Church, Twelfth and Crocker Streets, Sunday at 3 p. m. The day is observed throughout the country on the Sunday nearest the anniversary of the birth of President Lincoln, whose emancipation of the slaves was the first step toward better relationships between Negroes and white people of this country.

The principal address will be given by the Rev. Raymond M. Shipman, pastor of Wesley M. E. Church and President of the Iowa Ministers' Convocation, which met in the city this week; and Mrs. S. Joe Brown, member of the Church Women's Committee of the Federal Council of Churches, and chairman of the Race Relations Committee of the Women's Interdenominational Missionary Council. Music will be furnished by the East Des Moines Choral Club under the direction of W. M. Wheels, and community singing will be led by Dick Athens, director of Youth Movement, University Church of Christ.

The invocation will be given by the Rev. R. H. Hackley, pastor of St. Paul A. M. E. Church, and the benediction by the Rev. Paul E. Becker, pastor of the University Church of Christ. Mrs. Horace S. Hollingsworth, newly elected Chairman of the Commission and the first woman to hold this office, will preside. This meeting was arranged by the church relations committee of which Rev. Paul E. Becker is the chairman. The public is invited to attend.

Pollard Quits School

GRAND FORKS, N. D., Feb. 10, (A.N.P.)—Fritz Pollard Jr. of Chicago, Olympic hurdler and star half back at the University of North Dakota, has dropped out of school, it was revealed Friday by C. A. West, football coach and athletic director.

No reason was given for his leaving. Pollard had registered for the second semester and attended classes last week, which indicated, West said, his decision was sudden. The athletic director did not know of it until the star athlete had gone.

"Pollard was a junior and had two years of track competition and one year of football remaining at the university," West added.

Deny Bishop Tookes in Fight

LITTLE ROCK, ARK., Feb. 10, (A.N.P.)—Indignant denials that Bishop H. Y. Tookes, presiding bishop over the 12th Episcopal District of the A.M.E. Church comprising Arkansas and Oklahoma, had been involved in a brawl with W. A. Singleton, local attorney, as published in several newspapers last week, were issued by his friends here this week.

"As a matter of fact" said the signed statement, the article published was regarding an incident more than a month old. Bishop Tookes and Mr. Singleton disagreed over a debt owed Mr. Singleton by Shorter College. It was not the bishop's debt but the school's obligation. Mr. Singleton requested payment of the bill and the bishop settled for the school.

"The bishop was not slapped. There were no blows passed between the two men. Attorney Singleton himself swears that this statement was false. So is the published report that Bishop Tookes went to the office of the Southern Recorder and secured a gun. Editor J. H. Clayborn does not have a gun and never had one in his office.

The meeting took place in a drug store and witnesses have signed a statement that the story was untrue. Bishop Tookes friends wired \$200 to Atty. N. K. McGill instructing him to bring a libel suit against offending newspapers in the federal court if retraction was not forthcoming immediately.

Joe Wilson Guilty Of 'Dime' Slaying

After two hour's deliberation, a jury in the court of District Judge O. S. Franklin found Joe Wilson guilty of murder in the first degree for the "dime" slaying of Frank Crowder. The jury fixed the penalty at life imprisonment.

Wilson will be sentenced February 11. Motions for a new trial will be heard at that time. If denied, an appeal will be made to the Iowa supreme court, Atty. Charles P. Howard, defense attorney, said.

Wilson was charged with fatally stabbing Crowder for asking him for a dime in a crap game at 939 12th street on December 30. The prisoner was arrested two days later in Omaha and returned here for trial.

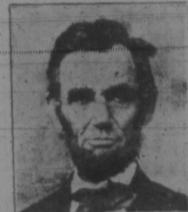

Health Chats

HEART PAIN

The interpretation of heart pain is often a most elusive symptom with which the physician has to deal. The pain may extend from the region over the heart to the left shoulder and left side of the neck.



Sometimes it may be over the base of the breast bone and epigastrium and may be confused with gastric ulcer, gall stone, or acute gastritis (indigestion).

In place of pain some patients complain of burning sensation, a coldness, or a sense of pressure or restriction in the chest or neck, extending occasionally down the left arm.

Well, that is a real confession that the south had not been doing the job properly in the past and that its citizens were willing to undertake the task in earnest since the federal government was threatening to do so.

The legislative and executive branches of our city should be separated. Trained executive at the head of the city will get more for the tax dollar paid into the public treasury than we are receiving at the hands of inexperienced heads of our city government.

Continued deficits in the operation of the city are bound to lead to a disastrous situation in our city finances which will hurt small as well as large taxpayers.

Excessive taxes tends to retard the progress of a town and prevents industries from locating in it.

The city manager law provides sufficient checks upon a manager that there is no sound basis for the argument that he will be a dictator.

Labor has no valid reason to fear that wages will be cut or that any legitimate employee who is giving a good days work will be disturbed. There is no difference in having a member of the city council hire and fire employees at will--which is the case now--than have a city manager do it.

The higher type servant we have at the city hall the higher type employee and the larger number of Negroes will be found at the city hall.

Negroes suffer more from the cheap log-rolling politicians than from the more independent who will not fear to favor minority groups in order to satisfy an intolerant bunch at the head of majority groups.

Negroes have found favor in most of the city where they have the manager plan. The people back of the city manager plan propose that Negroes shall have a fair deal should the manager plan carry. They have been liberal in their employment of Negro clerks in the conduct of the campaign.

That only one department of the city government--the Police Department--has been anything like fair in giving Negroes decent consideration in the distribution of jobs. I want ALL of them to be fair in this matter. Des Moines has increased its debt since 1933 in the sum of \$385,000 which does not take into consideration a claim of over \$200,000 of the Water Works and \$50,000 of the highway commission.

Over \$4,000,000 of Des Moines debt represents deficits. City Manager cities, have almost without exception operated without deficit.

"White collar" payrolls in City Hall in Legal, Clerks Office, Health, Auditors, Building and Electrical Inspection divisions have increased \$32,000 since 1928, while labor appropriation only increased \$23,000.

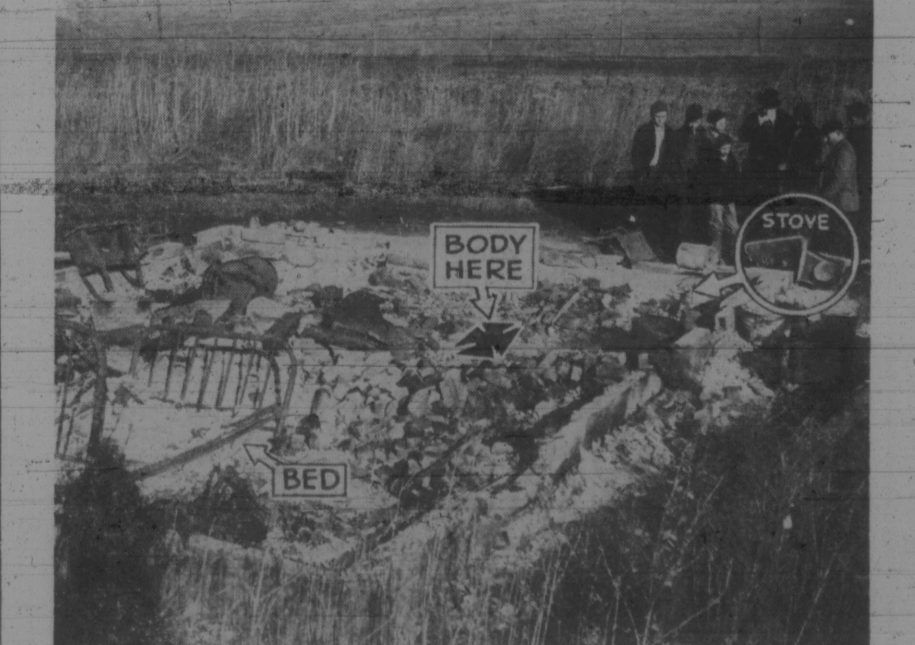
