This week women of the United States celebrate the twentieth anniversary of the Constitutional amendment which gave them the right to vote. Their participation in public life is now so widely accepted that memories of what used to be grow dim.

Back in 1776, the year the American colonies declared their independence, Abigail Adams wrote to her husband, John, in the Continental Congress:

"By the way, in the new code of laws which I suppose it will be necessary for you to make, I desire you would remember the ladies and be more generous and favorable to them than were your ancestors."

Then she added, in effect: "If women are not represented in this new republic, there will be another revolution."

These were not her exact words. She was too shrewd a woman to speak so bluntly. But her meaning was sufficiently clear that some historians quoted her that way.

And she was right. For in spite of her warning, the colonial dames were not given the right to vote. And the revolution they and their daughters kicked up in protest has been growing more explosive ever since.

As an aftermath it produced a Sojourner Truth; Mary Church Terrell; Francis Harper; Maggie Walker; Ida Wells Barnett; Mary Bethune; Nettie Napier and a host of other pioneer race women who could be classed under the heading of heroines before the 20th century. Those of the twentieth century are Sallie Stewart; Leatha; the late Dean Lucy Slowe; Judge Jane Bolin; Mrs. Arthur H. Faucett; Eunice Hunter; Mrs. S. Joe Brown; Faye Allen and many others; who since women have been given the right to vote made history. To these women of the white race—we salute you who helped Lincoln free the slave and have in force of condemnation stood for the rights of Negroes. All of you have contributed something worthwhile to America.

Typewriter keys fly fast and furiously in the Polk County Auditor's office where twenty-one-year-old Miss Annabelle Payne is one of the efficient stenographers and file clerks. Tax reports are her worries. Last month it was dog taxes—the length, the widths, weights, ages, names and valuation of the dogs.

In an interview this week at her desk Miss Payne smiled as she related parts of the humorous information that accompanied some of the dog tax reports.

At present she is busy compiling homestead tax reports, piles of which rise high on tables and desks almost hiding her cheerful smile with which she greets everyone.

The only Negro representative in her department, she received her appointment which is on the schedule of an "extra" from Auditor L. O. Linstrum.

Mr. Linstrum is quite pleased with the work of Miss Payne.

She is a young lady of very fine character and her work has been exceptionally good. When I say that I mean exceptionally good. She is a very consistent worker and gets along fine with all of the other workers. I feel very fortunate in having her in my department." Mr. Linstrum, county auditor for two years led a representative of the Bystander Wednesday.

A native of Iowa, Miss Payne attended Boone Biblical College for ten years, then graduated from North High school. In Chicago she was a student at Wilson Junior college.

MRS. MORRIS HEADS NAACP IOWA CONFERENCE

Mrs. Georgine C. Morris of Des Moines was elected president of the Iowa conference of the branches of the National Association of the Advancement of Colored People, at the session which convened here Friday night, April 26, at the Blue Triangle branch Y. W. C. A.

The conference represented six Iowa cities: Des Moines, Mason City, Waterloo, Ottumwa, Keokuk and Marshalltown.

Other officers are: L. D. Ferguson, Waterloo, vice president; Mrs. Gladys Carr, Des Moines, secretary; and the Rev. Paul Scott of Mason City, treasurer.

The executive committee is composed of S. Joe Brown, Des Moines; M. F. Field, Waterloo; R. O. Win-

ston, Ottumwa; Mrs. A. A. McGinty, Mason City and Mrs. C. D. Bland of Keokuk.

The meeting also authorized each of the branches represented to elect one member to an advisory committee to act with the executive committee.

First objective of the conference was announced as a movement to suppress what was reported to be the segregation of Negro patients in the state tuberculosis sanatorium, Oakdale, Ia.

The following committee chairmen were appointed this week by Mrs. Morris: legal redress—Atty. Casper Schenk, Des Moines; education—Miss Rose Bannon, Marshalltown; press and publicity—Mr. Quinten Mease, Des Moines; speakers bureau—Miss Jessie E. Walker, Marshalltown; finance—Mrs. Kenneth South Myers, Keokuk.

Started on Route Here as One of First Horse and Buggy Carriers in State

Sioux City—Four days following his sixty-fifth birthday on April 26, C. E. Stubblefield, Sioux City post-office employee, was retired on May 1, after 40 years service.

Mr. Stubblefield began work with S. C. postoffice September 1, 1901, during the horse and buggy days, as a carrier. He was promoted to a clerk March 1, 1911, then to special clerk in July 1936.

Born in Nashville, he was graduated from high school there and became a teacher in a rural school at the Hermitage, Andrew Jackson's homestead.

In 1939, when he was 21 years old, he took his bride with him to Kansas City, Mo., where he purchased an oil tankwagon. At that time kerosene was the principal source of illumination and Mr. Stubblefield intended to enter the oil business. Not preferring Kansas City they moved in 1899 to Sioux City. Not long after his arrival here he became a substitute carrier.

Saturday, April 27, Mr. Stubblefield broadcasted on the "Your Postal Service" over station KTRI, when postal officials and employees paid tribute to him.

Pastor Talks on Good Will Tour of West

Returning from over 20,000 miles from the Good-Will Tour which concluded in Chicago last Saturday, the Rev. G. W. Robinson, pastor of Corinthian Baptist church, brought echoes of his trip to his membership on Sunday night, April 28.

Headed by the Rev. E. Arlington Wilson of St. Louis and Dr. L. K. Williams of Chicago, teams mobilized in Omaha and Chicago.

The tourist party reached as high as 61 persons. "At every point we were met by a large delegation and had police escort to our places of entertainment," the minister said.

In Minnesota the party was welcomed by the governor of the state. From St. Paul the party journeyed to Spokane, stopping at Butte and

Pocahontas, and then the group went to Seattle.

"Our meeting in Seattle was a high point as many of the tourists filled the pulpits of many of the churches both white and colored," Rev. Robinson related. He revealed that 26 persons were added to Zion Baptist church, twenty-one for baptism.

Leaving Portland the tourists journeyed to Oakland and San Francisco, there meeting a number of Iowans, then to Santa Barbara, Los Angeles and San Diego marking the "highest point in our journey."

"We met so many Iowans that we thought we were in Des Moines, as we spoke to the Second Baptist church of which Rev. T. L. Griffith is the honored pastor," the minister remarked. Dr. Booker and Jesse Graves were other persons seen.

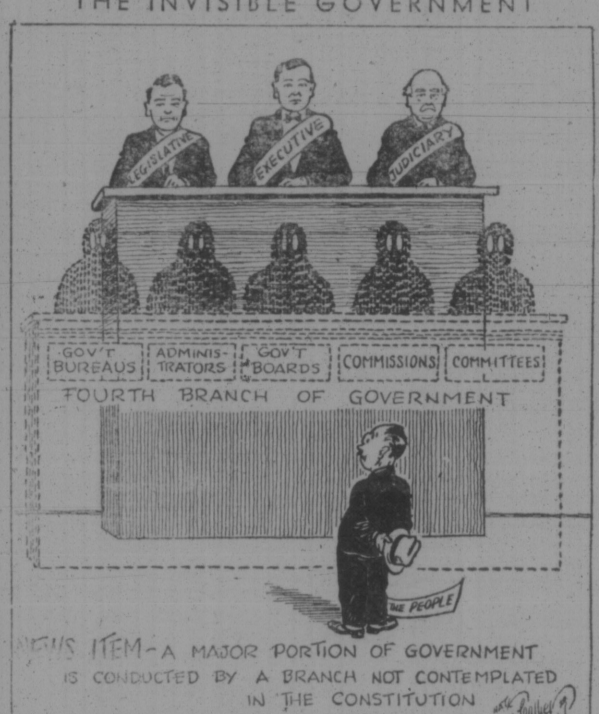

DEAN HASTIE REPLIES

In a speech before the National Negro Congress in session in Washington, D. C., Sunday, delivered by Dean Hastie of the Howard University Law School and broadcast over the radio, a logical reply was made to those who oppose anti-lynching legislation because the number of victims had decreased to the point where only five occurred last year. He said that while only five were lynched last year, every Negro in certain sections of the country lives in constant fear of mob violence; he knows that if he attempts to enforce his civil, political and economic rights as any other man would, he is subject to be met with mob violence and therefore rather than be embarrassed by threats or shot down, he passes up many things that ought to be contested.

Most laws in the South would not discriminate against Negroes if they were enforced fairly whether blacks or whites are involved. For instance far more Negroes would vote if the election clerk gave them the same test as he does the whites. But they don't and at times Negroes are warned to stay away from the polls. Of course there is no law for this, but they know trouble is likely to arise so they remain away from the polls.

As a matter of fact other sections, while not so pronounced, are not free from this threat of unpleasantness, which may not be mob violence but embarrassment. How often has the statement been made, "you have the legal right but in order to keep down trouble you ought not press the fight."

How often have Negroes gone into communities and desisted from exercising ordinary civil rights simply to keep down trouble? It is the same threat—only in a milder degree.

The Bystander thinks Dean Hastie has something here when he makes that argument believing that it is a very clear answer to those who oppose anti-lynching because the number of victims has decreased.

COUNTING LANDMARKS

Maple Street Baptist, one of the Des Moines' oldest churches, has just completed the celebration of its fortieth anniversary. Included in the series of services was the tenth anniversary of the pastorate of Rev. A. Ross Brent.

In spite of the depression, which hit these people about as hard as any other group in the city, they have built a new church and today it stands free of debt. The membership has kept pace with the material growth of the church. Of

course, a church building does not make a church, but it is evidence of progress and in the end most churches cannot get far without a building.

Maple Street and its pastor are to be congratulated and the Bystander takes this opportunity of wishing them many more years of spiritual and material growth.

LETTERS FROM SENATORS

TO MRS. S. JOE BROWN

In a letter to Mrs. S. Joe Brown, president of the Central Association of Colored Women, Guy M. Gillette, Iowa senator, responded regarding her reference to the Anti-Lynching Bill.

"I assure you that no one could be more strongly opposed to mob law than I. But I have been somewhat hesitant to support the pending Anti-Lynching bill because I believe it to be a clear invasion of the rights of States under the Federal Constitution. If the bill is amended to meet this Constitutional objection, I shall support it on its merit." This letter was written on April 19.

Senator Clyde Herring wrote Mrs. Brown regarding the bill: "should the measure to which it refers come before the Senate for consideration at the present session, I shall bear in mind your suggestions."

Negro Chamber to Begin Evening Meetings May 7

To widen the scope of economic opportunity for the Negro in Des Moines, to cooperate with any established organization or agency dedicated to achievements of civic and social justice for the Negro were the two objectives submitted by the Des Moines Negro Chamber of Commerce at the regular meeting Monday, April 29.

The planning committee of the Chamber pointed them out as the outstanding and important needs.

For the benefit of persons who are unable to attend the noonday sessions of the Chamber, a series of evening meetings, monthly, will begin on Monday, May 7, at the Maple Street Baptist church. Dinner will be served and the regular meeting of the Chamber will be held.

Among the interesting features of the noonday meeting last Monday was the presenting of Dudley B. Luck of the Continental Oil Company by the program chairman, Mrs. Marie Roberts.

Mr. Luck spoke on the development of Negro business pointing out the importance of improving the status of the credit rating of the Negro and of increasing the purchasing power of the Negro.

"The greatest weakness in Negro business," Mr. Luck pointed out, "is the poor management it has. Negroes should be trained in the practical side of business as well as the experimental."

Health Hints

By Dr. C. R. Bradford

RABIES (Hydrophobia)

Rabies is a specific infection of canines and man. It causes great excitability and derangement due to a virus of unknown character. The virus may be passed from man to man through bites, but man is most usually infected by the bites of a rabid dog, unless often by a rabid fox or wolf.

The virus is always introduced through the bite of a rabid animal which may have healed long before the initial symptoms appear. Therefore, the portal of entry may be indefinite. The incubation period may vary from six weeks to six months or even a year. This prolonged lapse of time is characteristic of the disease, and during this period there are no symptoms.

The first indication is a soreness or numbness at the point where the bite was inflicted. This is soon followed by dysphagia (difficulty in swallowing), dyspnea (difficulty of breathing), and dysarthria (imperfect articulation or utterance). This is soon followed by definite spasms, particularly of the muscles of the pharynx, larynx and diaphragm. The slightest stimulus of sight, sound, smell or desire to swallow may initiate a painful spasm. It is from this last symptom initiated by the sight of water that dehydrated individual suffers the most acute agony, hence the synonym—hydrophobia or fear of water.

The voice is husky and the laryngeal spasm may eject a cry likened unto a dog bark. This stage is accompanied by fear, mental excitation, delusions, hallucinations and even mania. It lasts several days and is followed by a state of depression and exhaustion which soon progresses to coma and death.

The successful treatment of rabies depends entirely on the recognition of the possibility of infection during the incubation period, when the patient may be immunized so that when the incubation period is over, there is complete protection which emphasizes the importance of ascertaining whether or not the dog or other canine which bites a person, is rabid. If this is not done, the possible diagnosis is purely speculative, and unfortunately people are prone to give the benefit of the doubt in favor of the animal's not being rabid.

Our nation is still burdened with unemployment; low wages; disfranchisement of black and white citizens; a low educational level; civil injustice and discrimination against minority groups. These are some of the things that Negroes, who are oppressed along with other minority groups in the nation, must use their ballots to abolish—nothing is more important.
