JAMES HENRY WOODS LIVED HERE 50 YEARS

Funeral rites for Mr. James Henry Woods who had been a resident of Des Moines for a half century, will be held Saturday, July 13, at 2 p. m. from Estes Funeral Home. Burial will be in Glendale Cemetery.

Following a long illness at his home at 1420 Maryland avenue, Mr. Woods died Thursday morning, July 11, at Broadlawn General Hospital.

Born in Mt. Pleasant, Iowa, he came to Des Moines 50 years ago, and was active in religious, fraternal and civic organizations.

He was affiliated with the North Star Lodge No. 12, of the A. F. of A. M. for over 40 years, serving at one time as Worshipful Master. He was a member of the St. Simon Episcopal church and a charter member of the Roosevelt club.

For eighteen years Mr. Woods was a porter at the Casino theatre. Later he was employed as messenger for Governor Turner during his administration.

Among his survivors are his widow, Mrs. Maude Woods of the home address, who before her failing eyesight was very active in the Women's Federated clubs of the city; a brother, George W. Woods of Omaha.

Wendel L. Wilkie made a statement to Negro leaders at Philadelphia. According to the Pittsburgh Courier, he was quoted as having said:

"I do not care whether the Negro delegates go down the line for me or not. The Negroes will get a fair share of appointments if I'm elected president. Furthermore, if all the Negro delegates vote against me, that still stands."

"Check my record. I stood up for civil liberties in this country when it was extremely unpopular to do so. I led the fight against the Ku-Klux-Klan in Akron, Ohio, in 1924, when every Judge on the bench in that city was a member of the Klan.

On Wilkie's full advisory committee for his forthcoming campaign are two Negro representatives: Thomas G. Nutter, Wes Virginia, and William King, Illinois, who will represent their race on the committee.

NAACP Says 4 Lynchings In 6 Months

4 LYNCHING, 3 WHITE. CITED BY NAACP IN REFUTING TUSKEGEE

New York—The following telegram refuting Tuskegee Institute's statement that no lynchings occurred during the first six months of 1940 was sent to Dr. F. D. Patterson, President of Tuskegee Institute, by the National Association for the Advancement of Colored People July 3:

"We are inexpressibly shocked by Tuskegee's statement that no lynchings occurred during first six months of nineteen forty. On March second Sarah Rawls and Benton Ford were flogged to death by a mob at Atlanta, Georgia. Five days later Ike Gaston was beaten to death by mob in same city. On June twenty-second Elbert Williams, Negro, was lynched at Brownsville, Tennessee, for attempting to exercise his constitutional right to register in order to vote in nineteen forty presidential election. Such inaccurate statements by Tuskegee Institute do irreparable harm by causing public vigilance against mob murder to relax and by giving enemies of anti-lynching bill ammunition for sabotage of such legislation."

Police Investigate Shooting Of Woman in Burlington

Burlington, Ia.—Police here are investigating the shooting July 5 of Thelma Logan, 33, who was wounded in the home of Theophis Tolar, 67, at 312 Angular street.

Tolar, held at the police headquarters without formal charge, said the shot which struck the Logan woman above the right eye, was an accidental one.

Mrs. Logan said it was fired while she was leaving the home. She resides next door at 314 Angular street.

The woman's condition was reported improved at St. Francis Hospital.

The bullet, it is reported, did not cause a skull fracture.

The woman is said to have admitted to investigators that she and Tolar had been arguing about money and liquor.

Tolar, questioned by Chief of Police Fred Machholz, said that Mrs. Logan came to his home on the afternoon, was abusive and threatening and had attacked him with a bottle, which, he said, had been filled with water to make it heavier.

Ruth Sanders, 35, who lived in is being held as a witness in the probe of the reported shooting.

Boys Urged To Sign Up For Y Camp

The camp committee of the Y. M. C. A. has virtually completed preparations for the 22nd annual Crocker Y camp at the Des Moines Y Camp near Boone, Iowa, August 12 to 19.

Plans to accommodate another large, lively group of campers and leaders for the 1940 period have been mapped out by the committee. An extensive program schedule that will keep each of the seven days of the period bristling with activity is in the making.

A number of the veteran leaders have already lined up for the period and are already selecting boys for their cabins. Although the camp enrollment card has not been posted, a large number of the boys have made payments on their fees, thus insuring themselves of a place in camp. Many more, in and out of the city, are daily requesting information.

Despite increased operating costs, due to the rise in the price of food and other commodities, the fee has been kept at the same low figure—\$5.50, which includes meals, lodging, countless programs and other activities, and transportation. This is made possible by the action of the Central Y. M. C. A. committee which subsidizes this period to the extent of paying the remaining \$5.00 for each Negro boy attending camp. Boys attending other periods of similar length are required to pay \$10.50.

Boys who have not signed up are urged to do so as soon as possible to be certain of obtaining a place in their favorite cabin and having a place reserved for them in camp as it looks like another capacity period. Reservations can be made at the Y office, or by calling 3-5611. Out of town boys should write the Crocker Y. M. C. A., Twelfth and Crocker Streets, Des Moines, Iowa for camp literature and information.

Local NAACP Delegates Return from Philadelphia with Many Impressions

Delegates from the Des Moines branch of the NAACP who attended the national convention of the Association which met recently in Philadelphia have returned with interesting impressions of the annual meeting.

Mrs. Georgine Morris, president of both the local and state branches, returned July 4 after visiting in Madison County, Va., with her father who is critically ill; then in Washington, Baltimore and Pittsburgh.

Mrs. Morris said the most spectacular interest of the convention came near the close of the meet when the Rev. Buster Walker of Brownsville, Tenn., one of the leaders of a group of Negroes, to the court house to vote, who escaped town after the murders of three Negroes on June 16, told the horrid details of the reign of terror. In less than four minutes the delegates contributed \$165 for him. He had fled without clothing or sufficient money and made his way to the national meeting.

Another item of importance stressed

at the convention was the health clinic problem which comes under the national hospitalization instruction act, Mrs. Morris commented. She urged Negro citizens to write to their congressmen and ask them to vote "yes" on the bill S32-20.

Mr. Smalls

Commenting on Mr. Ike Smalls who was elected to the national nominating committee, Mrs. Morris said: "Mr. Smalls was quite the toast of the convention. He made a wonderful report of his work which was put on display with other displays of the convention."

In an interview with Mr. Smalls well known Des Moines Jew, who runs the Smalls Medical Aid, he was highly impressed with the activities of the national convention on his first visit to a national meeting. "I will never forget the opening meeting," Mr. Smalls commented. "The excitement and the joy of all the people, the lights flashing—looked like a new hope coming the Negroes of the United States."

New York, N. Y.—An appeal to the country for help by Elisha Davis, who was driven from his business, his wife and seven children by a mob in Brownsville, Tennessee, is being answered by a country-wide campaign for funds by the N. A. A. C. P.

Mr. Davis, who is now living in another town in Tennessee (where he is also being threatened with violence), is 39 years old and was the owner and operator of a filling station in Brownsville prior to the outbreak of violence there in mid-June. The campaign of terror against colored citizens of Brownsville, and particularly against the officers and members of the Brownsville branch of the N. A. A. C. P., resulted from the attempt of several citizens to register and vote in the 1940 presidential elections.

When the Reverend Buster Walker, 55, president of the Brownsville N. A. A. C. P., and several others presented themselves before the proper official for registration they were told "You had better stop this or there will be a neck-tie party."

Mr. Walker and Mr. Davis and Mr. Davis's brother were run out of town and Elbert Williams, another member of the N. A. A. C. P., was found dead in the river with two wounds in his chest. He had been lynched.

The N. A. A. C. P. is calling on all citizens to contribute to a fund for the relief of the Brownsville exiles and for the purpose of attacking

the whole situation to the end that colored citizens may return to their homes vote in the 1940 elections, and pursue their normal lives.

In his letter to the N. A. A. C. P. Elisha Davis wrote:

"I gambled everything, my home, my business, my life, my family (wife and children) in order to prove to those people in Brownsville that the N. A. A. C. P. was all right. At present I am separated from my family. I am not making any money. I do not feel secure in the least. After having told all in this case, my life here, even in this town, is constantly threatened."

The Brownsville situation, from beginning to end, is a story of the most open, flagrant, and unashamed exercise of mob terror and lynching that has come to light in many years.

It has been shown conclusively that Brownsville officials, including a night marshal and candidate for sheriff a night policeman, a county highway commissioner, and other were among the leaders of the mob which drove Brownsville N. A. A. C. P. leaders from town.

Elisha Davis was waked in the middle of the night, forced to dress at the point of a pistol, and his wife was told "You will never see this black... again. We are going to kill him."

Taken to River

Davis was taken to a river bottom about six miles from town and asked about the purposes of the N. A. A. C. P. He was threatened with death unless he told the names of the members of the branch. Finally, he was released and told to leave the county and never show his face there again. Continued on page 3

WILKIE ACTS WISELY

Wendell Willkie may be a novice in politics, but he is no novice in knowing how to do things the people like. His attitude toward the Negro, while very little known heretofore, so far in his new role, offers much encouragement.
For instance he told Negro delegates to the Republican National convention that whether they voted for him or not, if nominated and elected he would give Negroes a square deal including their fair share of the patronage at his disposal. In other words, he said Negroes as American citizens were entitled to fair treatment whoever is in office.
This question as to whether a citizen should be given that justice contemplated in the constitution ought not be debatable—ought not be a political issue. And yet, that has been true in the past. Thus, the Negro was required to devote his energies to questions that are obvious rather than upon those issues involving the economic, civil and political life of all the people alike.
Generally, political leaders have been in the habit of making plans for a campaign without the knowledge or advice of the Negro and calling him in later to help execute them. Willkie has not followed this procedure.
Among the members of the advisory committee named to help run his campaign, two very able Negroes have been included. Both are lawyers, have been members of their legislatures and represent a departure from those heretofore selected for places higher up. Chairman John Hamilton made one of the biggest blunders of his career when he named Rev. L. K. Williams to head the Negro department in 1936 evidently reasoning because he headed a large religious organization all the Negroes would vote the Republican ticket. It worked out miserably.
So far Mr. Willkie has done a smart job. We hope he keeps it up.

Health Hints

IS HEART DISEASE ON THE INCREASE?

Heart disease is on the increase in this country, but it is often preventable, sometimes curable, and generally the symptoms can be ameliorated, and the individual not only prevented from becoming an invalid but can be kept, by proper treatment and by proper work, self-supporting.
Heart disease heads the list of causes of deaths in many parts of this country, especially, those sections with severe winters and heavy industry.
The majority of these deaths occur after 40 years of age although many deaths occur in early age. A large number of heart cases give a history of infection in early childhood; the greatest prevention of immediate and permanent injury to the heart is prevention of unnecessary infection, such as, teeth, tonsils, sinuses, etc. and the proper care of the patient, his heart, after any serious acute disease.
Heart clinics have been developed in most cities on the same plan as tuberculosis clinics. Proper treatment, good hygiene, nourishing food and changing the occupation of the individual from one he is unable to do to one he is physically able to do, have given astounding results. In other words, heart disease can be prevented, and if not cured, can certainly have its death rate decreased, by recognizing that heart disease needs special care and the opportunity for special management.
Heart and blood vessels' diseases are the greatest menace to the human race today. Over 200,000 children of school age in this country have heart disease. From 45 years on, organic heart disease causes more deaths than any other disease.
All patients of heart disease should be under the care of a physician at all times. Patients convalescing from acute infection should have their hearts examined frequently.

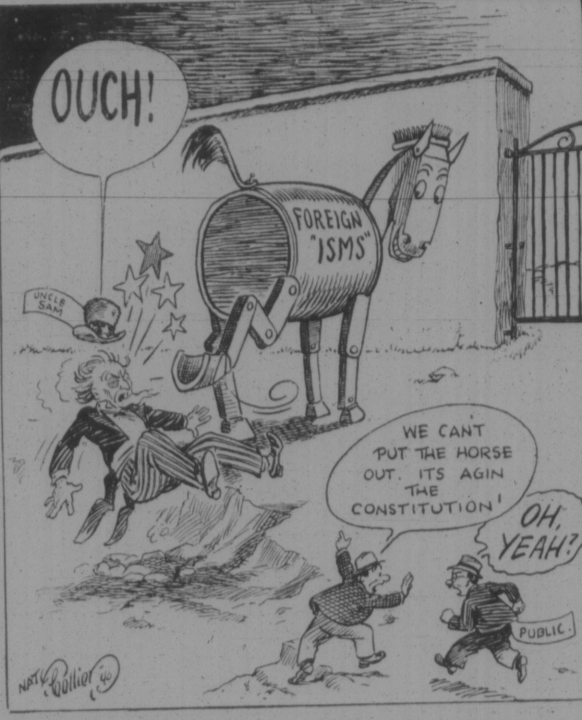

'Trick' Makes Laborers Out Of 'Eligibles'

New Orleans, (ANP) — Shrewd maneuvering on the part of the local postmaster was found to be the reason for several Negroes having been eligible for postal clerk appointments, no working as laborers in the post office. This trick was bared through an investigation following reports that there was no laborers' eligible list, and the several Negroes that had made "passing" grades on clerk examinations were now employed as laborers, and that their names had been "erased" from the clerks' eligible list.
Checking with the Civil Service commission on this, it was found that no eligible list for laborers existed, and that it had expired so long no records were readily available. Further investigation revealed that several appointments in this service had been made in the last few years and that these appointments were Negroes, formerly eligible on the clerk's list.
According to Leon Lewis, Associated Negro Press representative who is directing the investigation, there are at least four Negroes working in the local post office as laborers who were clerk-eligibles from the 1935 clerk-carriers' examination.

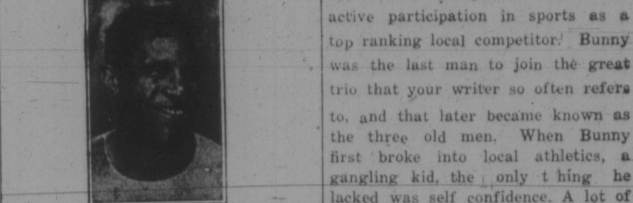

EYE INJURY ENDS ATHLETIC CAREER OF BUNNY WILSON

It is with deep regret that we note that the eye injury to Eugene (Bunny) Wilson will put an end to his active participation in sports as a top ranking local competitor. Bunny was the last man to join the great trio that your writer so often refers to, and that later became known as the three old men. When Bunny first broke into local athletics, a gangling kid, the only thing he lacked was self confidence. A lot of older fellows mistook this lack of confidence for fear, and we will never forget the amazement of those fellows when Wilson proved himself to have as much nerve as any man in town. He came up the hard way. A few of the old veterans were trying to hang onto their fading laurels and discouraged young competition, so Bunny never got a real chance until the advent of the Crocker Y Basketball team and the old Bulldog football team. He was fortunate in having good teachers and from then on Bunny took his place among the top ranking local athletes. Competing in track, he still holds the high jump mark for the Crocker Y track meet, jumping six feet three in basketball shoes in 1930. In football he became one of the best semi-pro tackles in town, and more than held his own against some of the best our state colleges could produce. Because of his great kicking ability, he was transferred to fullback and was soon rated as the best in town regardless of color. In fact, people are still talking about the game he turned in against the Daniels' Tire team, most of whom later became the local Comets. Old-timers down town do not even know his name, but whenever local semi-pro football is the topic will start talking about Bunny on that Sunday afternoon when he kicked the blamed ball nearly out of the stadium.
In basketball he became one of the leading scorers, and was always one of the high ranking men. Up at Alden, Iowa, the fans remember him as they saw him that night against one of the best of Iowa's teams. On that day he was the greatest basketball player who ever trod those boards. Then he could be just as bad as he was good. But one had to admit that on his day, no matter what sport, baseball, football, basketball, or track, Bunny Wilson was the greatest local athlete ever produced. But if it were not his day, well, let's not go into that. We are deeply sorry for Bunny, a swell athlete and a good fellow.

Wins \$53,500 Damages in Railroad Suit

Man's Oldest Food

"Barley has been called man's oldest food," says a bulletin from the National Geographic society "Widely grown now, from subtropical lands to regions beyond the Arctic circle, this hardy cereal was cultivated in China, according to ancient records, 20 centuries before Christ. The Egyptians, Greeks, and Romans knew it, as did the ancient lake dwellers of Switzerland. It even thrives on the roof of the world, 14,000 feet up in the mountains of Tibet and northern India.

Although every care is taken of the young trees, high-speed planting has been maintained.

At the nurseries, the little trees are packed and wrapped so that their roots are guarded from injury by wind and sun. When the trees arrive in the field, they are unpacked by WPA workers under supervision of trained foresters. The young trees are placed roots down in tin or wooden carriers and the roots covered with water or mud or both.

Trees are not watered at planting time nor afterward and must depend upon soil moisture and future rains if they are to survive. For this reason the trees are all grown from seed collected locally, so that they inherit their capacity to withstand plain environment. It has been found, the forest service explains, that trees develop capacities for survival in a given environment and transmit these capacities through the seed.

More than 42,000,000 trees in 4,500 miles of new windbreaks were planted last year. Plantings since 1935 total more than 127,000,000 trees in over 11,000 miles of field windbreaks on 20,000 farms in eastern counties of the Dakotas, central and western Nebraska, central Kansas and Oklahoma, and the Texas Panhandle.

22 Years of Blindness

Ends for Canadian Man After 22 years of blindness, the veil of darkness has been cut away from the eyes of William Hunter, 68-year-old news agent of Vancouver, B. C., by the magic of a surgeon's scalpel.

For the first time "since the mist came over my eyes in 1918," the onetime soldier can see again. He is reveling in his rediscovery of a world whose imagery had dissolved through the long years through lack of prompting.

"It was a miracle," he exclaimed happily, telling of the operation that restored his sight. "On the fifth night after the operation I had a hemorrhage in my right eye.

"I thought I had lost my sight forever. To be quite honest with you, I cried.

"But then the doctor examined me and told me I was going to be all right. Then they took off the bandages.

"I walked to the hospital window, not daring to hope for too much. But I looked out and for the first time in 22 years saw green grass. It was wonderful. I think I cried again.

Mercury Mine in Idaho

Discovered by Chance A chance discovery of a shepherd has provided Idaho with its first mercury mine and a new \$1,000,000 industry, according to state mining officials.

A sharp price rise in the quicksilver market gave a new impetus to the venture when the European war broke out and now the Almaden mines, developed by L. K. Requa, veteran Santa Barbara mining engineer, are producing an estimated 400 pounds of pure quicksilver a day.

Andy Little, young shepherd with a flair for mining, chased a lost sheep across the sagebrush-covered mountains 20 miles west of the city of Weiser in 1936 and noticed an outcropping of reddish ore at his pony's feet. He came back the next year and staked out 18 claims.

Requa visited the area on one of his periodic tours of western mining districts and examined the shepherd's cinnabar stake. He leased the property for 20 years with an option on further leasing, formed a company, set up a plant and began production last summer.

The venture is a closed corporation and no stock is sold. Requa believes the mountainside on which the mine is located is a solid mass of mercury in opalite and phyllite forms, left by an old lake bed. Cinnabar is an ore mineral that occurs in both bedded and vein deposits.

The plant is the latest metallurgical science has produced. The ore is roasted in a kiln at 1500 degrees and the mercury passes off in the form of a vapor to be condensed in 12 tubes, 30 feet high. The mercury is drawn off at the bottom into buckets and placed in flasks, ready for shipment.

The mine is an open pit operation. The ore is blasted out of the hillsides, tons at a time and rolled in cars along a narrow-gauge track to a bin, attached to a long conveyor belt. The belt carries the ore to a crusher and thence to a kiln where it is roasted.

Fuse Is Safety Valve

Of Electrical System Fuses, or circuit breakers, are the safety valves in the electrical system. Extra fuses should be kept on hand in case one blows out. There should be enough circuits, each controlled by a fuse, to carry all the appliances the home is likely to have, point out M. S. C. specialists.

When a fuse blows out it's usually an indication that there is a short circuit or an overload. Perhaps too many appliances have been connected to one circuit. This trouble occurs frequently in houses wired several years ago, before people began to have such a variety of electric devices, such as mixers, dishwashers, waffle irons, percolators, fans, razor and warming pads, as well as the refrigerator, washing machine, laundry iron and vacuum cleaner.

By removing fuses one at a time and noting which lights and outlets are "dead," a blown fuse may be found.

Safety First Is Goal

Of 'New Drug' Policy The "new drug" section of the Food, Drug and Cosmetic act, which went into effect recently, provides that no new drug shall be introduced into interstate commerce unless an application has been filed establishing that it is safe.

After a year of experience, the Food and Drug administration finds that these applications fall into contrasting groups. The greater number can be accepted and made effective promptly. Most are merely new combinations of familiar drugs that are safe enough to use, even though they may not be such "cures" as their sponsors hope. These pass quickly, though perhaps with a warning not to claim too much for the mixtures.

"A few of the new drugs submitted," says a current report, "are distinctly new and possibly highly valuable." Deliberate consideration and careful checking is essential. The administration has to shoulder a new and serious responsibility. It must avoid withholding a valuable drug from public use, but it cannot permit release without tests enough to insure that the drugs are safe.

Nearly one-third of the applications were held up for more complete information and checking in the first year. "One application covering an important new drug," the report comments, "called for a comprehensive review by medical officers of 2,000 cases reports recording the experiences of approximately 100 physicians. The application eventually was made effective upon the condition that the distribution of the new drug should be so controlled as to guarantee its use exclusively under medical supervision." Even when a new drug is licensed, there is need for continuing watchfulness.

EGGS ARE GOOD SUBSTITUTES FOR MEATS DURING HOT WEATHER

By Arden H. Duane (For ANP)

Eggs are a good substitute for meat. They contain protein for building up tissues—and a high percentage of easily digested fat. They also have a good source of iron and vitamin A. The problem is to prepare them in dishes that have variety and are still appetizing. Here are some unusual and delicious egg recipes that I think you will want to try at once.

Creamed Eggs and Mushrooms: One and one third cups mushrooms (canned), six tablespoons flour, three fourths teaspoons salt, few grains paprika, few grains pepper, three cups milk, eight hard-cooked eggs (sliced), one tablespoon chopped parsley. Slice mushrooms and cook in the fat for two or three minutes. Add flour, salt, paprika and pepper and mix until smooth. Add milk gradually and cook,

stirring constantly until thick. Add eggs and parsley. Serve on toast.

Eggs in Noodle Nests: Two cups noodles (one-fourth inch wide), six cups boiling water, two teaspoons salt, one half cup milk, one fourth teaspoon pepper, two tablespoons butter, melted, one cup grated cheese, six eggs. Cook noodles in water to which one and one half teaspoons salt have been added, for fifteen minutes or until tender. Drain and rinse with cold water. Mix with milk, one fourth teaspoon salt, one eighth pepper, butter and cheese. Divide mixture among six greased custard cups. Break a depression in center of each. Break an egg into each depression. Sprinkle with remaining one fourth teaspoon salt and one eighth teaspoon pepper. Set cups in shallow baking pan. Bake in moderate oven (325 degrees F.) twenty-five minutes or until egg white is jellied but not hard.

I suggest that the policy of our military and naval establishments should well be modified to enable these men to serve their country, as so many of them desire to do."

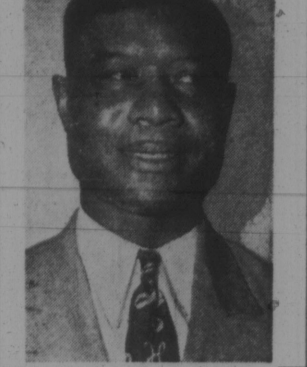

(Continued from Page 1) His wife and 7 children are at the mercy of the hoodlums in' Brownsville.

At the recent N. A. A. C. P. conference in Philadelphia, Pa., outraged delegates contributed spontaneously the sum of \$155 after the Reverend Buster Walker had told a graphic story of the terror in Brownsville.

The present fund being raised by the N. A. A. C. P. is for the purpose not only of individual relief for the families of terrorized Brownsville citizens but to carry on the fight to clean up the Tennessee town so that colored people may enjoy the rights to which they are entitled as citizens.

Every pressure is being brought to bear on the federal and state government to see that these people are restored in safety to their rights.

Meanwhile Brownsville is trying to block every effort to get at the trouble. Officers are posted on the highways leading into town and are turning back all colored who do not live in Brownsville.
