News Briefs From Far and Near

SHOULD NEGROES SUFFER?—In the bitter debates now being held in the nation's Capitol over the Lend-Lease Bill, the question of Britain's war aims in this present conflict is becoming of paramount importance. The more realistic opponents of American involvement in the Second World War point a reminding finger to England's unappreciated past record in such affairs. From 1533 until 1920 Great Britain managed to enslave some 495 millions of people, and acquire approximately one-third the earth's surface for her empire. In the present war, Great Britain is again silent on her territorial ambitions. A group of keen political observers in Washington, remembering the bitter aftermath of World War No. 1, are openly cynical of the future. In light of this semi-official suspicion of British motives, the colored people are asked to aid Britain, an exploiter of colored people, can well ask themselves, first, WHAT COLORED BROTHERS IN AFRICA AND THE FAR EAST THEY ARE BEING ASKED TO AID IN SUBJUGATING THEM TO WHITE IMPERIALISM.

NEGRO COUNTRY DOCTOR

Asheville, Tenn.—The negro country doctor of the South, located in typical rural town and probably the only negro practitioner in his county, treats an average of around 500 individual patients during the course of a year, nearly half of which are "charity cases" in the sense that the doctor knows at the time of undertaking the case that nothing can be collected, information secured by Meharry Medical College of this city reveals. Meharry Medical College, which is embarking upon a campaign to raise \$1,700,000 by July 1, has recently made a survey of conditions surrounding the Negro general practitioner in the South Central region, which, in addition to furnishing the information above, indicates that there is growing cooperation on the part of white doctors, many of whom are found to be assisting in operations.

Many of them have their daily cries and howls when their pops and moms leave them but after a session of games and songs by their efficient instructors, Mrs. Beatrice Caldwell, Mrs. Beatrice Crank and Miss Roberta Maupin, a hot meal of fresh vegetables and meats is ready and then the tots are ready for their daily snooze. Many a mother is finding the Nursery School of much value to her in getting her household duties and weekly activities accomplished. At nine o'clock they leave little Mary or Johnny and have the whole day—up to four o'clock to do their daily dozens or maybe go to their employment.

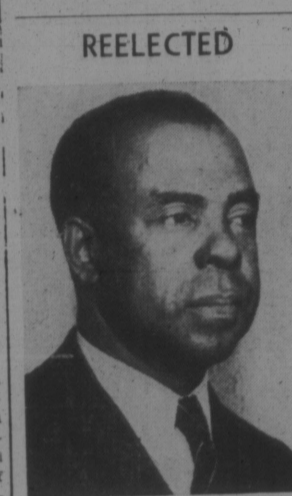

Conkling as the Chamber's representative and member on the Des Moines Industrial Defense Committee, reported on its activities to date and the efforts being made to locate some of the large defense industrial plants in Des Moines. As a representative of the Chamber, he is keeping a close check on all developments of the defense program to make certain that Negroes are guaranteed employment in these new openings.

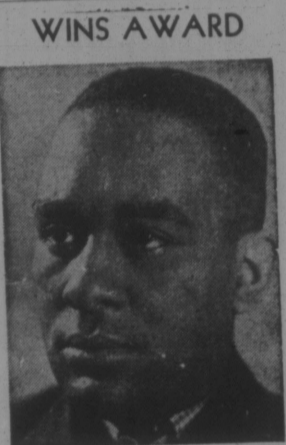
NEGRO MOTORIST GREEN BOOK IS AVAILABLE

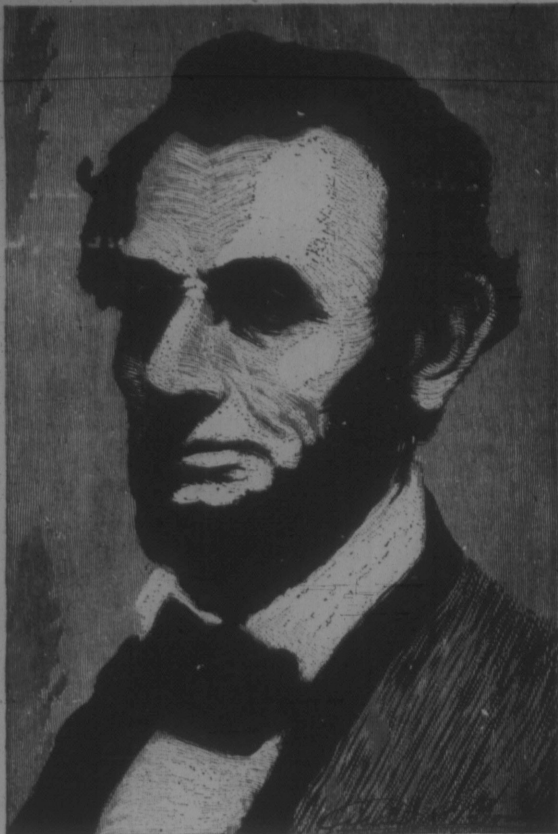

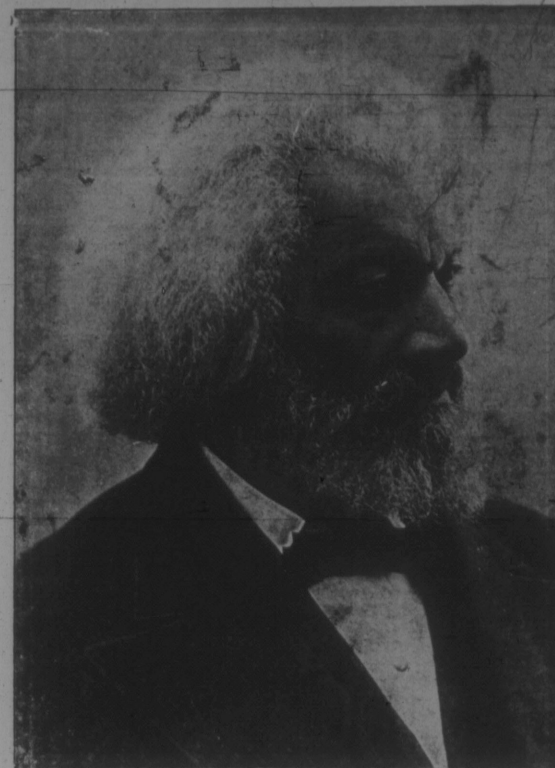

Dedicated to these Early Workers for Interracial Understanding

ABRAHAM LINCOLN EMANCIPATOR FREDERICK DOUGLASS ABOLITIONIST

LINCOLN

Abraham Lincoln, the Sixteenth president of the United States, was born in a rude farm cabin near Hodgenville, Ky., Feb. 12, 1809.

Known as the Great Emancipator, President Lincoln issued the Emancipation Proclamation announcing Jan. 1, 1863, abolishing slavery in all military sections of the South, except those territories occupied by Union armies.

On Aug. 9, 1861, an act had declared masters employing slaves against the government barred from further claim to them, but that was a mere warning and rule of the

I do not expect the house to fall—but court.

On Sept. 22, 1862, Lincoln issued a proclamation announcing that 100 days after, on Jan. 1, 1863, the Executive would issue another proclamation designating the states or parts of states then deemed in rebellion, evidence to the contrary being the presence of bona-fide representatives in Congress, that all slaves in the designated sections would be permanently free.

Lincoln's keynote pre-election speech in 1858 contained this memorable sentence: "A house divided against itself cannot stand. I believe this Government cannot endure permanently, half slave and half free.

I do expect it to cease to be divided. It will become all one thing or the other."

From the famous "Gettysburg Address" are the famous lines delivered by Lincoln: "...that this nation, under God, shall have a new birth of freedom—and that, government of the people, by the people, for the people, shall not perish from the earth."

Lincoln's career ended when he was assassinated in April, 1865.

He was president during the nation's most terrible war, but he always sought peace, prayed for peace, and made peace as soon as it was possible on terms that would make peace permanent.

DOUGLASS

Frederick Douglass, the famed Negro orator, was the champion of an oppressed race during the days of slavery.

Born in Talbot County, Maryland, on or about St. Valentine Day in 1817, he was sent to Baltimore to live with a relative of his master. In 1838 after having changed several masters, he escaped from slavery and went to New York City, where he was married and assumed the name of "Douglass."

During his spare time Douglass found work studied very hard during his leisure time and finally

became an orator by pleading for the freedom of the slaves.

Ever mindful of his people and seeing always to promote their welfare, Douglass was one of those who urged, in all his addresses at this period, the abolition of slavery and the arming of the Negroes as the most effective means of crushing the rebellion. In 1862 he delivered a series of lectures in New England under the auspices of the recently formed Emancipation League, which contended for abolition as a military necessity.

Douglass was instrumental in persuading the government to put colored soldiers on an equal footing with white soldiers, both as to pay and

protection. In the course of these efforts he was invited to visit President Lincoln.

Douglass edited a newspaper, "The North Star," later called "Frederick Douglass' Paper." He went to England; was once marshal of the District of Columbia; U. S. Minister to Haiti; and, recorder of deeds in Washington.

"Do not think that because you are colored you cannot accomplish anything. Strive earnestly to add to your knowledge. So long as you remain in ignorance, so long will you fail to command the respect of your fellow men." Douglass wrote in one of his editorials.

Many of the religious organizations will exchange pulpits in the regular Sunday services, emphasizing the theme of racial good will.

The American Christian—whether

white or black—cannot help but observe that the most grievous problem in America is that of Negro-White relations. In many American communities:

Fellowship is denied Negroes in many American churches;

They are segregated and given inferior accommodations in the train, in the bus, in the station and on the

boat, although they pay the same fare as the others.

Their educational opportunities are far inferior to those of the whites.

They are paid less than other Americans for the same work.

They may not hold certain positions even when they are well qualified.

They have little or no voice in the government under which they live, although they are native-born Americans.

And even in the present crisis— They have not been given by the national government an equal opportunity to prepare for service in national defense.

HEALTH HINTS

FOOD DEFICIENCIES AND CHRONIC DISEASE

The average diet is not deficient in one factor alone but there may be several slight food deficiencies which, when followed for a long period of time, may be responsible for various degrees of nutritional disturbances with accompanying ill health.

The influence of food deficiencies on chronic disease is just beginning to be appreciated. Some of the findings that are suggestive of possible food deficiencies are unexplained anemias, emaciation or undernutrition without organic disease, indeterminate gastro-intestinal symptoms or unexplained diarrhea, an edema without cardiovascular renal disease, peripheral neuritis with disorders of sensation and skin lesions of obscure cause.

Because of our faulty habits of living in the highly industrial machine age of our civilization, and our recent trends in modern dietary habits, the nutritional condition and physical vigor of our nation have unquestionably deteriorated.

The average physician is interested, therefore, in proper and adequate nutrition not so much because of its relation to ber-beri, scurvy, and xerophthalmia, all of which are rarely if ever seen by him, but because of the poorly defined states of ill health that may result from food deficiencies.

FIRST NEGRO ABOLITIONIST

Born in Africa during the 18th century, I succeeded my father as king of my tribe very early during my reign I was taken prisoner together with my tribe and sold into slavery in Brazil.

On voyage to the new world, all members of my family died of hardship and suffering with the exception of one son. Once in Brazil, the entire cargo was sent to the mines of Villa Rica, which was later to be known as Ouro Preto in Minas Geraes.

I swore that as king in my own right, I would continue as a king, even though exiled from my own land. Little by little I collected the necessary means to purchase the freedom of my son. And then, we two labored together to secure the needed sum for my own liberation.

After this was accomplished, we applied the same method in redeeming the freedom of our fellow-tribesmen. As each new man was freed, he would in turn join and work for the freedom of the others.

After the freedom of my own tribe, we turned our attention to the problem of freeing other tribes and slaves. In this manner we achieved the freedom of a great number of slaves throughout Villa Rica, which soon developed into a veritable colony, (a little state within a state), of which I was proclaimed king. (Called by many, "Little King.")

I took a second wife in Brazil, who was the mother of a daughter, and, as king and queen, prince and princess, we were accorded all the ceremonies and rights of our native land. I organized a brotherhood guild in which all paid a fixed quota into a common fund, which in later years developed into an association for the purchase of certificates of emancipation. I purchased the rich mines of Encardiera and Palacio Celho. The gold of these mines was used to widen the scope of my plan in the abolishing of slavery for my people.

I chose and adopted a patron saint, Saint Ephiqenia under whose auspices a fraternity of the same name was founded. The members constructed the magnificent Church of the Rosary which is still to be seen in Ouro Preto.

Synthetic Crude Rubber Developed by Industry

Development of synthetics in the United States is proceeding so rapidly that should a national emergency arise, this country could entirely eliminate the need for importation of crude rubber within one year.

A research program costing approximately \$30,000,000 — a small sum in a wartime budget — would bring a new compound of coke, limestone and salt called koroseal to a point where it could replace natural rubber, according to an article published in India Rubber World by S. L. Brous, engineer of the B. F. Goodrich company.

The new substance, which has been applied to more than 1,000 industrial uses, already ranks as a strategic material. Brous points out, because of its usefulness in protective wearing apparel and fabrics for lighter-and heavier-than-air craft. Also, in tests against mustard gas penetration, koroseal has been found superior to the best rubber compounds, while fabrics treated with it have been proven many times more resistant to hydrogen gas diffusion than rubber coated fabrics, he wrote.

It is predicted that other properties of this new synthetic point toward continued use in industry regardless of an emergency since it has been found to have high dielectric strength, complete resistance to ozone and corona cutting and resistance to acids, alkalis and light. It also does not swell in oil or common hydrocarbon solvents as rubber does, the engineer added.

MAKE SUN TANNING FUN

The outdoors present an irresistible invitation to all of us during the summer. There are so many things to do—swimming, games, sun-bathing, motoring—that we rush headlong into the sun and fail to take the proper precautions against its disastrous effects. A little sun, of course, is excellent for health, being the source of the much talked-of Vitamin D. It helps build up resistance to colds and strengthens us generally. But taken in over-doses, it can make us severely uncomfortable, even to the extent of a fever, convulsions and renal pain. And so it follows that we must take our sunning gradually and systematically.

Apply Oil Freely
Before you go out in the sun for any length of time, cover all the exposed parts of your body with a cream or oil. Olive oil is very effective applied both before you go out in the sun and after coming in. The sun has a tendency to dry up all the natural oils in the skin and the olive oil helps keep it lubricated. If you are out long enough for the first application of oil to dry out, be sure to use some more. Dry shine sun tan more easily and wrinkle faster than oily ones. Unless you keep your skin well lubricated, it is likely to become rough and coarse and, finally, dried.

When you come out of the sun it is wise to wash with the oil with warm water, being careful not to rub the skin roughly, and apply a coating of vinegar. If your skin is normally dry or if you feel that you have been exposed over-long, you might rub a bit of rich cream into your skin and leave it on overnight.
Drink plenty of water before and after being in the sun. The heat of the sun makes you perspire and you need more water to replace the fluid thus lost.
Don't be frightened out of your share of summer pleasures by fear of over-exposure to the sun. Just follow these simple rules—lots of water, frequent coatings of oil, and plenty of common sense—and you can have a glorious, carefree summer.
