CHURCHES LEAD CAMPAIGN TO KEEP NEGROES OUT OF 'WHITE SECTIONS'

Philadelphia, (ANP)—White Roman Catholic and Protestant priests and their churches have joined to purge Negroes out of certain sections of Philadelphia, it has become known here, with the exposure of letters showing the organization of these forces.

So anxious are these groups to keep Negroes from better homes that they have started the Girard Avenue union and are now raising \$12,000 to buy property in order to keep it out of the hands of the Young People's Fellowship, an interracial religious group.

The leading spirits in the anti-Negro drive are Fathers James L. Maguire and Thomas Love, of the Catholic church of the Gesu, both of the Jesuit Order, and the Rev. C. Herbert Reese, rector of St. Matthew's Episcopal church.

FATHER DIVINE OUT ON \$13,000 BOND

New York — Father Divine has escaped jail for the next months in spite of the efforts of Mrs. Virginia Brown, former "angel" of his "king dom," to have him imprisoned for failing to pay a \$5,949 judgment she obtained against him last year.

Father Divine's freedom is due to the posting of a \$13,000 surety bond which is supposed to guarantee his staying within the limits of New York county until September, 1941.

HOSPITAL ADMINISTRATORS MEET AT NEW ORLEANS

New Orleans, (ANP)—The National Association of Hospital Administrators, holding its sixth annual meeting at Flint-Goodridge hospital last week, discussed none too optimistically health problems as they affect Negroes in connection with national defense.

Dr. M. O. Bousfield chairman of the sub-committee on Negro health to the national defense council, A. W. Dent, secretary of the committee and Mrs. Mabel K. Staupers, also a member of the committee, were present and agreed to transmit the views of the group to the authorities in Washington.

Hospital nursing executives were invited to meet concurrently with the administrators. These nurses decided to form a National Conference of Nursing Executives which will meet annually at the same time and place that the administrators meet.

Mrs. Estelle Massey Riddle, superintendent of nurses, Homer C. Phillips hospital, St. Louis, was elected chairman of the group; and Mrs. E. Lyons Taylor, superintendent of nurses at Flint-Goodridge was elected secretary-treasurer.

Guest speakers at the administrators' conference were Dr. Russell H. Oppenheimer, dean, Emory University School of Medicine; Dr. C. Rufus Roren, director of the commission on hospital service, American Hospital Association; Graham Davis, consultant on hospitals, W. K. Kellogg foundation; and Dr. A. J. Hockett, superintendent, Toure Infirmary.

FOUND GUILTY



DANIEL L. H. WEST Daniel L. H. West, referred to in recent writings as the "Cinderella Man," was found guilty Tuesday night, March 12, on counts of forgery and "uttering a forged instrument," by a jury in District Judge J. E. Meyer's court.

The case went to the jury at 5 p. m. Wednesday and the verdict was returned at 10 p. m.

West was tried on a charge of forging a \$21.75 check on the Morgan Printing Co. and "uttering" or cashing it at Younker's store.

My record is as follows in Minneapolis: In 1931, nominated against president of park board, (first Negro to win nomination to a city office in Minneapolis or any other Minnesota city) received 5685 votes, defeated by 1,565 votes.

In 1932 defeated by 563 votes in the legislature in a field of six. Vitamin A, which is an absolute essential to good eyes, is lost from most vegetables by long storage. In the case of sweet potatoes, however, storage definitely increased the A content. Ordinary boiling caused no loss and increased the A content in string beans and carrots! Freezing caused no loss, but drying robbed spinach of Vitamin A.

The researches indicate that vitamin C, which prevents scurvy, is destroyed to a greater or less extent by heat, light, alkalis and some metals. Acids and sugars have a tendency to protect C. But storing foods at room temperature, or boiling, caused high losses. Refrigeration seemed to conserve a goodly portion of this essential, while pasteurization and irradiation robbed milk of 50 per cent of its C content.

Less definite information was available on vitamin B1, although there are indications that it will withstand a considerable amount of boiling, according to the best authorities.

West Makes His Reply

THE RECORD SPEAKS, WRITES MR. WEST TO THE EDITOR:

First let me thank you for your reprint from a Minneapolis "yellow" sheet; it is rather an amusing article; it was on this sheet that I first received my newspaper "experience." At that time it was the "Twin City Herald."

That I am the only Negro in Minnesota who was ever nominated to a city election, and the second to be elected; and on several occasions came within a few hundred votes of election.

In 1932 defeated by 563 votes in the legislature in a field of six. I am not discouraged, I am not afraid, I am not... You the people whom I've given years to the uplift of you and yours are, my judge.

You've defended me at the polls, and led me on to victory many times before.

Whether I am in prison or out, I have carried your fight. I shall continue to do so.

I shall always do the thing for the greatest number and as I see the right, regardless if I must walk this road alone.

I trust that you, Mr. Morris, as editor will give my side as impartial a hearing as you did the other side.

Sentence March 24 Tell Opportunities In Armed Forces

Increased opportunities for young Negroes entering the armed forces, brought about by the National defense program, was revealed by Sergeants George H. Watson and Oliver C. Christy of Fort Riley, Kansas, to the members of the Des Moines Interracial Commission at a meeting at North High School Tuesday evening.

The veteran Ninth Cavalry officers, stationed in Des Moines on recruiting duty, stated that all branches of service are open to Negro enlisted men with the exception of aviation, and that the discrimination in this field would shortly be removed.

Another speaker was Ozzie Morrow, president of the North High school student council. S. E. Thompson, chairman of the Commission, announced the appointment of the following persons as committee chairmen: Racial Justice, Ie Smalls; Housing, Prof. A. L. Severson; Program, Mrs. J. B. Morris; Industrial Relations, Anthony Sarcone; Education, P. O. Morrow; Health and Sanitation, Mrs. Lillian E. Edmunds; Church Relations, Mrs. William Dudley; Calling, Mrs. J. J. Campbell; Publicity, Quentin R. Meade.

"BODY LIKE A MACHINE," SAYS COOKING INSTRUCTOR
 "The body is like a machine," Mrs. Leona Kelly, cooking school instructor commented, adding that "if you don't have proper food it will run down."
 She believes in a well-balanced, tasty meal at low cost. Suggested below are some of the recipes that will be in Mrs. Kelly's collection for her cooking school audiences.
 Mrs. Kelly's favorite of foods to cook is rolls and she will demonstrate a variety of them, including criss-cross, tied, clover leaf, shamrock, brown sugar and orange rolls.

SALAD PLATE
 6 medium tomatoes
 1 1-4 cup canned tuna fish
 1-2 cup diced cucumber
 1 teaspoon lemon juice
 3 tablespoons mayonnaise
 6 tablespoons French dressing
 30 stalks cooked asparagus
 6 lettuce leaves
 6 stripes of pimento
 12 deviled egg halves
 stuffed and ripe olives
 salt and pepper

Cut a slice from stem end of tomatoes and remove pulp. Sprinkle with salt and pepper and invert tomatoes on plate to drain. Chop and drain tomato pulp, mix 1 cup of this with Tuna fish, cucumber, lemon juice and mayonnaise. Season with salt and pepper; chill. Pour French dressing over hot asparagus and chill. Before serving, fill tomatoes with tuna fish mixture. Arrange on large round platter on lettuce leaves. Between tomatoes arrange servings of asparagus and place a strip of pimento on top. Around the edge of the platter arrange deviled eggs; garnish with slices of stuffed olives and small wedges cut from ripe olives. This makes six servings.

Sausages for Company Dinner
 Take two pounds of well seasoned sausage. Form in a long mound or loaf in a small size bake pan and sprinkle a little flour over it. With fingers make as many dents, or hollow places (large enough to hold an egg) as there are persons to serve. Peel and split enough medium-sized smooth shaped potatoes to form a wall around the sausage by laying flat against meat. Place in hot oven and bake until potatoes are done. Then break an egg in each hollow in the sausage. When done remove to platter. Pile potatoes around it and make cream gravy from drippings.

Quaker Spaghetti-Italian Style
 1 pound ground pork and beef
 2 tsp. salt
 1-2 tsp. pepper
 2 1/2 tsp. grated Parmesan cheese
 1-2 tsp. chopped parsley
 1-2 tsp. powdered dried red pepper (use pepper pods)
 1-2 to 1 tsp. Fennel seed (may be omitted)
 2 eggs
 4 slices of bacon diced
 1 No. 3 cans tomatoes
 2 tsp. butter
 1 tsp. sugar
 1-4 cup tomato paste
 1 pkg. Quaker milk spaghetti
 1-4 pound Parmesan cheese
 Mix first the eight ingredients thoroughly; shape lightly into 18 to 20 small balls. Fry bacon until light brown; add butter. Brown meat balls until uniform in color. Remove meat balls and tomatoes and sugar. Cook slowly for 30 minutes, stirring frequently. Add tomato paste and water. Simmer 30 minutes longer, adding more water if too much evaporates. Add meat balls and simmer 45 minutes. Turn spaghetti until tender in boiling water (about 18 minutes). Drain. Turn into hot platter, cover with meat balls and tomato sauce and sprinkle parmesan cheese over all. Serve at once. Serves six.

Rhubarb Chiffon Pie
 2 cups finely cut rhubarb
 1 envelope unflavored gelatin
 2 tablespoons lemon juice
 2 cups sugar
 4 eggs
 1-4 teaspoon salt
 Cook chopped rhubarb and sugar ten minutes. Add the slightly beaten egg yolks and cook in upper part of double boiler until eggs are cooked. Add gelatin and lemon juice, stir until gelatin is dissolved and chill. When mixture begins to thicken, beat it and fold in stiffly beaten egg whites. Pour into baked pie shell and chill.

Hungarian Goulash
 1 1-2 pound lean uncooked beef cut into cubes
 1 onion
 potato balls
 Cook the onions in fat until brown. Add the cubes of beef and brown; put into casserole. Sprinkle with flour and add a pint of stock; half teaspoon paprika and salt to taste; cover closely and cook slowly. More fat may be added to that in the pan, and potato balls brown in it—added to the meat when it is about half done. The gravy may be thickened or cream added if desired—just before serving.

Children's Delight
 1 package vanilla rennet powder

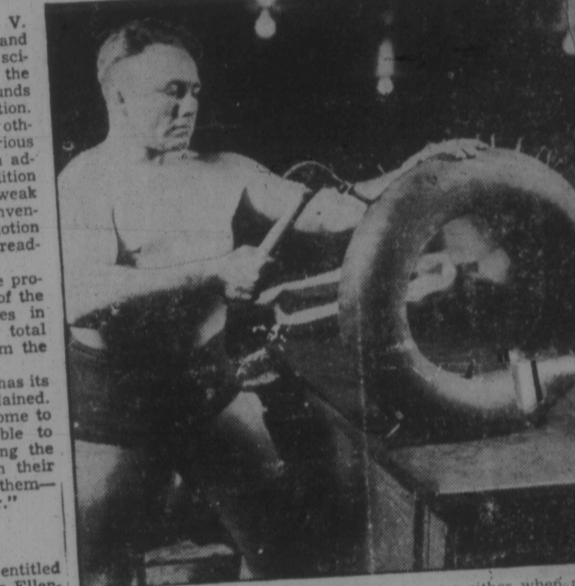

Hollywood is supposed to have spent \$1,739,000 in 1939 for new stage hits and top novels, yet its greatest activity these days seems to be re-makes.

How Fires Are Built

Have trouble getting a fire started
in your fireplace?
Here are a few directions that
should do the trick. Remember
that the foundation of your fire is
most important.
Crumple up three or four pages
of newspapers. Don't wad them up
hard as rocks, or you'll not get any
tall flames. Over the crumpled pa-
pers put a double handful of kindling
shavings, preferable box-wood. To
this add your smaller pieces of kind-
ling, building up to the larger
pieces. Then lay on two or three
small pieces of wood and on top put
your log. Light your paper in sev-
eral places at the same time. If
you still have trouble getting your
fire started, or your logs should be
damp, you can fall back on a bit
of kerosene.

the museum, believes that as a per-
son acquires greater familiarity
with his own organic structure, his
interest in maintaining health in-
creases.
As a result, the museum's exhibits
consist largely of ingenious mechan-
ical reproductions of human organs
from which the layman may gain a
knowledge of how his body works.
In the new institution people will
learn by seeing. The visitor will
be able to walk inside a model of a
human eye, press a button and see
the interior of the museum as it
appears to a near-sighted person. By
pressing other buttons it will look
as it would to one who is farsighted,
color blind or aged.
The public may start or stop a
model of a heart, see how it is built
and nourished, watch food in the
process of digestion, or minutely ob-
serve the movement of muscles.
The museum will maintain a work-
shop for the manufacture of models
of organs, now available only from
Germany and Japan.
