Congressman Mitchell to Quit at End of Session

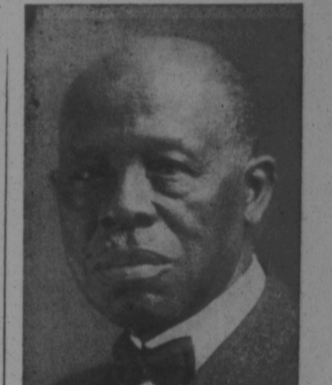

Oregon Reforestation. An increasing interest in reforestation on private land in western Oregon is reported by Dr. George W. Peavy, president emeritus of Oregon State college and a member of the state board of forestry. At these meetings hearings were held on the classification of approximately 40,000 acres of logged-off lands as reforestation lands. Under the state law, owners of cut-over forest lands may have their holdings classified as reforestation lands, explained Dr. Peavy. During the period of such classifications, taxes of only 5 cents an acre are collected. When the new crop of timber is removed, owners pay to the counties 12 1/2 per cent of the value of the logs removed as a yield tax.

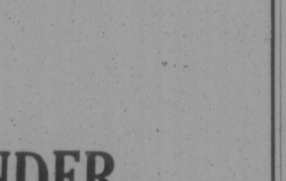

Science Finds New Types Of White-Tailed Deer

New types of white-tailed Virginia deer have been found by scientists in the last year, zoologists at the Smithsonian institution have announced.

On Blackbeard island, in Georgia, scientists found a small subspecies with black face and ears. It has a decidedly smaller skull and flatter antlers than the general recognized Virginia deer.

The Florida Everglades yields the Seminole deer, a large subspecies of the Virginia deer family, with notably short hair, short ears and hind feet and narrowly spreading antlers. From Bulls island, near Charleston, S. C., comes still another subspecies similar in general to both the Hilton island and Blackbeard island deer, but with differences in taxonomic details that account for its scientific separation.

Decidedly smaller than the generally recognized Virginia deer is a subspecies, the prototype of which was collected 10 years ago on Hunting island, off the South Carolina coast. Its back is described as a coarsely grizzled mixture of pinkish buff and brownish black. Its face is gray, with whitish markings around the eyes.

Double Magnesium Output

A plant which will make 12,000 tons of pig magnesium annually is about to be built near Palo Alto, Calif.

This is big news concerning national defense. Magnesium is extremely light. Two pounds of it will do the work of three pounds of aluminum. The Germans are using vast quantities of magnesium in their airplanes, and for bomb castings and other war purposes.

But magnesium has been a neglected metal in the United States. Until now there has been only one American producer of pig magnesium. In 1938 it made 2,400 tons, of which about one-third was exported. Part of the exports went to Germany. In the same year Germany produced 12,000 tons.

In 1940 we produced 6,000 tons (at a maximum estimate) and Germany produced between 50,000 and 75,000 tons.

Fall Planting of Roses

Assures Best Results

For a number of years rosarians have been advocating the fall planting of roses.

Mechanically, early planted spring plants will undoubtedly give as good results as fall planted plants, but somehow the human element and the vagaries of spring weather enter the picture and frequently spring planting gets under way much later than originally intended. As a consequence, these plants may not get a good start until well after the first blooming period.

Fall planted roses will usually bloom only a bit later than well established older plants, and as a rule will have a fine showing of flowers at about the same time.

Your nurseryman will not deliver plants until they are thoroughly dormant, but here also a bad season may interfere. It is therefore advisable to get the ground ready in good weather so that the plants can be set out immediately upon arrival.

Prepare the beds in the usual manner. If the area is large enough, throwing the soil to the side and putting four to six inches of rubble, gravel or cinders in the bottom of the bed. Return the soil, but add 25 per cent peat moss and about 25 per cent manure to the first 12 inches returned and work it in thoroughly before bringing in the later soil to which 25 per cent peat moss has been added. If no peat moss is available add a thin layer of straw manure to give some humus to the soil.

Before adding the top layer it is advisable to firm the lower layer either by tramping it or soaking it heavily. This will eliminate much later settling. This lower layer has been made richer in order to induce the roots to grow downward away from the hot, dry surface soil, to the cooler, moister lower strata.

Handy Household Tips

GOOD COOPERATION

Last week the Bystander carried a half page ad from one of the Des Moines department stores—Hills. The salesman from this store who had charge of Hills' booth at our cooking school in March urged upon the management to do this because such splendid results were obtained from the advertising and display at the time of the school. This not only showed that merchants do get results from ads in the Bystander but also it is evidence that our subscribers and friends are patronizing those firms which show cooperation with these institutions. The Bystander appreciates such cooperation, and is desirous that others follow this same example in dealing with this type of an institution.

No Freedom of the Press Here

Talk about freedom of the press as guaranteed by the constitution of the United States, but a municipal court judge in Florida demonstrated last week that there is no such thing in the jurisdiction of his court. Recently an election was held and the editor of a Negro weekly, aware of the disgraceful insults heaped on Negroes, said editorially that he hoped the newly elected progressive judge would refuse to allow such conduct in his court and would see that Negroes were treated like other human beings.

Enraged at the criticism, the retiring judge hailed the editor into court, fined him one hundred dollars and sentenced him to jail for ten days for contempt. Any judge who allows misconduct in his court is no better than those who practise it. And to allow insults to be heaped upon citizens is certainly uncalled for in a court of justice. Certainly Hitler would not have done much worse—in fact he has the courage to say in advance what he will permit papers to say—while this judge arbitrarily sends people to jail for no other cause than a man makes an effort to stand up for the rights of the people of his community.

Pegler, writing in the Des Moines Tribune this week, scores the ignorant whites in Florida for their disgraceful treatment of Negroes. The legal use of authority such as that of this judge, makes the Bystander feel that both classes join in mistreating the Negro citizens woefully.

Justice Under Pressure

Most daily papers with wire-photo service carried a remarkable picture Saturday of a Negro prisoner in Arkansas being marched through a line of United States soldiers to court where he confessed, pleaded guilty and was sentenced to die for the alleged raping of a white woman. The governor secured permission from the war department to use the federal troops because the states national guardsmen were in training out of the state. The Bystander congratulates the governor for at least making it possible to go through the motion of giving this man a trial. Some governors have not carried out their obligations to that extent.

But the question the Bystander raises is just how much of a fair trial could a defendant get under such pressure? No jury, no court, no prosecuting attorney is free to administer justice under such conditions. No defendant dares do other than the desire of the mob. Under such circumstances, and if it is necessary to bring a prisoner to court under such pressure there is no such thing as a fair trial. Several years ago the United States Supreme Court said in the Lee Frank case, which came up in Georgia—Frank was a Jew charged with raping a white girl—that as long as the lower court went through the motion of giving the defendant a trial, it had no right to go back of the proceedings to inquire whether those proceedings were dominated by mob violence. However, since that time,

the court has revised this ruling and in the Scottsboro cases, held that a trial dominated by mob violence did not comply with the due process clause of our Constitution and re-manded the cases back to Alabama for new trials.

Just what will happen in the instant case we do not know but the circumstances under which this man was tried certainly falls within the category of the court's last ruling.

BOOK REVIEW

FAITH CABIN LIBRARIES

(By Francis Allen in The Library Journal—March 1941).

Not long ago we read a dramatic success story, "One Dollar and a Prayer." Now comes another success story which might well be called, "One Dime and an Idea." In 1930 Willie Lee Buffington, mill post hand, wanted to do something about a condition common to the rural south, that is: no libraries available to Negroes. But, what could he, a mill hand, do? He had a dime that he could spare from his skimpy wages, so he bought some stamps and sent letters to people who might be interested.

As if by magic, his idea caught on. One letter alone brought a thousand volumes. In a short time Oberlin college had heard of this experiment in library work, going on in the back woods of South Carolina and established a unit in that state. Dartmouth and other schools and churches followed. Iowa City, Iowa sent 7,000 volumes. Faith Cabin Libraries are located on the grounds of Negro schools. Sometimes they are in one of the school buildings, sometimes on the grounds.

As might be suspected, these libraries are not built and managed according to standards of library science. Library cards are too much of a luxury. Records of loan and return of books are kept in a book. Teachers at the school volunteer to act as librarians. Labor and materials for shelves and so on are donated by the community.

Faith Cabin Libraries now have 36 units and have about 100,000 books. There is no way to estimate the amount of pleasure and inspiration they have brought to the people of South Carolina. Some of these people don't know how to read very well and naturally, they read very slowly. But, they get a lot of enjoyment from it anyway. It goes without saying, information is gained.

Then, too, these libraries serve as kind of social centers. One comes to get or return a book and he sees friends on the same mission. Anyone who would like to contribute some books may send them prepaid to: W. L. Buffington, Edgerton, South Carolina—Louise Glass.

HEALTH HINTS

PRE-NATAL CARE

About 20,000 women die in the United States every year of direct or indirect results of childbirth. Over half of these deaths can be prevented by proper care of the mother before and during labor period. In obstetrics, as in other branches of medicine, prevention is of paramount importance and simpler than cure, therefore, expectant mothers should avail themselves of this care at a very early stage during pregnancy.

Ideal Situation

This care means proper supervision of an expectant mother so she will be able to go through pregnancy without detriment to herself and so her new-born baby will be healthy after labor is over. The ideal situation is for every woman to be examined before she plans to become a mother.

If this procedure were carried out many abnormal conditions would be detected early and when possible, cured or alleviated. Families must realize that it is necessary for a mother to consult a physician as soon as they realize she is expecting. Once the patient is in the hands of the physician the responsibility rests largely on him.

Regular visits to your physician are very important no matter how busy you are. Husbands should cooperate with their wives in carrying out instructions given by their physician.
