PRIORITIES FOR \$1,500,000 GRANTED

Memphis (ANP)—An announcement was received by the Memphis Housing authority here last Wednesday that War Production board has granted a priority for materials for the construction of the \$1,500,000 addition to LeMoine Gardens, Negro housing project, which is scheduled to get under way early in May. The priority was granted providing a reasonable preference is given Negro war industrial workers in renting the units.

REPORT U. S. TO WIPE OUT COMBINE AGENCIES

Washington (ANP)—Rumors that will not down persist that the Public Works administration as such will be wiped out very soon and the officials assigned to that department and their departments of the Federal Works administration will be shunted over to the department of interior under Ickes. The Works Progress administration goes to Paul V. McNutt, in the course of the general split-up.

Workers in certain divisions of the PWA have been unofficially told that their divisions will cease functioning after March 30. While the entire matter is denied in official circles, there is talk that the two units mentioned here will be placed under different administrations, widely separated.

CITY COLLEGE ADOPTS REGIMENT

New York (ANP)—The City College School of Business and Civic Administration here adopted a regiment of Negro soldiers guarding strategic points within the city recently, and will provide athletic, educational and social functions for the diversion of the troops.

The soldiers will be quartered in an old postoffice near the college. During their off-duty periods, they will be allowed to participate in a seven-point program developed by the school's defense council and approved by Dr. Harry N. Wright, president, and Dr. Herman Foldman, dean. The program is to be administered by John Ferguson, instructor in hygiene.

APPEALS COURT UPHOLDS CONVICTION

Kansas City (ANP)—In the first higher court ruling on a selective service act case, the conviction of Edward Thomas Jefferson, 28-year-old Jefferson citizen was upheld here last Tuesday by a decision handed down in the eighth U. S. circuit court of appeals.

Johnson was charged with refusing to report for induction into the army after his local draft board had classified him L A over his contention that he was a conscientious objector and an ordained minister in the Jehovah's Witnesses. A graduate of Lincoln university, Jefferson City, he was convicted last May by a federal court jury and sentenced to four years in prison.

Thomas Nickens, 100-year-old former slave, a native of Portland, Mo., died Thursday morning at the residence of his daughter, Mrs. Margaret Wilkerson, 1303 Crocker, after several years of illness. He had been a resident here for 11 years.

NAACP Membership Drive Opens With Dinner Apr. 6

In a mammoth kickoff dinner meeting on Monday night, April 6, at the Central Y. W. C. A., the Des Moines branch of the National Association for the Advancement of Colored People will launch its 1942 drive for 500 members.

The dinner meeting will begin at 6:30 p. m. Reservations may be made by phoning 3-5611 until noon Saturday, April 4.

At 8 p. m., the public will be invited to hear the guest speaker, E. Frederic Morrow, national co-ordinator of NAACP branches. Many distinguished local persons have been invited as guests of the evening.

Mr. Morrow, the guest speaker, is a native of Hackensack, N. J., and a product of the Hackensack public schools, Lincoln Preparatory school

and Bowdoin college. At college he was the recipient of prizes for excellence in oratory.

Now 29 years old, Mr. Morrow has been a social worker, business manager for Opportunity Magazine and was at one time attached to the Republican National Committee as Eastern director of the youth division.

Ike Smalls, president of the local NAACP branch is urging all to see the advantage in joining an organization that fights for the rights of the Negro.

Heading this year's membership campaign is F. O. Morrow, past president; his membership committee, Mrs. F. O. Morrow, Jr., secretary, Mrs. Wm. Neal, Mrs. Julia Proctor; and a special army of captains, lieutenants and sergeants whose names will be announced later.

Coleman Heads Chamber Group

John S. Coleman, prominent civic worker, was elected president of the Des Moines Negro Chamber of Commerce at the annual election meeting Monday evening at the Blue Triangle Branch Y. W. C. A. During the past year, Mr. Coleman has served as chairman of the labor and defense committee and has been active in effecting an improvement in Negro employment in the city.

Other officers named are: Mrs. Belle Williams, vice president; Quentin R. Mease, secretary-treasurer, and Mrs. Marie Roberts, assistant secretary.

Funeral Service for Bishop Taylor

Kansas City, Mo.—All 1,000 seats in the Metropolitan Spiritual church of Christ were filled an hour before the funeral services began at eleven o'clock Tuesday for its founder, Bishop William F. Taylor. Another 1,000 admirers gathered on sidewalks and porches around the church at 1231 Garfield avenue.

Bishop Taylor died Tuesday morning, March 17, in Los Angeles, Calif. where he had gone several months for his health. He was a co-founder with Leviticus L. Boswell of the church here, in 1925.

A procession of bishops, clergy-

men and elders from many cities, altar boys, scepter bearers and a huge choir gowned in purple and white, entered the church to the tolling of the steeple bell and the shout from the Rev. C. H. Cobbs of the Church of First Deliverance, Chicago:

"Jesus, the Light of the World!" A spotlight played upon the \$2,500 bronze casket before the altar. Neon lights flashing the words, "God Is Love" and "Jesus Saves."

The tribulations of Bishop Taylor followed the inquiry by police in 1939 which resulted in the turning over by the bishop of \$12,000 hidden in the church. The money had been found by a workman while tearing down a house. Later the bishop was tried in the circuit court on another charge.

R. J. Blakely Speaks at Forum

"As you organize don't be just another small, narrow, selfish group," Robert L. Blakely of the editorial staff of the Register told members of the Negro Youth Forum Tuesday night at the Negro Community Center.

"See the problem—whole. Work for people everywhere," he stressed as he related the problem of the masses of people thru out the world, dangers of being an oppressed group, and the condition of the MR. BLAKELY world after the war.

"You are going to have opportunities—not because people finally see the light and say that 'I am going to treat the Negro as my brother,' but a lot of it will come from hard-headed necessity. Be prepared," he said.

The Negro Youth Forum will hold a business meeting on March 31, at which time final plans will be completed for the public meeting on April 12, at the Maple Street Baptist church, at which time Miss Lucile Blufford, news editor of the Kansas City Call, will be the principal speaker. Negro Health Week will be observed at this meeting, Freddie Hawkins, chairman, announced.

Buy Defense Bonds-Stamp

Praises Heroism of Mess Attendant and Patriotism Of Louis in Navy Benefit

New York—Wendell L. Willkie, chairman of the Inaugural Dinner of Freedom House, held at Grand Ballroom of the Commodore hotel Thursday evening, praised the heroism of the Negro messman at Pearl Harbor and the patriotism of Joe Louis in fighting for the benefit of the Navy Relief Fund, in making a plea for the "correction of injustices at home."

"Obviously among the purposes of the founders of Freedom House is the encouragement of our armed forces who constitute the battle line on which we fight for freedom throughout the world. Another purpose is to stimulate the people of America to support the cause of freedom everywhere.

"I wonder sometimes, however, whether we are not a little pharisaical or perhaps ever presumptuous in our high-handed statements about freedom. Are we always as alert to practice it here at home as we are to proclaim it abroad? Do we accord

freedom to all of our citizens?"

Willkie told of a belated press dispatch which described the personal heroism of men and officers during the Pearl Harbor attack, in which occurred the sentence of the "unnamed Negro mess attendant who manned a machine gun." The speaker cited the patriotism of Joe Louis who risked his world's championship in order to raise \$100,000 for the Naval Relief Society.

"Now you lovers of freedom," Willkie said, "I don't think this is right in a free country. Won't you, while you are proclaiming the necessity for freedom through the world, devote some time to bringing about a correction of this injustice at home, and injustice which makes a mockery of all our fine words. Don't you think that as American citizens, we should insist that our government and Navy department eliminate the bar that prohibits any American citizen from

Citywide Group Hears Judge Wm. Harrison of Chicago at Maple St

"Service counts; color doesn't," Judge William H. Harrison of Chicago, stressed Sunday afternoon as he addressed a crowd who attended the Men's Day services at the Maple Street Baptist church.

"In our own government—the flag in which we put the first drop of red blood—under that flag—our flag—the color line has been drawn," Judge Harrison spoke. He pointed out that "under that flag" the color line has been drawn in aviation defense, in "our great navy." In many places of national defense.

"The black man—best known for loyalty has been nudged away from the table of opportunity and chance.

"Something has filtered in our civilization that is a wolf in sheep's clothing," he said as he pointed out "great battleships catch fire and burn up and nobody around."

"If it should happen that we are kept out of the work of national defense let us remain loyal and patriotic and keep our faith in God.

"For it might be," the judge continued, "that Jehovah wants somebody who did not shed innocent blood to build another temple.

"Remain loyal—remain patriotic and wait on God," the speaker pleaded. "Don't tarnish the record we have made.

To the young people the speaker said "take hard, don't give up.

"You are going to run into some experiences that are going to hinder and hold you back—right here in Des Moines—in the state of Iowa. But don't stop. Don't quit. Have faith in God and go on."

"If you lose your patience and your sweetness, you lose your case," Judge Harrison said as he recalled his trials, tribulations and race prejudices when a child plowing the fields of Mississippi and later when attempting to complete his education and begin his practice of law in Oklahoma.

Judge Harrison cited an experience in Oklahoma in 1903 when he was serving his country?"

He was told, "Negroes and dogs can't

ride on the elevator."

"I didn't become angry. Words don't hurt me. I won't let them hurt me. I won't let a word embitter me. The man who is embittered hurts himself more than he hurts the object of his hatred."

The speaker pleaded for "patience and confidence in our selves. If you don't believe in yourself you are whipped before you start. Teach your children that given the same opportunity—the same advantages—the same circumstances and surroundings—you put as good a brand of goods on the market as anybody.

"Work when and whenever we can. Do the job so well—so faithfully, that you make the boss forget what color you are. Quit talking about color; forget it and go forward."

Sunday night Judge Harrison spoke on "the Christian church as the greatest institution in the world; and, the Christian family as the looking glass into which the world looks to see how Christ looks."

Sunday morning the men of the church heard the Rev. C. Lopez McAllister, pastor, speak on the subject "Wanted—a Man."

Boston was charged with slaying Lavelle Jackson, 36, his former landlord, at 923 sixteenth street, last Nov. 27. Boston claimed he was temporarily insane.

He admitted he had gone there to "talk" with Jackson about the latter's alleged attack on Mrs. Boston, and said he carried a loaded shotgun because he didn't know what Jackson's attitude would be.

This week another lady was interested in one of the desserts that did not appear on the recipe leaflet—Cherry Moss. For have benefit and others it goes like this: "1 tablespoon of plain gelatin; 1-4 cup cold water; 1-4 cup boiling water or cherry juice; 1-2 cups drained canned cherries; 1-2 cup cherry juice; 2 whites beaten stiff; few grains of salt. Soak gelatin in cold water until softened. Dissolve in the boiling water or juice. Add cherries and cherry juice. When mixture begins to thicken, beat to fluff it up, then fold in the egg whites and the speck of salt. Turn into slightly chilled mold. When ready to serve, remove from mold and sprinkle with a few nuts or almonds.

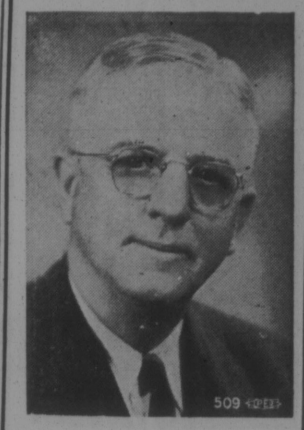

Shortage of Materials Affects Telephone Users

In order to conserve materials for war needs the telephone business is now operating under government restrictions as to installation and replacement of telephone equipment. Some of these are:

1. Wall and desk telephones are not being replaced with hand telephones.
2. Extension telephones in residences are being installed only under certain circumstances.
3. Party-line service is the only service which can be provided in some localities for new applicants and for those who move.
4. Replacements and improvements, which would be made under ordinary conditions, are now being deferred.

We realize that these war restrictions will affect many telephone users but we shall do everything in our power to provide as adequate service as is possible under existing conditions.

And now that we were free, free to assist in the building of the kind of world in which we could and would all enjoy, a democracy, a democracy for all the people, all the time, everywhere, we were a happy lot.

But today, as I look outward upon a bleak and ugly world, I wonder what became of that democracy that we were so willing to live for, love for and even die for.

Yes, I was glad of my assignment in the 9th Cavalry to scout duty near the Rio Grande river in Mexico, campaigning against Geronimo's Apache Indians in 1884. I was glad to receive a special medal for bravery by Lieut. McDonald for service rendered in Arizona, on being discharged from service, 1887. And on July 10 of the following year, I enlisted for scout duty with General Corbin, who were seeing a bit of tough going with the Moqui tribe.

Again, for the third time I enlisted and became engaged at Las Guasimas. Later in the following year, 1898, I went to the rescue of the Rough Riders during the siege of Santa Clara, Cuba, where I received a medal of honor for gallantry, presented by the great 'Master of the Rough Riders' (Teddy Roosevelt).

The main responsibility for the quality of butter consumed by the American people must ultimately rest on the cream-producing farmer. After all is said, the big job in producing quality cream on the farm lies in keeping outside bacteria from contaminating the cream while fighting strenuously to keep the bacteria normally in milk at a minimum. Principally it is a task in sanitation: Clean barn, clean udders, clean hands, clean utensils, cooling of the cream immediately after separation, and frequent milkings. It is as simple as that.

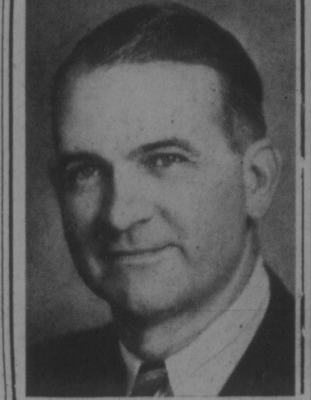
