

News Briefs From Far and Near

MISSOURI U CANCELS JOURNALISM COURSES TO BAR RACE STUDENTS

Kansas City, Mo.—The University of Missouri has discontinued its graduate work in journalism, and the school has not offered this work to any students in Missouri since January 29, according to the answer filed by S. W. Canada, registrar of the university to the suit of Miss Lucille Bluford against him for admission to the school.

The date given for the discontinuance of the courses is the Friday preceding the Monday that Lincoln university at Jefferson City was to open its school of journalism, and the University of Missouri's action is regarded as having been taken to end Miss Bluford's demands that she be admitted.

Charles H. Houston, member of the NAACP national legal committee, who is chief counsel in the case, states that Miss Bluford, on personal inspection of the facilities at Lincoln's new journalism school, did not find either the equipment faculty or courses to be substantially equal to what the University of Missouri had offered in graduate work in journalism up to that time.

EVACUATE JAPS, GERMANS, ITALIANS NOT BOTHERED

Los Angeles (ANP)—Despite protests from American-born Japanese who proclaim their loyalty to the nation, evacuation of all Japanese from prohibited zones on the Pacific coast is now going ahead.

However, this action on the part of the government is meeting with some protest on the part of other Americans who point out that nothing is being done to move the Germans and Italians out of strategic areas here. Germany and Italy are also at war with the United States.

BOMB AFRICAN NEWSPAPER

Johannesburgh, South Africa (Delayed ANP Correspondence)—Considerable confusion was caused and damages representing quite a sum of money suffered when the offices of Bantu World, well known African publication, were bombed. The explosive was placed secretly near the doorway of the newspaper, tearing away brickwork and shattering windows.

Thus far no trace of those responsible has been found. It is felt to be the work of fifth columnists. There is a seething undercurrent against war and England here particularly upon the part of the Boer-Dutch. These seek constantly to create dissatisfaction between the African and English.

NEGRO SOLDIERS IN AUSTRALIA

Washington, D. C.—The number of Negro soldiers now serving in every arm and branch of the Army practically equals the ratio of the Negro people to the total population of the nation, according to the Honorable Henry L. Stimson, Secretary of War, who disclosed further that Negroes are now serving with other American forces in Australia. Mr. Stimson stated also that many Negro officers, among the several hundred now serving in grades from 2nd lieutenant to brigadier general, are graduates from the various officer candidate schools. Other Negroes are serving in non-commissioned grades, as warrant officers, and as Army nurses.

DEAN PICKENS VISITS QUAKERS

Philadelphia (ANP)—"Friends" of Pennsylvania held a three-day session with Dean William Pickens of U. S. Treasury department defense savings staff last week, who visited Kennet square, Swarthmore college, Wilmington, Del., and State Teachers college, West Chester, Pa. The tour was managed by Dr. Jesse H. Holmes white, emeritus professor of philosophy at Swarthmore.

Business League Proclaims 1942

Memphis (ANP)—A proclamation issued by J. E. Walker, president of National Negro Business league, here last week announced the 1942 Spring Negro Trade week campaign and the observance of the birthday of Booker T. Washington, founder of the league. Combined with these two programs is the observance of National Negro Health week, a movement which was also started by the late Dr. Washington. All will be observed during the month of April.

Calling all local Negro business leagues, chambers of commerce and other groups devoted to the economic advancement of the race to arrange suitable programs for the birthday observance and for trade stimulating effort, the proclamation declared, "Our nation is engaged in a great war to preserve its traditions and its basic principles of free government. In this struggle all groups and individuals in our nation are impelled by instincts of preservation to devote their utmost in energy and resources to stay the advance of our aggressors."

The Federal Grand Jury in the Northern District of Florida will hear a case concerning brutal treatment administered to a Negro, "Impy" Johnson, in connection with his return to a turpentine farm.

The Department will retry in the United States District Court for the Northern District of Georgia, W. F. Sutherland of the Atlanta, Georgia, police force, for branding a Negro youth with a hot iron in order to extort a confession.

An FBI investigation of the State parole system in Arkansas has been ordered in an effort to verify persistent charges that certain members of the State Penitentiary Commission are placing paroled Negro prisoners in the custody of themselves and their friends and relatives. It is alleged that the guardians compel the parolees to work on their private plantations for only nominal wages.

GUS WRIGHT, COAL MINER, IS DEAD

Last Rites for Rev. McCraven

Funeral rites were held Monday afternoon for Rev. Henry McCraven, 85-year-old former slave and prominent citizen of Des Moines, from the St. Paul A. M. E. church, with the Rev. H. C. Boyd, officiating.

Rev. Mr. McCraven died on Thursday, March 26, at the home of his granddaughter, Mrs. Marie Carson, 925 Fifteenth street, of a heart attack.

Born in Mt. Sterling, Montgomery County, Ky., July 1856.

The Rev. Mr. McCraven early childhood was spent in slavery. He came to Des Moines in 1873 and entered school. Finishing elementary schools here he went to Missouri to teach.

His career in the ministry began in 1884 when he was ordained. He spent most of his time doing missionary work.

He held many offices of trust during his lifetime here. In 1884 he was appointed honorary commissioner to the World's Cotton and Industrial Exposition at New Orleans. In 1903 when President Theodore Roosevelt visited the city the Rev. Mr. McCraven was a member of the reception committee.

In 1876 he was elected to the cloak room service in the Iowa Senate and remained there until 1934. He served as toll collector for Polk county. He was a member of the Polk County Republican Central committee.

In 1882 when the Negroes had no church in this city, Rev. McCraven was appointed under Rev. Thomas Cheek to canvass for funds to build a church. In three weeks, \$11,000 cash was collected by him from white men of the city.

Rev. Mr. McCraven was a Sunday school and teacher, Adult Bible class teacher and class leader at St. Paul A. M. E. church. He was affiliated with the Doric Lodge and the Brotherhood, Inc.

Surviving are: three daughters, Mrs. Gertrude Stewart of Ogden Utah, Mrs. Maude Wyatt and Mrs. Carrie Colbert of this city; two sons, Harry McCraven of California and George McCraven of this city; sixteen grand children; sixteen great grand children and two great-great grand children.

Burial was in Woodlawn cemetery with the Estes Funeral directors in charge.

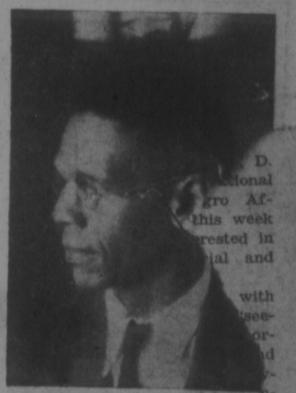

Origin and Ten Year History of the Brotherhood, Inc.

On March 16, 1933, 62 men of 130 men who had been suspended from an old organization by Court Order, met in a body and formed what at that time was called the Des Moines Brotherhood Association.

Being in the midst of the worst depression the world has ever known, many of the members lacked faith in a new venture at this time. In nine months, because of these reasons, all had quit but 12 men—the Noble Chieftain; the Secretary, the late George H. Edmunds; the treasurer, W. J. Newcomb; and 9 other faithful men who refused to quit. A Constitution and By-Laws were adopted, and in these, the dues was to be 25c per month, and each man placed \$1.00 in a burial fund to be paid to the beneficiary at death. At the death of a brother, each man was taxed another dollar to prepare for the next death. A plan was also adopted that the amount paid was to be governed by the number of members in good standing on the day of the brother's death.

October 18, 1934, the Brotherhood was incorporated for 50 years under

Chapter 394 of the 1931 Code of Laws and Acts amendatory thereto, and authorized to set up subordinate lodges anywhere in the United States and its possessions. In 1935 the women's auxiliary was organized. The Sisters, the newly organized body, grew by leaps and bounds, and soon had outnumbered the men. Today are working with the Brotherhood as constructive program.

The first brother we lost was called Joe Hall, who passed on and his beneficiary was paid (See Society Page)

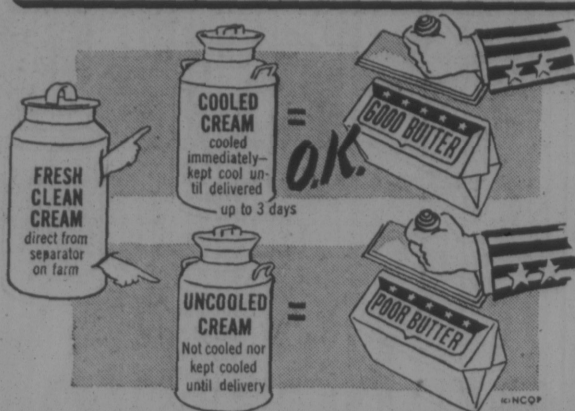

COOLED CREAM and GOOD BUTTER GO HAND IN HAND



Cream which was not cooled immediately after separation and which was not kept cool all the time it remained on the farm has "three strikes" on it by the time it reaches the butter-making plant. If there is one thing the butter maker has learned over the years it is that the best butter is invariably the product of properly cooled cream on the farm. Experiments at the dairy department of Purdue University show that through "temperature control" the farmer is enabled to hold the quality of his cream as many as three days and collect a premium price over the next grade product. The creamery striving to manufacture quality butter is glad to pay the premium for cream kept well-cooled on the farm and delivered clean and fresh. Cold temperatures will not prevent bacterial growth, unless the cream is cooled immediately. Bacteria start their work of destruction in the warm milk and cream. Air cooling, even in cold weather, is too slow to retard bacterial growth. If milk is allowed to stand before it is strained and separated, the damage will be done. Or if the cream is allowed to stand before being put in the cooler, another opportunity will be made for bacterial growth. Water-cooled cream—a great deal faster than the coldest air. A cold water cooling tank will quickly bring down the temperature of warm cream. It will slow down bacteria so that their rate of multiplication will be kept at a minimum. An efficient cooling tank can be made on the farm from an old barrel. Placed between the pump and the watering trough, with an inlet and outlet pipe, cold water can be kept flowing. Cream cooled in this way as soon as it is separated will have a low bacterial count. If all the other steps necessary to the production of quality cream have been observed, and if the cream is marketed every two or three days, it will grade No. 1 and be bought on quality.

Silva loves to recall his days at the CCC camp where he hopes to return when this war is over. He said he was very happy—just being their mess sergeant—preparing balanced diets and seeing that the boys were pleased. He has cooked so long that he does not need to follow recipes he says. He can "throw in a handful" of this or that and always get it right. He says he can make cakes that won't "bounce back" if thrown against a wall; he can fry chicken "that fairly melts in your mouth." He knows something else besides cooking—a lot of home remedies for colds, aches and pains—remedies that were handed down to him from his grandmother.

Now that Pvt. Silva is stationed here until one day when the war is over—he is hoping that he will get a chance to do a little cooking around the post.

Civic and Social Activities
In 1938, Jack Manuel, an ambitious young man, alone and without organizational connections, organized 10 boys into a Drum and Bugle Corp. He appeared before several organizations, trying to get them to finance his project, but none of them paid him any attention. One night he visited the home of the Chieftain of the Brotherhood, Inc., and got a promise from him that he would do something for Mr. Manuel. Since that time, both the Brotherhood and the Sisters have financed and promoted this character building and pride producing institution for children without outside donations. The amount this organization has spent for instruments, teachers, transportation, and insurance is \$421.00.

Swimming Pool
In 1939, the Noble Chieftain sat in Good Park near the swimming pool and watched three big strong life guards sit in their positions and watch five children swim in a pool that could accommodate 300. Not only was this situation unfair to the taxpayers of the city, but it wasn't benefiting the recreation and health of the children of the community.

The Noble Chieftain resolved then and there that he would try to do something to remedy this condition. So in 1940, he started the campaign for funds for free swims for under privileged children. First, he went to the Brotherhood and the Sisters with his proposition. They supported it 100 per cent and allowed \$35.00 out of their general fund to start the drive. We then collected \$56.00 from 11 other organizations in the city, which gave us a total of \$91.00 for our first effort, resulting in 851 free swims for the year 1940.

In 1941 the same method was again used, the Brotherhood and Sisters giving \$45.00 out of their general fund to start the drive and we collected \$71.00 from 18 other civic organizations which gave us a total of \$116.00. The children received tickets for 1,812 free swims. And this was not a Jim Crow service. White children received free tickets just the same as colored children.

In 1938, 200 white residents north of University Ave., and east of 19th street, petitioned the County Supervisors not to sell non-white people any property in that locality. The Brotherhood and Sisters with a petition of 400 names, sent a committee headed by W. Lawrence Oliver, to protest such action. Our committee was successful in this endeavor, and the Board of Supervisors assured us that they would not comply with the white petitioners' request.

In 1940, a certain Tavern Keeper on Keo-way and Crocker streets openly discriminated against a colored boy in selling him a sandwich. Atty. W. Lawrence Oliver was sent by the Brotherhood and Sisters to investigate, took the case into court and got a conviction. The discriminator was fined \$100 and costs by the judge.

In 1941, the State Legislature passed a Bill that could be used to send delinquent Negro children to Mississippi or any other state for incarceration, while white children were to be taken care of here in Iowa. Atty. Oliver brought the information to the Brotherhood, and was authorized to ask Governor Wilson to veto the bill. The bill was vetoed, and the Governor notified the Chieftain of the Brotherhood that he had done so, and thanked the Brotherhood for the interest they are taking in good government.

Also in 1941, to prepare the youth of the country for defense, young white men were being trained at West Junior High school, but they would not train any young Negro men. The Brotherhood sent Brother John S. Coleman and Atty. W. Lawrence Oliver to see what could be done about it. After months of hard work, they succeeded in getting our boys in the school. Brother John S. Coleman, representing the Brotherhood, has succeeded in getting the Brody Overall company to promise to hire Negro women in their factory.

The foregoing are some of the actual services rendered to the community by the Brotherhood. Inside the organization, we have helped our members in sickness, and we have been there to help in distress of all

kinds. When the Ordance plant started its construction, many of our men could not put up the deposit that the Unions demanded. We gladly supplied the amount, and they went on their way rejoicing.

We have proved what a small band of men and women can do with a little cooperation, a little money, and a little common honesty in spending it. If we have accomplished so much with so little, what could we do if we had the number of members that we should have?

The war is on—We know not what will follow—but we can be ready for whatever may come. We can be organized.
